# Vendors occupy footpaths, parking lots in city

#### Elbow out pedestrians to walk on roads

PORT BLAIR, NOV 4/--/ The Port Blair Municipal Council has started removing unauthorized stalls/carts/ kiosks & abandoned vehicles from various places in the city. PBMC officials have already removed the food kiosks from the Bathubasti parking areas. Encroachments on footpaths and roadsides had become a common sight in the city. "Most of these are in the form of temporary shacks on roadsides. People first establish temporary stalls by encroaching roadside payment or footpaths and then convert it into a permanent one at a later stage.

After noticing that a number of unauthorized stalls/carts/kiosks/

abandoned vehicles are placed in various places of the Municipal area viz., road side and parking lot of PBMC, the Civic Body directed all the unauthorized stalls/cart/kiosks around Municipal areas that are not having certificates of vending and owners of abandoned vehicles to remove their stalls/carts/

kiosks/vehicles within 07 days. Failing which strict action will be taken against the unauthorized vendors and PBMC will evict the entire stalls/carts/ kiosks/abandoned vehicle without any prior intimation. The PBMC parking area near Durgapuja parking lot is one such area which has been occupied and many eatery stalls have come up.

With the authorities turning a blind eye to the problem, encroachment of roadside payment has become alarming in the city, causing problems to not only pedestrians, but encroachment of footpaths have also narrowed down the roads, obstructing free flow of traffic. Almost all roadside pavements in the city have been encroached by people by putting up

abandoned vehicles, luring motorists to park their vehicles on roads to enjoy the food, causing traffic obstruction. "On several occasions, motorists exchange heated arguments with several people parking their vehicles on roads. But no one is willing to realize their mistake. While some small vendors set up their wares on the footpath itself, plastic sheets are being tied to serve as a shether", said a motorist.

Meanwhile, the Traffic Police have also initiated action to remove all discarded vehicles laying on the roads for the past many years. Abandoned vehicles and discarded carts and unauthorized stalls on the roadside in the city are adding to the traffic chaos unauthorized stalls/carts/kiosks/ and ruining the beauty of the city.

## MCD polls on Dec 4, results on Dec 7 Filing of nomination to begin from Nov 7

NEW DELHI, NOV 4 /--/ Polling for the municipal election in Delhi will be held on December 4 and the votes will be counted on December 7, state election commissioner Vijay Dev announced on Friday. The Model Code of Conduct comes into force in the national capital from Friday itself, Dev said. "The filing of nominations will begin from November 7 and the last date for the same is November 14," he said at a press conference. The election commisioner further said: "Scrutiny of nominations will be done on November 16 while the last date for withdrawal of candidature is November Candidates can submit their nominations between 11 and 3 pm while the poll time has been set between 8 am to 5:30 pm. The entire process of election will be completed on December 15. According to data shared by the SEC, as on today, total voters in Delhi are 1,46,73,847 -- 79,86,705 male, 66,86,081 female

and 1,061 transgender. There are a total of 250 wards in the Municipal Corporation of Delhi

Municipal polls were slated to be held in Delhi in April this year. They were put on hold hours before Delhi election commissioner Srivastava was to announce the schedule on March 8 due to the Centre's plan to reunify the three civic bodies. The three civic bodies were reunified by the Centre in May this year delimitation of wards was started in July 2022. According to officials, polls will be conducted at all polling stations using M-2 model of ECIL make EVMs. State Election Commission (SEC) has already made elaborate arrangements to ensure availability of adequate number of EVMs for smooth conduct of polls. "At least one model polling station would be set up in each assembly constituency and one polling station shall be set up to be manned

exclusively by women officer/officials in each constituency," a senior official said. There will be nearly 13,665 polling stations in 2022. The number of polling stations in 2017 was 13,138. The SEC has upgraded the status of facilities at the polling stations from the earlier concept of Basic Minimum Facility (BMF) to Assured Minimum Facility, he added. The officials said that the limit maximum expenditure by a candidate at an election to a ward has been fixed at Rs 8 lakh. The reunified MCD had formally come into existence on May 22 with IAS officers Ashwani Kumar and Gyanesh Bharti assuming charge as the new civic body's special officer commissioner, respectively. The erstwhile MCD, established in 1958, was trifurcated in 2012 during Sheila Dikshit's tenure as the chief minister. It was recently reunified by merging three civic bodies North, South and East Delhi municipal corporations or NDMC, SDMC and EDMC.

## Delhi, people will choose AAP, says Kejriwal; BJP not to repeat outgoing councilors on 60-70 per cent seats

NEW DELHI, NOV 4 /--/ Delhi chief minister Arvind Kejriwal on Friday accused the BJP of creating mountains of garbage in Delhi during their 15-year tenure in the MCD, asserting that people will choose the AAP in the December 4 civic body

"In the last 15 years, BJP has spread garbage everywhere and created mountains of garbage. On December 4, Delhiites will votefor cleanliness. They will vote to make Delhi beautiful. This time, Delhiites will choose the AAP in MCD," Kejriwal said in a tweet in Hindi. Meanwhile, the Delhi BJP on Friday hinted at not repeating its outgoing councilors on at least 60-70 per cent of the wards even as the Congress received over 1,000 applications from ticket seekers. The three major contestants -- the BJP, the AAP and the Congress -- have started working on their strategies and candidate selection for the polls to 250 wards of the Municipal

Corporation of Delhi (MCD), the dates of which are likely to be announced soon.

The Delhi Congress has

already received over 1,000 applications from probables seeking party tickets for the The party will streamline the candidate selection process in back-toback meetings on Saturday and Sunday, according to party unit chief Anil Kumar. Several Delhi BJP leaders said the reports that the party will replace all its sitting councilors with new faces wastechnically incorrect. "With several factors playing out like reduced number of wards, rotation of reserved seats for women and SC candidates and delimitation. almost 60-70 per cent sitting councilors will effectively loose the claim over party ticket,"saidaseniorDelhiBJP leader. Not more than 30 per cent sitting councilors will have the chance to be repeated this time even if the party so decides, he said.

"There were several reasons that necessitated changed faces in a majority

unification of the three municipal corporations earlier this year, the total number of wards was 272 that has now come down to 250 under the MCD," said a senior Delhi BJP leader. Of the 250 wards, there are many that were earlier reserved for women and Scheduled Caste (SC) candidates. "Due to rotation of wards, many of these that were earlier reserved for women or SC have now become general. Vice versa many general wards have become reserved," he added. Delimitation has also affected the voter composition of wards, thereby requiring candidate change for the coming polls, he said. The BJP leaders said two surveys -- one by the central leadership and the other by the Delhi BJP-- are

## Shiv Sena leader Sudhir Suri shot dead in Amritsar

AMRITSAR/CHANDIGARH, NOV 4 /--/ Shiv Sena leader Sudhir Suri was shot dead by unidentified people in Punjab's Amritsar on Friday, police said. The incident took place outside Gopal Mandir on Majitha Road -- one of the busiest places in the city -- where Suri and some other leaders of the party were holding a protest, they said. According to police, more than five shots were fired at Suri after which he fell down and lost consciousness. He was taken to a hospital where he succumbed to bullet injuries. they said. The accused has been arrested and the weapon used in the crime seized, police said. Suri was in the hit lis of several gangsters for a long time and was provided security by the government with around eight Punjab Police personnel being attached with him, they said. Reacting to the incident, Punjab BJP president Ashwani Sharma said the law and order situation has completely broken down in the state. (PTI)

## Delhi, Punjab CMstake responsibility for stubble burning, promise to curb practice by next winter

NEW DELHI, NOV 4 /--/ Delhi chief minister Arvind Kejriwal and his Punjab counterpart Bhagwant Mann on Friday admitted responsibility for paddy straw (Parali) burning in the border state and promised to curb the practice by next winter amid alarming levels of air pollution in the national capital.

Kejriwal said air pollution in the winters was not a "Delhi-specific problem", adding that it affected entire northern India and that there should be no blame game and politics on the issue. He also urged the Centre to take steps to prevent Parali burning, adding it was wrong to hold farmers alone responsible. Thick smog blanketed Delhi as the city's air quality remained in the 'severe' category for the second consecutive day, primarily due to unfavourable meteorological conditions and raging farm fires in Punjab. The overall air quality index (AQI) of Delhi stood at 445 at 2 pm. An AQI of above 400 is considered 'severe' which can affect healthy people and seriously impact those with existing illnesses. "We (AAP) have our government in Punjab and we are responsible if Parali is being burnt there. We accept the responsibility for Parali burning in

"We admit Parali is being put on fire in Punjab but farmers are not responsible for it. The farmers need a solution, they will stop burning Parali the day they have a solution." the Delhi chief minister said in a joint press conference with his Punjab counterpart. Mann said the

address the problem. He promised the issue would be brought under control by next November. Kejriwal said it was not a problem for Delhi alone and the entire north India was suffering from pollution. He claimed the air quality in many cities in Harvana, Rajasthan, Uttar Pradesh and Bihar was in the 'severe' or 'very poor' category. "Evidently, AAP or Kejriwal or (AAP) governments in Delhi and Punjab are not merely responsible for this. There are several reasons, including local and regional ones," he said. Kejriwal also urged the Centre to come forward and take specific steps to save north India from pollution. "We have governments in Punjab and Delhi. This is not the time for pointing fingers, blame games or name calling. It's not the time for politics over such a sensitive issue. It does not produce any solution and people need solutions," the Delhi chief minister said.

'The pollution level is high in many cities in Bihar for which Parali burning cannot be responsible," he said. "Several things, including joint meetings of chief ministers and employing experts for their opinion are needed to address the issue." Kejriwal said several specific and stringent steps would be taken with Punjab farmers. "But we do not want any blame game in this. If Parali is burning in Punjab, we are responsible for it and our government is responsible for it," he said. However, just holding Kejriwal alone responsible for everything and abusing him will not solve the country's pollution problem. It will only happen with a constructive approach and by working together, he added. "The AAP government in Punjab got just six months to address the problem of Parali burning. We need one more year to solve the problem. We will do everything, including management of Parali and crop diversification, to ensure considerable reduction in incidences of Parali burning,'

Mann said the farmers in Punjab did not want to burn Parali as it also affected them and their children. There are 10-12 days between harvesting the paddy crop and sowing the wheat crop and the farmers just have matchsticks, said the Punjab chief minister. He added that the Punjab government had deployed 1.20 lakh machines to bury stubble in the fields and an app was developed for farmers to fetch these. # Himachal: Congpromises pension scheme, financial

KANGRA, NOV 4/--/ Congress leader Priyanka Gandhi Vadra on Friday said her party will provide 1 lakh jobs, restore the Old Pension Scheme and provide financial assistance of Rs 1.500 to every woman in the state if it is voted to power in the upcoming Assembly polls. Addressing a rally here, Priyanka said the Congress will also fight the drug menace, which is ruining the future of the youth and build Englishmedium schools in every Assembly constituency. She also targeted the state government, saying the state has "drowned" in debt under the BJP dispensation and 63,000 government posts are lying vacant. Citing the work done by the Congress in Chhattisgarh and Rajasthan, the only two states where the party is in power on its own, the Congress leader said her party will fulfil its promises in Himachal as well. "The Congress will create 1 lakh jobs... Chhattisgarh chief minister Bhupesh Baghel is sitting here, he has provided 5 lakh jobs in three years. The Congress government in Rajasthan has provided 1.30 lakh jobs," she said.

Today, Chhattisgarh has the lowest unemployment rate. Priyanka added. She said the Congress, if voted to power, will finalise the decision to provide 1 lakh jobs to the youth of Himachal Pradesh in the first cabinet meeting. "We are also saving that we will try our best to provide 5 lakh jobs in five years. This is our guarantee," she stated. Priyanka said the decision to restore the Old Pension Scheme will also be finalisedin the first cabinet meeting if the Congress is voted to power. The Congress leader said she understands the burden shouldered by women, who work at home and outside. "This is why the Congress wants to provide monthly financial assistance of Rs 1,500 to every woman. This scheme is called the 'Har Ghar Lakshmi Yojna'," she said.

Besides, the Congress wants to build four English-medium schools in every Assembly constituency and fight the menace of drugs. Hitting out at the BJP, Priyanka said the party does not want to do anything for the people and works for its selfish interests. The Congress leader claimed 63,000 government posts in Himachal Pradesh have been lying vacant for the last five years and the state has a debt of Rs 70,000 crore. "When we say that we will provide 1 lakh jobs, their (BJP) chief minister says that is it not possible. But when they want to sell the country's assets, PSUs to their corporate friends, it is possible," she said. The BJP says there is no money for restoring the Old Pension Scheme, Priyanka said. "You have waived loans worth Rs 10 lakh crore of big corporates. You had money for that but do not have money for a worker's pension," she asked. Privanka said the Centre has failed to address issues like inflation and has in turn saddled people with more taxes. "The public is asking for freedom from inflation and you say, take GST and more tax. Even the GST on cartons used for packing apples has been increased. This is the answer you get," she said. Organizations which would be eligible for applying for financial assistance under this scheme are Societies registered under the Societies Registration Act, 1860; a public Trust registered under any law for the time being inforce, a private limited non-profit company registered under Section 25 of the Indian Companies Act,1956; Universities/Institutions of higher learning recognized by University Commission(UGC), Training institutes of Central and Government/UT

Panchayati Raj Training institutes and Duly registered Cooperative Societies of Women/ Self Help

The selected organization would have the responsibility to motivate, identify and select women to be trained in accordance with the criteria of the scheme from villages/urban localities having a substantial minority population. The organizations will involve Head of the Gram Panchayat/ Municipal Body/ Local Authority for identification/ selection of women trainees.

The details of the trainees will be submitted by the organization before the start of training through Online Application Management System (OAMS) for NaiRoshni, once the project is approved. Although there will be no annual income bar, a woman/

parent or guardian of woman having annual income not exceeding Rs.2.50 lakh from all sources would be given preference in selection. They should be between the age group of 18 years to 65 years.



## India: A major defence manufacturing hub

The 'Make-in-India' mantra appears to be fast changing to the 'Make-for-World' approach. At least the recent developments in the country's defence sector makes one believe this. India has inked a pact with Airbus Defence and Space to procure 56 C-295 aircraft, worth Rs 21,935 crore, to replace the IAF's ageing Avro-748 planes of 1960's. The first 16 aircraft will be delivered between September 2023 and August 2025 in 'fly-away' condition from Airbus's assembly line in Seville at Spain and the subsequent 40 aircraft will be manufactured by Tata Advanced Systems Ltd (TASL) at Vadodara plant in Gujarat between 2026 to 2031 under a mutual agreement. The C-295 aircraft are special transport aircraft of 5-10 ton capacity with latest technology, has a maximum speed of 480 kmph with a rear ramp door for quick reaction and para-dropping of troops and cargo, capable of short take-off and landing from semi-prepared surfaces and Advanced Landing Grounds (ALGs). The C-295 plane is used for tactical transport of up to 71 troops or 50 paratroopers, for logistic operations to locations that are not accessible to current heavier aircraft, can also be used for casualty or medical evacuation as well as for special missions for disaster response and maritime patrol duties.

With this deal, the Indian private sector has entered into the technology-intensive and highly competitive aviation industry as over 13,400 parts, 4,600 subassemblies and all the seven major component assemblies of the aircraft will be done in India. Only the engines, landing gear and avionics will be provided by Airbus to be integrated at the Vadodara plant which will have capacity of approximately 96% of the work that Airbus does in Spain to produce the plane. It is a matter of strategic importance and pride that for the first time C-295 aircraft will be manufactured outside Europe and subsequently it will be exported to other countries and private players. State-run Bharat Electronics Ltd and Bharat Dynamics Limited will provide an indigenous electronic warfare suite to be fitted in all 56 aircrafts. The project will be capable of generating 600 highly skilled jobs directly, over 3,000 indirect jobs and an additional 3,000 medium-skill employment opportunities with more than 42.5 lakh man-hours of work within the aerospace and defence sector, in addition, approximately 240 engineers will be trained at the Airbus facility in Spain.

Manufacturing of C295 aircraft in Vadodara will not only give strength to the military but it will also create an aerospace ecosystem, a milestone in India's quest for becoming self-reliant in defence as the government of India aims at achieving a turnover of USD 25 Bn including export of USD 5 Bn in Aerospace and Defence goods and services by 2025. India is already exporting defence equipment to 75 countries with defence export growth of 334% achieved in the last five years. India is the 3rd largest military spender in the world, with its defence budget accounting for 2.15% of the country's total GDP. Government has also established two Defence Industrial Corridors in Uttar Pradesh and Tamil Nadu. The Uttar Pradesh Defence Industrial Corridor (UPDIC) has signed 69 MoUs with potential investment of Rs 10,545 crore, and Tamil Nadu Defence Industrial Corridor (TNDIC) 42 MoUs having investment potential of Rs 11,359 crore. These initiatives have reduced the expenditure on defence procurement from foreign sources to 36% from 46% of the overall expenditure in the last four years, a really big achievement by any standards.

## US sanction on Chinese chips threat to global economy

The US has gambled big in its latest, across-the-board sanctions on Chinese companies in the semiconductor industry, believing it can kneecap China and retain its global dominance. From the slogan of globalisation and "free trade" of the neoliberal 90s, it has reverted to good old technology denial regimes followed by the US and its allies during the Cold War. While it might work in the short run in slowing down the Chinese advances, the cost to the US semiconductor industry of losing China - its biggest market will also have significant consequences. In the process, the semiconductor industries of Taiwan and South Korea and equipment manufacturers in Japan and the European Union are likely to become collateral damage. It reminds us again of what Kissinger once said: "To be an enemy of the US is dangerous, but to be a friend is fatal"!

The purpose of the US sanctions, the second generation of sanctions after the earlier one in August 2021, is to restrict China's ability to import advanced computing chips, develop and maintain supercomputers, and manufacture advanced semiconductors. Though its sanctions are cloaked in military terms - denying China access to technology and products that can help China's military - in reality, its sanctions are targeted at almost all leading semiconductor players in China and, therefore, its civilian sector as well. The fiction of "barring military use" is only to provide the fig leaf of a cover under WTO exceptions on having to provide market access to all WTO members.

What are the specific sanctions?

The sanctions also encompass any company that uses US technology or products in its supply chain. This is a provision in the US laws; any company that "touches" the US while manufacturing its products is automatically brought under the US sanctions regime. It is a unilateral extension of US national legal jurisdiction and can be used to punish and crush any entity - a company or any other institution - that is directly or indirectly linked to the US. These sanctions are designed to completely decouple the supply chain of the US and its allies from China.

The other part of the latest US sanctions, apart from specific companies already on the sanctioned list of Chinese companies, is adding 31 companies to an 'unverified list". These companies must provide complete information to the US authorities within two months, without which they will be barred as well. Furthermore, no US citizen or one domiciled in the US can work for those sanctioned or unverified companies, not even to maintain or repair equipment supplied earlier. How big is the global semiconductor industry? What are the likely consequences of the US sanctions?

The semiconductor industry's size is currently more than half a trillion dollars and is likely to double its size to more than one trillion by 2030. According to a Semiconductor Industry Association and Boston Consulting Group Report - Turning the Tide for Semiconductor Manufacturing in the US - China is expected to account for approximately 60 per cent of that

growth, displacing the US as the global leader. This is the immediate trigger for the US sanctions and its attempt to halt China's industry from taking over the lead from the US

While the above measures are intended to isolate China and limit its growth, what is the downside for the US and its allies in sanctioning China? The problem is that for the US, more so for Taiwan and South Korea, China is their biggest trading partner! Imposing such sanctions on equipment and chips also means destroying a good part of their market with no prospect of an immediate replacement. This is true not only for China's East Asian neighbours but also for equipment manufacturers like the Dutch company, the world's only supplier of Extreme Ultra Violet (EUV) lithographic machines. For Taiwan and South Korea, China is not only their biggest export destination for the semiconductor industry but also its other exports as well as its biggest supplier for a range of products. The forcible separation of its supply chain in the semiconductor industry is likely to be accompanied by separation in other sectors

So why has the US started a chip war against China at a time that its ability to win such a war is limited? It can, at best, postpone China's rise as a global peer military power and the world's biggest economy. An explanation lies in what the military historians claim as the Thucydides Trap: when a rising power rivals a dominant military power, most such cases lead to war.

According to Thucydides, the rise of Athens led to Sparta, the dominant military power, then going to war against it, destroying both - therefore, the trap. While such claims have been disputed by other historians, when a dominant military power confronts a rising one, it does increase the chance of either a physical or economic war. If the Thucydides Trap between China and the US restricts itself to only an economic war- the chip war - we should consider ourselves lucky! (IPA)

# Strong laws to protect Encryption the need of the hour

"Encryption safeguards the personal security of billions of people and the national security of countries around the world." The opening statement on the About page of the Global Encryption Coalition ('GEC'), which consists of 180 members from among civil society organisations, companies and individuals, captures the essence of encryption.

Once considered a wartime necessity, encryption has steadily become the technological backbone for secure online communications, digital privacy and protection of national critical information infrastructure ('CII'). Indeed, it is crucial to protect data at a time when data breaches are only increasing.

For instance, the Indian Computer Emergency Response Team ('CERT-In'), a nodal executive agency which monitors cyber security incidents in India, has reported a steady increase in data breaches since 2017, in a response to a question in the RajyaSabha. Section 70 of the Information Technology Act, 2000 ('IT Act') defines CII as a "computer resource, the incapacitation or destruction of which shall have debilitating impact on national security, economy, public health or safety".

Previously, the Union Government has notified the Unique Identification Authority of India-related facilities, assets and infrastructure as CII. Once declared as 'protected system' under section 70, any unauthorised persons accessing these resources may be jailed for up to 10 years, and fined. Nonetheless, vulnerabilities are often exploited by malicious actors. For instance, in June 2021, a personal data breach of millions of public distribution system ('PDS') beneficiaries in Tamil Nadu, including Aadhaar details, was reported, after an online vendor claimed access to nearly 2 terabytes of PDS data on a hacker's

platform and demanded a payment of USD 1,950 in cryptocurrency for handing over the decryption code. Governments and law enforcement agencies ('LEAs') are also increasingly undermining encryption to crimes and criminal communications. This includes the 'going dark' challenge wherein, with strong encryption protecting all kinds of data, criminals use online communications channels to hide their plans and activities. In such cases, LEAs struggle to read investigation-related information and actively oppose encryption. The most worrying of these has been the Five Eyes alliance which is composed of the governments of the United States, the United Kingdom, Canada, Australia and New Zealand. It voices the views of many LEAs in its unequivocal belief that

"privacy is not absolute" A 2020 joint statement released by the Five Eyes, India and Japan goes against not just end-to-end encryption, but also a range of encrypted services available, including device encryption, custom encrypted applications and encryption across integrated platforms, purportedly to deal with potential child sexual abuse material. In another statement, on countering child sexual exploitation and terrorism, it stated that "tech companies should include mechanisms in the design of their encrypted products and services whereby governments, acting with appropriate legal authority, can gain access to data in a readable and usable format.'

Further, since 2019, India is part of an international working group to deal with criminals online which states: "According to the participants, encryption is designed with no means of lawful access; it allows terrorists, drug dealers, child molesters, fraudsters, and other criminals to hide incriminating evidence.

Governments are trying to undermine encryption due to this issue through legislation, such as by introducing stipulations that erode strong end-to-end encryption deployed by many tech companies to protect consumer privacy and the integrity of personal communications. This includes tracing the first originator of messages on instant messaging freeware service Whatsapp. Since there is no way of knowing who may be subject to investigations, companies are required to store all communications in order to ascertain who said what, when they are required to do so. However, broad surveillance adversely impacts anonymity on the internet, access to strong encryption, the issue of traceability, and laws on identifying the first originator of a message. In 2018, Australia enacted the Assistance and Access Act, to allow LEAs access to messages on platforms like WhatsApp and Facebook. It enforced conditions on tech companies and service providers to build surveillance capabilities, such as through push notifications that download malware to a target's computer or phone.



called the "Snoopers Charter" by its critics. The UK Act contains mandatory, broad and secret decryption obligations for service providers. It allows for the U.K. government to order telecommunication providers to remove any electronic protection measure. Thanks to a series of cases by civil society organisations Liberty and Privacy International, the U.K. High Court of Justice found that it is unlawful for British security services like the Security Service, the Secret Intelligence Service and the Government Communications Headquarters, to obtain an individual's communications data from telecom providers without prior independent

investigations. However, it still allows indiscriminate snooping on people irrespective of whether they are suspected of crimes, although this is being appealed. That the Australian law followed the footsteps of the UK Act is hardly unique. A similar trajectory is noticeable with other countries. The first in the series of similar Asian laws came from the People's Republic of China ('PRC') which took the big brother trope to its farthest extent. 

## **SCupholds validity of Employees Pension (Amendment)** Scheme of 2014, quashes Rs 15,000 salary limit

NEW DELHI, NOV 4 /--/ The Supreme Court on Friday upheld the validity of the Employees' Pension (Amendment) Scheme of 2014 but quashed the threshold limit of Rs 15,000 monthly salary for joining

the pension fund.
The 2014 amendment had capped the maximum pensionable salary (basic plus dearness allowance) at Rs 15,000 per month. Prior to the amendment, the maximum pensionable salary was capped at Rs 6,500 a month. A bench of Chief Justice UU

and Sudhanshu Dhulia, however, read down certain provisions of the scheme. Employees who have not exercised the option to join the pension scheme must do so within six months, the bench said. It added that eligible employees who could not join the scheme by the cutoff date should be given an additional chance as there was a lack of clarity on the issue in view of judgments passed by the high courts of Kerala, Rajasthan and Delhi. The bench further held as invalid the condition in the employees to make a further contribution at 1.16 per cent onsalary exceeding Rs 15,000. It held that the condition to an additional make contribution on the salary exceeding the threshold limit to be ultra vires but added that this part of the judgement would be kept in suspension for six months to enable the authorities to generate funds. Employees Provident Fund Organisation and the Centre challenged the verdicts of the high courts of Kerala. Rajasthan and Delhi, which had quashed the 2014

The official said that searches were conducted at the office of another businessperson, who is closely associated with Agarwal, in the posh Salt Lake area. "We started conducting raids from 6.40 am today. Searches are still underway. Our detectives are questioning employees of Agarwal inside his office. Some of our officers are looking for clues at

## **NHRC summons** chief secys of Delhi, 3 neighbouring states over air pollution

NEW DELHI, NOV 4 /--/ Alarmed over the rise in pollution in Delhi-NCR, the National Human Rights Commission (NHRC) has asked the chief secretaries of Punjab, Haryana, Uttar Pradesh and Delhi to appear before it on November 10 to discuss the matter, an official statement said on Friday

The NHRC said it is "not satisfied" with the actions taken so far to address the issue and that "much more" needs to be done to reduce pollution in Delhi. The Air Quality Index (AQI) in Delhi stood at 426 (severe) at 9:30 am on Friday, according to Central Pollution Control Board (CPCB) data. An AQI above 400 is considered 'severe' and can affect healthy people and seriously impact those with existing illnesses. The NHRC asked the chief secretaries to inform it within a week about the steps taken by their respective governments to stop stubble burning. "Their reports must also inform about the effect of smog towers and anti-smog guns. It should also have information on how many antismog guns are operational and what further steps the Delhi and other governments are taking in the near future. "The report of Punjab and Haryana must also specifically inform about the effect of the scheme of in-situ management of crop residue," the NHRC statement said.

The commission said its directions follow a report and material on record received from the Union ministry of environment, forest and climate change (MoEF&CC) in response to a notice issued by it on June 22. It said it had issued the notice after taking suo motu cognisance of media reports alleging that air pollution is a great threat to human health in India and might reduce life expectancy for the people of Delhi. "The commission has noted the measures taken so far but observed that these are not enough to reduce the pollution level in Delhi-NCR. It is of the considered view that much more needs to be done to reduce the pollution level immediately," the statement said. Despite several directions from time to time, "nothing much has improved". One of the major causes of air pollution in the Delhi-NCR region is stubble burning in the states surrounding it, it said. The NHRC further stated that "notwithstanding several directions of the Supreme Court, the National Green Tribunal and other authorities, the air quality in Delhi-NCR has not seen required improvement for a human-friendly environment, which cannot be allowed to remain so perpetually". As many as 31 out of the 36 monitoring stations in Delhi recorded 'severe' AQI, the CPCB data at 9:10 am showed. Delhi's 24-hour average AQI stood at 450 at 4 pm on Thursday, just a notch short of the 'severe plus' category. (PTI)

## Delhi govt orders 50 per cent of staff to work from home, asks private offices to follow suit

#### Primary schools to be closed from today

NEW DELHI, NOV 4 /--/ Alarmed by hazardous pollution levels in Delhi, environment minister Gopal Rai on Friday ordered 50 per cent staff of the Delhi government to work from home and said an advisory will be issued to private offices to follow suit.

Earlier in the day, chief minister Arvind Kejriwal said primary schools will be closed from Saturday in a bid to protect children from the effects of worsening air quality. At a press conference, Rai said schools will be asked to curtail outdoor activities of senior students. He said the Delhi government has decided to implement the anti-pollution curbs recommended by the Commission for Air Quality Management (CAQM), including a ban on non-BS VI diesel-run light motor vehicles. "At a meeting with departments concerned, it has been decided that 50 per cent staff of government offices will work from home from Monday and an advisory will be issued to private offices to follow suit," Rai said. In a bid to ramp up public transport, the government will also launch 'Paryavaran Bus Service' which will include 500 privately-run CNG buses. Rai said a six-member panel chaired by the special commissioner, transport, has been set up to monitor the implementation of curbs on anti-polluting activities. It will have two members each from the transport department, traffic police and the Delhi Pollution Control Committee. Revenue commissioners have been asked to prepare a plan for staggered timings of markets and offices. The Delhi government will request Haryana and Uttar Pradesh to divert trucks from the entry point of peripheral expressways around Delhi. Resident welfare associations will be asked to provide electric heaters to security staff to prevent burning of coal and firewood.

Special task forces will be constituted to curb air pollution at hotspots. Thirteen teams of the DPCC will monitor industrial areas, Rai said. The minister said the oddeven car rationing scheme will be implemented if need arises and discussions on it are on. According to a study conducted by The Energy and Resources Institute in 2018, vehicular emissions account for around 40 per cent of the PM 2.5

#### Air quality remains in 'severe' zone for 2nd consecutive day

NEW DELHI, NOV 4 /--/ A thick layer of smog blanketed Delhi on Friday as the city's air quality remained in the "severe" zone for the second consecutive day, primarily due to unfavourable meteorological conditions and raging farm fires in Punjab. At 4 pm, Delhi's 24-hour average Air Quality Index (AQI) stood at 447. The concentration of lung-damaging fine particles, known as PM2.5, was above 470 micrograms per cubic metre, around eight times above the safe limit of 60 micrograms per cubic metre, in many areas. An AQI of above 400 is considered "severe' and can affect healthy people and seriously impact those with existing illnesses. Almost all the monitoring stations in the capital reported "severe" air quality, including 13 that logged an AQI of more than 450. According to the World Health Organisation (WHO), a 24-hour average PM2.5 concentration of up to 15 micrograms per cubic metre is considered safe. According to a study conducted by The Energy and Resources Institute in 2018, vehicular emissions account for around 40 per cent of the PM2.5 pollution in the capital. The maximum temperature settled at 31.3 degrees Celsius while the minimum temperature was recorded at 16.5 degrees Celsius, a notch below normal, the weather office said. The relative humidity oscillated between 96 per cent and 53 per cent throughout the day, the weather office said. "There would be a partly cloudy sky on Saturday with shallow fog in the morning. The maximum and minimum temperatures are likely to hover around 30 and 16 degrees Celsius respectively," an India Meteorological Department (IMD) official said. Delhi's 24-hour average AQI had jumped to 450, just a notch short of the "severe plus" category, on Thursday, prompting the authorities to invoke the final stage of anti-pollution curbs under the Graded Response Action Plan (GRAP), including a ban on non-BS VI diesel-run light motor vehicles. The entry of trucks in Delhi other than those run on electric and CNG is banned too. The trucks carrying essential commodities are exempted.

Khan suffered a bullet injury on the right leg when two gunmen man fired a volley of bullets at him and others mounting on a container-mounted truck in the Wazirabad area of Punjab province, where he was leading a protest march against the Shehbaz Sharif government. The former Prime Minister described the attack on his life and said he was on the container when a "burst of bullets" was directed at him, causing him to

get shot in the leg and fall down. "Then a second burst comes, there were two people," he said, narrating the incident. Khan, who was ousted from power in April after losing a no-confidence vote in his leadership, has talked about a 'threat letter' from the US and claimed that it was part of a foreign conspiracy to remove him as he was not acceptable for following an independent foreign policy. The US has bluntly rejected the allegations. He has been demanding early elections and he is leading the long march towards Islamabad to force his demands. The term of the National Assembly will end in August 2023 and fresh elections should be held within 60 days. (PTI)

MUMBAI, NOV 4 /--/ India and the United Kingdom are set up for the "final ascent" on signing a Free Trade Agreement (FTA) and expediting the pact in the next few months is one of the main aims of the two sides, British High Commissioner to India Alex Ellis said on Friday. Ellis said the two sides have got through the majority of the negotiations, but there are "tough issues" like the security of investments of British companies where some in the past had found difficulty in regard to the nowscrapped retrospective tax, in an apparent reference to the long-drawn Vodafone case. On extradition to India of economic fugitives like Vijay Mallya and Nirav Modi, Ellis said it is no longer a government matter. The

British home secretary had signed the extradition of businessman Mallya over three years ago and it is the issue that now lies with the court, he said. "The wheels of justice turn slowly, but they do turn," he said at the India Today Conclave here. Mallya, accused of cheating and fraud in India, has been declared a proclaimed offender by a Mumbai court. India and Britain launched negotiations for a free trade agreement (FTA) in January with an aim to conclude talks by Diwali (October-end), but the deadline was missed due to a lack of consensus on several issues. Ellis drew a parallel to the signing of the FTA to long climb up a mountain. "We have walked up the valley. We have now got up to the base camp. And now what we have to do a

short and steep ascent. That's tough and it requires trust on both sides. We got to adapt. We have got through the majority of the negotiations already



and now we are set up for the final ascent," said the High Commissioner. The long-pending FTA issue was also discussed during an interaction between Prime Minister Narendra Modi and his UK counterpart Rishi Sunak, who took charge of his new responsibility late last month. "So I think there will be a push and when the two prime ministers spoke last week, almost immediately after Rishi Sunak became Prime Minister, they agreed this is one of the main aims for the next few months," Ellis said in response to a question on by when he thinks the negotiations will be completed and the agreement signed.

Stressing that FTA will deliver growth and jobs in both the countries, he said any trade agreement comes down to balance and added the UK wants access to the goods market in India which has high tariffs. India, too, would also like to access the UK

market, said the British envoy. The High Commissioner said India nationals topped visas for students, overtaking China this year, and 45 per cent of skilled workers coming into his country on a visa were from India. On Russia's invasion of Ukraine, which has entered its ninth month. Ellis termed it as unjustified and said it is a matter that affects the entire world. High prices of fertilisers, oil and energy are affecting every country, he said. The British envoy said NATO (North Atlantic Treaty Organization) countries are allowing Ukraine to defend itself from territorial aggression, "a military invasion that is unjustified, unwarranted and deeply harmful to everybody".(PTI)

## Iran marks 1979 US **Embassy takeover amid** nationwide protests

DUBAI, NOV 4 /--/Iran on Friday marked the 1979 takeover of the US Embassy in Tehran as its theocracy faces nationwide protests after the death of a 22-year-old woman earlier arrested by the country's morality police.

Iranian state-run television aired live feeds of various commemorations around the country, with some in Tehran waving placards of the triangle-shaped Iranian drones Russia now uses to strike targets in its war on Ukraine, But while crowds in Tehran looked large with chador-wearing women waving the Islamic Republic's flag, other commemorations in the country appeared smaller, with only a few dozen people taking part. Iran's hard-line President Ebrahim Raisi, speaking to people gathered in front of the former US Embassy, criticised those protesting the theocracy. "Anyone taking the smallest step in the direction of breaching security and riots, must know that they are stepping in the direction of enemies of the Islamic Revolution," he said. Americans think they can execute the plan they carried out in some countries like Syria and Libya here. What a false dream! Those at the commemoration also waved effigies of French President Emmanuel Macron and Saudi Crown Prince Mohammed bin Salman. Signs and chants from the crowd called out: Death to America! Death

The demonstrations that have convulsed Iran for more than six weeks after the death of Mahsa Amini mark one of the biggest challenges to the country's clerical rulers since they seized power in the 1979 Islamic Revolution.

At least 300 protesters have been killed and 14,000 arrested since the unrest began, according to a Human Rights Activists in Iran, a group that's been monitoring the crackdown on demonstrators. Iran's government has not offered an overall death toll, with one state newspaper even making the counterfactual claim that no one had been killed by security forces over the 49 days of protests. Later on Friday, protests began in Iran's southeastern Sistan and Baluchestan province, which has seen weeks of unrest. Online videos purported to show people marching in the streets, with the crackle of gunfire in the background. Some protesters appeared bloodied. It wasn't immediately clear how many people had been injured. A Shiite cleric reportedly was shot dead on Thursday in Sistan and Baluchestan, a long restive province that's predominantly Sunni. Hard-liners within Iran long have bussed government workers and others into such November 4 demonstrations, which have a carnival-like feel for the students and others taking part on Taleqani Street in downtown Tehran. This year, however, it remained clear Iran's theocracy hopes to energize its hardline base. Some signs read We Are Obedient To The Leader, referring to 83year-old Supreme Leader Ayatollah Ali Khamenei, who has final say over all matters of state in the country.

The weeks long demonstrations have included cries calling for Khamenei's death and the overthrow of the government. The annual commemoration marks when student demonstrators climbed over the fence at the embassy on November 4, 1979, angered by then-President Jimmy Carter allowing the fatally ill Shah Mohammad Reza Pahlavi to receive cancer treatment in the United States. The students soon took over the entire, leafy compound. A few staffers fled and hid in the home of the Canadian ambassador to Iran before escaping the country with the help of the CIA, a story dramatized in the 2012 film Argo.

The 444-day crisis transfixed America, as nightly images of blindfolded hostages played on television sets across the nation. Iran finally let all the captives go the day Carter left office on Ronald Reagan's inauguration day in 1981. That enmity between Iran and the US has ebbed and surged over the decades since. The US and world powers reached a nuclear deal with Iran in 2015 that drastically curtailed its program in exchange for the lifting of international sanctions.

However, then-President Donald Trump unilaterally withdrew from the deal in 2018, sparking years of tensions since. Late Thursday in California at a rally before the US mid-term elections, President Joe Biden also stopped his speech to address a crowd that held up cellphones displaying the message FREE IRAN. # Bid on Imran's life: Spectre of political assassinations continues to haunt Pak

ISLAMABAD, NOV 4 /--/ The shootings and terrorist attacks for more than seven decades have taken the lives of several politicians in Pakistan, with former premier Imran Khan becoming the latest to join the long list of leaders who faced assassination bids.

October 16, 1951, stands out in the history of Pakistan as a date when the first prime minister of the country, Liaquat Ali Khan, was shot dead during a public rally in Rawalpindi's Company Gardens, damaging the foundations of a fragile democratic structure of the newly-born nation. The bullets fired in 1951 at the Company Gardens, later renamed Liaquat Bagh, led to the first major assassination but, unfortunately, it was not the last attempt as the Pakistan Tehreek-e-Insaf (PTI) chairman has become the latest to join the long list of politicians, who have faced such attacks. Such attacks which have continued with frequent intervals for more than seven decades took the lives of several politicians, including former premier Benazir Bhutto, her brother Mir Murtaza Bhutto, Gujrat's Chaudhry Zahoor Elahi, Punjab's former home minister Shuja Khanzada and ex-minister for minorities Shahbaz Bhatti.

Several others, including Khyber-Pakhtunkhwa (KPK) Assembly member and Awami National Party's Bashir Ahmed Bilour and his son Haroon Bilour: religious scholar and ex-senator Maulana Samiul Haq; Muttahida Qaumi Movement's Syed Ali Raza Abidi; and PTI's Sardar Soran Singh were also killed in such attacks. Just like Khan, the Pakistan Muslim League (Nawaz)'s incumbent Planning Minister Ahsan Iqbal has also survived an assassination attempt. Benazir was assasinated on December 27, 2007 by a suicide bomber when she had just finished an election rally in Rawalpindi. Her brother was shot dead along with six associates in a police encounter near his home in Karachi on September 20, 1996, during her tenure.

On March 2, 2011, gunmen killed Bhatti, who spoke about blasphemy law and championed the rights of the country's beleaguered minorities. Singh was gunned down in a targeted attack near his house on April 22, 2016. The attacks have continued in the country and scarred the consciousness of the nation. The spectre of political assassinations continues to haunt Pakistan. The flames have not yet been extinguished and the wounds are still gaping, The Express Tribune newspaper reported. We haven't learnt any lesson from the past. In fact, the frequency of violent

attacks has increased, the paper

guoted Ahmed Bilal Mehboob, the president of the Pakistan Institute of Legislative Development and Transparency (PILDAT), as saying. He said that there had hardly been any plan chalked out to carry out politics in an organised and civilised manner.

The PILDAT president recalled that the only serious effort to deal with violent and extremist

Commenting on the attack on Khan, he said that the reaction over the incident suggested that the tragedy would be used for political gains as the statements from the party leadership did not carry a reconciliatory tone, which could help in putting out the fire of

intolerance and polarisation. Analysts, while regretting that polarisation was at its peak, said the political leadership as well as the nation would have to come together to take meaningful action to prevent such attacks. They added that attempts were also required to cool down the political temperature. Regardless of the political affiliation and differences, they emphasised a dire need to sit together as violent attacks leading to assassinations were sending a shocking message to the world. (PTI)

#### Attack on Imran Khan: Pak police arrest 2 more suspects

LAHORE, NOV 4 /--/Police in Pakistan's Punjab province have arrested two more suspects, who they believe had sold the pistol and bullets for PKR 20,000 to Naveed Mohammad Basheer, the assailant who tried to assassinate former premier Imran Khan during a political rally, according to a media report on Friday.

Khan, 70, suffered a bullet injury in the right leg on Thursday, when Basheer fired a volley of bullets at him in the Punjab province, where he was leading a protest march against the government. Basheer later confessed that he attacked Khan because "he was trying to mislead the public." Police sources said that two other suspects Wagas and Sajid Butt sold Basheer a pistol and bullets for PKR 20,000, adding that the pistol did not have a number or license, Geo.tv reported. They were arrested from Wazirabad in Punjab

province, the report said, quoting police sources According to eyewitnesses, Basheer fired on the containermounted truck carrying Khan from a close range. Khan was shifted by road to his own-built Shaukat Khanum medical facility in Lahore where an operation was performed and was stable after it, according to his party. His party said he is stable now, adding that he was determined to continue his protest march. (PTI)

#### Multidisciplinary experts across countries reach consensus on ending Covid as public health threat

governments have moved on, specific efforts and resources are still required to save lives as SARS-CoV-2 continues to circulate among us, a new study has said.

Focus on saving lives through continued efforts and resources is one of the six main themes for action identified by a large panel of multidisciplinary experts from over 100 countries to recommend actions to end Covid-19 as a public health threat. Three of the highest-ranked recommendations are adopting a whole-of-society strategy that involves multiple disciplines, sectors and actors to avoid fragmented efforts; adopting whole-of-government approaches (e.g.

coordination between ministries) to identify, review, and address resilience in health systems and make them more responsive to people's needs; and maintaining a vaccines-plus approach, which includes combination of Covid-19 vaccination, other

structural and behavioural prevention measures, treatment, and financial support measures.

The panellists also prioritised recommendations for developing technologies, such as vaccines, therapies and services, that can reach target populations. Other recommendations by the study, published in the journal Nature, with at least 99 per cent agreement are communicating effectively with the public, rebuilding public trust, and engaging communities in managing the pandemic response, the study said. Only six recommendations had more than 5 per cent disagreement including one which considers further economic incentives to address vaccine hesitancy or a symptoms approach to diagnose Covid-19 in settings with low access to testing, it said. It added that over 180 organisations from 72 countries have already endorsed the findings of the consensus study, which was led by the Barcelona Institute for Global Health (ISGlobal), an institution supported by "la Caixa" Foundation, a not-for-profit banking foundation based in Catalonia, Spain.

The 57 recommendations are directed at governments, health systems, industry, and other key stakeholders. "To the greatest

LONDON, NOV 4 /--/Although some degree possible, our results place emphasis recommendations that can be implemented in months, not years, to help bring this public health threat to an end," says Quique Bassat, co-author of the study and member of the University of Barcelona, "Our study does echo some earlier recommendations, such as the Independent Panel for Pandemic Preparedness and Response and WHO's 2022 plan on Strategic Preparedness," said Jeffrey V Lazarus, coordinator of the study. "But what makes this work unique is the very large number of experts consulted, the wide geographical representation and the study design, which emphasises consensus

building and identifies areas of disagreement. It may prove to be a model for developing responses to future global health emergencies," he said. To develop a global consensus on how to address these issues going forward, Lazarus and his colleagues carried out a

Delphi study, a well-established research methodology that challenges experts to garner consensus on answers to complex research questions.

The Delphi technique, in the health sciences, relies on a panel of experts and is primarily used by researchers when the available knowledge is incomplete or subject to uncertainty and other methods that provide higher levels of evidence cannot be used. The aim of the method is to collect expert-based judgements and often use them to identify consensus. A multidisciplinary panel of 386 academic, health, NGO, government and other experts from 112 countries and territories took part in three rounds of structured consultation. The result is a set of 41 statements and 57 recommendations across six major areas -communication, health vaccination, prevention, treatment and care, and inequities. As of October 2022, more than 630 million Covid-19 cases and over 6.5 million deaths were reported, although the real death toll has been estimated to be upwards of 20 million. "Each country has responded differently, and often inadequately, which is partly due to a serious lack of coordination and clear goals,"

said Lazarus. (PTI)



Williamson perished in the 19th as his pull shot off Little did not get the desired elevation. New Zealand were set to

pegged them back by conceding only 12 runs in the last two overs. New Zealand on Friday became the first team to book a semifinal berth in the T20 World Cup after Australia were restricted to 168-8 by Afghanistan in a crucial game here. After New Zealand beat Ireland by 35 runs in their final super 12 defending group, champions Australia needed to win against Afghanistan by improbable 185 runs to overtake the net runrate of their Trans-Tasman rivals. The hosts, however, scored 168 for 8 after being invited to bat by Afghanistan, paving the way for New Zealand to qualify for the knockout stage. Australia now will need to limit Afghanistan to 106 or lower to stay alive in the semifinal race, which also involves England. The win over Ireland saw New Zealand grab the top spot with seven points and a net runrate of +2.113. England (5 points), who will take on Sri Lanka in their final super 12 game are currently in the second spot with a runrate of +0.547. Australia are placed third, also with five points but with a runrate of -0.304 If they can restrict Afghanistan to 106 or lower, they can get past England's NRR. New Zealand, led by Kane Williamson, began their campaign in the T20 showpiece with dominating 89-run win over Australia, before thrashing Sri Lanka by 65 runs following a washout against Afghanistan. Their only loss was against England by 20 runs at Gabba in Brisbane. New Zealand had reached the final of the last edition, where they lost to Australia by eight wickets.





#### cross 200 but Ireland FIFA urges World Cup teams to focus on football in Qatar over politics

ZURICH, NOV 4 /--/ Football top officials have urged the 32 teams preparing for the most political World Cup in the modern era to focus on the game in Qatar and avoid handing out lessons in morality. A letter urging teams to "let football take center stage" was sent by FIFA president Gianni Infantino and secretary general Fatma Samoura ahead of intense media focus on coaches and players when World Cup squads are announced next week. "Please, let's now focus on the football!" Infantino and Samoura wrote, asking the 32 football federations to "not allow football to be dragged into every ideological or political battle that exists." Qatar being picked in 2010 as World Cup host sparked scrutiny on its treatment of low-paid migrant workers needed to build projects costing tens of billions of dollars and its laws criminalising same-sex relationships.

Eight European teams have committed to their captains wearing heart-shaped armbands — in breach of FIFA rules — to support an anti-discrimination campaign. Several coaches and federations have backed calls to create a compensation fund for migrant workers' families. Denmark's squad is taking a black team jersey as a sign of "mourning" for those who died in Qatar. Iran has also faced calls to be removed before they play England in the second game of the World Cup on 21 November in a group that also includes the United States. Iranian fan groups want the federation suspended for discriminating against women,



from the World Cup for human rights violations and supplying the Russian military with weapons. "We know football does not live in a vacuum and we are equally aware that there are many challenges and difficulties of a political nature all around the world," the FIFA leaders wrote in their letter Thursday that did not address or identify any specific issue. "At FIFA, we try to respect all opinions and beliefs, without handing out moral lessons to the rest of the world. One of the great strengths of the world is indeed its very diversity, and if inclusion means anything, it means having respect for that diversity. Infantino and Samoura added: "No one people or culture or nation is 'better' than any promises made by Qatar, including by its Emir at the United Nations general assembly in New York in "regardless of origin, background, religion, gender, sexual visitors are expected in Qatar during the 29 November - 18

The T20 series against the West Indies was scheduled in January 2023 but will now be held in early 2024. 'Centrally contracted and non contracted players can now make themselves available for the SA league and also other leagues being held during this time frame excepting the Emirates league," an official source said. He said PCB changed its mind after the South African board had announced that each of the six franchises can now sign an extra wildcard player after the players auction was completed few weeks back.
