In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, read with Government of India, Ministry of Home Affairs, New Delhi Notification No.14/3/60-ANL dated 11.04.1960, and in supersession of Administration's Notification No. 98/90/F. No. 42-276/89-TR dated 23.05.1990, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands hereby makes the following rules regulating the method of recruitment to the group 'C' Non-Gazetted posts of **Chargeman (Mooring), Tindal Serang, Lascar (Mooring) and Boat Builder (Mooring)** in the Directorate of Shipping Services, Andaman & Nicobar Administration, namely:-

1. SHORT TITLE AND COMMENCEMENT:

- (i) These Rules may be called the Andaman & Nicobar Administration (Chargeman (Mooring), Tindal Serang, Lascar (Mooring) and Boat Builder (Mooring) in the Directorate of Shipping Services) Recruitment Rules, 2021.
- (ii) They shall come into force on the date of their publication in the Official Gazette.

2. NUMBEROF POSTS, CLASSIFICATION AND SCALE OF PAY:

Where the Lieutenant Governor (Administrator), Andaman and Nicobar Islands is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing, relax any of the provision of these rules with respect of any class or category of persons.

6. SAVINGS:

Nothing in these rules shall effect reservation, relaxation of age limit any other concessions required to be provided for candidates belonging to Scheduled Caste, Schedule Tribe and other specified categories of persons in accordance with the Orders issued by the Central Government from time to time in this regard.
