Port Blair, Dec. 21 Pradhan Mantri MUDRA Yojana (PMMY) is being implemented in letter & spirit by banks in these Islands. Mudra Yojana, a loan scheme initiated by the Government of India to offer loan amount up to Rs. 10 lakh for individuals and MSMEs to start their new business or for existing businesses, without submitting



any collateral or security was launched by the Hon'ble Prime Minister in 2015 for providing loans up to 10 lakh to the non-corporate, small/micro enterprises including Allied to Agriculture Sector. These loans are classified as MUDRA

loans under PMMY. Under the aegis of PMMY, MUDRA has created three products namely 'Shishu', 'Kishore' and 'Tarun' to signify the stage of growth/development and funding needs of the beneficiary micro unit/entrepreneur and

also provide a reference point for the next phase of graduation/growth.

In A&N Islands, under the Shishu loan scheme, 119 beneficiaries were disbursed loan amounting to Rs. 0.31 crores. Similarly, under the Kishore loan scheme, 448 beneficiaries were disbursed loan amounting to 13.22 crores while under

Certificates, thereby flouting the norms and wreaking havoc on the environment. As per Rule 115(7) of Central Motor Vehicle Rule, 1989, it is mandatory for all the vehicles plying on road must have an updated PUC

Certificate. Violators who are plying without following pollution norms shall attract penalty of Rs.10000 as per section 190(2) of the Motor Vehicles Act, 1988. In this regard, all concerned have been advised to get

their vehicle checked for smoke emission and keep a copy of PUC Certificate in the vehicle.

India loses 3-5 to Japan in semi-final of Asian Champions Trophy men's hockey tournament

Dhaka, Dec. 21

Defending champions India today suffered a 3-5 defeat against Japan in the semi-final of the Asian Champions Trophy men's hockey tournament at Dhaka. Japan started off with a flurry of attacks and penalty corners before gaining a two-goal cushion. The Indians fought back with a

goal at the start of the second quarter but a penalty stroke towards the end helped Japan to maintain the two-goal lead.

Later, a lapse in defence of the Indian side led to the fourth goal before Japan made it 5-1 towards the end of the third quarter. The intense fourth quarter was

marked by Harmanpreet Singh, who scored one to reduce the deficit. A Penalty corner rebound helped India to net one more goal but their unbeaten run ended with the loss versus Japan. After the defeat, India will face Pakistan for the bronze medal play-off and Japan will face South Korea in the final.
