Defaulters spared by PBMC

Serves preferential 'kindness' to 'fortunate' few

PORT BLAIR, NOV 20/--/While the Port Blair Municipal Council (PBMC) never delays in taking stringent action on small shop owners, failing to pay rents of shops owned by the Municipal Council, there are hundreds of 'surprisingly' fortunate ones who are running their offices on assets/

buildings allotted by the Municipal

Council and have defaulted to pay their

rents for the past many years. The civic

body is suffering loss to the tune of several

crores for non-payment of rents by a few

who have been allotted office/assets by

the Council. Surprisingly, the Municipal

Council on the one hand shows no mercy to

the petty shop owners threatening them eviction for not paying rents on time, at the same time, the Municipal Council takes a complete U-Turn when it comes to taking action on the selected few who have not paid rent to the Council for the past many years, causing loss to the tune of several crores to the Council. The Civic Body seems in no hurry to initiate action against defaulters,

who are allegedly having links with elected members of the Council. Despite nonpayment of rents for many years, the PBMC allowing the defaulters to keep the municipal assets in their possession. In such glaring example, the PBMC has maintained complete Priyadarshani Mahila

Mandal located near Jama Masjid at Aberdeen Bazaar. This

mahilamandal is housed in the municipal property and for the past many years, PriyadarshaniMahilaMandal has not paid rent to the tune of over Rs 2. 35 lakh to the Council. The building housing the PriyadarshaniMahilaMandal on the first floor near Jama Masjid at Aberdeen Bazaar was constructed under the MPLAD Fund and allotted to a former woman Councillor sometime in the year 2000 for carrying out activities related to the welfare of the women community. Sources told EOI that were served to PriyadarshaniMahilaMandal to clear their dues. But despite not clearing their dues/

rents, PBMC has failed to initiate action on the so-called MahilaMandal for not clearing the municipal dues. As of now, Priyadarshani MahilaMandal has to pay accumulated rent to the tune of over Rs 2.35 lakhs to the Municipal Council. The amazing part of the story is though PriyadarshiniMahilaMandal is allotted to a former

Municipal Councillor, actually this MahilaMandal is run by a male who has not even cared to respond to the notices of the Municipal Council. Inside

sources said that this is just the tip of the iceberg. The PBMC is still unaware of its properties and lands that were leased decades ago. Some private individuals has been taking advantage of flaws and are using the land and properties of the PBMC for commercial purposes and individual gains. PBMC officials have never made any field visit to inspect or check it out whether the municipal properties given on rental basis are being used for the purpose for which it has been allotted or not. Many of the shop owners without seeking permission from the PBMC have altered the municipal properties allotted to them on rent as per their own needs and

requirements basis, a gross violation to the agreement. The Priyadarshani Mahila Mandal is leading from the front when it comes to violating the Municipal rules. The Municipal asset has also been altered without permission of the Council by constructing a kitchen and illegal extension of the building. The sign board mentioning Priyadarshani Mahila Mandal has been removed deliberately so that

nobody knows about the MahilaMandal, opening scope for other activities. Besides, nearby residents have been complaining that people are staying in this municipal property, converting it as their homes. The most surprising part is that except activities related to the welfare of women, this municipal property is used for all other unauthorized purposes, including turning this office into an election hub during the



Don't vote for those who want to stop welfare work: Kejriwal to Delhiites ahead of MCD polls

NEW DELHI, NOV 20 /--/ Delhi chief minister Arvind Kejriwal on Sunday urged people not to vote for those in the upcoming municipal polls who want to stop the development and welfare work in the national capital.

Addressing a public meeting in Paharganj here, Kejriwal said though his government improved schools and hospitals, it could not do much on the sanitation front as the responsibility lies with the Municipal Corporation of Delhi (MCD). The chief minister alleged that the BJP, which has ruled the civic body for 15 years and is seeking a fourth term, is planning to create another garbage mountain in Delhi. The Delhi chief minister was accompanied by his deputy Manish Sisodia. "Do not vote for those who want to stop the development and welfare work in Delhi," Kejriwal said in an apparent reference to the BJP.

"During our tenure, we improved schools and hospitals, provided free electricity and water besides installing CCTVs and building mohalla clinics. But we feel sad that we could not do anything to improve sanitation as it is the responsibility of the MCD. "Give us one chance to clean



Delhi and we will deliver results," he added. Targeting the BJP, Kejriwal said the party has "deployed LG sahab to stop my work". "You have to support those who do the work and develop Delhi," he told the gathering. The chief minister said the BJP is "planning" to create another garbage mountain at Basant Road.

"They (BJP) will collect garbage from Karol Bagh and throw it on Basant Road. There will be a garbage mountain within a year. There will be a foul smell in the entire area, and mosquitoes and flies will breed at the landfill site. "I guarantee you that we will not let them create a garbage mountain at any cost," Kejriwal said. The national capital has three landfill sites -- Ghazipur, Bhalswa and Okhla. As part of its campaign for the December 4 MCD polls, Kejriwal's Aam Aadmi Party (AAP) had repeatedly targeted the BJP over its "failure" to clear the landfill sites during its 15-year tenure in the municipal corporation.

Over the years, fires have broken out at these dumping yards which have tonnes of legacy waste, leaving neighbouring areas shrouded in smoke for days. The chief minister also alleged a "conspiracy" by the BJP to stop the free power supply in Delhi. "But Kejriwal will not let them succeed," he said. Kejriwal exuded confidence that the A AP will oust the B.IP from the MCD this time. "We will win the MCD polls," the CM said, adding, "You gave me 67 out of the 70 seats in the assembly elections. I am fond of the taste of such victories. I do not want anything less than

Circumstantial evidence, forensic exam key in Mehrauli murder probe: Experts

Aaftab Amin Poonawala, for the murder of Shradha Walkar but it remains a challenge as the crime was detected after nearly six months.

Circumstantial evidence and forensic examination hold the key in such cases, according to experts here. Poonawala allegedly strangled his live-in partner Walkar, 27, and sawed her body into 35 pieces which he kept in a 300-litre fridge for almost three weeks at his house in Mehrauli before dumping them across the city over several days past

midnight. Noting that it is a sixmonth-old murder, former Delhi Police commissioner S N Shrivastava said the scene of crime has been cleaned up and police are basically depending on the confession of the accused, who seems to be a "clever" person. "It is going to be a very difficult case and will require the help of all organs of the criminal

The police have so far recovered 13 body parts, which are mostly skeletal remains, but the weapon used to chop her body is yet to be recovered, even as searches continue in the forest areas of Mehrauli and other parts of Delhi, and Gurugram. Shrivastava said since Poonawala did a lot of research on how to kill, dispose body and destroy evidence: it is possible he had also researched on how to "fool" the police. On November 17, a Delhi court granted permission to the police to conduct a nacro analysis test on Poonawala. The test will be conducted at Dr Baba Saheb Ambedkar Hospitalhere in Rohini, most likely on Monday as Poonawala's five-day police custody ends the next day. Officers are of the view that it even though it will not be admissible in court, the test could lead to some crucial

Another retired Delhi Police chief, who requested forensic science needs to be not to be named, said: "On the taken in this case, and if the basis of the narco analysis test, if the police recovered something, it is relevant. Confession is not admissible, but it is an aid to the investigator." Stressing that circumstantial evidence will play a crucial role in establishing the guilt of the accused, a serving Delhi Police officer said since the accused and Shradha were in a live-in relationship, the case would be strengthened by forensic evidence and DNA samples of the recovered body parts. "Even if the DNA of one of those partsmatcheswiththatofher kin, it will be enough to prove his guilt. The police are conducting searches and he is being taken along, so those things will also be used in court. The fact that he gave different versions to different people about Shraddha will also go against him," the officer said.

Shrivastava said the case would be a test for the

evidence to firm up the case forensics department because a lot depends on it. "The best-possible help of accused gets off scot-free, that will be the failure of the criminal justice system of which the police, courts and forensics all are part of." he said. Blast in autorickshaw: Karnataka CM says suspect had terror links

BALLARI, NOV 20 /--/ Karnataka chief minister Basavaraj Bommai on Sunday said the suspect who allegedly carried out a bomb explosion in Mangaluru had terror links as he had travelled to various places including Coimbatore in neighbouring Tamil Nadu.

According to the preliminary information, it was an LED-linked instrument, the chief minister told reporters here. The blast occurred on Saturday evening inside an autorickshaw, near a police station. leaving the passenger and the driver injured. Both have been admitted to hospital. According to police sources, a cooker fitted with detonator, wires and batteries were used to trigger the blast. After the explosion, the interiors of the autorickshaw were badly damaged. "When the antecedents of the suspect are carried out, it becomes very apparent that the name mentioned in the Aadhaar card found from the spot was different from the person who was carrying it. The suspect had a duplicate Aadhaar card. It had a Hubballi address," Bommai said. The chief minister said more details emerged when the police tracked the original address of the suspect and the locations where he had stayed. "Prima facie, this is a terror act. The places he had travelled to such as Coimbatore or any other places clearly point to his terror link.

The chief minister added that the National Investigation Agency (NIA) and Intelligence Bureau (IB) officials have also joined the state police in investigating the matter. A four-member team of the NIA has arrived at the spot and is coordinating with the police. "The suspect is in the hospital. After he regains consciousness, further investigation will be taken up. Investigation will reveal more details. There is a wide network which will be busted." he said. When his attention was drawn towards the fact that the incident occurred on the day he was in Mangaluru, the Chief Minister said he had attended the programme in the coastal city and returned from there at 3 pm whereas the blast happened after that. Regarding the terror incident's link with the banned outfit Popular Front of India, Bommai said the investigation will reveal the truth.

Meanwhile, police sources said the suspect had obtained a mobile SIM card using the fake Aadhaar card, which was found from the site of explosion. That SIM card was used everywhere by him, they said. Sources added that five teams have been dispatched to different locations including Coimbatore to investigate the case. Police suspect that the person had links with those who had carried out a car blast in Coimbatore in October ahead of Deepavali. On October 23, a youth was charred to death when a cylinder exploded in a moving car outside a temple in Coimbatore. The case is being probed by the NIA.

The police sources suspected that the terror suspect hailed from Shivamogga and might have been involved in the objectionable graffiti in the town. Recently, a few terror suspects were arrested from Shivamogga including some youth who were in touch with the terror outfit Islamic State (IS) through social

A Legend Named Lt Bikram Singh Rathore One of the bravest sons of India, sacrificed his life for the nation, 60 years ago

The 1962 War is a poignant reminder to acknowledge just how much is owed by so many, to just a 'few'. These 'few' were those who stood to the 'last man, last bullet'. Noting the hand given to the Indian Army materially and politically, the TIME magazine had observed on the prevailing situation then, "fighting has shown that the Indians need nearly everything, except courage". For the Indian volunteers to the profession-of-arms their self-imposed 'unlimited liability' towards timeless adjectives like duty. honour, courage, integrity and selfless service was a civilisational code and truth. Also Read - Will India Be Able to Give G-20 a New Direction? The 1962 war was just another duty-bound call to honour, irrespective of the personal cost and the end result. Exactly 60 years to this date, stood one such unsung colossus, who didn't return home, clearly, freedom isn't free. It is often a forgotten debt that can frankly never be fully repaid. Since time immemorial, fierce and noble Rathore warriors have established a saga of indomitable courage, supreme sacrifice and an unmatched talent for war. To this cauldron of instinctive soldering was born. Lt Bikram Singh Rathore (6 Kumaon), a revered family elder who remains an inspiration to our proud Military family to keep the faith and stand tall, irrespective. Also Read - 3-S For Unity - Sangeet, Sari, Sanskrit However, besides patriotism and pride, Military families are also freighted with irresolvable wounds, personal losses, and an occasional sense of being taken for granted and forgotten, especially considering the unparalleled valour and price involved. This weighty sentiment personifies our Military family, 60 years since Lt Bikram Singh Rathore paid that ultimate price, willingly. Within the family, generations have served the nation with great dignity, elan and much combat decoration in all wars and combat engagements since/before Independence. Each combatant tried to live up to the hallowed standards of Lt Bikram Singh Rathore's daredevilry and heroics. Also Read - Can EWS Reservation Remove Poverty in India? Bikram had followed the well-marked footsteps of his ancestors and joined the National Defense Academy (NDA) in 1956, and acquitted himself as a natural horseman and accomplished polo player. His sheer physicality, impressive bearing and thoroughbred conduct attracted the attention of the equally cavalier clansman, Lt Gen K Bahadur Singh (Kumaon Regiment) who talked out Bikram from opting for Rajput Regiment, as Lt Gen K Bahadur Singh wanted the fine specimen for his own Regiment. So Bikram was to join the much decorated and illustrious band of Bullas, the Kumaonis. Also Read - Massacre at Adelaide In the bloody Battle of Walong, Lt Bikram Singh Rathore was to forefront what was arguably the only counterattack of its ferocity, intensity, and Chinese fatalities, in the 1962 War. When the politicians and many of their interfered/preferred leadership within the 'Uniform' had capitulated to

ramrod steel and fire of the young him that he would fight to the end, leadership in the Indian Armed Forces to never give up and ensure a fight that the Chinese would remember, for

posterity. It wasn't the proverbial 'wall' of Himalayas that guaranteed the Indian sovereignty as much as the 'few' (completely outnumbered and illequipped) hardy men of battalions like 6 Kumaon, 2 Rajput, 4 Dogras, 1 Sikh etc., who defied all known limits of combat endurance and resistance. The 6 Kumaon was subjected

to a brutal and full-frontal 'wave' style attack of the Chinese and the doughty Kumaonis fought back in the true spirit of Parakramo Vijayate (Valour triumphs) - the raw fury of the 'creed of the maneaters' (Kumaon Regiment's motto) knew no bounds as they roared 'Kalika Mata Ki Jai' and kept counterattacking, ambushing and deterring the Chinese offensive Bikram and his band of fearless Bullas inflicted 200 Chinese casualties. As the war dragged on, supplies and support for the Indian line of defense waned, paltans like 6 Kumaon and individuals like Bikram Singh Rathore still stood staring the enemy in the eye, just like their forefathers had done for eons. Later, Bikram was tasked to defend a key feature and was surrounded by 300 Chinese, it was an impossible situation, but Bikram contacted his Brigade Commander,

come what may. This wasn't cheap talk or empty bravado as Bikram had repeatedly stared death in the face

> during the 27 days of relentless battle, as days earlier he had written a letter home, explicitly stating, "Don't worry at all. Traditions of our race can never be forgotten. I have killed many to avenge my comrades. I will kill more till the b.... finish up". He fought as only a true warrior could, he was the last man standing

of the 107 men of his paltan who were martyred (16th Nov 1962). By not retreating, even though he knew the consequences of his brazenness was a conscious decision as Bikram had given his word, and that had to be honoured at all costs. Such warriors are cut of a different cloth and the unbelievable odds faced by Bikram and his band of Kumaonis was ironically recognised by the Chinese who admitted to substantial losses, but somewhere in the larger din of the loss in 1962 – Bikram's personal valour went unrecognised institutionally, even though his personal legend reverberated within his paltan and in the odd survivor who lived to tell the tale. He was virtually left to engage in hand-to-hand combat after he had exhausted all ammunition and supplies and was ultimately run over. Many of us who have been in various combat situations in the thick of battle

and have seen/read various citations of valor, still wonder as to how Lt Bikram Singh Rathore's simply unmatched heroics in the annals of combat history, went unrecognized. His battle account is not hagiography but an historical record of the timeless neversay-die spirit, till the end. Perhaps the national pathos, shame and hurt of 1962 didn't help matters, even though Bikram's own Brigade Commander Brig NC Rawlley MC commented bluntly, "He (Bikram) held on as long as humanly possible. Very few men from his Company managed to escape. The bulk of them were killed and wounded on the hill. Under his courageous and gallant leadership the men fought until all their ammunition was exhausted and they were completely overrun. Bikram's message to me over the wireless was that he would hold on and not withdraw. He has fulfilled these words to the limit". Later Lt Gen K Bahadur Singh stated movingly, "Bikram died but like a gallant Rajput on a battlefield". Yet 60 years later, a Yodha (warrior) deserving of nothing less than a Param Vir Chakra (PVC) went to his Valhalla, sadly unsung and unrecognized. Years later, when Bikram's younger brother Narender Singh Rathore was to answer his own calling in the Indian Army - he marched up to the same Lt Gen K Bahadur Singh and requested for something that the grand General immediately understood appreciated, Narender Singh Rathore too joined the bloodline of 6 Kumaon. The short but glorious life of Lt Bikram

Singh Rathore are reminders of the true

strength of the sacred idea called

'India'. It is like Senator John McCain's daughter, Meghan, noted about her warrior father that he was, "the real thing, not cheap rhetoric from men who will never come near the sacrifice he gave so willingly, nor the opportunistic appropriation of those that live lives of comfort and privilege while he suffered and served. He was a great fire who burned bright". Despite the overall outcome of 1962, Lt Bikram Singh had to pay the unsaid price for the indignity of India's politicians and diplomats, when he himself did everything to make his own conscience, his family's legacy, his Kumaon Regiment's honor, and the dignity of the nation, supreme. Today the family treats a memorial dedicated to the 'unknown soldier' at a height close to Walong town as the sanctum sanctorum of Bikram's gallant

As the anonymous saying goes, "Our flag does not fly because the wind moves it. It flies with the last breath of each soldier who died protecting it." It was Lt Bikram Singh's last breath in service of his revered motherland, to whom we owe our freedom, and it is to him we owe that duty to never forget. Ever. Sixty years since the Battle of Walong, 6 Kumaon justifiably reflects, remembers, and celebrates it sons who gave their everything, just as Lt Bikram Singh's family has done every day since he finally fell, and just as the nation should do it, even if very belatedly. Nepal votes for hung parliament

Nepal went to polls on Sunday but political stability may elude the Himalayan nation as political experts closely watching the national and provincial elections have predicted a hung parliament, though the Nepali Congress-led ruling coalition is expected to emerge winner. Political instability has been a recurrent feature of Nepal's Parliament since the end of the decade-long Maoist insurgency, and no prime minister has served a full term after the civil war ended in 2006. The frequent changes and fighting among parties have been blamed for a slow economy, amidst the Covid-19 pandemic. There are two major political alliances fighting it out for the general elections - the Nepali Congress-led democratic and leftist alliance and the CPN-UML-led leftist and pro-Hindu-pro-monarchy alliance. The Nepali Congress-led ruling alliance includes CPN-Maoist Centre, CPN-Unified Socialist, and Madhesbased Loktantrik Samajwadi Party while the CPN-UML led alliance includes pro-Hindu Rastriya Prajatantra Party and Madhes-based Janata Samajwadi Party. Out of a total of 275 members of the federal Parliament, 165 will be elected through direct voting, while the remaining 110 will be elected through a proportional electoral system. Similarly, out of a total of 550 members of the Provincial Assembly, 330 will be elected directly and 220 will be elected through the proportional method in which over 17.9 million people were eligible to vote in seven provinces across the country -- sandwiched between India and China -- to decide the electoral fate of 5.907 candidates. Out of a total of 2.412 candidates contesting the election for federal Parliament, 867 are independents

Current prime minister Sher Bahadur Deuba has formed an electoral alliance with former Maoist guerrilla leader Pushpa Kamal Dahal Prachanda against former premier K P Sharma Oli. The next government will face challenges of keeping a stable political administration, reviving the tourism industry and balancing ties with neighbours. Among the major political parties, the Communist Party of Nepal-Unified Marxist Leninist (CPN-UML) has fielded 141 candidates while the Nepali Congress and CPN-Maoist Centre have fielded 91 and 46 candidates respectively. The Nepali Congress led by Deuba, a five-time premier, in its election manifesto promised to maintain good governance, accountability, transparency and financial discipline if it wins the election. The party has also assured to generate 1.25 million jobs for the youths in the next five years and provide skill development training and career-oriented education to generate more employment opportunities and to encourage people to self-employment. The party aims to resolve border issues through dialogue and diplomatic efforts while giving high priority to neighbours in foreign policy. The coalition government is needed for another five years for maintaining political stability, argues the party. Nobody will die of hunger and job and earnings will be ensured for all, if our party wins the election, claims the CPN-UML, led by former premier KP Sharma Oli, in its manifesto. While pursuing free and balanced international relations, the party aims to develop friendly relations with the international community by giving priority to relations with neighbours. It also romises to get back the three territories of Kalapani. Lipulekh and Limpiyadhura from India if it comes to power. The CNP (Maoist Centre) gives top priority to good governance, transparency, checking corruption and digitising government offices in its manifesto, which promises to maintain cordial, friendly and close relations with both the neighbours (China and India) keeping in view the geopolitical situation and will not take part in any type of multilateral or bilateral military groupings. Sustainable economic growth, quality education and health, and poverty reduction are the major agenda for pro-Hindu and pro-monarchy Rastriya

Italy's Far-Right govt already at war with migrants

Threats, lies, and the breaking of international conventions. Another Italian government, another round of attempts to turn the ports of Italy into a circus of violations and dehumanizing logistical wranglings. Another round of bolstering Europe's racist border regime — as if the sea were barbed wire and every boat a checkpoint.

Immigration has been the bugbear of Italian politics for over a decade. The boats of desperate souls have never left the front pages for long — whether rightfully (in recognition of the vast resistance mounted by the African and Asian proletariat to an unjust, divisive border regime), or in error (a spectacularized distraction from the siege launched by the Italian ruling class against society as a whole)

This story has continued with the new government formed in October, a right-wing coalition including the misogynist media mogul Silvio Berlusconi; the Trumpist, Putin-supporting MatteoSalvini; and, in the leading role, Prime Minister GiorgiaMeloni and her "post-fascist" Fratellid' Italia party. It was no surprise that after taking office three weeks ago, this coalition immediately took aim at the NGOs operating rescue missions in the Mediterranean Sea.

There has been no official search and rescue mission organized by either Italy or Europe since 2014; the majority of migrants arriving by sea either do so without assistance, or are intercepted by often dangerously inexpert military or commercial vessels. Yet many are rescued at sea by ships launched by NGOs. Of the eighty-five thousand people who have survived the crossing to Italy this year alone, around one-fifth were rescued by activists. Half a century of maritime law and international conventions establishes the limits and duties within which the rescues take place: anyone rescued at sea must be taken to the nearest port of safety; anyone arriving in port has the right to claim asylum. Despite the clarity and simplicity of these laws, successive Italian governments have attempted to sidestep them, infringing upon the human rights of those arriving along the peninsula's coastline. It happened in 2009 when hundreds of East African refugees were ferried to Libya by the Italian military under Berlusconi's watch. It happened

in a torturous 2016, when the government, led by Italy's Democratic Party, wiretapped rescue ships, sent secret service agents on board, and initiated criminal proceedings. It happened in 2018 when then interior minister Salvini detained hundreds of migrants on board Italian Coast Guard ships and NGO vessels alike. It happened in 2021 when ships were confiscated and activists' homes raided shortly after the inauguration of Mario Draghi's technocratic government. (For the first of these cases, Italy was sentenced by the European Court of Human Rights; for the second, the rescue crews are currently in court; for the third, Salvini himself is in the dock). And these are but a few exemplary episodes.

The new government formed while four NGO rescue ships were still at sea — and immediately declared that they would not be allowed to disembark anyone in Italian ports. It claimed that the migrants should be sent to other countries according to where the rescue ships are officially registered, in this case Germany and Norway. The claim makes for good nationalist propaganda but has no basis in international conventions. Nevertheless, with more than one thousand people on board, the four ships were left waiting for a place of safety to be assigned: the aptly named Humanity 1, the Geo Barents, the Rise Above and the Ocean Viking.

In this recent diplomatic war of words, the importance of "European solidarity" has been repurposed on all sides. "The other countries are isolating us," wails the Italian interior minister, "they are not acting in the spirit of European solidarity." "We must follow the rules," retorts the German government, "we have a mechanism for solidarity." "Yes, we can take some of them," indicate the French, "but we would like Italy to remember that they are the primary beneficiaries of European solidarity" — in

terms of economic redistribution among member states, they knowingly imply. The only remnant of the previous centrist hegemony, President Sergio Mattarella, attempted to calm the waters: "this is a challenge that can only be overcome through European solidarity." And finally, Meloni found an ally in the form of Manfred Weber, head of the European People's Party (EPP), the main centre-right group in the European Union parliament. He too commented that "Italy can't be left do go it alone, we need to show solidarity on a European level."

For the time being, it seems that the government has faced an embarrassing failure. Diplomatic incompetence, lawmakers with the wrong footnotes, outraged professionals — this is not the road to economic or political stability. Those in charge lack both the experience to govern, and the radicality to excuse their naivety. Furthermore, despite being only weeks into their legislature, this is not the first occasion on which they have demonstrated a certain juridical clumsiness, having already published a decree against "raves" and tabling an antiabortion law that both contain patently unconstitutional elements.

Perhaps the Italian government is less blundering than it might seem. If last year, for Draghi and the European political class, "European solidarity" meant redistributing wealth away from the North and down to the South — Italy included — today it means uniting with Ukraine against Russian military invasion. Draghi and his government were fully behind this project; the new government is looking toward other alliances. The last time a right-wing party dominated the government, in 2018, it soon found out there was little to play for on the European level: an attempt to install a sovereigntist economy minister was soon vetoed by President Mattarella.

But 2022 is not 2018. War and disease have transformed our world. And in this new political remaking of Europe, the racist attacks on the African and Asian working class arriving in Europe by sea may well be paramount. While European states argue over the meaning of their solidarity, internationalists must fight against the right-wing political forces trying to take hold of Europe, while remaining steadfast in our solidarity across all borders. Why the new CJI means hope for Indian Judiciary

"It is well for a judge to remind himself or herself of the fact that flattery is the graveyard of the gullible", said then Supreme Court Justice Dr. D.Y. Chandrachud, in one of his judgments. While being alive to this thought of his and how he handles encomiums, here's why the new Chief Justice of India ('CJI'), Dr. Chandrachud means the dawn of hope to new India.

While talking of the new CJI ('DYC', as he is endearingly referred to), what is spoken of in terms of his strengths is more of the new order he represents than of himself as an individual shouldering an onerous and powerful position of being a judge as well as the administrative head of the judiciary. The new CJI is known for his pleasant demeanour, youthful energy, sharp intellect, and distinguished legal acumen.

This vivacity is reflected with greater vigour in his judgments - on the right to privacy, decriminalising homosexuality, adultery, his dissent in the Aadhar case, abortion rights to unmarried women and to married women who are victims of marital rape, women's equal right to work-right to permanent Commission in the Army, recognising and protecting against intersectional discrimination, reasonable accommodation in respect of the disabled. maternity benefit to mothers who conceive through surrogacy, acknowledging the changing definition of the family and the household, to name the star judgments of the many erudite ones he has authored. His progressive thoughts, in sync with the times, are cast in iron in his judgments, which bear the unmistakable stamp of his

compelling commitment to personal liberty, individual dignity, and equality, holding them in high esteem, while upholding the pluralistic ethos of our nation and society, and guarding against erosion of secular values.

It is worth mentioning that the CJI's commitment to the values that stand out in his judgments are also seen in his personal interactions with people who work with him. In an article in The Week, one of his former judicial clerks, who is visually disabled, has elaborated on his inclusive experience in working with Justice Dr. Chandrachud, when the latter took many steps to implement the principle of 'reasonable accommodation' to make his judicial clerk have accessibility and comfort in all aspects of work on par with his sighted counterparts, including introduction of audio captcha on the Supreme Court website, and directing that all files and written submissions were to be mailed in PDF format in order that a screen reader could read all files for the benefit of his judicial clerk.

Beyond all trappings of power and position, legal jargon and prolix judgements, what stands out to the litigant public is the degree of sensitivity employed by the judges to see through the technicalities and to reach out to them to

address their real grievances. This, the new CJI, has excelled at and set a very high standard for everyone to follow in the higher judiciary as well as the subordinate judiciary.

The constitutional and legal principles applied in his judgments, reflect the welcome progressive thought of the higher judiciary, rejection of artificial distinctions and discrimination, and an equal acceptance of the State of all its citizens, regardless of their gender, sexual orientation, social status, and disability, to ensure their equal participation and enjoyment in all areas of life as equal stakeholders of society. This augurs well for a nation, diverse in every way while being unitary in spirit, and where the only test to be applied is that of constitutional morality. While the term 'constitutional morality'

is still being debated and is likely to be given expansive scope and meaning in the upcoming times, what one understands at the very first blush would be to mean the judiciary's single-minded commitment to the Constitution, its ideals and philosophy, and importantly putting them first. The judiciary deserves the credit for making the Constitution stand strong when faced with a storm of attacks from within and without, and in this, judgments by the CJI in cases mentioned above have been the

sturdiest of pillars. Such judgments have ensured the rich display of resilience by the Constitution with its ideals of liberty, equality, justice, dignity, democracy and secularism emerging more extensively meaningful than ever before. And for as long as these ideals are protected with unflinching commitment by the judiciary, even in the face of staunch attacks by majoritarian onslaught of ideology or politics, it can be asserted with faith and certainty that the Constitution will survive.

The new CJI will also have to ensure the independence of the judiciary and guard against the shifting of power of judicial appointments in any manner not constitutionally contemplated, as well as continue to fortify the secular democratic credentials of India.

While there is natural tendency to compare any CJI with his predecessor(s), especially when they have been hugely popular, the new CJI faces the formidable twin challenge of standing up to the legacy of Justice U. U. Lalit in terms of his blitzkrieg reforms in 74 days (increased listing of cases and setting up of more than one Constitution Benches), as well as measuring up to the expectations from his own larger than life persona.

The next two years are going to provide him further chance to be the harbinger of a more sensitive judiciary and to usher in systemic reforms in the judiciary. It is entirely for him to raise the bar of the judiciary to its highest, in order that it may attract the best talent of the country, given that it is Lady Justice that we must care for, for all time to come. Vishal bats for implementation of Minimum Support Price for Copra

Mr. Vishal Jolly, BJP's Executive Member has requested ground level implementation **Minimum Support Price** for Copra, in A & N Islands through a letter addressed to Prime Minister, Home Minister, Minister for Agriculture & Farmers Welfare and a separate letter addressed to the Chief Secretary, A & N Administration.

In his letter, he mentioned the vital issue pertaining to ground level implementation of the scheme of Minimum Support Price (MSP) on COPRA (an agricultural produce of Coconut) at A & N Islands. He mentioned that during his recently concluded visit to Car Nicobar Island, he came across certain disheartening facts pertaining to the condition of farmers, which require immediate intervention.

It is a matter of fact that the entire Tribal population of Nicobar group of Islands relies solely on the coconut

livelihood and the sale of Copra is the only source of income for the tribal population to meet their daily essential needs. Copra being the sole bread earner of the Tribal community of Car Nicobar, Kamorta. Chowra, Terrasa, Campbell Bay and other Islands, the minimum support price of the same are fixed by the Government of India for the benefits of all

farmers dealing with

COPRA.

support the To farmers, GOI from time time announces minimum price support scheme in the month of December every year for a period of next one year. Last year also the MSP was announced in the month of December 2021, but till date the same has not found being implemented on ground level and none of the farmers dealing with COPRA are availing the benefits which the Government of India has formulated for their welfare. Under the above circumstances the tribal farmers are compelled to sell their produce to local vendors at very meager prices of Rs. 35/- to Rs. 39/- per kilogram whereas the MSP fixed by the GOI is Rs. 105.90

per kilogram.
Although the scheme is announced every year, the same has not been implemented by the National Agricultural Cooperative Marketing Federation of India Ltd (NAFED) since 2013. It is pertinent to mention that the produce of Nicobar zone is 100 percent organic (notified by Agriculture Department).

It was placed on record that NAFED is the authority to deal with the farmers and purchase the agricultural produce from them.

The NAFED doesn't have any branch in our Islands and the entire transactions / arrangements are done at its regional jurisdictional office situated at Kolkata, West Bengal. Unless &

NAFED is set up in our Islands it would be extremely difficult for the farmers to get the real fruits of their hard-Furthermore, reportedly there is only one Surveyor deputed for the entire A & N Islands and that officer remains camped at Port Blair whereas the main "source" of collection/ procurement is at Car Nicobar, Kamorta, Terrasa, Campbell Bay, various parts of North & Middle Andaman District. villages South Andaman and Port Blair.

Disowned by teenage mother and kin, MP baby girl to get orphan' status

BHOPAL, NOV 20 /--/ A newborn baby girl, disowned by her teenage mother -- a "rape survivor" -- and her family members, is staring at an uncertain future and heading towards getting the status of an "orphan".

The 28-day-old baby, born prematurely on Diwali, was initially kept under observation of doctors and has now been shifted to a children's home (orphanage) -- Kilkari -- in Khandwa district of Madhya Pradesh, officials said. She has become a victim of a crime that has left multiple lives in disarray. It all unfolded when a 15-year-old girl returned to her home in a village located 45km from Khandwa district headquarters during Diwali after staying with her maternal aunt in Indore. The girl's parents, in a celebratory mood, were clueless about the storm brewing in their life. "The girl complained of severe abdominal pain after falling from stairs during cleaning work on the day of Diwali (October 24)," Khushbu Parmar, sub-inspector at Indore's Lasudia police station who is investigating the case, told PTI. The worried parents immediately rushed her to a local healthcare centre. A medical examination revealed the young girl was

pregnant and doctors

her to the district hospital in

Khandwa. However, the

girl on way to the hospital,

daughter were later shifted to the district hospital. The family members of the girl are saying they were unaware of her pregnancy all these months and came to know about it only when doctors told them, Parmar said. "After the young girl gave birth to the baby, she filed a police complaint of rape against a 15-year-old boy, a resident of Indore," the woman officer said. Parmar said the girl had stayed at her maternal aunt's house in Indore's Lasudia area for a few months and during this period, became friendly with the boy who lived in the neighbourhood. complainant accused the 15year-old boy of raping her when her maternal aunt and uncle were out of home for

said the police official. The police have collected DNA samples of all three -- the girl, the boy, and the newborn -- and sent for laboratory examination, she said. The police sub-inspector said following the complaint, the minor boy was detained under provisions of the Indian Penal Code (IPC) and the Protection of Children from Sexual Offences Act. The newborn's future is, however, hanging in the balance as the girl and her family members have refused to take care of the baby, who is heading towards getting the tag of an

work, and impregnating her,

"orphan".

"After the teenage girl delivered a premature baby,

we recorded her family members' statements. The girl and her parents expressed their wish to disown the newborn seeking to know where they will keep the baby and how will they face society. "But the survivor's parents are ready to keep their daughter with them," Vijay Sanava, chairman of the District Child Welfare Committee, said.

He said now that the baby has been disowned, legal steps to safeguard her future will be taken."The newborn is healthy after spending initial days in the hospital under doctors' observation. We are in the process of taking further legal steps as per rules and regulations," the District Child Welfare Committee chief said. Sanava said the girl and her family members will soon be called to complete the paperwork to surrender the child. "We will ask the family members again if they want to take the newborn with them. If they decline, the legal process to surrender the child to the orphanage will

be set in motion," he said. After this process, the girl and her family will have 60 more days to claim the newborn, Sanava said. Sanava said after the completion of 60 days, the baby can be adopted by others through Central Adoption Resource (CARA) by Authority following due process. CARA is the nodal agency for the adoption of children in the country. (PTI)

LeT'hybrid' terroristkilled in encounter in J&K's Anantnag

SRINAGAR, NOV 20 /--/ A "hybrid" terrorist of L a s h k a r - e - T a i b a, accompanying a police party for identifying a hideout, was killed in an encounter between security forces and ultras in Anantnag district of Jammu and Kashmir on Sunday, police said.

"Hybrid" terrorists are not listed as ultras but are radicalised enough to carry out a terror strike and then slip back into routine life. The "hybrid" terrorist, Sajad Ahmad Tantray alias Furgan, a resident of Shirpora in Kulgam, was involved in the killing of a non-local labourer at Rakhmomen in Anantnag's Bijbehara on November 12, a police spokesperson said. He was arrested and during questioning, he confessed to his involvement in the labourer's killing.

At his instance, a pistol used in the commission of the terror crime was recovered, the spokesperson said. Tantray also revealed information about the presence of terrorists in Bijbehara's Cheki Duddo area, he added.

On the basis of information provided by Tantray, the police said, a search and cordon operation was launched in Cheki Dudoo.

As the search party approached the hideout, it came under heavy firing from the hiding terrorists and Tantray was critically injured. (PTI)

CHENNAI, NOV 20 /--/ After a prolonged silence, rumblings against the state leadership surfaced in the Tamil Nadu Congress Committee with few office bearers

overtly expressing their resentment. What took everyone by surprise was the chaos and a sudden scuffle between the supporters of two MLAs on the premises of Sathymurthy Bhavan - the TNCC headquarters on November 15. Though TNCC chief KS Alagiri, later, dismissed this as the party's internal affair, which would be sorted out, the incident nevertheless brought to the fore the bickerings within the party. Party's Thoothukudi north district Congress president R Kamaraj resigned from party post protesting against the alleged handling of the incidents. TNCC treasurer and Nanguneri legislator Ruby R Manoharan, whose supporters created ruckus leading to a minor scuffle, said he has been served a show-cause notice by the party leadership and he would make his submission before the disciplinary committee on November 24. His supporters had protested against the election results of the block presidents for Kalakkad and Nanguneri. The supporters of Tirunelveli east district Congress committee president KPK Jayakumar entered into an argument with

them leading to a scuffle between the two groups. "The party posts were filled without consulting the district presidents. The arbitrary action against Manoharan is unacceptable. The party cadres were attacked by goondas inside the Congress state headquarters. What action has the state president taken against the goondas?" Kamaraj asked.

Also, he alleged that the TNCC did not pass a resolution condemning the release of the convicts in the former Prime Minister and Congress leader Rajiv Gandhi assassination case. Dismissing it as an internal issue, Alagiri claimed that "dissatisfaction against leadership is natural in any political party." The appointments were made as per the procedure laid down by the state election commission, he said. About 62 district leaders signed a petition seeking disciplinary action against the Nanguneri MLA. "We are trying to resolve the issue in a democratic manner. Alagiri's car was waylaid by a group of persons," claimed former union minister Dhanushkodi Athithan. Posters demanding action against Manoharan in Tirunelveli district and few posters in Chidambaram flaying Alagiri, took the party by surprise. (PTI)



Shah says Cong exploited tribal community for votes

Rahul accuses Centre of weakening laws framed during UPA regime to empower tribals

DEDIAPADA, NOV 20 /--/ Union home minister Amit Shah Sunday accused the Congress of exploiting the tribal community for votes, and said it was only after Narendra Modi became the Prime Minister that the country got its first tribal President in Droupadi Murmu. Shah also alleged that poverty increased under the Congress rule even as the party had given a call of eliminating it. "Congress only delivered speeches. It gave the slogan of eliminating poverty, but instead worked to eliminate the poor. It exploited tribals by garnering their votes. Despite 70 years of independence, not a single tribal brother or sister became the president of the country," Shah said, addressing a poll rally at Dediapada in tribaldominated Narmada district. "It was after Narendra Modi became the prime minister that he worked to make Droupadi Murmu, a daughter of a tribal, poor family from Santhal pargana of Odisha the country's

President," the home minister said. Shah said that Modi worked towards ending the division between the rich and the poor and delivered his first speech after becoming the Prime Minister. "When Modi became the Prime Minister, his first speech was that his government will be for the tribals, Dalits, poor and OBCs. He did what he said. In eight years, Modi reserved a large portion of the budget for 80 crore poor people of the country." Shah said. He said there is

is now without access to electricity. "Modi worked for uniting the country which was divided into poor and rich," he added. Shah also took a swipe at the Gujarat Congress' election campaign highlighting its achievements when it was in power three decades ago, and said the opposition party did not do anything other than increasing poverty. "Congress says "Kaam bole chhe" (it is work that speaks). It has not been in power since the last 32 years.

when former Congress president Rahul Gandhi accused the Narendra Modiled Central government of weakening laws framed by the United Progressive Alliance (UPA) to empower tribals, and said his party will strengthen them further after coming to power again. Addressing the Adivasi Mahila Workers' Sammelan at Jalgaon-Jamod in Maharashtra's Buldhana district, Rahul said tribals are the "first owners" of the country and have equal rights like other citizens. The Modi government was weakening laws like the Panchayats (Extension to Scheduled Areas) Act, Forest Rights Act, Land Rights, Panchayat Raj Act and the reservation for women in local bodies, the Congress leader said. He said PM Modi calls tribals as 'vanvasis'. There are different meanings of the words 'adivasi' and 'vanvasi', he said. "Vanvasi means you can live only in jungles, not in cities, you can't become doctor and engineer and can't travel by plane," he said. Rahul alleged that the PM wanted to take away the tribal land and give to his industrialist friends. "When we come to power, we will strengthen these laws and frame new legislations for vour welfare." he said. Rahul said his grandmother (former Prime Minister) Indira Gandhi would say adivasis were the first owners of the country. "You will not understand the country if you don't understand the culture and history of tribals," he said. (PTI)

On Saturday, FIFA president Gianni Infantino went on the offensive in an aggressive rebuttal of the opprobrium aimed at the event, arguing that much of the criticism was unfair. She may also draw the Prime Minister's attention to the issue of Ganga river bank erosion in areas around Farakka barrage, the official said. "In the meeting, the chief minister is expected to highlight the arrears pending for the implementation of the Mahatma Gandhi National Rural Employment Guarantee Act in Bengal. She may also remind the PM about the dues to the state," he said. The Prime Minister has convened the chief ministers' meeting in the national capital as India will host the G-20 Summit in 2023. The invitation has also reached Mamata's office and the CM will go to Delhi to attend the meeting, the official said. The meeting between Mamata and Modi is expected at a time when there is growing clamour from states for the release of dues from the Centre. Several states, including West Bengal, had claimed that they have been "facing difficulties" in taking up development and social welfare programmes as the fund flow from the Centre has been getting "inordinately delayed". In a memorandum to the Prime Minister, Mamata had tabulated that the dues to the state from the central government as on July 31, 2022 has been estimated to be around Rs 1,00,968.44 crore. The CM at a recent rally in Jhargram had said the Centre should do

The TMC supremo, during her last meeting with the PM in August, had raised a host of issues concerning West Bengal, including GST dues and timely release of funds by the Centre under various schemes. At that meeting, she had repeatedly sought the PM's intervention for urgent release of dues to the state on account of the implementation of the rural job scheme, MGNREGA, and other programmes like PM Awas Yojana and the PM Gramin Sadak Yojana. 



Pak's politically charged run up to appointment of next Army Chief may end soon

ISLAMABAD, NOV 20 /--Pakistan's controversial and politically charged run up to the appointment of next Chief of Army Staff may end soon with the government naming the next head of the Army within days

Though it may be a routine administrative affair in many other countries, in Pakistan the appointment of the army chief attracts a lot of attention, primarily due to multiple hidden powers attached with the powerful post. According to Article 243(3) of the Constitution, the president appoints all services chiefs on the recommendation of the prime minister, who may consult his aides but he solely has the power to make the appointment. The appointment of chiefs of navy and air force goes unnoticed but it is not the case with the nomination of the Army chief. The guessing game starts months before the end of the tenure of the incumbent. In the latest case, Gen Qamar Javed Bajwa, 61, is set to hang his boots on November 29 but speculation began as early as August as to who would be his successor. The leading Englishlanguage daily Dawn ran a report on August 16 about the top generals, with one of them entering the shoes of Gen Bajwa, whiles the other getting the post Chairman of Joint Chiefs of Staff (CJCS). The brief introduction of the top five is given below: Lt-Gen Asim Munir:



He is the senior-most. His four-year tenure as Lt-Gen will end on November 27, just two days before retirement of Gen Bajwa. He is in the race as the decision for the army chief would be made before his retirement. If appointed, he would get a three-year extension in the service. Lt- Gen Munir was commissioned into the Frontier Force Regiment and has been a close aide of the incumbent COAS ever since he commanded troops in the Force Command Northern Areas as a brigadier under Gen Bajwa, who was then the Commander X Corps. He was later appointed chief of Military Intelligence in early 2017, and in October next year was made the ISI chief. However, his stint as the top intelligence officer turned out to be the shortest ever, as he was replaced

by Lt-Gen Faiz Hamid within eight months, on the insistence of then-

Prime Minister Imran Khan. Lt-Gen Sahir Shamshad Mirza: He is senior-most amongst the other four candidates who belong to the same batch. He hails from the Sindh Regiment. He came to prominence as director-general military operations (DGMO) during the last two years of Gen Raheel Sharif, the COAS from 2013-16. In that role, he was part of Gen Sharif's core team at GHQ, which supervised the military operation against the Tehreek-i-Taliban Pakistan (TTP) and other militants in North Waziristan. He has served as the chief of general staff, and in that role he was closely engaged in crucial decision-making related to national security and foreign affairs. In October 2021, he was

posted as Corps Commander Rawalpindi to enable him to acquire operational experience and become eligible to be considered for the top posts. The Dawn newspaper quoted a military source as saying that while commenting on his profile he was the clear frontrunner for either of the two posts of COAS and CJCSC.

Lt Gen Azhar Abbas: He is the most experienced in Indian affairs among the current brass. Currently, he is the chief of general staff (CGS), effectively running the army with direct oversight of both operations and intelligence directorates at GHQ. Prior to that, he commanded the Rawalpindibased but Kashmir-centric and politically-significant X Corps, which indicates that he enjoys the complete trust of the present army chief. It was during his time as commander X Corps that the Indian and Pakistani armies reached an understanding on respecting the 2003 ceasefire agreement along the Line of Control (LOC). He has also commanded the 12th Infantry Division based in Murree, from where he was responsible for Pakistan-occupied Kashmir. Lt-Gen Nauman Mehmood: He belongs to the Baloch Regiment. He is currently president of the National Defence University. He also has extensive experience as chief instructor at the Command and Staff College, Quetta. (PTI)

Two death row convicts in **Bangladeshi-American blogger** murder case flee dramatically from court premises

DHAKA, NOV 20 /--/ Two Islamist militants, who were sentenced to death for killing prominent Bangladeshi-American secular blogger Avijit Roy and his publisher, escaped dramatically from the premises of a crowded court here on Sunday with the help of unidentified bikers who sprayed some chemical on police and created a smoke screen before whisking away the convicts.

Hours after the incident, home minister Asaduzzaman Khan Kamal told reporters that a nationwide alert has been issued to recapture them and an investigation launched to ascertain how the event took place. "We have launched a massive manhunt to recapture them and their helpers," a police spokesman told newsmen at the scene. He said Moinul Hasan Shamim alias Samir alias Imran and Abu Siddig Sohel -- both of whom were operatives of the outlawed terrorist group Ansarullah Bangla Team (ABT) -were brought to the court for indictment hearing in a different case when some unidentified mortorcycle-borne men whisked them away while they were being escorted to transition prison room. Police said the two ABT operatives were sentenced to death last year for killing 42-year-old Bangladesh-born US secular blogger Roy and his publisher

According to police and eyewitnesses, the convicts fled the court premises on motorbikes as their accomplices sprayed some chemical on policemen escorting them and created a smoke screen. The evewitnesses said the spray temporarily blinded only two policemen, suggesting that the convicts in the high-profile murder cases were being treated just like any other ordinary prisoners. "The prisoners were just handcuffed, their legs were not shackled, a usual protective measure for dangerous criminals or militants," a court official said.

CCTV footage aired by TV channels showed two bikers wearing helmets carrying the two militants through a narrow road in front of the Dhaka Metropolitan Judges Court complex, while a plainclothesman was chasing them. Roy, an outspoken critic of religious fundamentalism, was hacked to death with machetes by ABT militants just after he left a book fair at the Dhaka University on February 26, 2015. His wife Rafida Ahmed was also injured in the attack. The terrorist group also hacked to death his publisher Dipan in November the same year at his office at Dhaka's Shahbagh area. Dhaka's Anti-Terrorism Special Tribunal court sentenced five militants to death in the Roy murder case, while eight Islamists were sentenced to death for killing Dipan. (PTI)

Pak's ruling coalition PDM initiates talks with Oppn PTI to resolve political crisis

ISLAMABAD, NOV 20 /--/For the first time since coming to power, the Pakistan Democratic Movement (PDM) alliance-led federal government has initiated a dialogue with ousted prime minister Imran Khan's Pakistan Tehreek-e-Insaf (PTI) to resolve political issues, including the appointment of a new Army chief, according to a media report on Sunday.

The development came as Finance Minister Ishaq Dar met with President Arif Alvi on Friday and offered dialogue to resolve political issues, The Express Tribune newspaper quoted a source as saying. The source said the president, a member of Khan's party, told Dar that his message would be conveyed to the PTI leadership. In response to the government offer, the PTI leadership also showed willingness and authorised the president to engage with the government, the source added. Dar held two meetings with the president in the last three days, the paper "The PTIwants the announcement of the date for the early general elections. If the government agrees, then the PTI is willing to rejoin parliament for a dialogue on the electoral framework," the paper reported. It is also reported that the purpose of the meeting between the finance minister and the president was to ensure that the process regarding the appointment of a new Pakistan Army chief would culminate smoothly. Pakistan Army chief, General Qamar Javed Bajwa will retire on November 29.

Under the law, the president can hold back the summary on the appointment of the Army chief sent to him by the prime minister for 25 days. The sources, however, said the appointment of an army chief was a very sensitive matter, and it would not be in the national interest to delay the process. A PTI leader told The Express Tribune that if the government appoints an army chief in violation of the settled process then the president may hold the summary for reconsideration. He, however, said that the party would not dispute the appointment of any general as the army chief. "Now, the appointment of the new chief is not an issue of PTI," he added. However, he remarked that the civil and military leadership were not on the same page regarding the appointment of the new chief. The Express Tribune also reported that a summary regarding the appointment of the chief of army staff (COAS) is yet to be initiated by the defence ministry

One source claimed that the summary could be initiated anytime in the next 36 hours, but if it was delayed further, then the government may approve the appointment of the new army chief through the federal cabinet. However, a Pakistan Muslim League-Nawaz (PML-N) leader rejected the report regarding differences between the civil and military leadership on the matter, saving that the decision had already taken and the announcement would be made soon, Meanwhile, Prime Minister Shehbaz Sharif consulted former president Asif Ali Zardari and PDM chief Maulana Fazlur Rehman, On the other hand, Pakistan People's Party (PPP) Chairman Bilawal Bhutto-Zardari has warned that in case any mess is created in the process, then the president will be held responsible. UN climate deal: Calamity cash, but no new emissions cuts

SHARM EL-SHEIKH, NOV 20 /--/For the first time, the nations of the world decided to help pay for the damage an overheating world is inflicting on poor countries, but they finished marathon climate talks on Sunday without further addressing the root cause of those disasters - the burning of fossil

The deal, gavelled around dawn in this Egyptian Red Sea resort city, establishes a fund for what negotiators call loss and damage. It is a big win for poorer nations which have long called for cash - sometimes viewed as reparations - because they are often the victims of climate-worsened floods, droughts, heat waves, famines and storms despite having contributed little to the pollution that heats up the globe. It is also long been called an issue of equity for nations hit by weather extremes and small island states that face an existential threat from rising seas. "Three long decades and we have finally delivered climate justice," said Seve Paeniu, the finance minister of Tuvalu. "We have finally responded to the call of

hundreds of millions of people across the world to help them address loss and damage." Pakistan's environment minister, Sherry Rehman, said the establishment of the fund "is not about dispensing charity". "It is clearly a down payment on the longer investment in our joint futures," she said, speaking for a coalition of the world's poorest nations. Antigua and Barbuda's Molwyn Joseph, who chairs the organisation of small island states, described the agreement as a "win for our entire world". "We have shown those who have felt neglected that we hear you, we see you, and we are giving you the respect and care you deserve," he

The deal followed a game of climate change chicken over fossil fuels. Early Sunday morning, delegates approved compensation fund but had not dealt with the contentious issues of an overall temperature goal, emissions cutting and the desire to target all fossil fuels for phase down. Through the wee hours of the night, the European Union and

other nations fought back what they considered backsliding in the Egyptian presidency's overarching cover agreement and threatened to scuttle the rest of the process. The package was revised again, removing most of the elements Europeans had objected to but added none of the heightened ambition they were hoping for. "What we have in front of us is not enough of a step forward for people and planet," a disappointed Frans Timmermans, executive vice president of the European Union, told his fellow negotiators. "It does not bring enough added efforts from major emitters to increase and accelerate their emissions cuts. "We have all fallen short in actions to avoid and minimise loss and damage," Timmermans said. "We should have done much more."

Germany's Foreign Minister Annalena Baerbock likewise voiced frustration. "It is more than frustrating to see overdue steps on mitigation and the phase-out of fossil energies being stonewalled by a number of large emitters and oil producers," she said. The agreement includes a veiled

reference to the benefits of natural gas as low emission energy, despite many nations calling for a phase down of natural gas, which does contribute to climate change. While the new agreement doesn't ratchet up calls for reducing emissions, it does retain language to keep alive the global goal of limiting warming to 1.5 degrees Celsius (2.7 degrees Fahrenheit). The Egyptian presidency kept offering proposals that harkened back to 2015 Paris language which also mentioned a looser goal of 2

The world has already warmed 1.1 degrees (2 degrees Fahrenheit) since pre-industrial times. Nor does the deal expand on last year's call to phase down global use of "unabated coal" even though India and other countries pushed to include oil and natural gas in language from Glasgow. That too was the subject of last minute debate, especially upsetting Europeans. Last year's climate talks president chided the summit leadership for knocking down his efforts to do more to cut emissions with a forceful listing of what was not done. (AP)

Turkey strikes in Syria, Iraq a week after Istanbul bombing

ISTANBUL, NOV 20 /--/ Turkey launched airstrikes over northern regions of Syria and Iraq, the Turkish Defence Ministry said on Sunday, targeting Kurdish groups that Ankara holds responsible for last week's bomb attack in Istanbul.

Warplanes attacked

bases of the outlawed Kurdistan Workers' Party, or PKK, and the Syrian People's Protection Units, or YPG, the ministry said in a statement, which was accompanied by images of F-16 jets taking off and footage of a strike from an aerial drone. There was no immediate comment from either group. The ministry cited Turkey's right to selfdefence under Article 51 of the United Nations Charter in launching an operation it called Claw-Sword late on Saturday night. It said it was targeting areas "used as a base by terrorists in their attacks on our country." Turkey said it was seeking to prevent attacks, secure its southern border and "destroy terrorism at its source." The airstrikes came after a bomb rocked a bustling avenue in the heart of Istanbul on November 13, killing six people and Turkish authorities blamed the attack on the PKK and its Syrian affiliate the YPG. The Kurdish militant groups have, however, have involvement. denied Ankara and Washington both consider the PKK a terror group, but disagree on the status of the YPG. Under the banner of the Syrian Democratic Forces, the YPG has been allied with the US in the fight against the

Islamic State group in Syria. The PKK has fought an armed insurgency in Turkey since 1984. The conflict has killed tens of thousands of people since then. Following the strikes, the Defense Ministry posted a photo of an F-16 fighter plane with the phrase, "Payback time! The scoundrels are being held to account for treacherous attacks." The DHA news agency reported that F-16s took off from airfields in Malatya and Diyarbakir in southern Turkey while drones were launched from Batman. Defense Minister Hulusi Akar oversaw the airstrikes from an operations center and congratulated pilots and ground staff. "Our aim is

85 million citizens and our borders and to retaliate for any treacherous attack on our country," he said, according to a ministry statement.

Akar added: "Shelters,

bunkers, caves, tunnels and

warehouses belonging to terrorists were destroyed with great success. ... The socalled headquarters of the terrorist organization were also hit and destroyed with direct hits." The airstrikes targeted Kobani, a strategic Kurdish-majority Syrian town near the Turkish border that Ankara had previously attempted to overtake in its plans to establish a "safe zone" along northern Syria. Syrian Democratic spokesperson Farhad Shami in a tweet added that two villages heavily populated with displaced people were under Turkish bombardment. He said the strikes had resulted in "deaths and injuries." Local media reported that the northern Iraqi city of Sinjar was also targeted. Syrian opposition media reported that the Turkish airstrikes targeted Kurdish-led SDF positions. (AP)

The 34-year-old Real Madrid striker had been struggling with the injury for some time and had played less than half an hour of football in his club's last six games before the World Cup. On Saturday, he took part in full training for the first time since the World Cup holders gathered last week ahead of the tournament. He was forced to withdraw from the session at the home stadium of Qatari champions Al Sadd with the injury and was taken for tests. The French Football Federation (FFF) later said in a statement that the injury "will require a recovery period of three weeks", ruling out any prospect of him being fully fit for the tournament which finishes on December 18. "I am extremely sad for Karim, for whom this World Cup was a major objective," France coach Didier Deschamps was quoted as saying in the FFF statement. "Despite this new blow for the France team I have full faith in my squad. We will do all we can to rise to the huge challenge that awaits us." The 36-year-old Olivier Giroud is set to benefit from Benzema's absence by coming into the France attack alongside Kylian Mbappe and Antoine Griezmann. However, under FIFA rules Deschamps can still call up a replacement for an injured player until Monday, on the eve of their first game. France begin their defence of the trophy on Tuesday, when they take on Australia in Al Wakrah. They will also play Denmark and Tunisia in Group D as they aim to become the first team since Brazil in 1962 to retain hampered by fitness problems. France have come to Qatar without the key duo of Paul Pogba and N'Golo Kante, their starting midfield pairing from the successful 2018 World Cup campaign, who were both ruled out due to injury before Deschamps named his squad. Back-up goalkeeper Mike Maignan and centre-back Presnel Kimpembe also withdrew before RB Leipzig forward Christopher Nkunku had to pull out after suffering a knee injury in France's final training session before departing for Qatar. Nkunku was replaced in the squad by Eintracht Frankfurt forward Randal Kolo Muani. Manchester United defender Raphael Varane has also been struggling to prove his fitness since coming off in tears with a leg injury in a game against Chelsea on October 22. Benzema, who will turn 35 next month, had targeted the World Cup to cap off a remarkable career renaissance. He won the Ballon d'Or after scoring 44 goals in 46 games for Real Madrid last season as the Spanish club won the Champions League and La Liga. Benzema had previously been frozen out of the France team for five-anda-half years because of his involvement in a blackmail scandal over a sex tape involving his former teammate Mathieu Valbuena. That saw him miss France's victorious 2018 World Cup campaign and led to him being handed a one-year suspended prison sentence as well as a fine of 75,000 euros. On winning the Ballon d'Or he said: "There are things that are still left to be done. I hope to be in the squad for Qatar, to go to the World Cup and do everything to win it." (AFP)

Romelu Lukaku to miss Belgium's first two games, says report

DOHA, NOV 20 /--/ Romelu Lukaku will not play for Belgium at the World Cup until at least their final Group F match against Croatia, a team source told AFP on Sunday.



The forward did not take part in the Red Devils' first proper training session since they arrived in Qatar on Friday as he continues his recovery from a hamstring injury. Lukaku is Belgium's all-time top scorer with 68 goals in 102 appearances and was called up to their World Cup squad despite coach Roberto Martinez admitting he was not fully fit. The 29-year-old has endured a difficult past 18 months, moving back

to Inter Milan on loan after a dismal season with Chelsea. However, he has played just twice for Inter since August after first picking up the injury in a 3-1 defeat at Lazio. He returned to action in style last month, scoring in a 4-0 win against Viktoria Plzen that ensured Inter's passage to the last 16 of the Champions League but he then injured his hamstring again a few days later. His place in Qatar will be taken by Melbourne City FC winger Tilio, who has five caps and has been in Doha since Tuesday. "Marco has done

everything that has been asked of him to be ready for this tournament," said Arnold. "He is familiar with the national team set-up and we are looking forward to what he can bring to our squad." (AFP)

FIFA World Cup: Teams set to defy FIFA with 'OneLove' armbands

DOHA, NOV 20 /--/ FIFA proposed a series of alternative armbands featuring different social campaigns on Saturday in response to plans by European teams to wear "OneLove' rainbow armbands at the Qatar World Cup. European teams launched the "OneLove" initiative in response to the treatment of LGBTQ communities in Qatar, where homosexuality is illegal. FIFA though has requested that all captains wear a different armband on each match day, promoting social messages such as "Football unites the world" and "Share the meal" in a United Nations-backed campaign. "Each round of matches will be associated with its own dedicated campaign designed to maximise reach and impact," FIFA said in a statement. The move puts football's world governing body on a potential collision course with teams such as Germany, whose captain Manuel Neuer said he would still wear a "OneLove" armband to promote diversity and inclusion. "Other European nations are wearing (the armband) and it is good we are doing it together," Neuer said on Saturday. Denmark's Christian Eriksen said his country's captain Simon Kjaer would be wearing the rainbow armband too, regardless of any disciplinary action taken by FIFA. (PTI)

Sensational Suryakumar hits another T201, continues stellar run

MOUNT MAUNGANUI, NOV 20 /--/ had picked up a Richard Ngarava full toss Suryakumar Yadav on Sunday became only the second Indian to hit two hundreds in a calendar year, continuing his rich vein of form in the shortest format of the game. Skipper Rohit Sharma (4) is the only other Indian batter to score two T20I centuries in a calendar year in 2018. With the feat Survakumar also joins Rohit, opener KL Rahul (2) as the only other Indian to have two or more T20I hundred. While Suryakumar's second T20 ton came against New Zealand, he had scored his maiden hundred in July against England. "In T20 cricket, a hundred is always special," Suryakumar told the broadcasters after India's innings on Sunday. "I'm enjoying batting this way, I've been doing the same thing in the nets, all practice sessions and going out (to the middle), all these things happening, I'm very happy with that." Suryakumar reached the three-figure mark with backto-back boundaries off Lockie Ferguson in the 19th over. He remained unbeaten on 111. Since making his T20I debut in March last year, Suryakumar has been in scintillating form, collecting over 1300 runs at an average of 45.00 in 41 matches. His strike rate of 181.64 is the highest by any batter in the format. He has cemented his place in the Indian middle-order and seems to be in the form of his life over the past year. His phenomenal ability to play unconventional shots all around the ground has earned him the tag of 'Mr 360'. One such shot had come in the T20 World Cup Super 12 match against Zimbabwe. Going down on one knee, Survakumar

from outside the off stump and scooped it on the right of fine leg for an unthinkable six. He dazzled in his maiden T20 World Cup plundering 239 runs in six innings at a brilliant strike rate of a shade under 190 to end the tournament as the third highestrun getter. DOHA, NOV 20 /--/ Germany goalkeeper Manuel Neuer is set to defy FIFA's campaign for captains to wear only official armbands with selected slogans at World Cup games. "Yes," the veteran goalkeeper said when asked at the Germany training camp about overriding a new FIFA project backed by United Nations agencies. Denmark is also not backing down, playmaker Christian Eriksen said Saturday. The launch a day before the opening World Cup match seemed designed to supplant a pledge by European teams to wear their own armbands as part of a Netherlands-led anti-discrimination campaign drawing attention to host nation Qatar's laws and record on human rights issues. World Cup rules require that equipment such as captains armbands must be authorized and provided by FIFA, but Neuer said he will wear the "One Love' design even if it comes with a fine. "It's good that we have the power with other nations in western Europe," Neuer said. Although Germany does not play until Wednesday, against Japan, three teams that joined the "One Love" campaign in September will play on Monday: England, the Netherlands and Wales. FIFA had not directly addressed the Europeans' request several weeks



ago for permission to wear the heart-shaped, multi-colored logo, then unveiled its proposal on Saturday. The FIFA choice of slogans for group games include "SaveThePlanet," "ProtectChildren" and "ShareTheMeal." "These campaigns have taken into account feedback received from our member associations who, like FIFA, are committed to using the power of football to effect positive change around the world," the soccer body said. The slogan "NoDiscrimination" — the only one that aligns with the European teams' wish — is scheduled to appear at the quarterfinal stage. "Obviously the

short notice is surprising," Germany team director Oliver Bierhoff said within two hours of the announcement. "It looks as if FIFA doesn't have a clear stance." Denmark starts on Tuesday against Tunisia and captain Simon Kjaer should be wearing the "One Love" armband. "What the consequences will be, I don't know," Eriksen said at a news conference where he wore a plain black T-shirt for practice. Denmark has the option of playing in a black game jersey, the color of mourning for migrant workers who died helping build infrastructure needed for hosting the tournament. (AFP)
