

of vaccine received and country of origin. Such fully vaccinated individuals shall produce the final vaccination certificate at the origin sea port in the Mainland and at Port Blair Sea Port/ Harbour.

All asymptomatic children below 5 years of age are exempted from carrying RT-PCR negative test report and further RT-PCR testing at Port Blair Sea Port/Harbour.

All other passengers viz. unvaccinated and partially vaccinated passengers (those who have taken only 1st dose of COVID vaccine) shall have to produce RT-PCR negative test report to travel to Port Blair from mainland, as is the practice now. Such RT-PCR test should have been taken within 48 hours prior to commencement of journey from the origin sea port connecting Port Blair. Such passengers will also have to undergo additional RT-PCR test on arrival at Port Blair. Such passengers shall remain in self quarantine till the arrival of test report.

If a passenger on arrival is tested positive then, the prescribed quarantine protocol is to be

All passengers shall ensure strict compliance of this order and observance of COVID Appropriate Behaviour during the voyage, a press release from DSS said.

equipment shall be allowed from the Media Centre.

It is further clarified that nobody (not even the candidate or RO/ARO etc) except the Observers and Officers connected with Election Duty appointed by the Director, Panchayat and Municipal Elections shall be allowed to carry a mobile phone inside the counting hall.

A Public Communication Room at both the Counting Hall has been earmarked for safekeeping of the mobiles etc of the candidates and their agents/representatives to make use of their mobile phones in case of any need.

No camera- still or video of the media except for official recording of the entire counting process is allowed to be fixed inside any counting hall. No camera stand should therefore be allowed to be taken inside counting hall by media and journalists. Hand held cameras will be allowed to the authorized pass holders. The exact location, up to which the still and video camera of the media and press can move, shall be indicated by the Returning Officer in advance, marked by a line or a boundary for guidance of all concerned, a press release from DPME said.

|Cricket legend Shane Warne passes away

ORDER

No. 5-2/EC/A&N/2021: Whereas, it is necessary to check impersonation of voters in the interest of purity of elections to Panchayats and Municipal Councils and for the conduct of such elections in a fair manner;

And whereas, Rule (68) of the Andaman and Nicobar Islands (Panchayats) (Election Procedure) Rules, 1995 and Rule (55) of the Andaman and Nicobar Islands (Municipal) (Election Procedure) Rules, 1995, provide inter lia, that the elector shall produce his identity card before the presiding officer or the polling officer authorized by him in this behalf;

And whereas, according to the information received from the Andaman and Nicobar Administration, 98% voters have been issued Electoral Photo Identity Cards (EPICs). However, there may be electors who have lost their Identity cards and a few newly enrolled electors may not be having the EPICs, and such electors will find it difficult to cast their vote;

Now, therefore, after taking into account all relevant factors and the legal and factual position, the Election Commission, Andaman and Nicobar Islands, hereby directs that the following alternative documents to EPICs may be used for establishing the identity of those electors who have not been provided with EPICs or have lost their EPICs and whose names are included in the Electoral Rolls -

- (i) Unique Identity Aadhaar Card
- (ii) Indian Passport
- (iii) Motor Vehicle Driving Licence
- (iv) PAN Card issued by the Income Tax Department
- (v) Service Identity Cards issued to their employees by the Central Govt./Public Sector Undertakings and Local
- (vi) Service Identity Cards issued to its employees by the Andaman and Nicobar Administration (vii) Bank/Kisan/Post Office Passbook having photo affixed on it.

(viii) Certificates of Physical Disability issued by the competent authority with photograph:

The above alternative documents for identification will also apply in respect of such electors who have been supplied with EPICs but are not able to produce them for reasons beyond their control.






