Don't Lure, But Persuade

The Election Commission of India's proposal to require political parties to disclose the financial implications of the promises they make in their manifestos will add meaning and depth to electoral campaigns. The idea that parties should communicate to electors the fiscal rationale for promising delivery of goods or services that would involve a significant outgo from the exchequer is already part of the Model Code of Conduct from 2015. The ECI is now proposing a proforma for such disclosures. If parties agree and the idea is included in the Model Code, they will have to spell out the section of society that a particular promise is targeted at, the extent of coverage and the number of likely beneficiaries, and the cost of implementing it. They must also spell out how the required resources will be raised. To give the parties an idea of the fiscal challenge that their promised schemes may pose, the Centre and the States have been asked to disclose details of the budget revenue receipts and expenditure as well as the outstanding liabilities. The information, it is believed, will provide a framework under which a manifesto can be assessed by the voter from the perspective of its financial viability. It may also make parties treat manifesto preparation as a responsible exercise meant to persuade rather than lure the voter.

There is bound to be some resentment among sections of the political class. It may be argued that the ECI should not get into the nitty-gritty of manifesto formulation, especially the manner of its implementation, as that will be the political and administrative responsibility of the party that comes to power on the basis of its promises. The guideline itself arose from a Supreme Court judgment in 2013, upholding the right of parties to make electoral promises even if they involved distribution of consumer goods. It was held that such a promise would not amount to a corrupt practice, and as long as these were financed by budgetary allocations cleared by the legislature, they could not be invalidated. The Court also suggested that to prevent extravagant promises from upsetting the electoral level playing field, the ECI could lay down some guidelines. In practice, however, the ECI's guidelines did not elicit enough information, as parties made only routine and ambiguous disclosures. If implemented, detailed financial disclosures may help in informed voter choice, as rival parties are likely to subject manifesto promises to intense scrutiny. It may also have a more meaningful impact, be it positive or negative, on the prospect of a party winning over the electorate with a single flagship promise.

Maja Ma: Bollywood Comes **Out and How**

October 7: "Everything works out if your intentions are pure", says Pallavi Patel played brilliantly by Madhuri Dixit at the start of Maja Ma. And boy, the movie, released on Amazon Prime, indeed espouses the same thought throughout.

Pallavi Patel is your nextdoor middle-class (of course of Bollywood standards) housewife for whom her family means everything. She and her husband Manohar (Gajraj Rao) are getting ready towelcometheir NRIsamdhis who believe in truth only when validated by a lie detector test. Her son Tejas (Ritiwik Bhowmik) has already gone through one. Her daughter Srishti Shrivastav (Tara Patel) is into a long-distance marriage and is an LGBT activist.

Hell breaks loose on this seemingly perfect family when it is discovered that Pallavi, who is the ideal wife, a doting mother, the ideal neighbourhood aunty, is a lesbian.

Everyone reacts according to their understanding of the issue. Basically, all the reactions are on expected, hypocritical lines. The family is subjected to societal stigma. Pallavi does not find support from anyone except her daughter. The entire family relationship dynamics unravel. Worst, Pallavi is subjected to modern-day 'agni pariksha' - the lie detector test. (a ridiculous and horrendous idea, legal aspects apart).

But Maja Ma, written by Sumit Batheja, still works not only on the performance level but on many others. Basically, it's the story and the idea of a



parent, housewife, a mother that holds your attention. The idea was first explored in Arvind Swamy's 'Dear Dad'. Here, we have gone a step further and changed the gender and it is this change that makes all the difference.

It's after a long time Madhuri gets a strong, multi-layered character to essay where there is a lot to emote and say. Needless to say, she does not disappoint even for a second. Casting deserves a special mention here as roping in someone like hardcore mainstream actor Madhuri to play a lesbian helps normalise the talk around the tabooed subject. She provides the necessary grace and dignity to the character of Pallavi.

Madhuri debuted on OTT with her Fame Game wherein she plays a mother who finds out that her son is gay. And she supports him. Now, it is reversed.

She drops her fake Gujarati accent early on in the movie. Her voice sometimes quivering, sometimes sharp - her eyes and body language help us to understand Pallavi's vulnerability and what she goes through when her best-

Cities Globally Warming Nearly 30 Per Cent Faster than Rural Areas: Study

October BEIJING: Cities worldwide are warming by 0.5 degrees Celsius on average per decade, 29 per cent faster than in rural areas,



according to a study which suggests that climate change and urban expansion are accelerating surface temperatures.

Researchers from Nanjing University in China and colleagues noted that planting trees and vegetation in cities — also known as urban greening — is reported to offset about 0.13 degrees Celsius of surface warming per decade in European cities.

People who live in cities experience greater heat exposure during heat wave events than the general population due to the urban heat island effect, in which urban land gets hotter than surrounding rural land, they said. Climate change and population growth in cities are projected to increase the surface urban heat island effect, but many current estimates of future human heat exposure assume equal rates of surface temperature increase between urban and rural areas, the researchers said.

In China and India, they estimated that urban expansion was responsible for over 0.23 degrees Celsius of the observed surface warming in cities per decade. Urban greening is suggested to reduce surface warming, but whether it can slow the accelerating surface urban heat island effect remains unclear, the researchers said.

The study, published recently in the journal Communications Earth & Environment, analysed satellite land surface temperature data for over 2,000 city centers worldwide between 2002 and 2021 and compared them to background rural surface

Very large "megacities" such as Abujia in Nigeria, Phoenix in the US, London in the UK, Sao Paulo in Brazil, Beijing in China, and Moscow in Russia were included in the analyses.

The study estimates that cities are warming 29 per cent faster than rural areas, and that megacities are warming even more quickly.

The researchers estimated that climate change is the largest contributor to urban surface warming. increasing land surface temperatures by 0.30 degrees Celsius per decade, on average.

However, the researchers also found that urban greening in European cities offset 0.13 degrees Celsius of surface warming per decade, indicating the potential of urban vegetation to slow down surface warming in

For example, increased urban greening in Chicago, US was found to decrease the rate of surface warming by about 0.084 degrees Celsius perdecade, they added.

Amit Shah Sends Strong Message to Pakistan, Regional Parties from Soil of Kashmir

October 7: SRINAGAR: Home Minister, Amit Shah, seized his just concluded visit to Jammu and Kashmir to send a strong message to Pakistan and the political parties at home which insist dialogue with neighbouring country is the key to peace by asserting there can be no such engagement 'benefactors of terrorism and violence' in the erstwhile state.

"Those who ruled for 70 years in J&K suggest me to talk to Pakistan. I have a clear view, I do not want to talk to Pakistan, I want totalk tothe Gujjars, Paharis and Bakerwals here Baramulla. I want to talk to the vouth of Kashmir." he said while addressing an impressive public rally in the frontier district of Baramulla on Wednesday.

Several J&K parties including National Conference (NC) and People's Democratic Party (PDP) are of the view that lasting peace cannot be established in the Union Territory unless Pakistan is taken on board and for this the resumption of dialogue with the neighbouring country is inevitable. Former chief ministers Faroog Abdullah and Mehbooba Mufti, the presidents of NC and PDP respectively, had recently urged the Narendra Modi government to resume the stalled dialogue with Pakistan to "ensure lasting tranquillity and peace" in

But Shah asked them to "open your eyes and minds" and give a thought to who "planted the violence of gun and spread terrorism" in J&K. "What good have they (Pakistan) done to Kashmir?", he asked. He accused Abdullah and Mufti of shielding militants, separatist and stone-pelters. "Earlier, this was a terrorist hotspot, now it's a tourism



hotspot. You gave stones andguns in the hands of the youth, whereas Prime Minister Narendra Modiji has given laptops and mobiles into their hands by bringing industries here," Shah said.

An equally strongmessage the Home Minister sought to send across was that violence and militancy will not be tolerated on the soil of J&K. He appealed to separatist militants to shun the gun as treading on the path of violence will only ruin their lives whereas adopting that of peace and development will bring success and happiness to them and ensure a bright future for them and their families.

However, while speaking at a security review meeting with the top-brass of the J&K police, Central armed forces, paramilitary forces, the Army, intelligence agencies and officers of the civil administration in capital Srinagar, he asked them to act tough with those militants who remain adamant and refuse to give up the gun. "The Home Minister asked the security forces and the J&K police to conduct pro-actively countercoordinated terrorism operations to fulfil the Prime Minister's vision of a peaceful and prosperous J&K," an official spokesman here said. He also asked for making J&K free of the gun of violence in the shortest possible time, the spokes man added.

Local political watchers attached significance' to the Home Minister's visit as it was taking place at a time when various political parties including the Bharatiya Janata Party (BJP) are gearing up for campaigning for the J&K Assembly elections. Shah said these elections will be held in a transparent manner once the final voter list and other preparations are completed.

The Home Minister during his 3-day visit, apart from attending official meetings and public rendezvous, met dozens of select delegations including those from political parties, trade organisations and civil society groups in twin capitals of Srinagar and Jammu. He also laid launched several hundred developmental projects and schemes across J&K.

Apparently to strike chord with the followers of three main religions in J&K-Muslims, Hindus and Sikhs-he paused his speech at a rally in Baramulla for 'azaan', as the call for prayer was being given from a nearby mosque, paid obeisance at the revered shrineof Mata Vaishno Devi in the Trikuta hills near Jammu and also visited Srinagar's Chatti Patshahi Gurdwara named after Guru Hargobind Sahib, the 6th Sikh Guru who, who had stayed here for a few

First ODI: With a Late Charge, Sanju Samson Almost Pulls it Off for India

October 7: From the clutches of defeat, Sanju Samson almost scripted a famous heist over South Africa. His 63-ball-86 not out, one of crisp shot-making, dragged India from a crevasse and filled them with hopes of a victory that had seemed beyond them for most part of their chase. But just when it was his hour to seize the night, destiny turned cruel on him and heslipped into the night as a tragic hero, in a bizarrelythrillingmatch that South Africa bagged by nine runs. As gorgeous as his knock was — the unfussy beauty of his strokes, the unreal calm that dwells on his face, the calculation skills, and the pacing of his game Sanju would reflect on this night with a tinge of regret.

He did most things right in the innings. In the early passage of his innings, he farmed the strike to the more assertive Shreyas Iyer. After the latter's exit, he took control of the wheels, seamlessly shifting gears. After strumming the chords on a low pitch, he suddenly raised his tone in the 33rd over striking WayneParnell for two distinct boundaries, showing two different layers of his game. A dismissive pull followed by a dabto the third man, one stroke of pure power and the otherofridiculous placement. But the required rate was still too steep —a further86 runs were required off 42, more than two runs a ball. But Samson and Shardul Thakur seemed assured, and not frazzled, as they whittled down the target to 39 runs off 16 balls, a difficult but realistic equation in this day and age.But then Lungi Ngidi took out Thakur and Kuldeep

Yadav off successive balls and reversed the game's tide. It's a pity that Sanju could face just eight of the next 15 balls. He failed to take a single off Ngidi's last two balls of the 38th over; could not gather strike for a single ball in the 39th over, and was then tasked with the near-impossible task of belting 31 runs off 6 balls. He managed 21, but that proved inadequate.

The seeds of the defeat, though, were sown in the first 10 overs. The top-order wilted as Kagiso Rabada and Wayne Parnell hit high notes, extracting both swing and lift. Rabada was as sharp and mean as a butcher's knife. A ripping in-swinger nipped out Shubman Gill.The late, inward movement defeating Gill's purpose of driving him through cover, but with leaden feet. All he managed was a feathery inside edge. But it was Ruturaj Gaikwad that Rabada handed out a brutal realitycheck. In an over-and-a-half of relentless hostility, he beat both edges of his bat, made him insideedgea couple of times and had him flapping the thin air of a bouncer. Eventually Tabraiz Shamsi consumed him— a neat stumping by Quinton de Kock — as India plunged to 48 for three. Soon, it was to be 51 for four as the craft y Keshav Maharaj had Ishan Kishan caught at leg-slip. It was then that Samson united with Shreyas Iyer and began theresuscitation with a 67run stand, kindling hopes of a victory. Samson, who was playing the sidekick's role had to step into the hero's shoes when Iyer departed, undone yet again by the shortball, his kryptonite. However, India would not have ended up



chasing such a steep total but for the death-overdazzle of familiar nemesis David Miller and Heinrich Klassen, who reeled out 74 and and 75, sewing up 139 runs for the undefeated fifthwicket association, in which 54 runs were bargained off the last five overs. Both were offered respites soon after they had completed their fifties— Ruturaj Gaikwad dropped Miller off Siraj before Siraj spilled Klaasen off Avesh, both fairly straightforward catches.

But the match, for all its late thrills and twists, was inconsequential in the broader context. South Africa, at least, had the motivation of sealing an automatic berth for next year's 50over World Cup, for which they will have to win this series. But less for India and their supporters. The halffilled, or rather half empty stands, captured the story. The encounter, with three-fourth of the regulars abstaining, some had boarded their flight to Australia, did not raise the roof or the decibels. Matches winkon a premium at the venue, but most city residents did not take the trek to Ekana Sportz Cityon theoutskirts of Lucknow, rendering the empty stands emptier. There was no mood for a 50-over game in the shadow of the T20 World Cup in Australia. Besides there was rain, which eventually reduced the game to 40overs a side. But a bizarre thriller it turned out to be.

Daryl Mitchell Ruled Out of T20 Tri-Series with Fractured Hand

October 7: Two weeks before the T20 World Cup, New Zealand suffered a major injury blow. World Cup New Zealand allrounder Darvl Mitchell has been ruled out of the T20 Tri-Series in Christchurch after fracturing his hand during training on Friday

"The all-rounder sustained a blow to his right-hand while batting in the nets, with an X-Ray later revealing a fracture to his fifth metacarpal (pinkie finger)," New Zealand cricket said in a statement.New Zealand team's

physio Theo Kapakoulakis confirmed Mitchell's hand had been placed in a cast which would need to remain on for at least two weeks. Coach Gary Stead said some time was needed to consider decision on Mitchell's availability for the ICC T20 World Cup, with the squad set to depart for Australia on October 15. "It's a real shame for DarvI to suffer this injury on the eve of an exciting period of cricket for the side," Stead said." Daryl's become a really important player to our T20 unit

and we're certainly going to miss his all-round skills and versatility in the Tri-Series. "With our first game of the World Cup in just over two weeks we need to take some to consider Daryl's recovery timeline and his potential involvement in the tournament."Mitchell's replacement is yet to be announced.

New Zealand will play thier first game og the tri-Series against Pakistan at Hagley Oval on Saturday. The other team in the series is Bangladesh.


