What is a Coral?

Corals are tiny animals that have an outer stony skeleton and live in colonies in the sea. They belong to the same animals group as the sea anemones, and jelly fish. Each coral animal is called a polyp and lives inside a cup of carbonate (Limestone). It has a mouth at the top surrounded by tentacles. The tentacles help to capture food like plankton for the coral. While it is alive, a coral poly's tentacles protrude from the cups for feeding. In times of danger, the polyp can withdraw into its cup. This is similar to a turtle withdrawing into its shell when disturbed. A coral polyp cannot move and remains fixed to its cup throughout its life. Coral polyps can be of several species - in A&N alone, 135 species are found.

Coral Colonies :Many thous ands of coral polyps are connected together to form a coral colony. These colonies are of many shapes and colours. On a visit to a nearby coral reef, you can discover the kinds of coral in your area.

A new draft of the much-awaited data protection Bill, the Digital Personal Data Protection Bill (DPDP Bill) 2022, is now open for public comments. The Government had previously withdrawn an earlier draft by averring that it would come up with a "comprehensive legal framework" on data privacy and Internet regulation, and this draft seems to be a standalone attempt at bettering its previous iterations. There are only 30 clauses, for simplicity, but resulting in aspects of privacy protections remaining under-clarified. A case in point is how clauses define the need for consent from data principals for data fiduciaries to process their personal data. Now, a notice is to be provided for the consent of the data principal, and the withdrawal of consent should allow for fiduciaries to remove any such data stored or is to be shared with others. The new draft, unlike the 2018 version, does not refer to key data protection principles such as collection limitation — obligations on the data fiduciaries to collect only such personal data that is required for the purpose of processing. OnePlus Nord N20SE Spotted on Flipkart: Price, Others Details to Consider



November 23: One Plus smartphones have always been available exclusively on Amazon in India. This is also the case with the more affordable OnePlus Nord series of devices. But it appears that the OnePlus Nord N20 SE — which has not launched officially in India- is now listed on Flipkart. The phone was also listed on Amazon, though that listing has been taken down. The pricing makes this the most affordable Nord phone in India.

However, keep in mind that this is not an official listing, meaning the brand has not launched the phone in India. This is likely an imported unit which is being sold for the device, so if you do consider this you not might get brand warranty. According to Flipkart's listing, the Nord N20SE will cost Rs 14,799 while the phone was also listed for Rs 14,799 on Amazon before the listing was removed.

The brand has not launched any Nord N series of smartphones in India so far. The company has already launched this phone in the US for \$178.49.

As mentioned earlier, the OnePlus Nord N20SE is a mid-range smartphone, powered by the Mediatek Helio G35 processor. This makes the OnePlus Nord N20SE a 4G-only smartphone. The device comes with a 6.56-inch 60Hz HD+ (720p) resolution display.

The phone has a dual-camera setup at the back with a 50MP primary camera and a 2MP depth sensor. At the front, the Nord N20SE has an 8MP selfie camera with support for HD video recording capability. A 5,000 mAh battery fuels the device with support for 33W SuperVOOC fast charging and the brand will include the fast charger in the box as per the e-commerce listing.

The entry-level variant of the OnePlus Nord N20SE offers 4GB of RAM and 64GB of internal storage with a microSD card slot for additional storage expansion. Similarly, the device also has dual nano SIM card slots with support for a 4G LTE network and the phone also offers dual-band Wi-Fi and Bluetooth 5.

The OnePlus Nord N20SE will ship with Android 12 OS with custom Oxygen OS 12 skin on top. Unlike One Plus flagships, which receive two to three major Android OS upgrades, the Nord N20SE might just get a single major Android update and is likely to receive Android 13 OS with OxygenOS 13 skin.

6 killed in Firing at Assam-Meghalaya Border; Area Still Tense

November 23: including **GUWAHATI**: In what has triggered tension between neighbouring states, Assam forest guards are alleged to have shot dead at least five people from Meghalaya on Tuesday after the timber mafia attacked a team of the Assam police and forest guards in West Karbi Anglong district of the state, near the border with Meghalaya.

After the violence, authorities suspended mobile Internet services in the border areas of the two states to stop situation from escalating. Security sources said that an Assam forest guard who had accompanied the police team also died and scores more were critically injured in the clash.

Meghalaya Chief Minister Conrad Sangma told reporters that six persons,

Meghalaya and one Assam forest guard. were killed in the incident. He said the injured were rushed to hospital for medical treatment. Sangma said a magisterial inquiry will be initiated into the incident. He said that he has spoken to Assam Chief Minister Himanta Biswa Sarma about the incident and he had assured all kind of support in defusing situation. Fearing a back lash, the Assam police has started alerting travellers from Assam to Meghalaya and diverted hundreds of vehicles

The security sources told this new spaper that a timbercarrying truck was asked to stop at a police checkpost at Moikrang in West Karbi Anglong on the Assam-

going to Shillong.

Meghalaya border at around 3 am on Tuesday. The truck, instead, sped away. The police chased the truck and managed to stop it by puncturing one of its tyres. Three people were held and brought to Jirikinding.

Anglong district, Imdad Ali, told reporters that he asked government servants, another police team to bring workplace ethics and back the seized timber-laden integrity, human resource truck from the location. When the police team reached the location they were attacked by a large crowd armed with sharp weapons and sticks. The police had to resort to firing in self-defence.

Acche Din Begin as PM Modi Offers Jobs to 71,000 People

November 23: NEW **DELHI:** Prime Minister Narendra Modi on Tuesday handed out appointment letters to more than 71,000 youngsters under the Rozgar Mela via video conferencing. This is the second tranche appointment letters that the PM has distributed, while similar campaigns have been held in all states and Union territories in the past month.

"The government is working in mission mode to provide government jobs. The Central government is according the highest priority to utilising the talent and energy of youth for nation-building," the PM said while addressing the gathering.

The physical copies of the appointment letters to the appointees were handed over at 45 locations across the country, except in Gujarat and Himachal Pradesh where the model code of conduct is in force.

In Hyderabad, Union minister of state for tribal affairs Bisweshwar Tudu handed over appointment letters to the newly selected candidates of Telangana at the Group Centre of the CRPF at Chandrayangutta Tuesday CRPF South Zone inspector-general of polie G.V.H. Giri Prasad was present.In addition to the categories of posts filled earlier, posts of teachers, lecturers, nurses, nursing officers, doctors, pharmacists, radiographers and other technical and paramedical posts were being filled. A significant number of posts are being filled by the ministry of home affairs in Central armed police forces (CAPF).On Tuesday, the Prime Minister launched also "Karmayogi Prarambh" module. The module is an onlineorientation course for The SP of West Karbi new appointees. It will include a code of conduct for policies and other benefits and allowances that will help them get acclimated to the policies and transition smoothly into the new roles.

Addressing the new appointees, the Prime Minister said that more than 71,000 youth are being given appointment letters in more than 45 cities, which will result in a new era of



happiness for families. He recalled that on the day of Dhanteras, the Central government had distributed 75,000 appointment letters to the

He welcomed and complimented the new public servants and highlighted their role in the country's resolve to be a developed nation. Hefurtheradded that Goa and Tripura will also organisesimilar Rozgar Melas on November 24 and November 28, respectively.

The Prime Minister touched upon the crisis created for the youth at the global level due to the pandemic and the war. He said that even in these trying times, experts around the world are optimistic about India's growth trajectory. He said, as per the experts, India has become a major force in the service sector and soon it will be the manufacturing hubof the world too. While initiatives like PLI, the Prime Minister said, will play a significant role in this, the main foundation will be the youth and skilled man power of the country. The PLI scheme is likely to create 60-lakh jobs, the Prime Minister asserted. The possibility of new jobs in both the government and private sectors is continuously increasing. More importantly, these opportunities are emerging for the youth in their own cities and villages. This has reduced the compulsion of migration for the youth and they are able to play their role in the development of their area," he said.

SC: Constitution Called for Law on Poll Panel, But Nothing Was Done in 72 yrs

November 23: NEW **DELHI:** The Supreme Court on Tuesday said the Constitution has vested enormous powers on the "fragile shoulder" of the chief election commissioner and the two election commissioners and it wants a CEC of strong character like late T N Seshan.

Seshan was a former cabinet secretary to the Union government and was appointed as the election commissioner (EC) on December 12, 1990 with a tenure till December 11, 1996. He completed his six-year tenure and died on November 10, 2019.

A five-judge Constitution bench, headed by Justice K M Joseph, said its endeavour is to put a system in place so that the "best man" is selected as the CEC.

numerous CECs and T N how can it be done. Seshan happens once in a while. We do not want anyone to bulldoze him. Enormous power has been vested on the fragile shoulder of three men (two ECs and the CEC). We have to find the best man for the post of CEC. The question is how do we find that best man and how to appoint that best man," the bench, also comprising justices Ajay Rastogi, Aniruddha Bose, Hrishikesh Roy and C T Ravikumar, said.



It told Attorney General R Venkataramani, who appeared in the matter on behalf of the Centre, "What is important is that we put a fairly good procedure so that apart from competence, someone of strong character is appointed as the CEC."

Venkataramani said nobody can have any objection to it and in his view, even the government is not going to oppose the appointment of the "There have been best man, but the question is

> "There is no vacuum in the Constitution. Election commissioners are presently appointed by the president on the aid and advice of the council of ministers. When there were no enactments, the Vineet Narain and Vishaka judgments (that laid down guidelines for dealing with sexual harassment at workplace) happened but in this case, there is no such vacuum," he said, adding that the court has to look at the issue from this perspective.

The bench said since 1990, voices have been raised from various quarters and once, veteran Bharati ya Janata Party (BJP) leader L K Advani had written for a collegium-like system for constitutional bodies, including election commissioners.

"Democracy is a basic structure of the Constitution. There is no debate to that. We also cannot tell Parliament to do something and we will not do that. We just want to do something to the issue that has been raised since 1990. The situation on the ground is alarming. We know that there will be opposition from the ruling party to not allow us go past the present system," the bench said.

It added that the court cannot say it is helpless and cannot do anything and there needs to be a system that is different from the present structure of appointment of ECs and CECs.

"I was surprised with the ban. We players are very reflective and point the issues out, but we should talk about football again at some point. It's not my fault that the World Cup was awarded here 12 years ago. I was 15 back then," he said.

"I'm still available for New Zealand, I have the chance to explore other opportunities and I also get to spend more time with my family – which is important,"


