# One positive case detected during test conducted on incoming flight passengers: Director (IP&T)

The Director (IP&T), Shri Alok Kumar while giving information on COVID-19 status stated that during the RT-PCR test conducted on passengers who arrived here yesterday, one positive case has been detected. Today, 11 flights with 1927 passengers arrived, out of which, 1508

were vaccinated with both doses while RT- PCR test was conducted on 419 passengers and the reports are awaited.

During RAT conducted on 160 passengers bound for North & Middle Andaman at Ferrarguni, no positive case been detected. At Mohanpura Bus Terminus, test conducted on 67 passengers and all were found

negative. At Phoenix Bay Jetty, 9 passengers were tested with RAT and were found negative.

# Link between menstrual changes and COVID vaccination should be investigated: BMJ editorial

LONDON: A link between changes in the menstrual cycle and COVID-19 vaccination is plausible, and should be investigated, according to an editorial published in the British Medical Journal on Thursday.

In the editorial, Victoria Male, a reproductive specialist at Imperial College London, UK noted that periods or unexpected vaginal bleeding are not listed as common side effects of COVID-19 vaccination.

Over 30,000 such reports had been made to the UK Medicines and Healthcare Products Regulatory Agency (MHRA) surveillance scheme for adverse drug reactions by September 2, she said.

The expert, however, noted most people find that their period returns to normal the following cycle and, importantly, there is no evidence that COVID-19 vaccination adversely affects fertility.

"One important lesson is that the effects of medical interventions on menstruation should not be an afterthought in future research," Male said.

MHRA states that its surveillance data does not support a link between changes to menstrual periods and COVID-19 vaccines, since the number of reports is low in relation to both the number of people vaccinated and the prevalence of menstrual disorders generally.

However, Male said the way in which data is collected makes firm conclusions difficult.

She argues in the editorial that approaches better equipped to compare rates of menstrual changes in vaccinated versus unvaccinated populations are needed.

Reports of menstrual changes after COVID-19 vaccination have been made for both mRNA and adenovirus-vectored vaccines, she said.

This suggest that, if there is a connection, it is likely to be a result of the immune response to vaccination, rather than to a specific vaccine component, Male said.

The editorial also noted that the menstrual cycle may be affected by the body's immune response to the virus itself, with one study showing menstrual disruption in around a quarter of women infected with SARS-CoV-2.

If a link between vaccination and menstrual changes is confirmed, this will allow individuals seeking vaccination to plan in advance for potentially altered cycles, she explained.

She suggests that doctors should encourage their patients to report any changes to periods or unexpected vaginal bleeding after vaccination to the MHRA's scheme.

# Lakshadweep admin revises travel restrictions in view of Omicron


KAVARATTI: In view of a new coronavirus variant Omicron being reported from various parts of the world, the Lakshadweep administration on Sunday revised the travel restrictions and quarantine norms in the island archipelago.

This new variant is reported to have a significantly high number of mutations and thus, has serious public health implications for the country, the administration said in an order.

It said that anyone wishing to visit the island archipelago shall carry with them a negative RT-PCR test report obtained within 48 hours of the travel and submit the same at the entry and exit points.

This is applicable to crews of mechanised sailing vessels and fish collection boats also, it said.

After reaching the islands, visitors need to follow COVID appropriate behaviour and undergo three days mandatory quarantine, it said and added



that this is not applicable for those who have taken both doses of vaccine 14 days prior to their travel.

No COVID-19 test result is required for inter-island travels for those vaccinated with two doses 14 days prior to their trip, but those who are partially or non-vaccinated not only have to carry a RT-PCR negative test report, they also have to undergo three-days mandatory quarantine.

The other norms are that shore leave would be granted only to those ship crew who have been fully vaccinated and that thermal-scanning of passengers has to be carried out at Kochi and all ports of arrival.

"Wearing of face masks is an essential preventive measure. In order to enforce this core requirement, any person found without wearing a mask in public/workplaces shall be levied a fine of Rs 100 at the first instance and Rs 200 at second instance of violation," the order said.

Deputy Collectors or Block Development Officers have been directed to ensure strict enforcement of COVID-19 appropriate behaviour in all islands at all times, it said.

# Nearly all terrorists involved in civilian killings in Jammu and Kashmir last month neutralised: Sources

NEW DELHI: Nearly all the terrorists involved in the killings of civilians in Jammu and Kashmir last month have been neutralised and the armed forces are now focussing on intelligence-based "surgical operations" involving smaller teams to deal with terror activities in the Union Territory, sources in the security establishment said on Sunday.

They said a "refined" approach to deal with terrorism has been put in place under a more nuanced framework of better coordination among the Jammu and Kashmir police, the intelligence agencies and the Army with an aim to minimise collateral damage.

After a spell of relative calm, Jammu and Kashmir witnessed a spate of killings of innocent civilians last month, triggering apprehensions of an intense cycle of violence and turmoil in the region.

The sources said a major focus of the anti-terror drill has been to achieve "zero loss" of innocent lives and all wings of the security forces have been trying to achieve it.

That is why the focus has been on "intelligence-based surgical operations" involving



smaller teams, with a focus on drawing support from the local population to such actions, they added.

According to intelligence inputs, Pakistan-based terror handlers have instructed their proxies operating in Kashmir to ensure at least 10 civilian deaths whenever the security forces undertake counter-terror operations, the sources said

They said 24 civilians were killed and 49 injured in various counter-terror operations in 2018.

Over the past three years, the security forces undertook a series of measures to ensure minimum collateral damage and as a result of such efforts, only two civilians were killed and two received minor inju-

ries in 2021, the sources said.

Asked about the encounter in Srinagar's Hyderpora, they said a certain section is focussing on it to occupy "lost space".

Jammu and Kashmir police chief Dilbag Singh on Thursday said the ongoing investigation into the Hyderpora encounter suggests that the terrorists were supported by a network in carrying out terror activities.

The sources said the security forces have been getting support, including actionable intelligence, from the locals in several parts of Jammu and Kashmir as they have rejected the "false propaganda" unleashed by Pakistan.

# Omicron variant: Government to review decision on restarting international flights, SOP for incoming passengers

NEW DELHI: The government on Sunday decided to review the decision on resuming scheduled commercial international passenger services as well SOP on testing and surveillance of incoming passengers, especially from countries identified as 'at risk', in the wake of the emergence of the new COVID-19 variant of concern 'Omicron'.

The decisions were taken at an urgent meeting chaired by Union Home Secretary Ajay Bhalla and attended by various stakeholders, an official spokesperson said.

The meeting was held a day after a high-level review by Prime Minister Narendra Modi on the new COVID-19 variant of concern 'Omicron'.

After a long hiatus of more than 20 months, the government had on November 26 announced the resumption of scheduled international commercial flights from December 15.

The home ministry spokesperson said at the meeting, chaired by the home secretary, the overall global situation in the wake of the Omicron virus was comprehensively reviewed and various preventive measures in place and to be further strengthened were discussed.

The government will review



the decision on the effective date of resumption of scheduled commercial international passenger services as per evolving global scenario, the spokesperson said.

The new, potentially more contagious B.1.1.529 variant was first reported to the World Health Organisation (WHO) from South Africa on November 24 and has also been identified in Botswana, Belgium, Hong Kong and Israel.

It was on Friday designated as a "Variant of Concern" by the WHO, which named it Omicron.

A variant of concern is the WHO's top category of worrying COVID-19 variants.

"Government to review Standard Operating Procedure on testing and surveillance of incoming international passengers, especially for those countries identified 'at risk' category," the spokesperson said in a series of tweets.

The government has also

decided that the genomic surveillance for variants will be further strengthened and intensified and Airport Health Officials (APHOs) and Port Health Officials (PHOs) will be sensitised for strict supervision of testing protocol at airports and seaports.

"Decision on effective date of resumption of scheduled commercial international passengers service, to be reviewed, as per evolving global scenario," the spokesperson said.

A closer watch on the emerging pandemic situation within the country will be maintained, the spokesperson said.

The meeting was held with various experts including V K Paul, Member (Health), NITI Aayog, Vijay Raghavan, Principal Scientific Adviser to Prime Minister, senior officers from Health, Civil Aviation and other Ministries.

# Ahead of parliament session, NDA ally calls for repealing CAA



NEW DELHI: The ruling NDA is likely to be on the backfoot during the winter session of Parliament with the first sign of trouble coming up during the NDA coordination meeting on Sunday when ally National People's Party sought withdrawal of the Citizenship Amendment Act (CAA).

NPP leader Agatha Sangma told reporters that the government has taken note of her demand for repealing the CAA on the lines of the three farm laws. The government hasn't yet notified the rules of the CAA, which is seen highly-sensitive in the Northeastern states, including Assam.

After PM Modi's dramatic television announcement of the repeal of the farm laws, some opposition parties had called for similar action on the CAA since "a large number of people remains opposed to it".

The winter session, beginning Monday, is likely to take off on a stormy note as Lok Sabha will take up the Farm Laws Repeal Bill, 2021, with the Opposition throwing their weight behind the demands of the farmers' unions. Despite claims of multiple schemes benefiting small farmers, the NDA dispensation is not confident about its farm narrative in the absence of strong communicators within its ranks.

The legislative flurry shown by the NDA in the past may also take a pause with the Opposition in Rajya Sabha likely to press for sending bills to the standing committees for wider scrutiny before both Houses take them up for passage.

Unlike the previous sessions of Parliament when the government ensured passage of bills in a din, the resurgent Opposition, particularly the Trinamool Congress, which, eyeing a bigger role in national politics, may pose challenges for the ruling NDA, which barring the BJP and JD (U), is without any big ally in both the Houses. Making clear of its ambitions, the TMC has sought to dictate the agenda of Parliament, calling for passage of the Women's Reservation Bill.

Posturing of the opposition parties on Sunday clearly indicated that the Assembly elections in five states next year will weigh heavily on the winter session. It is likely to be an opportunity for the Opposition to set the narrative for the upcoming polls by putting spotlight on price rise, farm distress and unemployment.

Meanwhile, the BJP in its parliamentary party meeting on Sunday stressed on higher attendance of its MPs and asked them to come prepared to take on the opposition.

# Some parties express concerns over SC commenting on functioning of Parliament, other legislatures

NEW DELHI: Expressing concerns over the Supreme Court commenting on the functioning of Parliament and other legislatures and the manner of law-making, some leaders on Sunday told Rajya Sabha Chairman M Venkaiah Naidu that it is for the presiding officers to act in case of any violation and other constitutional bodies should not make adverse remarks on it.

The issue was raised in a meeting of leaders of various parties convened by Naidu at his residence ahead of the Winter Session beginning Monday.

According to sources, the leaders said that it is for the presiding officers of legislatures to take appropriate action if norms of functioning are be-

ing violated by any member or party and other constitutional agencies should not comment adversely.

Responding to the leaders, Naidu said, "I can understand your concerns. But such comments should be viewed in the context of the functioning of legislatures marked by persistent disruptions, unruly behaviour and violent actions which have deleterious effects."

"The best way to counter them is to ensure proper functioning of the legislatures by maintaining dignity and decorum of the house since such comments are finding resonance with the public from what they see," a source quoted Naidu as having told the meeting.

About 40 leaders of vari-

ous parties and ministers attended the meeting. While Parliamentary Affairs Minister Pralhad Joshi briefed the meeting about the legislative agenda, Leader of the Opposition Mallikarjun Kharge and leaders of other parties raised the issues that they want to be discussed during the Winter Session.

Some leaders expressed concern over the course of events during the last Monsoon Session when 70 per cent of the functional time of the House was lost due to persistent disruptions.

Many leaders stressed that they are in favour of smooth functioning of the House and called for a productive Winter Session.

Naidu urged the government and the opposition to regu-

larly talk to each other to enable effective functioning of the House. He appealed to all sections to cooperate in ensuring a productive Winter Session, the sources add.

The Monsoon Session of Parliament was washed out over the opposition demand for a discussion on the Pegasus snooping issue.

The issue is still alive and the opposition will continue to press its demand, even though the Supreme Court has intervened and set up a committee to look into it.

In the Winter Session, the opposition will also seek to raise the issue of farmers' protests and press for bringing a law to grant minimum support price for crops.

terrorists even being allowed to escape when there was a threat of collateral damage or when the lives of innocents were assessed to be at risk," said a source on condition of anonymity.

The sources claimed that the situation in Jammu and Kashmir has been under control and pointed out that compared to the 318 terror-related incidents in 2018, only 121 incidents were reported in 2021.

"Similarly, while 202 stonepelting incidents were reported in 2019, only 39 have been reported in 2021," said another source.

The sources said elements close to the Pakistani establishment have been relentlessly attempting to instigate the Kashmiri people.

On October 7, terrorist Mehran Yaseen Shalla killed two teachers inside a government boys' higher secondary school at Safa Kadal, Srinagar.

Shalla was killed by the security forces on November 24, the sources said.

Terrorist Adil Ah Wani killed Sageer Ahmed Ansari, a carpenter and a resident of Saharanpur, near the Litar bus stand in Anantnag.

Wani was killed by the security forces in Shirmal Shopian on October 20 under the "Operation Dragad", the sources said, citing certain anti-terror operations.

On October 17, terrorist Gulzar Ahmed Reshi was involved in the killings of two labourers from Bihar and one labourer was injured at Wanpoh in Kulgam.

Reshi was killed by the security forces on October 20 under the "Operation Sopat", the sources said.

# MP demands to resuming 6.00 AM morning convoy from Jirkatang to Middle Strait and increasing the number convoy to four

Port Blair, Nov 26: The Member of Parliament of Andaman and Nicobar Islands, Mr. Kuldeep Rai Sharma has requested the Chief Secretary of Andaman and Nicobar Administration to resume 6.00 AM morning convoy and also to increase the number of Convoy from Jirkatang to Middle Strait to four.

In a letter addressed to the Chief Secretary the Member of Parliament today said that the unemployed youths associated with Tourism Industry in Baratang Island are suffering heavy loss because large numbers of Tourists are unable to reach Baratang

Island due to the limit of allowing only 90 vehicles in 8.30 AM morning convoy from Jirkatang.

He added that atleast 20 to 30 tourist vehicles are not getting permission on daily basis to travel to Baratang from Jirkatang, which is not only causing loss to Tour Operators of Port Blair and Boat Operators of Baratang but also leaving a bad impression about Andaman, on the visiting Tourists.

Mr. Kuldeep Rai Sharma pointed out that most of the Tour Operators of Port Blair and Boat Operators of Baratang are unemployed youths, who have taken loan from Banks to run Tourism Activities in Andamans but due to the pandemic and lockdowns they have already suffered a huge loss in recent past and now when things have become normal, they are unable to reap the benefits, because of these restrictions.

He mentioned that there are three convoys from Middle Strait for Jirkatang at 6.30 AM, 11.30 AM and 2.30 PM but there are only two convoys from Jirkatang to Middle Strait, even when there is more pressure of passengers and tourists from Jirkatang side.

He mentioned that in case of COPRA, delay in procurement means further loss to the farmers as the COPRA gradually dries up and the weight decreases, hence immediate steps to resolve this issue is necessary.

"India has never had a female MMA champion in the past and now I have the power to change the narrative and place an Indian woman on the global MMA stage. I will try my best to make India proud," said Phogat in a release.

Muay Thai is also a form of martial arts which originated in Thailand, and is sometimes called "art of eight limbs".

"I've been focused on the finals for a very long time and I've trained for countless hours for the past two years."

Her opponent, Fairtex, is widely regarded as the most dangerous striker in the atomweight division.

Phogat, 27, said her wrestling experience will give her advantage over her Thai rival.

"Stamp is definitely a formidable opponent but she doesn't have the kind of wrestling experience and background that I have built over the last seven years. I am certain that my superior wrestling background will give me an edge," she said.

"Also, I've been training extensively and pushing through my wins and my losses, and I plan to make 3rd December an extraordinary match in MMA history. My improved striking capability and game plan will be on display for everyone to see inside the circle."

Mr. Sharma added that together with tourists, residents of the North Andaman region are also going through a difficult time due to the availability of only two convoys from Jirkatang to the Middle Strait that too late in the morning.

He said that for Islanders, especially those who are traveling to Diglipur and other

parts of North Andaman, the early morning convoy at 6.00 AM is the best option as in that case, they can reach their destination before evening. Presently in 8.30 AM convoy, often because of vehicle breakdowns, adverse weather conditions, or delay in vehicle ferry movements, the ATR passengers reach Diglipur by late-night, which is both risky

and troublesome.

The Member of Parliament pointed out that when normalcy has returned in the Andaman and Nicobar Islands and the number of flights has increased there is also a need to increase the number of Convoy from Jirkatang to Middle Strait to four, as it was before the lockdowns.
