# LAND CONVERSION FILES IN STAGNANT MODE

## Applying for land conversion? Be prepared for a long haul

PORT BLAIR, NOV 23/--/At a time when various State governments have been taking measures to make the land conversion process easier and simple, the Revenue Department of the UT administration has been drawing flak for inordinate delays in starting the land conversion process. As per sources, land conversion process has been completely halted in the islands for almost two & a half years and scores of applications are piled up in the department, gathering dust & cobwebs.

Over 1400 applications seeking conversion of land are pending with the Revenue department. Applicants have been approaching the department on a daily basis pleading for starting the process. But every time they are told "No land conversion as of now". Due to halting of the land conversion process, land conversion applications are piling-up high in the

# Corruption-accused minister enjoying 5-star luxury in jail: Anurag Thakur's digat 'Kejriwal model'

JAIPUR, NOV 23 /--/ Union minister Anurag Thakur on Wednesday referred to a purported leaked video that showed Delhi minister Satyendar Jain having a meal inside his jail cell to launch an attack on the AAP, saying a minister facing corruption charges was enjoying "five-star luxuries" in prison.

Fresh videos of Jain emerged on Wednesday in which he is seen eating uncooked vegetables and fruits in his Tihar Jail cell, with Union minister Meenakshi Lekhi alleging he was enjoying facilities

akin to a holiday resort. Jain's advocate has, however, claimed that the video was doctored. "The Health minister of AAP in Delhi has been in jail for the past six months and is enjoying entertainment and massage. How luxuries are enjoyed in jail and how entertainment and massage are done, AAP is a live example of it. "They tell lies. They talk about problems related to prison food but get food plates better than (those available in) five-star hotels in jail. They get mineral water and massages there," Thakur told reporters here.

The Union Information and Broadcasting minister said this was the model of Delhi Chief Minister Arvind Kejriwal where five-star facilities were provided in jail. "Arvind Kejriwal gives a certificate of honesty to such people who are in jail for the past six months.

This is Kejriwal's model," Thakur said. The BJP leader also said the people of Gujarat would not accept the AAP, whose ministers in Punjab and Delhi were facing corruption charges. He said the AAP had made big claims ahead of Assembly elections in Uttar Pradesh and Uttarakhand but ended up forfeiting their security deposit. "On all the Assembly seats, the security (deposits) of AAP candidates was forfeited in Uttar Pradesh. They could not get even one seat in Uttarakhand. The Health minister in the Punjab government had to resign on corruption charges.

The Education minister in Delhi is facing charges in a liquor scam. The people of Gujarat will not accept them," Thakur said. He also targeted the Congress government in Rajasthan, alleging the law-and-order situation deteriorated under Chief Minister Ashok Gehlot.

'Every day, some news or other comes from Rajasthan -- be it about crimes against women or atrocities against Dalits, Law-and-order situation has deteriorated. Just think about the image of Rajasthan that is being created," he said. (PTI)

# NIA set to formally take over Mangaluru blast case

MANGALURU, NOV 23 /-Mangaluru autorickshaw blast case would be formally handed over to the National Investigation Agency (NIA) Karnataka DGP Praveen Sood said on Wednesday.

He said the objective of Mohammed Shariq was to create a divide between communities. "What else was the objective? His aim was to create differences between two communities, is no doubt. there between Differences communities be it Hindu, Muslim, or Christian grow when there is a blast. It means destabilising the country. He definitely intended to disturb communal harmony and unity...," the DGP said. Karnataka Home Minister Araga Jnanendra visited the blast site near here. along with Sood, and also the hospital where Shariq auto-driver Purushottam Poojary were being treated Jnanedra said Shariq had visited different places like Coimbatore and Kanyakumari and an investigation has been on. Several police teams have been formed and been sent to different places as part of the probe.

Sood said the NIA and other central agencies have been working with the Karnataka police from dayone of the blast, adding that the case would be formally handed over to NIA. With demand growing for an NIA in Mangaluru, Jnanendra said the State government has brought this to the notice of the Centre, and expressed confidence there would be set an office in this coastal town. The Minister said the police were working to find the background of the accused in the November 19 blast at Nagori here, his financiers, and, "the forces which are compelling him to repeatedly do such acts.' Jnanendra said Shariq had planned a major blast, but "the bomb exploded midway and did not go off the way it was planned". "If the entire cooker (carried Shariq in the autorickshaw) had exploded then it would have led to major damage. He (Shariq) had managed to create a bomb using materials available locally," said the Home Minister.

He said the Home Department has resolved to "completely eradicate the fanatical forces which want bloodbath and kill people and try to disturb the unity and integrity of the country". "Our department has not taken this case lightly. An indepth study and inquiry will take place. We will expose the forces behind the case," the Minister vowed Jnanendra said Shariq was travelling as a Hindu and carrying a Hindu photo identity card with him, "So that no one could suspect him". Further, he used to frequently change his address and that it became difficult to trace him. The Minister said Shariq was arrested in an objectionable graffiti case in Mangaluru showing his support to the Islamic State and the Lashkar-e-Toiba, but the High Court granted him bail after he spent seven to eight months in jail. After coming out, he worked in a shop at Thirthahalli in Shivamogga district. He was under watch till then, but he disappeared all of a sudden, Jnanendra said.

According to him, those involved in this case used different modes communication. Sood requested the media to not portray people brought for interrogation as accused. Citing the example of Prem Raj, whose Aadhaar card Shariq had used, Sood said he has an important role in

## Congress model means casteism and vote bank politics which creates rift among people: Modi

MEHSANA, NOV 23 /--/ Prime Minister Narendra Modi on Wednesday said the "Congress model" meant casteism, division, and vote bank politics which has "ruined" Gujarat and the entire country.

Canvassing for BJP candidates at Mehsana in poll-bound Gujarat, Modi said the Bharatiya Janata Party never endorsed the policy of "fayouritism and discrimination" which is evident in youths reposing faith in the ruling party. "Congress model means corruption, nepotism, dynastic politics, sectarianism and casteism. They are known for indulging in vote bank politics and creating rifts between people of different castes or even in different districts to be in power. "This model has ruined not just Gujarat but also India. This is the reason why we have to try hard today to take the country ahead. We (BJP) have never endorsed such a policy of favouritism and discrimination. That is the reason youths are reposing their trust in us," the prime minister said.

Earlier in the day, Congress leader Rahul Gandhi targeted the ruling party after 'Bharat Jodo Yatra' led by him entered Madhya Pradesh and alleged the BJP "first spreads fear in the minds of youth, farmers, and labourers and when it sets in, they convert it into violence". Polling for 182 Assembly seats in Gujarat will be held in two phases on December 1 and 5. The counting of votes will be taken up on December 8. The north Gujarat region will vote during the second phase. "They (Congress) always wanted to keep people poor so they remain dependent on government," the prime minister said while addressing a rally in the north Gujarat town. He said voungsters are confident that BJP's policies will create more opportunities for them in the future. The PM said youths in the age group of 20 to 25 years may not even know the kind of hardships faced by the people of Mehsana district in the past including acute shortage of water and electricity. "Droughts were also common in those days. We (BJP) had put Gujarat on the path of prosperity amid natural calamities and using limited resources. In the past, water and electricity used to be the major issues during polls. Today, the opposition can't speak on these issues because such issues are resolved by us,' said Modi, who had served as the chief minister of Gujarat before assuming the office of the Prime Minister in 2014

The PM recalled several farmers including youngsters had been killed in police firing for demanding electricity connections when Congress was in power. "People have to pay bribes to get electricity connection in the Congress rule. To change the situation, we started reforms in the power sector by laying new transmission lines and setting up transformers. From just 5 lakh agricultural connections two decades back, Gujarat now has 20 lakh such electricity connections," he added. The prime minister also said the solar power generation in Gujarat has gone up to 8,000 MW while the windbased power generation has touched the 10,000megawatt mark. The prime minister is also scheduled to address poll rallies at Dahod, Vadodara, and

JAIPUR, NOV 23 /--/ Congress leader Sachin Pilot on outfit to disrupt the Bharat Jodo Yatra if its demand to make him the Rajasthan chief minister is not accepted, and instead accused the BJP of trying to create "disturbances".

Gurjar Arakshan Sangharh Samiti leader Vijay Singh Bainsla has threatened to oppose Rahul Gandhi's yatra in the state unless his demands, including making Pilot, a prominent face from the community, the chief minister are accepted. Bainsla has also accused the Congress government of not fulfilling the promises made to the community. "No matter how hard the BJP tries, the vatra will be successful," Pilot said when asked about Bainsla's threat. "The BJP may try to create disturbances...but it is 'Bharat Jodo Yatra' and it will be successful. We will all welcome the yatra with unity," he said outside the party's war room where a meeting has been convened to review

preparations for the foot march. On Bainsla's remarks that the community had voted for the Congress believing that a Gurjar leader will be made the chief minister, Pilot said the Congress was reduced to 21 seats in the 2013 assembly elections, but the people gave it a mandate in the 2018

The former deputy chief minister said he was confident that the yatra will be "historic" and that the people are excited. "People from all communities want the yatra to come to the state. From here, it will be a new beginning for the Congress for elections and for the people of the state," he said. The Congress leader, who attended the meeting at the war room briefly, said the yatra is expected to enter Rajasthan between December 3 to 6, but the exact date will be fixed later. "The yatra will be taken out for 15-18 days and will culminate with a rally in Alwar. It will be a big rally in view of the assembly elections next year and will give a positive message," he added.

The Gurjar community constitutes five to six per cent of the state's population and is influential in over 40 seats, mainly in eastern Rajasthan. This region includes the districts from where the yatra is scheduled to pass. Infighting between Chief Minister Ashok Gehlot and Pilot over the post of chief ministers has been going on for long, an issue which has triggered two political crises in four years of the Congress government. # Significant increase in Yamuna pollution since 2017, finds Delhi govt report

As the Delhi government has promised to clean the bathing Yamuna standards by 2025, the pollution load in the river has increased substantially over the last five years, according to a report by the

environment department. The report shows that barring Palla, the annual average level of biological oxygen demand (BOD) increased at every location of water sample collection for testing in the national capital. BOD, an important parameter for assessing water quality, is the amount of oxygen required by aerobic microorganisms to decompose organic material present in a water body. BOD per litre (mg/l) is considered good. There was no immediate reaction available from environment department. The Delhi Pollution Control Committee (DPCC) collects river water samples at Palla. where the Yamuna enters Delhi; Wazirabad, ISBT bridge, ITO bridge, Nizamuddin bridge, Agra Canal at Okhla Barrage, Okhla Barrage Asgarpur. The DPCC data showed while there has been no major change in the annual average BOD level at Palla over the last five years (from 2017 to 2022), it has increased from around 3 mg/l to around 9 mg/l at Wazirabad.

The BOD level has risen from around 30 mg/l to 50mg/l at the ISBT bridge and from 22 mg/l to 55 mg/l at the ITO bridge during the period. Similarly, the BOD level worsened from 23 mg/ 1 to around 60 mg/l at Nizamuddin bridge, from 26 mg/l to 63 mg/l at Agra Canal at Okhla Barrage, from 26 mg/l to 69 mg/l at Okhla Barrage and from around  $30\,mg/l$  to  $73\,mg/l$  at Asgarpur, the data showed. The Yamuna river can be considered fit for bathing if BOD is less than 3 milligram per litre and dissolved oxygen (DO) is greater than 5 milligram per litre. Dissolved oxygen (DO) is the amount of oxygen available to living

aquatic organisms. Aquatic life is put under stress if DO levels in the water drop below 5 mg/l. Twenty-two drains carrying domestic wastewater and industrial effluent fall into the Yamuna between Wazirabad and Okhla. Though the 22km stretch is less than two per cent of the river length, it accounts for about 80 per cent of the pollution in the

Though a minimum environmental flow is required to clean the river to bathing standards, treating all the domestic wastewater and industrial effluent and further cleaning it using insitu techniques can help reduce pollutant load significantly, according to eminent environmentalist Manoj Mishra.

In-situ bioremediation techniques involve treatment at the site using aquatic plants or microbial remediation methods. Such systems take less time to become operational, are easy to operate, and require less energy as compared to conventional treatment

technologies. Some common in-situ treatment systems are microbial bioremediation, phytoremediation, constructed wetland system and root zone treatment. Adequate space appropriate flow general requirements for adoption technologies. (PTI)

# Rozgar Mela, on a mission mode

Lack of employment opportunities is a serious problem in India. The Rozgar Mela (employment fair) is a step towards fulfillment of the commitment of Prime Minister Narendra Modi to give top priority to job generation. At the same time, the government's recent Rozgar Mela initiative, which promises to offer 10 lakh jobs, is an oblique admission of this complex situation. Last month, appointment letters were handed over to 75,000 newly inducted appointees at Rozgar Mela. Appointment letters were given for several posts including Central Armed Police Force, Sub Inspector, Constable, and Income Tax Inspectors, among others. This time, the posts of teachers, lecturers, nurses, nursing officers, doctors, pharmacists, radiographers and other technical and paramedical posts are also being filled up. The Central government can go on a hiring spree as it recently admitted that around 10 lakh posts in various Central government departments were lying vacant. The Rozgar Mela most likely see BJPruled states taking part and filling up some vacancies in state departments. When Prime Minister Narendra Modi handed out the appointment letters, he pointed out that similar campaigns have been held in NDA-ruled states and union territories in the past one month. "This is the double benefit of double engine governments. The campaign to hand over appointment letters to the youth shall continue in a sustained manner," was his message, loud and clear. Double engine government has been a campaign issue for the BJP in several assembly elections, including the recently concluded in Himachal and the upcoming polls in Gujarat. Tripura too will go to polls early next year. The prime minister said in the past one month alone union territories and NDA-ruled states have handed out appointment letters to thousands of youth. In the past one month alone, Maharashtra and Gujarat have handed out thousands of appointment letters. A few days back Uttar Pradesh government too has handed out appointment letters to several youth. Jammu and Kashmir, Ladakh, Andaman and Nicobar Islands, Lakshadweep, Dadra and Nagar Haveli, Daman and Diu, Chandigarh too have organized Rozgar Melas and handed out jobs to thousands of youth.

The holding of Rozgar Mela showed that the government was working in mission mode to provide jobs to the youngsters of the country. The Prime Minister's Office said the campaign is a step towards fulfilling his commitment to according highest priority to employment generation, and it is expected to be a catalyst in creating more jobs and providing meaningful opportunities to the youth for their empowerment and participation in national development directly. The government has long remained in denial mode on the issue of employment and the quality of jobs. It asserts that start-ups and the gig economy were creating millions of jobs. This claim has been belied by various job surveys—both government and private sector. Start-ups are creating jobs, but many of them have disrupted existing businesses, making several old business establishments redundant. So, a lot of people who were employed elsewhere are joining the now famously known gig economy.

# NPS will be a major election issue during 2024 poll

Employees are going on throughout the country against the no-guarantee National Pension System (NPS) implemented by the BJP-led NDA government during the year 2003. The central government and state government employees are grateful to the Communist Party of India for adopting a resolution against the NPS and demanding restoration of defined, guaranteed and non-contributory old pension scheme in the 24th Congress of the CPI held at Vijayawada from October14 to 18, 2022.

Recently, during the month of September, more than 3,000 defence civilian employees assembled at Jantar Mantar, New Delhi, and staged an anti-NPS dharna and submitted a memorandum to the government demanding for scrapping the NPS and restoring the old pension scheme. In Kerala the AITUC led state government employees' organizations led a strong 25,000 employees 'March to Secretariat' demanding withdrawal of NPS and for bringing back the old pension scheme for the state government employees.

The BJP government in 2003 under the pressure and dictates of the World Bank and IMF implemented the contributory NPS with lot of fanfare propagating that the employees would get a huge amount as pension, since the pension contribution of both the employees and the government would be invested in the stock market. Today after 18 years of the implementation of the NPS, the government stands totally exposed. Employees who are retiring after 18 years of service in the NPS is getting a very paltry monthly pension of Rs 2,000 to Rs 4,000 depending upon the value of annuity which they are purchasing from the 40 per cent of the pension fund available in their account. In the old pension scheme the minimum pension itself is Rs 9,000 and every year to compensate the price rise two instalments of dearness relief are being paid to the pensioners. Under the NPS the pension remains static and no provision for compensation of price rise.

The NPS is nothing but a gambling or a lottery. If there is a crash in the stock market, the burden of getting less amount of pension should be shouldered by the poor

pensioner. From various global studies it is revealed that most of the private pension funds were wiped away in the deep economic crisis. The argument put forth by the Vajpayee government in 2003 was that more than 25 per cent of the country's budget is eaten away by the pensioners. But the fact remains that the government gets back a major portion of the pension, either as income tax or through GST which is collected from the pensioners on whatever he or she is purchasing from the market.

Under the Pension's Act 1871 enacted during the British regime, pension is a bounty, given as a matter of grace depending upon the sweet will of the employer. In the year 1971 the Supreme Court has ruled that pension is not a bounty payable on the sweet will and pleasure of the government and that, on the other hand, the right to pension is a valuable right vesting in a government servant. The Supreme Court further held that pension is a property. In another historical judgment delivered on December 17, 1981 by the five member bench of the Supreme Court of India consisting of Chief Justice DY Chandrachud, Justice VD Tulzapurkar, Justice DA Desai, Justice O Chinnappa Reddy and Justice Baharul Islam declared that pension is neither a bounty nor a matter of grace depending upon the sweet will of the employer and that it creates a vested right subject to 1972 Rules which are statutory in character, because they are enacted in exercise of powers conferred by the Proviso to Article 309and Clause (5) of Article 148 of the Constitution; that Pension is not an ex-gratia payment, but it is a payment for the past service rendered; and it is a social welfare measure rendering socio-economic justice to those who in the heyday of their life ceaselessly toiled for the employer on an assurance that in their old age, they would not be left in the lurch.

assembly elections in mind has reduced the restoration of commuted pension after 13 years instead of 15 years. Apart from this in the old pension scheme, pension increases by 20 per cent from 80 years to less than 85 years, 30 per cent from 85 years to less than 90 years, 40 per cent from 90 years to less than 95 years, 50 per cent from 95 years to less than 100 years and 100 per cent of the basic pension from 100 years or more. At present the Parliamentary Standing Committee has recommended that pension should be increased by one per cent every year that is five percent after 65 years and soon.

ILO Convention No102 ensures periodical payments, corresponding to at least 40 per cent of the reference wage, ILO Convention No 128 ensures periodical payments corresponding to at least 45 per cent of the reference wage and ILO Convention No 121 ensures periodical payments corresponding to at least 50 per cent of the reference wage. This 50 per cent is ensured in the old pension scheme, whereas in the NPS there is no such guarantee of any minimum pension.

When the NPS was introduced in 2003 by the BJP government, the Left Front governments' of West Bengal, Kerala and Tripura refused to implement the NPS and continued with the Old Pension Scheme. Subsequently, after changes of governments, Kerala and Tripura have introduced the NPS and West Bengal is continuing with Old Pension Scheme. Considering the forthcoming elections and the ill effects of the NPS, the state governments of Rajasthan, Chhattisgarh, Jharkhand and Punjab have already withdrawn the NPS and have restored the old pension scheme for their employees.

It is now the right time for the central government employees and the state government employees to relentlessly fight against the NPS so as to make it a major issue for the 2024 general elections. The government employees and their families should decide that they will vote only for those political parties which are opposed to NPS and which are assuring that they will restore the old pension scheme if they come to power. # Future of India starves

The 17th edition of the Global Hunger Index (GHI) is out this October 2022; the image drawn by the said index is not at all  $rosy. \ Globally the progress \, against \, Hunger$ has "stagnated" due to various issues like ongoing conflicts between various countries across the globe notably Russo-Ukraine War, climate change, and the economic fallout post-Covid-19 pandemic.

GHI is jointly released by "Concern international humanitarian organization dedicated to tackling poverty in the world's poorest countries) and "Welthungerhilfe" (the largest private aid organization in Germany independent of politics and religion) every October since 2006, and is used as a comprehensive indicator for measuring and tracking Hunger at a global, regional and national level. GHI ranks individual countries on a 100-point scale, where, 0 means No Hunger. GHI scores are based on 04 indicators: Under-nourishment (% of the population whose caloric intake is insufficient); Child Mortality (mortality rate of children under the age of 05 years); Child Wasting (% of children under 05 vears, who have low weight for their height); and, Child Stunting (% of children under 05 years, who have low height for Among the 121 countries that

participated in this compound index in this edition, 44 countries are marked for having serious or alarming levels of hunger, India being one of them, which ranks at 107 (plummeted down from last 2021 index where India ranked 101). Such alarming levels of Hunger in Indian Society jeopardize the pledged Sustainable Development Goal (SDG) Goal 02: Zero Hunger, to be achieved by 2030. India has a score of 29.1 in the compounded index of GHI, ranking it at 107th which is behind most of the neighboring countries except Afghanistan which is ranked 109th out of **FOCUS**

121 countries. According to the latest GHI 2022 data, India has the highest Child Wasting Rate (19.3%) among all countries that are covered by GHI. Though the rate of Child Stunting and Child Mortality has declined, prevalence the undernourishment has risen from 14.6% in 2018-2020 to 16.3% in 2019-2021; which implies that 224.3 million people in India of 828 million undernourished.

Such plummeting ranking of India in GHI has again provided a fertile ground for political mudslinging in this Democratic State of Affairs. In response to the scenario,

the Union Ministry of Women and Child Development issued a criticism saying that "consistent effort is vet again visible to taint India's image as a Nation that does not fulfill the food security and nutritional requirement of its population". The Govt. marked that the Index is an erroneous measure of hunger and suffers from serious methodological issues. It further stated that the report is not only disconnected from ground reality but also chooses to deliberately ignore efforts like Eat Right India Movement by FSSAI: POSHAN Abhiyan; Pradhan Mantri Matru Vandana Yojana; National Food Security Act (NFSA) 2013; to ensure food security for its population.

Before we jump into conclusions and align ourselves to any of the views presented by our political representatives, it must be noted here that there may be some methodological issues present in the Global Hunger Index, as it is not only India but there are others, who have raised

concerns about the methodologies used in GHI, especially the sample size (~3,000) used for the calculation of such a comprehensive index, representing a national, regional and international image, which may nullify the Government efforts about securing food security for its population, but what about the data that Government itself has provided regarding nutritional status of the population through its National Family Health Survey (NFHS) 2019-2021. Is it reliable or again the resources (from the pool of diminishing resources of this overpopulated country) used for such a survey has all gone down the

NFHS 2019-21 notes that the rate of Child Stunting (% of children under 05 years, who have low height for their age) in India stands at 35.5% while the rate of Child Wasting (% of children under 05 years, who have low weight for their height) is 19.3%, similar to the figure noted by GHI 2022 and which is ALARMING as it crosses the WHO permissible limit of 15%. Thus, both GHI data at the international level and the national data made available by the Govt. of India, state that India has the highest number of \*wasted\* children across the globe, which makes the future of Indian Society bleak.

The Bleakness of the Indian Future can be drawn from another facet of NFHS 201921 data, where Wasted Children in Indian Families are classified based on  $Socio Economic\,Status.\,It notes that\,Families$ belonging to the top 20% have only 23.1% of wasted children, whereas families belonging to the bottom 20% have 46.4% of


wasted children; i.e., the difference between the two extreme sections of the Indian Society in the case of Child Wasting is 100%. Now, it is clear that socioeconomic status is inversely proportional to the rate of Child Wasting. The lower the socio-economic status the higher the chance of a child being wasted. Similar trends have been observed in terms of Stunting, where the average height of a person is directly proportional to his socio-economic status. Thus, the average height of the poor is comparatively less than the average height of the well-off people in society.

Both Child Stunting and Child Wasting, are the developmental Challenges that our Children are facing, due to unequal availability of nutritional food to all sections of Indian Society, indirectly reflecting the socioeconomic divide that persists in Indian Society; and threatens to endanger our future. Nutritional deficiency affects the allround development of a child, who are our future, from acquiring physical strength to having proper mental prowess; which again brings another Government Flagship Programme to question-Integrated Child Development Scheme (I.C.D.S.). If ICDS is continuing for almost half a century, providing seamless accessibility to nutritional food to all strata of Indian Society, focused primarily on Women and Children (upto 06 years of age) then why Indian Children are 'wasted' at such an alarming rate?

Aaditya Thackeray, accompanied by party Rajya Sabha MPs Anil Desai and Priyanka Chaturvedi, had "goodwill meetings" with Bihar Chief Minister Nitish Kumar and Deputy CM Tejashwi

During a brief interaction with the media here, Thackeray lauded Yadav for his "good work" and disclosed that he had been in touch, over phone, with the RJD leader for quite some time though this was the first occasion for them to meet in

person. He insisted that there was

"nothing political" about his Bihar visit and when journalists asked whether he expected Yadav to campaign for his party in the municipal polls at Mumbai, he replied "the elections are far away'

He, however, added "I have invited Tejashwi Yadav for a personal tour of Maharashtra. He has invited me to visit Bihar's tourist spots. We both shall be looking forward to each other's trips" When some of the scribes touched a raw

nerve with the query whether "Biharis can now rest assured that they will not be beaten up in your state", Thackeray said "those who indulged in such acts are now with the BJP. It is for them to answer". 'All lived together and in peace when we

ruled Maharashtra", asserted the young leader who held a ministerial berth in his father's government. Thackeray spoke with Yadav by his side and both ducked queries like "will Shiv Sena's Hindutva be able to make peace with RJD's secularism".

Yadav, on his part, stated that the need of the hour was to "save the Constitution from the onslaughts of the BJP government at the Centre".

"We all know about the brazen use of money power to topple the government in Maharashtra. The BJP had got emboldened by its success there and tried to do the same in Bihar where it ended up burning its fingers", said the RJD heir apparent.

The allusion was to Chief Minister Nitish Kumar's JD(U) and alleged attempts to split the party by its former national president RCP Singh who, it is widely believed, enjoyed the BJP's backing. (PTI)

"We have identified 300 refugee colonies in the state, and its residents will be given land pattas in due course of time,' she stated. The chief minister also said that beneficiaries need not furnish Aadhaar card to avail financial aid under her government's 'Lakshmir Bhandar' scheme. Without taking any name, she claimed that letters were being sent to the Centre alleging that funds are being misuses in West Bengal. "I feel ashamed to take names of those who are writing to the Centre asking it to create an economic blockade in West Bengal. They have alleged that central funds were being misused." Lashing out at the Narendra Modi-led dispensation, she said the central government "runs on the instructions of the party (BJP)". "The (Central) government takes instructions from the party. If the party says that it's night, they (Centre) too nod in agreement, she added. (PTI)

# Inclusion of CJI in consultative process for CEC appointment will ensure independence: SC

NEW DELHI, NOV 23 /--/ The Supreme Court on Wednesday said the inclusion of the Chief Justice of India in the consultative process for the appointment of Chief Election Commissioner would ensure independence of the poll panel. The apex court was of the view that any ruling party at the Centre "likes to perpetuate itself in power" and can appoint a 'Yes Man' to the post under the current system.

The court was hearing a batch of pleas seeking a collegium-like system for the appointment of Election Commissioners (ECs) and Chief Election Commissioner (CEC). The Centre argued that a 1991 Act ensured the Election Commission remains independent in terms of salary and tenure to its members and there is no "trigger point" which warrants interference from the court. It said that the mechanism adopted for appointment of Chief Election Commissioner (CEC) is seniority among the election

commissioners, who are appointed by convention from secretary or chief secretary level officers of the Centre and state level, respectively. However, a five-judge Constitution bench headed by Justice KM Joseph said the independence of the institution should be ensured at the threshold for which the appointment should be scanned at the entry level. "Each ruling political party in the Centre likes to perpetuate itself in power. Now, what we want to do is concentrate on the consultative process for the appointment of CEC and the inclusion of the Chief Justice of India in the process would ensure the independence of the commission", the bench also comprising justices Ajay Rastogi, Aniruddha Bose, Hrishikesh Roy and CT Ravi Kumar said. Attorney General R Venkataramani, appearing for the Centre pointed out that the Election Commission (Conditions of Service

Commissioners and Transaction of Business) Act, 1991 was a watershed moment that ensured independence in salary and tenure to the ECs. "The law was passed by the Parliament after the report from the Dinesh Goswami committee. So, it cannot be said that there was no application of mind. The law provides and ensures that the commission remains independent in terms of salary and tenure of its members which are intrinsic features for the independence of an institution", he said. The bench told Venkataramani that the 1991 law he is referring to only deals with terms of a service condition which is evident from its very name. "Suppose the government appoints a 'Yes Man', who has the same philosophy and is like-minded. The law provides him all the immunity in tenure and salary, then there is no so-called independence in the institution. This is an election commission, where independence should be ensured at the threshold", the bench said. (PTI)

Sources said this would be the first meeting of the Congress steering committee, which was formed in place of the working committee, the highest decision-making body of the party, after Kharge took charge as the new chief last month. During the all-important meeting, discussions on the party's strategy going forward would be held and preparations for the "Bharat Jodo Yatra", which enters the Hindi heartland states, would also be deliberated upon, the sources said. #### Bengal CM voices anguish over violence on Meghalaya-Assam border

KOLKATA, NOV 23 /--/ Chief insecurity. For how long will this minister Mamata Banerjee on Wednesday expressed anguish over the violence at a disputed Assam-Meghalaya border location that killed six people a day before and prayed for peace there.

Six people, including a forest guard, were killed in the violence in the early hours of Tuesday after a truck allegedly laden with illegally felled timber was intercepted by forest personnel from Assam. "I am gravely anguished by the tragic instance of firing at Mukroh, Meghalaya that claimed lives of 6 assuring them of full support, the people. I express my heartfelt party said in another tweet. In a condolences to the families who lost their loved ones in this conflict. I earnestly pray that peace and calm prevails for the greater good," Mamata said on Twitter. Notably, Trinamool Congress national general secretary Abhishek Banerjee on Tuesday alleged that the incident showed the 'ineptitude' of the Meghalaya government. Expressing shock over the incident, the TMC MP tweeted: "I am shocked and deeply saddened by the extremely unfortunate firing incident at Mukroh, Meghalaya which took away lives of five innocent civilians and a forest guard from Assam."

"For how long will CM @SangmaConrad @himantabiswa to take Meghalaya for granted? For how long should Meghalayans live in fear and

injustice go on," Banerjee, the nephew of the West Bengal chief minister, said. Taking a dig at the Meghalaya Democratic Alliance government, Banerjee November 22 said, "Today's incident exposes the ineptitude of the MDA Govt, failing its own people." Senior TMC leader and former Meghalaya chief minister Mukul Sangma visited the survivors of the Mukroh firing incident at the Jowai Civil Hospital and the kin of the deceased, tweet tagging Prime Minister Narendra Modi. Union home minister Amit Shah and Assam chief minister Himanta Biswa Sarma, Meghalaya CM Conrad K Sangma, whose party is an ally of the BJP, complained that the Assam Police and forest guards "entered Meghalaya and resorted to unprovoked firing". Assam Police officials, however, asserted that the truck was intercepted in West Karbi Anglong district of the state by a forest department team and a mob from the Meghalaya side had later attacked the forest guards and policemen, which led to firing by the Assam side to control the situation. Five of the six killed in the violence were Meghalaya residents and one was an Assam forest guard, Conrad Sangma said.

# CV Ananda Bose takes oath as West Bengal Guv

Adhikari skips ceremony over seat allocation, TMC says he set bad precedent

KOLKATA, NOV 23 /--/ CV Ananda Bose on Wednesday took oath as the new governor of West Bengal. Bose was administered the oath of office by Chief Justice of Calcutta High Court Prakash Shrivastava in the presence of Chief Minister Mamata Baneriee and Speaker Biman Banerjee at a programme in Raj Bhavan. Leader of Opposition in state assembly Suvendu Adhikari, however, skipped the programme. Bose, a retired Kerala cadre IAS officer of the 1977 batch, was named the new governor of West Bengal on November 17. He replaced La Ganesan as the state's constitutional head. Bose, the 22nd Governor of the state, had served as an administrator of the National Museum in Kolkata before superannuation in 2011. He had started his work life as a probationary officer in State Bank of India in Kolkata. Among others who attended the ceremony were city mayor Firhad Hakim, state minister Chandrima Bhattacharva and other dignitaries. The new Governor's wife, son and other family members were also present at the event. Mamata, following the swearing-in, offered rosogollas (sweetmeat) to Bose. Adhikari, who gave the ceremony a miss, told reporters in the Assembly that the TMC government "humiliated" him by allotting him a seat beside two MLAs who defected to the ruling party from the BJP after last year's Assembly polls. "Just to humiliate me and

the BJP at the oath-taking ceremony, I was given a seat beside two legislators who had won last year's elections on a BJP ticket and later defected to the TMC without resigning as saffron party MLA. "This TMC government is acting in a vindictive manner. It is yet to digest the fact that the TMC supremo lost to me in Nandigram seat. The government did not follow decorum and showed disrespect to the chair of Leader of Opposition. Hence, I skipped the programme," Adhikari told reporters. The Leader of Opposition further pointed out that TMC MPs Sudip Bandyopadhyay and Mala Roy were given front row seats at the event, while BJP's Balurghat MP and state president Sukanta Majumdar was assigned a rear row seat. "Mamata Banerjee had the opportunity to show grace and poise and be accommodating to the Opposition for an occasion like the swearing-in ceremony of the Honourable Governor. She failed to do so," he added. Responding to Adhikari's charges, TMC spokesperson Kunal Ghosh said the BJP leader skipped the programme on "flimsy grounds". "Adhikari is no saint who can make tall claims about courtesy. We are aware of the kind of language he uses against our chief minister every day. He was given due respect and recognition as the Leader of Opposition at the swearing-in ceremony. He set a bad precedent by skipping the programme," Ghosh added.

#### Shah targets Rahul, savs Medha Patkar's presence in Yatra biggest insult to Gujarat

AHMEDABAD, NOV 23 /--/ Union home minister and BJP MP Amit Shah on Wednesday said Congress leader Rahul Gandhi's gesture of taking along anti-Narmada activist Medha Patkar during his Bharat Jodo Yatra is the "biggest insult" meted out to Gujarat's people by the Opposition party.

Shah was addressing a poll rally in Jasdan town in Rajkot district in support of Bharatiya Janata Party (BJP) candidate Kunvarji Bavalia for the next month's Guiarat Assembly elections. # Search effort intensifies after Indonesia quake killed 271

CIANJUR, NOV 23 /--/ More rescuers and hamlets. But still, residents said the volunteers were deployed on Wednesday in devastated areas on Indonesia's main island of Java to search for the dead and missing from an earthquake that killed at least 271 people. With many missing, some remote areas still unreachable and more than 2,000 people injured in the 5.6 magnitude quake on Monday, the death toll was likely to rise. Hospitals near the epicentre on the densely populated island were already overwhelmed, and patients hooked up to IV drips lay on stretchers and cots in tents set up outside, awaiting further treatment. More than 12,000 army personnel were deployed on Wednesday to increase the strength of search efforts that being carried out by more than 2,000 joint forces of police, the search and rescue agency and volunteers, said Suharyanto, the National Disaster Mitigation Agency chief. Suharyanto, who like many Indonesians uses only one name, said aid was reaching thousands of people left homeless who fled to temporary shelters where supplies can be distributed only by foot over the rough terrain. He said rescuers recovered three bodies Wednesday and rescued a 6-year-old boy who was found alive next to the dead body of his grandmother after spending two days trapped under the rubble of his collapsed house. Television reports showed police. soldiers and other rescue personnel using jackhammers, circular saws and sometimes their bare hands and farm tools, digging desperately in the worst-hit area of Cijendil village where tons of mud, rocks and trees were left from a landslide. The government appeared to be focused on finding bodies, and wherever possible, survivors. Authorities struggled to bring tractors and other heavy equipment over washed-out roads after earthquake triggered landslides crashing onto the hilly

government was slow to respond to the earthquake.

Muhammad Tohir, 48, was sitting in his living room with family in Cijendil when the catastrophe struck. Although his family managed to make it out, his sister and her two children was crushed by a landslide, a few kilometres (miles) of his house. "When I came to my sister's house, I was devastated by what I saw," Tohir said. "Dozens of houses had been buried by landslides. I feel like doomsday." He said more than 40 houses in his sister's neighbourhood in Cijendil were buried under tons of mud with at least 45 people were buried alive, including Tohir's sister and her two children. Tohir, along with other residents in the area, searched for the missing using farm tools and managed to pull out two bodies buried under as much as 6 metres (10 feet) of mud. Two days later, rescue personnel arrived to help in the search. "The government too slow to respond to this disaster," Tohir said. "They should be bringing in heavy equipment to speed this up," he said. But he said that he will not give up until they can pull his sister and his nieces out of the mud.

In several hard-hit areas, water, food and medical supplies were being distributed from trucks, and authorities have deployed military personnel carrying food, medicine, blankets, field tents and water tankers. Volunteers and rescue personnel erected more temporary shelters for those left homeless in several villages of Cianjur district. About 800 police, soldiers and volunteers dug through the debris with their bare hands, shovels and hoes as heavy rain hindered their efforts. Arif Yulianto, a search and rescue operation coordinator said the search effort was halted Wednesday afternoon due to heavy rains that made the landslide areas unstable. The operation is to be resumed early Thursday. (AP)

# Strike on Ukrainian maternity hospital kills 2-day-old baby

KYIV, NOV 23 /--/ An overnight rocket attack destroyed a hospital maternity ward in southern Ukraine, killing a 2-day-old baby, Ukrainian authorities said on Wednesday

Ukraine's first lady said the attack caused "horrible pain," vowing that "we will never forget and never forgive." The baby's mother and a doctor were pulled alive from the rubble in Vilniansk, close to the city of Zaporizhzhia. The region's governor said the rockets were Russian. The strike adds to the gruesome toll suffered by hospitals and other medical facilities and their patients and staff in the Russian invasion that will enter its tenth month this week. They have been in the firing line from the outset, including a March 9 airstrike that destroyed a maternity hospital in the nowoccupied port city of Mariupol. "At night, Russian monsters launched huge rockets at the small maternity ward of the hospital in Vilniansk. Grief overwhelms our hearts a baby was killed who had just seen the light of day. Rescuers are working at the site," said the regional governor, Oleksandr Starukh, writing on the Telegram messaging app.

First lady Olena Zelenska wrote on Twitter that a 2-day-old boy died in the strike and expressed her condolences. "Horrible pain. We will never forget and never forgive,'

she said. Photos posted by the governor showed thick smoke rising above mounds of rubble, being combed by emergency workers against the backdrop of a dark night sky.

The State Emergency Service said the two-story building was destroyed. Vilniansk is in the Ukrainian-held north of the Zaporizhzhia region, and is about 500 kilometres (300 miles) southeast of Ukraine's capital, Kyiv. Other parts of Zaporizhzhia are Russian-held and it is one of four Ukrainian regions that Russia illegally annexed in September after internationally condemned sham referendums.

Medical workers' efforts have

been complicated by unrelenting Russian attacks in recent weeks on Ukraine's infrastructure that officials say have caused huge damage to the power grid. State grid operator Ukrenergo said that all regions of Ukraine would see power outages on Wednesday. The situation is even worse in the southern city of Kherson, from which Russia retreated nearly two weeks ago after months of occupation cutting power and water lines. Many doctors in the city are working in the dark, unable to use elevators to transport patients to surgery and operating with headlamps, cell phones and

flashlights. In some hospitals, key

"Breathing machines don't work, Xray machines don't work ... There is only one portable ultrasound machine and we carry it constantly," said Volodymyr Malishchuk, the head of surgery at a children's hospital in the city.

On Tuesday, after strikes on Kherson seriously wounded 13year-old Artur Voblikov, a team of health staff carefully maneuvered the sedated boy up six flights of a narrow staircase to an operating room to amputate his left arm. Malischchuk said that three children wounded by Russian strikes have come to the hospital this week, half as many as had previously been admitted in all of the nine months since the invasion

Picking up a piece of shrapnel that was found in a 14-year-old boy's stomach, he said children are arriving with severe head injuries and ruptured internal organs. Artur's mother, Natalia Voblikova, sat in the dark hospital with her daughter, waiting for his surgery to end. "You can't even call (Russians) animals, because animals take care of their own," said Voblikova wiping tears from her eyes. "But the children ... Why kill children?" In the northeastern city of Kupiansk, two civilians were killed and two more were wounded by Russian shelling on Wednesday morning, a regional official said. (AP)

### Lankan Prez rules out early elections, vows to crush anti-government street protests



COLOMBO, NOV 23 /--/ Sri Lankan President Ranil Wickremesinghe Wednesday rejected the opposition's demand for parliamentary elections and vowed to use the military to crush any future anti-government protests aimed at regime

Wickremesinghe, 73, who took over as the imports. The country President of Sri Lanka in July this year after then-Gotabaya Rajapaksa fled Colombo in the face of the country's worst economic crisis since 1948, said that he will not dissolve the parliament until the economic crisis is resolved. "I will not dissolve parliament early until the economic crisis can be resolved," he said while speaking in Parliament. Wickremesinghe has a mandate to serve out the rest of Rajapaksa's term, which ends in November 2024. However, the opposition parties are demanding early

parliamentary elections, claiming that Wickremesinghe's government lacks electoral credibility. The next presidential election is scheduled to be held in 2024. Sri Lanka has witnessed its worst economic crisis since early this year, with running out of reserves to pay for experienced long queues for fuel, and cooking gas while all essential supplies

In mid-April, the country declared its firstever sovereign debt default before approaching the International Monetary Fund for a bailout facility. The island nation survived with essential supplies being made available through dedicated Indian credit lines. The Indian assistance was worth 4 billion dollars to help Sri Lanka tide over the economic crisis in the first half of the year. Widespread

government's handling of the economic crisis turned into a political crisis. Tens of thousands of people took to the streets for monthslong protests and ousted the former president Gotabaya Rajapaksa in mid-July. Wickremesinghe succeeded him after Rajapaksa had fled the country and ordered the military to crackdown on protesters who had occupied government buildings.

Wednesday, Wickremesinghe said that even if the protesters call him a "dictator" they would need to obtain police permission to stage street protests. "They can call me a dictator but obtain police permission to stage street protests and cause road traffic. There is a plan to stage another Aragalaya (mass public protest) to oust the government. I will not allow that. I will put the military and use emergency laws to stop them if they try it again," Wickremesinghe said. Wickremesinghe faced criticism for ordering the crackdown and detaining at least two protesters under the draconian Prevention of Terrorism Wickremesinghe said a radical political party named Frontline Socialist Party was behind in organising street protests to achieve their political aims. ### Police: 6 people and assailant dead in **Walmart shooting**

CHESAPEAKE, NOV 23 /--/ A shooter opened fire in a Walmart in Virginia late Tuesday, leaving six people dead, police said, in the country's second high-profile mass killing in a handful of days. The assailant is also dead. The store in Chesapeake is now safe and will likely be closed for several days during the investigation, Officer Leo Kosinski said in the early hours of Wednesday. It was not clear who the shooter was or what their motive might be. "I am devastated by the senseless act of violence that took place late last night in our city," Mayor Rick W. West said in a statement posted on the city's Twitter account. "Chesapeake is a tightknit community and we are all shaken by this news." A database run by The Associated Press, USA Today and Northeastern University that tracks every mass killing in America going back to 2006 shows this year has been especially bad. The US has now had 40 mass killings so far this year, second to the 45 that occurred for all of 2019. The database defines a mass killing as at least four people killed, not including the killer. The attack at the Walmart came three days after a person opened fire at a gay nightclub in Colorado, killing five people and wounding 17. Earlier in the year, the country was shaken by the deaths of 21 when a gunman stormed an elementary school in Uvalde, Texas.

Tuesday's shooting also brought back memories of another at a Walmart in 2019, when a gunman police say was targeting Mexicans opened fire at a store in El Paso, Texas, and killed 22 people. Kosinski said he couldn't say how the shooter died but that he didn't believe police fired shots. The shooting had apparently stopped when police arrived at the store in Chesapeake, which is Virginia's second-largest city and lies next to the seaside communities of Norfolk and Virginia Beach. Mike Kafka, a spokesman for Sentara Healthcare, said in a text message that five patients from the Walmart were being treated at Norfolk General Hospital. Their conditions weren't immediately available. Walmart tweeted early Wednesday that it was "shocked at this tragic event." US Sen. Mark Warner said in a tweet that he was "sickened by reports of yet another mass shooting, this time at a Walmart in Chesapeake." State Sen. Louise Lucas echoed Warner's sentiment, tweeting that she was "absolutely heartbroken that America's latest mass shooting took place in a Walmart in my district." (AP)

# Pak defence minister says new Army Chief to be appointed before PM Sharif's Turkey visit

ISLAMABAD, NOV 23 /--/ Pakistan's defence minister Khawaja Asif Wednesday said he expected the new army chief to be appointed before Prime Minister Shehbaz Sharif's visit to Turkey on Friday, hours after the premier's office announced that it has received the names of six top generals for the coveted post.

Army chief Gen Qamar Javed Bajwa, 61, is scheduled to retire on November 29

after a three-year extension. He has ruled out seeking another extension. "The prime minister will leave the day after tomorrow in the evening. So it (the appointment of new army chief) will be settled before then," Asif said. The Prime Minister's Office (PMO) will send the summary to President Arif Alvi who will notify the appointments

# Supreme Court OKs handover of Trump tax returns to Congress

WASHINGTON, NOV 23 /--/ The Supreme Court on Tuesday cleared the way for the imminent handover of former President Donald Trump's tax returns to a congressional committee after a three-year legal fight.

The court, with no noted dissents, rejected Trump's plea for an order that would have prevented the Treasury Department from giving six years of tax returns for Trump and some of his businesses to the Democratic-controlled House Ways and Means Committee. Alone among recent presidents, Trump refused to release his tax returns either during his successful 2016 campaign or during his four years in the White House, citing what he said was an ongoing audit by the IRS. Last week, Trump announced he would run again in 2024. It was the former president's second loss at the Supreme Court in as many months, and the third this year. In October, the court refused to step into the legal fight surrounding the FBI search of Trump's Florida estate that turned up classified documents. In January, the court refused to stop the National

Archives from turning over documents to the House committee investigating the January 6 insurrection at the Capitol. Justice Clarence Thomas was the only vote in Trump's favour.

In the dispute over his tax returns, Treasury Department had refused to provide the records during Trump's presidency. But the Biden administration said federal law is clear that the committee has the right to

taxpayer's return, including the president's. Lower courts agreed that the committee has broad authority to obtain tax returns and rejected Trump's claims that it was overstepping and only wanted the documents so they could be made public. Chief Justice John Roberts imposed a temporary freeze on November 1 to allow the court to weigh the legal issues raised by Trump's lawyers

to complete their legislative work during this Congress, which is quickly approaching its end." Had Trump persuaded the nation's highest court to intervene, he could have run out the clock on the committee, with Republicans ready to take control of the House in January. They almost certainly would have dropped the records request if the issue had not been resolved by then.

The House Ways and Means panel first requested Trump's tax returns in 2019 as part of an investigation into the Internal Revenue Service's audit programme and tax law compliance by the former president. Federal law says the Internal Revenue Service "shall furnish" the returns of any taxpayer to a handful of top lawmakers.

The Justice Department under the Trump administration had defended a decision by then-Treasury Secretary Steven Mnuchin to withhold tax returns from Congress. Mnuchin argued that he could withhold the documents because he concluded they were being sought by Democrats for partisan reasons. (AP)

### One person dead, 21 injured after 2 explosions rock Jerusalem

One person was killed and 21 others injured in two separate explosions at bus stops at the entrances to Jerusalem on Wednesday, in what seemed like a coordinated terror attack, Israeli police and rescue officials said. The first explosion occurred close to the main entrance of Jerusalem in Givat Shaul, shortly after 7 AM when people were on their way to their offices and students to educational

institutions. Seventeen people at the bus stop were injured in the blast, including two critically and two seriously, medical officials said. One of the victims later died at Shaare Zedek Medical Center, hospital officials said. A second blast occurred shortly after at 7:30 AM at Ramot junction, another entrance to Jerusalem, which is normally jampacked in the morning. Four people were injured in the explosion. The devices were

packed with nails to maximise casualties and controlled by nearly identical remote devices, the police said in its initial response. Israel Police Commissioner Kobi Shabtai said that "this is a framework of attack that we haven't seen for many years". He called on the public to be alert for suspicious packages and said officers were scanning the city for other possible devices. It seemed like a coordinated terror attack, he said. (PTI)

DOHA, NOV 23 /--/ Brazil great Pele congratulated United States forward Timothy Weah for scoring his debut goal in the World Cup in the Americans' 1-1 draw with Wales. Weah got his goal in the 36th minute of Monday's game to become the first player to score against Wales in a World Cup since Pele, who was 17 years old when he did it in 1958. That was the last time Wales played at the World Cup before this year in Qatar. Weah posted a photo of him celebrating the goal on Instagram and Pele congratulated him in the comments section. "Congratulations. It was a beautiful goal. Keep dreaming, dreams come true," Pele wrote. Weah responded to "Papa Pele" by thanking him for the "inspiring message." "It is such a blessing and an honour to receive such an inspiring message from The King himself," Weah wrote.

#### France defender Lucas Hernandez limps out of the tournament

DOHA, NOV 23 /--/ France defender Lucas Hernandez will miss the rest of the defending champions' World Cup campaign after suffering a knee injury in Tuesday's opening match against Australia, a source close to Les Bleus told AFP. The Bayern Munich defender hobbled off in the holders' 4-1 win over the Socceroos. His absence comes with coach Didier Deschamps already grappling with a host of key players ruled out of the tournament in Qatar. The 2018 champions lost star striker Karim Benzema after the Ballon d'Or winner injured his left thigh in training on Saturday. Also missing are Paul Pogba, N'Golo Kante and Presnel Kimpembe. "Honestly, it's starting to become a big deal," said France captain Hugo Lloris. (AFP)

#### Senegal midfielder Cheikhou Kouyate likely to miss Qatar clash due to injury

DOHA, NOV 23 /--/ Senegal midfielder Cheikhou Kouyate is likely to miss the game against host Qatar at the World Cup because of a right hamstring injury, his team said Wednesday. Kouyate was "probably" out of Senegal's second Group A game on Friday, the team said, forcing the African champion to reshuffle its lineup again having already lost forward Sadio Mane to injury days before the tournament started. Kouyate, a key central midfielder for Senegal, went off on a stretcher in the second half of his team's opening 2-0 loss to the Netherlands after he went up for a header and came down clutching his right thigh Defender Abdou Diallo was also injured and came off against the Netherlands. Senegal said Diallo had muscle cramps but was expected to return to training on Wednesday.
