SC clubs, transfers to itself all pleas pending before different HCs on same-sex marriages

The Supreme Court on Friday clubbed and transferred to itself all petitions pending before different high courts seeking legal validation for same-sex marriages.

A bench of Chief Justice DY Chandrachud and Justices PS Narasimha and JB Pardiwala asked the Centre to file a joint reply to the petitions by February 15 and directed their listing on March 13. The bench said any petitioner, if not available to argue physically before the court or unable to engage a counsel, or to travel to Delhi, can avail the facility of a virtual platform to join the hearing. The apex court asked the registry to provide links for virtual hearing to all parties who wish to address the court virtually. It asked advocate Kanu Agarwal, appearing for the Centre, and advocate Arundhati Katju, representing the petitioners, to file a written note on the issue, cases laws and precedents to be relied upon by the parties, if any, and share it among themselves and with the court.

bench asked advocate Kanu Agarwal to ensure that no petitioner is left out and the details of all

the compilations to be made. During the arguments, Solicitor General Tushar Mehta told the bench since a petition is ripe for hearing before the Delhi High Court, the top court could either await its verdict or transfer all the petitions to itself. The counsel for multiple

The students were taken out of the classrooms and were put up in a safe place, a police officer detailed investigation carried out by the police revealed that it was a hoax mail and there was no truth in it, the officer said. Bharat Jodo Yatra beyond politics: Kamal Haasan

CHENNAI, JAN 6 /--/ Makkal Needhi Maiam (MNM) founder Kamal Haasan on Friday said Congress leader Rahul Gandhi's ongoing Bharat Jodo Yatra is a campaign that was beyond politics and stated there was a duty to 'reclaim' the country's "lost honour." Haasan had joined Gandhi in Delhi last month in the latter's pan-India foot march that started from Tamil Nadu in September last. "It is our responsibility to reclaim the lost ethos of our Bharat. This (Bharat Jodo campaign) is a yatra that is beyond politics," the reporters here. Haasan further said he wanted to conduct the bulltaming

If there are objections with merit, the party office-bearers are asked to respond. Otherwise, the EC calls them for a personal hearing before granting registration to the party. (PTI)

Delhi Police team in Mumbai in search of Air India 'urinating' incident accused

MUMBAI, JAN 6 /--/ A victim to the Tata groupfour-member Delhi Police team on Friday afternoon landed in Mumbai in search of the man, who had allegedly urinated on his female co-passenger on an Air India (AI) flight on November 26 last year, but found his home here locked, an official said. The Delhi Police have registered an FIR (first information report) against the man based on the complaint given by the

Central Vista: CPWD floats new tender for construction of MPs' chambers; cuts down project cost by Rs 225 cr operating from

NEW DELHI, JAN 6 /--/ The Central Public Works Department (CPWD) has floated a revised prequalification bid to build an office complex for MPs at a cost of Rs 1,210 crore, reducing the project cost by Rs 225 crore.

The proposed buildings will come up at plot number 119 in Lutyens' Delhi, where the Transport Bhawan and the Shram Shakti Bhawan are currently located. According to the revised bid document floated on Thursday, the total plinth area of the proposed buildings is approximately 98,000 square metres while in the previous tender, it was 1,18,000 square metres. The buildings will have eight floors. In the earlier tender, the proposal was for 10-storey structures. New chambers for the members of Parliament are part of the Union government's ambitious Central Vista redevelopment project and those will be built by

Bhawan and the Shram Shakti Bhawan. The project also

envisages a plan to build a

tunnel that will connect the MPs' chambers with the new Parliament building being built by Tata Projects Limited. In its latest bid document, government's construction agency said the proposed complex with the MPs' chambers will be built at a cost of Rs 1,210 crore against the Rs 1,435 crore estimated in the previous tender floated in November. "The existing structures on plot number 119 are to be demolished before the start of new construction. The existing boundary wall also needs to be demolished and new boundary wall shall be constructed as per design and drawings provided by the department. "Tree transplantation as per the requirement to be done and the existing services, if any,

to be diverted," it stated. The existing

Transport Bhawan and the Shram Shakti Bhawan will have to vacate the complex. The CPWD said the proposed buildings will be designed to improve potency and functioning through a carefullyplanned formation of the MPs' offices with supporting facilities. The work includes the construction of civil structure, the furniture, interiors, external development landscaping. It also involves stone masonry, stone carving, wood work and system glazing, the agency said. The redevelopment project of the Central Vista -- the country's power corridor -- envisages a new triangular Parliament building, a common central secretariat, the revamping of the three-kilometre-long Rajpath from Vijay Chowk to India Gate, a new Prime Minister's Residence and a Prime Minister's Office, and a new Vice-President's Enclave. Students hail UGC stand on foreign varsities in India

The University Grants Commission's draft norms for establishment and operation of foreign universities in India have been hailed by students, who believe that it will improve the quality of education and research and give aspirants exposure to world-class learning without having to travel abroad. Academics and industry experts, however, differ on the draft norms for establishment and operation of foreign universities in the country with some saying such varsities would not be able to address the unique problems of the Indian education sector. The final norms will be notified by January-end after considering feedback from all stakeholders on the draft regulations for 'Setting up and Operation of Campuses of Foreign Higher Educational Institutions in India'. According to the draft norms, foreign universities will be able to set up their campuses in India for the first time. These varsities can also decide on the admission process, fee structure and repatriate its funds back home. Studying abroad is expensive, especially in countries like the UK and the US. Because of the high costs associated, a lot of students who have the potential but don't have the means to afford the education, are not able to go to the universities of their choice. If foreign universities set up their campuses in India, this cost would be reduced significantly and Indian students will be able to benefit from the world-class expertise of these varsities. A few students, however, raised questions over the move, saying the government should instead focus on improving the standard of education and infrastructure in Indian universities so that they are able to compete with universities at a global level.

Noting that foreign universities with campuses in the country can only offer full-time programmes in offline mode and not online or distance learning, UGC chairperson M Jagadesh Kumar said the foreign universities and Higher Education Institutions (HEIs) will need a nod from the UGC to set up their campuses in India. The initial approval will be for 10 years and will be renewed in the ninth year subject to the meeting of certain conditions, he said, clarifying that these institutions shall not offer any such study programme which jeopardises the national interest of India or the standards of higher education. The UGC Chairman said several countries in Europe have expressed interest in setting up their campuses in India. Surprisingly, the UGC was finalising the norms at a time when it was supposed to be dismantled under the National Education Policy - 2020. The draft regulations published by the UGC are quite clear and flexible. They are in a way in line with the regulations that were introduced recently. Previous attempts through complex legislation didn't work and a regulatory approach appears far more feasible. There will be two categories of foreign institutions eligible to apply for setting up their campuses in India---the universities that have secured a position within the top 500 of overall or subject-wise global ranking or a reputed institution in its home jurisdiction. The foreign institution shall have the autonomy to recruit faculty and staff from India and abroad as per its recruitment norms.

Falling industrial growth and high inflation main problem

2022 was a good 'growth' year for India. India's economy was among the fastest growing large economies. This was commendable, especially in a year marred by war and extreme climate events, rising commodity and energy prices, tightening global monetary policy, and slower global economic growth. India is poised to grow at 6.9 per cent in 2023, as per the estimate by World Bank. However, India's Achilles heel is its burgeoning current account deficit (CAD), falling value of the Indian rupee, falling industrial growth and high domestic inflation numbers. Let's first examine the negatives, and then the positives, as we go into

During the second quarter of this fiscal, India's CAD widened to \$23.9 billion, the highest since 2012. Rupee touched a record low of 83.07 against the dollar in October 2022. Retail inflation hovered at over 7 per cent (against the upper tolerance limit of 6 per cent) for most part of this year. A bulk of India's exports, for example, refined petroleum products, pearls, precious stones and chemicals are not picking up. Weak global demand implies a lower demand for these income-sensitive items. A strong Indian economy demands more energy and fossil fuels, most of which are imported. As imports continued to grow, without a commensurate increase in exports, the rupee depreciated. A depreciating rupee also leads to domestic inflation, as the 'imported' commodity and energy prices which are used for domestic manufacturing and services become costly.

It will be difficult to sustain a GDP growth of 6.9 per cent without ensuring healthy domestic demand. For instance, in November India's industrial production shrank 4 per cent from a year earlier in October 2022, the steepest pace of contraction since August 2020. Real wage growth in the agriculture and construction sectors is stagnating. This is a cause of concern as marginal propensity to consume for lower-income groups is higher in comparison to the upper 10th percentile of population. Most of the consumption for the rich and wealthy are on imported merchandise and services items which do not contribute to domestic demand. Lack of domestic demand coupled with higher energy and input price will send a negative signal to the manufacturers against possible capacity expansion. Government should find ways through programmes such as MGNREGA to boost domestic demand. However, it must be said that the Centre and the Reserve Bank of India (RBI) are making coordinated efforts to make exports competitive, lower

domestic inflation, and arrest a fall in the rupee value. To reduce dependence on foreign imports and increase export competitiveness, the GoI launched programmes such as the National Manufacturing Policy in 2011. Additionally, several policies; such as the Focus Market Scheme (FMS) and Production Linked Incentives (PLI) were launched. The PLI scheme was meant for increasing competitiveness of 14 items under manufacturing sectors such as pharmaceuticals engineering, and electronics.

To lower trade and logistics costs related to the movement of goods, the Centre increased outlay on capital expenditure from Rs 5.54 lakh crore in 2021-22, to Rs 7.50 lakh crore in 2022-23. Such allocation of funds is expected to provide impetus to the Gati Shakti project, a plan to improve multimodal connectivity. Some positive results are emerging so far India's exports are concerned. In the case of high-value-added pharmaceutical exports such as formulation and vaccines, India is performing well because of FDI and government's support in the form of various schemes such as FMS and PLI. Foreign smartphone manufacturers are showing interest to invest in India. Export of electrical and telecom equipments are showing an uptick.

In the short run, policymakers undertook a few micro measures to reduce the widening CAD. For instance, India is buying oil from Russia. The share of Russian mineral fuel imports in India's trade basket went up from 1 per cent in February 2022 to 22 per cent by November 2022. On September 9, 2022, India banned export of 100 per cent broken rice, an input for producing ethanol, an alternative source of fuel. India increased customs tariffs on gold imports from 7.5 per cent to 12.5 per cent. Gold is another item responsible for increasing trade deficit. The rupee has also fallen on account of monetary tightening in the US. Since March 2022, the US Federal Reserve has raised interest rates by 350 basis points. A hawkish policy stance has led to a rise in returns of the US treasury security. The yield on two-year US treasury security increased from 1.56

per cent on August 1, 2020, to 4.50 per cent on December 9 2022. This has led to outflow of capital from the Indian economy, pulling down the rupee. Since March 2022, this year, RBI increased the policy rates by 225 basis points. In addition to raising the reporates, the RBI took a few other policy measures. For example, RBI giving permission to commercial banks to open Foreign Currency Non-Resident (FCNR) accounts (held in foreign currency) and Non-Resident External (NRE) deposits from Indians residing outside India without any cap on interest rates. This is likely to increase deposits of foreign currencies. RBI is also contemplating about listing Indian government bonds in the JP Morgan Emerging Markets Government Bond Index and FTSE Emerging Markets Government Bond Index. This when done, will ease the inflow of foreign currency. improving foreign exchange reserves and curtailing a fall in the value of the rupee

The combination of fiscal and monetary policy initiatives has begun to show results. Foreign exchange reserves increased from \$528.37 billion in October 2022, to \$564.07 billion in December 2022. Net foreign direct investment rose to \$22.7 billion in April-October 2022 up from \$21.3 billion during the corresponding period last year. Foreign portfolio investment contributed to inflow of \$11.8 billion between June and early December, reversing negative trends of the past. Although the rupee has depreciated up to 9.8 per cent this calendar year, it was less when compared to other developed countries in the EU regions, Japan, and South Korea, where exchange rates depreciated in excess of 15 per cent. Remittances from abroad also started looking good, estimated to reach \$100 billion in 2022, up from \$81 billion in 2021. According to the World Bank data, there is a structural shift in remittances from largely low-skilled workers in the Gulf Cooperation Council Countries to remittances from highskilled workers in the UK, US, Australia, and Singapore. Only events, such as another war in the Asia Pacific region, or a newer fatal variation of COVID hitting the world, can derail India's growth process.

Make in India, Atmanirbhar Bharat and PLI schemes will take time to make exports competitive. Meanwhile, Indian negotiators should find ways to deal with extra-trade provisions such as labour, environment, IPRs etc., which are increasingly hurting access to India's exports in the developed markets. Workers and Trade Unions struggle to intensify in 2023

The year 2023 is beginning with a prospect of more intensified labour and trade union movement in India. A convention of all Central Trade Unions is already scheduled to be held on January 30 to chalk out an intensive path for concrete struggle to be taken unitedly in the country against alleged anti-labour and pro-corporate policies of the incumbent government at the centre lest it would implement the four controversial labour codes before the General Election 2024

It would worsen PM Narendra Modi's predicaments since nine states of the country would go for polls, considered to be semi-final political contest to test respective strength of the ruling and opposition political parties, and the result of which would cast its spell on the outcome to the Lok Sabha election due to be held by mid-2024. Modi government would be tabling its last full budget in February 2023 before the general election in 2024, thereby it would be last chance for him to politically appease both the corporate friends and the workforce, who have been agitating against its policies - particularly on labour reforms through four labour codes and privatisation of public sector undertakings.

A year before in January 2022, PM Narendra Modi was somewhat relieved after the farmers movement led by SKM was called off in December 2021, after he had unilaterally withdrawn the three farm sector laws seeking to bring corporate to the farm. Farmers have been campaigning against BJP in the state elections throughout 2021, and the party had to undergo electoral setbacks that had frustrated its expectation, more pronounced in the West Bengal elections of April. Electoral setbacks to the party were also witnessed during by-elections.

Farmers, Trade Unions, and Employees associations etc had joined hands to protest Modi government's policies. Withdrawal of farm laws did not help the government in 2022. It could not even win back its estranged political partner SAD again into NDA. Farmers of Punjab opted for AAP during February 2022 election, after which the party formed its government in the states. The year closed with two other significant loss for Modi's BJP - in Himachal Pradesh to Congress, and in Delhi Municipal Corporation to AAP.

The entire 2022 was a year of Trade Union and Employees Union Movements, as the year 2021 was the year of Indian Farmers' Movement. Ten Central Trade Unions organized all India strike actions in March. They continued agitation the whole vear. Banks, Insurance Companies, Public Sector, and government sector employees' associations and unions also went for demonstration and strikes. Now we see, that the year is closing with upsurge in general disenchantment of farmers and workforce, have resumed their protest demonstration afresh in November and December. Additional factor is coming of RSS-affiliated Bharatiya Kisan Sangh (BKS) and Bharatiya Mazdoor Sangh (BMS) into the picture in December, BKS organized Kisan Garjana Rally in Delhi and threatened political consequences if Modi government would not concede to their demand in time, while BMS leaders in rare gesture of expressing unity of the trade union fraternity went to AITUC convention in Alappuzha and voiced their concern on several issues confronting labour.

It is out of fear that PM Modi would devise certain means to implement some of the provisions of the scraped three farm laws, of yet-to-be-implemented four controversial labour codes, and privatisation of public undertakings, the farmers and workers have stepped up their agitations again and are preparing for more intensive struggle in 2023. Such a fear has roots in several initiatives of Modi government relating to farm sector, labour reform, and privatisation especially through subtle disinvestment of certain public sector undertakings, such as seen in selling of IPOs in LIC, mere offering of constitution of a high-powered committee on legal guarantee of MSP, and encouraging private sector banks and insurance companies.

Due to political reasons, many observers feel that PM Modi would not opt for implementation of four controversial labour codes or bring back some farm sector reforms in 2023. Moreover, they also expect the pace of privatisation of public sector companies, banks, insurance, etc to be slowed down. PM Modi would not like to take risking BJP's political prospect either in 2023 or 2024, unless he or his advisors are overwhelmed by overconfidence. The four controversial labour codes that were labelled by PM Modi as the much needed, much awaited, biggest labour reform in independent India, has been resisted tooth and nail by the Central Trade Unions ever

since they came into existence in 2019 and 2020. They could not be implemented since labour is in concurrent list of the Constitution of India and states needed to come out with their rules before notification of implementation. States were preoccupied in tackling COVID-19 crisis, and hence framing of rules delayed. Modi government has missed several targeted dates for their implementation. Union Ministry of Labour has said that they are almost ready for their implementation, that has alarmed the Central Trade Unions resulting in preparation for more intensive

united struggle in 2023. Restoration of old pension scheme for government employees have become an issue now, the impact of which has been against the BJP as we have seen in Punjab and Himachal Pradesh elections. Central Trade Unions have come out in support of restoration of old pension scheme, enhancement of pension to at least Rs 5000 for workers in the organised sector, and credible social security net for unorganised and informal workers, who according to a AITUC study has increased to 97 per cent of the total workforce.

The recent years have been marked with "lack of dialogue" between the Modi government and Central Trade Unions. ILC meetings have not been called since 2015. Labour codes were passed in 2019 and 2020 consultation. consultations have been put on back burner. Only RSS-BJP-affiliated BMS has been given importance, and this year it was included in ILO representation and now appointed L-20 chair to discuss labour related issues of the G-20 summit later in 2023. Central Trade Unions were not given enough time in Union Budget consultations of the Union Minister of Finance which led to their boycott. (IPA)



DMRC employee held for impersonating IAS, flashing red beacon

NEW DELHI, JAN 6 /--/ A 40-year-old a threatening manner introduced himself DMRC employee was arrested for allegedly impersonating an IAS officer and using red beacon on his personal car, police said on Friday. The accused has been identified as Manoj Kumar Gupta, a resident of Ganga Vihar, Shahdara, they said. On Thursday around 7 pm, a man saw a Tata Tigor car flashing red beacon light in the Shastri Nagar fruit market. He found the vehicle suspicious as there was only one person in the car and shared the information with traffic policeman ASI Dhamendra Kumar, a senior police officer said. When the ASI stopped the vehicle and asked the driver about his identity, he started arguing with him, following which the matter was reported to the local police. Gupta was caught driving a car which had "Bharat Sarkar" written on its front bonnet and "Government of India and Ministry of Power and Energy" on its back, police said.

A sticker of advocate was also found pasted on the windscreen which confirmed that the man was an imposter, police said. When Gupta was asked if he was authorised to use the red beacon, he got annoyed and in as Sanjeev Kumar, IAS, posted as deputy director in the Ministry of Power & Energy. He further said that he is authorised for flashing the red beacon, police said.

The car Gupta was driving was found registered in his name, so was the driving licence found on him. Police also found in his possession an ID card, apparently issued by the DMRC, which showed him to be employed as the head maintainer with the transporter, Deputy Commissioner of Police (northeast) Sanjay Kumar Sain said. After that, police arrested Gupta and booked him on relevant charges. During interrogation, Gupta revealed that he had got the beacon and other insignia to showoff and create an impression on the public, the DCP said.

As the Republic Day celebrations are in full swing, unauthorised use of red beacon could lead to sabotage in security arrangements, police said. Information about the incident was shared with intelligence agencies, special cell etc and a joint interrogation was conducted in the matter, they said. D Y Chandrachud and Justices PS Narasimha and J B Pardiwala agreed that urgent steps were needed to be taken to enforce Section 136A (electronic monitoring and enforcement of road safety) of the Motor Vehicles Act, 1988. "The Motor Vehicle Act was amended in 2019 so as to incorporate provisions of section 136 A for electronic monitoring and enforcement of road safety on national highways, state highways, roads and urban cities. The issue now is about ensuring due enforcement of the provisions of section 136A by drawing out state specific guidelines which would have

to be done in collaboration

"Section 215 B of the MV Act has provided for the constitution of a national road safety board in an advisory capacity. Having due regard to the framework, it would be appropriate for Justice A M Sapre, chairperson of committee appointed by the court, government official and amicus to set out modalities. The meeting may be convened preferably in two weeks.

The amicus can then report to the court on the consensus arrived at in the meeting," the bench said. The matter is now listed for hearing in the first week of

February. Additional Solicitor General Madhavi Divan, appearing for the Centre, said the government has already framed Rules under Section 136 (2).

According to Section 136 Government shall make rules for the electronic monitoringandenforcement of road safety including speed cameras, closedcircuit television cameras, speed guns, body wearable cameras and such other technology."



Govt sending back names reiterated by Collegium matter of concern: SC

NEW DELHI, JAN 6 /--/ The Supreme at times has considered the view of the Court said on Friday it is a "matter of concern" that the government is sending back the names reiterated by the Collegium for judgeship in constitutional courts despite there being nothing in the present scenario


to prevent the appointment post reiteration. A bench of Justices S K Kaul and A S Oka observed that nothing prevents the legislature from bringing in a better system for appointment of judges to Constitutional courts but till the time the law holds it must be implemented. Advocate Prashant Bhushan, appearing for one of the petitioners, said even the names reiterated by the Collegium have been sent back by the government "That is a matter of concern. We have already flagged it in the last order," said

the bench, which was hearing a matter related to the alleged delay by the Centre in clearing the names recommended by the Collegium for appointment as judges to the Supreme Court and High Courts. It said the government may have its own views when a recommendation is made but it can't be kept on hold without sending back the comments on it. "What is to be done is that comments can be sent to us. We will look into the comments, see whether we want to reiterate it or drop

the name. If we reiterate the name, then $% \left(1\right) =\left(1\right) \left(1\right$ there is, as per the present scenario, nothing which can prevent the appointment," it said. The bench said every system has its positives and negatives and neither anyone is saying that there is a perfect system nor can there be a perfect system. Justice Kaul observed the grave concern is, "are we creating an environment where meritorious people have hesitancy in giving their consent(forjudgeship). It is happening. I have seen it happening." The bench said the delay in clearing the names deter people from giving consent.

When the bench asked Attornev General R Venkataramani about the five names recommended by the collegium last month for elevation as judges of the apex court, he requested the court to defer it. saying he is looking into the matter. "This should not take time. They are already existing Chief Justices and senior judges, Justice Kaul said. The bench also observed: "If you look at the statements made in the parliament and otherwise, the court itself

government and dropped names. That has also happened." The apex court said it is not that every name recommended by the High Court's Collegium goes through and this shows the scrutiny. It said there are people with different points of view and a court must reflect different philosophy and course of views. "I do believe when you join as a judge... you are here to do a job and trained yourself to do a job independently, dehors (other than, not including or outside the scope of) whatever may have been your political affiliations, what may have been the thought processes," Justice Kaul said. He said there is a spectrum of thought process in appointment of judges and if a person has his or her own thought process

The apex court said some of the names sent back by the government were reiterated by the Collegium and some are those which the Collegium did not clear but the government in its wisdom felt they ought to be considered. Amid the frosty executive-judiciary ties over the system of judges appointing judges, Attorney General R Venkataramani told the top court the government will adhere to timelines and the recent recommendations made by the Collegium of High Courts have been processed with "utmost dispatch". Not complying with regulations on handling unruly passengers to be dealt with strictly: DGCA to airlines

MUMBAI, JAN 6 /--/ Aviation safety regulator DGCA on Friday warned airlines that any noncompliance regulations on handling unruly passengers will be dealt with strictly and invite enforcement action.

The advisory comes in

the backdrop of two shocking incidents of urination on Air India flights late last year, which the airline failed to report to the regulator. In an advisory issued to the airlines' head operations, the DGCA reiterated the responsibility individuals -- pilot-incommand, cabin crew and director in-flight services -- towards handling of unruly passengers under various provisions of Aircraft Rules, 1937, regulations, circulars and manuals of

approved/ airlines accepted by the regulator. "Head of operations are hereby advised to sensitise pilots, cabin crew and director-in-flight services of their respective airlines on the topic of handling of unruly passenger through

airline finds a passenger's behaviour unruly, the pilot-in-command has to file a complaint, which is to be investigated by an internal panel. During the probe, the airline can ban the flyer for a maximum of 30 days. The committee

NEW DELHI, JAN 6 /--/ All passes issued to employees and visitors of airports across the country have been withdrawn by the Bureau of Civil Aviation Security (BCAS) after it was found that a "distorted" map of India was printed on them, officials

Map images of Jammu and Kashmir. the North-Eastern region, Rajasthan and Gujarat were wrongly depicted in the passes issued at all Airports Authority of India operated airports and six Adani group-run airports -- Ahmedabad, Jaipur, Lucknow, Thiruvananthapuram, Guwahati and Mangaluru. After it was found that the images were "distorted", the BCAS has withdrawn the passes, an official privy to the development said. In a communication to the chairman of the Airports Authority of India (AAI), the BCAS said the embedded hologram roll being used is not according to the sample hologram approved by the BCAS. "Keeping in view the seriousness of the issue, it is hereby directed that all Aerodrome Entry Permits (AEPs) issued with holograms shall be withdrawn and further printing with these hologram roll shall be stopped with immediate effect," the letter said. The BCAS also conveyed that the AAI will conduct an inquiry in the matter,



find out at which level the lapses occurred, who is responsible for procuring these hologram rolls and take appropriate action against the responsible officers. The AAI has been directed to submit an action taken report on the issue to the BCAS at the earliest, it said. A person, who is not a passenger with a valid ticket, requires an AEP that is issued by the airport. The AEP application form, which is issued by the BCAS, mentions 13 zones that a person can enter. The permitted areas include the arrival halls, the departure halls, the terminal building, the apron area, the security hold area, cargo terminal among others. (PTI)

Gotabaya Rajapaksa returns to Sri Lanka from Dubai

President Gotabaya Rajapaksa, who was ousted from power last year over his government's mishandling of the cash-strapped country's economy, has returned here from Dubai, his first foreign trip since returning to Sri Lanka four months ago.

Rajapaksa and his wife Ioma Bandaranaike International Airport here from Dubai on Thursday, the Daily Mirror Lanka newspaper reported, quoting the airport duty manager and spokesperson of the airport immigration department. They arrived on an Emirates flight from Dubai, the report said. During his visit to Dubai, Rajapaksa visited the exotic animal farm called "Fame Park," according to news portal newsfirst.lk. Rajapaksa, 73, fled Sri Lanka to the Maldives on a Sri Lankan Airforce plane in July, as the country plunged into its worst economic and humanitarian crisis since its independence from Great Britain in 1948. He then proceeded to Singapore, from where he submitted his resignation on July 14 last year. Weeks later, he flew to Thailand, seeking

Rajapaksa can stay in the country for 90 days because he is still a

diplomatic passport holder. However, he was not allowed to political activities in Thailand. He was confined to a hotel and surrounded by security personnel.

In September 2022, he was special given

security and a state bungalow upon his return to Sri Lanka from Thailand. Rajapaksa, an exmilitary officer, became the president in November 2019. Rajapaksa, formerly a dual citizen of both Sri Lanka and the US, had to give up his US citizenship ahead of the 2019 presidential elections. As per Sri Lankan Constitution, dual citizenship holders are barred from contesting elections. A corruption case against him when he was a top defence official was elected in 2019. Earlier this month, Rajapaksa applied for restoration

> his citizenship after he failed to get asylum in any country, according to The Sunday Times newspaper. However, the US government is yet to consider the request, ${\tt n}$ e ${\tt w}$ s ${\tt p}$ a ${\tt p}$ e ${\tt r}$ reported. An appeal to restore

US citizenship previously held is a costly legal process and time-consuming, the report said.

The Rajapaksa family has dominated Sri Lankan politics for over two decades. Mahinda Rajapaksa, the 76-year-old patriarch and elder brother of Gotabaya was the country's president and prime minister. Younger brother Basil Rajapaksa, 71, was earlier Sri Lanka's finance minister. Sri Lanka, a country of 22 million people, is going through its independence in 1948 which was triggered by a severe paucity of foreign exchange reserves. In September last year, the IMF announced that it will provide Sri Lanka with a loan of about USD 2.9 billion over four years under a preliminary agreement to help the bankrupt island nation tide over its worst economic crisis and protect the livelihoods of the people. The country is also expected to restructure its debt worth USD 29 billion, with Japan expected to coordinate with other creditor nations, including China on this issue. In mid-April, Sri Lanka declared its international debt default due to the forex crisis. The country owes USD 51 billion in foreign debt, of which USD 28 billion must be paid by 2027. There have been street protests in Sri Lanka against the government since early April due to its mishandling of the economic crisis. A crippling shortage of foreign reserves has led to long queues for fuel, cooking gas, and other essentials while power cuts and soaring food prices have heaped misery on the people. (PTI)

Japan, US to hold security talks before Kishida meets Biden

States will hold security talks between their foreign and defence ministers in Washington the day before Japanese Prime Minister Fumio Kishida lands in the US capital next week wrapping up his tour of Group of Seven nations as Tokyo expands its military and deepen alliance with America amid China's growing influence.

Kishida will embark on a six-nation trip Monday to France, Italy, Britain and Canada ahead of his January 13 summit with US President Joe Biden. Defense Minister Yasukazu Hamada and Foreign Minister Yoshimasa Hayashi will fly to Washington to join their American counterparts Lloyd Austin and Antony Blinken for their "2+2" security talks on Wednesday, just before their leaders' summit at the White House, Japanese officials said Friday. The "2+2" talks are expected to focus on their new national security strategies, released by Japan in mid-December and the United States in October, and how the two allies plan to tackle security concerns including China, North Korea and Russia. "We will discuss strengthening of deterrence and response capability of the Japan-US alliance as we take into consideration our new strategy documents," Hamada told reporters.

Hamada said Friday he and Austin will separately hold bilateral defence talks on Thursday to discuss details of how their militaries can expand and deepen their

based on Japan's more defensive role, Hamada said nothing has been decided. Japan in December adopted a set of three security and defense strategy documents that break from its exclusively self-defenceonly stance. Under the new strategies, Japan vows to build up its counterstrike capability with long-range cruise missiles that can reach potential targets in China, double its defense budget within five years and bolster development of advanced weapons. US officials have welcomed Japan's willingness to take on more offensive role, while experts say it could also help widen cooperation with Australia, their main regional defence partner. Kishida on Wednesday said his talks with Biden will underscore the strength of the Japan-US alliance and highlight closer cooperation between the countries under Japan's new security and defense strategies adopted last month. Kishida said coordination with other G-7 leaders ahead of the Hiroshima summit he will host in May is a key purpose of his trip, but Japanese officials said their talks will also focus on security and military cooperation. Kishida plans to discuss further deepening of security ties with France through joint military exercises. Multiple people wounded in shooting near Florida restaurant

MIAMI GARDENS, JAN 6 /--/ Multiple people were wounded in a shooting after an altercation outside a restaurant in south Florida, police said. It wasn't immediately clear how many people were hit by gunfire Thursday night, but the Miami Herald cited a law enforcement source saying as many as 10 people were wounded in the shooting outside a soul food restaurant in Miami Gardens. Investigators were looking into reports that a video was being shot at the restaurant. Miami Gardens Police Chief Delma Noel-Pratt said. "We believe it's an isolated incident," Noel-Pratt said. Miami Gardens police spokesperson Diana Gourgue told reporters that she could not confirm reports that as many as 10 people had been wounded, saying "right now it is just multiple victims that were injured." She said the condition of those hurt was unknown, but there were not any fatalities. She said a large crowd had gathered outside the restaurant at the time of the shooting. Social media posts also said a music video was being filmed. (AP)

Covid may change body's response to other threats in men: Study

WASHINGTON, JAN 6 /--/ Covid-19 can trigger stronger inflammatory responses in males, resulting in changes to their functional immunity long after recovery, a study has found. The findings may also help create better vaccines against diverse threats by, for instance, mimicking how mild Covid-19 changes the male immune system, the researchers said. Scientists have long believed that the immune system reverts to the previous stable level after



viral infection. However, the latest study published in the journal Nature, shows that it depends on the individual's sex. Researchers at the US National Institute of Allergy and Infectious Diseases (NIAID) systematically analysed immune responses of healthy people who had received the flu vaccine. From that data, they then compared the responses between those who had never been infected by SARS-CoV-2, the virus that causes Covid-19, and those who experienced mild cases but recovered.

The team found that immune systems of men who had recovered from mild cases of Covid-19 responded more robustly to flu vaccines than women who had mild cases or men and women who had never been infected. The baseline immune statuses in men previously infected with SARS-CoV-2 was altered in ways that changed the response to an exposure different from SARS-CoV-2, the researchers said. "This was a total surprise," said John Tsang, an immunobiologist at Yale University in the US, who was previously at NIAID. "Women usually mount a stronger overall immune response to pathogens and vaccines, but are also more likely to suffer from autoimmune diseases," Tsang said. The findings may also be linked to an observation made early in the pandemic: Men were much more likely to die from a runaway immune response than women after contracting the Covid-19 virus. The findings suggest that even mild cases of Covid-19 might trigger stronger inflammatory responses in males than females, resulting in more pronounced functional changes to the male immune system, even long after recovery. Their analysis of immune system status down to the individual cell level showed several differences between Covidrecovered males and healthy controls and Covidrecovered females, both before and after receiving flu vaccinations. For instance, previously infected males produced more antibodies to influenza and produced increased levels of interferons, which are produced by cells in response to infections or vaccines. "Our findings point to the possibility that any infection or immune challenge may change the immune status to establish new set points," said lead author of the study, Rachel Sparks, from NIAID. "The immune status of an individual is likely shaped by a multitude of prior exposures and perturbations," Sparks added. (PTI)

Kremlin-ordered truce is uncertain amid suspicion of motives

President Vladimir Putin's order for his forces in Ukraine to observe a unilateral, 36hour cease-fire was in doubt Friday after Kviv officials dismissed the move as a plov but didn't clarify whether Ukrainian troops

Moscow also didn't say whether it would hit back if Ukraine kept fighting. The Russian-declared truce in the nearly 11month war began at noon Friday and was to continue through midnight Saturday Moscow time (0900 GMT Friday to 2100 GMT Saturday; 4 a.m. EST Friday to 4 p.m. EST Saturday). There were no immediate reports of it being broken. Putin's announcement Thursday that the Kremlin's troops would stop fighting along the 1,100kilometer (684-mile) front line or elsewhere was unexpected. It came after the Russian Orthodox Church head, Patriarch Kirill, proposed a cease-fire for this weekend's Orthodox Christmas holiday. The Orthodox Church, which uses the Julian calendar, celebrates Christmas on Jan. 7. But Ukrainian and Western officials suspected an ulterior motive in Putin's apparent

Ukrainian President Volodymyr Zelenskyy questioned the Kremlin's intentions, accusing the Kremlin of planning the fighting pause "to continue the war with renewed vigor." "Now they want to use Christmas as a cover to stop the advance of our guys in the (eastern) Donbas (region) for a while and bring equipment, ammunition and mobilized people closer to our positions," Zelenskyy said late Thursday. He did not, however, state outright that Kyiv would ignore Putin's request, U.S. President Joe Biden echoed Zelenskyy's wariness, saying it was "interesting" that Putin was ready to bomb hospitals, nurseries and churches on Christmas and New Year's. Covid infection reshapes immune status depending on gender: Study

WASHINGTON, JAN 6 /--/ Scientists have found that the baseline immune statuses in men previously infected with SARS-CoV-2 was altered in ways that changed the response to an exposure different from SARS-

The team of researchers systematically analyzed immune responses of healthy people who had been given the flu vaccine. From that data, they then compared the responses between those who had never been infected by SARS-CoV-2, the virus that causes Covid-19, and those who experienced mild cases but recovered. The team led by John Tsang, an immunobiologist from Yale University, US, found that immune systems of men who had recovered from mild cases of Covid-19 responded more robustly to flu vaccines than women who had had mild cases or men and women who had never been infected. "This was a total

surprise," said Tsang. "Women usually mount a stronger overall immune response to pathogens and vaccines, but are also more likely to suffer from autoimmune diseases," said Tsang. The longterm effects of infection on the

immune system had long intrigued Tsang. After the body has faced down pathogen, does the immune system return to the previous baseline? Or does a infection change it in ways that alter how it will respond not only to a familiar virus but also to the next new viral or bacterial

Tsang, a professor at Yale University, had long believed that the immune system reverts to the previous stable baseline after viral infection. The emergence of

the Covid-19 pandemic in 2020

allowed him and colleagues to test that theory. The answer, they depends on individual's sex. The findings have been published in the journal Nature. The findings may also be linked to an observation



were much more likely to die from a runaway immune response than women after contracting the Covid-19 virus. Even mild cases of Covid-19, the new findings suggest, might trigger stronger inflammatory responses in males than females, resulting in more pronounced functional changes to the male immune system, even long after recovery.

According to the study, their unbiased analysis of immune system status down to the

individual cell level revealed several differences between Covid-recovered males and healthy controls and Covidrecovered females, both before and after receiving vaccinations. For instance, previously infected produced

antibodies to influenza and produced increased levels of interferons, which are produced by cells in response to infections or vaccines. Generally, healthy females have stronger interferon responses than their male counterparts, the study said. Understanding the lingering effects of Covid-19 on the immune system is crucial, the authors said, since more than 600 million people worldwide have been infected so far, and the emergence of "long-COVID" symptoms in some people continues to be a major health concern. "Our findings point to the possibility that any infection or immune challenge may change the immune status to establish new set points," said lead author Rachel Sparks, from National Institute of Allergy and Infectious Diseases (NIAID). "The immune status of an individual is likely shaped by a multitude of prior exposures perturbations," said Sparks.

Tsang thinks these findings may also help scientists create better vaccines against diverse threats by, for instance, mimicking how mild Covid-19 changes the male immune baseline. (PTI)

Cricket calendar was sent to PCB on Dec 22, Sethi's comments baseless: ACC

Cricket Council (ACC) has slammed the Pakistan Cricket Board (PCB) chairman over the comments made by him following the announcement of ACC Calendar 2023-24 and the pathway structure on Thursday. PCB's interim chairman Najam Sethi had criticised Jay Shah for 'unilaterally' presenting the structure and calendar. Now, the Asian cricketing body has hit back, suggesting the calendar was shared on December 2022 with all the members, including the Pakistan board but no

communication came from the latter's side. On Thursday, Shah had announced the ACC calendar 2023-24 and pathway structure for the continental body along with ODI Asia Cup slated in September. However, the calendar didn't have the host country's name as BCCI secretary Shah had already said last October (2022) that the tournament will be shifted out of Pakistan as India won't be able to travel. Sethi's predecessor Ramiz Raja had then made a counter-threat of pulling out of the ODI World Cup being held in India later this year. Sethi, who is

the media which effectively means that the PCB chairman was lying.

"The calendar was approved by its Development Committee and Finance & Marketing Committee in a meeting held on December 13th, 2022. The calendar was then communicated to all the participating members individually, including Pakistan Cricket Board (PCB), via an e-mail dated December 22nd, 2022," it further stated.

The PCB in the last two weeks didn't seek any modification in the proposed calender and hence there was a public announcement. "While responses were received from certain Member Boards, no comments or suggested modifications were received from PCB. In view of the above, Sethi's comments on a social media

denied by the ACC," the statement concluded. The socio-political tension between India and Pakistan has prevented the neighbours engaging in any bilateral cricket since 2012 and India has not visited the country post the 2008 Asia Cup. Team rebuilding for next T20 World Cup, we have got to be patient with youngsters, says Dravid

Dravid said the team was in the rebuilding phase, given the "next cycle of the T20 (World Cup)" had started. He added that youngsters will be handled patiently and will continue to get support from the team management, hinting that it could be the end of the road for the likes of Virat Kohli, Rohit Sharma and KL Rahul. Not blaming Arshdeep but no-balls in any format is a crime: Pandya

PUNE, JAN 6 /--/ Bowling no balls in any format is a crime, said India skipper Hardik Pandya, adding that it was not about blaming Arshdeep Singh but the young pacer needs to go back and rectify his basic errors. 

Gianluca Vialli, former Italy striker, dies At 58



ROME, JAN 6 /--/ Gianluca Vialli, the former Italy striker who helped both Sampdoria and Juventus win Serie A and European trophies before becoming a player-manager at Chelsea, has died. He was 58. The Italian football federation confirmed Vialli's death on Friday. Vialli announced in 2018 that he had overcome a year-long battle with pancreatic cancer but then said in December 2021 that the disease had returned. With his condition worsening, Vialli announced in mid-December that he was temporarily stepping down from his role as the delegation chief for Italy's

national team. Vialli had been appointed delegation chief under Azzurri head coach Roberto Mancini, his longtime friend and former teammate. Vialli and Mancini were known as the "gemelli del gol," or "goal twins," when they played together at Sampdoria, leading the club based in Genoa to its only Serie A title in 1991 and its only European title in 1990 with the Cup Winners' Cup — plus four Italian Cup trophies. Vialli and Mancini also led Sampdoria to the 1992 European Cup final, which it lost to Barcelona at Wembley Stadium.
