Andaman Law College established by Andaman and Nicobar Islands Legal Education Society (ANILES) and functioning under A & N Administration invites applications for filling-up the following teaching positions on contract basis for a period of 01 year:

1. Assistant Professor in Law

2. Director of Physical Education

Educational Qualification for the post Assistant Professor on Contract basis will be as per the UGC regulations, 2018

- (i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned subject from an Indian University, or an equivalent degree from an accredited foreign university. However, a relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differently abled for the purpose of eligibility and assessing good academic record for direct recruitment.
- (ii) The eligibility criteria of 55% marks and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
- (iii)Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC / NTA or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Educational Qualification for the post Director of Physical Education on Contract basis will be as per the UGC regulations, 2018

- (i) A Master's Degree in Physical Education and Sports or Physical Education or Sports Science with 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed)
- (ii) The eligibility criteria of 55% marks and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
- (iii)Record of having represented the university / college at the interuniversity /inter-collegiate competitions or the State and/ or national championships.
- (iv) Besides fulfilling the above qualifications, the candidate must have cleared the UGC/NTA-National Eligibility Test (NET), or have been awarded a Ph.D. Degree in Physical Education or Physical Education and Sports or Sports Science, in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time, as the case may be exempted from NET.

OR

(i) An Asian game or commonwealth games medal winner who has a degree at least at Post-Graduation level.

Note: The Academic score as specified in Appendix II (Table 3B) for Colleges shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.
