

Smti Droupadi Murmu elected as 15th President of India; first tribal woman and youngest President to hold post ; to be sworn-in on Monday

New Delhi, July 22

Smti. Droupadi Murmu has been elected as the 15th President of India. Returning Officer of the Presidential Election and Rajya Sabha Secretary General, Shri P C Mody announced the election of Smti Murmu after completion of counting of the votes last evening.

He said, Smti Murmu bagged 64 per cent of the votes in the poll and opposition Candidate Shri



Yashwant Sinha got 36 per cent. The Secretary-General said, of the four thousand seven hundred 54 valid electors, Smti Murmu got votes of two thousand 824 including 540 MPs

and the value of the vote is Six lakh 76 thousand 803. He said, Shri Sinha got the votes of One thousand eight hundred 77 law makers including 208 MPs and the value of the vote is three lakh

80 thousand 177.

Later, Returning Officer, Shri Mody went to Smti Murmu's residence and handed over the certificate to her.

Smti Murmu is the first tribal woman and the second woman to hold the position of President of India. Chief Justice of India, Justice N V Ramana will administer the oath of office to Smti Murmu on Monday at the Central Hall of Parliament. (Source: india.gov.in)

years, 4 beneficiaries were in the age group of 15 to 18 years and the number of beneficiaries administered precautionary dose of vaccine stood at 342.

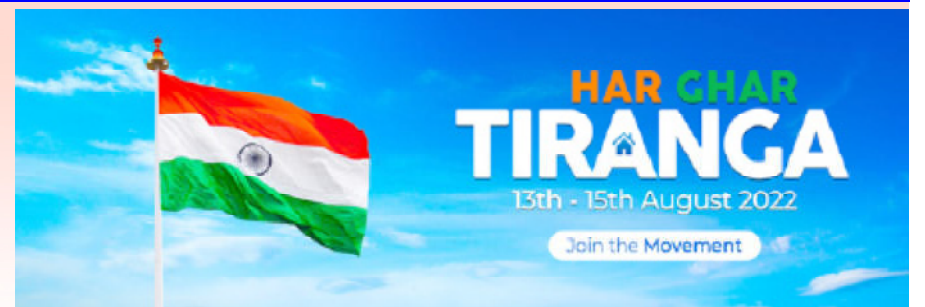





New Delhi, July 22

Indian students bagged three Gold, sixteen Silver, and five Bronze medals in various international Olympiads in Mathematics, Physics, Biology, and Chemistry. While the Mathematics Olympiad was held in Norway and Biology Olympiad in Armenia, the other two, hosted by Switzerland and China, were held virtually. In the International Mathematical Olympiad, (IMO) the Indian team got one gold and five bronze medals. Pranjal

Srivastava scored a hat trick with his 3rd consecutive Gold medal at the IMO. He is the first Indian to win 3 Gold medals at the IMO. In the International Physics Olympiad (IPhO) all five students who participated in the competition won medals. Deevyanshu Malu won Gold medal, Abhijeet Anand, Anilesh Bansal, Dheeraj Kurukunda, and Harsh Jakhar bagged silver medals. All the four Indian participants of the International Chemistry

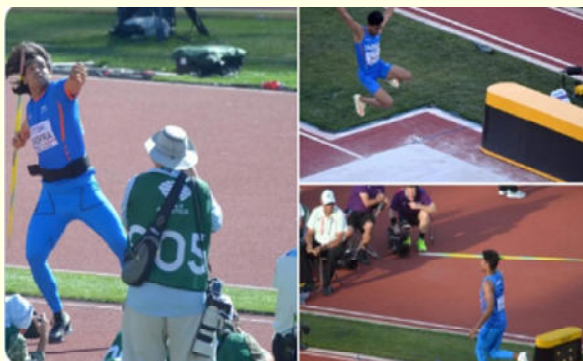
Olympiad (ICChO) also emerged victorious as Mahit Rajesh Gadhiwala, Nivesh Aggarwal, Tanishka Rameshchandra Kabra, and Chinmay Khokar bagged a silver medal each.

Neeraj Chopra, Rohit Yadav qualify for maiden World Athletics Championships final at Oregon in US

Oregon, July 22

India's Neeraj Chopra and Rohit Yadav have qualified for the men's javelin throw final at World Athletics Championships, in Oregon, USA. Olympic gold medalist, Chopra sealed his spot in the final with the very first throw of 88.39 metres in the qualification round. Chopra was the first to throw in Group A of the qualification round. The 24-year-old will now compete in the final, which is set to be held early morning tomorrow. Rohit Yadav joined Chopra in the javelin throw final with a best effort of 80.42 metres. Along with Neeraj and Rohit, India's Eldhose Paul



qualified for the men's Triple Jump final with a jump of 16.68m. Paul became the first Indian to qualify finishing sixth in the Group A qualification round and 12th overall to make the cut for Sunday's final. Sports Minister, Shri Anurag Singh Thakur has congratulated Neeraj Chopra, Rohit Yadav and Eldhose Paul for their performances in the

World Athletics Championships at Oregon in the United States. In a tweet, Shri Thakur said, India created history at the championship. He said, for the first time two Indian Javelin throwers Neeraj Chopra and Rohit Yadav reach the Final at World Championships. He said, Eldhose Paul, becomes the first Indian to reach the Men's Triple Jump Final.'
