# Maharashtra: 12 dead, 43 injured as bus catches fire after hitting truck in Nashik

# CM Shinde orders probe, survey to identify 'black spots' in state

passengers, including a two-year-old child, were killed and 43 others injured as a private bus travelling to Mumbai caught fire after hitting a trailer truck in Nashik city of Maharashtra early on Saturday, police officials

The accident took place at Nandur Naka on the Nashik-Aurangabad highway around 5.15 am when the sleeper bus was coming from Yavatmal in eastern Maharashtra, they said. PM Modi expressed grief over the loss of lives in bus tragedy and announced an ex-gratia of Rs 2 lakh for the next of kin

of each deceased and Rs 50,000 each for the injured. Chief minister Eknath Shinde announced a financial assistance of Rs 5 lakh to the families of the dead and said the medical expenses of the injured would be borne by the state government. The CM visited the spot and the District Civil Hospital, where most of the patients were admitted. He said a detailed inquiry into the accident will be carried out. "A luxury bus travelling to Mumbai from Yavatmal hit a trailer truck going to Pune at an intersection near Mirchi Aurangabad highway. Soon after ramming into the

truck, the bus caught fire in which 12 passengers died and 43 others suffered injuries," a police official

The deceased included a two-year-old child, he said, adding that the bus was completely destroyed in the incident. The injured

skull cap surface in Gujarat cities AHMEDABAD, OCT 8 /--/ Banners terming Delhi chief NEW DELHI, OCT 8 /--/ minister Arvind Kejriwal as "anti-Hindu" and showing him wearing a skull cap surfaced in several prominent cities in Gujarat on Saturday, the day the AAP leader is on a visit to the poll-bound state to campaign for his party ahead of the Assembly elections. Along with Kejriwal's pictures, some banners carried lines like "I consider Hindu religion as madness", while some others had "anti-Hindu Keiriwal go back" message. These banners cropped up in Ahmedabad, Rajkot, Surat and Vadodara cities, a day after a controversy erupted over a video clip showing Aam Aadmi Party's Delhi minister Rajendra Pal Gautam at a "religious conversion" event where hundreds could be heard taking an oath Sunday. denouncing Hindu deities. The Bharatiya Janata Party (BJP) has slammed the minister and accused the AAP of hurting the sentiments of Hindus. In Rajkot, the posters

targeting the AAP and Kejriwal were destroyed by the party workers. Banners saying "anti-Hindu Kejriwal go back" were seen in Dahod town, where the Delhi CM and his Punjab counterpart Bhagwant Mann were to address a public gathering on Saturday. These two AAP leaders have started their two-day Gujarat visit from Saturday. The banners carried different sentences, including, "I consider Hindu religion as madness", "I will not believe in Brahma, Vishnu, Ram and Krishna" and "I will not do 'shraddha pind daan' or any other Hindu ritual". However, all the banners had a common sentence - "These are the words and culture of AAP." The AAP has positioned itself

as a main contender of the BJP in Gujarat, where Assembly elections are slated to be held soon. On Friday, the BJP said that people will teach AAP a lesson in the upcoming Assembly elections over its Delhi minister Gautam taking oath denouncing Hindu deities. State education minister Jitu Vaghani said the AAP minister insulted Hindu deities that are centres of devotion for the people of Gujarat, and asked Kejriwal to take strict action against him by sending him to jail. The political row erupted after a video clip of Gautam at a "religious conversion" event went viral in which hundreds can be heard taking an oath denouncing Hindu deities. Gautam is the social welfare minister in the Arvind Kejriwal government. During the programme, around 10,000 people reportedly took vows to convert to Buddhism to follow Lord Buddha's teachings and give up worship of Hindu deities. Delhi Chief Minister Arvind Kejriwal has been campaigning aggressively in Gujarat by making several promises. (PTI)

#### Media report claiming shortage of pneumococcal vaccines 'ill-informed', says Union health ministry

NEW DELHI, OCT 8 /--/ The Union health ministry on Saturday said a recent media report claiming there is a shortage of pneumococcal vaccines in the country is "illinformed" and over 70.18 lakh doses are available with states and union territories. The report, which quoted health officials including Maharashtra's State Immunisation Officer, stated that a tendering delay has led to the disruption in pneumococcal vaccination schedules of tens of thousands of children across the country for over a month. "The news report is ill-informed and provides erroneous information," the ministry said in a statement. "As per data available till October 7, 2022, sufficient doses of PCV vaccine are available. A total of 70,18,817 (70.18 lakh) doses of PCV (pneumococcal conjugate vaccine) are available with all States and UTs. This includes 3,01,794 (3.01 lakh) doses of PCV with Maharashtra," it said. According to Health Management Information System data, a total of 3,27,67,028 (3.27 crore) PCV doses were supplied to all states and union territories by the government between January and September this year, the ministry said. This includes 18,80,722 (18.80 lakh) doses of PCV utilised in Maharashtra, it added. The supplies against procurement of PCV for 2022-23 have also commenced to the states and UTs, it added. Pneumonia is one of the major causes of child mortality. (PTI)

The project involved developing a groundmounted solar power plant and more than 1,300 rooftop solar systems on residential and government buildings, all integrated with a battery energy storage system (BESS). It will demonstrate how India's renewable prowess empower people grassroots, the statement said. The projects being dedicated to the nation by the prime minister include the gauge conversion of the Sabarmati-Jagudan rail segment, ONGC's Nandasan geological oil production project and projection mapping at the Sun Temple at Modhera, among others. In Bharuch, Modi will lay the foundation stone of the Bulk Drug Park at Jambusar. Noting that bulk drugs accounted for over 60 per cent of total pharmaceutical imports in 2021-22, the statement said the project would play a key role in substitution and help make India self-reliant in the sector. # Witness statement, including cross-examination, be recorded either on same or following day: SC

NEW DELHI, OCT 8 /--/ The Supreme Court has held that statement of a witness, including crossexamination, has to be recorded either on the same or the following day and there should not be any ground for adjournment on this. The apex court, which was hearing two pleas seeking quashing of bail granted by the Allahabad High Court to two persons in murder case, was informed that it took almost

three months to conclude recording of statement of one of the prosecution witnesses. "The mandate of law itself postulate that examination-in-chief followed with crossexamination is to be recorded either on the same day or on the day following," a bench of justices Ajay Rastogi and C T Ravikumar said. "In other words, there should not be any ground for adjournment recording

examination-in-chief/crossexamination of the prosecution witness, as the case may be," the top court said in its order passed on September 30. The high court, in its two separate orders passed in February and March, had granted bail to the two persons in connection with the case lodged at Bhadohi district in Uttar Pradesh for the alleged offences including that of murder. During the hearing before the apex

court, the bench was recorded on September 21 informed that there are eye-witnesses according to the list of witnesses and charge sheet has been filed in the case.

The bench was also told that statement of one of the prosecution witnesses has been recorded and it took almost three months to conclude. It was apprised that so far as statement of another prosecution witness is concerned, part of the examination-in-chief was and despite request been made, the mandate of section 309 of the Code of Criminal Procedure (CrPC) was not being followed which has been considered by the apex court in a judgment delivered in 2014. Section 309 of the CrPC deals with power to postpone or adjourn proceedings. In its order, the apex court noted that it would like to observe that the trial judge may take a note of the top

reference to section 309 of the CrPC. It noted that the trial judge may not only expedite the trial but the examination-in-chief or cross-examination of a witness is to be recorded either on the same day or on the day following but no long adjournment should be granted while recording the statement of prosecution witnesses. The bench has posted the matter for hearing after six weeks. (PTI)

NEW DELHI, OCT 8 /--/ Voicing strong support for Shashi Tharoor in the Congress presidential poll, party MP Karti Chidambaram on Saturday said the former diplomat's pragmatic modernism coupled with his appeal beyond the party is crucial to fight against the BJP's "divisive politics" Chidambaram also asserted that business as usual will not help the Congress and there is an urgent need for reformist thinking in the party. "I support Shashi Tharoor for Congress President. His pragmatic modernism coupled with his appeal beyond the party, is crucial to fight BJP's divisive politics,' the MP from Tamil Nadu's Sivaganga said. "Status quo and business as usual won't help our party. There's an urgent need for reformist thinking in our party," said Chidambaram, who was among those who signed Tharoor's nomination forms for the Congress presidential polls as proposers. Responding to a social media user who claimed that Tharoor is everything that the ruling Bharatiya Janata Party (BJP) propagates as 'English-enabled privileged elitism", Chidambaram asked since when was proficiency in a language considered to be a disadvantage and a liability. "Shashi Tharoor appeals to an audience well beyond the party faithful. (PTI)

### Land-for-railway jobs scam: CBI files charge sheet against Lalu, Rabri

NEW DELHI, OCT 8 /--/ The CBI filed a charge sheet Friday against former railway minister Lalu Prasad, his wife Rabri Devi and 14 others in connection with alleged appointments made in Railways in return for land parcels gifted or sold to his family, officials said.

In the charge sheet filed before a special CBI court here, the agency has also named Prasad's daughter Misa Bharti, former general manager of Central Railways Sowmya Raghvan, former CPO Railways Kamal Deep Mainrai, seven aspirants appointed as substitutes and four private individuals. "During investigation, it has been found that the accused in conspiracy with the then GM, Central Railways, and CPO, Central Railways, engaged persons as substitutes in lieu of land either in their name or in the name of their close relatives," a CBI spokesperson said in a statement. The agency has kept the investigation open with respect to other transactions, they said. "This land was acquired at prices lower than the prevailing circle rate and much lower than the market rate. It was also alleged that the candidates have used false TC and submitted false attested documents to the Ministry of Railways," the spokesperson said.

During the probe, the agency claimed to have found a hard disc from 10 Circular Road, Patna, the then camp office of Prasad when he was the Union railway minister. The CBI said it had a list of 1,458 candidates engaged in the Railways during his tenure. The agency has alleged that residents of Patna were appointed as 'substitutes' in group D posts in different zones of the Railways who were regularised during 2004-09. In exchange, the beneficiaries themselves or their family members allegedly transferred land parcels in the name of family members of Prasad and a company called AK Infosystems Private Limited, the agency has alleged. The company was subsequently taken over by Prasad's family members, it said. The payments for the parcels of land were mostly shown to be made in cash, while there were also instances of transfer of land through gift deeds, it is alleged. (PTI)

#### Brain dead ex-BSF jawan donates organs at AIIMS Delhi, saves 3 lives

NEW DELHI, OCT 8 /--/ The family of a 52-year-old ex-BSF jawan who was declared brain dead at the All India Institute of Medical Sciences (AIIMS) here donated his organs, offering a new lease of life to three people.

While Rakesh Kumar's one kidney was used at the AIIMS Delhi itself, the other was sent for a patient at the Safdarjung hospital. His heart was transplanted in a patient at the Army's Research and Referral (RR) Hospital. Kumar, a native of Firozabad, had suffered a fall while carrying out some electricity repairs at his home on October 3. He was rushed to a local trauma centre which referred him to the AIIMS, a doctor said. Kumar was admitted to AIIMS Trauma Centre early on October 4 and was operated upon. He was declared brain dead on October 6, the doctor added. His family was counselled for donating the organs and they agreed. "His heartwas transplanted in a patient at the Army RR Hospital on Friday. His one kidney went to a patient at Safdarjung hospital while his other kidney was used at AIIMS. Both his corneas have been preserved for transplant in the coming weeks," the doctor said, adding the liver was not found to be suitable for transplantation. The organ procurement services at AIIMS Trauma Centre is led by Professor of Neurosurgery, Dr Deepak Gupta. Nearly one person dies in road traffic accident every three minutes in India currently (1,50,000 deaths per year) but only 700 organ donations happen each year. Awareness about organ donation is the need of hour, he said. (PTI)

#### Uttarkashi avalanche triggers debate, experts differ over cause

**DEHRADUN, OCT 8**/--/The recent avalanche near Draupadi Ka Danda-II peak that killed at least 26 mountaineers in Uttarkashi district has triggered a debate among scientists unanimous view on the possible reasons, most of them feel attributing the avalanche to a mild earthquake that rocked Uttarkashi two days earlier was incorrect. The tremor, measuring 2.5 on the Richter scale, hit Uttarkashi on October 2. It was too mild and its epicentre too far from the avalanche site, said a scientist at Wadia Institute of Himalayan Geology here. "The mild-intensity earthquake occurred two days before the avalanche and its epicentre was in a village whose aerial distance from the peak is around 25 km," Manish Mehta, a scientist at the Wadia Institute of Himalavan Geology here said. "So it is least likely that the avalanche was caused by the earthquake.

One expert attributed the avalanche to higher snowfall in the region. Snowfall in the upper Himalayan region has been more frequent this time and, due to fluctuation of temperature, fresh snow accumulated on the slopes may be sliding down in the form of avalanches before it can settle. As many as three avalanches hit the neighbouring Kedarnath valley over 11 days since September 22. Of the three, the latest avalanche occurred just 5 km away from Kedarnath temple at Chorabari glacier on October 1. But no one was harmed in these avalanches. "Fresh snow avalanches can be caused even by high-speed winds. Hence, no one can pinpoint one single reason for the avalanche that hit the mountaineers in Uttarkashi," said Uttarakhand Space Application Centre Director MPS Bisht. Avalanches cannot be prevented but precautions and safeguards can be taken while trekking or mountaineering in the upper Himalayan region, he added. Nehru Institute of Mountaineering (NIM) Registrar Vishal Ranjan said the injured trainees who were part of the team said it was a slab avalanche. They said a portion of the ice slab towards which the team was trekking was the first to cave

Many of whom have upheld that solemn affirmation with utmost dignity, sincerity and apolitical courage that can only be personal to the individual concerned. whereas many, could have

done a lot more. The challenge on the various incumbents was to disallow the slide from a constitutional democracy to a diminishment thereof (as it happened, infamously in 1975), and even to a populist one could also have a majoritarian acceptance the political passions and compulsions of the 'executive-of-the-day' must always remain subordinate the canons of Constitutional propriety and spirit, as envisaged originally.

This natural conflict or challenge is, at the heart of the litmus test of apolitical conduct, sagacity and ability to remain unbeholden to forces that may have helped the incumbent to become the 'First Citizen', in the first place.

Amongst the most assertive, constitutionally sensitive Rashtrapati was KR Narayanan who often scripted his own speeches punctuated with facts that forced the dispensation of the day to act or retract on a stated line.

Presidentship for KR Narayanan, did not tantamount to a mere titular head, or worse, 'rubber stamp'. While addressing the nation on the Golden Jubilee of Indian Republic on 26 Jan 2000, instead of parroting the usual generalities that the dispensation would have shared, he chose to breakaway and express his of the concerns on the growing

societal disparities, socioeconomic inequities, rural or agrarian stress, spoke against the elites - clear departure from the rosier picture that the government may have liked to project.

KR Narayanan was not happy to rest on the symbolic laurels of 'First Dalit President' rather, he exercise to Presidential discretion, Presidential assert responsibility and to be a 'working President' who 'within four corners of the Constitution'.

It is frightening to see how increasingly, people use the word 'ceremonial' along with the post of 'Rashtrapati', as the definitive adjective. It need not, should not, be so.

We now have the 15th Rashtrapati, who like KR Narayanan's 'First Dalit'. has been prefixed with a political espousal tag of symbolic nomenclatures.

The highest point on the Raisina Hill i.e., Rashtrapati Bhavan, overlooking India's governance quarters of North/South block. Parliament and other Ministries must always retain its apolitical voice, necessary intervention, unmistakable articulation, in defence of the Constitution.

It simply cannot go silent, purely ceremonial or obliging to the passions of partisan quarters littered across the Raisina Hill. The institutions of checks and balances like the uncaged, regulatory bodies like Enforcement Directorate(ED), Reserve Bank Of India(RBI), Comptroller and Auditor General of India(CAG) etc., free press, empowered judiciary and above all, the institution of Rashtrapati, needs to be

safeguarded from partisan appropriations, suppressions obligations. Many have unfortunately bowed to the partisan forces that were responsible for escalation of the said individual to the Rashtrapati post-whereas, many have admirably shed their political past and upheld the apolitical and constitutional covenant,

sacredly and fearlessly,

without fear or favour. While the lead-up to the Rashtrapati elections a couple of months back was unusually quiet, unfought for and a bit of a foregone conclusion considering the backdrop of the electoral maths involved - the winning candidate barely made a compelling pitch, perhaps it wasn't required at all. All perfunctory and platitudinous statements that followed, were also politely generic.

It must be said, that for the last few years the 'Voice' from the top of Raisina has only been ceremonial and rather muted - especially considering that the nation has been in the throes of extreme socio-economic pressures, polarisation and 'divide' that has been unprecedented. It is not as if every little 'masterstroke' of the dispensation of the day has landed at the right spot. With a fragmented and inefficacious opposition, the onus of calling a spade a spade is even more loaded onto the Rashtrapati. Will she deliver? Only time will

fearless, as the cost of a weakened institution could be fatal, especially one that it at the top of sovereign's identity and democratic mooring. Now, with the historic and martialsounding Rajpath getting renamed as 'Kartavya Path', the onus is on the sole incumbent who resides at the beginning or end of that path having even more kartavya to 'voice' its duty. And that reminder at the forecourt standing tall (without a change of name, as yet), will constantly remind the Rashtrapati with the simple and timeless goad, "In thought faith, In word wisdom, In deed courage, In life service, So may India be great."

# IAF gets newage chopper

The induction of the first fleet of the indigenously built Light Combat Helicopter (LCH) comes as a major demonstration of India's combat prowess, over two decades after the need for such a lethal platform for mountain warfare was felt following the Kargil conflict with Pakistan. Developed by staterun aerospace major Hindustan Aeronautics Limited (HAL), the 5.8-tonne twin-engine chopper is armed with air-to-air missiles, 20-mm turret guns and rocket systems, and is capable of destroying enemy tanks, bunkers, drones and other assets in highaltitude regions. The helicopter possesses modern stealth characteristics, robust armour protection and formidable night-attack capability, and is fully capable of even operating in Siachen, the world's highest battlefield. Prime Minister Narendra Modi hailed the induction of LCH 'Prachanda' as a "special moment for the collective resolve of 130 crore Indians to make our nation strong and self-reliant in the defence sector. Congratulations to every Indian! The defence minister named the helicopter as "Prachand" (fierce). The IAF said the helicopter's name is a "testimony to its lethality and versatility" The induction of the LCH, with its tremendous power and versatility, not only enhances the combat capabilities of the IAF but is also a big step towards self-reliance in defence production. The all-terrain, day-and-night chopper perfectly meets the needs of the armed forces and is among the best in its class globally. The combat helicopter is a shot in the arm for the 'Make in India' initiative in the defence sector and reflects the country's capabilities in defence

The induction of the chopper comes at a time when India and China are locked in a military standoff at certain friction points in eastern Ladakh. Since the Kargil War in 1999, the need for the LCH was felt more and the chopper was a result of two decades of efforts in that direction. The four gunship choppers — armed with air-to-air missiles, 20-mm turret guns, rocket systems and other weapons - have been developed mainly for mountain warfare. The agility and manoeuvrability make the LCH an appropriate choice for mountain warfare as it can take off and land with a payload even at 16,000 feet. The helicopters are expected to bolster Indian Air Force's air power as they are capable of carrying out strikes on the enemy's infantry, tanks, bunkers and drones in high-altitude areas, besides being well equipped for counterinsurgency operations.

Previously, the IAF had to depend on foreignorigin attack helicopters not just for its own operations but also for UN peacekeeping missions abroad. The welcome addition of LCHs to the IAF inventory comes a month after the commissioning of India's first indigenous aircraft carrier, INS Vikrant. In June, the Coast Guard had commissioned the indigenous Advanced Light Helicopter MK-III's squadron. These are good tidings for India's defence industry, which is not only becoming less importdependent but also making its presence felt in the international arena. The government claimed recently that defence exports had grown 334% in the past five years, with India now exporting to over 75

He remained in jail for 16 months during Emergency. Kodiyeri became the Kannur district secretary of the party in 1980. that Kodiyeri's passing away will create a big void in Pinarayi's political and personal life. Kodiyeri was, as Pinarayi himself described, not only the closest comrade but a loving brother who stood by him through thick and thin. An affable leader, Kodiyeri was also an efficient minister. His term as the Home Minister under VS saw the implementation of the novel concept of a "janamaitri" (people-friendly) police. # Marxist scholar Ramkrishna Bhattacharya passes away

Dr. Ramkrishna Bhattacharya, a renowned Kolkata based Marxist scholar passed away in a city hospital on October 2. He was 74. An unrepentant old-fashioned Marxist, Ramkrishna Bhattacharya preferred, for the most part of his life, to work for the 'party in the broad historical sense', as envisaged by Marx in a letter (29 February 1860) to Ferdinand Freiligrath. Of course, during his student life Bhattacharya was involved in active party politics and even became the President of the Bengal Provincial Student Federation. However, he resigned from the post following the invasion of Czechoslovak Socialist Republic by the Warsaw Pact countries headed by the then USSR in 1968. Gradually Bhattacharya withdrew himself from active Left politics which he came to see as increasingly getting tied up with the electoral mechanism. His faith in Marxism as a radical philosophy was never shaken.

Marxism, for Bhattacharya, was primarily a worldview and its objective was to overthrow the capitalist system. He accepted that it has to be a long unabated struggle (by no means to be completed in one's lifetime) to spread ideas conducive to bring about a qualitative change in the prevalent socio-economic set-up. It was Bhattacharya's sincere belief that as agents of socio-economic change human beings must undergo a process of change themselves. It was with this intention that he, through his varied and copious writings, launched a relentless effort to create a scientific temperament among his readers necessary for establishing socialism. for Bhattacharya. Marxism, for

He set for himself the task of a

marathoner, not bothered about short-

term electoral politics. Bhattacharya always believed that Marxism is not merely a political programme. In fact, its philosophical basis of dialectical materialism taught him to view the past and the present as a continuous process of struggle against oppression, both economic and ideological. It is for this reason that Bhattacharya, inspired by the late and Debiprasad Chattopadhyaya, studied, researched and championed the Carvaka/Lokayata, the materialist school of Indian philosophy. Besides, Bhattacharya also understood the significance of the post-Renaissance European materialist philosophy as regards the emergence of Marxism. It is for this reason, he made critical investigations into the nineteenthcentury Bengali rationalist and materialist thinkers, focusing particularly on the outlook of Iswarchandra Vidyasagar in the context of his lifelong fight against obscurantism and bigotry. Bhattacharya had always acknowledged the progressive role played by an individual in history while, at the same time, accepting his/ her limitations imposed by time, place and circumstances. This dialectical approach and the long view of history have together been the guiding principle

Bhattacharya, was a working principle, not a closed philosophy. He, therefore, appreciated the pioneering roles of D DKosambi, Bhupendranath Dutta and Sankrityayan, writing Rahul extensively on the creative application of Marxism in their respective fields of inquiry.


Bhattacharya believed that an individual, working even in unconducive times, can leave a lasting impact on the posterity. Not only he had a longer perspective on history but also an inveterate optimism about human civilisation. No doubt, this conviction stemmed out of Bhattacharya's hope for a socialist future. He advocated others who (at the same time he himself tried) lit a lamp, as per a Chinese proverb, instead of cursing darkness. Ramkrishna Bhattacharya was, at

the same time, at home with English and Bangla. But he wrote more in Bangla in both renowned and obscure little magazines and periodicals. In fact, it was his lifelong uncompromising attitude to avoid the corporate-sponsored big publishing houses (in spite of 'offers' from them) for publicity and/ or honorarium. Moreover, he was equally sincere about the form of his essays and articles. In fact, Bhattacharya can be considered as one of the important Bangla prose writers of the present age. His dedication for research methodology is also noteworthy. Bhattacharya has rarity in these days. (IPA)

worked exhaustively on Marxist aesthetics, materialist philosophy and dialectics. What is significant in these and all his other books is his use of lucid prose. He made a point that his writings should be intelligible to both the initiated and uninitiated reader. Reading and writing for him was an illustration of his socialist mission. Bhattacharya wanted his work to reach as many people as possible who would all contribute in their own ways to build a better future.

Ramkrishna Bhattacharya, lest we forget, was a professor of English literature at both under-graduate and post-graduate levels. He not only excelled at and inspired many students with his classroom teaching but also contributed significantly to research in English studies. Moreover, his researches on Aristotle's Poetics and Sophocles' King Oedipus are also noteworthy.

Always keeping himself away from the glare of publicity, Bhattacharya, had a circle of associates, friends and colleagues and students, where he was in his elements. He had a liking for humour which his critics had no idea about. A relatively unknown fact about him is that he wrote for children in his inimitable prose style using the pseudonym of AngshuMitra. A life dedicated to reading and writing, Ramkrishna Bhattacharya will be remembered by his works (many writings are made available for free on academia.edu) and a man who fought obscurantism, both old and new, and sowed the seeds of change in the minds of his readers. Such a man is indeed a

According to doctors, the number of such cases has nearly doubled owing to an increased awareness about such infections necessitated bv the pandemic. "These days, we are getting more than 20 patients every day in the OPD with complaints of upper respiratory tract infections, undiagnosed prolonged fever, typhoid, cases of swine flu, allergies, pneumonia and dengue, said Dr Bhagwan Mantri, consultant pulmonologist and critical care specialist at Moolchand Hospital. "Earlier, the number of such patients was less than 10 per day but we are seeing a spike now," he said. The infections are happening across all age groups but when respiratory tract infections happen among the elderly, they assume a severe form, he added. Experts say that the surge of infectious diseases is generally seen after monsoon every year. But unlike in previous years, some hospitals are also witnessing cases of scrub greater numbers. "Dengue which has become a regular burden this season is a regular ailment these days among OPD patients. Besides, we are getting typhoid fever, acute gastroenteritis. viral hepatitis, upper respiratory infections, some cases of swine flu, and occasional Covid cases," said Dr Manoj Sharma, Senior Consultant Internal Medicine, Fortis Hospital Vasant Kunj. "This year we are getting cases of typhus and leptospirosis as well, although numbers are not huge, they are definitely more than previous years," he said. Scrub typhus is an infectious disease caused by Orientia tsutsugamushi, a mite-borne bacterium. Chigger mites, the larval stage of mites, transmit the disease from animals like rats, squirrels, and rabbits to humans. Leptospirosis is a infection transmitted through urine or excreta of rats and cattle. According to Dr SCL Gupta, Medical Director, Batra Hospital, the unseasonal rains and the sudden weather change could be a reason behind the spike in among the seven to eight years old. The symptoms breathlessness, cough, and uneasiness," Gupta said. Mantri concurred with Gupta and said that the month of September saw unseasonal rains, which could have been the trigger for this. "Earlier, the illnesses would rear their head in July and August but now with the rains in September, the timing of emergence these illnesses has also shifted to September," Manti said, adding that when Covid-19 was at its peak, a spike in such cases was not seen. Doctors advise people to wear masks since it not only protects against Covid-19 but other viruses too which get transmitted through the air. "Consult a doctor if you have a fever for more than 48 hours. Fever, if not treated well in time, can lead to complications,' advised Mantri. The senior doctor also said that thanks to Covid-19, people have started taking respiratory infections seriously people experience breathlessness, they consult a doctor since there is still some fear of Covid. Even physicians refer patients of respiratory illnesses to pulmonologists, " he added. (PTI)

#### Chandrayaan-2 spectrometer maps abundance of sodium on moon for 1 st time

BENGALURU, OCT 8 /--/ The X-ray spectrometer 'CLASS' on Chandrayaan-2 orbiter has mapped an abundance of sodium on the moon for the first time, according to the Indian Space Research Organisation.

Chandrayaan-1 X-ray Fluorescence Spectrometer (C1XS) detected sodium from its characteristic line in Xrays which opened up the possibility of mapping the amount of sodium on the moon, ISRO said. In a recent work published in 'The Astrophysical Journal Letters', Chandrayaan-2 mapped the abundance of sodium on the Moon for the very first time using CLASS (Chandrayaan-2 Large Area Soft X-ray Spectrometer), the national space agency said in a statement on Friday. "Built at the UR Rao Satellite Centre of ISRO in Bengaluru, CLASS provides



clean signatures of the sodium line thanks to its high sensitivity and performance," the statement said. The study finds that a part of the signal could be arising from a thin veneer of sodium atoms weakly bound to the lunar grains. These sodium atoms can be nudged out of the surface by solar wind or ultraviolet radiation more easily than if they were part of the lunar minerals. Also shown is a diurnal variation of the surface sodium that would

explain the continuous supply of atoms to the exosphere, sustaining it, the statement said. An interesting aspect that widens the interest in this alkali element is its presence in the wispy atmosphere of the moon, a region so thin that the atoms there rarely meet. This region, termed an 'exosphere', begins at the surface of the moon and extends several thousand kilometres merging into the interplanetary space, the statement noted. "The new findings from Chandrayaan-2 provide an avenue to study surface-exosphere interaction on the moon which would aid the development of similar models for mercury and other airless bodies in our solar system and beyond," the

ISRO said. (PTI)

#### Heroin worth Rs 350 crore seized from Pakistani boat off Gujarat coast

AHMEDABAD, OCT 8 /--/ The Coast Pakistani boat started evasive Guard and Gujarat Anti-Terrorist Squad have seized heroin worth Rs 350 crore from a Pakistani boat off the state coast and apprehended its six crew members, officials said on Saturday. The ICG and ATS personnel seized the boat Al Sakar, which had 50 kg heroin on board, in the Arabian Sea. The operation was conducted during the intervening night of Friday and Saturday, they said. The boat with six crew members on board was brought to the state's Jakhau port for further investigation, they added. A release issued by the ICG said the joint operation was carried out during the intervening night of October 7 and 8, when a Pakistani boat was observed moving suspiciously in Indian waters, five nautical miles inside notional International Maritime Boundary Line (IMBL) and 40 nautical miles from Jakhau. "On being challenged, the

manoeuvring. Two fast interceptor class of ships - C-429 and C-454 deployed by the ICG for patrolling in areas close to the IMBL, intercepted the Pakistani boat and forced it to stop," it said.vbFollowing a search of the boat, 50 kg of narcotic was found concealed in five gunny bags. The market value of the seized drug is estimated to be Rs 350 crore, it said, adding that the boat was brought to Jakhau for a further joint investigation by all agencies along with the six crew members, who were apprehended. This is the sixth such joint operation by the IGC and state ATS in the last year and the second such operation in less than a month when 40 kg drugs was seized from a Pakistani boat on September 14. Such operations have been a result of effective coordination and synergy amongst security agencies, the ICG said in a release.(PTI)

circular issued by All **India Institute of Medical** (AIIMS) Sciences Director Dr M Srinivas on Friday, the security staff shall ensure that all such people are handed over to the police outpost at the hospital for trespassing and exploiting patients. The information may also be e-mailed to director@aiims.edu, the circular said. It mentioned unidentified and unauthorised individuals belonging to certain private hospitals, laboratories

companies, and radiology centres etc., are often seen  ${\bf roaming\,inside\,the\,AIIMS}$ campus to seek monetary gain from the patients. It is also learnt that they facilitate the issuance of OPD cards and admissions. These agents also divert patients for laboratory or radiology investigations to private facilities. Some of them medicines, disposables, surgical

items and implants, the circular said. All such unidentified individuals, vendors and agents are strictly barred entering hospital campus, according to the circular. "All the doctors, nurses and staff members are hereby instructed that, even on the slightest suspicion of the presence of any unauthorised and unidentified person in the campus or around the departments and areas of the campus, immediately report to the special WhatsApp number 9355023969," it stated. The identity of the person who reports about such unauthorised people will be kept confidential and appropriate action will be taken to stop the exploitation of the patients. Wearing the designated uniform and displaying identity cards is a simple method to enhance security on the hospital premises and this will enable the administration unauthorised individual. Hence, the circular asked

all the staff members of the AIIMS to ensure that identity cards are worn within the campus. In addition, the staff working in the operation theatre shall have their names embroidered on their scrubs.



#### India adds 2,797 coronavirus infections, active cases drop below 30K after 122 days

NEW DELHI, OCT 8 /--/ India on Saturday logged 2,797 fresh Covid-19 infections that pushed its tally to 4,46,09,257, while the number of active cases dropped below 30,000 after 122 days, according to Union health ministry data.

The toll due to the viral disease climbed to 5.28,778 with 24 fatalities, including 12 deaths reconciled by Kerala, the data updated at 8 am stated. There are 29,251 active Covid-19 cases in India which comprise 0.07 per cent of the total infections. The national recovery rate has increased to 98.75 per cent, the ministry said. A decline of 1,111 cases has been recorded in the active Covid-19 caseload in a span of 24 hours. The daily positivity rate was recorded at 1.05 per cent. The weekly positivity rate was recorded at 1.30 per cent, the ministry said. The number of people who have recuperated from the disease surged to 4,40,51,228, while the case fatality rate was recorded at 1.19 per cent, it said. So far, 218.93 crore doses of Covid-19 vaccines have been administered under the nationwide vaccination drive, according to the ministry. India's Covid-19 tally had crossed the 20-lakh mark on August 7, 2020, 30 lakh on August 23, 40 lakh on September 5 and 50 lakh on September 16. It went past 60 lakh on September 28, 70 lakh on October 11, crossed 80 lakh on October 29, 90 lakh on November 20 and surpassed the one-crore mark on December 19. India crossed the grim milestone of two crore cases on May 4 last vear, three crore on June 23 and four crore on January 25 this year. The 12 fresh fatalities include five from Maharashtra and one each from Delhi, Gujarat and Karnataka, the ministry said. (PTI)



# Bengal's biggest festival gets back its grand closing ceremony after a gap of 2 years

KOLKATA, OCT 8 /--/ Durga Puja, the biggest festival in West Bengal finally ended on Saturday afternoon with a grand carnival of idols at the historic Red Road. The Durga Puja Carnival, which was introduced by the Mamata Banerjee-led West Bengal a few years back, skipped by the government during the last two years due to Covid-19 pandemic. This year however, there was no kind of restrictions on the Durga Puja organisers as Covid cases witnessed a sharp decline across the country.

Idols of the top 95 community Durga Pujas in the city were showcased at a grand carnival in the heart of the city on Saturday afternoon. Members of the  $community \verb"puja" committees"$  took part in a colourful parade on Red Road, showcasing the brilliant craftsmanship which was on display during the fiveday festival before an audience led by chief minister Mamata Banerjee, representatives UNESCO, diplomats of different countries and

others. UNESCO has accorded Intangible Heritage status to the city's Kolkata Durga puja. The carnival started around 4.30 pm after the chief minister reached the venue.

With musical and dance performances, the puja committees gave a tough competition to each other throughout the event. However, the biggest moment of the carnival was the chief minister's participation in a dance performance. Mamata came down straight from the dais,

held the hands of tribal dancers and danced to the tunes of a tribal song. TMC MLA June Malliah also joined the performances of several puja committees. The carnival in Kolkata is being organised annually since 2016. This year, such carnivals were organised in every district of the state this year to mark the UNESCO honour.

However. programme was held in Jalpaiguri as the district mourned the deaths of eight people who were swept away by a flash flood in the Mal river during immersion of idols on Bijaya Dashami. # India takes strong note of comments made by foreign ministers of Germany, Pak on J&K

Says all conscientious nations have responsibility to call out international terrorism

NEW DELHI, OCT 8 /--/ India on Saturday took strong note of comments by foreign ministers of Germany and Pakistan on Jammu and Kashmir and said all conscientious members of the global community responsibility to call out international terrorism, especially of a cross-border

Without directly naming Pakistan, external ministry spokesperson Arindam Bagchi said Jammu and Kashmir has borne the brunt of a terrorist campaign for decades and it continues till now. Bagchi responding to comments on Jammu and Kashmir by the Pakistani German foreign ministers at a joint press conference in Berlin on Friday. "All serious and conscientious members of the global community have a role and responsibility to call out international

terrorism, especially of a cross-border nature," he said. "The Indian Union Territory of Jammu and Kashmir has borne the brunt of such a terrorist campaign for decades. This continues till now," the MEA spokesperson said. Bagchi said foreign nationals have been victims there, as also in other parts of India. "The UN Security Council and FATF are still pursuing Pakistan-based terrorists involved in the horrific 26/11 attacks," he said. "When

states do not recognise such dangers, either because of self-interest or indifference, they undermine the cause of peace, not promote it. They also do grave injustice to the victims of terrorism," Bagchi added. At the press conference in Berlin on Friday, Pakistan foreign minister Bilawal Bhutto Zardari said peace inside South Asia would not be possible without the peaceful resolution of the Jammu and Kashmir dispute in accordance with the UN resolutions and taking into consideration the aspirations of Kashmiri

India has been strongly maintaining that Kashmir is a bilateral issue between New Delhi and Islamabad. German foreign minister Annalena Baerbock said she believed that every country in the world has a role and responsibility for solving conflicts and for ensuring that "we are living in a peaceful world". # Both Cong prez poll contenders people of stature, neither can be remote-controlled: Rahul

#### Objective of Bharat Jodo Yatra is not 2024 polls, says party's former chief

/ As Mallikarjun Kharge and Shashi Tharoor fight it out for the Congress chief's post, Rahul Gandhi on Saturday described both as people of stature and understanding, asserted that it was insulting to suggest that either of them can be remote-controlled by the Gandhi family as party president. Addressing a press

conference here during the Bharat Jodo Yatra, Rahul said lakhs of people have joined the yatra as they are tired of the type of politics being done under the BJP and the prevailing unemployment, price rise and economic inequality. A day after Gautam Adani pledged huge investments in Rajasthan, the former Congress president, who has often accused the Modi government of favouring the industrialist, said the Congress government in the state has not given any preferential treatment to the businessman, and asserted that he is not against corporates but monopolies. Asked about criticism from certain quarters that the next Congress president could be remote-controlled by the Gandhi family, Rahul said: "Both the people who are standing (in the polls) have a position, have a perspective and are people of stature and people of understanding. I don't think either of them is going to be a remote control (chief) and frankly, this tone is insulting to both of them."

Asked why he did not contest the polls, he said his reasons are there in his resignation letter that he gave while quitting the party chief's post in 2019. Elections to the Congress president's post will take place on October 17 and results will be announced on October 19. Rahul said by nature he believes in 'tapasya' and wanted an element of suffering in this

communication to people through the Bharat Jodo Yatra which seeks to cover a distance of about 3,500 km from Kanyakumari to Kashmir on foot. He also said the party is opposing the new education policy as it is "an attack on the ethos of our country, it distorts our history, culture". "We are opposing the policy as it concentrates power in the hands of a few people and centralises the education system. We want a decentralised education system. We want an education system that reflects our history, tradition and languages," the Congress leader added.

Asked about reported infighting in the Congress unit in poll-bound Karnataka, with former chief minister Siddaramaiah and DK Shivakumar engaged in a tussle, Rahul said: "We are not a fascist party, we are a party that believes in conversation, we are a party that believes in discussion and we are perfectly happy to have different viewpoints in the party.' 'However, everyone in the party understands that in order to win the (Karnataka Assembly) election they have to work together, they have to work as a team and that is exactly what is happening, that is exactly what is going to happen," he said. Rahul said the yatra's objective was to bring India together and not the 2024 Lok Sabha elections. "India is being divided, violence is being spread into our society, and this is damaging for our country," he said.

The objective as I have stated is to bring India together. Objective from my perspective is not the 2024 elections, I am seeing that India is being divided, violence

is being spread in our society and this is damaging for our country," the former Congress chief said. He also said the yatra is aimed at raising three issues -- violence and hatred "the BJP-RSS (Rashtriya Swavamsevak Sangh) are spreading"; the massive concentration of wealth being allowed which is destroying India's economy and resulting in unemployment; and massive and continuous increase in inflation

Talking about his yatra experience and the image that has been built of him over the years, Rahul said he stands and has always stood for certain ideas and that disturbs the BJP and the RSS. "Thousands of crores of media money, media energy has been spent on trying to shape me in a way which is just untruthful and wrong. That machine is going to continue, that machine is well oiled and financially rich. My truth is different and has always been different and people who look carefully will see what I stand for and what my truth is," he said. "There is a political element to it (vatra) but this yatra, I see in the political system a distance that has developed between the political class and our citizens. The idea for me was to go right on the road and go close physically to our people," Rahul said. This is different from going in a car, or plane, or even reaching out in a press conference through the media, he said.

"There's no effort in this; it's easy. I am by nature, I believe in tapasya. That has been my family's nature. I wanted an element of suffering in communication for myself. I did not want it to be easy. So, I thought, while talking to my people, I can share their suffering. I find that to be a very powerful experience,' Gandhi said. When one is walking on the road and speaking to people after having suffered a little, communication is better, he

"For me, its been a learning experience. But frankly, it hasn't even begun yet. It's been only 31 days. I can already see the advantages of this communication" Rahul stated. On the Centre recently banning the Popular Front of India, he said it doesn't matter who the person spreading hatred in India is and which community they come from. Spreading hatred and violence in India is an antinational act and "we will fight anybody who spreads hatred and violence in this country", Gandhi asserted. The former Congress chief also expressed confidence about the party's victory in the Karnataka Assembly elections next year.

Asked about Adani's presence at a Rajasthan government event and the industrialist pledging investments in the state, Gandhi said: "Mr Adani has committed Rs 60,000 crore to Rajasthan. No chief minister can refuse such an

# WHO alert on cough syrups 'alarming', there are missing links that need to be probed: Expert

NEW DELHI, OCT 8 /--/ The World Health Organisation's (WHO) recent alert linking cough syrups manufactured by an Indian pharmaceutical firm to the deaths of children in Gambia is "alarming" and there are some missing links that need to be "investigated", an expert said on Saturday.

The WHO on Wednesday issued an alert, saying four "contaminated" and "substandard" cough syrups Maiden Pharmaceuticals Limited could be the reason for the deaths in the West African nation. The four products are Promethazine Oral Solution, Kofexmalin Baby Cough Syrup, Makoff Baby Cough Syrup and Magrip N Cold Syrup.

"The information from WHO that cough syrups manufactured by an Indian pharma company caused the death of 66 children due to the presence of ethylene glycol is alarming.

"There are, however, some missing links that need to be ascertained and investigated," said Professor Y K Gupta, senior pharmacologist and vice chairman of the Standing National Committee on Medicines

Dr Gupta said the first death suspected to be due to the same reason was noted in July. The Drugs Controller General of India (DCGI) received a communication from WHO on September 29 and the

Government of India and the drug regulator immediately swung into action. The letter was responded to instantly by seeking full details. Despite October 1 being a Sunday and October 2 being a national holiday, investigations were initiated, Dr Gupta explained.

"It is important to understand here that only new drug approval is granted by DCGI whereas license for manufacture and sale is given by state drug controller. "In this case, the license for manufacture and sale was given by the state drug controller. The company was licensed to export only to this one country and not in any other country or in the Indian domestic market," he told PTI. The other missing link is that of the 23 samples which were tested by WHO, ethylene glycol was found only in four samples, Dr Gupta said adding, 'This is perplexing and needs clarification.'

"Also, the importing country gets it tested as per defined standards or their pharmacopeia. It seems this was somehow missed," he said. Indian regulations are very robust and have a zero tolerance policy in such matters. So one should not question the alertness of regulators, he said. The Indian pharma sector is producing drugs and vaccines which are used throughout the world and they are known for quality, and trust them, people pharmacologist stated. (PTI)

#### BJP destroying lives of Delhiites via LG: Kejriwal

NEW DELHI, OCT 8 /--/ Delhi chief minister Arvind Kejriwal on Saturday hit out at the BJP and Lieutenant Governor V K Saxena, saying the saffron party is destroying the lives of people of the national capital through LG.

Kejriwal's remarks came after Saxena in a letter accused Kejriwal and his ministers of running away from their constitutional duties and responsibility of governance in Delhi. Saxena has also accused the chief minister and his associates of levelling false allegations and spreading them through social media causing "irreparable loss" to the people they targeted. In a cheeky reply to Saxena's letter, Kejriwal in a tweet on Saturday said: "Another love letter has come." He also accused the LG of destroying the lives of people in Delhi. "BJP is hell bent on destroying the lives of the people of Delhi through LG. Every day these people make a fuss about something or the other. I assure Delhiites that as long as this son of yours is alive, don't worry. I won't let any harm come to you," the Delhi chief minister said in another tweet in Hindi.

Earlier too Kejriwal had taken a dig at the LG in a tweet saying he is scolded by Saxena more than he is scolded by his wife. Deputy chief minister Manish Sisodia also reacted to the LG's letter, saying that it was being done due to Kejriwal and Aam Aadmi Party's growing popularity in Gujarat. "Every day AAP's support base in Gujarat gets stronger, and everyday a new fake investigation starts in Delhi. Everyone is aware of his (LG's) conspiracies to stop Arvind Kejriwal. They can do whatever they want but neither the work being done in the interest of the public in Delhi will stop, nor will the AAP wave in Gujarat, Sisodia said in a tweet in Hindi. (PTI)

# Women's Asia Cup: India ride on top-order show to beat Bangladesh by 59 runs

SYLHET, OCT 8 /--/ Shafali Verma once again showed her matchwinning prowess with an attractive 55 off 44 balls as India out-batted Bangladesh by 59 runs to win their fourth match and clinch a semifinal spot in the Women's Asia Cup T20 here on Saturday.

After an indifferent batting show in the defeat against Pakistan, the 'Women In Blue' put up a much improved performance scoring 159 for 5, largely due to a 96-run opening stand between Shafali and stand-in skipper Smriti Mandhana (47 off 38 balls). Credit should also go to Jemimah Rodrigues, whose 35 not out off just 24 balls helped the Indian team score nearly 160. Bangladesh managed 100 for 7 at the end of 20 overs and never looked like being in the hunt for a victory. With 8 points from five games, India are on top of the seven-team table with a match left in the round robin stage. Having never chased a total beyond 142 in their entire T20I history, Bangladesh did try their bit but could never force the momentum against a solid Indian tight. After a shoddy fielding effort against Pakistan, it improved by a couple of notches on the day as there were no easy runs in store. The hosts couldn't even score 50 in the first 10 overs and scoring more than 110 runs in the back-10 was virtually impossible for them. None of the Indian bowlers were off target for the better part with Sneh Rana (1/17 in 3 overs) and Deepti Sharma (2/13



in 4 overs) being parsimonious as ever. Even Shafali's loopy legbreaks (2/10 in 4 overs) seemed unplayable. The slowness of the track also meant that spinners could vary the pace and most of the balls were not coming onto the bat. The two openers Fargana Hoqie (30 off 40 balls) and Murshida Khatun (21 off 25 balls) could add only 45 in the first nine overs and Bangladesh actually were thrown out of the contest at that stage.

Earlier, Shafali showed why she is one of the most destructive batters in this format as she struck five fours and two huge sixes. En route her fourth half-century in T20Is, Shafali also completed 1000 runs in the format. With the elegant skipper Mandhana for company, the duo added 96 in just 12 overs.

Mandhana as usual peppered the field with six crisp boundaries.

Once both Mandhana and Shafali, who tried a reverse slog, were dismissed, Bangladesh could briefly put brakes on scoring but the in-form Jemimah used her cricketing smarts to find the gaps as she and Deepti Sharma added 29 in just 2.3 overs to set a challenging

The opener went on to post his 28th T20 international halfcentury, the second-most alongside Rohit Sharma, with both sitting behind another Indian, Virat Kohli (33). Southee snared the early wicket of Mohammad Rizwan -- who scored a match-winning unbeaten 78 against Bangladesh -and the Pakistan middle order largely struggled aside from Shadab Khan's 34 off 22 balls. However, Azam's presence meant his team were always in control. The result was virtually sealed when he and Haider Ali took 21 runs off the final over of Blair Tickner (2-42), the third-last of the innings. Azam said the rapid 61-run stand with Shadab for the third wicket gave an insight to a tactic they could employ at the World Cup, with the allrounder shifted up the

"Definitely, we have a plan to send Shadab up to charge

the bowlers, to utilise his skills," Azam said. "He played very well. We planned that I would go all the way and Shadab would take a chance." Earlier, it took late blows from middle-order batsman Mark Chapman to revive a muddled New Zealand effort with the bat. Chapman's 32 off 16 balls followed solid innings from opener Devon Conway (36 off 35) and captain Kane Williamson (31 off 30), although both struggled for timing during a 61-run stand for the second wicket. It was another frustrating outcome for the accomplished Williamson, who has passed 50 on just two occasions in all formats over the last 18 months, a period that has encompassed 29 innings. He was cleanbowled attempting a slog-sweep off spinner Mohammad Nawaz, while Chapman holed out to a slower ball from Pakistan's best bowler, paceman Haris Rauf (3-28). (AFP)

NEW DELHI, OCT 8 /--/ The All India Football Federation (AIFF) will host the knock-out stages of the Santosh Trophy in either Jeddah or Riyadh in Saudi Arabia for three years, AIFF president Kalyan Chaubey said on Saturday. AIFF on Thursday signed a Memorandum of Understanding (MoU) with their Saudi Arabian counterparts to "study the possibility to stage the final stages of the Santosh Trophy in the West Asian country in February 2023."

"The MoU that we signed with the Saudi Football Federation, one was for hosting Santosh Trophy in Jeddah and Riyadh,' Chaubey told PTI during an interaction.

"Jeddah has more Indian population there, but Riyadh is the capital. And so the government there can club it together with art and culture. So these are the areas we will discuss and maybe by January we'll take a final call," said BJP leader Chaubey. The MoU was signed in Dammam.

"We will make it for three years. See it, is not that easy. One year, it may not be successful, because several unexpected challenges will come but that does not mean you stop this tournament," he said.

"So it's a three years thing and I'm sure year-wise we will do well. We definitely have to see what is the pace of improvement, where are we improving, and whether it is 10% growth rate or a growth of 50%. So we have to monitor it properly." Chaubey said AIFF is planning to implement equal pay for men's and women's footballers in the country.

"I have realised as a former player unless you are paid a decent remuneration, you can't feel motivated so I feel it is important to honour the women footballers.

We will speak to various stakeholders so that we can remove the disparity of men's and women's football. We will ensure that."



The 45-year-old from Kolkata said AIFF will come up with a regular calendar for women's football.

"As part of MoU, we will create exposure matches by organising three-nation tournaments twice in a year, so you get six matches to play,"

"Once it can be in Northeast or Bangalore in India when it is hot in the middle east and in winter time we can have it in the Gulf. It will be for u-17 and u-19, initially, it will be for boys and gradually it will be for women." "We will come up with a calendar where the women can play in the women's league... the way they are doing, we will soon be in a position to be Asian champions.

"This U-17 World Cup team is at a nascent stage. Once they get the confidence and if we can nurture this team, it can play the U-23 world cup and six years down the line, some of them will be known face in women's football in the world," he concluded. (PTI)


