## Labour department at N&M Andaman MP seeks reconstruction of entire stretch becomes non-functional identity

MAYABUNDER, DEC 20/-Labour -/The Commissioner Office at Rangat which looks after the duties of the Rangat, Mayabunder and Diglipur North & Middle Andaman is functioning without the Assistant Labour Commissioner for more than 4 months now. Absence of the Assistant Labour Commissioner for the past many months has functional works in this region. Labourers from Diglipur to Baratang approach the Labour Commissioner Office at Rangat for making Labour Cards which is mandatory for availing various benefits of Labour welfare schemes implemented by the government.

Absence of the Assistant Labour Commissioner has brought a full-stop in execution of activities like trade license, labour insurance, getting No Dues Certificates, the submission of which is a must for private Contractors for releasing their bills.

According to sources, the Assistant Labour Commissioner Office is functional with only one DRM staff member. Shortage of staff in this office has almost halted activities like renewal of trade license, labour cards. The entire Assistant Labour Commissioner office is managed by the lady DRM. Right from opening of the office door to collecting office daks, cleaning of the office premises and all the works clerical performed by the DRM. Now everybody knows that in government services, DRMs cannot be held responsible for major mistakes. In such a scenario, tasking such vital official works to a DRM can lead to major problems for the



Labour department.

Earlier, the Labour Commissioner office at Rangat used to be run by as many as four staff. But in due course, some staff retired from service while few were transferred to other departments without providing replacement. Now what is left is a DRM running the entire office of Assistant Labour Commissioner.

Awareness about the grains could be spread by hostingdebatesinschoolsand colleges, the Prime Minister said and noted that food items whose high nutritional values are shared with people are also

## Naxal violence reduced by 77 per cent in 11 years, Govt tells Lok Sabha

NEW DELHI, DEC 20 /--/ The incidents of Naxal violence have reduced by 77 per cent from the high of 2,213 in 2010 to 509 in 2021, Union minister of state for home Nityanand Rai said in Lok Sabha on Tuesday.

Similarly, resultant deaths (civilians and security forces) have reduced by 85 per cent from the high of 1,005in 2010 to 147 in 2021, Rai said, adding that the declining trend continues in 2022. "Steadfast implementation of the national policy has resulted in consistent decline in violence in Left Wing Extremism (LWE) affected areas. Incidents of LWE violence have reduced by 77 pert cent from the high of 2,213 in 2010 to 509 in 2021," he said replying

The minister said geographical spread of the violence has also significantly reduced and only 191 police stations of 46 districts reported LWE related violence in 2021 as compared to high of 465 police stations of 96 districts in 2010. Rai said decline in geographical spread is also reflected in the reduced number of districts covered under Security Related Expenditure (SRE) scheme and the number of SRE districts reduced from 126 to 90 in April, 2018 and further to 70 in July, 2021.

Similarly, Rai said the number of districts contributing approximately 90 per cent of the LWE violence, categorised as most LWE affected districts, came down to 30 from 35 in 2018 and further to 25 in 2021. (PTI)

## Govt hospitals in NC have to treat patients irrespective of residence, can't insist on voter ID: Delhi HC

NEW DELHI, DEC 20 /--/ Medical treatment has to be provided to all citizens by government hospitals in the national capital irrespective of the patient's place of residence, the Delhi High Court said on Tuesday, observing hospitals cannot insist on "voter ID".

Justice Prathiba M Singh, while hearing a petition by a Bihar resident who alleged the city government-run Lok Nayak Hospital provided free MRI test facility only to the residents of Delhi, said hospitals cannot deny treatment to tnose coming from outside.

The Delhi government assured there was no discrimination by the hospital on the basis of a patient's place of residence as alleged by the petitioner. "They (hospital) can't insist on voter ID here . For hospitals, either AIIMS or any other hospital in Delhi, you cannot stop citizens from outside coming (and seeking treatment)," the court said. "A perusal of the judgement of this court makes it very clear that insofar as health treatment is concerned, the treatment has to be provided to all citizens without any consideration as to their place of residence," added the

Delhi government counsel Satyakam said there was nothing on record to show that the petitioner was asked to furnish his voter ID, adding the dates for MRI were given as per the status of availability. He also said the MRI scan of the petitioner's left knee will also be conducted. The court took on record the stand of the Delhi government and directed that the petitioner's MRI shall be conducted on December 26 at 11 am. The petitioner, represented by lawyer Ashok Agarwal, contended the hospital adopted a "discriminatory approach" against those who did not belong to Delhi and so the petitioner was given a date in July 2024 for the MRI scan of his knee.

The petitioner claimed although all state funded hospitals are obliged to provide free treatment to any person approaching them, people possessing voter ID cards of Delhi were given "quick treatment" and outsiders were handed "long dates for check-up" at the hospital in question. "The respondent hospital has given 15.07.2024 date for MRI (L) Knee test because the petitioner is resident of Bihar and not of Delhi. It is done under written or unwritten policy of the respondent Government of NCT of Delhi." the petition claimed. The petition said the patient again went to the OPD at the hospital on November 21 and December 5, 2022 with his X-Ray report. After seeking the report, the doctor advised him to get an MRI of the knee done outside the

"It was also informed by the Doctor that free of cost MRI test facility is available to resident of Delhi only who possess voter Id Card of Delhi and others have to take the test at their own cost," the petition claimed. It said the action of the hospital authorities was "totally arbitrary, discriminatory, without authority in law and violated the Constitution of India". (PTI)

## Union minister Irani questions WEF's gender gap assessment which ranked India at 135th place

/--/ Union women and child development minister Smriti Irani on Tuesday questioned the World Economic Forum's Global Gender Gap Index assessment which ranked India at 135th place in terms of gender parity.

Iranisaid the Index failed to take into account the political empowerment and financial inclusion of women at the grassroots level. The Union minister interacted via video link with the audience during a seminar organised at the Rashtriya Raksha University at Lavad in Gandhinagar district of Gujarat. She was asked questions related to the empowerment of women and gender equality. "It is time to challenge what the Global Gender Gap Index has done in the way India has challenged the Global Index. measurement has been done through the western standards," Irani said. She said when it comes to marks of political empowerment, the Index does not take into account women who serve

municipalities as district panchayat presidents, sarpanchs, mayors and councillors.

"If we may just take into

serving across all the political systems in our country, our number would go up. They do not have systems in their countries, hence they would like to measure us through western standards," the Union minister said. In the WEF's report released in July 2022. India was ranked low at

gender parity despite an improvement of five places since last year on better performance in areas of economic participation and opportunity.

Iceland retained its place as the world's most genderequal country, followed by Finland, Norway, New Zealand and Sweden, as per the annual Gender Gap Report 2022 of the World Economic Forum (WEF) released in Geneva. Iranisaid women are serving the country in various capacities including in administrative system as collectors, superintendents of police, and paramilitary

There are crores of women serving as ASHA (Accredited Social Health Activist) workers and anganwadiworkers, she said. "They do not count our political intervention, they do not take into considerationour administration offices. The minute we start counting women in political offices at the grassroots level in India, the minute we start counting will shoot up in the top 20," she said. Irani said the Index also did not take into account the women who have been financially empowered through Central schemes like Mudra Yojana and Stand Up India etc. "If we do not count 22 crore women as empowered who are financiallytransactingevery day if we do not count 1.90 women administrative offices if we do not count over 20 lakh women who serve in panchayats across the country, then honestly the question before us, is the index fair in its assessment," she asked.Iranisaidherministry has worked to secure women by using Nirbhaya Fund up to Rs 9,000 crore, which was

otherwise lying unused. "Projects worth Rs 9,000 crore have been evaluated across all state governments and all ministries of the Government of India. Fiscal support worth Rs 5,000 crore under such projects has already been obtained by various state governments and Union ministries," she

## Oppn targets Karnataka govtin Maharashtra Assembly over 'ill-treatment' to Marathi people

NAGPUR, DEC 20 /--/ Opposition parties in Maharashtra on Tuesday targeted the Karnataka government in the state Assembly here over the alleged ill-treatment being meted out to Marathi-speaking people in the neighbouring southern state

Raising the issue in the Lower House, Nationalist Congress Party (NCP) MLA Jayant Patil said a lathi was raised at his party colleague and legislator Hasan Mushrif on Monday who had gone to Belagavi to meet the Marathispeaking people. Leader of Opposition Ajit Pawar said the issue is very sensitive to everyone. Replying to the issue, chief minister Eknath Shinde said for the first time the Centre has intervened which is a positive step. Speaker Rahul Narvekar said it has already been decided the matter will be discussed in detail and agreed to by the treasury and Opposition benches. The long-pending border dispute between the two states flared up again on Monday when members of Opposition parties- Shiv Sena (Uddhav Balasaheb Thackeray), Congress, and Nationalist Congress Party (NCP) - from Maharashtra were stopped from entering Karnataka by the police.

They were scheduled to attend a gathering organised by the pro-Marathi group Maharashtra Ekikaran Samiti (MES), an Opposition leader from Maharashtra's Kolhapur district had said. These leaders, including NCP MLA Hasan Mushrif, were on their way to participate in a 'maha melava' (mega gathering) organized by the MES in the adjoining state. Leaders alleged they were lathi-charged by the Karnataka Police at the border, while the Maharashtra police detained them and later released them. However, the Kolhapur district police refuted the claim of detention.

## Delhi LG directs chief secy to recover Rs 97 cr from AAP for 'political advertisements'

Delhi Lieutenant Governor V K Saxena has directed the account of "non-conforming chief secretary to recover advertisements", Rs 97 crore from the AAP for political advertisements it published in the guise of government advertisements in 2016, official sources said

development comes days after the AAP wrested power from the BJP in the MCD polls. The AAP alleged that the LG gave the order on the saffron party's directions and claimed that Saxena has no power to issue such a directive. The Opposition BJP in Delhi welcomed the LG's directions and claimed that the amount to be recovered from the ruling party will rise to Rs 400 crore. At a press conference held here, Leader of Opposition in Delhi Assembly Ramvir Singh Bidhuri alleged an "advertisement scam" and demanded a CBI inquiry into it.

The LG in his orders to the chief secretary also that advertisements since September 2016 be referred the Committee on Content Regulation in Government Advertising (CCRGA), set up by the ministry of information and broadcasting for vetting and ascertaining if they are in consonance with Supreme Court guidelines.

The Delhi government's Directorate of Information and Publicity (DIP), acting on a 2016 directive from the CCRGA, had notified that Rs had been spent or booked on the payments amounting to over Rs 42.26 crore had already been released by the DIP. Rs 54.87 crore for advertisements published still pending disbursal," a source said. Asked to recover the amount, the DIP had in 2017 directed the AAP to pay

over Rs 42.26 crore to the exchequer immediately and directly pay the pending amount of Rs 54.87 crore to the advertising agencies or publications concerned within 30 days, the sources

"However, even after the lapse of five years and eight months, the AAP has not complied with the DIP order. defiance of legitimate order by a registered political party is not only contemptuous of the judiciary, but also does not augur well for the health of good governance," the source added. The Directorate of Vigilance (DoV) also inquired into complaints and found that not only did the DIP not recover amounts worth Rs 42.26 crore but it also proactively paid the pending amount of Rs 54.87 crore, rather than getting the AAP to pay it, a source

Asked about the MLAs of the rival faction led by chief minister Eknath Shinde telling the staffers including two women, to vacate the old party office on Monday, Thackeray said he consoled the employees who are attached to the Shiv Sena Bhavan Mumbai and come to Nagpur during the winter session of the state legislature to help in managing legislative work. "This is called loyalty. These employees have been working for the Sena for the past thirty years. Tears rolled down from their eyes today," he said. The Shiv



Sena (Uddhay Balasaheb Thackeray) leader, who was accompanied by his MLA-son and former minister Aaditya Thackeray, garlanded a bust of Chhatrapati Shivaji Maharaj in the office. The Balasahebanchi Shiv Sena faction, led by chief minister Shinde, took possession of the existing office of the Shiv Sena in the Nagpur Legislative Assembly complex on Monday, the first day of the winter session. 



## Bihar hooch tragedy: **Prohibition goes for toss**

The latest hooch tragedy in Bihar that claimed dozens of lives once again proves that alcohol abuse has terrible social consequences. Every time a liquor tragedy takes place, be it in any part of the country, a hue and cry breaks out with stereotyped demand for a national-level liquor policy to reduce consumption of spurious liquor Once the tragedy fades out from public memory, the matter gets shelved, at least till another tragedy is reported. The World Health Organization (WHO) says unrecorded alcohol represents about 46 per cent of all alcohol consumption in India, indicating the need for better regulation in the sector. Based on latest available data, of the 947 deaths due to spurious liquor in 2020, a majority were in Madhya Pradesh (214), Jharkhand (139), and Punjab (133). The National Crime Records Bureau show that deaths due consumption of illicit liquor declined from 1,510 in 2017 to 947 in 2020. In 2018 and 2019, they were seen at 1,365 and 1,296, respectively. The five major states that reportedly banned liquor are Gujarat, Bihar, Nagaland, Mizoram, and Manipur. But, that pertained to the supply side, nothing on consumption. Experts are of the firm belief that prohibition alone will not work unless there's a national alcohol policy in place. There is demand and therefore, supply. Prohibition should remain, but it should not be the only answer. There should be an alcohol demand reduction policy. Another WHO data indicates that India's per capita alcohol consumption has increased from levels of 2.2 litres in 2000 to 5.61 litres in 2019. The large number of deaths in Bihar's Saran district allegedly happened due to the consumption of spurious liquor and the highest death toll since liquor prohibition in Bihar in 2016. The Nitish Kumar government has put at 38 the number of people who died in the Saran hooch tragedy. Higher death figures quoted by various quarters were "misleading" the CM said after BJP leaders claimed that "more than 100 people" have died. Most media reports put the death toll at 50 plus. In the case of Bihar, most of the liquor comes from neighbouring Uttar Pradesh and even Nepal, or it is

manufactured locally through illegal means. Hooch tragedies happen when alcohol unfit for human consumption is drunk, leading to death or permanent disability such as blindness. When alcohol is manufactured, it is of two types. One is potable alcohol suited for human consumption and can have 96 per cent strength in its purest form. When the same is denatured (taking away the natural qualities by adding an extraneous substance), it becomes unfit for human consumption and is referred to as non-potable alcohol. Denaturing is done to use alcohol for industries such as paints, varnishing and shoe polish. All denaturants are not poisonous but some, like methyl alcohol, when used for denaturing, make the drink poisonous and fatal. It is this denatured alcohol when consumed that triggers deaths. There are various reports and studies on adulteration in Indian liquor, with some saying that nearly 20 per cent of all spirits sold in India are adulterated, while others peg it at 40-50 per cent.

# China's interest in Tawang Buddhist Monastery is for internal reasons

China appears to have made a planned and heavy intrusion in the areas close to Tawang in Arunachal Pradesh last week, which were repulsed by the Indian army forthwith. The Chinese have repeatedly forayed into the area to make gains in Arunachal Pradesh

This is critical for China because Tawang is the seat of one of the most revered monasteries in Tibetan Buddhism. As a result, Tawang monastery plays a critical role in Tibetan internal politics. Therefore, China's efforts are to get control of the area and the Tawang monastery to control more effectively Tibet's internal politics. One has to remember that the Tibetan religious head, Dalai Lama, had come to Tawang and sought his first refuge in the monastery. Ever since, Dalai Lama is a continuing pain in China's neck. Now that Dalai Lama is getting old and a new spiritual head will have to be sworn in after the present Dalai Lama, China is seeking to ensure that its nominee becomes the new Dalai Lama. Getting control of the Tawang monastery before that could give some legitimacy for China's selection of the next spiritual head for Tibetan Buddhists.

These issues apart, China has been nibbling at the line of actual control—the so-called LAC—off and on and has already claimed some victories. China has thus sliced away from India's part of the border over the years through these small incursions. It is only now that that the Indian aide has reacted vigorously to the Chinese tactics. The Galwan valley incident, in which 20 Indian soldiers had died and some unknown numbers of the Chinese, was the biggest incident recently. But, last week's Chinese attempt to capture some high grounds in the areas, only 25 kilometres from Tawang, is the most ambitious and determined

attempt.. This time, when the winter had set in, the sudden sweep was meant to take possession of grounds to set up an observation post, according to some reports. In Galwan valley as well, China was seeking to acquire lands on Indian side to set up observation posts. Chinese have already setup some villages in the areas adjoining the border, which can quickly be turned into supply bases for the Chinese

In Yangtze area near Tawang, the Chinese were working with the same objective in mind. With the observation posts the Chinese could better monitor the Indian positions as well as movements. They are interested in tracking Indian preparations in the border areas. The Chinese have so far downplayed the incident apart from a brief mention in the Chinese foreign ministry briefing. This they did only after the statement of the defence minister, Rajnath Singh, in parliament subsequent to the incident.

The Chinese foreign ministry is seeking to pass this off as incursions by the Indian army personnel across the LAC. This is understandable since the Chinese are seeking now to modify their image. Chinese threats to south east Asian countries and the entire South China Sea has sent alarm bells across the region. Its earlier practice of "world warriors", who were the hostile diplomats belching fire over alleged insults to China, had given a very unwelcome picture of the country. After election of Xi Jinping at the 20th

party Congress in November, it appears China is taking some care to project a more favourable picture of the country. The release of the details of last week's incidents by India, has been to vindicate government's claims of wrong handling of all border incursions. India seems to be taking the Chinese threats seriously and expects these to continue in future as well. It appears the political circles deliberately highlighted the episode as the Indian army had acted swiftly and gained the upper hand over the Chinese. The Indian opposition parties had allalong criticised the government for its lukewarm responses to Chinese incursions.

This time the political set up had some advantages in showing off the robust responses to the incursions. The Indian army was better prepared for the sudden eruption of violence. Along with this incidence, some videos have gone viral in the social media, depicting some face-offs between Indian soldiers and the Chinese. The videos depict the two sides fighting with lathis and rods in the hills, surrounded by green forests around. The videos show Indian soldiers beating the Chinese who then retreat followed by the Indian army personnel. Thereafter, the Indian roar in victory and some structures are demolished. The videos have now gone viral in the international media and showing the apparent victory of the Indian side. The videos had made first appearance in Indian social

For whatever reasons and results, border clashes with China are expected to continue. The silver lining is that these have remained confined to local levels. Eruption of these on a larger scale could make things rather difficult to control, as has been seen in the disastrous Russian campaign in Ukraine. (IPA)

# India's next IT boom may be in AI, related sciences

A global survey of companies has revealed a serious shortage of tech talent when it comes to artificial intelligence, which is threatening to slow down the shift towards the new productivity tool.

A majority of respondents in the survey, carried out by management consultancy McKinsey, have reported difficulty in hiring for each AI-related role in the past year, and most say it either wasn't any easier or was more difficult to acquire this talent than in years past. AI data scientists remain particularly scarce, with the largest share of respondents rating data scientist as a role that has been difficult to fill, out of the roles we asked about.

The findings are particularly relevant to India, which boasts the world's biggest talent pool, and have lessons for the country's education system. India has been one of the biggest beneficiaries of the IT boom, triggered by the highly feared Y2K problem at the turn of the new millennium, which ultimately turned out to be a non-issue. But it had opened up a new world of opportunity for India's human resources pool. AI may well become another such opportunity. According to UNESCO's State of the Education Report for India 2022, India has an advantage of having an compound annual growth rate. It is also

advanced IT sector and a large number of young people who will join the labour market in the near future.

There is of course concern that even as additional jobs will be created for AIliterate people, many other jobs may be lost due to AI-based automation. But a McKinsey had projected that while 57 million jobs would be eliminated in India due to AI and automation, 114 million or twice as many news jobs will be created due to AI technologies.

According to the Artificial Intelligence Index Report 2021, India had the worlds' second highest growth in AI hiring from 2016 to 2020, behind Brazil and ahead of Canada, Singapore and South Africa. Analyst India magazine as well Jigsaw Academy also reported that there were almost 91,000 AI-related staff working in India, with 16,500 job openings as of July 2020. The median salary was Rs 14.7 lakh, with the highest median salary of Rs16.7 lakh being paid in Mumbai. The AI market in India is expected to reach \$7.8 billion by 2025 at the rate of 20.2 percent predicted that the AI software market itself will grow to \$6.4 billion in 2025. According to NAASCOM, AI will add between \$450 billion and \$500 billion to India's GDP by 2025. Similarly, a survey of over 3.000 stakeholders, conducted by Intel and the Indian School of Business on the suitability of machine learning showed 80 percent of the respondents expected their staff to undergo significant retaining over the next two years owing to the advent of AI in their businesses.

In 2018, NITI Aayog recognized the importance of AI in education, which is reflected in the National Education Policy 2020. The National Education Policy of 2020 has, accordingly, highlighted several important areas in which the application of AI is mentioned. It recommends introducing courses related to AI at all levels of education to develop the skills required to meet the current demands of industry.

In this regard, the policy recommends introduction computational thinking (CT) at a technological dimension. (IPA)

foundational stage of children's education so that India plays a leadership role in the fields of AI, machine learning and data science.

NEP advocates the development of hardware and software that use AI, machine learning, learning analytics, big data, blockchain, smart boards, adaptive systems etc to improve students' learning and to identify their learning paths. ## Delhi's winter power demand can go up to record 5,500 MW this year

NEW DELHI, DEC 20 /--/ The national capital's peak power demand this winter cango up to a record 5,500 MW,

officials said on Tuesday. The power demand peaked at 5,104 MW last year and 5,021 MW in 2020. The peak winter power demand in BRPL and BYPL discom areas reached 2,140 MW and 1,122 MW, respectively, during the last winter. This year, Delhi's peak power demand during winter can go up to 5,500 MW. It is expected to reach 2,289 MW and 1,159 MW for BRPL and BYPL respectively, a BSES spokesperson said. He said BSES discoms are geared to ensure for its around 47 lakh consumers (around two crore residents) during the winter months. BSES discoms will alsobanksurpluspowerwith other states, which need additional power during the winter months. This banked power will be available during the summer months. BRPL will bank up to 415 MW with states like Himachal Pradesh, Goa, Kerala and Tamil Nadu. BYPL is expected to bank up to 300 MW with states like Meghalaya, Maharashtra, Tamil Nadu and Kerala. The backbone of BSES'power-supply arrangements during the winter months includes long-term agreements from power plants, including hydro and Delhi-based gas-fuelled generating stations. Additionally, BSES is also receiving 840 MW of solar power from Solar Energy Corporation of India, 439 MW of wind power, and around 25 MW from waste-to-energy plants. It is also being helped by more than 127 MW of solar power installed on roof-tops in south, west, east and central Delhi. In case of any contingency, BSES discoms will buy shorttermpowerfromtheexchange which is available at economicalrates. ## Ex-gratia of Rs 50,000 approved for next of kin of Covid-19 victims: govt

NEW DELHI, DEC 20 /--/ The Centre has allowed the states to use the State Disaster Response Fund (SDRF) to provide ex-gratia assistance of Rs 50,000 to the next of kin of those who have succumbed to Covid-19, Lok Sabha was informed on Tuesday, Union Minister of State for Home Nityanand Raisaid as per the national policy on disaster management, the primary responsibility for disaster management, including disbursal of relief assistance to the affected people, rests with the state governments concerned. He said the state governments undertake relief measures

in the wake of natural disasters with help from the SDRF, already placed at their disposal, in accordance with the Government of India's approved norms. Rai said keeping in view the spread of coronavirus in India and the declaration of Covid-19 as pandemic by the World Health Organisation (WHO), by way of a special onetime dispensation, the central government has allowed the states to use SDRF towards containment measures for the financial years 2019-20, 2020-21 and 2021-22. "Further, based on the guidelines issued by National Disaster Management Authority

(NDMA), under section 12(iii) of the Disaster Management Act, 2005, on September 11, 2021, the central government had allowed the states to use the SDRF to provide ex-gratia assistance of Rs 50,000 to the next of kin of the deceased due to Covid-19," he said replying to a written question. (PTI)

Financial Cyber Fraud Reporting and Management System, under the Indian Cyber Crime Coordination Centre (I4C), has been launched for immediate reporting of financial frauds and to stop siphoning off funds by fraudsters. The tollfree helpline number '1930' has been operationalised for assistance in lodging online cyber complaints. "Since the inception of Citizen Financial Cyber Fraud Reporting and Management System.

more than six lakh complaints have been registered till December 12, 2022, and in more than 1.11 lakh complaints, so far, financial amount of more than Rs 188 crore have been saved." he said in Lok Sabha during Question Hour. The minister said the states and Union Territories are primarily re-

sponsible for the prevention, detection, investigation and prosecution of crimes including cyber crimes through their Law Enforcement Agencies (LEAs). The LEAs take legal action as per the provisions of the law against persons involved in cyber crime.

The Central Government supplements the initiatives of the states and Union Territories through advisories and financial assistance under various schemes for their capacity building, he said. Mishra said the I4C has been set up to deal with all types of cyber crime in the country in a coordinated and comprehensive manner.

The National Cyber Crime Reporting Portal (www.cybercrime.gov.in) was launched on August 30, 2019, as a part of the I4C, to

enable people to report incidents of cyber crimes with a special focus on cyber crimes against women and

"Cybercrime incidents reported on this portal, their conversion into FIRs and subsequent action thereon are handled by the state and UT LEAs concerned as per the provisions of the law," the minister said. He said more than 27,900 police officers from states and Union Territories are registered and over 7,300 certificates issued through the portal. The Ministry of Home Affairs has provided financial assistance to states and Union Territories under the Cyber Crime Prevention against Women and Children (CCPWC) scheme for their capacity building such as

setting up of cyber forensic-

capacity building and hiring of junior cyber consultants, Mishra informed the Lok Sabha. He said cyber forensic-cum-training laboratories have been commissioned in 30 states and Union Territories



## Oppn targets Govt in RS over inflation, unemployment, GST dues to states

NEW DELHI, DEC 20 /--/ Opposition parties on Tuesday targeted the Union government on several issues, including inflation, unemployment, payment of GST dues to the state governments and the plight of farmers, while discussing Appropriation Bills in the

Upper House Congress and Bharat Rashtra Samithi (BRS) MPs in the Rajya Sabha slammed the government for "gross expenditure" in the Budget and sought to know whether there was any "misplaced focus" when the funds were allocated. During the discussion on the Supplementary Demands for Grants, which Lok Sabha passed last authorising the government to spend an additional Rs 3.25 lakh crore in the current financial year, Amee Yajnik of the Congress said it was a big amount for which Parliament's approval is being sought. "The moot question that arises is how come there is so much error in planning? I would like to

know from the honourable

finance minister was it

devoid of any priorities or

was there any misplaced

focus when the monies were

allocated,"yajnik asked.

"Whatever it is or whatever it may be, it definitely indicates a gross miscalculation expenditure," Yajnik added. K Keshava Rao of the BRS said this could be due to a "lack of control in preparing the Budget". Welcoming the additional demand, stating it deals with subsidies, Rao, however, said there were about 75 supplementaries and six appropriations. In a Rs 400 lakh crore Budget "10 per cent is coming as supplementaries", he said. "I want the minister to revisit the figures. Ten per cent coming as supplementary demand is something which is not palatable," Rao said. Taking part in the discussion, Trinamool Dola Sen Congress' lamented that India's "AER (agriculture expenditure ratio) of crop husbandry has dropped from 4.2 per cent to 2.8 per cent in the

last few years". Sen also asked the Centre not to discriminate against non-BJP-ruled states in fertiliser allocation. Defending the additional demands, BJP MP Arun Singh said it has been made to benefit farmers and poor people. Under the leadership of Prime Minister Narendra Modi, several steps have been taken such as increasing the minimum support price to enhance farmers' income while keening prices of fertilisers under check despite a rise in global gas prices, he said. multifaceted relationships with India and Pakistan and does not want to see a "war of words" but a constructive dialogue between the two nations for the betterment of their people, a top US official has said. Relations between India and Pakistan have often been strained over the Kashmir issue and crossemanating from Pakistan. "We have a global strategic partnership with India. I have also spoken about the deep partnership we have with Pakistan. These relationships in our mind are not zero-sum. We do not view them in relation to one another." US State **Department spokes person** Ned Price told reporters at his daily news conference

about the recent outburst against Prime Minister Modi by Narendra Foreign Pakistani Minister Bilawal Bhutto-Zardari in New York. Price said each of these relationships indispensable to the US and to the promotion and pursuit of the shared goals that the US has with India and Pakistan. "The partnerships with both countries leaves us not wanting to see a war of words between India and Pakistan.

We would like to see a constructive dialogue between India Pakistan. We think that is for the betterment of the Pakistani and Indian people. There is much work that we can do together bilaterally," Price said in response to the question. "There are differences that, of course, need to be addressed between India and Pakistan. The United States stands ready to assist as a partner to both," he asserted. The ties between India and Pakistan nosedived after **India abrogated Article** 370 of the Constitution, revoking the special status of Jammu and Kashmir and bifurcating the State into two Union Territories

## North Korea threatens strong militarystep against Japan

take a "resolute and decisive military step" against Japan while it slammed Tokyo's adoption of a national security strategy as an attempt to turn the country into "an offensive military giant."

The North's statement came four days after Japan announced a security strategy that includes a counterstrike capability against enemy targets and doubles its military spending to gain a more offensive footing against threats from China and North Korea. The North's Foreign Ministry said in a statement that Japan's push to acquire counterstrike capability has nothing to do with selfdefence but is a clear attempt to acquire "preemptive attack capability meant to launch strikes on other countries

"Japan's foolish attempt to satiate its black-hearted greed the building up of its military invasion capability under the pretext of (North Korea's) legitimate exercise of the right to self-defence -- cannot be justified and tolerated, an unidentified ministry spokesperson said in a statement carried by state media. The statement accused the United States of supporting and instigating the Japanese military ambitions and undermining regional peace. It said that such U.S. moves are forcing North Korea to work hard to complete its plans to develop new strategic weapons to thwart enemy attempts to invade it.

The statement said North Korea wants to make sure it can take "a resolute and decisive military step" to protect its sovereignty and national interests in the wake of the complexity of regional security caused by the Japanese strategy. "Our country will continue to take actions to show how much we are concerned and displeased with Japan's unjust, greedy attempt to realise its wild ambitions," the statement said. Like in some other Asian countries, anti-Japanese sentiments still run deep in North Korea because of Japan's wartime atrocities.

The Korean Peninsula was under Japanese colonial rule from 1910-1945 before it was split into a capitalist, U.S.backed South Korea and a socialist, Soviet-supported North Korea at the end of the World War II. North Korea's state media routinely criticize Japanese colonial past. Its statement Tuesday called Japan "a war criminal state which inflicted untold misfortune and sufferings upon the Korean

North Korea's pursuit of nuclear-tipped missiles is a major security concern for Japan, which sits in their range together with South Korea and the mainland U.S. In October, North Korea fired an intermediate-range missile over Japan, forcing Tokyo to issue evacuation alerts and halt trains. On Tuesday, Japanese Chief Cabinet Secretary Hirokazu Matsuno accused North Korea of posing "serious and pressing threats" to Japanese and regional security with its unprecedented pace of missile tests this year. He said Japan will cooperate with the United State and South Korea to achieve North Korea's denuclearisation.

The Japanese strategy names China as "the biggest strategic challenge" before North Korea and Russia to Tokyo's efforts to ensure peace, safety and stability. Chinese Foreign Ministry spokesperson Wang Wenbin said last week that "hyping up the so-called China threat to find an excuse for (Japan's) military buildup is doomed to fail." (AP)

## Pak's Punjab Guv asks CM Elahi to seek vote of confidence in Assembly today

country: Rishi Sunak LONDON, DEC 20 /--/Britain's first Indian-origin Prime Minister Rishi Sunak has defended the UK's record on race amid a brewing row over controversial remarks by a columnist attacking Prince Harry's wife Meghan Markle, who is of African-American heritage.

Sunak was addressing questions posed by reporters during a visit to the Latvian capital of Riga on Monday when he spoke out against racism and highlighted his own heritage as carrying some weight on the subject. "I absolutely don't believe that Britain is a racist country. And I'd hope that as our nation's first British Asian Prime Minister when I say that it carries some weight," he told reporters. "You know, I'm really proud of our country, its

culture, its resilience, its beauty. And actually, it's an enormous privilege to champion Britain and indeed, its institutions like the monarchy when I'm out and about on the world stage as I am here today," said the UK-born politician, who has his family roots in Punjab.

Sunak was reacting to an ongoing row over former television presenter and columnist Jeremy Clarkson writing in The Sun' about loathing Meghan Markle, the Duchess of Sussex, "on a cellular level", in the wake of the controversial Harry and Meghan' documentary being aired on Netflix recently. Clarkson's column received over 6.000 complaints to the Independent Press Standards Organisation (IPSO), resulting in an apology from the writer and the newspaper removing the column from its website. "For everyone in public life, language matters," said Sunak, when asked about the furore. Meanwhile, more than 60 cross-party British MPs have written to the editor of The Sun', Victoria Newton, to demand action be taken against

In a letter, they said Meghan Markle had received credible threats to her life and that columns such as Clarkson's contributed to an "unacceptable climate of hatred and violence". The letter, coordinated by the Conservative Party Chair of the Women and Equalities Select Committee in the House of Commons, Caroline Nokes, was signed by fellow Tory MPs as well as Opposition MPs from Labour, Lib Dem, Green and SNP. "We cannot allow this type of behaviour to go unchecked any longer. We welcome the Sun's retraction of the article and we now demand action is taken against Mr Clarkson and an unreserved apology to Ms Markle immediately," they write.

## Power crisis: Pak plans to shut markets by 8 pm, put curbs on weddings

ISLAMABAD, DEC 20 /--/ Markets and restaurants across Pakistan will have to pull down their shutters by 8 pm while wedding halls will be limited till 10 pm, as the cashstrapped country on Tuesday unveiled a desperate plan to conserve energy. Pakistan is in the midst of an acute energy crisis, high inflation and depleting remittances. The ongoing Russia-Ukraine war and the catastrophic floods in June have only compounded the country's energy woes. The national energy-conservation programme was launched by Pakistan's Defence Minister Khawaja Asif, and it comes a day after Prime Minister Shehbaz Sharif directed authorities to reduce circular debt in the energy sector. Asif said the federal government will approach provinces for the implementation of this nationwide scheme. Briefing the media after the cabinet meeting, the minister said a final decision will be taken by Thursday. "In the next few days, we will be approaching all the provinces with this national project and then on Thursday the final approval of the conservation policy will be given," Asif said. (PTI)

Magnitude 6.4 earthquake shakes parts ofNorthern California

## Lanka to set up institute to educate MPs on economic management

COLOMBO, DEC 20 /--/ Sri Lanka has approved a proposal to set up an institute aimed at educating parliamentarians and officials to help them make informed decisions on economic and trade affairs, a senior official said on Tuesday. Cabinet spokesman Bandula Gunawardena told reporters that the cabinet approved the proposal of

President Ranil Wickremesinghe to set up the Sri Lanka Economic and Trade Institute. "This will help them to make informed decisions on formulation," he said. The legal draftsman would begin work to compile a draft bill, he said. Sri Lanka plunged into its worst economic crisis with the country declaring its firstever sovereign debt default early this year. Analysts said the crisis could have been averted if informed decisions had been taken around 2020. Current foreign minister Ali Sabry said parliamentarians had not been adequately aware of the looming crisis despite warnings from many quarters. The political authority and senior fiscal faced officials have

which prevented them from taking informed decisions such as making a timely approach to the IMF for a bail out. The cabinet also approved changes to the laws governing the Central Bank of Sri Lanka to make it more independent. Sri Lanka, a country of 22 million people, plunged into financial and political turmoil earlier this year as it

accusations of ignorance faced a shortage of foreign currencies. The worst economic crisis since its independence in 1948 was triggered by a severe paucity of foreign exchange reserves. In mid-April, Sri Lanka declared its international debt default due to the forex crisis. The island nation is currently negotiating a bailout with the IMF. A staff-level agreement reached in

August led to a USD 2.9 billion assistance package over 4 years. The release is currently on hold due to the need to restructure debt.

Sri Lanka is talking to creditors to meet the IMF condition for the facility. Due to this, the island nation has been unable to afford key imports, including fuel, fertilisers and medicines, leading to serpentine queues. (PTI)

## World Cup winners Argentina return ahead of welcome home party

Argentina's World Cup winners led by captain Lionel Messi returned home from Qatar in the early hours of Tuesday morning ahead of a welcome home party in the nation's capital.

Having beaten France in Sunday's thrilling final, the players will now spend the night at the Argentine Football Association (AFA) training complex near the Ezeiza airport where they arrived in Buenos Aires and where thousands of supporters were waiting to greet them. They will then begin a tour of the Buenos Aires city centre from midday on Tuesday with millions expected out in the streets on what is a public holiday.

"Crowned with glory," read a banner on a newspaper kiosk in Buenos Aires on Monday, while Clarin and La Prensa dailies both sent a huge "Thank you" to Messi and his team-mates for winning the country's third world title, and first in 36 years. Argentina won the final in Qatar 4-2 on penalties after a rollercoaster 3-3 draw over 120 minutes of unparalleled drama. Messi, who scored twice in the final, was the first player to emerge from the plane, holding the World Cup aloft, with coach Lionel Scaloni right behind him. Forward Julian Alvarez, a revelation in Qatar with his four goals, was one of the next players to emerge. A picture of Messi was emblazoned on the plane's tail with the words: "one team, one country, one dream" on its
