New Delhi, Aug. 25 (PIB)

Prime Minister, Shri Narendra Modi today chaired the meeting of the 37th edition of PRAGATI, the ICT based multi-modal platform for Pro-**Active Governance and Timely** Implementation, involving Centre and State Governments. In the meeting, nine agenda items were taken for review including eight projects and one scheme. Among the eight projects, three projects each were from the Ministry of Railways and Ministry of Road Transport & Highways and two projects were from the Ministry of Power. These eight projects have a cumulative cost of Rs. completion of these projects.

Nature inspired shell-shaped structure terminal to bring in sea change in Isles aviation sector

The upcoming major infrastructure development project by Airports Authority of India -the New Integrated Terminal Building at VSI Airport is pacing up in full swing despite the pandemic. With 83 per cent of the construction work been completed, the mega project in all aspects is expected to be completed by June 2022 and become operational from September 2022. The upcoming terminal will have all the essential facilities meeting the international standard across globe and will be a game changer for the socio-economic development of A&N Islands.

The integrated terminal is being constructed at an estimated cost of around Rs. 707.73 Crores. The completion of the project will be a stepping stone for expansion of tourism activities in the Islands, thereby opening new vistas of job opportunities in varied sectors for the Islanders.

This aesthetically designed Integrated Terminal is a shell shaped structure depicting sea and islands which is inspired from nature. The terminal has a total built up area of 40,837 sqmts. Another unique feature of the terminal is that it will entirely be lit with 100 % natural lighting through skylights during the day time. The terminal will have the capacity to handle 1200 passengers per hour (600 pax Arrival + 600 pax Departure) and about 5 million (Domestic + International)





passengers per year. The facilities that will be included in the new terminal building are 3 aerobridges, 6 escalators and 10 elevators for all departure & arrival areas, 4 conveyors for baggage handling system, 28 check-in-counters with inline xray machines, 6 Immigration Counters and 3 Custom Counters. To enhance the airport ambience, the city side area will be developed with adequate parking facilities for car, taxi and buses alongwith landscaping.

CIRCULAR

On promulgation of Andaman & Nicobar Value Added Tax Rules, 2020, Statutory forms have been prescribed for filing quarterly return in ANI VAT-16 and it is observed that many dealers have not filed returns filing returns without supporting documents as prescribed under rule 40 of A & N Islands VAT Rules 2020.

Accordingly, in exercise of power conferred under section 48 of Andaman & Nicobar Valued Added Tax Regulation 2017, all the registered dealers under Andaman & Nicobar Value Added Tax Regulation 2017 are hereby directed to submit quarterly return along with following supporting documents in hard / soft copy for assessment of tax. Documents required along with Returns (ANI VAT-16) are as under:

1. Stock as on 30th June, 2017.

- 2. Monthly Opening and Closing Stock (Soft Copy).
- 3. Goods purchased and Sold by the dealer (Daily Sale Details) (Soft Copy).
- 4. Balance Sheet and Loss & Profit Account.
- 5. Audit Certificate (Annual Basis).
- Details of input tax Claimed (Purchased invoice should be enclosed).
- 7. Proof of tax paid to the department (Bank Statement / DD / Cheque

Non-compliance of this direction shall attract the penal prevision of the Regulation.




