MP calls on Hon'ble Union Home Minister

Highlights host of crucial issues of A&N Islands

PORT BLAIR, JAN 9/--/ Mr. KuldeepRai Sharma, Member of Parliament called on Union Home Minister, Mr. Amit Shah at New Delhi on Monday and highlighted some of the most crucial issues of Andaman & Nicobar Islands. Notable issues highlighted by Mr. KuldeeepRai Sharma includes centpercent job reservation for local youth, Chatham to Bambooflat bridge, central university for islands, creation of Andaman & Nicobar Public Service Commission, IT Park, Laying of 2nd OFC line from Diglipur to Puri, Odisha, air subsidy for islanders and a host of other issues concerning the people of the islands.

100% job reservation for domicile of the Islands in Government appointment under Administration: The Member of Parliament informed the Home Minister that in Andaman & Nicobar Islands, one of the major concerns for the Islanders, particularly for the youth is lack of sufficient employment opportunities in the region especially given the high literacy rate among the Islands' population. He said that there are around 10,000 vacant posts in Andaman & Nicobar administration which needs to be filled-up as early as possible. He mentioned about the very recent decision of the Central Government to extend 100% job reservation in public appointments to the local residents of the newly created Union Territories of Jammu and Kashmir and that of Ladakh in -**D**-their respective Union Territories. For the Union Territory of Jammu and Kashmir the reservation has been

implemented by an order of MHA issued on April 3, 2020, which provides protection to the domiciles of the UT of Jammu and Kashmir to "any post" in the government, including senior level positions in Group 'A' and Group 'B' category. A similar order for public appointments in the Union Territory of Ladakh was issued through its Lieutenant Governor on 08.06.2021 stating that "No person shall be qualified for appointment to the service unless the person is a resident of the Union Territory of Ladakh."

Taking into cognizance of the above made submission, the Member of Parliament requested to grant 100% job reservation for the domiciles of Andaman & Nicobar Islands in public appointments for jobs meant for the Union Territory of Andaman & Nicobar Islands in the manner similar to the decision taken in respect of the newly created Union Territories of Jammu & Kashmir and Ladakh. Alternatively 100% job reservation for the domiciles of A & N Islands may be enacted under "The Public Employment (Requirement as to Residents) Act 1957. Construction of bridge connecting Chatham and Bambooflat: The Member of Parliament informed the Union Home Minister that there is an eminent need for construction of a bridge from Chatham Island to Bambooflat to facilitate uninterrupted and fast movement of men and materials through road transport which is presently being carried out by means of boats and vehicle ferries. Construction of the bridge will also save the recurring expenditure now being incurred on operation and maintenance of the boats/vehicle ferries and port infrastructure. Setting up of Central University in A&N Islands: Presently, the Institutions of higher education in the Islands are affiliated to the Pondicherry Central University. Increase in number of higher educational institutions from the lone Jawaharlal RajkeeyaMahavidyalaya (JNRM) to

06 (six) numbers consisting of Degree Engineering College, Medical College and Law College, besides 02 (two) Degree Colleges has necessitated the need to have a separate Central University for Andaman & Nicobar Islands. Upgrading Medical Science Education and treatment facilities: He informed the Home Minister that the present medical treatment facilities in Andaman & Nicobar Islands are far below average and the Islanders have to travel either to Chennai or Kolkata for treatment of major ailments which is beyond the reach of economically weaker sections of the society. The Member of Parliament requested the Home Minister to set up AIIMS in Andaman & Nicobar Islands so that the Islanders can avail top class medical science education and treatment facilities Moreover, ANIIMS which is imparting UG courses in medical science needs to be upgraded to PG level. Setting up of Women College in A & N Islands: As there is no women college in the Islands, setting up of women college will also add to higher education among women. Setting up of Women Commission in A&N Islands: As there is no Women Commission in Andaman



& Nicobar Islands, setting up of Women Commission will also add to the empowerment of women in the Islands. Creation of Andaman & Nicobar Public Service Commission: Presently, direct recruitment to all gazetted posts belonging to the UT Administration of the A&N Islands are filled by the UPSC on all India selection basis which has been depriving the educated youths of the Islands of their legitimate right to serve the Islands. Candidates from mainland India selected to the posts UT Cadre of the Administration consider their postings as stepping stones in their career advancements and relinquish the job as soon as they get postings in mainland India. Hence, creation of Andaman & Nicobar Public Service Commission will put an end to this fiasco and will provide opportunity to well educated youths of the Islands in the UT Civil and Public Service, Medical Services, Engineering Services etc. Establishment of IT park in A&N Islands: Unemployment is the major concern for the Islanders,

hence to solve the unemployment

problems of the youth of the Islands and also to protect the environment, it is proposed to make Andaman and Nicobar Islands an Information Technology hub development of Business Process Outsourcing (BPOs) / Call Centres/ Software Park under schemes like Digital India, Scheme for promotion of IT &ITeS industries. Andaman and Nicobar Islands will be conducive for fast pace development as an IT Hub/IT Park due to its strategic location and proximity to several South East Asian countries like Indonesia, Singapore, Malaysia, Thailand, Myanmar etc. Such a step will be a big boost to employment generation, revenue generation and holistic development of Andaman and Nicobar Islands and will also aid the Act East Policy of the Government of India. He demanded that for this purpose approximately 3000 Acres of land may be earmarked with a budgetary provision of Rs.10,000Crores for the project which will solve unemployment issues and generate revenue. Laying of 2nd OFC line from Diglipur to Puri, Odisha: At present the internet facilities in Andaman & Nicobar Islands are provided through the Submarine Optical Fibre Cable System (CANI) laid between Chennai and Port Blair which has facilitated high speed and reliable connectivity in the Islands But he said that even a single day of breakdown of CANI OFC would prove costly for the industry against temporary outages and connectivity failures. In view of the above, if a parallel net connectivity to Andaman & Nicobar Islands through undersea OFC cable between Diglipur Islands in North Andaman and Puri in Odisha is provided, it will ensure uninterrupted connectivity even if the other grid fails due to any reason.

Subsidy in airfare for Islanders between mainland and A&N Islands: The Andaman & Nicobar Islands being distantly located from the mainland of India and situated in the Bay of Bengal is circumstanced with various limitations and one such being the mode of transportation/ communication between Island and mainland and its high cost. The Member of Parliament requested the Home Minister to extend subsidies in the airfare on the lines of North East India to residents of Andaman and Nicobar Islands and also to the tourists visiting the Islands to promote tourism. Ideally, airfare of Rs.5000 for Port Blair- Chennai/ Kolkata/ Visakhapatnam would be reasonable for the Islanders and justified for the Airlines too. Setting up of Fisheries College in A&N Islands: The Andaman & Nicobar Islands have vast potential for fisheries development in view of its coastal length of about 1,962 km which is approximately 1/3rd of total coastal length of India and Continental shelf area of 35,000 Sq Km. The Exclusive Economic Zone (EEZ) around these islands is about 6,00,000 Sq Km with an estimated Fishery potential is 2.43 lakh MT which is around 6% of our Country's total Fishery Potential. Of this 2.43 lakh MT, the coastal Tuna has the potential for the harvest upto 1 (one) lakh MT and Oceanic tuna and Tuna like fishes upto 0.82 lakh MT per annum. (Contd. on page-6)

'Make in India' initiative neither 'isolationist' nor meant for country alone: Rajnath

NEW DELHI, JAN 9 /--/ India does not believe in a "hierarchical' world order where few countries are considered superior to others and its ties with other nations are based on sovereign equality and mutual respect, defence minister Rajnath Singh said on Monday amid growing global concerns over China's muscle flexing.

at an In an address ambassadors' roundtable on the upcoming Aero India exhibition, Singh said India's international relations are guided by the very essence of human equality and dignity and it does not believe in making or becoming a client or satellite state. The defence minister said India's national efforts towards 'Make in India' are neither "isolationist" nor are they meant for the country alone as he made an open offer of partnerships with New Delhi for production of various military equipment. The 14th edition of 'Aero India', billed as Asia's largest aerospace exhibition, will be held in Bengaluru from February 13 to 17. "We do not believe in making or becoming a client or satellite state, and so, when we partner any nation, it is on the basis of sovereign equality and mutual respect," he said while inviting the ambassadors to the mega event.

There have been mounting global concerns over China's military muscle flexing in the South China Sea, East China Sea and the Indo-Pacific. The defence

minister said "partnership and ioint efforts" are the two key words that differentiate India's defence industry cooperation with other nations, "India does not believe in a hierarchical conception of world order, where few countries are considered superior to others.' Underlining that the 'make-in-India' programme encompasses make-for-the-world, the defence minister asserted that the selfreliance initiative is the beginning of a "new paradigm of partnership" with India's partner countries. "Within the domain of defence research and development and manufacturing, it translates into an open offer to you all, for joint efforts

and partnerships in defence R and

D and production," he said.

defence equipment from our valued partner nations, very often, they are sharing the technical know-how, setting manufacturing plants in India, and working with our local firms for various sub-systems," Singh said. The defence minister noted that it is India's endeavour to "transcend the relation of buyer and seller to that of a co-development and coproduction model, irrespective of whether we are a buyer or a seller". "I would like to emphasise that our national efforts towards 'Make in India' are neither isolationist, nor

are they just meant for India alone," he said. Showcasing the growth of India's defence manufacturing sector, Singh especially spoke about the indigenously developed Light Combat Aircraft (LCH) and the Light Utility Helicopter (LUH).

'Our large population and abundant skilled work-force has led to the creation of a thriving innovation ecosystem, led by startups in high technology areas. I believe that the Indian Aerospace and Defence manufacturing sector is well prepared to take up the future challenges and capitalise on emerging opportunities," he said. Singh also noted that India's defence exports have grown by eight times in the last five years and now the country is exporting to more than 75 nations. "India has been working towards enhancing its defence manufacturing capabilities, particularly in the emerging areas of drones, cyber tech, AI, radars and other equipment," Singh said.

'When we are exporting our defence equipment to our friendly nations, we offer our full support capability towards development of the buyer through sharing of technology, training, coproduction," he said. Touching upon India's G-20 presidency, the defence minister said its endeavour is to build consensus within the grouping and shape the agenda for a "more secure, prosperous,

Switzerland, India working to create innovation platform; seeks to accelerate bilateral ties: Swiss Ambassador

NEW DELHI, JAN 9 /--/ Switzerland is an inter-governmental organisation of keen to accelerate bilateral ties with India by tapping more trade and investment opportunities, and both countries are also working to create an innovation platform, according to Swiss Ambassador to India Ralf Heckner.

Emphasising that his "expectations are very high", Heckner said innovation and a free trade agreement can take the bilateral relations to the next level. In an interview with news agency PTI on Monday here, Heckner said he sees a lot of convergence between both countries when it comes to innovation, "Switzerland being the most innovative country and more innovations (are) being created in India, what I would like to see is the most strategic innovation relationship. We are working with the Indian government to create an innovation platform that will bring the best universities, IITs and federal institutes of technology in Switzerland together with very innovative Swiss and Indian businesses," he said.

The idea of creating an innovation platform is at an initial stage, and in this regard, a pilot project that is focused on anti-microbial resistance is in progress. "By the end of the year, we will be presenting our first results when it comes to the pilot project," the Ambassador said, adding that there is also convergence in terms of Intellectual Property Rights (IPR). "The more innovative India becomes, India will have an interest in IPR. Switzerland attaches a lot of importance to IPR and I see India moving into that space. That will also open up quite some interesting cooperation," he noted. In the Global Innovation Index 2022, India's ranking improved to the 40th position and the list was topped by Switzerland. On the trade front, negotiations between India and the European Free Trade Association (EFTA) have been going on for some time. EFTA is

Iceland, Liechtenstein, Norway and Switzerland.

Against the backdrop of India recently concluding trade deals with Australia and the UAE, Heckner said that he would like to see the negotiations on a free trade agreement between India and EFTA moving forward at a quick pace. "I feel that the Indian government is now open for trade deals...The proof of the pudding is already there, because of trade deals that India has signed with Australia and the UAE. "The next important visit will be that of the State Secretary for Economic Affairs to Delhi in the beginning of February. If we are able to move our negotiations forward, that would take our relations to the next level," he said.

In 2020 to 2021, bilateral trade between Switzerland and India stood at around 11 billion Swiss francs. "In 2023, I would like to see our bilateral relations accelerating... we are not only celebrating 75 years of India's independence but also 75 years of friendship. "It is so important that countries that are friendly work together. So, we would like to celebrate our friendship, and we expect high-level visits to India and from India also," Heckner said. "Switzerland is economically an important country. We are an innovative country and among the biggest investors...There is the potential for our trade relations. There are around 330 Swiss companies located in India, and in China, it is around 1,000. The potential is we could triple the number of Swiss companies in India," Heckner said.

Further, the Ambassador said that Swiss investments are about USD 300 billion in the US, the world's biggest economy. "So, USD 300 billion (was) invested in the US and USD 10 billion invested in India from Switzerland. That gives you an idea of the potential we have when it comes to trade relations between Switzerland and India.' he added. (PTI)

PM holds talks with Prezs of Suriname and Guyana

INDORE, JAN 9 /--/ Prime Minister Narendra Modi on Monday held separate bilateral talks with Surinamese President Chandrikapersad Santokhi and President of Guyana Mohamed Irfaan Ali, focusing on bilateral cooperation in areas of defence, digital technology and capacity building.

The meetings took place on the sidelines of the Pravasi Bharatiya Divas (PBD). Santokhi and Ali are attending the mega event as the chief guest and special guest of honour. About Modi's meeting with Santokhi, the ministry of external affairs (MEA) said the talks focused on cooperation in areas of mutual interest including hydrocarbons, defence and maritime security. "In their meeting, both leaders held discussions on cooperation in areas of mutual interest including hydrocarbons, defence, maritime security, digital initiatives and ICT, and capacity building," it said in a statement.

"Suriname appreciated restructuring by India of Suriname's debt arising from Lines of Credit availed by Suriname," it said. After the conclusion of the PBD, Santokhi will visit Ahmedabad and New Delhi. On talks between Modi and Ali, the MEA said they held comprehensive discussions on a wide range of issues including cooperation in energy, infrastructure development, pharmaceuticals, healthcare, technology and defence cooperation. "Both leaders recalled the 180 year old historical bonds of friendship between the people of India and Guyana and agreed to deepen them further," it said. President Ali will also visit Delhi, Kanpur, Bengaluru and Mumbai. (PTI)

Delhi HC asks PFI leaders to wait for trial court order on plea for interim bail in PMLA case NEW DELHI, JAN 9 /--/

The Delhi High Court on Monday disposed of the pleas of two leaders of the banned outfit Popular Front of India (PFI) for interim bail in a money laundering case, saying they should wait for the trial court's order in the matter.

Mohd Perwez Ahmad, who was the president of PFI's Delhi unit, and its office secretary Abdul Muqeet had sought interim bail in the case registered by the Enforcement Directorate (ED) as the agency failed to file a charge sheet within the stipulated period of 60 days from arrest which expired on November 21, 2022. Their counsel Mujeeb Ur Rehman submitted before the high court that on December 17, 2022, they approached the trial court for the grant of default bail and, during the pendency of the plea, they should be released on interim bail. He said that on January 2, the prosecution failed to file a to the bail applications and the trial court is scheduled to hear the matter on Tuesday. Noting the submissions, Justice Anish Dayal disposed of the two petitions saying that let the trial court first adjudicate the matter. The High Court granted liberty to the petitioners to approach the court in case any grievances are left. The ED, however, claimed that it has filed the



statutory time period and cognisance on it has been taken by the trial court. In the petition before the High Court, the accused alleged that their fundamental right to a speedy trial was violated as the trial court has not disposed of the bail applications within two weeks as directed by the Supreme Court. applicant is in judicial custody and is innocent as police officials falsely implicated him in a fabricated case while acting against the very settled principles of law and violated the fundamental rights of the applicant," Ahmad alleged in the plea. The agency had earlier submitted before the trial court that the accused along with other members of PFI collected funds through donations, hawala, banking channels, etc and used the funds for unlawful activities and commission of scheduled offences.

It had alleged that over the years, the transfer of funds was even being done

clandestine or illegal channel under a conspiracy hatched by office bearers of PFI. A large number of alleged PFI activists were detained or arrested in several states during the massive raids preceding the nationwide ban imposed on September 28, 2022. The government banned the PFI and several of its associate organisations on September 28, 2022 for five years under the stringent anti-terror law UAPA, accusing them of having "links" with global terror groups like the ISIS. In near-simultaneous raids across the country as part of a multi-agency operation spearheaded by the NIA, PFI activists were detained or arrested in 11 states for allegedly supporting terror activities in the country. The arrests were made in states and union territories including Maharashtra, Karnataka, Tamil Nadu, Assam, Uttar Pradesh, Andhra Pradesh, Madhya Pradesh, Puducherry, Delhi and Rajasthan. (PTI)

Separate road accidents on **Agra-Lucknow Expressway** claim 7 lives

UNNAO/KANNAUJ, JAN /--/ Seven people, including three Nepalese citizens, died in separate incidents after their vehicles met with an accident on the Agra-Lucknow Expressway amid dense fog, police said on Monday.


In the first incident, a Nepal-bound bus rammed into a truck on the expressway in Uttar Pradesh's Unnao on Monday, leaving the driver and three Nepalese citizens dead, officials said. Six other passengers, four of them also from Nepal, got injured in the incident and have been hospitalised, they said. Additional superintendent of police Shashi Shekhar Singh said the bus carrying 60 passengers was going from Rajkot in Gujarat to Nepal. The accident occurred in the Auras area of Unnao. Singh added three male passengers of the bus died on the spot, while one woman succumbed to her injuries on the way to the hospital. Hasanganj

divisional magistrate Ankit Shukla said the deceased have been identified as Chandra Saud (50), Lalit Saud (35), and Nirmala (25), all residents of Kailali district of Nepal. The fourth deceased is Sajid, the bus driver. (PTI)

Priests criticise Rahul over remarks on 'pujaris'

NEW DELHI, JAN 9 /--/ Several priests on Monday accused Congress leader Rahul Gandhi of "insulting" those engaged in worship with his comment that India is a country of "tapasvis" not "pujaris".

Rahul had recently said in Haryana that the Congress believes in 'tapasya', while the Bharatiya Janata Party (BJP) is an organisation of 'pooja'. The BJP-RSS force people to worship them, he had alleged, adding that India is a country of 'tapasvis' (ascetics) and not 'pujaris' (priests).



Ujjwal Pandit of Yuva Teerth Purohit Mahasabha alleged that Gandhi had insulted India's ancient cultural traditions in which priests have played a central role. It is clear that the Congress leader wore 'janeu' (holy thread) and tilak on his head for show, he alleged in a statement, claiming that Gandhi's remarks are against Brahmins.

Swami Dipankar noted that the Gandhi scion had described his Bharat Jodo Yatra as his "mohabbat ki dukan" (place for love), but was now talking about "hate". The Congress leader should think before speaking as he, on one hand, is working to unite people and on the other hand, is making this kind of statement. Should priests be then thrown into sea, he asked. "He has undertaken such a glorious journey. I am shocked that he has made such a statement," Dipankar said.

Rajnikant Semwal of Gangotri Dham said priests have had a key place in the land of 'sanatan dharma'. Pujaris have been following an ancient tradition, he said, urging Gandhi to study the same. At some places, including Prayagraj in Uttar Pradesh, priests carried out protests and burnt Gandhi's effigies. In the temple town of Deoghar in Jharkhand, priests demanded an apology from the Congress leader for insulting their tradition. (PTI)

NEW DELHI, JAN 9 /--/ The Supreme Court on Monday granted time till March 15 to the Centre for payment of arrears of One Rank-One Pension (OROP) to all eligible pensioners of the armed forces.

A bench of Chief Justice DY Chandrachud and Justice PS Narasimha asked the Centre to ensure that all arrears are paid expeditiously to the pensioners of the armed forces and that there is no further delay.

The apex court granted liberty to ex-servicemen association to file an application, if they feel aggrieved by any action of the Centre on payment of arrears of the OROP. Attorney General R Venkataramani, appearing for the Centre, said the tabulation process has been completed by the Comptroller General of Defence Accounts (CGDA) and now the tables have been sent to the ministry of defence for final

of OROP to pensioners of armed forces

approval. "By March 15, the money will start flowing into the accounts of 25 lakh pensioners of armed forces", Venkataramani said.

Last month, the government has moved the top court seeking extension of time till March 15, 2023 for payment of arrears of OROP scheme to all eligible pensioners of the armed forces.

This is the second extension given by the apex court to the Union government to pay the arrears after it had first moved the top court in June, last year and sought three months to compute and make payments in accordance with the March 16, 2022 verdict of the top court. The apex court's 2022 verdict came on the plea filed by the Indian Ex-servicemen Movement (IESM) through advocate Balaji Srinivasan against the Centre's formula.

It had said in terms of the communication dated November 7, 2015, the benefit of OROP was to be effected from July 1, 2014 and the communication states that "in future, the pension would be refixed every five years".

"Such an exercise has remained to be carried out after the expiry of five years possibly because of the pendency of the present proceedings," the bench had said, adding: "We accordingly order and direct that in terms of the communication dated November 7, 2015, a re-fixation exercise shall be carried out from July 1, 2019, upon the expiry of five years. 'Entry of foreign varsities in India will lead to healthy competition,' say private universities

NEW DELHI, JAN 9 /--/Foreign universities setting up their campuses in full-time programmes in offline mode and India will offer healthy competition to leading private universities in the country, according to several Vice Chancellors, even as they maintained that the "devil lies in the details." The University Grants Commission (UGC) last week unveiled draft norms for allowing, for the first time, foreign universities to set up campuses in India with autonomy to decide the admission procedure, fees structure, and even repatriate funds back home. According to Dr Aman Mittal, Vice President, Lovely Professional University, Punjab, the foreign universities setting up their campuses in India will offer healthy competition to top private universities here. "India is a very large country with a very large number of students who are pursuing their higher education dream. The existing leading universities need not worry as it will be a healthy competition. "That being said, competition improves the ecosystem in a better way in that sector and we have seen that in the case of the airlines, banking, and telecom sector where a lot of foreign players have come in, and the Indian institutions and various organisations have ramped up their level," he told PTI. "On the whole, the consumer gets benefited from that. In the near future when the foreign institutions come, institutions here which are already doing a great job would be very happy to play in that ecosystem where everybody is providing quality education," he added. As per the draft norms, foreign universities

with campuses in the country can only offer not online or distance learning. Such universities, termed Foreign Higher education Institutions (FHEIs) in the draft. will need a nod from the UGC to set up their campuses in India. The initial approval will be for 10 years which will be renewed in the ninth year subject to the meeting of certain conditions. These institutions will not be allowed to offer any programme which jeopardises the national interest of India or the standards of higher education here, the commission has said. While these universities will have the freedom to decide their admission criteria and fee structure, the commission has advised them to keep the fees "reasonable and transparent." "The devil really lies in the details. The draft regulations are silent on many issues which will need further clarifications in the final regulations. Investment in Greenfield projects will need huge investment and prolonged gestation period. Working with existing universities and HEIs in India will have challenges of cultural fit or misfit," said Dr Raj Singh, Vice Chancellor, JAIN (Deemed-to-be-University), Bengaluru. "Students who study abroad look not only for better quality education but also exposure to a multicultural environment. "These universities, which will be required to offer the same quality of education as in the parent campus, may not be able to do so during the initial years and they will have to create global communities on Indian Campuses to ensure exposure," he said. 



SC ousts eviction order from land

Supreme Court has stayed the removal of encroachment on land in Haldwani, Uttarakhand. The order to evict thousands families from their homes in the name of eviction has been overruled. This decision is a big relief for those thousands of people who were protesting in the bitter cold to save their homes.

The decision also reminds us that the administration only follows the text written in the book but it cannot and should not walk blindly. The administration must take legal and human rights issues in consideration while arrival to a decision.

The High Court in this case had ordered in December that 28 acres of land under encroachment should be removed. But the properties are not just brick and stone constructions. There are several houses, government schools, private schools, Mosques

According to the results this land belongs to him. Nainital High Court was told that any encroacher has any legal document to claim that land could not be present. There are thousands of people in these settlements who have been living for many generations, sources claimed.

There are many people living here who came to Haldwani in search of livelihood and stayed here. These thousands of families have supported themselves with their hard earned money and arranged a roof over their head.

In this area of Haldwani, children, women elders all sit on the streets day and night to save their homes asking answers to what will happen to their future. These people sit on the streets carrying placards with slogans, so that bulldozers should not run on their houses. Anyway the bulldozerhas become a new symbol of justice.

If the sword of homelessness hangs over 50,000 people at once, then the government should first reach out to those people and give relief to them. But the people of this area say that the representatives of the state government did not defend their rights in the court. People say that it is completely wrong to call it encroachment because here they have been living for years and will save their homes at any cost.

The displeasure with the government is justified because thousands of houses, schools and religious sites have not come up overnight when all these were being built, then why the administration remained silent, this question will

There is a danger of action, because despite the rules being made in 2016, any there was no regularization of settlement. At that time, before the elections, the government issued strict guidelines to regularize slums.

Most of the settlements were built on riverriver or forest land, so they were not regular encroachers. The people have definitely got immediate relief from the order of the court. And for the time being this matter has calmed down for a few days, but the issue persists as to what will be the final outcome.

To glorify myths as facts bode ill for knowledge

A few days ago, while addressing the 75th Amrit Utsav of Swami Narayan Gurukul Rajkot Sansthan, Prime Minister Narendra Modi said that education has been completely neglected after independence. Therefore, it has become necessary that the government should bring forward the importance of ancient educational system. When previous governments faltered, he said, saints came forward and Swami Narayan Sansthan is an example. He said that in ancient times our education system was exemplary which gave importance to knowledge. "Our Gurukuls have been representing equity, equality, care and a sense of service for centuries".

Educational system in a particular period depends on the social and economic conditions prevailing at that time. It is well known that in ancient times education was reserved for a special type of caste and the so-called upper class. A large section of the society did not have the right to education. When Eklavya mastered the art of archery on his own, Guru Dronacharya asked for his thumb in Dakshina because he belonged to so-called lower caste, and his caste people did not have the right to education. There are also examples that even if a so-called low caste person overheard any educational talk, his ears were filled with lead so that he would not be able to hear any

The modern society spread education even among the economically and socially backward sections of the society by breaking these obscurantist ideas and breaking those bonds of religion and caste which prohibit right to education to all. Although there are many weaknesses and shortcomings in the education system of our country, but one thing is clear that after independence, due to the persistence of campaigns by the progressive movements, government high schools were opened on a large scale in many parts of the country where it became possible for the children of low socio-economic groups to get education under one roof along with others. In 1968, the Kothari Commission gave specific recommendations for common school system to end disparity in education. Unfortunately, these have not been implemented till

We hardly find mention of education among women in the ancient history. Even in the last century, Savitri Bai Phule, who was born in 1931 and who was encouraged by her husband JyotibaPhule to study, she

had to face many hardships. She was ridiculed and even stones were thrown so as to stop her from pursuing education. Social reformers, Raja Ram Mohan Roy and Swami Dayananda Saratwati did a lot for the education of women. After independence. many girls' schools and colleges were opened in the government sector to encourage education among

In the same speech, the Prime Minister goes on to say that the new education policy will produce new type of ideal citizens. But when we take a look at the new education policy, we find that this will lead to complete privatization of education further increasing inequality in education. This will also deprive large part of the society of quality education. Presently only about 2% of the GDP is spent on education as against the required 10%. Such type of education is intended to prepare a class of specially educated persons to serve the corporate sector as was done by the education system introduced by the British in our country to produce 'BhadraLok' to serve the masters.

Similar is the story of health services. India has to its credit the contribution in medical science by Charaka, a great physician of the time around 300BC. Accordingly, the Charaka Samhita mandates the physician to lead a life of celibacy, grow beard and hair, pray for cows and Brahmins. It forbids the doctor from treating those who are in opposition to the King or whom the physician or society may despise. But that was the period of Kings where Brahmins were at the top in the social Hierarchy. The modern oaths, belonging to the present, with tremendous advances in modern science bind that every human shall be treated equally and the physicians must be committed to treat fellow humans to the best of their abilities under any circumstances.

The health policy 2017 promotes insurance-based healthcare system. This far from universal healthcare system as envisaged by several health experts. Because of exorbitant cost, quality health care is getting out of reach of people. Government expenditure on health is only 1.28 percent of GDP, while according to the World Health Organization it should be 5%. Ironically health and education are taken as liability not as an asset by our policy makers. Both health and education should be fundamental right of every Indian citizen. No wonder we are at a rank of 107 out of 121 in Hunger Index as a result of the exclusive policies. Our dismal performance in managing COVID Pandemic is not an old story.

I have given these two examples because there is persistent attack not only in the political and economic sphere but all the aspects of life. There has developed strong linkage between forces of obscurantism and the corporate sector. There is concentration of wealth in few hands while vast majority is deprived of basic needs. The ruling clique use coercion, oppress people and try to divide the people through false propaganda. The Prime Minister had in 2014 said that in ancient times science in our country was so much advanced that the head of an elephant could be transplanted on a man's head and also that genetic science was so developed in our country that Karan could be born without mother's womb. Many scientists also started expressing similar views. The Vice Chancellor of Andhra Pradesh University G. NageswaraRao said in the Indian Science Congress at Jalandhar that the Kauravas who numbered 100 were born due to advanced stem cell research and technology in our country. Recently, the Indian Space Research Organization - ISRO and the Indian Council for Historical Research - ICHR have started working together on how to integrate ancient science with modern science.

When the forces in power fail to act in the interests of the common people, then they try to highlight the achievements of the society in the past in such a way that the people forget the failures of the ruling circles and are obsessed with the glory of the achievements

It is time we understand how such forces thrive on concocted stories and false propaganda. A lie spoken time and again appears to be truth and becomes part of people's psyche. The struggle against the forces of obscurantism is not only political or economic but there is a need to struggle at every level including developing scientific outlook in education and healthcare based on present day developments in medical science. BJP will fight Karnataka Assembly Poll with Narendra Modi as face

Sometime back Kiran Mazumdar-Shaw, executive chairperson of Biocon Ltd, had also urged Basavarai Bommai to resolve the "communal exclusion" and "growing religious divide" in the state. She had said that the state's global leadership in the ITBT (information technology and business transformation) sector was at stake.

One of the reasons for Bangalore losing its sheen for investors is the dismal infrastructure – broken sewage lines, erratic power supply, congested industry clusters. The political leadership is left with no time and energy to take care of these needs. According to industry groups, Bengaluru's crumbling infrastructure has caused millions in productivity losses locally. According to Outer Ring Road Companies Association (ORRCA), representing major IT and banking companies, IT companies in the city lost over \$28 million (INR 225 crore) in a single day on August 30, 2022, as the employees were stuck in traffic jams for over five hours.

Recently the industry in a letter to chief minister Basavaraj Bommai expressed its concerns. "ORR IT generates revenue of \$22 billion per annum (32 per cent of Bengaluru's revenue) and is the highest tax contributor. However, the lack of focus on development of the infrastructure in this corridor is appalling".

Some companies have transferred

critical work to locations outside of Bengaluru and Karnataka, causing reputational and economic damages to the city and the state. It is also alleged that nearly 300 foreign companies operating in Bangaluru have shifted to other states, especially to other southern states.

Incidentally the ORRCA had made this request in 2019 to the chief minister. But it is lying unattended. It had urged the chief minister to improve 19 ORR sub arterial roads, which were supposed to ease traffic on ORR during the construction phase. The quality of roads was very poor, making them non-motorable.

"All of this is impacting brand Bengaluru as there is a growing sense that Bengaluru is at risk with inadequate infrastructure vis-a-vis other destinations; with increasing social media coverage, the situation is being closely monitored by CEOs many of whom sit in other parts of India or elsewhere in the world," said the president of ORRCA, in a letter to development commissioner in 2017. However, despite its worldwide fame as a hub of the IT industry, Bengaluru's poor infrastructure has often been its black spot. The craze of Bengaluru being the most fabulous wage earning city has turned it into the most favoured destination for migration. Lakhs of people belonging to upper class and high earning groups from other states are migrating to Bengaluru. According to the BBMP Commissioner Gupta nearly 5 million (50 lakh) people have been added to the city population in the last 10 years, taking the city's population to 13.5 million (1.35 crore)

Situation which had emerged during the rule of S M Krishna some thirty years back has surfacing once again. The existing infrastructure is unable to cope with the modern challenges. In her tweet Kiran Mazumdar-Shaw, Executive Chairperson and founder, Biocon, says she has not been pleased with the infrastructure.

Former president, Federation of Karnataka Chambers of Commerce & Industry (FKCCI), D Muralidhar, who has served as member of city's planning commission and member of the board of governors at Indian Institute of Management (IIM) Bangalore is not a happy person. He says, "Bengaluru has

attracted investments worth lakhs of crores over a period of time. A large chunk of investments, up to a quarter of the \$88 billion in FDI, come to Bengaluru. But there is a marked deterioration in the quality of lower bureaucracy as there is rampant corruption.'

It is really a sad experience that India's Silicon Valley is facing stiff competition from unexpected quarters as the country's hottest IT destination. Notwithstanding Bangalore is still the number one IT/ITeS location, the bare fact is no longer the natural or the top choice of IT entrepreneurs. They are looking elsewhere to start their IT ventures and to their happiness are finding choices in various parts of the country.

educational entrepreneurial institutions are also facing probable threat. This may not happen immediately. The threat looms. Bengaluru is recognised as the educational hub. Just imagine what will happen when other cities turn to the preferred destination for IT sector. Chief Minister Basavaraj Bommai recently dismissed the attempts to compare Bengaluru and Hyderabad as a 'joke'. But to really let it be joke he has to ensure that politics of hate and communalisation have no place in Karnataka. He has to eliminate the fear of uncertainty from the minds of the industry. Speculation on Kishor's political plunge gains currency as supporterspitchforfightingLSpolls

NEW DELHI, JAN 9/--/Political strategist-turned-activist PrashantKishor, currently on a padayatra in Bihar, has so far shied away from making a definite assertion about whether he or his organisation will contest elections. However, the outcome of an opinion poll among his supporters -- more than 95 per cent of whom in one district backed participation in the 2024 LokSabha polls -- has strengthened the view that Kishor may take the political plunge as he has often said the campaign participants will have the final say

Jan SurajPadayatra, as the foot march has been named, hosted on Sunday its first poll among its followers on whether it should contest the parliamentary elections, organisers said, adding that participants were those who had joined the exercise in East Champaran district.

In November last, it had conducted a poll among its followers in West Champaran district on whether the campaign should take the form of a political party and 2,808 of 2,887 persons (over 97 per cent) had supported it.

Going a step ahead, the organisers took the campaign's followers' view on whether it should now fight the LokSabha polls, in an indication that the I-PAC founder may be warming up to the idea of throwing his hat in next year's polls.

Its organisers said more than 98 per cent of the followers in East Champaran supported the formation of a political party, while 3,515 of 3691 persons, over 95 per cent, wanted it to fight the next LokSabha elections.

Nearly 50 per cent of the respondents described unemployment and migration as two biggest problems of Bihar while 33 per cent said corruption was the most serious problem. More than 17 per cent of them chose the poor state of farmers as the biggest problem facing the largely poor state.

Kishor has maintained that it is for the people associated with the campaign to decide whether the ongoing exercise should take a political turn and fight elections.

Associated with a number of successful campaigns of different political parties, mostly regional and against the BJP, in his capacity as a strategist, he has been vocal in his criticism of the Chief Minister NitishKumar-led grand alliance government throughout the yatra that started from Bettiah on Mahatma Gandhi's birth anniversary on October 2.

He had asserted after the West Bengal assembly polls in 2021 that he will no longer be part of election management of any political party. Kishor had a brief career as a politician in Kumar's Janata Dal (United) before he was sacked in January 2020 for his vocal stand against the party's support to the Citizenship (Amendment) Act, a legislation hewed to the BJP's ideological project. KOLKATA, JAN 9 /--/ Chief minister Mamata Banerjee on Monday said her government works to give a humane face to the development that it brings about in the state, as she addressed a G20 meeting attended by delegates from across the world. Mamata said her government's welfare programmes, including those on women empowerment, have been designed to push for digital and financial inclusion of the poorest sections of society. "We believe in giving a humane face to development," said the chief minister, pointing out that her state's development programmes helped increase Bengal's GDP fourfold since she took over in 2011. The chief minister, who won a third term last year, said that despite the economic turmoil caused by Covid-19 pandemic, the state managed to create 12 million jobs, mostly in the MSME sector. "We managed to create jobs, grow our GDP four-fold, mainly because we empowered women, small industries, farmers and youth. We are fighting against hunger and

have provided free food to the poor," she said. Mamata pointed out that her government had ensured financial inclusion of women and people of vulnerable sections through digital transfers. "For women's empowerment, we give them money through digital transfers some USD 1.5 billion have been spent on this programme," the chief minister pointed out, adding that self-help groups, comprising $1.2\,$ million women, have been created in "We launched the 'government at your doorstep' (Duare Sarkar) programme to ensure that people get the benefits of our development initiatives. The programme won a national award," Banerjee said here at the first 'Global Partnership for Financial Inclusion' meeting of the G20. Every minute is important, says Uttarakhand chief secy as more houses in Joshimath develop cracks Cong demands situation be declared national calamity

DEHRADUN, JAN 9 /--/ Every minute is important, the Uttarakhand chief secretary said on Monday as more houses, buildings and roads developed cracks in the sinking town of Joshimath, red crosses came up on hundreds of unsafe structures and many residents stayed on despite the imminent

The number of subsidence-affected $homes\,rose\,to\,678\,while\,27\,more\,families\,were$ evacuated to safety, a bulletin from the Disaster Management Authority in Chamoli said, adding so far 82 families have been shifted to safe locations in the town. Chief secretary S S Sandhu held a meeting with officials at the state secretariat to review the situation in Joshimath and asked them to speed up the evacuation exercise to ensure the safety of residents as "every minute is important". The district administration had put red cross marks on more than 200 houses in the sinking town that are unsafe for living. It asked their occupants to either shift to the temporary relief centres or rented accommodation for which each family will get assistance of Rs 4000 per month for the next six months from the state government. Personnel of the National Disaster Response Force and State Disaster Response Force have been deployed for the relief and rescue efforts. Even those who have shifted to temporary shelters keep returning to their abandoned houses in the danger zone, unable to overcome the pull of home. Parmeshwari Devi, an elderly resident of Marwari ward which is one of the worst-hit in the town, said she spent her entire savings on having a house of her own and now she is being asked to leave it and shift to a relief camp. "I would



The poll panel said in its view, the technology for remote voting should be standalone like electronic voting machines (EVMs) and should not be connected to any network in any form to rule out any transmitting data. Kishida highlights security concerns on trip to Europe, US

TOKYO, JAN 9 /--/Japanese Prime Minister Fumio Kishida begins a weeklong trip Monday to strengthen military ties with Europe and Britain and bring into focus the Japan-U.S. alliance at a summit in Washington, as Japan breaks from its postwar restraint to take on more offensive roles with an eye toward China. Kishida's talks with U.S. President Joe Biden on Friday will highlight his five-nation tour that also takes him to France, Italy, Britain and Canada some of Group of Seven nations with which Japan has stepped up defence ties. His first stop is Paris on Monday. Kishida said his summit with Biden will underscore the strength of the Japan-U.S. alliance and how the two countries can work more closely under Japan's new security and defense strategies. Japan in December adopted key security and defense reforms, including a counterstrike capability that makes a break from the country's exclusively self-defense-only postwar principle. Japan says the current deployment of missile interceptors is insufficient to defend it from rapid weapons advancement in China and North Korea. Kishida said he will explain to Biden the new strategy, under which Japan is also reinforcing defences on its southwestern islands close to Taiwan, including Yonaguni and Ishigaki, where new bases are being constructed. "Will will discuss further strengthening of the Japan-U.S. alliance, and how we work together to achieve a fee and open Indo-Pacific." Kishida told a NHK national television talk show Sunday referring to a vision of national and economic security cooperation the two countries promote to counter China's growing military and economic influence. Under the new strategies, Japan plans to start deploying in 2026 long-range cruise missiles that can reach potential targets in China, nearly double its defense budget within five years to a NATO standard of about 2 per cent of GDP from the current 1 per cent, and improve cyberspace and intelligence capabilities. The idea is to do as much as possible in a short time as some experts see growing risks that Chinese President Xi Jingpin may take action against self-ruled Taiwan, which Beijing claims as part of its territory Japan's new strategy has been well received by the Biden administration and some members of the Congress, Experts say it would also widen cooperation with their main regional partners Australia and possibly South Korea. "This is an opportunity to rethink and update the structure and the mechanisms of the alliance to reflect a much more capable partner that's coming," said Christopher Johnstone, senior adviser and Japan chair for the Centre for Strategic and International Studies. He said, however, that Japan's focus on the strike capability and budget is a welcome but "a daunting agenda" that will require a lot of cooperation with the United States. Paving the way for the summit, Japanese Defense Minister Yasukazu Hamada and Foreign Minister Yoshimasa Havashi will fly to Washington to meet their American counterparts, Lloyd Austin and Antony Blinken, on Wednesday, followed by separate defence ministers' talks Thursday. The Biden administration, which also adopted its security strategy in October, expects Japan to assist in the supply and storage of fuel and munitions in case of a Taiwan emergency, experts say. Biden flies in to Lopez Obrador's new airport for summit

MEXICO CITY, JAN 9 /--/ One of the most important diplomatic decisions by President Joe Biden at the gathering this week of North American leaders might have been his choice of airport.

Biden arrived in Mexico City on Sunday evening via Mexico's newest hub, the Felipe Angeles International Airport, a prized project by Mexican President Andres Manuel Lopez Obrador. The hub was christened last year with much fanfare, though it's located more than an hour's drive north of the city centre, has few flights and until recently lacked consistent drinking water. Biden and Lopez Obrador, whose relationship is transactional at best and absent the warmth and camaraderie Biden has with other world leaders, shook hands and walked together down a long red carpet on the tarmac, flanked by soldiers. The two then took the long drive into the city centre together. Along with Canadian Prime Minister Justin Trudeau, who arrives on Monday, the trio will spend the next two days discussing climate change, manufacturing, trade, the

North America. "This gathering will deepen our coordination and advance our shared priorities for North America," Biden tweeted on Sunday after his arrival.

Prince Harry accuses royals of complicity in Meghan's pain

LONDON, JAN 9 /--/Prince Harry has accused the royal family of being complicit in his wife Meghan's anguish, claiming his stepmother Camilla, the queen consort, leaked private conversations to the media in order to burnish her own reputation. In interviews broadcast

on Sunday, Harry accused members of the royal family of getting "into bed with the devil" to gain favourable tabloid coverage, singling out Camilla's efforts to rehabilitate her image with the British people after her longtime affair with his father, now King Charles III. "That made her dangerous because of the connections that she was forging within the British press," he told CBS. "There was open willingness on both sides to trade information. And with a family built on hierarchy, and with her, on

the way to being queen consort, there was gonna be people or bodies left in the street." Harry spoke to Britain's ITV and CBS's "60 Minutes" to promote his book, "Spare", which is due to be widely released on Tuesday. It has already generated incendiary headlines with its details of bitter family resentments. He repeated his claim on ITV that there was "concern" in the royal family about his unborn child's skin colour after he married biracial American actress Meghan Markle.

Harry and Meghan first mentioned the incident during an interview with Oprah Winfrey in 2021, but they haven't identified the family member who expressed concern. Harry insisted the family wasn't racist, but said the episode was an example of unconscious bias, adding that the royal family needed to "learn and grow" in order to be "part of the solution rather than part of the "Otherwise problem". unconscious bias then moves into the category of racism." Harry said. He said that "especially when you are the monarchy you have a

Aid chief: Taliban decrees against women paralysing NGO work

KABUL, JAN 9 /--/ The Taliban's "internal debates and extreme decrees" paralysing are humanitarian work in Afghanistan, the head of a major aid agency told The Associated Press on Sunday. after he arrived on a week-long trip to talk to Taliban leaders about reversing a ban on women working for national and international nongovernmental groups.

Jan Egeland, the secretarygeneral of the Norwegian Refugee Council, is the first NGO chief to visit Afghanistan for talks with the Taliban since the ban came into effect more than two weeks ago. Authorities have barred Afghan women from working at NGOs, allegedly because they weren't wearing the Islamic headscarf correctly.

The ban follows a slew of moves that have severely limited or suspended women's rights and education. Aid groups, foreign governments, and the United Nations say women are vital for the delivery of lifesaving assistance in Afghanistan and are calling for the ban's reversal. Many groups have suspended their operations, warning of dire and deadly consequences for a population already battered by decades of war, deteriorating living conditions and economic hardship. The Norwegian Refugee Council says it has worked in Afghanistan since 2003 and employs 470 women. It helped more than 840,000 people last year and was intending to help 700,000 this year, the group said.

Egeland said that he was meeting Taliban leaders in the capital of Kabul and in the southern city of Kandahar, the birthplace of the Taliban movement and the base of the group's supreme leader Hibatullah Akhundzada. Egeland has already met the economy minister, who initially announced the ban, and other Taliban officials. Egeland indicated that those in Kabul were more willing to contemplate women returning to work because of their crucial role in delivering

humanitarian aid. They all say that they want us to continue work and hope we will continue without females,"

Egeland said in an interview Sunday at his group's Kabul office. "But when I say we're not willing or able to work with males only, they (Taliban officials) realize that the population is totally dependent on international assistance at the moment, food, shelter, sanitation." Women are needed to contact women, including female-headed households and widows, he said. Aid agencies say it is impossible for men to do this work because of Afghanistan's social and cultural norms as well as the Taliban's own prohibitions against the mixing of

Separately, two aid officials have told the AP that they were given the impression by Taliban ministers in Kabul that they want women to resume their work at NGOs but that this decision lies with the leadership in Kandahar. Egeland said the economy minister "sent us the message given by the supreme leader that we had to discontinue all work." He said he is traveling to Kandahar because "it is there that the ideological and religious decrees come from." "The

(Taliban's) internal debates and extreme decrees have paralyzed our work," Egeland said. The NRC chief said it was impossible to meet the supreme leader in Kandahar but hoped to influence those around him. Two weeks after the ban, it remains unclear how comprehensive it is, and some groups have reported that they are able to continue their work.

Egeland said this raises further questions. "Can this be a religiously activated ban if some (women) are working and some are not? It's not thought through at all," Egeland said. "We can't work with males only because we can't follow their (the Taliban's) rules and regulations." The Norwegian aid chief said the group's female staff have complied with the Taliban's dress codes, gender segregation rules and even the need to have a male chaperone on certain occasions. The damage caused by the ban will become worse the longer it continues, he warned, saying malnutrition and death is rising and maternal health is plunging. (AP)

Plane prepares to take off for 1st UK satellite launch

making final preparations for the first satellite launch from the UK later Monday, when a repurposed passenger plane is expected to release a Virgin Orbit rocket carrying several small satellites into space.

If successful, the mission will mark the first orbital space launch from UK soil and the first international launch for Virgin Orbit, founded by British billionaire Richard Branson. The company, which is listed on the NASDAQ stock exchange, has already completed four similar launches from the US. The latest mission will see a repurposed Virgin Atlantic Boeing 747 aircraft carrying a rocket take off from Cornwall in southwestern England from around 10.15 pm on Monday. Around an hour into the flight, the plane will release the rocket at 35,000 feet (around 10,000

LONDON, JAN 9 /--/Engineers are metres) over the Atlantic Ocean to the south of Ireland. The rocket will then take several small satellites for mixed civil and defence use into orbit, while the plane returns to Cornwall. It will be the first commercial satellite launch from Western Europe, Virgin Orbit said. In the past, satellites produced in the UK had to be sent to spaceports in other countries to make their iourney into space.

> Ian Annett, deputy chief executive at the UK Space Agency, described his "immense excitement" Sunday and said it was "a new era for space in the UK". The mission is a collaboration between the UK Space Agency, the Royal Air Force, Virgin Orbit and Cornwall Council. The launch was originally planned for late last year, but it was postponed because of technical and regulatory issues. (AP)



Bumrah's injury tempers return of stalwarts for ODIs against Sri Lanka

GUWAHATI, JAN 9 /--/ India were left with a mixed feeling on the eve of their ODI series against Sri Lanka as on one hand they will have stalwarts Rohit Sharma and Virat Kohli returning to the side while on the other, unfit pace spearhead Jasprit Bumrah will yet again miss the action. Bumrah was expected to bolster the bowling attack in the three-match series commencing here on Tuesday, but his return has been delayed further after he failed to recover completely from the stress fracture in the lower back, which has seen him miss several assignments including the Asia Cup and the T20 World Cup.

There is now a question mark over whether the pace spearhead will be available for the white-ball home series against New Zealand beginning on January 18, and whether he will be in contention for the four-Test Border-Gavaskar series commencing on February 9. With India set to host the ODI World Cup in October-November this year, Bumrah's last-minute exclusion is only adding to the mystery surrounding the pace bowler's recovery and rehabilitation process. The return of old guards Rohit, Kohli and KL Rahul and also Shreyas Iyer, though, will give the hosts a huge boost as they eye the series after clinching the T20Is against Sri Lanka. India have a packed ODI calendar -- 15 matches excluding the Asia Cup -- in the 10month window in the build-up to the World Cup in October-November and the key will be to not just get the balance right but also manage the workload in the midst of the Indian Premier League and the highlyanticipated Australia Test series. But another injury scare to Bumrah has thrown



the spanner in the works of the team management. There also lies the problem of plenty in picking the top-five batters. Opener Rohit and No. 3 Kohli pick themselves, while on form, it will be tough to drop Ishan Kishan and Iyer.

Kishan played a sensational knock in his last ODI in Bangladesh recently when he scored a career-best 210. The youngster could be in a direct clash with Shubman Gill

Star India asks BCCI for discount in current deal, exiting Byju's wants board to encash bank guarantee

NEW DELHI, JAN 9 /--/ India's home season media rights holder Star India has asked the BCCI for a Rs 130 crore discount in the existing deal while jersey sponsor Byju's, which is on its way out, wants the board to encash bank guarantee worth an estimated Rs 140 crore to honour the current agreement. The BCCI top brass deliberated on the two subjects for more than an hour in the emergent meeting of the Apex Council on Monday. It was a virtual meeting In November, Byju's had communicated to the BCCI that it wants to exit as the jersey sponsor of the Indian cricket team but the board asked the edtech company to continue until at least March 2023. However, in June, BYJU's had extended its jersey sponsorship agreement with the BCCI until November 2023 for an estimated USD 35 million While an approximately Rs 140 crore will be paid to the BCCI through bank guarantee, the remaining, around Rs 160 crore, will be paid via installments. "Only Byju's and Star India issues were discussed in the meeting but that also took well over an hour. It was a serious matter involving millions of dollars so naturally it took time," a BCCI source told PTI

Pretorius retires from international cricket to focus to T20s

JOHANNESBURG, JAN 9 /--/ South Africa all-rounder Dwaine Pretorius has retired from international cricket with immediate effect to shift "focus on T20 and other shorter formats". The 33-year-old has represented South Africa in 30 T20Is, 27 ODIs and three Tests since making his debut in 2016. He holds the record for the best bowling figures for South Africa in men's T20Is with his 5-17 against Pakistan in 2021. "A few days ago, I made one of the toughest decisions of my cricketing career. I have decided to retire from all forms of international cricket," Pretorius wrote said in a statement posted by Cricket South Africa (CSA) on Monday. "I am shifting my focus to T20 and other shorter formats for the rest of my career. "Growing up, my only goal in life was to play for the Proteas. I didn't know how it was going to happen, but God gave me talent and a serious will to succeed. The rest was in his hands." The all-rounder said by retiring from the national team will he be able to balance his career and family life better as he can freelance across the globe in best T290 leagues.



BARCELONA, JAN 9 /--/ Ousmane Dembele's strike sent Barcelona three points clear at the top of La Liga with a tense 1-0 win over Atletico Madrid on Sunday. Earlier David Silva produced a masterclass to help third place Real Sociedad beat Almeria 2-0, while Real Betis moved fourth with an entertaining 2-1 win at Rayo Vallecano. Struggling Sevilla earned a crucial 2-1 win over Getafe to climb out of the relegation zone on goal difference. Capitalising on champions Real Madrid's defeat by Villarreal, Barcelona set out to make a statement victory over Atletico at the Metropolitano. Shorn of suspended top scorer Robert Lewandowski, Xavi selected Ansu Fati up front in his place, but it was Dembele who made the difference, finishing a slick move in the 22nd minute. Atletico ramped up the pressure, with the superb Ronald Araujo clearing off the line from Antoine Griezmann at the death, but Diego Simeone's side could not find an equaliser. Both teams finished with 10 men after Ferran Torres and Stefan Savic were sent off for brawling with each other on the floor as tempers soured. "It's a win, but it's not just three points. It gives us morale and confidence for what's left of the league," Xavi told reporters. "We are



knew how to suffer and we take three golden points. It's a real statement that we are candidates to win this league.' Barcelona have conceded just six goals in their first 16 La Liga matches but Griezmann twice came close to finding the equaliser Atletico craved. The Catalans only mustered two shots on target and Atletico goalkeeper Jan Oblak said his side deserved more, "We had a good game, apart from the first 25 minutes," Oblak told DAZN. "We pressed well, we had chances, but lacked a bit of luck to score." "We started badly, the first 25 minutes we had little confidence, and later we woke up, but at 1-0 down it's already harder." Defeat means Atletico languish in fifth, 14 points behind leaders Barcelona. "It's not a worrying situation but it is one that we have to deal with," Simeone told reporters. "The reality is that we lost. It's true the team had the merit to take away another result, that didn't happen because we didn't put it away. What happens in the boxes is crucial." Youngster Fati had an early effort brilliantly blocked by the sprawling Jose Gimenez, as Barcelona dominated the opening exchanges. orld Cup stars chase

PARIS, JAN 9 /--/ Lionel Messi finally has something Kylian Mbappe already had with a World Cup winners' medal. Now Mbappe wants what Messi has won many times: the Ballon d'Or. After their fascinating duel in a wild World Cup final, the tournament's best player Messi and its top scorer Mbappe are firm frontrunners to win the next men's Ballon d'Or. Call it Messi vs. Mbappe part II, and it continues Wednesday when the Paris Saint-Germain teammates face Angers in

a French league game. Messi was given an extended break back home in Argentina after the World Cup, but has resumed full training and PSG coach Christophe Galtier hopes he'll be ready to play. Because they play for the same team, their rivalry could intensify over the rest of this season. The 35-year-old Messi has won a record seven Ballon d'Or trophies given to the best player in Europe. Only five Frenchmen -- including Zinedine Zidane and Karim Benzema -- have won it but the 24-year-old Mbappe has never

been on the podium. Mbappe made his goals clear while at the ceremony when Benzema won: "For me, of course it's an objective to win one or many of them. But of course there's a process to reach that. I think I'm on the right track." A challenger this time could be prolific Manchester City striker Erling Haaland, but he didn't play at the World Cup -- let alone star in it -- after Norway failed to qualify. Mbappe won the 2018 World Cup with France when he was just 19. Messi waited agonisingly long to get his hands on the trophy, losing in the 2014 final. He did so in style last month when Argentina beat France to win its third World Cup title

in arguably the most intense final in the tournament's 92-year history. Messi's two goals in the final capped a remarkable tournament where he scored seven times, finished as the best player, and reached a whopping 98 goals overall for Argentina. The good news for Argentina fans is that he wants to play a little while longer wearing the Albiceleste jersey. Mbappe, meanwhile, became only the second player to score a hat trick in a World Cup final and finished one ahead of Messi on eight goals as



tournament's top scorer -- the first to reach that haul since Brazil's Ronaldo in 2002. Mbappe's overall tally of 12 World Cup goals puts him level with Brazil great Pele -- and one behind Messi and Frenchman Just Fontaine, the single-tournament record holder with 13 in 1958. Former West Germany striker Gerd Mueller (14), Ronaldo (15) and record holder Miroslav Klose of Germany (16) are well within Mbappe's sights considering the young Frenchman may have three more World Cups ahead of him. By the 2026 World Cup, Mbappe should also be well in front as France's all-time leading men's scorer. He currently has 36 goals and World Cup teammate Olivier Giroud leads Les Bleus with 53. By the time the next World Cup comes around, Messi will be nearly 39 and perhaps retired from soccer altogether.

So the coast is clear for Mbappe to pulverise World Cup scoring records.

But before he starts thinking about that he has the pressing matter of a first Ballon d'Or to win, and it's a tall order with Messi as his main rival. But what a treat in store for French soccer fans if they both keep raising their game. Mbappe played for PSG

> 10 days after losing the final in Qatar, showing great determination to put that defeat behind him. The Ballon d'Or race has the makings of a classic contest between the teammates, since they were both in fine form for PSG before heading to the World Cup. Mbappe tops the league scoring charts with 13 goals and Messi is tied with PSG teammate Neymar for the most assists (10). Mbappe is co-top scorer

in the Champions League with seven goals, while Messi again heads the assists chart with four. Messi won the Champions League four times with former club Barcelona, where he became a superstar and scored 672 goals before joining PSG last season. PSG has never won the Champions League and this could prove a key factor in Ballon d'Or consideration -- especially if Mbappe leads the French giant to the European title. If Messi doesn't play Wednesday at home, PSG's next game is at Rennes on Sunday. "He had an extraordinary World Cup with a lot of physical effort and challenges," Galtier said. "We hope he's ready for (Angers)." (AP)
