- These Rules may be called the A & N Islands Land.

(i) Rule 132 of the Principal Rules shall be substituted as under:"The Record of Rights shall be prepared in Form 'F' for each village both urban and Non-urban and shall be issued alongwith corresponding map, QR Code capturing village name, survey numbers, total area, name of the tenants, mobile number, Aadhaar number and PAN number of the tenants."
