## Chief Secretary on visit to Southern Group of Islands Inaugurates newly set up four bedded Dialysis Unit at BJR Hospital, Car Nicobar Patients of Car Nicobar can now avail dialysis facility at their doorsteps: CS Chief Secretary interacts with Chief Captain & Members of Tribal Council and general public

Car Nicobar, Feb.6

The Chief Secretary, A&N Administration, Shri Keshav Chandra, IAS on first leg of his five days visit to Southern Group of Islands arrived at Car Nicobar this morning. On arrival at Car Nicobar Helipad, the Chief Secretary was accorded a warm welcome by the Deputy Commissioner, Nicobars, Shri Yash Chaudhary, IAS, SP District Nicobars, Shri Manjeet, IPS, Assistant Commissioner (HQ), Car Nicobar, Shri Vikram Singh, Chief Captain, Tribal Council, Car Nicobar, Shri Lionald Nicomede, Village Captains, Senior Officers of line Departments and others.

Soon after arrival, the Chief Secretary visited BJR Hospital, Car Nicobar and inaugurated a newly set up four bedded Dialysis Unit in the presence of Shri Yash Chaudhary, IAS, Deputy Commissioner, Nicobar District, Shri Lionald Nicomede, Chief Captain, Tribal Council, Car Nicobar, Medical Superintendent, BJR Hospital, Car Nicobar and other Senior Officers.

Interacting with the Health Officials, the Chief Secretary appreciated the efforts of the Health Department for installing the much needed facility in BJR Hospital. He said, with the inauguration of this Unit, patients who are in different stages of Chronic Kidney Disease (CKD) needing frequent dialysis hereafter need not come all the way to Port Blair to avail such facility, thereby helping in cost cutting of travel, lodging expenses and long duration of stay. Now, the patients can avail the dialysis facility at their door steps in Car Nicobar itself, he said. The Chief Secretary also interacted with the patients and enquired about their wellbeing. He also inspected other health care facilities available in the Hospital for the benefit



of the residents of Car Nicobar and appreciated the Health Department for keeping the premises of the hospital spic and span. To cater to the needs of pregnant women, a Gynecologist has been posted in BJR Hospital and the needy patients are now able to access health care facilities pertaining to C- Section, critical deliveries at their convenience in Car Nicobar itself without the need of coming to Port Blair.

With the opening of this Dialysis Unit at BJR Hospital, the long pending demand of tribal



people of Car Nicobar has been fulfilled. Meanwhile, 12 Chronic Kidney patients belonging to Car Nicobar Island who are presently compelled to undergo haemodialysis at GB Pant Hospital, Port Blair can now avail this facility at BJR Hospital, Car Nicobar itself.

Under the Pradhan Mantri National Dialysis Programme (PMNDP) which was rolled out in 2016, every District in the country is supposed to have a Dialysis Unit. The Dialysis Unit at GB Pant Hospital, Port Blair in South Andaman was



established in the year 2002 at Dr RP Hospital, Mayabunder in North & Middle Andaman District in 2013 and now with the inauguration of the Dialysis Unit at BJR Hospital, Car Nicobar in the Nicobar District, the A&N Islands will have a rare distinction of having one Dialysis Unit in all three Districts. A&N Administration has gone a step further and established Dialysis Unit at CHCs in Bambooflat, Diglipur and Rangat too.

Thereafter, the Chief Secretary visited Self Help

## Secretary (Agri./E&F/IT) visits Little Andaman; reviews activities pertaining to Agri, E&F & IT sectors Interacts with PRIs and farmers at RK Pur Panchayat

Port Blair, Feb. 6

The Secretary (Agriculture/E&F/IT), A&N Administration, Shri Pankaj Kumar, IAS visited Little Andaman Zone from Feb. 4 to 6 and reviewed activities pertaining to Environment & Forest, IT and Agriculture of the zone. On Feb.4, he chaired a meeting and interacted with PRIs and farmers at RK Pur Panchayat Hall. During the meeting, farmers raised various issues pertaining to low price of coconut in local market, irregular supply of agriculture inputs like fertilizers, bio-fertilizers, bio-pesticides, seeds and planting materials



through Sub-Depots and problems in marketing of spices etc. A progressive farmer from Ramkrishnapur also raised the issue of marketing problem of vegetables due to lack of proper transportation facilities. The Pramukh, Panchayat Samiti, Little Andaman also requested to consider extending subsidy to Boulder Pitching Wells. Addressing the issues raised by the farmers, the Secretary (Agri.) stated that Agriculture Department is taking action for timely supply of Agri inputs. He also informed that the Department has kept provision in UT Plan for extending subsidy to Boulder Pitching Wells also. For solving marketing problems of Agricultural produce, the Department is



establishing two e-NAM markets at Attam Pahad, South Andaman and DB Gram, Diglipur which will have facility for online trading. The construction work will be completed within a year. With the establishment of both these markets, farmers will be able to trade online with the traders of any part of the country, he said. Regarding the MSP of Copra, the Secretary said that since 2014, the Price Support Scheme for Copra is not being implemented due to some payment issues with the State Level Supports (SLS) and NAFED. He informed that the matter is being continuously pursued with the Ministry and assured that very soon, the scheme will be approved for Andaman

Thereafter, the Chief Secretary visited Round Hut at Chukchuka and held meeting with the general public and Tribal Council, during which, various issues

were raised by the Tribal Council and general public. He directed all Departments to resolve public grievances in a time-bound manner and also advised the Department Officials to adopt a proactive and committed approach in resolving public grievances.

The Chief Secretary also announced the reintroduction of procurement of copra under Minimum Support Price scheme through NAFED. He also directed the Officials of Electricity Department to ensure seamless power supply while APWD officials were directed to ensure better road connectivity.



In the afternoon, the Chief Secretary visited Arong Veterinary Farm and advised the officials to reach out to the people and provide poultry chicks, piglets and goat kids to the farmers extensively for promoting goatery, piggery and poultry activities. The Chief Secretary also visited Skill Development Centre (ITI), Arong, Car Nicobar and directed that courses which generate potential employment locally should be introduced for the benefit of the students.

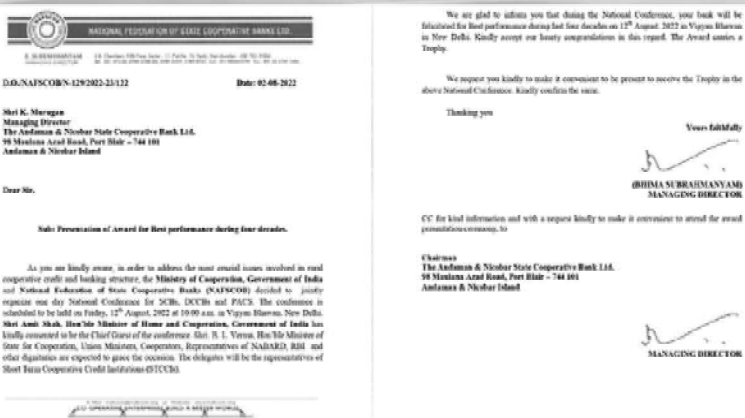
