entitled for 5 kg foodgrains in the scale of 3.5 kg rice and 1.5 kg wheat per person per month free of cost. Since, the tribal population is habitual rice eater and as per their request, PHH & AAY beneficiary of Car Nicobar and Nancowire group of Islands will be entitled for 5 kg Rice only per person per month free of cost under Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY). This is in addition to their regular entitlement under NFSA.

All such ration card holders have been informed to draw the foodgrains as per their entitlement for 2 months in one go between 1st April, 2022 to 31st May, 2022 in addition to their regular PDS foodgrains. However, the Ration Card holders who are not able to lift ration in the month of April, 2022 can also lift their foodgrains in the month of May, 2022.






