LPG distributors should provide weighing instrument to measure quantity of LPG cylinder at the time of delivery

All LPG consumers and the authorized LPG distributors of this UT have been informed that as per the Legal Metrology (Packaged Commodities) Rules, 2011 framed under the Legal Metrology Act, 2009, it is mandatory for all the authorized LPG distributors to

provide their delivery man a check weigher or non-automatic weighing instrument to measure or weigh the quantity of the LPG cylinder at the time of delivery. The consumers have the right to demand weighing of



LPG cylinders at the time of delivery so as to ensure exact

A&N Police celebrates its 70th Raising Day DGP exhorts Police personnel to discharge their duties with utmost dedication & sincerity

Port Blair, Jan. 16
Commemorating their 70th Raising Day, Andaman & Nicobar Police organized a brief Ceremonial Parade today at Police Line Parade Ground while observing all COVID related guidelines. The Director General of Police, A&N Islands, Shri Satyendra Garg, in his address conveyed his greetings to the members of A&N Police. He lauded the services rendered by A&N Police towards the well being of society and highlighted the major achievements of A&N Police force in the past one year. Some of the achievements included successful



installation of CCTV Cameras in all the 24 Police Stations of A&N Islands as per Hon'ble Supreme Court's directions and establishment of a Cyber Lab to effectively tackle cybercrimes. On the enforcement front, apart from diligently generating awareness about COVID Appropriate Behaviour, 82,778

crimes, especially drunken driving, over speeding, bootlegging and drug peddling, there has been a thirty nine percent (39%) reduction in IPC crimes, a fifty five percent (55%) drop in bootlegging cases, forty nine (49%) decrease in drug peddling cases and an eighteen percent (18%) drop was noticed in road accident cases in the year 2021, with respect to the previous year, 2020.

COVID-19 status in A&N Islands

Port Blair, Jan. 16
During the RT-PCR test conducted on 134 passengers who arrived here yesterday, 28 positive cases have been detected. Today, 9 flights with 504 passengers arrived, out of which, 385 passengers were vaccinated with both doses while RT-PCR test was conducted on 109 passengers (3 foreign travellers) and the reports are awaited.

During RAT conducted on 48 passengers bound for

North & Middle Andaman at Ferrargunj, 2 positive cases have been detected. At Mohanpura Bus Terminus, test was conducted on 38 passengers, no positive case has been detected. At Phoenix Bay Jetty, 7 passengers were tested with RAT and no positive case has been detected. RTPCR test was conducted on 1 crew member of MV Rangat, the report of which is awaited, a press release from Directorate of IP&T said.

COVID-19 vaccination for children continuing smoothly in A&N Islands 78.81% of target beneficiaries in the age group 15-18 years of age vaccinated with first dose so far 6,01,026 doses of vaccines administered to beneficiaries in the age group of 18 and above so far

Port Blair, Jan. 16
COVID-19 vaccination for children between 15-18 years of age which began in these Islands from Jan. 3 is continuing smoothly in A&N Islands too along with the rest of the country. With the concerted effort taken by the A&N Administration and the Health Department, so far, 18,126 doses of Covaxin have been administered to children between 15-18 years of age out of the 23,000 approx eligible beneficiaries



under this age group. To cover maximum number of eligible beneficiaries especially students and to achieve the target, the Health teams are visiting schools and administering Covaxin. Similar exercise is being carried in different schools all over the

Islands. Apart from the vaccination drive to cover children between 15-18 years of age will continue in all the COVID Vaccination Centres (CVCs). Today, a total of 70 doses of Covaxin were administered to children between 15-18 years of age. The percentage of eligible

beneficiaries under 15-18 years of age stands at 78.81% as on Jan 16, 2022. The children who have been inoculated with Covaxin, second dose will be repeated between 4-6 weeks after the first dose. The beneficiaries will receive the certificate online after the

COVID-19 Crisis

Measures for Enhancing Immunity

- Drink warm water throughout the day.
- Daily practice of Yogasana, Pranayama and Meditation for at least 30 minutes.
- Spices like Haldi (Turmeric), Jeera (Cumin), Dhaniya (Coriander) and Lahsun (Garlic) recommended in cooking.

Ayurvedic Immunity Enhancing Tips

- Take Chyavanprash 10gm (1tsf) in the morning. Diabetics should take sugar free Chyavanprash.
- Drink Herbal Tea/Decoction (Kadha) made from Tulsi (Basil), Dalchini (Cinnamon), Kalimirch (Black Pepper), Shunthi (Dry Ginger) and Munakka (Raisin) - once or twice a day. Add jaggery (Natural Sugar) and/or fresh Lemon Juice to your taste, if needed.
- Golden Milk- half tea spoon Haldi (Turmeric) powder in 150 ml Hot Milk - once or twice a day.

Immunity Boosting Measures for Self-Care

Simple Ayurvedic Procedures

- Nasal Application** - Apply Sesame Oil/Coconut oil or Ghee in both the nostrils (Pratimarsh Nasya) in morning and evening.
- Oil Pulling Therapy** - Take 1 table spoon Sesame or Coconut Oil in mouth. Do not drink, swish in the mouth for 2 to 3 minutes and spit it off followed by warm water rinse. This can be done once or twice a day.

Actions During Dry Cough/Sore Throat

- Steam inhalation with fresh Pudina (Mint) leaves or Amlain (Caraway Seeds) can be practiced once in a day.
- Lavang (Clove) powder mixed with Natural Sugar/Honey can be taken 2-3 times a day in case of cough or throat irritation.
- These measures generally treat normal dry cough and sore throat. However, it is best to consult doctors if these symptoms persist.

vaccination which needs to be downloaded from portal. The beneficiaries will also be given a vaccination slip which needs to be produced during the second dose of vaccination. If anyone is not able to download the vaccination certificate online they must contact the nearest COVID Vaccination Centre within 24 hours. The beneficiaries can also administer the second dose in any part of the Islands.

Meanwhile, as per data available, a total of 6,01,026 beneficiaries in the age group of 18 and above have been vaccinated so far in A&N Islands. The number of beneficiaries administered precautionary dose of vaccine so far stands at 2619. quantity being delivered to them. The weight of a domestic LPG cylinder is weight of empty cylinder +14.2 kg of LPG filled in it with a maximum permissible error of 150 gm. Similarly, the weight of a 19 kg commercial LPG cylinder is weight of empty cylinder +19 kg of LPG filled in it with a maximum permissible error of 1% and that for a 5kg commercial LPG Cylinder is weight of empty cylinder +5 kg of LPG filled in it with a maximum permissible error of 1.5 %. The empty weight of LPG cylinder is printed on the body of the cylinder.

The distributor shall get the weighing machine duly verified and stamped from the Legal Metrology Section functioning in the Directorate of Civil Supplies & Consumers Affairs prior to using it for any commercial transaction.

All the authorized LPG distributors have been informed to strictly comply with the rules and make necessary arrangements for weighing of LPG cylinders during delivery, failing which, strict action as per law shall be initiated against the distributor.
