Member of Parliament Requests Lt. Governor to Approach Ministry of Shipping to Give Preference to Andaman Ships for Annual Survey in Mainland Dockyards

Port Blair, Jan 18: The Member of Parliament, Shri. Kuldeep Rai Sharma called on the Hon'ble Lt. Governor of Andaman & Nicobar Islands yesterday and took up some important issues of these Islands.

Among other crucial issues, he requested the Hon'ble Lt. Governor to take up this matter of shortage of ship for

Southern Group of Islands as shipping is the lifeline of with the Ministry of Shipping to give preference to Andaman Ships for Annual Survey in Mainland Dockyards so that the turnaround timing of the ship after Annual Survey is reduced to minimum and round the year at least 50% of the ships are available for Hut Bay and Nicobar District

Andaman & Nicobar Islands.

He informed the Lt. Governor that there is a shortage of ships for Car Nicobar, Kamorta and Great Nicobar Islands.

He said that at present only MV Bharat Seema is available for Car Nicobar sailing while only MV Nalanda is available for

sailing for Kamorta and Great Nicobar.

The Member of Parliament added that presently there are eight ships for inter-islands sector viz. MV Sentinel, MV Chowra, MV Campbell Bay, MV Nalanda, MV Sindhu, MV Kalighat, MV Bharat Seema and MV Dering but out of these eight ships only three

Your Nature Guide

The Oceanic Giant Wheel: How does the complex web of life in the sea sustain itself? Who eats what? What happens when plants and animals die?

Marine plants covert the inorganic nutrients available in the sea into organic matter and atone it. These are eaten by the vegetarian forms of life. which in turn are eaten by the carnivores. When they die, the plants and animals of the sunlight zone start sinking down towards the ocean floor. They gradually decomposed along the way. Nutrients locked aw ay in their body tissues are released.

Some remains of dead plants and animals reach the deeper oceans and are fed on by the scavenger animals (like the deep water sharks) living there. Even wastes from animals in the surface w aters provide nutrients for the animals living in the deep sea. This entire downward movement of organic debris recycles the nutrients that are gradually carried back to the surface to be used by the plants there to make food.

UNSC Sanctioning Abdur Rehman Makki as Sanctioned **Terrorist**

India has welcomed the designation of Lashkare-Taiba (LeT) deputy chief Abdur Rehman Makki as a sanctioned terrorist by the UN Security Council, after China withdrew the "technical hold" it had placed on the listing last year. Makki, the brother-in-law of 26/11 mastermind Hafiz Saeed, is on the most wanted lists of India and the United States for terror attacks in India, and support to terrorists in Pakistan. China's hold on the Makki listing process in June was one of five holds it placed on similar proposals against other wanted LeT/ Jaish-e-Mohammad (JeM) terrorists based in Pakistan. It had led to an angry response from New Delhi, which accused Beijing of "double standards" on terrorism and "making a mockery" of UNSC counter-terror mechanisms. In that sense, China's decision to allow the listing is a win for India: this is the first time a listing proposal where India is a co-sponsor has been allowed to go through; and it is the first time a terrorist has been listed primarily for attacks in India, particularly in Kashmir, as most others have been listed for their al-Qaeda links and for attacks in other parts of the world. It is unclear what prompted China to relent, as it has continued to hold out despite the 14 other UNSC members agreeing to the listing. In 2019, China agreed to a decade-old demand from India to list JeM chief Masood Azhar only after international outcry over the Pulwama suicide bombing. The Chinese Ministry of Foreign Affairs has called the Makki listing as "conducive to enhancing international counterterrorism cooperation" and a "recognition" of Pakistan's fight against terrorism.

As India knows from experience, the designation of UNSC terrorists, who are subject to an assets freeze, travel ban and arms embargo, is only one step towards bringing them to justice. Pakistan has yet to hold even one of the many terrorists on the list accountable for the major attacks they are accused of: from the 1999 IC-814 Kandahar hijacking, to the Mumbai 26/11 attacks, and Pathankot and Pulwama. New Delhi will have to persevere in its seemingly Sisyphean task of keeping the spotlight on Makki and others to ensure that Pakistan continues to feel pressure to prosecute them successfully. It is possible that the Makki designation is the result of behind-the-scenes India-China negotiations at a time the relationship is mired in issues over the LAC standoff. The test of this diplomacy will perhaps be known if and when China acts on the listings of the four other terrorists proposed, i.e., Hafiz Saeed's son Talha, 26/11 handler Sajid Mir, LeT recruiter Shahid Mehmood and Abdul Rauf Azhar (Masood Azhar's brother) wanted for the IC-814 hijacking.

Pathaan: Shah Rukh Khan-Starrer's OTT Release Date on Prime Video Revealed **During Court Proceedings**

January 18: Nine days before the theatrical release of Shah Rukh Khan's muchawaited actioner Pathaan, the Delhi High Court on Monday directed Yash Raj Films to make some changes in the film, for its OTT release. Pathaan, starring Deepika Padukone and John Abraham, has already been approved by the Central Board of Film Certification, but will have to be submitted again to the CBFC for re-certification ahead of its streaming premiere on Prime Video on April 25.

According to Bar & Bench, The Delhi High Court asked the producers of Pathaan to provide Hindi subtitles, closed captions as well as audio description for the OTT release of film for the benefit of those with visual and hearing impairments.

Since Pathaan is just days away from its big screen release on January 25, the court observed that directions for inclusion of audio description and other measures for theatrical release cannot be passed at this stage, but passed directions with respect to the release of the film on Prime Video in April, asking the CBFC to consider recertification of the same by March 10 after the producer prepares subtitles.



While hearing a plea seeking visually and hearing impaired persons to access the film as per the rights guaranteed under the Rights of Persons with Disabilities Act 2016, a single-judge bench of Justice Prathiba Singh observed: "The present writ petition raises very important issues as to access of entertainment to the hearing and visually impaired persons. Under Section 42 of the RPWD Act 2016, the government has an obligation to take measures to ensure that all plea. content is available in accessible formats for persons with disabilities. In the context of films, most importantly, special measures would have to be taken for hearing and visually impaired persons, as the experience of watching a film in a movie theatre cannot be denied to such persons."

The plea was moved by four persons – a law student, two lawyers and a disability rights activist – who sought the enforcement of various rights and accessibility requirements as prescribed under the 2016 Act. Apart from Yash Raj Films and OTT platform Prime Video, Ministry of Information and Broadcasting (I&B) and

Department **Empowerment of Persons** with Disabilities under Ministry of Social Justice and Empowerment were added as respondents in the

Taking to the platform, the multi-billionaire announced the features which will appear in the 'first part' of a 'much larger UI overhaul'.

"Easy swipe right/left to move between recommended vs followed tweets rolls out later this week," he wrote.

"Bookmark button (de facto silent like) on Tweet details rolls out a week later," he added.

The Tesla CEO further revealed that 'Long form tweets' will be a part of Twitter from 'early Feb'.

Netizens lauded Musk for the changes he introduced, showing excitement for the upcoming upgrades on the microblogging platform.

"Can't wait for long form tweets!! Loving the new changes and updates so far," a user wrote.

"Boss moves. Thank You!!!" another user wrote. Meanwhile, yet another user wrote, "Those are good

The upgrades came after Musk tweeted the announcement of a change in the User Interface of the platform's 'Bookmarks' feature in December 2022.

Musk had hinted that the upcoming changes would make it "Easy to create folders to bookmark tweets into various categories".

The Tesla CEO replied to a user asking for a bookmark organizer positively, ninting at it being part of the new feature.



Kathmandu: The search for the last missing person in the Nepal plane crash resumed on Wednesday after rescuers on Tuesday pulled out one more body a Yeti Airlines aircraft carrying 72 people, had plunged in a river gorge in the resort city of Pokhara.


Two days after the fatal crash, a woman's body was found deep down in the Seti River gorge on Tuesday. With this, the bodies of 71 people who died in the crash have been retrieved.

The search for the missing person started early morning on Wednesday with the help of divers and four drones, rescuers have given up hope of finding the

18: missing person alive, MyRepublica newspaper reported. The Yeti Airlines aircraft took off from Kathmandu's Tribhuvan International Airport at 10:33 am on Sunday and crashed from the crash site where on the bank of the Seti River between the old airport and the new airport in Pokhara, including five Indians, minutes before landing. Fiftythree Nepalese passengers and 15 foreign nationals, including 5 Indians, and four crew members were on board the Yeti Airlines aircraft when it crashed. The five Indians, all from Uttar Pradesh, have been identified as Abhisekh Kushwaha, 25, Bishal Sharma, 22, Anil Kumar Rajbhar, 27, Sonu Jaiswal, 35, and Saniava Jaiswal. As many as 48 bodies of the deceased have been brought to Kathmandu, the report added. The dead bodies except that of the locals and

48 victims have been brought to Kathmandu via Nepal mortem at Maharajgunj-Teaching completion of autopsy. "Forensics experts are currently working to respective family members," he said.

'Whenever I am Batting, the Mood in the Dressing Room is Relaxed'

January 18: The past few days have been tough to walkthrough for Sarfaraz Khan. Only hours ago had the 25-year-old conceded to The Indian Express that 'he wasn't able to sleep' after he was not picked in India's Test squad for the first two Tests against Australia. But with the support and trust of his Mumbai teammates, he dispelled the disappointment to construct a Ranji Trophy century against Delhi.

"Everyone supports me. The team trusts me so much and I don't want to break that," he said at the end of day one's play at the Arun Jaitley Stadium. "Jab tak mai wicket pe rehta hu, team ka mahol thanda hi rehta hai. Mujhe accha lagta hai ki mai waha enjoy karu aur ye log yaha enjoy karein. (Whenever I am batting, the mood in the dressing room is relaxed. I feel good that I am enjoying myself in the middle and they are in the dressing

Enjoy is just what the Mumbai dugout did as Sarfaraz thighfived after picking a single to reach triple figures against Delhi, eventually 125 runs off 155 deliveries. 'What a shot' shoutouts had followed throughout his innings, at times even when he nudged the ball for doubles. Just as he reached his century, standing ovations and a hat-tip followed.

Mumbai coach Amol Mazumdar couldn't resist saluting him. The latter provides some context. "Amol sir keeps

telling me, 'Your job is to score runs. You are the one who, if our wickets fall early, can take the game to the opposition," Sarfaraz

Sarfaraz has scored the most runs for Mumbai across the previous two Ranji editions, and only sits behind Sir Don Bradman in terms of batting average after 53 first class innings. A stat he shared on Instagram after his recent snub from India's Test team.

"No one can argue over Sir Don Bradman. Khushi hoti hai ki mai unke record ke aaju baaju chalte rha hu teen saal se (Happy that I am moving there or thereabouts his record). It won't stay the same all the time," the Mumbai middle-order batter said after his recent hundred, third this

When Sarfaraz walked in to bat, Mumbai were three down at 62. Four runs later, they'd lose another, the in-form captain Ajinkya Rahane.

It took the 25-year-old 25 deliveries before hitting his first boundary of the day. But once he did, Sarfaraz discovered his rhythm, adding 144 runs for the fifth wicket alongside Shams Mulani. "We knew he'll counterattack in the second session," said Delhi all-rounder Pransh Vijayran.

While Vijayran was successful in tempting Mumbai batters including captain Rahane to the outside-the-off-stump trap, Sarfaraz kept his calm, going only after his odd loose ball.



Harshit Rana was dispatched down the ground on the off when he pitched further up. Switching round the wicket and pitching short next over barely helped as Sarfaraz hooked him for another maximum. "The wicket had bounce and they were swinging the ball as well, so I was taking my time in the first session. I knew there'll be an opportunity to score after lunch. owing to laziness after eating and that's exactly what happened."

Sarfaraz further flexed his ability to play spin by forcing Delhi to take Hrithik Shokeen off the attack after he scored for 14 runs off the off spinner's second over. Against leftarm spinner Yogesh Sharma, he illustrated a variety of avenues to score big, dancing down the track, sweeping, cover driving and backfoot punching his way through before eventually being stumped while looking for glory.

"There's no grass on good length at one side of the wicket, from where they were bowling spin. I was thinking of not letting them settle in and take control of the play before they do so."


