Port Blair, Dec. 15: The are situated nearly 1200 KM (approx) away from nearest Airport in Mainland India, Chennai and Kolkata. For serious medical cases, evacuation in passenger aircraft remains the only option.

> He said that in the recent past for evacuation of serious stretcher patients from Port Blair till now family members of the patient had to pay Rs. 1,32,000 (One lakh thirty-two thousands) one way, excluding cost of tickets for patient attendants.

He pointed out that nearly two months ago the rate of tickets for stretcher patients has been almost doubled without any valid reason to nearly Rs. 2,41,000 (two lakh forty one thousand only), which has come as a massive blow to the people of Andaman & Nicobar Islands, most of whom can't afford to buy tickets for stretcher patient in such a high rate in case of medical emergency.

He mentioned that charging such an exorbitant amount from stretcher

patients during the time of medical emergencies is unethical.

The MP further pointed out that prior to the year 2007 for few years the Government of India had fixed the rate for stretcher patients from Andaman & Nicobar Islands, under which a stretcher patient had to pay only Rs. 29,000 approx (lump-sum rate), which used to be issued through ANIIDCO. But in 2007 the fare was revised.

What is a Coral?

Corals are tiny animals that have an outer stony skeleton and live in colonies in the sea. They belong to the same animals group as the sea anemones, and jelly fish. Each coral animal is called a polyp and lives inside a cup of carbonate (Limestone). It has a mouth at the top surrounded by tentacles. The tentacles help to capture food like plankton for the coral. While it is alive, a coral poly's tentacles protrude from the cups for feeding. In times of danger, the polyp can withdraw into its cup. This is similar to a turtle withdrawing into its shell when disturbed. A coral polyp cannot move and remains fixed to its cup throughout its life. Coral polyps can be of several species - in A&N alone, 135 species are found.

Coral Colonies : Many thous ands of coral polyps are connected together to form a coral colony. These colonies are of many shapes and colours.

An Energy Conundrum

At the core of India's energy transformation is its bet on solar power. Based on a commitment to address the global climate crisis, India has promised to source nearly half its energy from non-fossil fuel sources by 2030 and, in the shorter term, source at least 60% of its renewable energy from solar power. However, a disclosure in Parliament by the Minister for Power, New and Renewable Energy suggests that India faces significant headwind in this guest. A key central policy to source solar power is facilitating the establishment of large solar parks; small solar power projects usually translate to higher per-unit production costs. And so, in 2014, the Centre announced the 'Solar Parks and Ultra-Mega Solar Power Projects' policy to facilitate the creation of large parks. The initial plan was to set up 25 parks capable of generating at least 20,000 MW by 2019. In 2017, the Government scaled this to 61 parks with a target of 40,000 MW. It emerges, however, as of 2022, that only a fourth of the capacity has been achieved, that is, projects worth 10,000 MW have been commissioned. Four projects have been cancelled, by the Centre's own admission, due to tardy progress. The roadblocks, in the Centre's estimate, have been challenges in acquiring land with a clear title, setting up infrastructure necessary to transmit power produced at these parks to the grid and, in an unusual disclosure, "environmental issues" in Rajasthan and Gujarat, where projects have been halted because their transmission lines encroach upon the habitat of the critically endangered Great Indian Bustard.

Notwithstanding its claims on international podia that it is on track to meeting renewable energy targets, it is no secret that India is lagging behind. By the end of 2022, India had committed to having in place 1,75,000 MW of renewable energy capacity, with 1,00,000 MW from solar power. However, only around 61,000 MW of such capacity has actually been installed. For a few years now, there has been considerable hype around solar power achieving grid parity in India — meaning power companies are able to sell it at a price lower or as much as conventional sources — but this does not account for the subsidies or concessions frontloaded by the Government. While India should continue to expand its economy on the back of renewable energy, the Government must take a hard look at whether renewable power, solar, wind or nuclear, meets standards of economic viability and environmental sustainability. Solar power may be a valuable tool in India's energy transformation story, but it cannot be the panacea for every need.

Modified Wood Likely to Turn Transparent to Replace Glass, Say Researchers



December 15: HYDERABAD: Wood that is made of plant fibre has transformed into a translucent material, thanks to Forest College and Research Institute (FCRI). The innovation was first of its kind in the state and only second in the country after the Institute of Wood Science Technology (IWST), Bengaluru.

The research was carried out by Ch. Mahesh, a student of the department of forest product and utilization under the head of the department Kapil Sihag and professor Sumit Yadav.

Wood has components likecellulose, hemicelluloses and lignin, wherein both cellulose and hemicellulose are optically transparent but lignin is optically

Researchers modified lignin to alter the characteristics of wood.

Speaking to Deccan Chronicle, HoD Kapil Sihag said, "We have been working on this research for the past one year and have been successful in modifying the lignin with the help of chemicals such as sodium hydroxide (NaOH) and hydrogen peroxide (H2O2) to alter the opaque characteristics of wood into translucence. Upon further infiltrating the polymer of the same refractive index as translucent wood, we could make the wood transparent."

Bamboo and Balsa wood was used in the research process and it was also found out that the innovation could be carried out on any locally available wood material. With further research, there was a possibility of processing the furniture wood into translucent planks and efforts were being made for the same.

"As far as the application of transparent wood is concerned, it will be a promising alternative for glass. Moreover, it will be more durable than glass due its flexibility and strength and transparent wood is easier to handle and operate than glass." Sihag added.

Plea in SC to Expedite Division of Assets Between AP, TS

December VIJAYAWADA: The Andhra Pradesh government has moved the Supreme Court seeking that the apex court direct Centre to expedite division of assets and liabilities between residuary AP and Telangana as per the AP Reorganisation Act, 2014. AP pointed out in its plea that even as erstwhile Andhra Pradesh got bifurcated to form the new state of Telangana way back in June 2014, apportionment of assets and liabilities under the provisions of the AP Reorganisation Act has not been done so far despite repeated efforts by the AP government.

The plea underlined that assets and liabilities specified in Schedule IX having 91 institutions and Schedule X having 142 institutions of AP Reorganisation Act, 2014, and another 12 institutions have been apportioned between the two states.

Non-division of these assets valued at 1 1,42,601 crore is only benefitting Telangana, as 91 per cent of these assets were situated in Hyderabad, the erstwhile capital city of AP, which is now the capital of Telangana.



The AP government listed in its plea how resources of erstwhile AP had mostly been invested for developing infrastructure in and around Hyderabad. The value of Schedule IX institutions is estimated to be 1 24,018.53 crore. Of these, assets worth 1 22,556.45 crore (93.9 per cent) are located in Telangana. The value of Schedule X institutions is 1 34,642 crore and assets worth 1 30,530.86 crore (88 per cent) are located in Telangana. The remaining 12 institutions are valued at 1 1,759 crore and they are all located in Telangana.

AP contended that nonapportionment of these assets has led to several issues, which have adversely affected the residuary state and violated the fundamental and

other constitutional rights of AP people. Nearly 1,59,096 employees working in these institutions since 2014 are facing adverse conditions. Those employees who have retired from these institutions have not even got their terminal benefits.

Moreover, all these institutions perform a series of activities. Non-division of their assets between AP and TS in affecting the very functioning of these institutions and having an adverse impact on people.

Andhra Pradesh has asked Supreme Court to declare that Telangana's inaction on division of assets is violating the fundamental rights of the people in AP.



Home Secretary to Chair Meeting on Delhi Airport Rush



December 15: New Delhi: Union Home Secretary Ajay Kumar Bhalla will chair a high-level meeting on airport rush here in the national capital on Thursday morning.

The meeting is likely to be held after 11 am in the Ministry of Home Affairs (MHA). Senior officers in the MHA, officials in the Minister of Civil Aviation and others concerned with the matter, including those in Delhi International Airport Ltd (DIAL) and the Central Industrial Security Force (CISF), will attend the meeting.

The meeting is being held considering the complaints on social media by irate passengers about missed flights and serpentine preboarding lines at India's busiest airport in Delhi.

The pictures posted on Twitter showed overcrowding at Delhi International Airport. There were reports of passengers grumbling about long waits for security checks and mismanagement by the airportstaff. The government has even stepped in to help ease the congestion, with India's Civil Aviation

Ministry earlier saying in a statement that it's working with airlines to reduce flight departures to 14 during peak hours. It did not disclose data for normal traffic.

Civil Aviation Minister Jyotiraditya Scindia also visited one of the terminals earlier this week and said that he will look into concerns around the management of security checks at Delhi's T3 Indira Gandhi (IGI) airport in response to a complaint by a passenger on social media. The minister has ordered airport officials to resolve the issues on priority.

Additionally, the Delhi airport is adding baggage screening systems at the security checks and increasing traffic marshals to avoid vehicles clogging the departure.

Delhi airport has deployed 26 additional staffers to help passengers in the entry forecourt and security area and is working with the security agency Central Industrial Security Force (CISF) to have full manning through Flexi shift from 5 am to avoid queue build-up.

Scorer Turns Provider as Griezmann Shines in France's Midfield

December 15: Back in 2018, Antoine Griezmann had told reporters about how he feels after scoring a goal. "Whenever I score a goal, I go back to being a child," the France forward had said in a press conference. On Wednesday night, the 31-year-old did not score, but there was a child-like enthusiasm in the way he played.

Griezmann linked up with the forwards, assisted build-ups towards the Moroccan goal, won midfield-battles and tracked back to help his defence as France overcame the gritty African trailblazers 2-0 to reach the final of the World Cup, where they will face Argentina on Sunday.

Griezmann, who is being played as a midfielder by coach Didier Deschamps in the World Cup, would first play a role in France's first goal scored by Theo Hernandez before contributing to key moments in the game as well as being roughed out passes by the Moroccan players, who were constantly on his back.

Griezmann would praise the Moroccans post the match. "Morocco impressed me tonight. They set up very well tactically, offensively. They caused problems for us." Griezmann said post the match. Born in 1991 with his father hailing from France and mother of Portuguese-French origin, a young Griezmann grew up in Macon, a region famous for Burgundian wine in France. As a child, the diminutive Griezmann was rejected by French clubs like Olympique Lyon, Saint-Etienne and Auxerre before Spanish club Real Sociedad's scout Eric Olhats saw a 13-year-old Griezmann playing in a youth tournament in Paris. "He did not stand out above everyone else. He played for ten minutes as he came off the bench because he was, physically, completely overwhelmed by other players. But that technique, that flow and that ease in play caught my eye," Olhats once told website LaInformacion.com in an interview.

With the French law requiring young players to attend school in their home country, Griezmann continued his studies in the French town of Bayonne, a city closer to the Spanish border and playing for the junior teams of Real Sociedad in Spain starting 2005. The France youngster would stay for more than six years at Olhats's home in Bayonne. "I became his father, mother, his grandma and his best



friend," Olhats recalled in the interview.

Griezmann played for the Spanish club for more than nine years before he joined Atletico Madrid. The early Spanish influence in his life does show in Griezmann's daily life and he talked about this in an interview with La Parisien, a French newspaper. "Every training session was at the intensity of a match. In daily life, I feel Spanish more than French. I eat at 3 pm, I talk to my dog in Spanish," Griezmann told La Parisien.

After signing with Atletico Madrid in 2014, the French striker played for the Spanish Club for five years before he was signed by FC Barcelone for a then record fee of 108 million pounds in 2019. The two years at Barcelona saw him scoring 35 goals in 102 games before he returned to Atletico Madrid last year on loan. With coach Diego Simone not starting Griezmann for major part of last year and playing him for less than 30 minutes per match to avoid Atletico Madrid paying a sum of 40 million euros if Griezmann played for more than 45 minutes on average during the loan period, a part of the loan clause, the French striker would feel disappointed.

He though surpassed Paco Campos's tally of 146 goals to become the club's third highest scorer for the club. The forwardalso talked about lack of game time for his club last year. "I am feeling physically very well in my legs. Pre-season did a lot of good for me, I needed that. I had a big empty spell last season where I wasn't doing well mentally. Now I am doing a lot better and I am giving it my all," he told Canal+ earlier.

Griezmann made his debut for France in 2014 and since then he has played in 113 matches for France prior to the World Cup in Qatar including 72 consecutive matches for France. The striker, who was the player for the tournament and Golden Boot winner in Euro 2016 and man of the match in the 2018 World Cup Final claiming the bronze ball, has a total of ten goals in Euro 2016 and 2018 World Cup and is placed third on France's all time scorer lost with a total of 42 goals.

With Deschamps deciding to play Griezmann in midfield, the striker was open to the idea. "I am not wracking my brains figuring out how to score, the team needs me more at the heart of the game. I enjoy being the link between midfield and attack. I'm more in a role where I drop deep and try to help others. I am here to do what the coach asks me. I want to be proud of the jersey and make the coach proud. I want to make things as easy as possible for my teammates. I'm in very good shape physically, and when that happens I feel better in my mind," Griezmann had said earlier in the tournament.

While his goal against Tunisia was disallowed by VAR, the 31-year-old now leads the tournament in terms of assists with a total of four, ahead of Portugal's Bruno Fernandes and England's Harry Kane. Prior to the semi-final, he also led in terms of key passes with a total of 17 key passes, six great chances and most crosses with 34 crosses, according to website Livescore.com. Wednesday's assist also saw him extend his all-time assists to 29, highest for France followed by 27 assists by Thierry Henry and 26 by Zinedine Zidane.

Back in the late 2000's as a ball boy at Real Sociedad Stadium, Griezmann had once asked France legend Zinedine Zidane for his shirt but had got shorts. "He had already swapped with a rival, but I was so disappointed that he gave me some shorts," Griezmann had written in his biography, Behind the Smile.


