EDITORIAL

Tackling challenge of weak credit growth amid rate hike cycle

The twin balance sheet problem (bad loans of banks and high corporate debt) is nearly behind us, yet robust credit growth appears to be a low percentage shot during the current fiscal. Latest RBI data pegs FY22 bank credit at 8.6% or thereabouts, indicating an extremely slow recovery and miles behind the 14-16% growth seen in the last decade. While improved asset quality of banks and deleveraging corporate balance sheets are encouraging, rising inflation could throw a nasty surprise.

We are heading into a rate hike cycle amid weak credit growth, which has been below the trendline for over five years on a trot. Prior to the Covid-19 pandemic, the Indian economy slowed down due to a weakening corporate capex cycle, and this was accentuated by demonetisation, GST implementation and the NBFC crisis. In FY22, loan growth did recover, but signs of a complete rebound in the capex cycle are still not visible. Interestingly, lenders appear bullish, but big borrowers are yet to warm up to the so-called 'capex mahotsay' theme. It means demand uncertainty and high inflation only point to slower loan growth and higher pressure on margins.

As history shows us, borrowers' confidence influences the credit cycle more than policy rates themselves. Companies take out loans even during a rate hike cycle provided they are confident about cash flows. Even though banks' overall loan books are better than during the pandemic years, recovery isn't uniform with at least two key segments, namely corporates and the self-employed, especially in the services sector, yet to overcome the financial trauma caused by Covid lockdowns.

Disappointingly, we are witnessing high inflation well before loan growth has begun in full strength or even before it has regained pre-slowdown levels. Liquidity is abundant and interest rates have generally been benign, but the question is to what extent will the RBI's action to curb inflation through interest rate hikes delay the recovery in bank credit, which in turn depends on strong economic growth. Policymakers must ensure that rate hikes as a response to inflation doesn't eventually hurt demand.

Zero tolerance towards encroachment on Govt. land





Port Blair, April 23:

Continuing its zero tolerance policy towards encroachment on government land, the revenue department of South Andaman District carried out eviction drive committed over Government land situated near the beach area at Shaheed Dweep, recorded road at Carbyn's Cove junction and from Brookshabad road side area with in Port Blair tehsil under South Andaman District.

On 21.04.2022 encroachment eviction drive was carried out in Shaheed Dweep at Lakshmanpur beach near parking area upon land bearing SY No. 138/1, stands recorded as Tree Forest, a total of 13 Nos. of temporary sheds/ hutments were removed and an area of 500 sq. mtrs; restored to its original status. Similar drive carried out at Bharatpur beach and encroachments in the shape of temporary shed and

fencing were removed from land bearing Sy No. 147 recorded as Path.

During the drive on dated 22.03.2022 at Carbyn's Cove junction, Brookshabad village, the road side temporary sheds / gumties and other temporary hutments were removed from land bearing Sy No. 1/P situated at Brookshabad recorded as Government Revenue Land restoring an area of 400 Sq. Mts out of Sv No. 1/P.

It is further submitted that the encroachment eviction drive will continue in coming weeks within Port Blair tehsil.

'Industry Drive & Apprenticeship Mela' to be held at ITI Dollygunj, ITI Arong & VTI Bakultala on April 26

Port Blair, April 23:

The Apprentices Act, 1961 was enacted with an objective to provide training to the apprentices in the industry by utilizing the facilities available therein. The Ministry of Skill Development and Entrepreneurship (MSDE), GoI is the administrative ministry responsible for the implementation of the Act for skill-based trade apprenticeship with the assistance of State/UT Gov-

Apprenticeship training is one of the most efficient way to develop skilled manpower for the industry by using training facilities available in the establishments without putting any extra burden on the exchequer to set up training infrastructure. The unemployed youth, after undergoing apprenticeship training can easily adapt to the industrial environment at the time of regular employment. The other advantages of apprenticeship training are that, it is one of the most important schemes in terms of quality of training, experiential learning and the enhanced employability that it provides and it also the most promising skills delivery vehicle in the industrial / training ecosystem of the country. It

also extended structured and rigorous training programme which helps apprentices becomes skilled and stimulates apprentices a real chance to put skills into practice and helps them to gain confidence in a working environment.

The establishments can engage 2.5 to 15% apprentices of their overall sanctioned strength including contractual staff. A prescribed stipend has to be paid for engaged apprentices. However, the reimbursement of 25% of prescribed stipend, subject to a maximum of Rs. 1500/- per month per apprentice shall be paid by the Government of India (GoI) to all registered establishments who engage apprentices under "National Apprenticeship Promotion Scheme (NPAS)'. The employers having 4 or more workers shall only be eligible to engage apprentices. However, it is mandatory for an establishment to engage apprentices, who have 30 or more number of workers as per the Apprenticeship Act.

As the GoI is promoting the said scheme in a large way, it shall be an obligatory to engage apprentices in every Department/Establishment, so as to provide a platform for unemployed youths for their gainful employment. In this regard, a one day 'Industry Drive and Apprenticeship Mela' to be organized on April 26 from 9.30am to 5pm at ITI, Dollygunj, ITI, Arong and VTI, Bakultala with a view to facilitate onboard of the MSMEs, Industries, PSUs, Govt. Departments, other eligible establishments and registration of aspirational candidates under the National Apprenticeship Training Scheme. This Mela shall give a comprehensive knowledge session on National Apprenticeship Training Scheme for all the stakeholders alongwith new guidelines, increased understanding and clarity on the system, process, roles and structure of implementation helping stakeholders into their outreach and support and key recommendation to plug the gaps in portal, policy performance system to the industry.

All the establishments and aspirational candidates/ students have been requested to register their names at GoI'sweblink https:// dgt.gov.in/appmelaapril22/ and participate in the 'Industry Drive and Apprenticeship Mela' on the above mentioned date and venues.

"The Mangeshkar family avoided mentioning the name of the Chief Minister on the invitation card of the Lata Mangeshkar Award Ceremony. Their role is incomprehensible. This act of the Mangeshkars is an insult to 12 crore Marathi people," Awhad tweeted.

In his speech, PM Modi said Lata Mangeshkar's voice enthralled the audience for over 80 years, from the era of "gramophone, CD, DVD, pen drive, digital music to apps".

"The journey of songs and the world ran through the journey of Lata Didi, who gave voice to five generations of actors and made India proud. Her journey on this planet came to an end at a time when our country is celebrating Azadi Ka Amrit Mahotsav. She gave voice to India, even before its Independence. The 75-year journey of the country was always tied to her 'sur'. Our entire nation is grateful for the contribution of Mangeshkar family to the country. Apart from singing, the passion of 'rashtra bhakti' that was within her, was due to her father," the prime minister said.

ter Deenanath Mangeshkar, the singing legend's father.

The prime minister said he generally stays away from felicitation ceremonies but made an exception to receive the first Lata Deenanath Mangeshkar award named after the legendary singer whom he considered his "elder sister".

"I generally keep myself away from such felicitation ceremonies. I cannot adjust myself (in such programmes). But when an award is named after an elder sister like Lata Mangeshkar, then it becomes an obligation for me to accept it because of the affection and right of the Mangeshkar family over me," he said.

Modi said when he was contacted for this award, he told his assistants to confirm his presence at once.

"I informed my staff that I will plan other things later. I could not say no to such an event. I dedicate this award to all Indians," the prime minister added.

He said Lata didi always used to say that a person becomes great by his deeds and not by age.

"I think we all can learn from her thoughts," the PM added.

Noted musician and Lata Mangeshkar's younger brother Hridaynath Mangeshkar couldn't attend the event as he was admitted to a hospital, his singer son Adinath Mangeshkar said at the function.

The 84-year-old musician, younger brother of Lata didi and Asha Bhosle, will be discharged within ten days, Adinath said without divulging the cause of his hospitalisation.

Modi wished Hridaynath Mangeshkar a speedy recovery at the start of his address.

The Lata Deenanath Mangeshkar Puraskar will be given every year to an individual who has made a "pathbreaking, spectacular and exemplary" contribution to the nation, its people and society, according to the Master Deenanath Mangeshkar Smruti Pratishthan Charitable Trust, which has instituted the award.

right at the middle of Bay of Bengal, which is a gold mine for fisheries but unfortunately we are unable to tap the immense potential of fisheries till date, mostly because of lack of trained manpower and technical expertise.

He said that there is an urgent need to establish a Fisheries College of International Standard in Andaman and Nicobar Islands so that Island youths as well as researchers from India and neighboring countries can get a professional degree from Andaman and also get themselves trained in the field of Fisheries and earn from Local as well as International Mar-

The Member of Parliament pointed out that as per a rough estimate there is about 1. 47 Lakh MT tonnes of fishes available in Andaman and Nicobar Sea but we are able to fish only 32,000 MT of fishes annually and once a Fisheries College is established the trained man power will be able to understand how to carry out deep sea fishing professionally from Andaman and Nicobar Sea, where to market Andaman Fishes and how to export Fishes to other countries.
