Like antibodies keep check on bad cells, State's responsibility to check anti-national forces: BJP chief Nadda

VADODARA, NOV 27 /--/ BJP president JP Nadda on Sunday said like "antibodies keep a check on bad cells", it government's responsibility to maintain vigil on anti-national forces, as he batted for an antiradicalisation announced by his party in its Gujarat assembly polls

Releasing the BJP manifesto for the polls, Nadda on Saturday had announced setting up the cell to identify and eliminate potential threats and sleeper of terrorist organisations and anti-India forces. In an interview with PTI, he said it is the State's responsibility to keep a check on forces working against the country and society. "Like antibodies in

check on bad cells. It is the State's responsibility to keep a check on anti-national cells in the country. Then there are some cells that work underground so this anti-radicalisation cell is required to keep a check on such cells," said the chief of the BJP, which has been in power in Gujarat for nearly 25 years. On the Uniform Civil Code (UCC), which the BJP has promised in several assembly polls, including for the recently held Himachal Pradesh elections and now for Gujarat, Nadda said it is a "national issue" for the party and it is committed to it. "The country's resources and its responsibilities are equal for all. Therefore, the UCC is a welcome step. We would like to implement the UCC in as many states as India) with the BJP's possible," he said.

Cong chief Kharge lambasts Modi; calls him 'chieftain of liars', sympathy seeker

DEDIAPADA, NOV 27 /--/ Congress president Malikarjun Kharge on Sunday called Prime Minister Narendra Modi a "jhoothon ka sardar" (chieftain of liars), and said the latter tries to gain sympathy by calling himself poor and claiming that people abuse him. Addressing a public rally at Dediapada in tribal-dominated Narmada district of pollbound Gujarat, Kharge said he himself comes from the 'poorest of the poor and untouchable caste". "Modiji and (Union Home Minister Amit) Shah ask what Congress did in 70 years? Had we not done anything in 70 years, you would not have got democracy. And people like you who always claim to be poor. I am also poor. I am from the poorest of the poor. I come from the untouchable caste. At least people drink your tea. People do not even drink my tea," he said. "And then you say, I am poor, someone abused me, said something to me, asked what my status is. If you are trying to gain sympathy by saying such things, then (understand) people are now intelligent. They are not that foolish," he said. Asserting that people will listen if you lie once or twice, Kharge asked the PM, "How many times have you

He alleged Modi had indulged in telling "lie after lie" and was accusing the Congress of looting the country while himself standing with the rich. "How many times have you told a lie? Lie after lie. He is a chieftain of liars. And on top of it he says, these Congress people looted the country. You are also looting the land of the poor, not giving land to the Adivasis. Who is destroying land, water and forest? You and the rich people with whom you stand, they are looting us," he alleged. The Assembly polls in Gujarat will be held in two-phases - on December 1 and 5, while votes will be counted on December 8. (PTI)

NCP asks Centre to take action against Karnataka CM over statements on border dispute

MUMBAI, NOV 27 /--/ The Nationalist Congress Party (NCP) on Sunday demanded that the Centre take immediate action against Karnataka chief minister Basavaraj Bommai for allegedly making statements that were disturbing peace in Maharashtra and Karnataka. Earlier this week, Bommai had claimed that 40 villages in Jat taluka of Sangli district in Maharashtra had passed a resolution in the past to merge with Karnataka, and said that Kannada-speaking areas of the state such as Solapur and Akkalkot should join Karnataka. Bommai also condemned the alleged incidents of painting of Karnataka buses with pro-Maharashtra slogans and appealed to the Eknath Shinde government to take immediate steps to stop this. NCP national spokesperson Clyde Crasto said, "Yes, action should be taken against people who caused problems to the buses. But in that case, action should also be taken against Bommai because his unwanted statements on the Maharashtra-Karnataka border issue seem to have influenced the minds of some people who are taking law into their hands and causing disturbance.

Crasto in a statement said the Karnataka chief minister should not have raked up a sub-judice matter and gone a step further by saying that he would claim other districts of Maharashtra as well. "His statements over the last few days are hurting the sentiments of people and making them express their feelings negatively," the NCP leader said. The Central government must take immediate action against Bommai for making statements that disturbed peace in both the states, he said. "Why is the BJP's central leadership not asking Bommai to refrain from making such statements? Do they agree with what he said?" Crasto said. The Maharashtra government has appointed cabinet members Chandrakant Patil and Shambhuraj Desai as nodal ministers to coordinate with the legal team regarding the court case on the border dispute with Karnataka.

Maharashtra, since its inception in 1960, has been locked in a dispute with Karnataka over the status of Belgaum (also called Belagavi) district and 80 other Marathi-speaking villages, which are part of the southern state. Maharashtra has staked claim over the Marathispeaking areas and the matter is pending before the Supreme Court. (PTI)

Fire in Chandni Chowk's Bhagirath market continues to rage for 4th day

NEW DELHI, NOV 27 /--/ The fire at the Bhagirath Palace market in Chandni Chowk continued to rage for the fourth consecutive day on Sunday even after the engagement of more than 150 fire tenders since its outbreak, officials said.

Nine fire tenders are still present at the spot. More than 200 shops have been damaged in the massive fire that broke out in the wholesale market for electrical appliances on Thursday night, the officials said. 'Around 150 fire tenders have been engaged till now. nine of them are still at the spot. Around 200 shops have been affected and while five building have been completely or partially burnt, three have collapsed,' a senior fire department official said. A case under IPC sections 285 (negligent conduct with respect to fire or combustible matter) and 336 (act endangering life or personal safety of others) has been registered against unknown people, the official said. The fire was brought under control by Friday morning but while the cooling process was still underway, the blaze reignited again and turned massive by the evening. The area's narrow lanes and shortage of water posed a major challenge for the firefighters. While traders suspect short-circuit as the cause of the fire, officials said the reason is yet to be ascertained.

On Saturday, Delhi Lieutenant Governor V K Saxena visited the market and said a multidisciplinary committee had been constituted to look into ways to effectively address issues like hanging wires and overloaded circuits. He sought the active involvement of residents and other stakeholders in areas like Chandni Chowk, Sadar Bazar and Paharganj, among others. He has also sought a report within 30 days. According to the fire department, due to the lack of water supply, a remote-controlled machine that was being used in the firefighting operation proved to be less effective. "The narrow bylanes of congested Chandni Chowk made it difficult for the fire tenders to enter the spot. At some places, firefighters were forced to break the barriers which were put up for beautifying the area," said Atul Garg, the director of Delhi Fire Service. (PTI)

Gehlot-Pilot tussle: Congress won't shy away from taking 'tough decisions' to strengthen organisation, says Ramesh

INDORE, NOV 27 /--/ Amid the power tussle between Rajasthan Chief Minister Ashok Gehlot and his former deputy Sachin Pilot, senior Congress leader Jairam Ramesh on Sunday said if needed, the party will not shy away from taking "tough decisions" to strengthen the organisation in

For the Congress, its organisation in Rajasthan is most important, Ramesh, the party's general secretary in-charge of communications, told reporters in Indore during the Bharat Jodo Yatra. Gehlot on Thursday told a TV channel that Pilot is a 'gaddar' (traitor) and cannot replace him drawing a sharp response from his former deputy who said such "mud-slinging" would not help, in an escalation of their rift days ahead of the entry of Rahul Gandhi's 'Bharat Jodo Yatra' into the desert state. Gehlot also said Pilot had revolted against the Congress in 2020 and alleged that he tried to topple the state government. Pilot had hit back at Gehlot to say it was unbecoming of his stature to use the kind of language to attack him and make completely "false and baseless" allegations. Asked about the tussle between Gehlot and Pilot, Ramesh on Sunday said, "The organisation is most important for us. On the issue of Rajasthan, we will decide on a solution which will strengthen our organisation." "For this, if we have to take tough decisions, we will take. If a compromise has to be made (between the factions of Gehlot and Pilot), then it will be done," he said.

Ramesh also said the Congress leadership is considering a proper solution to the Rajasthan issue. "But, I cannot fix any time frame for this solution. Only the Congress leadership will decide the time frame for it," he said. Ramesh further said the Congress needs both Gehlot and Pilot. He also said the Rajasthan CM should not have used certain words in his interview. Speaking on the Rahul Gandhi-led Bharat Jodo Yatra, Ramesh said like other states, it would also be successful in Rajasthan.

The foot march, a mass contact initiative of the Congress, started from September 7 at Kanyakumari in Tamil Nadu. It is currently underway in Madhya Pradesh. On December 4, the yatra will enter Rajasthan, where the Assembly elections are due next year. On the Bharativa Janata Party's promise of the implementation of Uniform Civil Code in its manifesto for the upcoming Gujarat Assembly polls, Ramesh said, "The debate on the UCC should continue inside and outside Parliament." "But, the BJP deliberately raises divisive issues during elections to polarise votes," he alleged. Ramesh said the BJP has raised the issue of UCC to gain in the Gujarat Assembly elections, scheduled on December 1 and 5. "They (BJP) will forget the issue after the elections," he claimed.

The main contest in Gujarat is between the ruling BJP and the opposition Congress, Ramesh asserted and claimed the Aam Aadmi Party's "balloon" will burst after the results are declared. "The media has inflated this balloon. The AAP does not seem strong at the grassroot level in Gujarat," he further claimed. (PTI)

Promises old pension scheme for govt employees by Jan 31

AHMEDABAD, NOV 27 /--Delhi chief minister Arvind Kejriwal on Sunday made a written assertion that the Aam Aadmi Party (AAP) will form government in Gujarat after the upcoming

Assembly polls. also urged government employees in Gujarat to back the AAP promising implementation of the old pension scheme for them by January 31 next year. Addressing press conference in Surat, AAP national convener Kejriwal said his predictions for the Delhi and Punjab Assembly elections came true, and the same will happen in Gujarat

AAP national convener asked government employees seeking the old pensionschemeamongother demands to help his party formgovernment in the state. The Gujarat government had introduced contributory pension scheme (NPS) for employees joining the service on or after April 1, 2005. According to the notification, it will make a matching contribution of 10 per cent of the basic pay plus contributed employees in the NPS fund. Under the Centre's scheme. government will contribute 14 per centagainst an employee's contribution of 10 per cent of his/her salary and DA with effect from April 1, 2019. After protests by employees, the state governmenthadsaidthenew pension will not be applicable to those employees who had joined duty before to increase its contribution in the fund to 14 per cent from the 10 per cent earlier.

The employees have staged massive agitations against the government in Gujarat while demanding restoration of the OPS because they believe the NPS is not in the interest of retiring employees.

Kejriwal said, "By January 31, we will issue a notification implementing the old pension scheme in Gujarat. am not just talking. In Punjab, we have issued the notification." Other contractual employees, policemen, state transport workers, village computer entrepreneurs, anganwadi workers, teachers, health workers, talatis, sanitation workers have different issues related to grade pay, permanent job, increase of wages and transfer posting, he noted.

"I assure them that we will resolve their issues. I request the mall with folded hands thatfor a party to win an election. the support of government employees is important. I would appeal to them to give every single vote to the AAP in postal ballot and canvass for the party during the next three-four days," he said. The BJP was agitated because it was staring at defeat, and the Congress was nowhere in the picture, he claimed. "It is the first time in 27 years that the BJP is so agitated. You go out on a street and ask people whom they would vote for. They would either say the AAP or the BJP. Those who say they would vote for the BJPrevealafterfiveminutes that they and their entire mohalla were going to vote for broom (AAP's poll symbol)," Kejriwal said.

The AAP leader said looking at people's reaction, it appeared everyone was deserting the BJP to vote for the AAP. "We have contested elections in many states, but Gujaratisthefirststatewhere peoplearescared of declaring whom they would vote for. The common man is scared. Second, the Congress voters are nowhere to be found, and third, the BJP supporters are going to vote for the AAP in large numbers," he further claimed. (PTI)

In his early years, Tyaga Mal learnt Gurumukhi, Hindi, Sanskrit and Indian religious philosophy from BhaiBudhhaJi while his father Guru HargobindJi, master of Miri(temporal power) and Piri (spiritual authority) taught him swordsmanship. When He was only 13 years old, he asked his father to allow him into battle, as, his village was attacked by Painde Khan and the Mughals in a battle. During this battle, he fought fiercely, slashing his sword right and left. He came to be known as Tegh Bahadur (Mighty of the Sword).

*GURIJI'S BANI AND SERMONS

Guru Tegh Bahadur meditated at Bakala for about 26 vears 9 months 13 days.(1644 - 1664) .His pious soul received Guruship on 30th March, 1664 when he was living at Baba Bakala. He was a learned spiritual poet, whose 115 hymns are included in the Sri Guru GranthSahibji, the main text of Sikhism . Anandpur Sahib was founded in June 1665 by the ninth Sikh Guru, Guru Tegh Bahadur. Guru Tegh Bahadur contributed many hymns to Granth Sahib including the Shloks near the end of the Guru Granth Sahib. His works include 116 Shabds and 15 ragas. His Bani covers a wide range of topics, such as the nature of God, human attachments, body, mind, sorrow, dignity, service, death and deliverance. His famous saying is:

"Why go to search forests (to find Him). He who dwells in all hearts but remains ever pure, pervades thy heart also. Just as fragrance fills the rose and reflects the mirror, the Lord pervades all without a break; search Him inside

*GURUJI'S SUPREME SACRIFICE

The Mughal Emperor of India then, Aurangzeb attempted to consolidate India into one Islamic nation. In order to achieve this aim, he set out virtually eliminating Hindus from India. In May 1675, Guru Tegh Bahadur Ji was approached by Hindu pandits from the Kashmir region, seeking the Guru's intercession against the forced conversions of Hindus to Islam, Guruji himself would not embrace Islam. He offered to sacrifice everything for the cause of righteousness. Thus, Guruji was imprisoned by Aurangzeb in 1675. Refusing to convert to Islam, Guru Tegh Bahadur Ji was publicly beheaded on the orders of Emperor Aurangzeb. Today Gurudwara Sis Ganj Sahib and Gurudwara RakabGanj Sahib in Delhi stand at the sites of beheading and cremation of Guru Ji's body respectively. A severe storm had come up after the





Gujarat polls: BJP manifesto eyes farmers

The BJP manifesto for next month's Gujarat Assembly elections has a special focus on the agriculture sector, to keep farmers in good humour and get their votes. Learning from experience, the saffron party has laid special emphasis on issues relating to farmers in poll-bound Gujarat this time round. The ruling party has promised Rs.10,000 crore fund for agri-marketing infrastructure and a whopping Rs.25,000 crore for expansion of irrigation facilities in South Gujarat, besides setting up two sea food parks in Saurashtra, the blue economy industries corridor. Agrarian distress, especially in Saurashtra region, among other factors, had led to a drop in the BJP seat tally from 115 in 2012, to a double-digit figure of 99 in the 2017 state assembly elections. There are 182 seats in the Gujarat Assembly. The BJP, when re-elected, will provide Rs 10,000 crore under Gujarat Krishi Infrastructure Kosh to develop Khedut Mandis, modern Agricultural Produce Market Committees (APMC), sorting and grading units, cold chains, warehouses, primary processing centres. It will expand the existing irrigation network through projects such as Sujalam Sufalam, SAUNI, lift irrigation projects, micro irrigation, drip irrigation. With the additional budget of Rs 500 crore, the party will strengthen the Gaushalas here and set up 1,000 additional Mobile Veterinary Units. The widespread losses to the dairy sector due to the lumpy skin disease has added to the party's worries as the state has lost an estimated 5,800 cattle. Earlier this year, farmers in the state protested against inadequate power supply, rallied against low remuneration for certain products and demanded a minimum support price for salt. The BJP also promised to build seafood parks in South Gujarat and Saurashtra, build the country's first Blue Economy Industrial Corridor and strengthen the fishing-related infrastructures.

In the run up to next month's assembly elections in Gujarat, the BJP intensified its campaign to ensure that farmers get the full benefits of state and central schemes for the agricultural sector. It is being done to ensure the party does not lose out on support from the farming community like it did in the previous election. The BJP is relying on initiatives such as the Na Mo Kisan Panchayat launched by party president JP Nadda last month to create awareness about schemes for farmers, besides incentives and financial aid to adopt technology such as drones to meet challenges of labour shortages. In 2017, when the party's tally dropped to 99 from 115 in 2012, the loss was attributed to several factors. The Patidar agitation and the anger against the implementation of Goods and Services Tax were cited as some of the reasons. But, farm distress, particularly in the Saurashtra region was the most significant. The condition of farmers in the region had worsened by rainfall deficit and drought that the state faced in 2016 and 2017. There was also some anger against the government for not being able to implement minimum support price for cotton and groundnut produce that time. Though those issues have now been resolved, problems like water and power shortages still persist in certain areas, coupled with low returns from certain items such as salt, which have the potential to upset the ruling party's apple cart. Gujarat Assembly polls will be held in two phases -- December 1 and 5. Counting of votes will be taken up on December 8.

Domestic and sexual violence against women has reached new peak

The United Nations' call to observe November 25 as an International Day for "Elimination of Violence against Women" has got wide media coverage after the UN Secretary General, Antonio Guterres, presented a chilling fact sheet that across the world every 11 minutes a woman or a girl is killed by an intimate partner or family member. He called violence against women and girls as the most pervasive human rights violation in the world.

Domestic violence is an undeclared war against women which has taken more victims through the years than any conventional war. So-called developed countries, that are the epicentres of capitalism, hold the worst record according to country-wise data available on the UN website. In India the situation is grave. On an average, every day the National Crime Bureau 2021 reports that 86 women are raped and whose cases are registered. Every hour there are 49 offences committed against women registered under the IPC, every day on an average 18 women lost their lives in dowry related domestic violence-6,589 dowry deaths registered in a single year. The National Family Health Survey-5 shows that one third of all women surveyed, said they had faced domestic or sexual violence

These are statistics which should make any country hang its head in shame. But in India there has not been a single word from the government. Some people have described this as a pandemic—in fact violence against women has become endemic in our social systems. Dalit women face the worst kind of violence inflicted by aggressive casteist practices. One of the causes is that perpetrators of violence have an immunity granted to them by a casteist and patriarchal system due to which 75 per cent of perpetrators of violence against women remain unpunished. This low rate of conviction is directly a result of biased investigations by the police, long delays in the

court system and social pressures on the survivors of violence to compromise. Cultures that normalise domestic violence have got new life under the present regime with the promotion of notions of the ideal woman as one who adjusts to violence by her husband or his relatives as part of the way a good woman behaves. The refusal of the government to recognise marital rape as a criminal offence on grounds that it would be disruptive of the family, is a reflection of that mentality. This manuwadi culture is a big barrier to democratise family relations and to protect women's equality.

Even more dangerous is the communalisation of every rape case depending on the religious affiliation of the victim and the accused. In The Bilkis Bano case the affidavit of the Gujarat government in the petition opposing the release of the gang rapists and killers, specifically mentions that before their release sanction was given by the union home ministry. In other words, home minister Amit Shah is directly involved in the release of these killers and rapists in a most heinous crime based on their religion. their political affiliation. It is no coincidence that it is when Muslims are the accused that the ruling party and its sanghcohorts, remember the need for justice for women.

This was exemplified by the recent and highly condemnable statement of the Assam Chief Minister, Himanta Biswa Sarma, in reference to the Shraddha Walkar case. He said that you need to vote for Modi, "a strong man, "to prevent Aftabs in every city." That the horrific crime of murdering and dismembering the body of Shraddha was perpetrated by her Muslim partner, is used for the most vicious communal propaganda and claims of love jihad. Around the time this terrible crime was detected in Delhi, in Azamgarh in Uttar Pradesh, a young woman was killed and cut into six parts by her exboyfriend. Another woman in Sitapur district was killed by her husband and her body hacked into pieces and dumped in a field.

Not a single word was uttered by the BJP leaders in both these cases as the accused and the victims belonged to the Hindu community. When dalit girls are raped or killed by upper caste men, not a word is said. This communalisation of violence against women in India is a highly dangerous weapon which will further subvert the judicial process and rendering of justice. It is clear that capitalism and its social structures have supported and helped patriarchal notions and practices to grow across the world, based on a social and cultural system which promotes the subordinate status of women to exploit cheap female labour. It is on this fundamental basis that women across the capitalist world face discrimination and violence, some more than others. In India, the misogyny and patriarchal values that prevail are being reinforced by the open advocacy of manusmriti and caste hierarchies by the rightwing Hindutya forces. This in turn strengthens the forces in the minority communities who enforce further subordination of women.

The struggle to defend the rights of women guaranteed in the constitution and to enforce the laws against violence on women must be waged with renewed vigour. The Left and democratic forces must make this an important part of their ongoing platform of action. (IPA)



A Pan-Indian Law against 'forced' conversions should respect right to privacy

The restrictions provided under Article 25 were used by the court and it was observed that because "forced conversions" have an adverse impact on public order, any right to convert to a different religion is prohibited by Article 25.

Public order, morality, and health are constraints on the right granted by this article, and therefore "it cannot be predicted that freedom of religion can have no bearing what-so-ever on the maintenance of public order or that a law creating an offence relating to religion cannot under any circumstances be said to have been enacted in the interests of public order."

Therefore, the validity of both the acts was upheld by the court and the competence of legislature to pass such laws was accepted and upheld as a legal exercise of legislative authority under the exception of public order to Article 25 of the Constitution, stating that the right to convert others is not included under the ambit of this article and that forcible conversions may incite communal enmities that lead to a breach of the public order.

The petition filed by Upadhyay seeks directions of the court against the prevailing forced conversions and the gap in criminal legal system to persecute the perpetrators of the crime of forceful conversion. It says that a special law must be enacted against forced conversion, or the act should be made an offence under the Indian

Mihir Nigam Penal Code. Acknowledging the gravity of laws requiring a person converting to give the issue, a Justice M.R. Shah-led division bench of the Supreme Court asked the Union Government to step in.

The issue of forced conversion needs enough deliberation on part of the Union Government, as the issue encompasses many issues and the right of individuals is at stake, which cannot be constrained without reasonable grounds and enough

The common view advanced by intellectuals in this regard is that the forced conversions would invariably fall under the purview of the Indian Penal Code, and that an anti-conversion law would only serve to impede voluntary conversions, particularly those made by lower caste individuals.

The main criticism that these anticonversion laws attract is that they breach the right to privacy of an individual. A person changing their religion would like to make public their conversion on their own terms or when they think it is the right time to make public the same. However, almost all the states have enacted anti-conversion notice to the competent authority and public of the same

Section 5 of Madhya Pradesh Dharma Swatantrya Adhiniyam states that intimation is to be given to District Magistrate with respect to conversion. The section provides that: "Whoever converts any person from one religious faith to another either by performing himself the ceremony necessary for such conversion as a religious priest or by taking part directly or indirectly in such ceremony shall, within such period after the ceremony as may be prescribed, send an intimation to the District Magistrate of the district in which the ceremony has taken place of the fact of such conversion in such form as may be prescribed." (emphasis supplied).

Just like Madhya Pradesh, Himachal, Jharkhand, Gujrat, Chhattisgarh, and Uttarakhand have also incorporated such provisions under their respective anticonversion laws, which require converts to give notice/intimation to the authority before/after a prescribed time-period. The Himachal Pradesh High Court, in Evangelical Fellowship of India and Anr.versus State of Himachal Pradesh (2012), declared a provision of the Himachal Pradesh Freedom of Religion Act, 2006 as unconstitutional because it required the citizens to notify the authorities of their desire to convert to other

Recently, in an order regarding Section 10 of the Madhya Pradesh Freedom of Religion Act, 2021, the Madhya Pradesh High Court, in Rev. Suresh Carleton &Ors. versus The State of Madhya Pradesh, has supplied emphasis to an observation of the Supreme Court in Paragraph 298 of its judgment in K.S. Puttaswamy case that the Constitutional right to the freedom of religion under Article 25 has implicit within it the ability to choose a faith and the freedom to express or not express those choices to the world. Therefore, even if the Union Government goes ahead with formulating a special law on the subject of 'forced conversion,' all the problems and issues regarding the state-enacted anticonversion laws must be taken into consideration.

The special law should be coherent with the fundamental rights guaranteed under the constitution and should not be based on vagaries. The law should not appear to be arbitrary or targeting a particular community in furtherance of political motives or ideologies. (IPA)

relatives. He assured them that the accused will be arrested as soon as possible following which the dharna was called off and postmortem of the bodies Additional Superintendent of Police Anil Meena said additional policemen have been deployed in the area to maintain law and order and different teams have been formed to locate and arrest the accused involved in the triple murder.

In October also, a man and his two sons including a constable were killed in a group clash in Bhusawar area of Bharatpur. The reason behind the murders was also a petty issue. Minister Vishvendra Singh said that it is an alarming thing that people are losing patience on small issues.

Man's resolve to recharge groundwater pays off, 3,500 water bodies dug in 7 months

In May, Dwarika Prasad Semwal started going door to door in Chamkot village in Uttarakhand, convincing people to dig pits near their homes to store rainwater.

Seven months on, his perseverance has paid off. A total of 3,500 water bodies have come up over an area of 3 sqm in the village as a result of Semwal's persistent efforts. However, involving people in the campaign called 'Kal Ke Liye Jal' (Water for tomorrow) was not easy. "They seemed attentive as I urged them to make a small

significant contribution to save water, recharge the receding water table underground and offer birds and animals a means to quench thirst by digging ponds. "But the response initially was rather lukewarm. It got me thinking what I could do to lure them to the campaign in larger numbers," said Semwal, who also heads the Himalayan Paryavaran

Jadibooti Agro Sansthan. Soon an idea dawned upon him. Semwal began asking people to dig water bodies in memory of a near and dear one or to mark an important occasion in the family like a marriage anniversary or a birthday. "I dug two water pits in memory of my two nephews to show the way and people followed. If blessed to be a part of a

some did so to celebrate their children's birthdays, others did it to immortalise ancestors," Semwal said. On Semwal's request, Chief Minister Pushkar Singh Dhami allowed him to dig a pond on his birthday in September this vear in the forest of Dudhli in Dehradun. Connecting the campaign with filial sentiments struck a chord with people as they began to join the campaign in larger numbers, Semwal

"I am satisfied that our efforts are bearing fruit. As many as 3,500 ponds or water pits have come up already in Chamkot village and the process continues. "We now plan to dig 1,000 such ponds in Dehradun as its receding groundwater levels are causing concern among experts," he said.

At least 70 women volunteers from the 'Ganga Sakhi Sangathan' have joined the campaign. "We are happy to join this campaign for saving water. Together, we have created 3,500 ponds. We feel enthused to extend our activities to new areas," the president of Ganga Sakhi Mahendri Sangathan, Chamoli, said.

Ram Kumar Chamoli, a of member organisation, said, "We feel save water campaign like this in the memory of our ancestors." Parvati Devi, a village, said she dug two ponds in the name of her family deity and ancestors. "This initiative has given us a chance to honour our forefathers and fulfil a duty to society."

Each the participants is not just digging pits but also contributing Rs 50 per to fund the month campaign, Semwal said. The average size of such ponds or water pits is supposed to be three to five feet wide and 1.5 feet deep. "But we have kept it flexible and it depends on the availability of space. If the participants lift a spade and a shovel to dig a pit that's enough," he said. Not just recharging the water table, if ponds are dug deep in the forests, water will be available for wild animals in their natural habitats, reducing chances of man-animal conflicts,

Semwal said. Such water bodies can help in controlling forest fires and increase the green cover, he said. However, since permission from authorities is needed to dig such water bodies in forest areas, laws may have to be relaxed so that this initiative can be extended across the state, Semwal added. (PTI)

In the current financial year, 1,939 children below the age of six years have been identified with hearing impairment, Sudhakar said. 'The Karnataka government will gift to 500 children below the age of six who were

born with congenital hearing loss by providing them with free Cochlear Implants," the minister said in a statement. He added that the state health department is working on a mission mode with a slogan 'Health for All' to cover every aspect of health and well-being and a new initiative has been planned to make Karnataka from impairments Special attention has been given to eliminating hearing loss in children under six years of age, Sudhakar further said. Most of them have suffered from congenital deafness and

According to Sudhakar, a cochlear implant is a small electronic device that helps children with severe and profound hearing loss hear

Migratory birds from different countries have started arriving at Punjab's Harike wetland, with around 40,000 winged visitors reachingthenorthernIndia's largest wetland so far. More than 90,000 migratory birds of over 90 different species from different countries, including Siberia, Mongolia, Kazakhstan, Uzbekistan, Russia and other parts of the world arrive at the Harike wetland every year after water bodies get frozen in their native places in winter. Harike wetland, spread over 86 square kilometers in Tarn Taran, Ferozepur, and Kapurthala districts, serves as a home to rare species of migratory water birds during the winter season. The wetland is situated on the confluence of Sutlej and Beas rivers.

According to an official

Punjab's preservation department, around 40,000 migratory birds have so far arrived at Harike wetland, which is also known as 'Hari Ke Pattan'. The number of migratory birds is expected to rise in the coming weeks, said the official. Winged guests like spoonbills, painted storks. common pochard, ruddy shelduck, gadwall, bar headed geese, greylag geese and common teal have arrived, said Gitanjali Kanwar, coordinator, World Wild Fund for Nature (WWF) India. "Shoreline birds like gulls, terns, sandpipers and plovers are the first ones to arrive," she further said. "The migration of birds this time is a bit late but more birds will be arriving in the coming days," she added. "We are waiting for flocks of greylag geese and redcrested pochard. They have come but in small groups,' said Kanwar.

Congress and like-minded parties view terrorism as shortcut to achieve success, remain silent on big terror attacks: PM Modi

KHEDA, NOV 27/--/Remembering the 26/ 11 Mumbai terror strike, Prime Minister Narendra Modi on Sunday said Gujarat and the country need to be "alert" about Congress and like-minded parties which keep mum on "big terrorist attacks" to not offend their vote bank. Addressing a rally in Kheda district in Gujarat where Assembly elections are scheduled for December 1 and 5, the prime minister said Congress and many likeminded parties view terrorism as a shortcut to achieving success.

Terrorism is not over yet and the politics of the Congress has not also changed. The fear of terrorism will remain till appeasement politics continues. "Congress views terrorism from the prism of vote bank, Not only Congress but many like-minded parties have come up now who view terrorism as a shortcut to achieve success and this small party's hunger for power is even bigger," he said without naming the "small party". The prime minister said the mouths of these parties remain "locked when big terrorist attacks take place so that their vote bank is not offended. They even go to courts from the back door to save terrorists". "When Batla House encounter took place, a Congress leader cried for terrorists. Gujarat and the country should remain alert from such parties," he added. The 2008 encounter near Delhi resulted in the deaths of two terrorists hiding in a flat in the Batla House area in Okhla and a police officer. "Your one vote in 2014 (Lok Sabha elections) strengthened the fight against terrorism. Now forget about terror attacks in our cities, they (India's enemies) think 100 times before even conducting such attacks on our borders," the PM said, adding they know India will hit by entering their homes ("ghar main ghus ke marege"). In an apparent reference to Delhi

Chief Minister Arvind Kejriwal, the PM said Congress and like-minded parties had raised doubts about surgical strikes and the ability of our armed forces. "Those countries which took terrorism lightly are in clutches of terrorism. Terrorism is not over yet. The politics of the Congress party has also not changed, while small parties are also indulging in vote bank politics," he said. The PM said, "till the vote bank politics remains the fear of a resurgence of terrorism is also 'We have to save Gujarat from those playing the dirty game of terrorism. This is a long fight and we need your support," Modi said. He said the 2008 Mumbai terror attack was the "epitome of terrorist attacks in the country". "I pray for the departed souls," the PM said, a day after tributes were paid to commemorate the 14th anniversary of the 26/11 strike unleashed by 10 Pakistani terrorists in which 166 people were killed and several injured. "Gujarat also faced serial blasts in Ahmedabad and Surat and many people had lost their lives," he said. "In Gujarat, we kept track of terrorist sleeper cells and arrested terrorists," the PM said referring to the action taken by the BJP government when he was the chief minister. 'But instead of targeting terrorists, the (erstwhile) Congress government (UPA) was interested only in targeting Narendra Modi only," he said. Attacking Congress president Mallikarjun Kharge who is campaigning in Gujarat on Sunday, Modi said Kharge had said he will show "Modi his aukat (status)". 'Today Congress president is in Gujarat. He has been sent here by Soniaben (Sonia Gandhi). He came here and said he will show Modi his aukat. I have no status, I was born as a common man. Let us see how he shows me my aukat," the prime minister added. (PTI)

Indore Commissioner of Police H C Mishra said 1,400 personnel have been deployed in the city to provide security to the vatra and barricades have been put up at various places. Twelve dilapidated houses in the densely populated Rajwada area with narrow streets have been temporarily evacuated to avoid the possibility of any untoward incident during the march, he said. Earlier, a sweet shop in Juni area of Indore received an anonymous letter by post on November 17, threatening bomb blasts in Indore city during the yatra. The letter, which referred to the 1984 anti-Sikh riots, had also threatened assassinations of Rahul Gandhi and MP Congress chief Kamal Nath. The police had arrested a person in this connection. The Congress's Bharat Jodo Yatra, a mass contact initiative, will take a night halt at Chimanbagh Ground in the city, officials said. As per the initial plan of the Congress, Gandhi and other yatra participants were to be accommodated at the city's Khalsa Stadium. But the plan could not materialise following a controversy. A row had erupted after Kamal Nath, facing allegations in connection with the 1984 anti-Sikh riots, was felicitated by organisers at a Sikh religious event held at Khalsa College in Indore on November 8. After Nath left the venue, famous kirtan singer Manpreet Singh Kanpuri had lashed out at the organisers for inviting the Congress leader. (PTI)

Protests against COVID lockdowns intensify in China; Protestors shout anti-Xi Jinping slogans

BEIJING, NOV 27/--/China's rare public protests opposing stringent COVID lockdowns turned political on Sunday with protestors shouting slogans against President Xi Jinping and the ruling Communist Party, as the demonstrations spread to the university campuses in Beijing and Nanjing.

Shanghai, where thousands of protestors converged at the Wulumuqi Road - which is named after Xinjiang provincial capital Urumqi - on Saturday night, witnessed fresh demonstrations on Sunday despite the heavy presence of police. The protests, which began in the morning, intensified with the participation of hundreds of people by mid-afternoon, Thomas Hale, Correspondent of the Financial Times, who was present at the protest site, told BBC. According to videos posted on social media about the protests in Shanghai, people were heard openly shouting slogans such as "Xi Jinping, step down" and "Communist party, step down", the BBC report said. Hale said the protests are extremely significant as the politics of COVID policies reflected wider political frustrations including the slowing down of the economy. Elsewhere protesters held blank white banners, while others lit candles and laid flowers for the

victims in Urumqi, where 10 people were killed in a fire at a building reportedly under Covid lockdown on Thursday. Observers say that the latest political protests appeared to be in continuation of "banner protest" in Beijing last month ahead of the CPC's once-in-a-five-year Congress which elected 69-year-old Xi for an unprecedented 3rd five-year term. The anti-lockdown protests appear to be posing a major challenge for Xi, just over a month into his third term in power. Political protests opposing the CPC and its leadership are very rare in China while the country witness sporadic agitations over various issues. As such criticism of the party and leadership could result in harsh penalties. Videos posted on social media showed police arresting several protesters in Shanghai amid protests against their detention from the angry crowd. Also, students' protests broke out in the prestigious Tsinghua University in Beijing as well as Communication University in Nanjing. Photos and videos posted online showed students holding vigils for the Urumqi fire victims and launching protests at universities in Beijing and Nanjing. Students said hundreds of people took part in one such demonstration in Tsinghua University where they held up blank sheets of paper - an act which has become a

symbol of defiance against Chinese censorship. One protester in Shanghai told the BBC that he felt "shocked and a bit excited" to see people out on the streets, calling it the first time he'd seen such large-scale dissent in China. He said lockdowns made him feel "sad, angry and hopeless", and had left him unable to see his unwell mother. who was undergoing cancer treatment. A female demonstrator said that police officers when asked how they felt about the protests, and the answer was "the same as you". But, she said, "they wear their uniforms so they're doing their job." Shanghai, a city of over 25 million, endured weeks of COVID lockdowns in April sparking protests. With protests over lockdowns of dozens of apartment buildings intensifying, the government stepped back on Saturday from enforcing lockdowns in Urumqi, the provincial capital of Xinjiang. During the weekend. Urumqi witnessed a huge demonstration in which many Han Chinese nationals took part along with Uygur Muslims. Urumqi authorities on Saturday said the city would lift coronavirus restrictions "in phases" after footage surfaced online showing rare protests against a threemonth lockdown, Hong Kong-based South China Morning Post reported on Sunday. Members of Indian diaspora protest outside Pakistani Consulate in New York on 26/11

NEW YORK, NOV 27 /--/ Several members of the Indian diaspora protested outside the Pakistani Consulate here on the 14th anniversary of the Mumbai terror attacks, demanding that perpetrators of the dastardly attack be brought to justice.

Raising chants of Vande Mataram' and Bharat Mata ki Jai', the people held placards that read Mumbai 26/11. We Won't We Won't Forget' and #SanctionPakistan.' They also had a digital van parked outside the Consulate that flashed images of 26/11 mastermind Hafiz Saeed and terrorist Ajmal Kasab as well as images of a burning Taj hotel in Mumbai when terrorists attacked the landmark building. The Mumbai terror attack which drew widespread global condemnation began on November 26 and lasted until November 29, 2008. A total of 166 people, including several other foreign nationals, were killed and more than 300 others wounded. Nine Pakistan-based LeT terrorists were killed by the Indian security

Ajmal Kasab was the only terrorist who was captured alive. He was hanged four years later on November 21, 2012. "We request all like-minded countries to come together and put sanctions on Pakistan until terrorists are brought to justice," said

Shashank Telkikar, who was among the diaspora members at the protest. Ravi Shankar, another protester, said that the Indian diaspora gathered in front of the Pakistan Consulate to protest against the dastardly acts of state sponsored terrorism, adding that "we will never forget or forgive." Vilas Reddy said all nations should come forward and unite to fight against terrorism and Pakistan should be put back on the Financial Action Task Force (FATF) black list.

Srikant Venkat said "we honour the sacrifices" made during the 26/11 terror attacks by "our brave martyrs who laid down their lives" while protecting others. Last week, just days before the 14th anniversary of the 26/11 Mumbai attacks. India's Permanent Representative to the UN Ambassador Ruchira Kamboj had said "Terrorism continues to pose a grave threat to international peace and security, as ISIL and Al-Qaida affiliated and inspired terrorist groups, particularly in Asia and Africa continue to operate targeting civilians and security forces. Lest we forget, in November 2008, 10 terrorists entered the city of Mumbai through sea route from Pakistan, ravaging the city for 4 days, killing 166 people, including 26 foreign nationals." (PTI)

UK marks 26/11 Mumbai attacks anniversary with tributes, protests



LONDON, NOV 27 /--/ Sombre musical, floral tributes and anti-terrorism protests in the UK commemorated the 14th anniversary of the Mumbai terror attacks that claimed 166 lives in 12 coordinated strikes across the city.

The High Commission of India in London hosted a special homage on Saturday, replete with a photography exhibition and snapshots from November 26, 2008, a shrine to the victims and tributes attended by members of the Indian diaspora and senior parliamentarians. A film depicting the message of Prime Minister Narendra Modi, voices of many Mumbaikars and foreign tourists caught in the attacks, including at the city's iconic Taj Palace Hotel, was followed by a violin recital by musician Sunita Bhuyan. "These were real people, with real families with real hopes and aspirations, all of which were cut short," said Indian High Commissioner Vikram Doraiswami, in his address to the gathering. "We salute the police personnel, the members of the National Security Guard (NSG) who

Let us remember the many who lost their lives doing what was daily for them Every one of us remembers and commemorates on this day the courage, fortitude and resilience of Mumbai and every citizen of the world who has known terror and has had to see it in its face and has not blinked but has

stared back," he said. The theme of the commemoration was around "never forget, never forgive and never again" and also included messages from Britain's members of Parliament from across party lines. "There is one strong message that we must all take away: that terrorism will never win because we will always stand in the face terrorism perpetrators of terrorist activities. That is the one thing that unites us all," said Priti Patel, Indian-origin Conservative Party MP and former UK Home Secretary. "We must all pull together to defeat terrorism and today. together we say: never again," said Catherine West, Labour MP and Shadow Foreign Minister. Indian student in Canada dies after being struck and dragged by pickup truck

General Mirza takes charge as Pak's new CJCSC

RAWALPINDI, NOV 27 /--/ Pakistan Army General Sahir Shamshad Mirza on Sunday took charge as the Chairman Joint Chiefs of Staff Committee (CJCSC) in a ceremony at the Joint Staff Headquarters here. According to the Inter-Services Public Relations (ISPR) military's media wing, a "smartly turned-out" joint services guard presented the salute to Gen Mirza after he arrived at the venue. He also reviewed the guard of honour and marchpast. A large number of serving and retired officers from the tri-services as well as the former CJCSC also attended the ceremony. it added. Gen Mirza took charge after the former chairman of the Joint Chiefs of Staff committee, Gen (retd) Nadeem Raza, hung up his boots a day earlier. The CJCSC is the highest authority in the hierarchy of the armed forces but the key powers including mobilisation of troops, appointments and transfers lie with the Chief of Army Staff (COAS) which makes the person holding the post the most powerful in the military.

On Thursday, President Arif Alvi promoted Lt Gen Syed Asim Munir to the rank of General with immediate effect and appointed him as Chief of Army Staff (COAS), ending intense speculation over the most powerful position in the coupprone country, where the military wields considerable power in matters of security and foreign policy. The President also promoted Lt Gen Mirza to the rank of General with immediate effect and appointed him as Chairman Joint Chiefs of Staff Committee (CJCSC) with effect from November 27. Gen Munir and Gen Mirza were the first and second on the seniority list, respectively. Therefore, both key slots went to the most-senior generals. Lt Gen Mirza, who hails from the Sindh Regiment, has had an impressive career in the army, particularly in senior leadership positions during the past seven years.

He came to prominence as directorgeneral military operations (DGMO) during the last two years of Gen Raheel Sharif, the COAS from 2013-16. In that role, he was part of Gen Sharif's core team at GHQ, which supervised the military operation against the Tehreek-i-Taliban Pakistan (TTP) and other militants in North Waziristan.

Further, he was closely involved in the Quadrilateral Coordination Group (QCG) that brokered intra-Afghan talks involving Pakistan, China, Afghanistan and the United States. Besides, he was also a member of the Sartaj Aziz-led committee on reforms for Gilgit-Baltistan. After his promotion to the three-star rank, he was appointed chief of general staff, effectively making him the second-most powerful person in the army after the COAS. In that role, he was closely engaged in crucial decision-making related to national security and foreign affairs. He also joined former foreign minister Shah Mehmood Qureshi in strategic talks with Chinese Foreign Minister Wang Yi in 2021.

In October 2021, he was posted as Corps Commander Rawalpindi to enable him to acquire operational experience and become eligible to be considered for the top posts. The powerful Army, which has ruled Pakistan for more than half of its 75-plus years of existence, has hitherto wielded considerable power in matters of security and foreign policy. (PTI)

Venezuela's govt, Oppn resume talks; US eases sanction

MEXICO CITY, NOV 26 /--/ Venezuela's government and its opposition on Saturday agreed to create a U.N.-managed fund to finance health, food and education programs for the poor, while the Biden administration eased some oil sanctions on the country in an effort to boost the newly restarted talks between the sides. The agreement signed in Mexico City by representatives of President Nicols Maduro and the opposition, including the faction backed by the United States and led by Juan Guaid, marked the resumption of long-stalled negotiations meant to find a common path out of the South American country's complex crisis. The U.S. government, in response, agreed to allow oil giant Chevron to pump Venezuelan oil. The broad terms of the agreement for the United Nations-managed social fund were announced by the head of a group of Norwegian diplomats guiding the negotiations. Venezuelan resources held in the international financial system will be directed to the fund, though neither side in the talks nor Norway's facilitator, Dag Nylander, said whether the U.S. or European governments have agreed to allow frozen assets to be funneled to the new mechanism. "In line with UN norms and procedures, (the fund's) objective would be to support the implementation of social protection measures for the Venezuelan people," Nylander said. "The parties have identified a set of resources belonging to the Venezuelan state frozen in the international

financial system to which it is possible to

progressively access, understanding the need to obtain the authorizations and approvals" from foreign institutions and

A U.N. report published earlier this year estimated humanitarian needs at 795 million to help about 5.2 million people in Venezuela through health, education, water and sanitation, food and other projects. Under President Donald Trump, the U.S. ramped un economic sanctions against Venezuela and granted Guaid authority to take control of bank accounts that Maduro's government has in the Federal Reserve Bank of New York or any other U.S.-insured banks. Guaid declared himself Venezuela's interim president in January 2019, arguing that his capacity as then-president of the country's National Assembly allowed him to form a transitional government because Maduro had been re-elected in a sham vote in late 2018. Dozens of countries, including the U.S., Canada and Colombia, recognized him as Venezuela's legitimate leader. European banks also hold Venezuelan frozen assets. About 7 million people have left Venezuela amid a complex political and humanitarian crisis. Three-quarters of those who remain in the country live on less than 1.90 a day, an international measure for extreme poverty.

Maduro's delegates walked away from negotiations in October 2021 after businessman Alex Saab was extradited on money laundering charges from Cape Verde to the U.S. Maduro conditioned a resumption on the release of Saab. (AP)

Imran Khan claims 3 shooters tried to kill him in Wazirabad

ISLAMABAD, NOV 27 /--/ Pakistan's ousted prime minister Imran Khan has claimed that there were three shooters involved in the failed assassination attempt on him during a protest march in the eastern city of Wazirabad earlier this month.

The chairman of the Pakistan Tehreek-e-Insaf (PTI) party suffered

bullet injuries in the right leg when the gunmen fired at him Punjab's Wazirabad area on November 3, where he was leading the march against the



government to press for snap elections. Addressing a massive rally of his party on Saturday night in this garrison city, which houses the headquarters of the powerful Army, Khan said the two attackers previously identified were the one who fired at him and other PTI leaders and the second shooter fired at the container's front, while the third attacker was tasked to eliminate the first gunman. Khan, 70, claimed that this third shooter actually killed a person at the rally while trying to kill the would-be assassin. Addressing the nation from the Shaukat Khanum Hospital in Lahore a day after the attack, Khan had said he was hit by four bullets in his right leg by two shooters.

He said he was on a container when a "burst of bullets" was directed at him. "Then a second burst came, there were two people," he said. Khan, in his first in-person address to the party workers after the attack, also alleged that "three criminals", who were behind the failed assassination attempt, are waiting to target him again. He has repeatedly alleged that Prime Minister Shehbaz Sharif, Interior Minister Rana Sanaullah and ISI Counter Intelligence Wing head Maj-Gen Faisal Naseer were behind the attack on him. Khan also announced to continue his protest until new elections were announced. Elections are not due in Pakistan until the term of the current National Assembly gets over in August 2023. "The movement of Haqeeqi Azadi will continue until genuine freedom is achieved." he said, adding that the moment would come once new elections were held. Khan was ousted from power in April after losing a no-confidence vote in his leadership, which he alleged was part of a US-led conspiracy targeting him because of his independent foreign policy decisions on Russia, China, and Afghanistan. The US has denied the allegations. He is the only Pakistani prime minister to be ousted in a noconfidence vote in Parliament. The term of the current National Assembly will end in August 2023. (PTI)

Pockets of shelling across Ukraine as wintry warfare looms

KHERSON, NOV 27 /--/ Shelling by Russian forces struck several areas in eastern and southern Ukraine overnight as utility crews continued a scramble to restore power, water and heating following widespread strikes in recent weeks, officials said Sunday. With persistent snowfall blanketing the capital, Kyiv, Sunday, analysts predicted that wintry weather bringing with it frozen terrain and gruelling fighting conditions could have an increasing impact on the direction of the conflict that has raged since Russian forces invaded Ukraine more than nine months ago. But for the moment, both sides were bogged down by heavy rain and muddy battlefield conditions in some areas, experts said. After a blistering barrage of Russian artillery strikes on at least two occasions over the past two weeks, infrastructure teams in Ukraine were fanning out in around-the-clock deployments to restore key basic services as many Ukrainians dealt with only a few hours of electricity per day if any. Ukrenergo, the state power grid operator, said Sunday that electricity producers are now supplying about 80 per cent of demand. That's an improvement from Saturday's 75 per cent, the company says.

The Institute for the Study of War, a think tank that has been closely monitoring developments in Ukraine, said reporting from both sides indicated that heavy rain and mud have had an impact but wider freezing expected along the front lines in coming days could play a role. "It is unclear if either side is actively planning or preparing to resume major offensive or counter-offensive operations at that time, but the meteorological factors that have been hindering such operations will begin lifting," it said in a note published Saturday. ISW said Russian forces were digging in further east of the city of Kherson, from which they were expelled by Ukrainian forces more than two weeks ago, and continued "routine artillery fire" across the Dnipro River. In the eastern Donetsk region, five people were killed in shelling over the past day, according to governor Pavlo Kyrylenko. Overnight shelling was reported by regional leaders in the Zaporizhzhia and Dnipropetrovsk areas to the west, Kharkiv governor Oleh Syniehubov said one person was killed and three wounded in the northeastern region. A day earlier, a long column of cars, vans and trucks caravanned away from the recently liberated city of Kherson after intense shelling in recent days and amid concerns more pummelling from the Russian forces nearby could loom again in coming days. "The day before yesterday, artillery hit our house. Four flats burned down. Windows shattered," said city resident Vitaliy Nadochiy, driving out with a terrier on his lap and a Ukrainian flag dangling from a sun visor. "We can't be there. There is no electricity, no water, heating. So we are leaving to go to my brother." (AP)

Counter-terrorism, reformed multilateralism India's key priorities during its UNSC presidency

UNITED NATIONS, NOV 27 /--/ Countering terrorism and reformed multilateralism will be among the key priorities for India as it assumes the monthly presidency of the UN Security Council from December 1, culminating its two-year tenure as non-permanent member of the 15nation powerful body.

According to the UNSC rules of procedure, the Council presidency rotates between each of the 15 members of the UNSC, in alphabetical order. "For us, in the December Presidency, our priorities will be countering terrorism for which we have very successfully built a good narrative in these past few months as well as reformed a focus on

multilateralism," India's Permanent Representative to the UN Ambassador Ruchira Kamboj told PTI in an exclusive interview

India assumes the monthly rotating presidency of the Security Council from December 1, the second time after August

2021 that the country will preside over the Council during its two vear tenure as elected UNSC member. India's 2021-2022 term on the Council ends December 31, with Kamboi, India's first woman Permanent Representative to the United Nations in New York sitting in the President's seat at the powerful horseshoe table for the month. India will also take over the vear-long G20 presidency from December 1.

External Affairs Minister S Jaishankar will travel to New York to preside over "signature events" in the Security Council on renewed orientation for reformed multilateralism on December 14 and on countering terrorism on December 15. UN Secretary General Antonio Guterres and President of the 77th session of the UN General Assembly Csaba Korosi are also expected to brief the UNSC meeting on December 14. Kamboi said counter-terrorism was one of India's top priorities when it entered the Council on January 1, 2021. She underscored

plan on combating terrorism outlined in the Security Council by Jaishankar in January 2021 to the October 2022 Special Meeting of the Counter-Terrorism Committee hosted by India during which the Delhi Declaration' was adopted. India has been successful in demonstrating two things. "One that there can be no justification for terror, it is condemnable, it has to be called out and countries who seek to obfuscate that, seek to justify that should be called out," Kamboj said.

The second point is that all countries, importantly, should speak with a united voice. "The problem (of terror) transnational and we have to pool in our resources, knowledge and expertise to speak with a united voice," she said. On October 28-29, the Security Council Counter-Terrorism Committee, currently chaired by India, organised a Special Meeting in New Delhi and Mumbai on the overarching theme of "Countering the use of

that from the eight-point action new and emerging technologies for terrorist purposes". As an outcome of the special meeting. the Committee adopted the "pioneer document" Delhi Declaration' on countering the use of new and emerging technologies for terrorist purposes. The Delhi Declaration serves to focus attention on the scourge of terrorism and particularly the fact that it has raised its head in a "new avatar" where terrorists have been abusing, misusing virtual platforms to forward their narrative, Kamboj said.

She added that this message was taken forward in New Delhi this month through the No Money for Terror' (NMFT) Ministerial Conference on Counter-Terrorism Financing that was addressed by Prime Minister Narendra Modi. "That was a continuation of what we have been doing, specifically where the CTC meeting in New Delhi and Mumbai left off and going forward, to complete the arc, during our term we will be having a focussed discussion" on December 15 in the presence of the External Affairs Minister and other foreign dignitaries in the Council. "India has done everything that it could to fulfil the mandate of the CTC. All countries across the table, without exception, have complimented India for the Delhi Declaration, for the CTC event in Delhi and complimented the conference as being outstanding both in terms of logistics and substance. That is not insignificant and that must be noticed." Kamboi said.

Jaishankar had announced a voluntary contribution of USD 500,000 by India to the UN Trust Fund for Counter-Terrorism to augment the UNOCT's efforts to build the capacity of member states to counter terrorism. "India is very strong on this narrative. We are very mindful that countries in Asia and Africa particularly" are facing the scourge of terrorism. "This is something that we'll continue to keep our focus on while we're in the Council," she said. (PTI)

Messi emotional after firing Argentina into lead against Mexico with vital World Cup goal



ABU DHABI, NOV 27/--/ Lionel Messi's dream of matching late great Diego Maradona's Argentina legacy lives on. The seven-time Ballon d'Orwinning forward pulled level with Maradona on eight World Cup goals and a record 21 appearances at the tournament for his country on Saturday. Messi's brilliant low strike from outside the box sparked a 2-0 win over Mexico to take them second in Group C, just as their hopes of victory were starting to fade and fear was setting in. Argentina's talisman is two goals short of their World Cup topscorer Gabriel Batistuta's tally of 10 goals, but his winner should bring more opportunities to overtake "Batigol" in Qatar.The real dream is emulating Maradona's 1986 World Cup win, but Messi can content himself for now by levelling Maradona's World Cup appearance record and goal haul, two years and a day after 'El Pelusa' passed away. The curly-haired playmaker inspired Argentina to victory in Mexico in 1986, as well as playing in the 1982, 1990 and 1994 editions. Some insist Messi cannot be considered the greatest of all time unless he lifts the trophy, and in Argentina, Maradona's gleaming World Cup legacy often aids him in comparisons, his flawed genius winning out against Messi's nearperfection. Maradona scored five and

set up another five as Argentina waltzed to their second World Cup trophy 36 years ago in Mexico. Almost a year later Messi was born, but Argentina have not managed to lift the trophy in his lifetime. The Albiceleste captain managed to inspire the team to second place in 2014, with Argentina losing 1-0 in extra-time against Germany in the Rio de Janeiro final. The Paris Saint-Germain No 10, playing in his fifth World Cup, converted a penalty in Argentina's opener but they crashed to a shock defeat by Saudi Arabia.

Against Mexico he sporadically burst into life but his team were largely suffocated by their energetic opponents. Early in the second half Messi sent a free-kick over the crossbar from a dangerous position, as Argentina's desperation grew. Eventually he broke the deadlock in the 64th minute, finishing exquisitely beyond the reach of Mexican cult hero Guillermo Ochoa, with Enzo Fernandez adding a brilliant second late on. Maradona scored only 15 goals for Argentina in 41 competitive appearances, compared to Messi's 49 in 115, but some led him to World Cup glory. After elimination in the second group stage in Spain 1982, Maradona returned with a vengeance four years later. He conjured the most talkedabout display in football history

against England in the quarter-finals. The stocky attacker scored one of the great all-time goals with a magnificent solo dribble, after opening the scoring with the infamous "hand of god" punch over England goalkeeper Peter Shilton. Another brace followed against Belgium in the semis and Maradona provided an assist in the 3-2 final win over West Germany, perhaps the country's finest sporting moment. In 1990 Maradona guided Argentina to the final but they fell 1-0 against West Germany. A wild eye-bulging celebration after scoring in 1994 World Cup became an enduring image --Maradona failed a drugs test and was sent home after two games. Messi, who became the first Argentinian to score at four World Cups this week, struck on his debut at the 2006 tournament against Serbia and Montenegro as a teenager. He was an unused substitute as Germany eliminated Argentina in the quarter-finals, then suffered another 4-0 thrashing by the same opponents at the same stage in 2010 Germany foiled Messi again at the final hurdle in 2014 and France beat them in the last 16 in 2018, the playmaker creating two goals in a 4-3 defeat. Messi has never scored in a World Cup knock out tie and with two goals in two games this year, and strikes in each of Argentina's last six matches, this could

Costa Rica beat Japan to hand Germany lifeline

DOHA, NOV 27 /--/ Costa Rica stunned Japan 1-0 thanks to a late goal at the World Cup on Sunday to blow Group E wide open and hand a potential lifeline to Germany.

Japan, who shocked four-time champions Germany 2-1 in their opener in Qatar, could have taken a giant stride towards the last 16 with a win. Instead they laboured for large parts of the match against a Costa Rica side who were hammered 7-0 by Spain, then defender Keysher Fuller scored in the 81st minute with a deflected strike. It was Costa Rica's first shot on target at this World Cup and could be of huge benefit to the Germans. The result left Spain, Japan and Costa Rica all on three points. Spain face Germany later Sunday in another crucial contest. Japan made five changes to the team which shocked Germany in their opening match as coach Hajime Moriyasu made full use of his 26man squad. In temperatures of 32 degrees Celsius (90 degrees Fahrenheit) at Ahmad Bin Ali Stadium, Japan immediately went on the attack and won a corner within 30 seconds to signal their intent. Costa Rica coach Luis Fernando Suarez had resisted making wholesale changes to the team thumped by Spain, dropping teenage winger Jewison Bennette and defender Carlos Martinez to the bench. Gerson Torres and 34-year-old centre-back Kendall Waston took their place in an ageing XI which featured four players from the 2014 World Cup quarter-finals. But Japan's early promise melted in the Doha sun and the first shot at goal -- a tame effort which sailed high and wide -- did not come until 10 minutes from half-time through Costa Rica's 30-year-old Joel Campbell. A dreary first half came to a close with "Los Ticos" having had more of the ball but neither side mustering a shot on target. Moriyasu had seen enough and made a double change at the break, one of them the introduction of Bundesliga-based striker Takuma Asano, who scored the winner against the Germans.

The Blue Samurai were immediately more cutting and midfielder Hidemasa Morita drew the first proper save of the match within seconds of the restart with a powerful strike. Moriyasu threw on Brighton attacker Kaoru Mitoma for a defender just after the hour as Japan chased the victory that would put them on the cusp of the last 16. It was all Japan as the match ticked into the last 20 minutes in front of 41,000 spectators. Substitute Junya Ito looked to have wriggled free and was closing on goal, only for Costa Rica defender Francisco Calvo to cynically tug him back on the edge of the box, earning a vellow card that could easily have been red. Costa Rica had done nothing for most of the game as an attacking force, but nine minutes from normal time they stole it when Fuller's shot took a deflection and looped in. (AFP)

"The highest level is unforgiving," Cameroon coach Rigobert Song said after his team's opening 1-0 loss to Switzerland. "We no longer have any room for error and we'll be going for broke." Serbia has a fine finisher in Juventus striker Dusan Vlahovic, but he has only just shaken off a groin injury. If he starts, coach Dragan Stojkovic would ideally pair him with Aleksandar Mitrovic. Mitrovic has 50 goals for Serbia and his last-minute header against Portugal in Lisbon last year sent the Serbs to Qatar and put the Portuguese into a playoff. He started the 2-0 loss to Brazil but looked jaded, as did Vlahovic when he came on. Stojkovic is hopeful Juventus left winger Filip Kostic will be fit to start. (AP)

Team doctors said Neymar will miss Monday's match against Switzerland but did not elaborate on a timetable for his return — or say whether he will be able to return at all. Neymar wrote on

Instagram he was enduring "one of the most difficult moments" of his career, but seemed optimistic about his chances of returning. He showed two photos of his swollen ankle in an



Instagram story.

"I'm injured, yes, and it's a pain, and it will hurt," he said.

"But I'm sure that I'll have the chance to return, because I'll do anything possible to help my country, my teammates and myself." He said he's been waiting too long for this World Cup to go out like this. "Nothing in my life was easy or given to me," Neymar said. (AP)

DOHA, NOV 27 /---Deschamps insisted he was never worried his side might be the latest defending champions to be eliminated from the World Cup in the group stage after they became the first team through to the last 16. The holders followed their opening 4-1 win over Australia by beating Denmark 2-1 in Doha on Saturday thanks to a Kylian Mbappe brace, with the all-important second goal coming four minutes from time. That left France on six points after two games, and they now look set to win Group D as well, with just a draw in their last match against Tunisia all they need to guarantee the top spot.

It is a far cry from the last three World Cups, in which the holders have gone out in the group stage on each occasion.

That statistic had been mentioned to Deschamps prior to the tournament, especially as injuries ruled out key players including Karim Benzema and N'Golo Kante. "Soon I will have to thank everyone who spoke to me about that,' said Deschamps. Italy were the holders when they went out at the first hurdle in 2010, with the same fate befalling Spain in 2014 and Germany four years later. "I am never worried, even if know atmosphere around the squad is not always calm," he added. (AFP)

opening 3-2 win against Ghana. "This is just the beginning," Ronaldo said in an Instagram post, adding that "there are no impossibilities." But if soccer's ultimate numbers man is to achieve his ambition of lifting the one major trophy that eludes him, he cannot do it by himself. That much was clear against Ghana, when Portugal also needed goals from Joao Felix and Rafael Leao to hold on for victory. Felix is the likeliest heir to Ronaldo's throne as Portugal's inspiration-in-chief — and has even been linked with a potential move to United. If Qatar is Ronaldo's last World Cup dance, the moves are not quite as fluid as they once were. His goal against Ghana came from the penalty spot, rather than a moment of the type of individual brilliance



on which his career has been built. That being said, FIFA Technical Study Group member on Sunday Oliseh still described as "total genius" his ability to win a disputed foul from Mohammed Salisu that Ghana coach Otto Addo insisted should not have been awarded. Ronaldo's celebrations suggested he does not care where the goals come from, so long as they keep on coming. But Portugal cannot solely rely on such moments — and amid the noise that surrounds its most celebrated player, it can be forgotten how much talent coach Fernando Santos has at his disposal. Not least Atletico Madrid forward Felix, United midfielder Bruno Fernandes and Bernardo Silva of Manchester City. "A selection with the quality of ours has to be favorite

in any game," said Portugal forward Goncalo Ramos ahead of Uruguay at the Lusail Stadium. "It's important to win the second game now." Uruguay drew 0-0 with South Korea in its first game of the tournament. Like Portugal, Uruguay is blending the old and the new. Ronaldo's long-time rival from their time at Real Madrid and Barcelona respectively, Luis Suarez, is in an attack that also features the country's new generation of talent in Darwin Nunez and Facundo Pellistri. At 35, Suarez is no longer the force he once was and he was substituted just after the hour against South Korea. Another 35-year-old in Edinson Cavani replaced him, but Uruguay still couldn't find a goal. (AP)
