## Atal Pension Yojana: A boon for unorganized sector

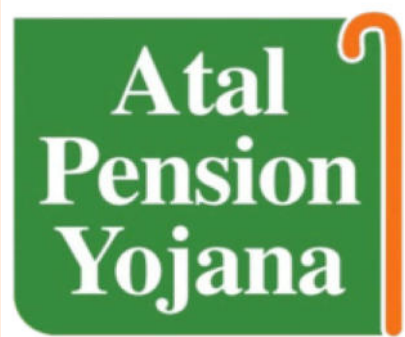
### 12672 persons enrolled under the pension scheme in A&N Islands so far

Port Blair, Aug. 21

The Atal Pension Yojana (APY) is a pension scheme for the workers in the unorganized sector. As per the scheme, people can make contributions in their Atal Pension Yojana account till the age of 60 years and get a monthly pension. The APY focuses on all citizens in the unorganized sector, who join the National Pension System (NPS) administered by the Pension Fund Regulatory and Development Authority (PFRDA). As per the data provided by Lead Bank, Port Blair, altogether, 12672 persons have been enrolled under the universal social security scheme 'Atal Pension Yojana' in A&N Islands as on 30<sup>th</sup> June, 2022.

Under APY, the subscribers would receive fixed minimum pension of Rs. 1000 per month, Rs. 2000 per month, Rs. 3000 per month, Rs. 4000 per month, Rs. 5000 per month, at the age of 60 years, depending on their



contributions, which itself would be based on the age of joining the APY. The minimum age of joining APY is 18 years and maximum age is 40 years. The age of exit and start of pension would be 60 years. Therefore, minimum period of contribution by any subscriber under APY would be 20 years or more. The benefit of fixed minimum pension would be guaranteed by the Government.

APY is open to all bank account holders with auto debit facility to

accounts, leading to reduction in contribution collection charges. The subscribers should keep the required balance in their savings bank accounts on the stipulated due dates to avoid any late payment penalty. Due dates for monthly contribution payment is arrived based on the deposit of first contribution amount. In case of repeated defaults for specified period, the account is liable for foreclosure and the GoI co-contributions, if any shall be forfeited. Any false declaration about his/her eligibility for benefits under this scheme for whatsoever reason, the entire Govt. contribution shall be forfeited along with the penal interest.

For enrolment, Aadhaar would be the primary KYC document for identification of beneficiaries, spouse and nominees to avoid pension rights and entitlement related disputes in the long-term.

## 'Nari Shakti Puraskars' to be conferred on Individual & Institutions in recognition of their service towards women empowerment

Last date for receipt of online application/nomination is Sept. 1

Port Blair, Aug. 21

The Ministry of Women & Child Development is celebrating International Women's Day every year on 8<sup>th</sup> March to acknowledge the achievement of women for the nation and recognizing their contributions to the society. The Ministry has decided to confer 'Nari Shakti Puraskars' every year to individual and institutions in recognition of their service towards the cause of women empowerment, specially vulnerable and



marginalized women.

The recipient of the 'Nari Shakti Puraskar' is declared every year by 20<sup>th</sup> February and awards are conferred on March 8 on the occasion of International Women's Day. The maximum number of awards (including individual and institutional) would be 15. However, any relaxation to the maximum number may

be at the discretion of the Selection Committee. The award in each category shall carry a certificate and a cash amount of Rs. 2 lakh per awardee.

The eligibility criteria for nomination are available in the guidelines of the Ministry. The designated portal is open throughout the year and details are placed on the

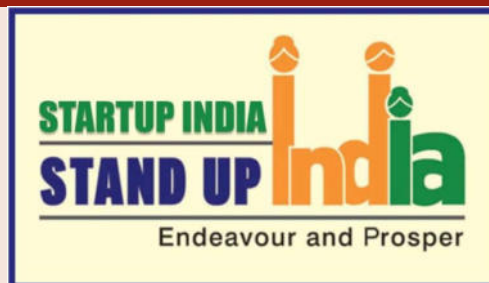
## Promoting entrepreneurship through Stand-Up India Scheme in A&N Islands

### Loan amounting to Rs. 55.59 crores disbursed to beneficiaries for setting up own ventures

Port Blair, Aug. 21

The Stand up India scheme aims at promoting entrepreneurship among women and Scheduled Castes and Scheduled Tribes. The scheme is implemented by Department of Financial Services (DFS), Ministry of Finance, Government of India. Stand-Up India Scheme facilitates bank loans between Rs 10 lakh and Rs 1 Crore to at least one Scheduled Caste (SC) or Scheduled Tribe (ST) borrower and at least one woman borrower per bank branch for setting up a greenfield enterprise. This enterprise may be in manufacturing, services or the trading sector. In case of non-individual enterprises at least 51% of the shareholding and



controlling stake should be held by either an SC/ST or woman entrepreneur.

SC/ST or woman entrepreneurs, above 18 years of age, can avail loans under the scheme only for greenfield project. Here, greenfield signifies first time venture of the beneficiary in manufacturing or services or trading sector. In case of non-individual enterprises, 51% of the shareholding and controlling stake should be held either by SC/ST or woman entrepreneur and borrower should not be in default to any bank/financial institution.

As per the data received from Lead Bank Port

Blair, in A&N Islands, altogether 264 beneficiaries have availed loan under the Stand-Up India Scheme and an amount of Rs. 55.59 crores have been disbursed to the applicants for setting up their own ventures as on 30<sup>th</sup> June, 2022.

Composite loan (inclusive of term loan and working capital) between 10 lakh and upto 100 lakh is provided for setting up a new enterprise in manufacturing, trading or services sector by SC/ST/Women entrepreneur. The loan is repayable in 7 years with a maximum moratorium period of 18 months. The scheme, which covers all branches of Scheduled Commercial Banks is accessible either directly at the branch or through Stand-Up India portal [www.standupmitra.in](http://www.standupmitra.in) or through the Lead District Manager (LDM).

The Department of Industries is implementing a Centrally Sponsored Scheme christened 'Prime Minister's Formalization of Micro Food Processing Enterprise (PM FME)' launched by the Ministry of Food Processing Industries, Govt. of India under Atmanirbhar Bharat Abhiyaan with the objective to strengthen backward/



forward linkages, common infrastructure, packaging, branding & marketing of products pertaining to micro food processing enterprises. Under this scheme, financial assistance in

the form of credit-linked subsidy @ 35% of the eligible project cost with a maximum ceiling of Rs.10 lakh per unit would be provided to individual entrepreneurs/Proprietorship Firms/Partnership Firms/Farmer Producers Organization (FPOs)/NGOs/SHG's/Co-operatives/Pvt. Ltd. Companies who have established or propose to

## U-20 World Wrestling Championships: Antim Panghal becomes first Indian woman wrestler to win Gold Medal

Sofia, Aug. 21

17-year-old Haryana wrestler, Antim Panghal has become the first Indian woman wrestler to win Gold medal at Under-20 World Wrestling Championship in Sofia, Bulgaria. She scored an 8-0 win over Atlyn Shagayeva of Kazakhstan in 53kg category to achieve this feat.

This gold medal is historic in its own



ways as India has never won any gold medal in women's wrestling at U20 World Championships. Antim Panghal belongs to Haryana's

Bhagana village in the Hisar district. Sonam Malik and Priyanka won silver medals in 62 kg and 65 kg respectively after losing the gold medal bouts.

## COVID-19 status in A&N Islands

Port Blair, Aug. 21

Five positive cases have been detected today in A&N Islands, of which, 3 were from incoming flight passengers who arrived here yesterday. Today, 9 flights with 1430 passengers arrived, out of which, 1314 passengers were vaccinated with both doses while RT-PCR test was conducted on 64 passengers and the reports are awaited.

During RAT conducted on 35 passengers bound for North & Middle Andaman at Ferrargunj, no positive case has been detected. At Phoenix Bay Jetty, 3 passengers were tested with RAT, no positive case has been detected. RAT was conducted on 17 passengers at Mohanpura Bus Terminus, no positive case has been detected, a press release from IP&T said.
