

Bursting of firecrackers on Diwali in Delhi will attract a jail term of up to six months and a fine of Rs 200, Environment Minister said on Rai Wednesday.

Production, storage and sale of firecrackers in the capital will be punishable with a fine of up to Rs 5.000 and three years in jail under Section 9B of the Explosives Act, the minister told a press conference here. In September, the city government re-imposed a complete ban on the production, sale and use of all types of firecrackers till January 1, including on two years. Rai said a public awareness campaign -- Diye Jalao Patakhe Nahi (light diyas, not firecrackers) -will be launched on October

The Delhi government will light 51,000 diyas at the Central Park in Connaught Place on Friday. "The purchase and bursting of firecrackers in Delhi will be punishable with a fine of Rs 200 and six months in jail under the Indian Penal Code," the minister said, Rai said 408 teams have been set up to implement the ban.

The Delhi Police has set up 210 teams under assistant commissioners of Diwali, a practice it has police, while the Revenue

Scheme on Nov 18 NEW DELHI, OCT 19 /--/ The Delhi High Court Capital Region last year, Wednesday listed for hearing on November 18 several pleas challenging the Centre's Agnipath scheme for recruitment in the armed forces.

A bench of chief justice Satish Chandra Sharma and Justice Subramonium Prasad granted two weeks' time to the petitioners to respond to the Centre's stand on the matter. In a "consolidated" reply filed in response to several petitions against the Agnipath scheme as well as those concerning the recruitment processes for the armed forces under certain previous advertisements, the Central government has there is no legal infirmity in the scheme. The government submitted the Agnipath scheme was introduced in exercise of its sovereign function to make national security and defence more "robust, "impenetrable" and "abreast with changing military requirement". The Agnipath scheme, unveiled on June 14, lays out rules for the recruitment of youths in the armed forces. According to these rules, those between 17-and-a-half and 21 years are eligible to apply and they would be inducted for a four-year tenure, and 25 per cent of them will be granted regular service subsequently. Later, the government extended the upper age limit to 23 years for recruitment in 2022. On Wednesday, the counsel for one of the parties informed the court that there are two categories of cases concerning the Agnipath scheme -- one that assails the scheme while the others pertain to recruitment in the armed forces under certain earlier advertisements -- and they should be heard separately.

Solicitor General Tushar Mehta, representing the Centre, submitted that all the cases are essentially against the scheme and some "additionally" raise the issue of right to appointment under earlier advertisements, and, therefore, all the cases must be heard together.

The court, during the hearing, also questioned the petitioners if any right with respect to appointment was created in their favour on account of their participation in the recruitment process.

"Employer has the right to curb process at any time. There is a Supreme Court judgement. What is the right created?," asked the court.

One of the petitions before the high court has sought a direction to the armed forces to resume the recruitment process which have been cancelled due to the introduction of the Agnipath scheme and prepare the final merit list after conducting a written examination within a stipulated time.

A petitioner, named Rahul, has submitted he had applied for the post of soldier (general duty) and his physical and medical examinations were conducted which he cleared successfully, and was waiting for the written examination. However, he said, he found on the official website that consequent to the implementation of the Agnipath scheme, the ministry has stopped and cancelled all pending processes including the Common Entrance Examination (CEE) of Indian Army recruitment for the previous recruiting years. He said there were several candidates like him who applied for other posts in the armed forces but their respective processes were also cancelled. Another petition, seeking that the recruitment process in the Indian Air Force as per a 2019 notification be completed without being affected by the scheme, is also pending in the high court.

Besides the pleas filed before it, the high court is also hearing those transferred to it. Earlier, the Supreme Court had asked the high courts of Kerala, Punjab and Harvana, Patna and Uttarakhand to transfer the PILs against the Agnipath scheme pending before them to the Delhi High Court or keep it pending till a decision from the Delhi High Court is delivered, if the petitioners before it so desire.

Kharge will consult everyone, give preference to party workers, says his son

BENGALURU, OCT 19 /--/ Priyank Kharge on Wednesday said his father Mallikarjun Kharge, who was elected as the Congress President, will strengthen the outfit by consulting everyone and give preference to the party workers. Addressing reporters in New Delhi, the Congress MLA said, "We have to build the party at the grassroots level,

encourage our cadre and have to work beyond our capacities to ensure that the governments are formed in various states. Challenges are very clear and his directions are very clear. The process of building the party will be consultative and the workers will get the preference. Priyank Kharge was replying to a query on the challenges before the new party President in the context of the crucial Assembly elections in Karnataka, Gujarat and Himachal Pradesh. He said collective effort will be made to win the elections. On BJP's charge that Mallikarjun Kharge will be a puppet at the hands of Gandhi family, the Chittapur legislator wondered why the JP Nadda-led party was so keen about the internal matters of Congress.

The BJP said that their party president JP Nadda was re-elected. Let them clarify first whether it is re-election or re-selection. Let them share their voters' list. Wasn't our election process open to all? The internal democracy is quite visible in our party, he said. Regarding Shashi Tharoor's defeat, the former State Minister said he led a good campaign with good election publicity in the social media. Tharoor spoke to the delegates and youth in the party, he added. People blessed Mallikarjun Kharge because someone had to win the election. However, Tharoor is an important part of the party. Modi to unveil 108-feet statue of Kempegowda on Nov 11: Karnataka minister

BENGALURU, OCT 19 /--/ The 108-feet bronze statue of Bengaluru's founder Kempegowda will be unveiled by Prime Minister Narendra Modi on November 11 near the international airport here, Karnataka minister CN Ashwath Narayan said on Wednesday. The statue weighing 220 tonne is being installed at the Kempegowda International Airport here at an expense of Rs 85 crore. Renowned sculptor and Padma Bhushan awardee Ram Vanji Sutar has designed the statue. Sutar had built the 'Statue of Unity' in Gujarat and the statue of Mahatma Gandhi in Bengaluru's Vidhana Soudha. Besides Kempegowda's statue, there will also be a heritage park in an area covering 23 acres dedicated to the

Narayan, who is also the Vice-Chairperson of the Kempegowda Heritage Area Development Authority, said a campaign for collecting sacred mud from across the state to be used for the development of Kempegowda theme park at the international airport, will be flagged off by Chief Minister Basavaraj Bommai on October 21 in front of Vidhana Soudha here. "The campaign will run till November 7 and during this period, vehicles named as 'Nadaprabhu Kempegowda Ratha' will collect the sacred mud across all the districts of the state. The sacred mud thus collected will be used during the unveiling of the 108feet statue of the Bengaluru founder by Prime Minister Narendra Modi on November 11." he said. To ensure the success of the campaign, committees have been formed at the district level, the minister said; CEOs of zilla panchayats in each district will be the nodal officer of the

Conversion, 'infiltration' causing population imbalance, savs RSS leader Hosabale

PRAYAGRAJ, OCT 19 /--/ RSS leader Dattatreva Hosabale on Wednesday said religious conversion and migration from Bangladesh are causing population imbalance and called for strict implementation of anti-conversion laws. Addressing reporters after a four-day all-India working committee meeting of the Rashtriva Swavamsevak Sangh here, the RSS general secretary said the organisation is trying to create awareness on conversions. He said as a result there has been a favourable outcome of Ghar Wapsi -- the Sangh Parivar effort to bring back to the Hindu fold people it says converted to faiths like Islam and Christianity. He said the existing laws to prevent religious conversion need to be implemented strictly. The apparent reference was to laws in some states, including Uttar Pradesh, that prohibit conversion by force or allurement, particularly through marriage. RSS chief Mohan Bhagwat too attended the meet in Prayagraj from October 16 to 19.

Ecstatic pilgrimage turns nightmarish for TN family in Uttarakhand

CHENNAI, OCT 19 /--/ What began as a spiritual journey for a family in Tamil Nadu to shrines in the faraway Himalayan ranges ended on a tragic note with three of its members getting killed in a helicopter crash in

The pilgrims believed that the ecstatic trip to the famous temples of Kedarnath and Badrinath in the northern State would bring unforgettable life-time memories but the eventuality --the accident-- was nightmarish and it has shaken the family, a relative said.

According to police sources, the victims were Premkumar Vanchinathan, his wife Sujatha Premkumar and her relative Kala Ramesh. V Ramkumar, the elder brother of Premkumar said the trio had undertaken a 12day journey and when they were about to complete the pilgrimage tragedy befell them. All the three people hail from the city. "My younger brother V Premkumar, his wife Sujatha and their relative Kala Ramesh had gone on a 12day pilgrimage. When they were about to conclude the trip, the accident occurred. We came to know about it this morning around 1.15 am." Ramkumar said.

The helicopter ferrying the pilgrims from Kedarnath temple to Guptkashi crashed into a hill in Rudraprayag, Uttarakhand due to poor visibility, killing six passengers and the pilot. Soon after the mishap, officials from Tamil Nadu government got in touch with us and updated us of all the measures taken for the safe arrival of the mortal remains of the victims, he said.

Premkumar and his wife Sujatha are survived by a son, who is working in the US and daughter working in Singapore. "The children have been informed about the accident and are on their way to Chennai", he said. "My brother and his wife are religious and have visited various temples in the recent past. Their deaths have come as a huge shock for us," he said.

Chief minister M K Stalin offered condolences to the bereaved family and added that his government was coordinating with the Uttarakhand administration bring back the remains of the victims. The chopper-a Bell 407 operated by private company burst into flames around 11.45 am on Tuesday at Dev Darshini in Rudraprayag's Garud Chatti. (PTI)

PORT BLAIR, OCT 19/--/The Deputy Commissioner, South Andaman, Mr. SuneelAnchipaka, along with Mr. DilkhushMeena, Sub-Divisional Magistrate (SA), Rahul Dev Boora, (Probationer), Vinayak Mr. Chamadia (Probationer) and Tehsildar, Port Blair visited the areas predominantly inhabited by Ranchi community such as Ranchi Basti, AttamPahad, Mahaveer Nagar. The Chairperson, Port Blair Municipal Council and concerned Ward Councillors accompanied.

During the visit, the DC (SA) interacted with the residents at Lambaline village. Various issues were raised such as construction of new community hall, construction of black top road connecting VKV Nagar Palikaschool and Jawahar Colony, School Line village, Renovation of Balwadi, Maintenance of community toilets, trimming of trees nearby VKV Nagar Palika school. DC (SA) inspected all the spots and gave a



patient hearing to all their grievances and assured them of its early disposal. DC (SA) has requested the ward councilor to put forth a proposal for construction of black top road under the Central Road Fund (CRF). At AttamPahad village the residents raised issues related to non functioning of street lights, widening of footpaths, allotment of land for playground, replacement of old pipelines. 

Debate over language back in focus

The Madhya Pradesh government deciding to launch Hindi instruction for the medical course in the state, with Home Minister Amit Shah releasing in Bhopal Hindi texts of three subjects taught in the first year of the MBBS programme, has brought back to limelight the debate over language. This has come around the time when the Committee of Parliament on Official Language headed by the Union Home Minister recommended that Hindi should be the medium of instruction in all technical or non-technical educational institutions in Hindi-speaking states, including central universities. The recommendations of the panel have triggered angry reactions in Tamil Nadu, Kerala and other southern states. But, for students whose medium of instruction in school was Hindi, the unveiling of MBBS Hindi textbooks is a positive development. Students schooled in their mother tongue have a disadvantage in higher education where English is usually the medium of instruction and examination. Flexible language policies can greatly benefit such students, which is why this reform should be extended to other languages and disciplines too. But it's important to ensure that local language books maintain the quality standards of the source books. The corpus of local language texts must also expand so that a student who opts to study in the local language isn't left behind by others. Language flexibility in higher education should include students having room to improve their English skills too. This will open up more opportunities for them in the global knowledge

There is nothing new about the opposition to Hindi in the south, where the first anti-Hindi imposition agitation was launched in 1937. This time too the situation is no different. Tamil Nadu Chief Minister M K Stalin has written to the Prime Minister that the "aggressive attempts of the Union government" to 'impose' Hindi are "impractical and divisive in character", putting non-Hindi speaking people in a disadvantageous position. The DMK youth wing has held protests in the state and is threatening a massive demonstration in Delhi. Kerala Chief Minister PinarayiVijayan has also termed the committee's recommendations as an assault on federalism and the very essence of India's unique unity in diversity.

It may be recalled that under the Left rule, West Bengal paid a heavy price for curbing English to promote the local language. India's workforce, from IT to nursing, is prized everywhere because of familiarity with English. Parents, across classes, seek English medium education for their wards for this reason. Political parties a bridge between electorate & govt

campaign promises should be has remained constant in public discourse. This increased attention for election promises is partly the result of a public interest litigation ('PIL') filed at the Supreme Court in January by politician and lawyer Ashwini Kumar Upadhyay. This PIL contests the practice of promising "irrational freebies" by political parties from public funds during election campaigns and the use of public funds for the distribution of the promised freebies by the elected government.

The petition claims that the promise of freebies unfairly influences the electorate, and the distribution of irrational election freebies from public funds not meant for "public purpose" violates Article 282 of the Constitution. The next hearing in this matter is expected to come up on October 21 (based on information sourced from the official website of the Supreme Court of India). The ongoing controversy illustrates the difficulty and potential disagreements in determining what election freebies are. Generally speaking, freebies can mean anything given out for free, especially to attract support or interest in something. The term "election freebies" is being extensively used in India to describe (as well as disapprove) certain welfare schemes promised for free (or at a bare minimum cost) by political parties during their election campaigns to attract voters and delivered out of the public funds when they form the government (especially at the state level). Of course, this is not a precise definition of the term - election freebies remain bereft of

This PIL seeks a direction against political parties that promise election freebies out of the public fund during election campaigns to attract voters, which raises a rather fundamental question - are not all promises made during an election campaign aimed at attracting votes? The answer to this inevitably requires a detailed theoretical discussion on political parties and election campaigns. Freebies are welfare measures promised and delivered out of public funds. The funds for these supposedly controversial welfare schemes (which may include the distribution of items such as free laptops, smartphones, bicycles and scooters for students, LPG cylinders and free transportation for women, cash and gifts, among other things) are drawn out of the

Consolidated Fund of the state (Article 266 read along with Article 162) via Article 282 of the Constitution. Concerns surrounding the uninhibited use of Article 282 to effectuate centrally sponsored schemes have persisted for several years

Article 282 is now in question for channelling grants for state welfare schemes, christened as "freebies." Article 282 enables the Union and the state to make discretionary grants (expenditures) on any subject for "public purpose," even if the Union or the state is not empowered to make laws for such a public purpose under the scheme of the Seventh Schedule of the Constitution. Thus, for an Article 282 expenditure to be good in law (presumably, a warranted welfare expenditure), it must strictly be for a "public

The Constitution, however, does not provide an explanation for the term "public purpose". In 2010, a fivejudge Constitution bench of the Supreme Court in Bhim Singh versus Union of India gave the term a broad interpretation to mean anything designed to promote the purpose underlying the Directive Principles of State Policy ('DPSPs') and the Preamble of the Constitution. Following from this, any welfare scheme designed by the Union or the states which furthers the DPSPs and the Preamble could be said to further a public purpose, and expenditure to that end could be termed rational. The issue of their unrestricted use was first brought before the Supreme Court in 2013

In S. Subramaniam Balaji versus State of Tamil Nadu, a division bench of the Supreme Court heard a challenge to the practice of promising and distributing freebies (like colour TV sets, grinders, mixies, fans, lantons, cash, and so on) by political parties in Tamil Nadu. The court held that such promises in an election manifesto could not be construed as corrupt practices under Section 123 of the Representation of the People Act, 1951. The court linked

"State largesse" to the DPSPs, and ruled that it is for the elected government to decide on the policy to implement these principles. It maintained that it could not interfere in policy decisions unless there was a clear violation of some statutory or constitutional provision, or the policy in question was shockingly arbitrary in nature. Notably, in Ashwini Kumar Upadhyay, this division bench judgment in Subramaniam Balaji is under reconsideration before a three-judge bench of the Supreme Court. Interestingly, and as mentioned above, the five-judge Constitution bench ruling in Bhim Singh also linked "public purpose" to the DPSPs. In Bhim Singh, the Supreme Court also maintained that judicial interference is permissible only when the actions of the government are unconstitutional, and not when such actions are not wise or that the extent of expenditure is not for the good of the State. All such policy questions must be debated and decided in the legislature instead of the court.

In Subramaniam Balaji, the court, however, agreed that freebies alter the level-playing field for candidates contesting the election and, in the absence of any enactment governing election manifestos, directed the Election Commission of India ('ECI') to frame guidelines to regulate election promises. These guidelines now form part of the Model Code of Conduct ('MCC') for the guidance of political parties during elections. Following the decision in Subramaniam Balaji, the ECI has already framed guidelines for election manifestos in the MCC to be followed by political parties. Strict implementation of these guidelines would perhaps resolve a few concerns around election promises.

Political parties are a bridge between the electorate and the government. Although one of the most important institutions of Indian democracy, political parties remain largely unregulated. Thus, a necessary first step toward attaining a better democratic order in India could be to have a framework for the regulation of political parties for securing transparency and accountability in electoral democracy. Their regulation would also ensure that such matters concerning the regular operation of political parties do not have to end up at the doorstep of the judiciary, and could perhaps be resolved through other

Panchayat polls in Bengal will be a fight between TMC & BJP

Panchayat elections scheduled to be held in West Bengal early next year will be in stark contrast to the rural polls held five years ago. But the CPI-M has little reason to be upbeat about its chances of surging past the BJP which many voters opposed to Trinamool Congress feel is a better choice than CPI-M to support.

Absence of a level playing field led to Opposition namely BJP, Left Front and Congress withering away in Birbhum, Burdwan(East) and Midnapur (East) and (West) in the last rural polls. The other district where this phenomena was found to be present was Nadia district at Nakashipara and Chapra. There will be marked differences in the campaigning and the polling day scenarios between 2023 Panchayat polls and the one held in 2018 in which more than 35 per cent of the seats went uncontested in the ruling party's favour. Charges of intimidation of voters and Opposition candidates which marred the 2018 rural polls in the state are likely to be absent in next year's election.

The change of heart and thinking process of some of those who chalked out plans of cornering the Opposition in the last rural polls is likely as they found to their dismay the voters' ire rebounding in 2019 LokSabha polls.

For the BJP had benefitted from an outpouring of votes from those who could not exercise their franchise in 2018 rural elections. The rural voters disenchantment with the ruling dispensation in 2019Lok

Sabha polls coupled with an antiincumbency factor and Prime Minister, NarendraModi and Union home minister, Amit Shah hitting the campaign trail almost daily was a wakeup call for Trinamool Congress in 2021 assembly polls and the polling was done comparatively in a peaceful manner compared to the 2018 rural

The CPI-M continues to be hamstrung by organisational weakness which is now.all the more visible sans any tilt of the police administration which was a boon to it during the Left Front regime. Moreover, the public memory need not be refreshed about the incidents of Singur, Nandigram and Netai to name a few. The veterans still remember the unalloyed politicalisation of the every institutions to favour the CPI(M) nominees and supporters.

On the other hand, the BJP, even though it is a house divided is an almost untested entity in this state and voters will be prone to give it a chance. Many of the rural voters who are angry with Trinamool are unlikely to be swayed by reports of its alleged misrule in Uttar Pradesh and Madhya Pradesh. In rural Bengal, it is mostly between Trinamool and the BJP. A "silent voting segment" continues to support the saffron camp nominees in successive elections. The reasons behind their allegiance which is yet to be laid threadbare may vary from a charismatic prime minister to the so called achievements of the NDA government or the state of affairs nearer home being unsatisfactory.


The BJP having polled nearly 38 per cent votes in the Assembly election last year sans any significant support from a minority community speaks volumes about its core vote bank's faith on it. The Trinamool polling 49 per cent votes. while the Left's vote share being a mere eight percent highlight the extent of their respective support bases in rural and urban

Though there has been an improvement in the morale of the CPI-M's rank and file in the state post 2021 elections and capturing a greater percentage of votes than BJP in Ballygunge by-election last year the success is of a flash in the pan variety. Out of five wards mostly populated by minority community voters, the Trinamool nominee won in three and CPI-M candidate in two wards in this by-election is a clear pointer

to the support base of the ruling party though it's candidate had defected from BJP not too long ago. Yet a section of state CPI-M leadership is nursing a hope of relegating the BJP to the third position in the rural polls next year. It has been buoyed by a marked spurt in the sale of books from CPI-M stalls during the pujas and attacks on

The book stalls selling party literature and ideology had been decked up by placards of "NajarePanchayat" in rural areas with a phone number given to register complaints and others in Kolkata with "ChorDharo, Jail Bhoro". If the attack on the stalls located. At Dinhata in north Bengal, Chatterjee hat in Howrah and Rashbehari in south Kolkata. are interpreted by some party faithfuls and fellow travellers to be signs of some turn around.

A week is a long time in politics and a few months are to go of this year following which Panchayat elections are scheduled to be held in the state. But given the state of its preparation in the run up to the elections. even some of the most hard core supporters of CPI-M won't predict that it will unseat the BJP to the third position. From all indications, the CPI(M) is still not in the radar of the rural Bengal as a viable opposition to Trinamool Congress, it is still BJP and that too far ahead of the CPI(M) led Left Front.. The CPI(M) can only fight to improve its voting percentage by one or two points, still remaining at distant third in the political landscape of Bengal. (IPA)

Two Nigerian nationals arrested from Delhi for duping women

NEW DELHI, OCT 19 /--/ Two Nigerian nationals were arrested for allegedly duping women after befriending them on social media, police said on Wednesday.

The accused, identified as Raphael (19) and Evans Chukwudi (20), lived in west Delhi's Tilak Nagar, they said. The police said they received a complaint from a woman from Tri Nagar alleging that she was duped of Rs 149,100 by one Deepak Kumar, who she was friends with on social media. The woman alleged that a few days after she became friends with the accused, he pretended to send her costly gifts. The following day, she received a call from someone claiming to be a customs official from the airport. The 'customs official' instructed her to transfer money for "clearance" of a gift, a senior police officer said. The complainant transferred Rs 149,100 into his account as 'customs duty and foreign currency conversion charges', the officer said. The police then conducted a raid in Tilak Nagar and nabbed the accused, Deputy Commissioner of Police (northwest) Usha Rangnani said.

The two Nigerian nationals arrived in India in 2022 for medical treatment and started scamming people through social media, she said. They revealed that they befriended women on social media and induced them to pay large amounts on the pretext of customs duty and foreign currency conversion charge on costly gifts and jewellery, the police said. Five mobile phones and SIM cards were recovered from them, they added. (PTI)

1997 Uphaar cinema fire: HC asks police to reply to plea by convict in evidence tampering case

NEW DELHI, OCT 19 /--/ The Delhi High Court Wednesday sought the response of the city police to a plea by a former employee of the Ansal family seeking setting aside of his conviction and sentence for tampering with evidence in the 1997 Uphaar

cinema fire tragedy case. Justice Purushaindra Kumar Kaurav issued the notice and asked the Delhi Police to respond to the plea by P P Batra. Batra has already completed his jail term in this case which pertained to the fire incident on June 13, 1997 that left 59 people dead. Besides Batra, 83-year-old Sushil Ansal of the Ansal family that owned the approached the high court seeking to set aside his conviction and sentence. On October 11, the high court had issued bailable warrant against Batra as neither he nor any lawyer on his behalf was present in the court during the hearing on the victims' plea to enhance punishment of the convicts in the evidence tampering case. A magisterial court had on November 8, 2021 awarded seven-year jail term to the real estate barons. The District Judge had on July 19 modified the magisterial court's order on the sentence and ordered the release of Sushil and Gopal Ansal, former court staff Dinesh Chandra Sharma and Ansal's then employee Batra against their already undergone jail term.

It imposed a fine of Rs 3 crore each on Sushil and Gopal Ansal, Rs 30,000 on Batra and Rs 60,000 on Sharma. Batra, in his criminal revision petition challenging the trial court's judgement, contended that the order was passed in a mechanical manner, in clear lack of appreciation of both the law and the facts of the instant case. He said there was not even an iota of evidence to show his complicity in the alleged While conspiracy. upholding the conviction of the Ansal brothers, the trial

court had acquitted co-

accused Anup Singh. The case is related to tampering with the evidence in the main fire tragedy case in which the Ansals were convicted and sentenced to a two-year jail term by the Supreme Court. The apex court, however, released them taking into account the prison time they had done on the condition that they pay a Rs 30 crore fine each. to be used for building a trauma centre in the national capital.

According to the charge sheet, the documents tampered with included a police memo giving details of recoveries immediately after the incident, Delhi Fire Service records pertaining to repair of transformer installed inside Uphaar cinema, minutes of Managing Director's meetings, and four cheques. Out of the six sets of documents, a cheque for Rs 50 lakh, issued by Sushil Ansal to himself, and minutes of the MD's meetings, proved beyond doubt that the two brothers were handling the day-today affairs of the theatre at the relevant time, the charge sheet had said. The tampering was detected for the first time on July 20, 2002, and a departmental enquiry was initiated against Dinesh Chandra Sharma. He was suspended terminated from and service on June 25, 2004.

Addressing a 'Bijaya Samillani['] or post-Durga Puja meeting in Siliguri, Mamata said she only returned the land to the people that was forcibly acquired by the former Left Front government for the Tata Motors' Nano factory in Singur in Hooghly district. "There are people who are spreading canards that I have driven away the Tatas from West Bengal. I did not force them away, but

You (CPM)) forcibly took land from the people for the project, we returned that land to the people. We have done so many projects, but never taken any land forcibly from anybody. Why should we take land forcibly? There is no dearth of land here," Mamata stated. The TMC supremo is often criticised by her opponents, especially the CPM, for the movement against the acquisition of land at Singur in the mid-2000s, which forced the Tata group to abandon its ambitious car manufacturing project, which could have created thousands of jobs, even after completing a significant part of it. The movement fuelled her rise to power in the state as she routed the Left Front government of 34 years in 2011. The then CPM-led Left Front government had acquired around 1,000 acres of farmland for the project, which was taken back from the Tatas following a court order after Mamata became the chief minister. Her government partly returned the land to its owners. "There is no discrimination in Bengal. We want each and every industrialist to invest here," she said,

referring to the Tajpur port project of the Adani group and the Deucha Pachami coal mine project.

In an apparent reference to the ongoing agitation for school jobs in Kolkata, the chief minister said her government would continue providing jobs to the people though there were forces who create hindrances. "I want massive employment opportunities to be generated here. There are forces that do not want people to get jobs. They are causing hindrances for them. We will not stop employing people. We will employ them regularly and not take away jobs," Mamata said. (PTI)

Kharge elected Cong president, first non-Gandhi to head party in 24 years

PM wishes him 'fruitful tenure', Tharoor camp flags polling irregularities in UP

Congress on Wednesday elected Mallikarjun Kharge as its president, the first non-Gandhi to head the party in 24 years at a time the 137year-old party is struggling to reverse its slide in the country's electoral politics. A staunch Gandhi family loyalist from Karnataka, the 80-yearold leader defeated Shashi Tharoor in an electoral contest by bagging nearly 84 per cent of votes in the party presidential election. Kharge got 7,897 votes and Tharoor 1,072 votes, while 416 votes were declared invalid, Congress' central election authority chairman Madhusudan Mistry said at a press conference at the AICC headquarters here. Kharge said he will formally take charge on October 26. Though a late entrant in the Congress' internal elections, held to choose Sonia Gandhi's successor, Kharge's victory was almost certain as he was considered a 'familyapproved' candidate. The last non-Gandhi Congress president was Kesri, who unceremoniously removed in 1998 just after two years into his five-year term. While former Congress president Rahul Gandhi said the president was the "supreme authority" and would decide on the way forward for the party, it will be a challenge for Kharge to send a clear message that he is the one in the driving seat and not a proxy of the

However, the campaign team of Tharoor, had written to the party's chief election authority, "extremely irregularities" in the conduct of the election in Uttar Pradesh, sources said. Besides demanding that all votes from Uttar Pradesh be deemed invalid, Tharoor's campaign team had also raised "serious issues" in the conduct of the election in Punjab and Telangana. In his letter to party's central election authority, Tharoor's chief election agent Salman Soz has said the facts are "damning" and the election process in Uttar Pradesh is "devoid of credibility and integrity", they said. He said that after a detailed discussion with polling agents, Tharoor's team is constrained to report "disturbing facts". 'Eager' to secure trade deal with India, says UK's Home **Secretary Suella Braverman**

LONDON, OCT 19/--/Home Secretary Suella Braverman has said the UK is "eager" to secure a trade deal with India to boost both economies and that Brexit has meant that Britain no longer has a Eurocentric mindset towards trade or visas, days after she caused a stir with her "concerns" over what she feared could be an "open borders" approach in the ongoing trade talks with India. Addressing a Diwali event organised by UK-based India Global Forum (IGF) here on Tuesday evening, the Indian-origin Cabinet minister spoke of being a proud member of the British Indian community and hailed the contribution made by the Indian diaspora to British life. In an apparent effort to override her recent controversial remarks about Indians forming the largest group of visa overstayers, the minister said the UK's villages, towns and cities have been profoundly enriched by immigration from India.

"Naturally, there is an economic imperative for our countries to work together, which is why we are so eager to secure a trade deal," said Braverman. "But the boost to our economies is not the only virtue in making our friendship even stronger. We have a shared vision that by 2030 we will enjoy an even stronger partnership As Home Secretary, I particularly value the cooperation on security matters between our two countries. This is vital, on a domestic level in India and in the UK but also more broadly on an international scale, especially in the Indo-Pacific," she said. With Diwali no longer the target deadline for a draft free trade agreement (FTA), Braverman sought to reiterate that the Liz Truss led government remains determined to build on the momentum set by Prime Minister Narendra Modi and former UK Prime Minister Boris Johnson

"Candidly, leaving the European Union (EU) means the United Kingdom is better placed to think outside of the Eurocentric mindset, look to every horizon and cherish and nurture relationships with old friends like India. The points-based immigration system means that we no longer favour people from Europe over people from elsewhere. Meanwhile, around a quarter of all foreign students in the UK are from India." she noted.

Dressed in a lehenga for the Diwali celebrations attended by other senior parliamentarians, business leaders and diplomats, the 42-year-old minister also reflected upon her very personal connect with India and spoke of being struck by how "fresh and vibrant" the India-UK relationship always feels on her travels "from Kerala to Bihar, from Delhi to Calcutta". "India is in my heart, she's in my soul, she's in my blood. I'm very proud that my father has his roots and his family home in Goa and my mother can trace her ancestral origins to Madras," she said.

"India is part of my own heritage, I'm Indian on both sides of my family. My mother came here from Mauritius and my father came here from Kenya. They felt a deep connection and love for Britain even before they came here. It is a love that I share. And, I have never seen any inconsistency in that, for no inconsistency exists," she added. The UK-born member of Parliament for Fareham in southern England also referenced her upbringing in the north-west London Indian diaspora hub of Wembley, "the home of the Asian community here" in her Diwali message.

The minister said she wanted British people to be able to "drink deeply of Indian culture", through visiting, studying and working in India and by throwing themselves into it in the UK, where entry must be based on merit, not the ability to pay people smugglers, whose wicked lethal

"We consume food, music, movies and art from each other's countries voraciously. The story of India and the story of the UK are so intimately linked that they are to a great extent the same story, she declared. The UK and India launched the Free Trade Agreement negotiations on January 13. India's exports to the UK stood at USD 10.5 billion in 2021-22, while imports aggregated at USD 7 billion.

India's main exports to the UK include ready-made garments and textiles, gems and jewellery, engineering goods, petroleum products, transport equipment, spices, pharmaceuticals and marine products. Imports from Britain include precious and semi-precious stones, ores and metal scraps, engineering goods, chemicals and machinery. In the services sector, the UK is the largest market in Europe for Indian IT services. (PTI)

Putin declares martial law in annexed regions of Ukraine

MOSCOW, OCT 19/--/Russian President Vladimir Putin declared martial law Wednesday in the four regions of Ukraine that Moscow annexed and gave additional emergency powers to the heads of all regions of Russia.

Putin didn't immediately spell out the steps that would be taken under martial law, but said his order was effective starting Thursday. His decree gives law enforcement agencies three days to submit specific proposals and orders the creation of territorial defense forces in the four annexed regions.



The upper house of Russia's parliament was set to quickly seal Putin's decision to impose martial law in the annexed Donetsk, Kherson, Luhansk and Zaporizhzhia regions. Draft legislation indicates it may involve restrictions on travel and public gatherings, tighter censorship and broader authority for law enforcement agencies. Putin also didn't provide details of the extra powers the heads of Russian regions will have under his decree.

In a signal his moves could have broad restrictions for people living in Russia, his decree states that the types of measures envisaged by martial law could be introduced in Russia.

The Russian leader also ordered the establishment of a Coordination Committee to increase interactions between government agencies in dealing with the fighting in Ukraine that he continued to call a special military operation. Kremlin spokesman Dmitry Peskov said Putin's order doesn't anticipate the closure of Russia's borders, state news agency RIA-Novosti reported. (AP)



Embattled UK leader Liz Truss says she's 'not a quitter'

LONDON, OCT 19/--/British Prime Minister Liz Truss described herself as a fighter and not a quitter Wednesday as she faced down a hostile opposition and fury from her own Conservative Party over her botched economic plan. Truss attended her first session of Prime Minister's Questions since newly appointed Treasury chief

Jeremy Hunt ripped up the taxcutting package unveiled by her new government less than a month ago. She apologized to Parliament and admitted she made mistakes during her short tenure as the U.K.'s head of government. Some lawmakers shouted Resign! as she spoke. Asked by the opposition Labour Party's leader, Keir

Starmer, Why is she still here? Truss retorted: I am a fighter and not a quitter. I have acted in the national interest to make sure that we have economic stability. A package of unfunded tax cuts Truss' government announced Sept. 23 sparked turmoil on financial markets, hammered the value of the pound and increased the cost of U.K. government borrowing. The Bank of England was forced to intervene to prevent the crisis spreading to the wider economy and putting pensions at risk.

Under intense political and economic pressure. Truss last week fired her ally Kwasi Kwarteng as Treasury chief, replacing him with Cabinet veteran Hunt. On Monday Hunt scrapped almost all of Truss' tax cuts, along with her flagship energy policy and her promise of no public spending cuts. He said the government will need to save billions of pounds and there are many difficult decisions to be made before he sets out a medium-term fiscal plan on Oct. 31. Foreign Secretary James Cleverly urged Conservatives to give Truss another chance, saying mistakes happen." What you've got to do is recognize

when they've happened and have humility to make changes when you see things didn't go right, he said. Official figures released Wednesday showed U.K. inflation rose to 10.1% in September, returning to a 40-year high first hit in July, as the soaring cost of food squeezed household budgets. While inflation is high around the world - driven

up by Russia's invasion of Ukraine and its effect energy supplies - polls show most Britons blame the government for the country's economic pain. With opinion polls giving the Labour Party a large and growing lead, Conservatives now believe their only hope of avoiding electoral oblivion is to replace

Truss. But she insists she is not stepping down, and legislators are divided about how

Truss faces another test in Parliament later when lawmakers vote on an opposition Labour Party motion seeking to ban fracking for shale gas - a policy Truss recently greenlit. Conservative Party whips said the vote would be treated as a confidence motion in the government, meaning the government would fall if the motion passed. The Conservatives' 70-plus majority makes that unlikely, but the vote will be closely watched for signs of dissent about Truss' leadership. Under Conservative Party rules, Truss is safe from a leadership challenge for a year, but the rules can be changed if enough lawmakers want it. Some Conservative legislators also believe Truss could be forced to resign if the party agrees on a successor. As yet, there is no frontrunner. Truss' defeated Conservative leadership rival Rishi Sunak, House of Commons leader Penny Mordaunt and popular Defense Secretary Ben Wallace all have supporters, as does Hunt, who many see as the defacto prime minister already. North fires more shells toward inter-Korean sea buffer zone

SEOUL, OCT 19/--/North Korea fired drills are aimed at improving a military about 100 more artillery shells toward the sea Wednesday in response to South Korean live-firing drills at border areas as the rivals accuse each other of dialing up tensions on the Korean Peninsula with weapons tests. The drills conducted by both sides come amid heightened animosities over recent North Korean missile tests that it calls simulated nuclear attacks on South Korean and U.S. targets.

South Korea's military detected the artillery being fired from a western North Korean coastal town, the Joint Chiefs of Staff said in a statement. On Tuesday night, North Korea fired about 100 shells off its west coast and 150 rounds off its east coast, the Joint Chiefs of Staff said earlier.

Both days, the North Korean shells landed in the northern parts of the maritime buffer zones the two Koreas created off their eastern and western coasts as part of agreements they made in 2018 to reduce tensions, according to the South's Joint Chiefs of Staff. North Korea also fired hundreds of shells at the buffer zones Friday in its most significant direct violation of the 2018 agreement. North Korea's military said the launches were a warning against what it called provocative South Korean artillery firing drills along the border earlier this week. Our army strongly warns the enemy forces to immediately stop the highly irritating provocative act in the frontline areas, an unidentified spokesperson at the General Staff of the North's Korean People's Army said in a statement Wednesday.

South Korea's Defense Ministry said it conducted artillery drills at land border areas as part of its annual military exercises. But it said its drills didn't violate the 2018 accord because its shells didn't land in the buffer zones. South Korea's Joint Chiefs of Staff warned North Korea to immediately stop provocations that threaten peace and stability on the Korean Peninsula. It added that it is boosting its military readiness and, in coordination with the United States, is closely monitoring North Korea's moves.

There were no reports of violence between the two Koreas. But animosities could persist as North Korea will likely react to South Korea's ongoing annual Hoguk field exercises with its own weapons tests. South Korean officials said the Hoguk

readiness against North Korean nuclear and missile threats and involve an unspecified number of U.S. troops. North Korea views regular South Korea-U.S. military training as an invasion rehearsal. It said its recent barrage of missile tests were meant to issue a warning to one of the allies' earlier exercises involving a U.S. aircraft carrier.

In parts of the Hoguk drills open to the media, South Korean and U.S. troops built floating bridges on a river southeast of Seoul to let tanks and other armored vehicles move over them. South Korea's army said Wednesday's training was meant to deal with a hypothetical enemy attack that would leave some of the bridges over the river destroyed. It's so far been extremely successful and demonstrated the strength of the ROK-U.S. alliance, said Capt. Sean Kasprisin, a company commander at the U.S. military, using the initials of South Korea's official name, the Republic of Korea. We are definitely stronger together with the two nations. From Oct. 31 to Nov. 4, South Korea and the United States will also hold combined air force drills involving some 240 warplanes, including F-35 fighters operated by both nations. The drills are designed to inspect the two countries' joint operation capabilities and improve combat readiness, the South Korean military said Tuesday. China's Foreign Ministry spokesperson, Wang Wenbin, said at a briefing Wednesday that Beijing hopes all relevant countries would keep trying to look for a political settlement to ease tensions on the Korean Peninsula.

North Korea has test-launched 15 missiles since it resumed testing activities Sept. 25. One of them was an intermediaterange ballistic missile that flew over Japan and demonstrated a range capable of reaching the Pacific U.S. territory of Guam and beyond. Some foreign experts say North Korean leader Kim Jong Un would eventually aim to use his expanded weapons arsenal to pressure the United States and others to accept his country as a legitimate nuclear state and lift economic sanctions on the North. The North's artillery tests draw less outside attention than its missile launches. But its forward-deployed longrange artillery guns pose a serious security threat to the capital, Seoul, about 40 to 50 kilometers (25 to 30 miles) from the border

UK inflation accelerates to 40-year high as food prices rise

LONDON, OCT 19/--/British food prices rose at the fastest pace since 1980 last month, driving inflation back to a 40-year high and heaping pressure on the embattled government to balance the books without gutting help for the nation's poorest residents. Food prices jumped 14.6 per cent in the year through September, led by the soaring cost of staples such as meat, bread, milk and eggs, the Office for National Statistics said on Wednesday. That pushed consumer price inflation back to 10.1 per cent, the highest since early 1982 and equal to the level last reached in July. The figures immediately fuelled demands that the government do more to help families and retirees as it struggles to regain credibility after an illfated package of tax cuts roiled financial markets.

Treasury chief Jeremy Hunt ditched the package after he took office last week, but he has warned that this will be a difficult winter and spending reductions also will be needed. Glenn Sanderson, head teacher at St. Aidan's Catholic Academy in Sunderland, said schools across the country are finding it difficult to feed needy children, with many diverting money from textbooks and classroom teaching to subsidise meal programs. The suggestion of government budget cuts in this environment is appalling, he said.

Parents are having to make difficult decisions do they pay the bus fare to send their child to education or do they use that money to feed their child, Sanderson told the BBC. In today's society, I find that completely



unacceptable. Hunt this week told the House of Commons that the government would prioritise help for the most vulnerable while delivering wider economic stability. But he also backed away from Prime Minister Liz Truss' previous commitment to increase pensions in line with inflation.

Downing Street spokesman Max Blain said no decisions have been made on pension guarantees. We are very aware of how many vulnerable pensioners there are, but the government is not making any commitments on any particular policy areas at this point," he said.

Russia's invasion of Ukraine has boosted food and energy prices around the world, with shipments of natural gas, grains and cooking oil disrupted. That added to price rises that began last year as the global economy started to recover from the COVID-19 pandemic. While the jump in food costs took

the biggest bite out of household budgets in Britain last month, prices are rising across the board. Transportation costs jumped 10.9 per cent, furniture and households goods rose 10.8 per cent, and clothing was up 8.4 per cent. Housing costs rose 9.3 per cent, driven by the rising price of energy. The government has sought to shield consumers from the impact of rising energy prices by capping the cost of electricity and natural gas. But Hunt has now limited the price cap to six months, instead of the two years originally promised. That means inflation is likely to stay higher for longer than previously forecast, said Jack Leslie, senior economist at the Resolution Foundation, at hink tankthat focuses on improving living standards for low- and middleincome people. This bleak outlook means that family incomes will continue to fall sharply again next year, especially as support with

energy bills is withdrawn, Leslie said in a statement. That is the context of debates within government about whether previous commitments to uprate benefits or pensions in line with prices should be the next U-turn to be announced. Faster inflation also fuels expectations that the Bank of England will raise interest rates further and faster as it struggles to return inflation to its 2 per cent

The central bank is trying to slow inflation without tipping Britain into recession. The British economy shrank an estimated 0.3 per cent in August after growing just 0.1 per cent in July, according to ONS figures. Today's hotterthan-anticipated inflation reading paves the way for another aggressive interest rate increase from the Bank of England at its next meeting in early November, said Victoria Scholar, head of investment at Interactive Investor.

However, the central bank is between a rock and a hard place as it looks to curb price pressures without inadvertently adding to the risk of recession." It's the same calculation going on in other countries, but the US Federal Reserve has signalled it will continue its rapid rate hikes to combat inflation that is at a decadeshigh 8.3 per cent. The European Central Bank at its meeting next week is expected to make another big increase to curtail record inflation in the 19 countries that use the euro currency. The EU's statistics agency, Eurostat, on Wednesday adjusted eurozone inflation for September down slightly to 9.9 per cent. (AP)

Campher decorated his quick fire 32ball knock with seven fours and two sixes, while Dockrell hit four boundaries and one maximum. Lorcan Tucker (20), captain Andy Balbarinie (14) and Harry Tector (14) were the other notable scorers for Ireland. Campher's exploits with the bat came after the all-rounder turned out to be the pick of bowlers for Ireland with figures of 2/9 from his two overs of right-arm medium fast bowling. (PTI)

Bhanwala becomes first Indian to win medal at U23 Worlds, takes bronze

PCB says Jay Shah's statement can 'split' cricketing communities, requests ACC to call emergency meeting

'disappointed' Pakistan Cricket Board on Wednesday requested the Asian Cricket Council to convene an emergency meeting in the wake of BCCI secretary Jav Shah's statement that India won't travel to Pakistan for next year's Asia Cup. In its first official response to Shah's statement that India would like to play the continental tournament at a neutral venue and not tour Pakistan, the PCB said "such statements can spilt the Asian and international cricket communities" and impact Pakistan's visit to India for the 2023 World Cup. Shah, who made the statement after the BCCI AGM on Tuesday, also happens to be the ACC president. "The overall impact of such statements have the potential to split the Asian and international cricketing communities, and can impact Pakistan's visit to India for the ICC Cricket World Cup 2023 and future ICC Events in India in the 2024-2031 cycle. "The PCB has to date not received any official communication or clarification from the ACC on the statement of the ACC President. As such, the PCB has now requested the Asian Cricket Council to convene an $emergency\ meeting\ of\ its\ Board$ as soon as practically possible to discuss this important and sensitive matter," the PCB said. Pakistan has been allotted hosting rights for the Asia Cup which will be held ahead of the ODI World Cup in India in October-November. The T20 Asia Cup held last month had to be shifted from Sri Lanka to the UAE amid the economic crisis in the island nation. The 2018 Asia Cup, scheduled to be held in

The ICC is yet to comment on the matter. A top official from an Asian cricketing nation hoped the matter would be sorted amicably and said there is no Asia Cup without India or Pakistan. "It is the biggest match of the Asia Cup and with either team missing,



KL Rahul (13), Virat Kohli (15) and skipper Rohit Sharma (16) are all static in the latest update. Pakistan skipper Babar Azam is placed third ahead of South Africa's Aiden Markram and Devon Conway of New Zealand. The only movement inside the top 10 following the latest rankings update for batters saw aggressive New Zealand right-hander Glenn Phillips jump an impressive 13 spots to equal 10th on the back of his strong tri-series efforts against Bangladesh and Pakistan. Hardik Pandya also remained static at the sixth spot in the T20I all-rounder rankings with 173 rating points. Bangladesh captain Shakib Al Hasan will enter the T20 World Cup as the top all-rounder. Shakib claimed the top billing on the back of an excellent tri-series against New Zealand and Pakistan, with the veteran hitting consecutive halfcenturies during Bangladesh's final two matches. Shakib displaced Afghanistan's Mohammad Nabi. There was very little movement inside the top 10 in the updated list for bowlers, with Mujeeb Ur Rahman (up two spots to fifth) and South Africa counterpart Keshav Maharaj (up one place to eighth) climbing up. Australia seamer Josh Hazlewood (705 rating points) retains his lead at the top of the T20I bowlers' rankings, followed by Afghanistan spinner Rashid Khan (696), Sri Lanka tweaker Wanindu Hasaranga (692) and South Africa veteran Tabraiz Shamsi (688). 23rd respectively. India beat Kuwait 2-1 but fail to qualify for AFC U-20 Asian Cup 2023

KUWAIT CITY, OCT 19 /--/ Skipper Taison Singh and Gurkirat Singh struck in either half as India edged past hosts Kuwait 2-1 in their final qualification match but the third-place finish in Group H was not good enough to qualify for the next year's AFC U-20 Asian Cup. India finished ahead of Kuwait but behind toppers Australia and second-placed Iraq at the qualification event, which identified participants for next year's tournament in Uzbekistan. Top teams from all the 10 groups and the five best runners-up qualified for the final tournament, with Uzbekistan getting a direct entry as hosts in the 16-team continental event to be held from 1 to 18 March in 2023. India had lost 2-4 and 1-4 to Iraq and Australia respectively in their previous group matches. In the matchagainst Kuwait on Tuesday night, Taison and Gurkirat scored for India while Saleh Almehtab pulled one back for the hosts at the Ali Sabah Al-Salem Stadium. India started on the front foot, and in the very first minute, a long throw hurled into the box caused some confusion in the Kuwait defence. resulting in an Indian corner. Himanshu Jangra made a fine run at the near post onto a Vibin cross, but his effort went over the cross-bar. India goalkeeper Zahid Bukhari had to make a crucial save a minute later off a shot by Fahad Alazmi. However, Taison gave India the early lead in the eighth minute when he burst into the box, skipped past his marker and laced a powerful shot into

a draw at Atletico Madrid, Sevilla hold Valencia MADRID, OCT 19 /--/ Former Atletico Iraola's team battled to find the equaliser, Madrid striker Radamel Falcao earned Rayo and substitute Sergio Camello flashed a shot Vallecano a 1-1 draw against his old side in LaLiga with a 92nd minute penalty on Tuesday. Alvaro Morata's first-half strike seemed poised to help Atletico strengthen their grip on third place and keep close to leaders Real Madrid and Barcelona, but Rayo snatched a deserved draw. After the break the hosts had their backs to the wall at the Metropolitano and weren't able to finish their chances on the break. The pressure eventually told when Jose Gimenez handled in the box. "We had good chances to score the second and kill the game off, but we didn't score," Atletico coach Diego Simeone told Movistar. "We've dropped two important points." The Rojiblancos broke the deadlock in the 20th minute when Antoine Griezmann won the ball high up the pitch and crossed for his strike partner Morata to finish consummately. The France forward was impressive again and seems to be returning to his best level. Pathe Ciss headed wide from

just past the post.

The lively striker, on loan from Atletico, nearly set up Falcao to score but Ivo Grbic saved and Gimenez managed to hack the ball away. Griezmann fired home at the other end but the goal was disallowed for a tight offside and Matheus Cunha had a shot saved from a tight angle as Atletico rediscovered some attacking impetus. However, when Gimenez handled a Rayo header in stoppage time they surrendered the three points. Falcao, who played for Atletico between 2011-2013, slammed the penalty into the top corner. "It leaves a bad taste in the mouth," grumbled Morata, after the referee checked the penalty incident on the pitchside VAR screen. "I don't understand anything. When things happen to us, they don't look at it and when we're defending in our box they look at everything." Elsewhere Ernesto Valverde's Athletic, now sixth, were unable to pull themselves back into the top four as they six yards early in the second half as Andoni drew 2-2 at Getafe. Valencia captain Jose

Gaya missed a late penalty amid a chaotic finale as Sevilla held the visitors to a 1-1 draw. Erik Lamela's 86th minute strike earned Jorge Sampaoli's side a creditable draw against Gennaro Gattuso's relentless Los Che, in a pulsating clash at the Ramon Sanchez Pizjuan. Sampaoli was not able to build on his first win since replacing Julen Lopetegui at the helm, but will be happy with a point as Valencia blew the chance to snatch all three in stoppage time. Edinson Cavani sent the visitors ahead with a firm header from Dimitri Foulquier's deep cross in the sixth minute.

Valencia goalkeeper Mamardashvili made two stunning saves in quick succession to deny Rafa Mir, first twisting to tip over a vicious strike, then clawing away a header. Sevilla kept pushing in the second half and Nemanja Gudelj headed against the crossbar. Both sides were guilty of heavy challenges but it created a chaotic, aggressive contest, amid which Sevilla eventually found a leveller through Lamela. (AFP)
