conducted by Union Public Service Commission (UPSC); State Public Service Commissions (SPSCs) for Group A and B (Gazetted and non-gazetted posts Staff Selection Commission (Combined Graduate Level), CAPF for Group 'B'(Non-Gazetted posts).

Implementing Agency and Eligibility: Ministry of Minority Affairs will be the implementing agency and only candidates belonging to notified Minority Communities who clear the Prelim examinations conducted by UPSC; SPSC or SSC etc. and fulfill all other eligibility criteria and conditions will be considered for financial support under the scheme. The eligibility criteria and conditions of the Scheme will be as follows:

- The candidate should belong to one of the Minority Communities notified under Section 2 (C) of the National Commission for Minorities Act, 1992 and should have passed any of the Prelim exams conducted by UPSC, SPSC, or SSC listed at Para 5 of the scheme.
- Total family income of the candidates from all sources should not exceed Rs. 8.0 lakh per annum.
- The financial support can be availed by a candidate only once. The candidate will not be eligible to benefit from any other similar Scheme of the Central or State Governments/UT Administrations. In case the candidate decides to opt for other Schemes; he/she will have to forgo the claim from this Ministry and refund the amount if already availed with 10% interest. He/she needs to give an affidavit to the effect, that he/she is not availing such benefit from any other source.

Procedure: Eligible candidates may apply online through the portal i.e. www.naiudaanmoma.gov.in for availing the benefit under the Scheme within one month from the date of declaration of the result along with all requisite documents. However, Selection Committee can also consider applications received even after one-month time, a press release from Directorate of Social Welfare said.

The Melas will also help in making people aware about the various health programmes being implemented by the Administration besides it will also create awareness on different Health programmes with focus on Ayushman Bharat Health & Wellness Centre and issuance of Ayushman Bharat e-Cards on the spot. During the mela, creation of Unique Health ID under Ayushman Bharat Digital Mission for attendees will be facilitated besides provision of Ayushman Bharat Card under Ayushman Bharat Pradhan Mantri Jan Arogya Yojana. It will also increase health awareness of the population for prevention of various communicable and noncommunicable diseases and provide screening for early diagnosis, basic health care services with drugs and diagnostics, tele-consultation with relevant health specialists and referrals as needed. During the mela, Mobile Food Testing Vans (Food Safety on Wheels) will be deployed for generating awareness on 'Eat Right Movement India' and demonstration of food samples. It will also generate awareness and display IEC on 'Fit India Movement'. Apart from this, multiple activities under 'Khelo India' programmes will be organized for diverse audience. Wellness-related activities like Yoga, Zumba, Meditation etc. will also be conducted for the mela attendees.

The mela aims to generate awareness on kitchen gardens, medicinal plants and home remedies. Services through AYUSH clinics and deployment of Ayushman School Health & Wellness Ambassadors will be provided during the mela. Stalls will also be set up to educate communities about Ayushman Bharat Health & Wellness Ambassador, Health messengers and school health and wellness day will be organised in schools.

The District Women & Child Development teams will engage Anganwadi Workers for community sensitisation about Health Mela and mobilize communities for Health Mela. Issuance of Unique Disability Identity cards for Divyang, awareness on Village Health Sanitation & Nutrition Day for early childhood development, nutrition and sanitation will be organised across the block including awareness generation and display of IEC on POSHAN Abhiyan including takehome ration, nutrition education, immunization, etc.

PRIs have to conduct Special Gram Sabhas before the Health Mela for ensuring community mobilization for Health Melas using local announcement and awareness generation mechanisms.
