





# Gujarat polls: BJP manifesto promises Uniform Civil Code, anti-radicalisation cell, meals at Rs 5, temple circuits

/--/ The ruling Bharatiya Janata Party (BJP) on Saturday released its manifesto for the upcoming Gujarat Assembly polls and promised to implement the Uniform Civil Code (UCC) and also create an 'Antiradicalisation Cell' to identify and eliminate potential threats as well as sleeper cells of terrorist organisations and anti-India

The party's other promises include creation of "20 lakh employment opportunities" and take the state's economy to USD one

The manifesto was released at the state BJP headquarters by party president J P Nadda in the presence of Gujarat Chief Minister Bhupendra Patel and state unit chief C R

The annual cover under the Pradhan Mantri Jan Arogva Yojana (Avushman Bharat) being doubled per family from Rs 5 lakh to Rs 10 lakh, and girls getting free education from "KG to PG" (kindergarten to postgraduation) are among other promises in the manifesto.

On October 29, the Gujarat government had announced that it would form a committee for  $implementation \, of \, the \, UCC.$ The decision was taken in a

cabinet meeting that day. manifesto also promised enactment of the Recovery 'Guiarat Damages of Public and Private Properties Act' to recover the cost of damage caused to public and private properties by antisocial elements during riots and protests.

Other key promises include setting up of two seafood parks in south Gujarat and Saurashtra region, free diagnostic service at health centres and approved laboratories for EWS households, setting up three civil hospitals or 'Medi Cities', two AIIMS-level institutions, and converting

into 'Schools of Excellence'. The BJP also promised to establish four Gujarat Institute of Technology on the lines of the Indian Institute of Technology

Talking about farmers, Nadda said the BJP, if voted to power, will spend Rs 10,000 crore for the overall development of APMCs, mandis, sorting and grading cold chains, warehouses and processing centres, while Rs 25,000 crore will be spent to strengthen the irrigation

Devbhumi Dwarka Corridor to establish it as western India's biggest spiritual centre. It will have the world's tallest Sri Krishna statue, ED immersive Bhagwat Gita zone and a viewing gallery for the lost city of Dwarka," the manifesto stated.

The state will see twophase Assembly polls on December 1 and 5, while the votes will be counted on December 8. It is witnessing a three-cornered fight with the BJP, Congress and Aam Aadmi Party (AAP) in the fray. (PTI)

THIRUVANANTHAPURAM, NOV 26 /--/ Kerala chief minister Pinarayi Vijayan on Saturday said constitutional values like secularism, democracy and federalism are facing serious challenges in the country and hurdles are being created in realising the true federal concept of complacent states, a strong Centre and dynamic local self-

threat, says Kerala CM

The fundamental democratic principle that the state governments, elected by the people of the respective states, the development of the country is being forgotten, he said in his Constitution Day message. Since 2015, November 26 is observed as Constitution Day to commemorate the adoption of the Constitution of India by the Constituent Assembly in 1949.

Earlier, the day was observed as Law Day. "India's Constitution, which encompasses the ideals of our antiimperialist struggle, is facing a wide array of challenges on this 73rd anniversary of its adoption. It's time to join the fight to fend off such threats and defend its spirit and values on our #ConstitutionDay," Vijayan tweeted. Indirectly referring to the ongoing tussle between his government and Governor Arif Mohammed Khan, the CM said even those holding high Constitutional positions are being used to pressurise elected governments is one of the concerns on this Constitutional Day. "Today, the values of secularism, democracy and federalism in our country are facing serious challenges...The challenges being faced by our Constitution, even on the 73rd anniversary of its adoption, are not just trivial." he said.

Targetting the Centre, he said there are moves to make citizenship in accordance with ones' religion and the public sector undertakings (PSUs) are being sold off one by one in the country. The Marxist veteran further charged that employees' rights were being stripped off and the Constitutional principles of secularism were being subverted in the higher education sector. All of these are being challenged legally and through protests in the public sphere and this "objection is the voice for the protection of the Constitution", he added. The Constitutional Day is also an occasion to renew our pledge to counter such challenges and to preserve and protect constitutional values and principles. (PTI)

# J&K's final electoral rolls: Political parties say studying details of new voters, want elections now

SRINAGAR, NOV 26 /--/ A day after the final electoral roll of Jammu and Kashmir was published, political parties in Kashmir on Saturday said while they were  $studying the {\it details}\, about \, the$ addition of new voters, the **Election Commission should** now announce assembly polls for the union territory

The final electoral roll of Jammu and Kashmir was published on Friday with the highest-ever net addition of more than 7.72 lakh voters, officials said. It has a total of 83.59.771 electors -- 42.91.687 males, 40.67,900 females and 184 third gender -- Joint Chief Electoral Officer of Jammu and Kashmir Anil Salgotra had said. National Conference spokesperson Tanvir Sadiq saidaroundsevenlakhvoters have been added and the party will have to see as to how many of them were those voters who have turned 18 from the last revision till now. "We are studying the details of it, constituency-wise," he told PTI. Sadiq, however, said, now that the whole process is over, the party expects the Election Commission(EC)tocomeout and talk about assembly elections in Jammu and Kashmir. "How long should the people of Jammu and Kashmir be deprived of a representative, responsive government? So, this is the first and foremost that the ECshould come out and state about how soon will they hold elections in Jammu and Kashmir," he said. With the

release of the final electoral roll, Sadiq also expressed hope that now the confusion andresultingapprehensions about addition of 25 lakh new voters, as the then CEO of Jammuand Kashmir Hridesh Kumar had said in a press conference in August, will be puttorest."We also expect the whole confusion and the apprehensions of the people are addressed," he added.

Party (PDP) said it would be important to wait and see who these new voters are. "How many of them are the people who were otherwise the state subjects and how many are those who acquired domicile certificates. These details are vet to come out. It will be very important to see that breakup," party chief spokespersonSuhailBukhari said. On the question of assembly elections, Suhail Bukhari said the present dispensation has "snatched all rights" from the people of Jammu and Kashmir and their democratic rights were not an exception. "We really do not expect things from them, because they have beengivingstatementswhich are contradictory on one hand saying the security situation has improved and is great, but, on the other saying, that once the situation improves, elections will be held, and then the statehood (will be restored)," he said. Peoples Conference spokesman Adnan Ashraf Mirsaid as the final rolls were published only on Friday, "it will take us sometime to study it before

#### Contribution of women members of Constituent Assembly rarely discussed: Modi

NEW DELHI, NOV 26 /--/ Prime Minister Narendra Modi on Saturday lamented that the contribution of women members in the Constituent Assembly is rarely discussed even as he stressed on the need to make the youth better understand the Constitution.

Addressing the Constitution Day event at Supreme Court in the presence of Chief Justice of India DY Chandrachud and other judges, he said the future of India's Constitution and institutions rests on the shoulders of the youth. Modi said there were 15 women members in the Constituent Assembly with one of them being Dakshaavini Velayudhan -- a woman who had come out of the deprived society. She made important interventions on many topics related to Dalits and labourers, he noted. Durgabai Deshmukh, Hansa Mehta, Rajkumari Amrit Kaur, and many other women members had also contributed significantly on topics related to women. "Their contribution is rarely discussed," he underlined. He said there is another feature of the Constitution which has become even more relevant in today's

The Constitution makers gave us a document which is open, futuristic and known for its modern vision, which makes it youth-centric, the prime minister said. He said be it sports or startups, information technology or digital payments, youth power is making its mark in every aspect of India's development. He said in order to increase the understanding about the constitution among youth, it is necessary that they become a part of debates and discussions on constitutional subjects. This, Modi said, will further increase their interest in the constitution. This will create a vision among the youth to understand topics such as equality and empowerment. (PTI)

#### 'Sheer hypocrisy': Congattacks PM on Constitution Day

NEW DELHI, NOV 26 /--/ Accusing Prime Minister Narendra Modi of "hypocrisy", the Congress on Saturday alleged that the "ideological fountainheads" of the BJP had nothing to do in the making of the Constitution and he decided to mark November 26 as Constitution Day as he "desperately"

The Opposition party's attack came hours after Prime Minister Modi addressed Constitution Day celebrations at the Supreme Court. "The draft Constitution was adopted by Constituent Assembly on 26.11.1949. Constituent Assembly decided it would come into force from 26.01.1950 which is since celebrated as Republic Day," Congress general secretary in-charge communications Jairam Ramesh said in a tweet. Ideological fountainheads of BJP had nothing whatsoever to do in making the Constitution, he said in a series of tweets. "In fact the RSS was opposed to the Constitution of India.  $Desperately\,wanting\,to\,show\,that\,he\,respects\,the\,Constitution$ while he subverts it daily in letter and spirit the prime minister decided to celebrate November 26 as Constitution Day. This is sheer hypocrisy," Ramesh said.

Babasaheb Ambedkar made one of the greatest speeches of the twentieth century on November 25, 1949, while piloting the final draft of the Constitution, Ramesh said. "It's a speech worth reading over and over again. I wish to remind the prime minister and his drum beaters of just two paras from that speech," the Congress leader said sharing screen shots of portions from the speech. "The task of the drafting committee would have been a very difficult one if this Constituent Assembly has been merely a motley crowd, a tessellated pavement without cement, a black stone here and a white stone there is which each member or each group was a law unto itself. There would have been nothing but chaos," Ambedkar had said. "This possibility of chaos was reduced to nil by the existence of the Congress Party inside t Assembly which brought into its proceedings a sense of order and discipline," he had said. "It is because of the discipline of the Congress Party that the Drafting Committee was able to pilot the Constitution in the Assembly with the sure knowledge as to the fate of each article and each amendment. The Congress Party is, therefore, entitled to all the credit for the smooth sailing of the Draft Constitution in the Assembly," Ambedkar had said.(PTI)

#### Conversion of Supreme Court into small causal court must stop: R Venkataramani

NEW DELHI, NOV 26 /--/ Attorney General for India R Venkataramani on Saturday stressed on the need to decongest the Supreme Court and said it is important that the government stops overloading it with endless statutory appeals and huge flow of cases from high courts. Addressing a gathering at the Constitution Day celebrations at the Supreme Court. Venkataramani said there is a need to have a litigation policy for the government so that every matter does not become a matter of litigation. "It is important that the government stops overloading the Supreme Court with endless statutory appeals alongside seamless and huge flow of cases from high courts. Venkataramani said every department must have a resolution wing with competent and independent legal equipment to resolve facts based issues. "Only complex matters with legal issues which cannot be resolved must go for institutional resolution. I am confident the government will give an ear to an earnest attorney general to draw a quick roadmap," Venkataramani said at the event also attended by Prime Minister Narendra Modi, Law Minister Kiren Rijiju and Chief Justice of India DY Chandrachud. # Woman ragpicker shares her woes with Rahul Gandhi in MP town during his Bharat Jodo Yatra

BARWAHA, NOV 26 /--/ Congress leader Rahul Gandhi interacted with a woman ragpicker as his Bharat Jodo Yatra passed through a town in Khargone district of Madhya Pradesh on Saturday, during which she told him about the issues she and her family faced, including lack of basic amenities like electricity and water.

The foot march led by Gandhi entered the fourth day of its Madhya Pradesh leg on Saturday. After an overnight halt, the yatra began from Mortakka in Khandwa district in the morning. When it was passing through Barwaha town in Khargone, Gandhi met 45-year-old ragpicker Shannu and her family members, who were part of the crowd standing along the road. "We are poor and make a living through ragpicking at different places. We live in a hut, which doesn't even have

Officially, the Pakistani Military has taken over national leadership of Pakistan thrice (1958-71, 1999-2008). Unofficially, it has been under the Khakhi coloured Dock Marten boots since 1958, barring the post-71 phase of Pakistan's 'worst hour' till the return of the 'establishment' (read, Pakistani Military) with General Zia-ul-Haq in 1978.

Each of three times that the surly and burly Generals took over the Pakistani leadership, they had double-crossed the same political power that was responsible for their ascendancy to Generalship. Biting the same hand that feeds, is a consistently repeated phenomenon. The trend started with the then Defence Secretary Iskandar Mirza lobbying for the junior-most Maj Gen Ayub

native Commander-in-Chief of Pakistani Army (despite Ayub's name not even figuring in the nomination list). Later as President, Iskandar Mirza, abrogated the constitution and declared Martial Law with General Ayub Khan as the Martial Law Administrator (CMLA) within 20 days of the move, General Ayub bumped Iskandar Mirza banished him to England! Decades later, Zulfigar Ali Bhutto superseded seven senior Generals to appoint the junior-most Lt Gen in seniority, Zia-ul-Haq, as the Army Chief. Despite his junior-most status, Zia also had a dodgy track record, creepy nature and above all, and reputation of being overtly obsequious and beholden to Zulfiqar Ali Bhutto - in less than a year of becoming the Army Chief, General Zia declared

Khan to become the first

Martial Law and a couple of years thereafter, sent his initial benefactor to the gallows! A couple of decades later, General Zia's political protégé Nawaz Sharif, too sprung a similar surprise when he appointed an ostensible 'safe' Pakistani Army Chief in General Pervez Musharaf, superseding two seniors. History was to repeat for the third time with General Pervez Musharaf deposing the man who made him the COAS and banished the hapless Nawaz to Saudi

Interestingly each of the three civilian governments that were dethroned in the coup d'états represented the 3 varied persuasions of Pakistani politics Musharaf had removed PML-N dispensation, Zia had removed the PPP dispensation and Ayub had removed an illiberalauthoritarian strain (closest

in instinct to Imran Khan's PTI) in bumping-off Iskander Mirza. Also, each of these Military usurpers were from the so-called 'minority/safe' ethnic denominations as Ayub was

a Hazara from Haripur (and not a Pathan as popularly postured), while both Ziaul-Haq and Pervez Musharaf were Mohajirs (immigrants from India).

ultra-ambitious These Generals were not from the traditional Punjabi (Rajput/ Jat) or Pathan ethnicity that makes the bulk of Pakistani soldering stock, yet their institutionalised bearing allowed them to roughshod well-entrenched

However even when the politicians ostensibly ruled the roost, the decisive imprint of the 'Army House' in overruling the politicians, who were in fact responsible for their appointment as Chief of Pakistan Army, is consistent.

Waheed Kakar forced Nawaz to resign, next was Gen Jehangir Karamat who was forced into premature retirement, third was Gen Pervez Musharaf whose revenge needs reiteration, fourth was Gen Kayani who unilaterally gave himself a

second term, fifth was Gen Raheel Sharif who gave Nawaz sleepless nights with his popularity and talks of an extension (though didn't take) and the sixth, is the current Gen Qamar Bajwa who in 2018 was singularly responsible for dumping Nawaz and 'selecting' Imran Khan as Prime Minister!

Today, ironically it is the same Gen Qamar Bajwa who has done a complete 360 degree turn by flirting with Imran's PTI (till Imran got too big for his own boots) and then returned to the coalition of PML-N and PPP. Pakistani

'establishment' or Military has always been its own entity with no permanent loyalty to any political leader, partisan flag or ideology - it has sided tactically with PML-N, PPP or even PTI as it deemed topically necessary, but never subscribed or rooted itself into any partisan preference, for long.

With this backdrop, topicality suggests that the next Chief (as confirmed by Gen Qamar Bajwa in Washington DC, hence believable) will certainly not be from Imran's preference e.g., Lt Gen Faiz Hameed (previous DG-ISI, believed to be close to Imran).

It is also clear that the Sharif brothers, though in a coalition with PPP may not take to kindly to a perceived PPP loyalist like Lt Gen Mohammad Amir (once the Military Secretary to Asif Zardari). It will also stay away from appointing anyone with known religious conservatism as 'establishment' fears a redux to Zia's 'shariaization'. Even suggestions of manipulating the system to accommodate

any contender would be avoided, and that may cost Lt Gen Asim Munir to be left out. The law of elimination leaves the field to the likes of Lt Gen Sahir Shamshad Mirza, Lt Gen Azhar Abbas and Lt Gen Nauman Mehmood to fill the posts of the Chief of Army Staff and the nominally more senior, Chief Joint Chiefs of Staff Committee

All three are supposedly experienced professionals with no known partisan loyalty or overt religiosity thus affording farcical optics of the 'final word' to the civilian politicos in Islamabad, whilst having the institutionalised clearance from the 'establishment' in Rawalpindi GHQ. 

#### From prisoner to PM: Aroller-coaster political journey for Anwar

More than two decades after his dramatic ouster from government and imprisonment, Malaysian oppositionleader Anwar Ibrahim finally had his day. Becoming Malaysia's 10th prime minister caps Anwar's roller-coaster political journey, from a former deputy prime minister whose sacking and imprisonment in the 1990s led to massive street protests and a reform movement that rose into a major political force. It is a second victory for his reformist bloc, which won 2018 polls but lost power after 22 months due to a power struggle that has led to continuous political turmoil. Last Saturday's election, which was supposed to end the instability that had led to three prime ministers since 2018, instead produced new uncertainty after no party won a clear mandate. Anwar's multi-ethnic Alliance of Hope, led with 82 seats, short of the 112 needed for a majority. Muhyiddin's right leaning National Alliance won 72 seats, with its ally Pan-Malaysian Islamic Party emerging as the biggest single party with 49 seats. Anwar emerged victorious after smaller blocs agreed to back him to form a unity government. Still, he faces a tall task in bridging racial divides that deepened after Saturday's polland revivinganeconomystrugglingwithrisinginflation and a currency that has fallen to its weakest point. Malays are two-thirds of Malaysia's 33 million people, which include large ethnic Chinese and Indianminorities.

Anwar's political struggle is of a comparable level as South Africa's Nelson Mandela, as both went through many persecutions in the process of democratising their countries. It is hoped that with Anwar in charge, Malaysia could revert to a more open and inclusive society and economy that would hopefully restore its prestige on the world stage. Anwar, 75, had been on the cusp of power twice. A firebrand youth leader, Anwar founded an Islamic youth movement before he was recruited into the then-ruling United Malays National Organisation. He enjoyed a meteoric rise to become deputy prime minister-cum-finance minister in the 1990s and was groomed to take over from then Prime Minister Mahathir Mohamad but a bitter fallout over Malaysia's response to the Asian economic crisis saw Anwar sacked in September 1998, detained without trial and then charged with sodomy and corruption Tens of thousands took to the streets to protest Anwar's treatment. When Anwar was brought to court with a black eye nine days after his arrest "due to an assault in custody by the country's then police chief"itquicklybecameasymbolforhisnewPeople's Justice Party and its vows for reforms. He was jailed six years for sodomy in 1999 and a year later, another nine years for corruption -- charges Anwar said were a political conspiracy by Mahathir to end his career. His case drew international criticism, with Amnesty International calling Anwar a prisoner of conscience. Anwar was freed in 2004 after Malaysia's top court overturned his sodomy conviction, a year after Mahathir stepped down as prime minister after 22 years in power. But Anwar was imprisoned a second time for sodomy in 2015, in a case he said was aimed at crushing his alliance which was making gains against the UMNO-led government. Yet, he didn't give up. The rest is history.

# SC warning to NIA is an eye opener

The National Investigating Agency (NIA) under Union Home Minister Amit Shah as Union Minister of Home Affairs has now gained enough notoriety in the public as violators of rule of law and even the order of the courts of justice. NIA's attitude towards the human rights defenders have even been heavily censured by UN human rights body for victimisation of those who cooperate with their investigation. Now the Supreme Court of India has to warn the super power investigating agency for defying its orders.

All these are giving more credence to the old allegations that the NIA has been misused under Modi regime to hound the human rights activists, and the agency officials have been ignoring all rules of law and even directions given by the Supreme Court of India. This allegation labelled on NIA is similar to other allegations on almost all central investigating agencies like CBI, Enforcement Directorate, and Income Tax Department etc that are said to be misused to victimise political opponents. NIA has even been caught in the act of defying rules of law and court orders by a Supreme Court bench comprising Justices KM Joseph and Hrishikesh Roy. The bench had passed an order on November 10 permitting the transfer of Bhima Koregaon case accused Gautam Navlakha from Taloja jail to house arrest, however, the order was not carried out until November 18. Not only that, in their audacity, NIA moved an application to the bench seeking to vacate the Court's order.

The 'intention to victimise', whether it was of the NIA officials or of someone in the Union Government, has always been suspected in the Bhima Koregaon case. In Navlakha's case when the order was passed by the Supreme Court on November 10, NIA became super active to find ways an means for not carrying out the orders. The Agency moved NIA Special Court at Mumbai and just objected the location chosen by Navlakha to be kept in house arrest. On NIA's

objection, the Special Court on Wednesday refused to pass order to execute the house arrest of Navlakha. This prompted Navlakha to go again to the Supreme Court bench where he told the court that implementation of the November 10 order granting him house arrest was being delayed. The bench heard his petition on November 18, and had to caution NIA when it found that the agency was looking for ways to defy the Court's orders. The bench then gave the agency 24 hour time to carry out the order for Navlakha's house arrest while dismissing the NIA's application seeking to vacate the Court's order of November 10. Everybody known how the parties in litigation find loopholes in laws and orders to violate and defy them. In the present case Additional Solicitor General SV Raju had also submitted that every time the NIA pointed out a loophole, the petitioners said that they would close it. "What if it turns out to be a gaping hole."

Justice K M Joseph then remarked, "We can take it another way, if you are taking loopholes to defy our orders, then we will take a serious view.'

NIA in their application had cited that the medical report of Juslok Hospital which examined Navlakha was 'biased' and that he had suppressed certain material facts before the Court. On this came the Justice Roy's comment that reveals the level of NIA's performance. "If with the entire police force you cannot keep a watch on a 70 year old ailing man, they think about the weakness ... please do not say such things. With all the might of the State, you are not able to keep a 70 year old ailing man in house confinement,"

commented Justice Rov. NIA had also contended that the petitioner had tried to mislead the court with regard to the location of his house arrest. It said that the petitioner was currently residing at the top floor of a public library under the Communist Party. NIA and the Government's political bias and attitude of victimisation was further revealed in their submission that "it is inconceivable how the house arrest of a person who is accused of Maoist activities be carried out in building which is a public libraray/Bhawan registered in the name of a political party, ie the Communist Party.'

When this aspect was brought to light by SG Tushar Mehta before the bench, Justice Joseph asked, 'What is this political party argument? ... Is the Communist Party not a recognised party?'

How much political bias was there was revealed further in the statement of SG Mehta who said, "If that does not shock this court, I will leave it at that. ... A person accused of indulging in a serious terrorist act being a Maoist is staying at some political party's office? What is this institution being driven to?'

It was replied by the Senior advocate Nitya Ramakrishnan appearing on behalf of the petitioner, 'The Communist party itself condemns Maoists. Anybody with basic understanding of contemporary politics will know that Communist party is a recognised party."

Bombay High court's comment that came out today regarding performance of NIA is even more shocking, as regards to 2018 Elgar Parishad (Bhima Koregaon) case. The court while granting bail to Anand Teltumbde (73) said that on the basis of case record it cannot be concluded that he indulged in terrorist act. The bail is a first on merit in the case. The court found lack of corroboration in NIA case and prima facie inadmissible "hearsay evidence". NIA case primafacie inspires no confidence, said the High Court. (IPA)

# APan-Indian Law against 'forced' conversions should respect right to privacy

Religious conversion is a topic that has remained central to the country's politics. It also gained significant attention in many recent intellectual debates and discussions on freedom of religion. Article 25 of the Constitution grants "freedom of conscience and free profession, practice, and propagation of religion" to the non-citizens and citizens of the country. The questions like what is the scope of the article and whether it also includes "freedom to convert to other religion" have always posed difficulties for those who interpreted the provision.

Many politicians claim that increasing religious conversions acrossthe country and the so called "love jihad" made it an absolute necessity for the legislators to formulate anticonversion laws and implement them stringently across the State. However, the blatant imposition of these laws not only deters the 'forced conversions' but also acts as an impassable wall for the rightful conversions.

The first state to enact an anticonversion law was the government of Odisha (then Orissa). The Orissa Freedom of Religion Act, 1967 was enacted by the state government to deal with the forced conversions. Section 3 of the Act provided that, "no person shall convert or attempt to convert, either directly or otherwise, any person from one religious faith to another by the use of force or by inducement or by

any fraudulent means nor shall any person abet such conversion." (emphasis supplied)

The following year, Madhya Pradesh also came up with the Madhya Pradesh Dharma Swatantra Adhiniyam of 1968, which was almost parallel to the act passed by Odisha. Instead of going with the term 'inducement,' the legislators used the term 'allurement' which was defined under Section 2(a) as an "offer of any temptation in the form of any gift or gratification, either in cash or kind; (ii) grant of any material benefit, either monetary or otherwise.'

According to the rules under the Act, anyone who aspires to switch to another faith must first declare their intention to do so to a Magistrate. The District Magistrate must be notified fifteen days in advance by the priest who will officiate the event. The Superintendent of Police, who is responsible for relaying the information to the relevant police station, is then informed by the District Magistrate. The next step is for the officer-in-charge to find out if there are any objections to the proposed conversion. Both Acts made the offences committed under the act cognisable and imposed a penalty of up to one year in prison and a fine of INR 5,000. In case a minor, woman or a member of scheduled caste or scheduled tribe, imprisonment could be extended up to two years imprisonment, and a fine of INR 10,000.

Naturally, legislation like these which impose such restrictions on the rights of individuals would be subjected to the scrutiny of the courts. Accordingly, both state laws were challenged in the high court of their respective states.


The Orissa Freedom of Religion Act was challenged before the High Court of Orrisa in the case of Mrs. Yulitha Hyde and Ors. vs State of Orissa and Ors. (1972). In this case, while declaring the act void and ultra vires of the constitutional values, the court held that the term "inducement" is ambiguous and many proselytising activities may fall within its scope. Further, the court observed that conversion to religion must be included in the right as far as a Christian citizen is concerned. This is because the true scope of the right guaranteed under Article 25(1) must be considered to broaden the ambit of the propagation of religion. It was also held that the legislature of state lacked the requisite jurisdiction or competence to make the law on the topic of "religion."

As a result, the court acknowledged for the first time that the right to conversion is a fundamental right under Article 25 because it is a necessary corollary for Christians for their religion to be propagated.

The act, along with the Madhya Pradesh Dharma Swatantrya Adhiniyam, was further scrutinised by the Supreme Court in the case of Rev. Stainislausvs State of Madhya Pradesh (1977). Here, the court disagreed with the stance taken by the High Court of Orissa and observed that: "the word 'propagate' has been used in Article 25 (1), for what the Article grants is not the right to convert another person to one's own religion, but to transmit or spread one's religion by an exposition of its tenets." (emphasis supplied)

The court was of the view that it is important to keep in mind that Article 25(1) guarantees 'freedom of conscience' to all citizens, not just to those who adhere to a particular religion.

This implies that there is no fundamental right to convert someone to one's own religion because doing so would violate the 'freedom of conscience, 'as it would be different from the effort of a person to transmit or spread the tenets of their religion. (IPA/ To be continued)

Reaffirming his commitment to implement the UCC, he said, "..we have been talking about uniform civil code from the time of Deendayal Upadhyay.

There is a serious thought going on in the country at the national and state level. There is also an intention to implement it when the right time comes." "... we are also discussing how to do (implementation) it in our state." Bommai also told the gathering that the state government will take all necessary measures to implement it.

"I would like to say very clearly that we not only expound things we believe in that can make people's

welfare possible and bring equality, but also will take all strong measures to implement it," the Chief Minister explained. On the anti-conversion law which the BJP government in Karnataka has introduced, Bommai said many people called it anti-constitutional, but now the Supreme Court has passed an order, saying that forced conversion is a crime. "Whenever we think of introducing reforms to bring equality in the society, most often it is wrongly interpreted," he said.

A few BJP-ruled states in the country like Assam and Uttarakhand have their expressed intent to implement the UCC. The Chief Minister also said his party has a strong belief that devotees should manage the temples. In the coming days, provisions will be made in that direction. # Constitution faces existential crisis, India no longer collaborative federal nation: Cong chief's dig at Centre

NEW DELHI, NOV 26 /--/ Congress president Mallikariun Kharge Saturday hit out at the government alleging the Constitution faces an existential crisis and India is no longer a collaborative federal nation. In a statement on Constitution Day, Kharge alleged ever since the BJP government came to power in 2014, the RSS has used it as a political vehicle to curtail freedoms enshrined in the Constitution. "Illegal has become legal because the fringe has now become mainstream. The foremost tangible spirit of our democracy is being distorted and disrespected by people who are using it as a means to push a completely contrasting agenda," the Congress leader said. In his statement titled 'The Looming Crisis of the Indian Constitution', Kharge said India's first president Rajendra Prasad had said: "If the people who are elected are capable men of character and integrity, they should be able to make the best of a defective constitution. If they are lacking in these, the Constitution cannot help the country." Kharge claimed that "these words ring deafeningly true as we celebrate the 73rd year of the Constitution". A Constitution that has successfully stood the test of time for over seven decades, "today faces a fundamental crisis, indeed an existential crisis for the spirit behind its text", the Congress president claimed. "We have reached a point where there is a growing disharmony, not just among people but also between governments and states. Ours is no longer a collaborative federal nation," he said. The Congress chief claimed that "this crisis finds its roots in the RSS's ever-expanding reach within state institutions and the electoral (and by extension judicial) legitimacy of its ideology, with BJP in power". "The government has completely surrendered itself and its institutions to the diktats of the RSS, an organisation that pushes hateful propaganda under the garb of social service. In fact, it is no longer incorrect to use the terms RSS and  $\ensuremath{\mathsf{BJP}}$ interchangeably," he noted. "We are witnessing the onset of what Baba saheb

(Bhimrao Ambedkar) would have referred to as 'lawless law', riddled with never-ending infringements on fundamental rights, systematically engineered by the BJP-RSS government since they have been in power,' he also said. The Congress chief recalled B R Ambedkar's caution that "if the parties place creed above country, our independence will be put in jeopardy a second time and probably be lost forever. This eventuality we must all resolutely guard against". He said the Congress has embarked on the Bharat Jodo Yatra to unite the nation against forces of hatred and divisiveness. "Let us unitedly take ownership of bringing India back to its constitutional values and restoring the nation to a time when these values thrived. The only way to control this new hegemonic disposition is to counter it with ideological and moral strength," Kharge said. The Congress chief also alleged that within the system, the ruling party has restricted the Opposition's all avenues to express dissent. "Routine muting of microphones in Parliament whenever the BJP's (in)actions are questioned and spaces in the media that are accessible to us are shrinking every day," he said. Kharge also attacked the government over the "misuse" of agencies against the opposition, saying, any dissent is being "tackled by coercively misusing central investigative agencies" against them. "The functioning and independence of the Election Commission of India have been jeopardised. Opaque system of Electoral Bonds enforced as money bill has been brought to give undue advantage to the ruling party," he alleged. Kharge claimed that the law minister lectures the Executive and Judiciary by saying "'Aapas mein ladne ka koi fayda nahi hai (There's no point in infighting)". "The BJP/RSS and its messengers are dividing the country along religious, caste and communal lines. "There is moral surveillance in all public arenas. Privacy is being banished. Citizens and the civil society have been mercilessly attacked by the topmost echelons of power, for raising their voices," Kharge alleged. (PTI)

Tributes were also paid at the places targeted by terrorists including Chhatrapati Shivaji Maharaj Terminus, Cama and Albless Hospital, Hotel Taj Mahal Palace, the Oberoi Trident, Nariman House, the Jewish community centre, and the memorial of ASI Tukaram Omble who was martyred while overpowering Ajmal Kasab, the only terrorist who was captured alive. # Legislature, executive, judiciary need to have 'one thinking' for country and its people: Prez

NEW DELHI, NOV 26 /--/ President Droupadi Murmu on Saturday said the legislature, the executive and the judiciary need to have "one thinking" for the country and its people.

In her valedictory address at the Constitution Day celebrations organised by the Supreme Court here, she suggested decongesting jails by helping poor people languishing there for years for petty crimes. "It is said that jails are getting overcrowded and there is a need to set up more jails. Are we moving towards development? What is the need to set up more jails? We need to reduce their numbers." Murmu said in Hindi. The President said there is a need to do something for these poor people in prisons. "You need to do something for these people. Who are these people in jail? They do not know the fundamental rights, preamble or the

fundamental duties," the President said while addressing the event. Chief Justice of India D Y Chandrachud and Union Minister of Law and Justice Kiren Rijiju also attended the event. The President said: "The three wings of the government -- legislature, executive and judiciary -- there has to be one thinking somewhere for the country and its people (Sabka mann, sabki soch ek honi chahiye)." Checks and balance need to be there, but somewhere we need to work together, she said.

"Our job is to think about people (poor undertrials languishing in jails). We all have to think and come out with some way I am leaving it all on you," Murmu said amid huge rounds of applause. She said these people are in jails for slapping somebody or for similar minor offences, and they were slapped with legal provisions even as

some of these provisions do not apply in such cases. "I come from a very small village. Where I was born, people there considered three people as god -- teachers, doctors and lawyers," the President said.

People are even willing to give away all their money and property to doctors and lawyers to help them overcome their troubles, the President said. Murmu said people do not get their family members freed from jails as they feel their properties and utensils at home would have to be sold (in the process). On the other hand, there are some people who do many things, even kill others, but they are roaming free, she said. "It (cases of people landing up in prison after doing petty crimes) is a burden on the government I leave this to you (referring to judges and the law minister)," the President added. (PTI)

# Essential to make process of litigation citizen centric, technology must be augmented: CJI

NEW DELHI, NOV 26 /--/ Chief Justice of India (CJI) D Y Chandrachud on Saturday said technology must be augmented with institutional reforms to resolve issues of access to justice, and it is essential to simplify the litigation process and make it "citizen centric". The CJI also said the judiciary has been adopting technology to improve the working of courts and it is of "supreme importance" that courts are remodelled to reach out to citizens instead of them reaching out to courts in their quest for justice. Speaking at the Constitution Day celebrations at the Supreme Court, the CJI said judges across the country must reflect upon the constitutional vision of securing justice, equality and liberty. He said it is important that representation of marginalised communities and women in the legal profession and judiciary is increased. Justice Chandrachud also spoke about the e-initiatives -- virtual justice clock, justIS mobile app 2.0, digital court and s3WaaS websites of district

courts -- that were launched by Prime Minister Narendra Modi during the function. In a nation as large and diverse as India, the "paramount challenge" the judiciary faces as an institution is to ensure that the justice delivery system is accessible to everyone, he said. "We have been adopting technology to improve the working of courts. It is of supreme importance and necessity that courts are remodelled to reach out to people instead of people reaching out to courts in their quest for justice," the CJI said. "To ensure that courts reach out to people, it is essential that the process of litigation is simplified and made citizen centric," he said. Justice Chandrachud said though the judiciary's engagement with technology gained prevalence during the Covid-19 pandemic, "we must not dismantle the infrastructure but built upon it". "I will earnestly request the chief justices of high courts to ensure that the technological infrastructure, on which public funds have been spent, is not dismantled but

strengthened further," he said. Justice Chandrachud said as the CJI, he is attempting to adopt technology based services in listing of cases and court hearings "so that institutional flaws such as delays in listing and hearing can be removed from our vocabulary" "While technology has ably aided us in ensuring functionality of the judiciary during the pandemic, technology must be augmented with institutional reforms to resolve the chief issue of access to justice," he said. The CJI said the first interface of people with the judicial system is the district judiciary and it is of paramount importance that it is strengthened and supported. "The district judiciary must be lifted from the mindset of being a subordinate judiciary," he said. Giving details of the e-initiatives launched by the prime minister, Justice Chandrachud said these initiatives reflect upon the commitment of judiciary towards providing access to justice. "Our endeavour is to enhance access to

the Turkish President, during the inauguration on Friday said that the launch of PNS Khyber represents the deepening of defence cooperation between the two nations. the state-run Associated Press of Pakistan reported. "It was high time that Pakistan and Turkiye transform their ties into a strategic partnership as the world was envious of the relationship between two brotherly countries," Sharif said during the inauguration of PNS Khyber at the Istanbul shipyard. He said that the launch of the ship manifested the deep bilateral engagement between the two countries in defence cooperation. PNS Khyber is third of the four corvette ships that has been built by Turkive for the Pakistani Navy under a joint cooperation project. Under the project, Turkiye was tasked to build four corvette warships for the Pakistan Navy-- two in Istanbul and two in

The first corvette warship for the Pakistan Navy known as PNS Babar was launched in Istanbul in August 2021 while the foundation stone for the second ship PNS Badr was laid in Karachi in May 2022, another report on the inauguration ceremony by the Dawn newspaper said. The warships have been built by ASFAT inc, a Turkish stateowned defence contractor firm. Sharif during the inauguration informed that the fourth warship would be delivered in February 2025. Sharif on the occasion called for the need to enhance trade between Pakistan and Turkiye. He also made a pitch to Turkish entrepreneurs to invest in a 10,000-megawatt solar power project for Pakistan, the report said. (PTI)

#### **Pricy sculpture for UK** PM Rishi Sunak's garden attacked as "extravagant"

LONDON, NOV 26 /--/A bronze sculpture by a celebrated English artist has come under fire as "extravagant" after the UK government spent GBP 1.3 million of taxpayer's money to acquire it and then send it on for British Prime Minister Rishi Sunak's 10 Downing Street garden.

According to The Sun newspaper, Henry Moore's 'Working Model for Seated Woman" an abstract 1980 sculpture is believed to have been sold at a Christie's



by the taxpayer-funded Government Collection last month. It has sparked a cost-ofliving row at a time when the country is struggling through soaring inflation, mounting household bills, and cost-cutting measures across public funding. "It is a fine piece and an important example of Moore's collection of seated

auction and acquired

women sculptures," an expert told the newspaper. "However, it may be considered an extravagant use of public funds, particularly given the economic climate," the expert said. Downing Street said no politicians were involved in the decision to acquire the artwork after the partially-covered sculpture was seen being wheeled into No. 10 on Thursday. It "conveys a strong sense of maternity and pregnancy", according to Christie's website. It lauds "the gentle watchfulness of the woman's face and her guarded posture to the protective nature of her arms and the architectural shelter she offers between her lap and shoulders", the website adds. There has been a Moore piece in 10 Downing Street garden for the past 40 years, with works regularly rotated at the request of the late sculptor's charitable foundation.

The UK's Government Art Collection owns more than 14,000 such valuable art pieces in buildings across the political establishment at Whitehall in London and around the world. Henry Spencer Moore, who died in 1986, is considered one of the most important British artists of the 20th century and arguably the most internationally celebrated sculptor of the period. He is renowned for his semi-abstract monumental bronzes seen all over the world, including in India. (PTI)

#### Landslide leaves up to a dozen missing on Italian island

MILAN, NOV 26 /--/ Heavy rainfall triggered landslides early on Saturday on the southern Italian island of Ischia that collapsed buildings and left as many as 12 people missing.

Italy's interior minister said no deaths had yet been confirmed, appearing to contradict announcement by another senior politician, "At the moment there are no confirmed deaths," said Interior Minister Matteo Piantedosi, speaking from the firefighters emergency coordination centre, Italian

Vice Premier Matteo Salvini, who is also the infrastructure minister, earlier had said that eight deaths had been confirmed, speaking to reporters at the opening of a subway extension in Milan. The prefecture for the Naples region, which includes Ischia, said at least 12 people were missing. Video from the island shows paths that the landslides had cut down slopes, leaving behind traces of mud. Streets were impassable and mayors on the island urged people to stay at home. At least 100

people were reported stranded. The news agency was previously

ANSA reported that at least 10 buildings had collapsed. One family with a newborn reported missing had been located and was receiving medical care, according to the Naples prefect, Claudio Palomba. Firefighters were working on rescue efforts. Reinforcements were being sent from nearby Naples, but were encountering difficulties in reaching the island either by motorboat or helicopter due to the weather, (AP)

## Lanka Tamil parties to press for autonomy in a new Constitution

minority parties who had an intra-party discussion following president Ranil Wickremesinghe's invitation to talks have agreed to put forward a three-point formula, including their push for federalism, a Tamil National Alliance (TNA) source said on

The island nation's all Tamil political parties based in the East and the North on Friday met at the residence of 89-year-old TNA leader Rajavarothiam Sampanthan to for federalism ahead of Wickremesinghe's proposed all-party meeting next month to address the long-held demand for political autonomy for the minority community in the country. The formula decided in the intra-party meeting on Friday includes the proposal to hold the stalled provincial council elections, including devolution to the Tamil regions in formulating a brand new Constitution, and put a stop to what they call the grabbing of lands belonging to the Tamils by the State. "The parties will meet again before meeting the president," the TNA source said on condition of anonymity.

Wickremesinghe on Wednesday invited all political parties for talks aimed at ending the Tamil ethnic issue by February 4 next

COLOMBO, NOV 26 /--/ Sri Lanka's Tamil year -- Sri Lanka's 75th anniversary of independence from Wickremesinghe told Parliament that he was willing to hold the meeting after December 11. He said it was important to build trust between the majority Sinhalese and the Tamils to resolve the long-standing conflict. The TNA -- an alliance of parties who represent Tamils from the north and east regions -- responded to Wickremesinghe's call. However, at least one Sinhala majority hardline parliamentarian objected to the proposal. Wickremesinghe as prime minister in 2015 had started a reconciliation process with the veteran TNA leader Sampanthan.

Many attempts since the 1950s to resolve the Tamil demand for autonomy were thwarted by the hardline Sinhala majority, leading to a violent armed campaign for separatism by the Liberation Tigers of Tamil Eelam (LTTE) on behalf of the Tamils. An Indian effort in 1987, which created the system of a joint provincial council for the Tamil-dominated North and East, faltered as the minority community claimed it fell short of full autonomy. C V Vigneswaran was elected as the first-ever Tamil chief minister for the North in 2013. The elections since 2018 have been on hold for a technicality connected to electoral reforms. (PTI)

Rawalpindi on Saturday, accompanied by a team of doctors to address a mega rally organised by his party, the first since the former prime minister was wounded during an assassination bid. Khan left his Zaman Park residence in Lahore around 1 pm local time in a bullet-proof vehicle, which was sent to his place. Meanwhile, convoys of PTI leaders, workers and supporters are making their way to Rawalpindi for the Haqeeqi

## Ukraine works to restore water, power after Russian strikes

KYIV, NOV 26 /--/Ukrainian authorities endeavoured on Saturday to restore electricity and water services after recent pummelling by Russian military strikes that vastly damaged infrastructure, with President Volodymyr Zelenskyy saying millions have seen their power restored since blackouts swept the war-battered country days earlier.

Skirmishes continued in the east and residents from the southern city of Kherson headed north and west to flee after punishing, deadly bombardments by Russian forces in recent days. The strikes have been seen as attempts at Russian retribution against Ukraine's beleaguered but defiant people after Ukrainian troops over two week ago liberated the city that had been in Russian hands for many months. "The key task of today, as well as other days of this week, is energy," Zelenskyy said in his nightly televised address late on Friday. "From Wednesday to today we have managed to halve the number of people whose electricity is cut off, to stabilize the system." He said, however, that blackouts continued in most regions. including Kyiv, the capital. "In total, more than 6 million subscribers are affected. On Wednesday evening, almost 12 million subscribers were cut off," Zelenskyy

He allowed himself a rare show of pique about how Kyiv authorities were faring, alluding to "many complaints" with the rollouts of "points of invincibility" public centers where residents can stock up on food, water, battery power and other essentials in the capital. "Please pay attention: Kyiv residents need more protection," he said. "As of this evening, 600,000 subscribers have been disconnected in the city. Many Kyiv residents were without electricity for more than 20 or even 30 hours." "I expect quality work from the mayor's office," he said, alluding to the administration of Mayor Vitali Klitschko. The president and the mayor have sporadically sparred since Zelenskyy took office in 2019.

Zelenskyy has accused Klitschko and officials around him of corruption, while Klitschko contends the president's office has put him under political pressure. Early Saturday, the Kyiv municipal administration said water connections had been restored throughout the city, but that about 130,000 residents remain without electricity. City authorities said on Saturday morning that all power, water, heating and communication services would be restored within 24 hours. The scramble to restore power came as Belgian Prime Minister Alexander De Croo met on Saturday with Zelenskyy in Kyiv. De Croo tweeted that Belgium was "releasing new humanitarian and military aid," but gave no immediate details. Meanwhile, Ukrainians were marking the 90th anniversary of the start of the "Holodomor," or Great Famine, that killed more than 3 million people over two vears as the Soviet government under Josef Stalin confiscated food and grain supplies and deported many Ukrainians.

German Chancellor Olaf Scholz marked the commemoration by drawing parallels with the impact of the war on Ukraine a key supplier of wheat, barley, sunflower oil and other foodstuffs on world markets. Exports from Ukraine have resumed under a UN-brokered deal but have still been far short of pre-war levels, driving up global prices. "Today, we stand united in stating that hunger must never again be used as a weapon," Scholz said in a video message. "That is why we cannot tolerate what we are witnessing: The worst global food crisis in years with abhorrent consequences for millions of people from Afghanistan to Madagascar, from the Sahel to the Horn of Africa." He said a World Food Program ship was in the process of delivering Ukrainian grain to Ethiopia, and Germany was adding another 10 million euros to efforts to help expedite grain shipments from Ukraine. # Australia beats Tunisia 1-0 to revive its campaign



AL WAKRAH, Nov 26 /--/ Australia only needed to avoid defeat to stay in the World Cup. The Socceroos did more than that in a 1-0 win over Tunisia on Saturday. Mitchell Duke gave Australia the lead midway through the first half with a header and Australia went on to register its first win at soccer's biggest event since a victory over Serbia back in 2010. The result means

Australia still has a chance to qualify for the round of 16. despite losing 4-1 to defending champion France in their opening France Australia lead Group D with three points each, while Denmark and Tunisia have one point each. France was playing Denmark later. In the final round of group games on Wednesday, Tunisia plays France and Australia meets Denmark.

After a scrappy start from both sides, Australia went ahead with a play out of the back from its goalkeeper. Duke collected goalkeeper's pass near midfield and made a quick touch to set Craig Goodwin down the left flank. He then sprinted forward to nod Goodwin's deflected cross into the far corner. Duke celebrated by making a 'J' with his fingers in a tribute to his son, Jaxson, who was

in the stands. The goal the contingent of red-clad Tunisia fans among the crowd of 41.823 inside Al Janoub Stadium and sent the small pockets of Australian supporters dressed in vellow into delirium. Tunisia impressed when it held European Championship semifinalist Denmark to a 0-0 draw in its opener but only occasionally threatened against Australia until the Aussies sat back and defended toward the end. Australia had also gotten off to an early 1-0 lead over France in its opener but then was outplayed in a loss which it blamed on a series of defensive errors. There were fewer errors this time, some timely interventions, too – none bigger than a last-gasp sliding clearance from centre-back Harry Souttar to block Mohamed Dräger's dangerous shot shortly before halftime. Tunisia is still seeking to advance from the group stage for the first time in its sixth World Cup appearance but now needs to beat France. During the second half, Tunisia fans held aloft a large Palestinian flag with the words, "Free Palestine" printed on it. (AP)

HAMILTON, NOV 26 /--/ India would expect a better approach from skipper Shikhar Dhawan and young Shubman Gill in the Powerplay overs when the team clashes with New Zealand in the do-or-die second One-Day International here on Sunday. The Seddon Park is a three-way open ground but is known for being one of the batting friendliest tracks in New Zealand where willow wielders would get value for their shots. Dhawan (72 off 77) and Gill (50 off 65 balls) added 123 in their opening stand but on a small Eden Park ground, a score of 306 for 7 was at least

40 runs short of par score. The bowlers could be taken to task for conceding those runs in just over 47 overs, the buck actually stops at the main batters since if it was not for Washington Sundar's brilliant cameo, India would not have touched the 300-run mark. It was largely due to the safety-first approach of the Indian openers during the first 10 Powerplay over where the runs did not come at a desirable pace. Moeen Ali in a



recent interview to PTI spoke how in earlier times, teams followed Australian template in white ball cricket and now it is the English way that is being aped by the teams. And that is where India is lagging behind as it could score only 40 runs in the first Poweplay overs in Auckland. Sample another piece of statistic which will give an idea that the problem lies in the general outlook of Indian top-order batters across limited overs formats (not just Rohit Sharma, KL Rahul or Virat Kohli). Dhawan hit 72 off 77 balls that had 13 fours. So effectively, he scored 52runs in boundaries in 13 deliveries. He scored another 20 runs in 64 deliveries and out of which 44 were dot balls as he was unable to get going in the Powerplay. As the skipper struggled, at the other end, Gill didn't do his overall averages any harm by stacking up another halfcentury, but the pace of his innings was also a debatable one. His 50 was scored in 65 balls with three sixes and a boundary. This means 22 runs were scored from four deliveries. He scored the remaining 28 runs from

DOHA, NOV 26 /--/ Just one match into the Qatar World Cup, Germany face what amounts to a must-win clash against Spain on Sunday, a team they have not beaten in a competitive fixture since 1988. Before Germany were stunned 2-1 by Japan in their opening match, the team faced heavy criticism for backtracking on a promise to wear a rainbow "OneLove" armband in support of diversity and human rights.

Their response was powerful-- a team photo before the Japan match in which all 11 players covered their mouths, suggesting they had been silenced by FIFA, who had threatened on-field sanctions for anyone wearing the armband.

But after Japan scored two late goals to beat Hansi Flick's team, the Germans were hammered by some observers for losing focus on the football when they should be concentrating on avoiding a second successive group stage exit in a World Cup.

On Friday, Chelsea striker Kai Havertz said the players were holding onto their beliefs but knew the challenge ahead, especially against a Spain team that steamrollered Costa Rica 7-0 in their opening game. "Everyone knows our point of view and how we think," Havertz said in a pre-match press conference. "Really, our focus is 100 percent on football, nothing else. We just said what we think, what our point of view is, everyone knows that, and now it is about playing football." With supermarket chain Rewe pulling their sponsorship and with TV ratings for the Japan game the lowest in Germany for a World Cup in more than 30 years, Havertz recognised that the challenges were not just on the field, saying: "I know not everyone is behind us." Havertz

revealed the squad and Flick held a wide-ranging team meeting on Thursday, admitting "it was time to tell ourselves the truth". Havertz said "everyone left the meeting knowing what's going on". Sitting alongside Havertz, midfielder Julian Brandt said "we had a very good exchange. All of us left the conversation feeling like we had the determination to win the game." The importance of the Spain match at the Al Bayt Stadium cannot underestimated -- national squad manager and 1996 Euros winner Oliver Bierhoff has asked what another early exit would mean for the future of football in Germany. Speaking with Germany TV network ARD on Friday, Bierhoff said losing "our first final" in Qatar have widespread ramifications for the sport. "What does it mean for German football? For the further development?" Bierhoff asked. "And if you go a

little deeper: (what does it mean) for the investment we have to make to stay competitive (and) to have new players in eight or ten years?" Far from being haunted by the ghosts of their early exit in Russia however, Havertz said the match could represent "a turnaround" for the under-fire side, saying "we all dreamed of playing these games". "Now we are in a bad moment, but I think that can switch around quite fast -- if we win the game on Sunday." Captain Manuel Neuer on Friday said Sunday's match was "a huge chance", emphasising the side could learn from Russia "we blew it once and now we know how not to do it". Brandt agreed, "People keep talking about us being in a 'shitty situation', and yes, we are." "Spain come to the stadium on Sunday on the back of a 7-0 victory but it is a chance, on Sunday, a chance to change the atmosphere." (AFP)
