SC dismisses Bilkis Bano's plea for reviewing order asking Gujarat to examine convict's remission application

The Supreme Court has dismissed a plea filed by Bilkis Bano seeking a review of its May 13 verdict by which it had said the state of Gujarat was the "appropriate government" competent to examine the application for the pre-mature release filed by a convict in the gang-rape and murder case. Bano's petition separate challenging the remission of the sentences of the 11 convicts by the state government is pending before the Supreme Court. She was gang-raped and

family were killed during the 2002 Gujarat riots. In its May 13 order, the apex court asked government to consider the plea of a convict for premature release in terms of its policy of July 9, 1992, which was applicable on the date of conviction and decided it within a period of two months. All 11 convicts were granted remission by the Gujarat government and released on August 15. Bano's plea seeking a review of the May 13 order came up

When will nation have 'Chinape Charcha'? Congress prez Kharge asks Modi

The Congress on Saturday accused Prime Minister Narendra Modi of not allowing a discussion in Parliament on the situation along the border with China and asked why he was not taking the nation into confidence in the matter.

His attack on the government came days after Indian Army personnel clashed with Chinese soldiers in the Tawang sector in Arunachal Pradesh. Claiming that Chinese build-up in Doklam is threatening the strategic "Siliguri Corridor" -- the gateway to northeastern states -- the party asked when the nation will have charcha". "Chinese build-up in Doklam up to 'Jampheri Ridge' is threatening India's strategic 'Siliguri Corridor' the gateway to Northeastern States! This is of utmost concern for our National Security! @narendramodi ji, When will the nation have... 'CHINA CHARCHA'?" Eyewitnesses slogan-shouting protesters tried to cross barricades put up by the police at the shooting venue but failed to do so.

Some of them shouted slogans against the Jabalpur for collector giving permission for the shoot, and tried to push policemen standing along barricades, eyewitnesses added. (PTI)

Nadda says Rahul speaking language of China and Pak as BJP seeks his expulsion from Congress

NEW DELHI, DEC 17 /--/ In an all-out attack on Rahul Gandhi for his remark that Chinese soldiers are beating up Indian Army personnel in Arunachal Pradesh, the BJP said on Saturday that the Congress should expel him from the party as its president J P Nadda accused him of speaking the language of China and Pakistan.

 $"This \, underlines \, the \, question \, mark \, about \, his \, patriotism.$ $He \, had \, also \, questioned \, surgical \, strikes \, and \, Balakotair \, strikes.$ It is a reflection of his metal bankruptcy," Nadda said as a number of senior party leaders seized on the former Congress president's comments to target the opposition party which is seeking some sort of political revival with Gandhi's 'Bharat Jodo Yatra'. At its official briefing, Bharatiya Janata Party spokesperson Gaurav Bhatia said if Congress president Mallikarjun Kharge is not "remote-controlled" and if the opposition party stands with the country, then Gandhi should



be expelled for his comments as they "belittle" India and break the morale of its armed forces. Bhatia likened Gandhi to Jaichand, the king of Kannauj who is projected as a betrayer to the Indian cause in some historical accounts, and alleged that he has constantly tried to break the armed forces' morale, be it after the surgical and air strikes on terror camps in Pakistanor after the Galwan valley clashes, in which 20 soldiers had laid down their lives.

While Gandhi allegedly sought evidence of the armed forces' strikes on terrorists inside Pakistan, he called the prime minister "Surender Modi" after the Galwan fight, the BJP leader said. The Congress leader should tender an apology to the country for his statement, he said. His sin will not be washed away with the apology but it will at least demonstrate $that he \, has \, realised \, his \, mistake, he \, said. \, At \, a \, press \, conference$ in Jaipur on Friday during his "Bharat Jodo Yatra", Gandhi claimed that China is preparing for a war and accused the government of trying to "ignore" the threat, saying it is "asleep" and not ready to accept the situation. In an apparent reference to a recent clash between Indian and Chinese soldiers in Arunachal Pradesh, he said Indian jawans in the region are

Nadda said no amount of condemnation of Gandhi's statement will be enough and added that Indian armed forces symbolise courage and valour. He noted that the Congress, when it was in power, had signed a memorandum of understanding with the Chinese Communist Party and that the Rajiv Gandhi Foundation had received funding from the Chinese embassy here. "Probably, this is the reason that Rahul Gandhi speaks the language of China and Pakistan," he said, adding that Gandhi was "secretly" meeting Chinese officials at their embassy in New Delhi when Indian and Chinese soldiers faced off in Doklam. MVA allies take out protest march against Maharashtra govt, demand Guv's removal for 'insulting' icons

MUMBAI, DEC 17 /--/ In a show of strength, the opposition Maha Vikas Aghadi (MVA) constituents in Maharashtra took out a' Halla Bol' protest march in Mumbai on Saturday againstthe Eknath Shinde-BJP government in the state, and emphatically demanded removal of Governor BS Koshvari for passing "insulting" remarks against iconic personalities. including Chhatrapati Shivaji Maharaj. Senior leaders of the three MVA allies - Shiv Sena (Uddhav Balasaheb Thackeray), Nationalist Congress Party (NCP) and Congress - shared the stage after the protest march, where NCP chief Sharad Pawar said if the governor was not removed, a "lesson" would be taught, while Uddhav Thackeray warned that there can be no compromise on the state's self respect and pride. NCP leader Ajit Pawar demanded a strict law to ensure that dignity of national icons is protected. The protest march began from near J J Hospital in Byculla around noon and ended at the Chhatrapati Shivaji Maharaj Terminus (CSMT), a distance of around 4 km, where the MVA leaders addressed a rally. Speaking at an event last month, governor Koshvari had dubbed Shivaji Maharaj an "icon of olden times". The remark sparked outrage from both the descendants of the Maratha king and the opposition parties. Earlier this year, he had also passed alleged derogatory remarks against social reformers Mahatma Phule and Savitribai Phule.

Speaking at the 'Halla Bol' protest rally, Sharad Pawar said, "The governor should be immediately removed for insulting Chhatrapati Shivaji Maharaj and Mahatma Phule."He also said that the ideologies of the three MVA partners may be different but there was a need to be together to protect Maharashtra's self-respect. "If the governor is not removed, we will have to take steps to teach them a lesson," he added. The former Union minister said a competition was on, not for the state's progress and development, but to malign it. "Maharashtra cabinet minister Chandrakant Patil says $BRAmbedkar, Mahatma\,Phule\,begged\,to\,start\,schools...Such$ an insult cannot be tolerated. We have to be united irrespectiveof our political ideologies to safeguard the state's prestige. If the governor is not removed we have to take steps to decide our future action." he said.

Former chief minister Uddhav Thackeray accused the Shinde government of being ideologically bankrupt. "One minister Chandrak ant Patil says Phule and Ambedkar beggedto collect funds to start schools, while another minister MangalPrabhat Lodha likens Chhatrapati Shivaji Maharaj's great escape from Agra to Eknath Shinde's rebellion and backstabbing," he said. Shinde had led a rebellion against the Shiv Sena leadership in June this year, which led to the collapse of the Thackeray-led MVA government in the state. "I don't consider Koshyari as governor. The post of a governor is a respectable one. I reiterate my demand that a criteria be decided on selection of a governor," Thackeray said. There can be no compromise on the state's self-respect and pride, Thackeray added.

On the ongoing Maharashtra-Karnataka border row, he said the unfulfilled dream of 'Samyukta Maharashtra' about the inclusion of Belagavi, Karwar, Nipani and other villages into Maharashtra has to be achieved. Leader of Opposition in the state Assembly Ajit Pawar said the governor should be removed "to save Maharashtra". He demanded that a strict law be enacted to protect the dignity of national icons. On the border row, he said, "Never before villages from Maharashtra openly spoke about breaking away from the state. Why is this happening?" The former deputy chief minister stressed the need to stay united and said this protest march was the first step in that direction as the MVA's aim was to protect the integrity of the state. (PTI)

BJP workers, as well as citizens, have joined a state-wide protest against Bhutto's remarks," Korat told reporters. Bhutto made the comments following India's External Affairs minister S Jaishankar's sharp attack on Pakistan over its support for terrorism at the United Nations Security Council meeting.

Gujarat BJP president CR Paatil dubbed Pakistan a 'beggar' and said Bhutto's remarks on PM Modi have attracted criticism from the entire world. He said the people of India will never tolerate such comments against the PM. "Entire country is angry over Bhutto's vile and shameful remarks about PM Modi. Pakistan is no less than a beggar. Its economy is so weak that Pakistan is forced to sell their assets, even its donkeys, to keep running the country. Pakistan needs to focus on their own condition before commenting on others. The entire world knows the misdeeds of the Bhutto family" said Paatil. (PTI)

MUMBAI, DEC 17 /--/ Former Supreme Court judge B N Srikrishna has called for preserving the independence

journalists to ensure smooth functioning of democracy in the country.

"If journalism as a profession falters, democracy will collapse,' Justice Srikrishna said Friday night after presenting the RedInk awards for excellence in journalism, instituted by the Mumbai Press Club.

"Speak the truth to the powers that be," he said. "Two professions have to be necessarily independent, a judge and a journalist. If they falter, democracy collapses," he added. Justice Srikrishna said a journalist who loses his independence is as bad as a judge who has lost his

independence. "Remember, you are in a profession where honesty is really the best policy," said the noted jurist, who headed the Srikrishna



apportioned blame for the Mumbai riots of 1992 93. "We all know about the four pillars of democracy: legislature judiciary, executive and the press or the fourth estate. If the first three cozy up, it is the duty of the fourth estate to take them to task," he said.

India-China Border Clash: Can The Govt Stand Up to Xi Jinping's Military Policy?

In stable democracies, political civilian leadership's control and oversight over the Military is a prerequisite and established doctrine. Lack or deficiency of political role in the decision-making within the realm of security can create a 'State within a State.' The joke on account Military's unaccountability to its ostensible civilian government across the Line Of Control (LOC) goes, "Most countries have an

has a country." China is unique in that its Military ie, the People's Liberation Army (PLA) is not the national army of the sovereign, but the political army or 'wing' of the ruling Chinese Communist Party (CCP). The allegiance of the PLA soldier is not to the nation-state of China or even its constitution, but to the ruling 'Party' (simply called so, as there is no other allowed) that has ruled uninterrupted in a singleparty format, since 1949.

Zedong rationalised the concept of Dang Zhihui Qiang. "Our Wenyuan, and Wang

principle is that the Partv commands the gun, and the gun must never be allowed PLA's command. subservience to the 'Party' has ensured that no rival political formation or

ideology could emerge. While multiple rumours of attempted coups within the Chinese narrative abound, perhaps, the most famous one pertains to Lin Marshal of the People's Republic Of China and accomplished General of the Chinese Civil War. Lin Bao was the longestserving Chinese Minister of National Defense (1959-1971) and was touted as Mao Zedong's successor but Lin got increasingly impatient and lost Mao's trust and therefore, planned a coup.

Following a botched coup attempt, a flight carrying him and his family to Mongolia mysteriously crashed after accusations of them fleeing. He was officially condemned as a traitor by the CCP. Later, in another attempt, the famous 'Gang of Four' from the CCP ie, Jiang Qing (Mao Zedong's last wife) and three of her associates Zhang Chunqiao, Yao Hongwen got officially notified revolutionaries'.

But for the CCP to fully

control PLA (once a gargantuan five million force – today a leaner two million) is a constant task. political commissars within the PLA are entrusted with the sensitive task of ideological indoctrination discipline as per the 'Party' norms. Xi Jinping's era may have seen a sharper, more modern PLA but also one with more presence and alignment with the 'Party' as part of his 'national

rejuvenation' project. Clearly, Xi has subliminal worries about the PLA's equation with the CCP (and, has even appropriated the title of Commander-in-Chief that neither Mao Zedong or Deng Xiaoping, had assumed). Tellingly, the Beijing Garrison had refused to break up the Tiananmen Square protests and units from outside had to be brought in.

Frequent purges to loyalty and complete control of the top PLA Generalship (as done in 2016, or later, following the seemingly inept handling of the Xinjiang unrest) suggests that nothing can be taken for granted, not even the PLA. In 2015, Xi accused

Therefore, wearing the PLA Uniform (the first Chinese President to do so in Military parades), saberrattling Taiwan,

showcasing Military hardware and goading the PLA to, "focus its energy on fighting and war" is par for the course, towards perception management.

Dismantling the earlier PLA superstructure of four headquarters and replacing with fifteen more controllable agencies with loyalists and visibilising signature corruption drive may still not guarantee the latter's absolute control of PLA, which he seeks.

It is with this backdrop that localised or isolated incidents may not necessarily suggest Xi Jinping's personal imprint and nudge, especially if they are as shoddily planned and conducted as the recent attempt at land grab in Arunachal. Xi's

greenlighting expansionism would be expected to be more robust, scaled-up, and professional than that warranted by the news and visuals filtering in. In authoritarian times, many senior officials try to deliver 'good news' that they believe the top leader would like to receive, and herein, short-circuiting the

formal approval processes

before initiating a move.

It is not beyond the local PLA leadership in the region to ingratiate itself with the powers that be in Beijing. Importantly, the previous head of the Indiafacing Western Theatre Command ie, General He Weidong, was given a double promotion to become the new Vice Chairman of Central Military Commission (CMC). Weidong was incharge of the operations in the 2017 Doklam and the Line-of-Actual-Control stand-off in

2020 with India. In times like this, kneejerk action and reaction by both the Supreme Leader, in this case Xi Jinping, or by in the functionaries operational realm, like General Wang Haijiang in command of Western Theatre Command now (or hv even further junior leadership), cannot be ruled out. For a nation that deploys unmatchable resources of deceit

sophistication, it is unlikely that Xi Jinping's personally authorised doctrine on expansionism would include sending 300 odd unarmed (owing to bilateral agreement) PLA soldiers, who then beat a hasty retreat. Certainly, India needs to remain hypervigilant as its Armed Forces have remained so. However, it is equally important to go beyond the suffixation of (which

disconcertingly broke rather belatedly) with 'more Chinese were hurt' or release of WhatsApp clips. While psychology is an important part of modern warfare, it would be naïve not to consider partisan utilities that are inherent in a competitive democracy.

However, security preparedness goes far beyond the platitudinous 'Kadi Ninda' or 'not an inch of land' (worse so, if ascribed to a political leader and not to the Armed

Armed Forces belong to a partisan persuasion and not to the sovereign!). The governance Chinese structure between the CCP and PLA is not as seamless or aligned as projected, nor are their postures or actions infallible (as validated by recent incidents). What is however, required is to put the Indian security issues above partisan passions (and social 'forwards'), empower the Indian Forces further, and develop a strategic culture that is proactive and reactive. The Arunachal incident is not the first, and it, unfortunately, wouldn't be the last - the Chinese may well recollect their experiences with the Indian Forces post-1962, be it in 1967 (Cho La and Nathu La) or more recently in 2020, or even earlier this week. The Indian Armed Forces did what they did, not because of the political cover that has been historically afforded to them, but despite it. 

India's trade on a high trajectory

India's trade is moving forward on the high growth wave even with the high base of last year, and despite global demand slowdown, exports performance continues on the high growth run. Exports moving to positive territory, after a drop in October, is on expected line though the challenges continue. The off take has slowed down with rising inflation in most economies affecting the purchasing power. Moreover, the large departmental stores are maintaining lean inventories as credit cost of building inventories have gone up with interest rates moving northwards. Pressure from persistently high global inflation despite accelerated monetary tightening has also raised the import bill for essential commodities like crude petroleum, coking coal that need to be imported.

Latest data showed that India's exports recorded a flat growth of 0.59 per cent to USD 31.99 billion in November, even as trade deficit widened to USD 23.89 billion during the month. Exports stood at USD 31.8 billion in November last year, while imports rose by 5.37 per cent to USD 55.88 billion in November as compared to USD 53.03 billion in the corresponding month a year ago. During April-November 2022, exports rose by 11 per cent to USD 295.26 billion as against USD 265.77 billion in the same month last year. Imports, however, rose by 29.5 per cent to USD 493.61 billion during the eight months period of this fiscal. It was USD 381.17 billion during April-November 2021, as per the data. The merchandise trade deficit for April-November 2022 has increased to USD 198.35 billion as against USD 115.39 billion in April-November 2021.

India's exports entered negative territory after a gap of about two years, declining sharply by 16.65 per cent to USD 29.78 billion in October, mainly due to global demand slowdown, even as trade deficit widened to USD 26.91 billion. The World Trade Organisation (WTO) has projected that the global trade growth will rise by 3.5 per cent in 2022, but by only one per cent in 2023. The exports exhibited a positive growth in 15 out of 30 key sectors in November as compared to the same period last year. Sectors which recorded positive growth include electronic goods (54.48 per cent), gems and jewellery (4.61 per cent), RMG of textiles (11.70 per cent), pharmaceuticals (8.66 per cent), rice (19.16 per cent), and leather (8.68 per cent). With exports $continuing to {\it remain}\, under {\it stress}\, for the {\it second}$ consecutive month in November, and imports alsofalling, the current account deficit is likely to moderate in the second half and close the fiscal with a 3.3 per cent of GDP or USD 108-112 billion, which will still be a record high. Falling exports and commodity prices will also help the country print in a moderate CAD at USD 24-26 billion in Q3FY23 from likely high of USD31-34 billion in Q2FY23, Icra Ratings said in a report. The next move by the USFed would be very important and

FM must focus on speedy job generation through 2023-24 budget

World Bank has revised upwards its earlier GDP growth estimate to 6.9 per cent for India this financial year on the back of strong macroeconomic fundamentals and economic revival after Covid-19 mayhem. This is certainly music to the ears as India is perhaps a few countries looking up in otherwise gloomy global economy. Inflation is one factor, which is still daunting the economy and Reserve Bank of India has rightly taken measured monetary steps to bring it down to acceptable band. RBI has raised short-term repo rate, a barometer of interest rates, by a mere 0.35 per cent as against expectation of 0.5 per cent. This has been done to ensure that growth momentum is not severely hampered by going all out contain inflation. Consumer Price Index at 6.7 per cent is still higher than the RBI band of 4 plus-minus 2 per cent, but it has started slowing down. It is, however, still a source of worry as food and fuel inflation, which affects the poor most, are still high and are expected to continue for a few more quarters.

In such a scenario, speculation is ripe on what the general budget on February one can do to step-up economic recovery. This will be the last full budget to be presented by Nirmala Sitharaman, before the general elections in May 2024. Though there will be one more for BJP government present a budget in February 2024, it will be an interim one as the practice is to allow the newly elected government in the Lok Sabha elections to present the full budget in June-July. This is because in India general budget is not merely an annual statement of government expenditure and revenue but lays down the annual economic roadmap besides some medium term strategy and vision of the government of the day.

As has been pointed out by several economists, monetary actions alone cannot contain inflation in the present circumstances, as it is triggered by several factors including global. Monetary action of rising interest rates can only contain to some extent demand factors. The current inflation as supply factors as well besides slowing down of global economy and the uncertain geo-political situation arising out of the prolonged Russian-Ukraine war. There is also monetary tightening by many central banks in advanced economies to suck out excess liquidity pumped into the system due to covid 19 to alleviate the suffering of the people. So well thought out fiscal measures are required

to deal with this peculiar inflation due to a combination of factors, external as well as domestic. So fiscal measures has to be calibrated in a manner that it did not impinge upon growth momentum. This balancing act is going to be tough and is going to be tight rope walk for Sitharaman in the budget.

One positive factor in the economy is that Banks have adequate liquidity at the moment, their balance sheets have been cleaned up and have low bad debts. Also private investments have started picking up with most of the companies working 75-80 per cent of capacity after covid-19. The corporates, which had over-leveraged from banks during boom period, have cleaned their balance sheets as well and have started investing in creating fresh capacity. Rising interest rates at this juncture could act as a dampener, particularly in the real estate sector and automotives, which are on revival mode. There could also be some impact on exports with global demand being subdued. But hopefully the situation improved in a few quarters.

Apart from usual prescriptions of keeping the fiscal deficit under check and targeting a lower fiscal deficit as per the recommendations of Fiscal Responsibility and Budget Management Act, Sitharaman needs to think out of the box to pump-prime the economy. The usual strategy in the budget is to step up public expenditure particularly in the infrastructure sector like rail, road, ports, airports and telecommunications. This has to be done to ensure revival of the economy. There will also be some tax proposals and PLI schemes to incentivize the private industries to make big investments. These are standard prescriptions, which are done year after year and perhaps done more vigorously when the economy is on a revival mode. Of course Corporates are now contemplating big-ticket investments. Tata sons have announced investment of \$90 billion in next five years in various activities including semiconductors, Air India, Apple mobile phones, EVs and so on. Mukesh

Ambani has committed to over \$75 billion in the next few years including hydrogen fuel and telecom. Adanis are making huge investments. Vedanta and a few other players too are investing big. At least six Indian cities Mumbai, Delhi, Chennai, Kolkata, Bengaluru and Hyderabad, are going to be among the top ten cities in the World. Ahmedabad is not far behind. That apart, five states Maharashtra, Gujarat, Tamil Nadu, Karnataka and Uttar Pradesh will have GDP that is almost equivalent to India's present GDP in the next 10 years or so. These are already happening

So, the budget could make a huge difference this time through out of the box thinking on how to revive struggling MSMES. It can come out with some drastic and big-ticket measures to revive the MSME sector, badly hit due to 2016 demonetization, followed by hasty implementation of GST and two years of Covid 19. At the moment, there is no statistics available on how many of the six crore MSMEs have closed down cumulatively in the last five to six years. Nearly 97 per cent of these MSMEs are micro industries employing less than10 persons and this sector is a major job creator accounting for over 30 per cent of India's GDP and over 40 per cent of India's manufacturing and exports. MSMEs account for nearly 80 per cent of employment in the informal sector outside agriculture.

Informal lending on which MSMEs depended has virtually disappeared after demonetization and an alternative has not yet emerged. Mudra provides only working capital loans. A similar scheme is needed to be created for term lending to MSMEs with the help of banks and institutions like SIDBI and NABARD. The good news is banks have already started increasing term lending to small industries. But unfortunately it is only established small industries, some of whom have now become medium industries. The lending problem is for micro and cottage industries. Banks at the moment do not have the wherewithal to reach out to them. Tamil Nadu government is contemplating some measures to improve term lending through the state lending arms. More states are expected to follow suit. Self Help groups too needed hand-holding. It would be worthwhile for the budget to consider even setting up of a separate institution for term lending to MSMEs particularly micro, cottage and small industries. SIDBI somehow has not delivered adequately on this score. (IPA)

Harming the programme for climate change

The crux of the issue is that non-fossil, or even a low fossil fuel path, will need grid-level storage costs to drop by a factor of 10 times what they are today! If they don't, then the grid supply will become unreliable, with cascading costs for the people and the economy.

That green energy has a storage problem did not bother us earlier. Coal or gas-fired plants on the grid can be used to meet the shortfall due to the variable supply from renewables. The shortage of renewables is not a problem as long as renewables are not the major source of supply for the grid. Once renewables become the major source of supply for the grid, then the reliability of the grid supply depends on grid-level storage batteries. How variable are these supplies? In Germany, wind energy in 2019 went from supplying 59 per cent one day to as low as 2.6 per cent on another. In the same year, solar peaked at 25 per cent and bottomed out at 0.3 per cent. What happens if both solar and wind are not available simultaneously? This would mean installing much bigger storage batteries for a reliable grid supply than what we are planning for today with the luxury of fossil fuel as a backup.

While many may feel that having two renewable sources should take care of the relative unreliability of each, it, unfortunately, does not work that way. If there is a prolonged period of calm, typically lasting for days, then at night time, both sources will be unavailable. This can be an even bigger problem at high altitudes, as days are short and nights

longer. We can either spend money now to provide a reliable grid based on renewables or continue using fossil fuels as long as we can and postpone the transition. The pretence that only coal-fired plants are fossil while natural gas is a transitional fuel is to postpone the investments that the rich countries need to make in grid-level energy storage.

Instead of having an honest discussion about how to reach a low carbon trajectory quickly, the politics of the rich countries is how can "we" postpone our transition to green energy in the name of natural gas as a "transitional" fuel and dump the problem of the energy transition on the poor countries. The rich countries can then also extract their profits from selling us renewable energy technology as well as batteries.


The most hypocritical of the lot are the Nordic countries, who have argued that they can fund African countries' development of gas and oil fields provided the gas and oil are exported entirely back to them. The African countries should go in exclusively for renewable energy. This is what WGyude Moore and Todd Moss pointed out in a recent article in Foreign Policy called, "Europe to Africa: Gas for Me but Not for Thee".

Renewable energy has a storage problem, is well known. Fossil fuels are both stores of energy and source of energy, assuming coal, gas and oil resources are inexhaustible. That they are not, was thought to be a problem for future generations. Just as global warming was relegated to a problem of the future until drought, heat, and an increasing number of extreme weather events convinced us that the problem has already arrived. This means we need to plan for a grid using much larger amounts of renewables and have it in place as quickly as possible. And in order to do that, we will have to solve the problem of grid-level storage of energy.

The simplest storage for any grid is to convert the existing hydroelectric plants to be run exclusively as complementary to wind and solar energy, converting them to pumped storage except for the period when inflows exceed their current levels of storage, as often happens during rainy seasons. The main problem with hydroelectric power of land acquisition and displacement does not exist here, and no new hydroelectric projects are required. In the current scenario, using hydroelectricity for any other purpose, except to meet a peaking load or in a pumped storage mode is a sheer waste. To

answer the serious question of how to reach a low carbon path rapidly, we need to look not only at future solutions which may or may not come but at the already existing ones. Instead of trying to shift the burden of the energy transition onto the poorer countries, we need to look at not just the amount of carbon emission of a country but the per capita emissions.

Comparing the total emissions of China to that of the US, with its population five times that of the US, or India's with European countries of much smaller population size, lumping all of them as large emitters is simply to confuse the issues. Just for the record, India uses 60 per cent of its energy from fossil fuels instead of 68.6 per cent of the US. And China, in the last three years, has added more renewables each year than the US and Europe together. There are two ways to meet the climate crisis: look honestly at the problem and do the best that each country can do to avert the impending crisis. I am not even talking of a just share of carbon space, simply that rich countries do not occupy even the remaining carbon space as the US and the EU-UK seem to be bent on doing. This means not playing games with climate targets, accepting that rich countries have to shoulder a larger of the costs of transition and not charging extortionate money for patents/know-how from the poorer countries. And not single out only coal while pretending that natural gas is a transitional fuel. A capitalist principle of beggar thy neighbour may help the rich countries in the short run but will only bring disaster for humanity. (IPA)

NRI nurse, 2 kids murder in UK: Family in Kerala blames husband

the killing of an Indian-origin nurse from Kerala and her two young children was reported from the UK, her family on Saturday alleged that her husband was a "cruel" man and he had assaulted his wife in the past also.

According to police there, Asok died at the scene and the children succumbed to injuries in the hospital. Speaking to the media at their home in Vaikom area of Kottayam district of the state, Asok's parents said that local police had informed them on the previous night that according to the post mortem of their daughter, she was strangled to death using a cloth or a grandkids was to be conducted today. Asok's mother alleged that her son-

in-law -- Saju-- is a "cruel" person and she has seen him assault her daughter and grandson when the couple was living in Saudi Arabia."I was staying with them when my granddaughter was born. "He would decide when we can see our daughter and grandkids via video call," Asok's mother claimed. She also said that her son-in-law's family, who daughter and grandkids and they never had any complaints about Asok. Asok's father said that his daughter

studied nursing in Bengaluru and was working there when she met Saju, who used to work in a travel agency. "It was a love marriage. When she informed us, we were hesitant. But they were both adults and educated people. He was working in a travel agency. "My daughter said she would accept it if we said no to their marriage, but she also said not to insist on marrying someone else. So, we agreed to their getting married," he said. He also said that while he has not seen his daughter being hit, he has seen his grandson being allegedly manhandled by Saju who was short-tempered. Bring legislation for mandatory physical activities in schools to fight child obesity: UPBJPMLA

LUCKNOW, DEC 17 /--/ has urged the Union government to bring a legislation that mandates a compulsory physical fitness period in schools that will help to combat the rising cases of obesity and diabetes among children.

The Uttar Pradesh legislator has written a letter Education Union Minister Dharmendra Pradhan early this week expressing his concern over the issue and that there was "no single legislation which governs all the schools in Ĭndia". "I propose that Parliament introduce a legislation to govern the inclusion, access, and provision of basic physical health and fitness to all children in the education system.

proposed legislation should seek to mandate institutions to have a 45 minute time slot every day dedicated to imparting physical fitness to all students, be it through yoga and exercise, or sports and physical activities," Singh wrote in the letter, citing relevant official data. The MLA from the Sarojini Nagar seat in Lucknow quoted data to state that around 5-8.8 per cent of school children are obese in India and if the rates continue to increase at this pace, India will be home to 27 million obese children by 2030. Childhood obesity, he wrote in his letter dated December 14, particularly troubling because it has a ripple effect causing a plethora of health



RANAGHAT, DEC 17 /--/ Trinamool Congress national general **Abhishek** secretary Banerjee on Saturday accused the BJP of insulting the people living near Bangladesh border by asking them to prove their Indian citizenship for a second time in the name of CAA.

Banerjee, who was addressing a public meeting at Ranaghat in Nadia district, said that if a resident of West Bengal's Nadia or North 24 Parganas districts, bordering Bangladesh, has to prove his citizenship again, the same yardstick has to be applied for all, including the prime minister and Union home minister. who "Those are misleading the people in the name of the Citizenship Amendment Act, I have one question for them. Why rules cannot be framed even after the CAA was tabled in Parliament. Because they used the CAA to get votes. "If you have all documents and got benefits of government's welfare schemes, and if you have voted in earlier polls, why there is a need to do it all over again? Because the BJP wants to divide the people," the TMC's Diamond Harbour MP said while addressing the gathering. (PTI)

Rahul speaking China's language to lower armed forces' morale, alleges Nadda

BJP seeks Congress leader's expulsion from party

NEW DELHI, DEC 17 /--/ In an all-out Yatra", Rahul claimed that China is attack on Rahul Gandhi for his remark that Chinese soldiers are beating up Indian Army personnel in Arunachal Pradesh, the BJP said on Saturday that the Congress should expel him from the party as its president J P Nadda accused him of speaking the language of China and Pakistan. Nadda accused Rahul of "again lowering the morale of our armed forces" and slammed his comments as highly condemnable and unpardonable. "This raises question mark about his patriotism. He had also questioned surgical strikes and Balakot air strikes. It is a sad reflection of his metal bankruptcy," Nadda said as a number of senior party leaders seized on the former Congress president's comments to target the opposition party which is seeking some sort of political revival with Gandhi's 'Bharat Jodo Yatra'. At its official briefing, Bharatiya Janata Party spokesperson Gaurav Bhatia said if

Congress president Mallikarjun Kharge is not "remotecontrolled" and if Opposition party stands with the country, then Gandhi should be expelled for his comments as they "belittle" India and

break the morale of its armed forces. Bhatia likened Gandhi to Jaichand, the king of Kannauj who is projected as a betrayer to the Indian cause in some historical accounts, and alleged that he has constantly tried to break the armed forces' morale, be it after the surgical and air strikes on terror camps in Pakistan or after the Galwan valley clashes, in which 20 soldiers had laid down their lives. While Rahul allegedly sought evidence of the armed forces' strikes on terrorists inside Pakistan, he called the Prime Minister "Surender Modi" after the Galwan fight, the BJP leader said. The Congress leader should tender an apology to the country for his statement, he said. His sin will not be washed away with the apology but it will at least demonstrate that he has realised his Jaipur on Friday during his "Bharat Jodo

preparing for a war and accused the government of trying to "ignore" the threat, saying it is "asleep" and not ready to accept the situation. In an apparent reference to a recent clash between Indian and Chinese soldiers in Arunachal Pradesh, he said Indian jawans in the region are being "beaten up". Nadda said no amount of condemnation of Gandhi's statement will be enough and added that Indian armed forces symbolise courage and valour. He noted that the Congress, when it was in power, had signed a memorandum of understanding with the Chinese Communist Party and that the Rajiv Gandhi Foundation had received funding from the Chinese embassy here.

"Probably, this is the reason that Rahul Gandhi speaks the language of China and Pakistan," he said, adding that Rahul was "secretly" meeting Chinese officials at their embassy in New Delhi when Indian and Chinese soldiers faced off in Doklam. Union

> minister Anurag Thakur said he was not surprised by Gandhi's statement as even at the time of the Doklam incident was seen drinking soup with Chinese officials. Indian soldiers carried out

the surgical strikes, even then he raised questions. He and the Congress seem to have no faith in the Indian Army. But we have full faith in our army. Today our army is capable of conducting surgical strikes and gives a befitting reply to the encroachers," he said.

Union minister Kiren Rijiju said Rahul has not only insulted the Army but also damaged the country's image. "He is not only a problem for the Congress Party but he has also become a huge embarrassment the country. We are proud of our Armed Forces,' the MP from Arunachal tweeted. Bhatia told reporters that if the Congress does not act against Gandhi, who continues to be seen as its main driving force, it will mean that his statement is reflective of the opposition party's mindset. The Congress has become less of a political party and more of a den of mistake, he said. At a press conference in anti-India activities, the BJP leader alleged.

Rajnath praises armed forces for display of their bravery, valour in Galwan, Tawang

NEW DELHI, DEC 17 /--/ Bravery and valour displayed by the armed forces during the Galwan valley clashes and the recent face-off in the Tawang sector of Arunachal Pradesh is commendable and no amount of praise for them is enough, defence minister Rajnath Singh said on Saturday. In an address at industry chamber FICCI, Singh also said that India aspires to become a superpower to ensure global

prosperity, but it does not have any intention to dominate other nations or capture even one inch of land of any country, in comments seen as a thinly veiled reference to China's aggressive behaviour along the borders. The defence minister also took an indirect dig at Rahul Gandhi over his comments on the border row with China, a day after the Congress leader accused the government of downplaying the threat posed by the Chinese military along the Line of Actual Control. "Any amount of praise is not enough for the armed forces for the way they displayed brayery and valour, be it in Galwan or Tawang," Singh said. "We have never questioned the intention of any

leader in the Opposition, we have only debated on the basis of policies. Politics should be based on truth. Politics cannot be done on the basis of falsehood for a long time," he said, without naming anyone. "The process of taking the society towards the right path is called 'rajniti' (politics). I do not understand the reason behind doubting anyone's intention always," Singh added. Citing the stiff opposition faced by the government in rolling out the GST (Goods and

Services Tax), the Production Linked Incentive (PLI) scheme and agricultural reforms, the defence minister said the trend of opposing any decision or scheme for the sake of opposition should stop as it is not a good sign of a healthy democracy. Indian and Chinese troops were engaged in a fresh clash in the Yangtse area of Arunachal Pradesh's Tawang sector on December 9, in a first such major flare-up

> after the deadly hand-to-hand combat in the Galwan Valley in June 2020 that marked the most serious military conflict between the two sides in decades. "When I am saying we aspire to become a superpower, it should never be construed that we want to dominate over countries in the world. We do not have any intention to even capture one inch of land of any country," he said. "If we want to become a superpower, then we want to become a superpower for global good and prosperity. The world is our family," Singh added. The defence minister also said that India's economy was among the six-seven large economies during the time of Independence and when China witnessed

a new system following the 1949 revolution, its GDP was less than that of India. He said though India and China kept marching together till 1980, the neighbouring country went ahead, riding on economic reforms. "In 1991, economic reforms started in our country too. But China has made such a long jump in a short time that, except the US, it has left behind all other countries of the world in the pace of development," he said. (PTI)

The FO claimed that India is "desperately using international platforms to advance its agenda to defame and target Pakistan" following Islamabad's exit from the FATF grey list in October and international recognition of its counterterrorism efforts. Pakistan was taken off the grey list of the Paris-based Financial Action Task Force (FATF), the global watchdog on terror financing and money laundering, four years after it was put in the infamous categorisation. It also alleged that India was following a "policy of pettiness towards its neighbours". "Intimidation and demonisation of religious minorities receives official patronage in states across India," FO alleged, adding that New Delhi was "peddling a fictitious narrative of victimhood." Relations between India and Pakistan have often been strained over the Kashmir issue and cross-border terrorism emanating from Pakistan. However, the ties between the two countries nosedived after India abrogated Article 370 of the Constitution, revoking the special status of Jammu and

Indian-American woman charged in 2018 death of her newborn baby

Kashmir and bifurcating the State into two Union

Territories on August 5, 2019. (PTI)

NEW YORK, DEC 17 /--/ A 29-year-old Indian-American woman has been charged with first-degree murder for causing the death of her newborn infant by allegedly tossing the baby into a seaside inlet in Florida in 2018 because "she didn't know what to do with her", according to media reports. Arya Singh, the mother of the female infant known only as 'Baby June', was arrested on Thursday after she confessed to the crime. The baby's body was found floating in the Boynton Beach inlet in Florida on June 1, 2018 after she had been disposed of "like a piece of trash," said New York Post newspaper quoted Sheriff Ric Bradshaw as saying. The mother confessed to the crime, saying "she didn't know what to do with her". The arrest was made after investigators from Palm Beach County Sherriff's cold case unit found the father who cooperated in the probe, the WPTV report said. "He knew nothing about the baby," Detective Brittany Christoffel said. "He knew that he had a girlfriend around that time (who) told him that she had been pregnant, but she had taken care of it," Christoffel was quoted as saying by the news channel. The father of the infant believed that Singh had an abortion.

Singh confessed to putting the baby in the water and told that she hadn't realised she was pregnant until she gave birth to the baby in the bathroom of a hotel room, said Christoffel, who spearheaded the case. "She said when the baby was born she wasn't sure if the baby was alive or dead and that was that," Christoffel said of the Singh. The baby was believed to be alive when she was thrown into the ocean, authorities said. "She didn't know what to do with her and she still had her with her and she just decided that's where she was going to dispose of her," Christoffel said. Christoffel said Singh was taken into custody after determining that she "was solely responsible for the baby ending up in the Boynton Beach Inlet." Palm Beach County State Attorney Dave Aronberg said Singh is being charged with first-degree murder. The DNA sample collected from the father and covertly from Singh herself helped the investigators in confirming she was the mother, the authorities said. (PTI)

Global target for pesticide reduction unnecessary: India's environment minister at COP15

MONTREAL, DEC 17 /--/ A numerical global target for pesticide reduction in the agriculture sector is unnecessary and must be left for countries to decide, India has said at the UN biodiversity conference here in Canada. India also supported subsidies for the agriculture sector, Currently, more than 40 per cent of India's total workforce is employed in agriculture, according to the World Bank data released till 2019. Speaking during a high-level segment of the 15th Conference of Parties (COP15) to the Convention on Biological Diversity (CBD), Union Environment Minister Bhupender Yadav said that the agriculture sector in India, like other developing countries, is the source of "life, livelihoods, and

culture for hundreds of millions".

"Such essential support to

vulnerable sections cannot be

called subsidies, and targeted for threat to food safety and elimination," Yadav said on Friday. "While they are being rationalised, biodiversity

must be promoted through positive investment," he said. "Similarly, a numerical global target for pesticide reduction is unnecessary and must be left to countries to decide," the minister added. The Target 7 of the

the reduction of pesticides by at least two-thirds by 2030. More questions than answers as **EU** corruption scandal unfolds

BRUSSELS. DEC 17 /--/ No one answers the door or the phone at the offices of the two campaign groups linked to a cash-forfavours corruption scandal at the European Union's parliament, allegedly involving Qatar. No light is visible inside. No Peace Without Justice (NPWJ), a pro-human rights and democracy organisation, and Fight Impunity, which seeks to bring rights abusers to book, share the same address, on prime real estate in the governmental quarter of the Belgian capital. The heads of the two organizations are among four people charged since December 9 with corruption, participation in a criminal group and money laundering. Prosecutors suspect certain European lawmakers and aides "were paid large sums of money or offered substantial gifts to influence parliament's decisions". The groups themselves do not seem to be under suspicion. Qatar rejects allegations that it's involved. The Gulf country that's hosting the soccer World Cup has gone to considerable trouble to boost its public image and defend itself against extensive criticism in the West over its human rights record. The lawver for Fight Impunity President Pier Antonio Panzeri is not talking. He declined to comment about his client's role in an affair that has shaken the European Parliament and halted the assembly's work on Qatar-related files. The secretary-general of NPWJ, Niccolo Figa-Talamanca, has left jail but must wear an electronic monitoring bracelet. On its Italian website, after he stepped down, the group praised his work, saying it hopes "the ongoing investigation will demonstrate the correctness of his actions". Charged along with them are Eva Kaili, who was removed as an EU parliament vice president after the charges were laid, and her partner Francesco Giorgi, a parliamentary assistant. Pictures they've posted on social media project the image of an attractive and

ambitious Mediterranean jet-set couple. Following months of investigations, police have so far launched more than 20 raids, mostly in Belgium but also in Italy.

Hundreds of thousands of euros have been found in Brussels: at an apartment and in a suitcase at a hotel not far from the parliament. Mobile telephones, computer equipment and the data of 10 parliamentary assistants were seized. Taking to Twitter. Belgian Justice Minister Vincent Van Quickenborne described what he calls the "Qatargate" investigation as a "game changer". It was achieved, he said, "partly thanks to years of work by State Security",

the country's intelligence agency. According to what Italian newspaper La Repubblica and Belgian daily Le Soir said were transcripts of his December 10 statements to prosecutors, Giorgi allegedly confessed to managing money on behalf of an "organisation" led by Panzeri that dealt with Qatari and Moroccan representatives. "I did it all for money, which I needed," Giorgi told prosecutors, according to La Repubblica. He tried to protect his partner Kaili, a 44year-old Greek former TV presenter with whom he has an infant daughter, asking that she be released from jail. Kaili's lawyer has said she knew nothing about the money.

Giorgi arrived in Belgium in 2009. He made a career at the parliament with the center-left Socialists and Democrats (S and D) group. He met Panzeri, at the time an EU lawmaker, at a conference. "I asked him to give me an internship, and he did," Giorgi said in his statement. Panzeri became his mentor, made him an assistant and introduced him around, the Italian newspaper said. Giorgi expressed relief that the scheme had been uncovered. He described himself as a simple person who got in over his head due to a moral obligation he felt toward Panzeri. Up until his arrest. Giorgi worked as an assistant for another S and D lawmaker, Andrea Cozzolino. Italy's centre-left Democratic Party suspended Cozzolino on Friday while the probe goes on. He temporarily withdrew from the S and D. In Italy last weekend, Panzeri's wife, Maria Dolores Colleoni, and daughter, Silvia Panzeri, were taken into custody on a European arrest warrant. (AP)

Dead boy pulled from rubble of latest Russian hit on Ukraine

KYIV, DEC 17 /--/ Emergency crews pulled the body of a toddler from the rubble in a pre-dawn search for survivors on Saturday of a Russian missile strike that tore through an apartment building in the central Ukrainian city of Kryvyi Rih. The missile was one of what Ukrainian authorities said were 16 that eluded air defences among the 76 missiles fired on Friday in the latest Russian attack targeting Ukrainian energy infrastructure, part of Moscow's strategy to leave Ukrainian civilians and soldiers in the dark and cold this winter. Gov. Valentyn Reznichenko of the Dnipropetrovsk region, where Kryvyi Rih is located, wrote on the Telegram social media app that "rescuers retrieved the body of a 1-1/2-year-old boy from under the rubble of a house destroyed by a Russian rocket." In all, four people were killed in the strike, and 13 injured four of them children authorities said. Reznichenko said the pounding from Russian forces continued overnight, damaging power lines and houses in the cities and towns of Nikopol, Marhanets and Chervonohryhorivka, which are across the Dnieper River from the Russian-occupied Zaporizhzhia nuclear power plant. By Saturday morning, Ukraine's military leadership said Russian forces had fired more than a score of other missiles since the barrage a day earlier. It did not say how many of those might have been stopped by the air defences

Friday's onslaught, which pummelled many parts of central, eastern and southern Ukraine, constituted one of the biggest assaults on the capital, Kyiv, since Russia began the war by attacking Ukraine on February 24. Kyiv came under fire from about 40 missiles on Friday, authorities said. nearly all intercepted by air defences. Utility crews scrambled to patch up damaged power and water systems. Kyiv Mayor Vitali Klitschko reported on Saturday that twothirds of homes had been reconnected to electricity and all had regained access to water. The subway system also resumed service, after serving as a shelter the day before. The head of Ukraine's northeastern Kharkiv province Oleh Syniehubov said Saturday that electricity had been restored to the entire region, including Kharkiy city, the country's second-largest metropolis. The power had been knocked out on Friday in attacks involving 10 S-300

In Kryvyi Rih, 596 miners were stuck underground because of missile strikes, but all were eventually rescued, Mayor Oleksandr Vilkul said late on Friday. Installation of a protective dome has begun at the Zaporizhzhia nuclear power plant, an official from the Moscow-installed authorities of Ukraine's southeastern Zaporizhzhia province said on Saturday. Vladimir Rogov said the dome would protect against fragments of shells and improvised explosive devices carried by drones.

The Russian-held plant, Europe's biggest nuclear power station, has been repeatedly shelled. Its six reactors have been shut down for months. The International Atomic Energy Agency recently announced plans to station nuclear safety and security experts at Ukraine's nuclear power plants to prevent any nuclear accident. The UN nuclear watchdog has already deployed a permanent mission to the Zaporizhzhia plant. (AP)

UN rejects seats for Myanmar junta, Taliban, Libya's east

UNITED NATIONS, DEC 17 /--/ The U.N. General Assembly on Friday rejected attempts by Myanmar's military junta, Afghanistan's Taliban rulers, and Libya's rival eastern-based government to take their country's seats at the United Nations. The 193-member world body voted by consensus, with a bang of the gavel by assembly president Csaba Kor si, to approve a recommendation by its Credentials Committee that the requests be deferred. The decision means that Myanmar will remain being represented at the United Nations by Kyaw Moe Tun, who was Myanmar's ambassador when the military ousted civilian leader Aung San Suu Kyi on Feb. 1, 2021. Afghanistan's seat will remain with the country's previous government led by President Ashraf Ghani, which was ousted by the Taliban in August 2021. And Libyan Ambassador Taher Elsonni, who represents the government based in the capital, Tripoli, in western Libya will remain the country's envoy. Guyana's U.N. ambassador, Carolyn Rodrigues-Birkett, who chairs the credentials committee, introduced its report before the vote, citing rival communications from Myanmar, Afghanistan and Libya seeking to represent their countries. "The committee decided to postpone its consideration of the credentials pertaining to the representatives of Myanmar, Afghanistan and of Libya" to a future time in the current 77th session of the General Assembly, which ends next September, she said. Kor si then gaveled adoption of the resolution approving the committee's report. Myanmar's military rulers sought the U.N. seat after Suu Kvi was ousted. The army's coup was met with widespread peaceful protests that were quashed with lethal force, triggering armed resistance that some U.N. experts have characterized as civil war. After the Taliban overran Afghanistan in the final weeks of the U.S. and NATO forces' pullout from the country after 20 years of war, they sought a U.N. seat and initially promised to allow women's and minority rights. (AP)

The latest extension funds federal agencies through Dec. 23. It passed the Senate on Thursday evening by a vote of 71-19. "Negotiations keep trending in the right direction, but we still have a lot of work left to do and not enough time to do it. unless we extend government funding for another week," Majority Leader Chuck Schumer, D-N.Y., said in urging lawmakers to support the stopgap measure. The roughly 1.7 trillion package being negotiated would finance the day-to-day operations of government agencies for the current fiscal year that began Oct. 1. Federal spending programs such as Social Security and Medicare is not part of the annual appropriations process and is not included in the package. House Republicans overwhelmingly have called for a longer-term extension into early next year so they could have a bigger role in setting spending levels for the agencies.

Democrats in the House were able to advance the bill with little GOP support earlier this week. But Sen. Mitch McConnell, the top Republican in the Senate, has made the case that passing a full-year spending bill this Congress is better than the alternatives because it ensures a sizable increase in spending for defense. "If a truly bipartisan full-year bill without poison pills is ready for final Senate passage by late next week, I'll support it for our Armed Forces," McConnell said Wednesday. "Otherwise, we'll be passing a short-term continuing resolution into the new year.' Some Senate Republicans disagreed with efforts to pass a spending bill before House Republicans could take charge. Sen. Mike Lee, R-Utah., said he supported providing a short-term extension into next vear because that would mean "more Republican priorities" in the final package. Sen. Richard Shelby, the

lead Republican on the Appropriations Senate Committee, has said the two parties were about 25 billion apart on overall spending. But lawmakers announced Tuesday night that they had reached agreement on a "framework" that should allow negotiations to be completed by next week. (AP)

Covid-linked deaths seen in Beijing after virus rules eased

BEIJING, DEC 17 /--/ Outside a funeral home in eastern Beijing, dozens of people were bundled up in parkas and hats against the freezing temperatures Friday evening as workers in full protective suits wheeled out coffins one by one.

When an employee with a clipboard shouted the name of the dead, a relative trundled up to the coffin to examine the body. One of the relatives told The Associated Press their loved one had been infected with Covid-19. Deaths linked to the coronavirus are appearing in Beijing after weeks of China reporting no fatalities, even as the country is seeing a surge of cases. That surge comes as the government last week dramatically eased some of the world's strictest Covid-19 containment measures. On Wednesday, the government said it would stop reporting asymptomatic Covid-19 cases since they've become impossible to track with mass testing no longer required. That halt in reporting made it unclear how fast the virus is spreading. Social media posts, business closures and other anecdotal evidence suggest huge numbers of infections. It's also unclear how many

people are dying from the virus. An AP reporter who visited the Dongjiao Funeral home was told by relatives that at least two people cremated there had died after testing positive.

authorities had Health designated Dongjiao and one other funeral home to cremate those who die after testing positive, according to a relative of one of the dead. The woman said her elderly relative had fallen ill in early December, tested positive, and died Friday morning in an emergency ward. She said there were lots of people in the emergency ward who had tested positive for Covid-19, adding that there weren't enough nurses to take care of them. The woman did not want to be identified for fear of retribution. Over about an hour, an AP reporter

> saw about a dozen bodies wheeled from the Dongjiao funeral home. About a halfdozen people inside described how another victim had struggled to breathe that morning before

dying, and the death certificate listed "pneumonia" as the cause of death, even after a positive test for Covid-19, one of those people said. The people interviewed did not want to be identified for fear of retribution.

Three employees of shops in the complex that houses the funeral home said there had been a marked increase in the number of

people going there in recent days. One estimated about 150 bodies were being cremated daily, up from what is normally a few dozen a day. One employee attributed it to the coronavirus, although another said there are usually more deaths with the arrival of winter. The employees did not want to be identified for fear of retribution. China has not reported a death from Covid-19 since Dec. 4. China's official death toll remains low, with just 5,235 deaths - compared with 1.1 million in the United States. However, public health experts caution that such statistics can't be directly compared. Chinese health authorities count only those who died directly from Covid-19, excluding those whose underlying conditions were worsened by the virus. In many other countries, guidelines stipulate that any death where the coronavirus is a factor or contributor is counted as a Covid-19-related death. (AP)



Argentina and France: Routes to the FIFA World Cup final

DOHA, DEC 17 /--/ It is now or never for Lionel Messi. The Argentina superstar's once-in-ageneration career will be defined — for many — by whether he leads his country to the World Cup title on Sunday.

Can he finally, at the age of 35, win soccer's biggest prize to secure his place alongside Pelé and Diego Maradona in the pantheon of the game's greatest ever players? Standing in his way are France, the defending champion, and Kylian Mbappé, the player best positioned to take over from Messi and Cristiano Ronaldo as soccer's marquee name. That's if he hasn't already. Mbappé also is standing on the cusp of history heading into the match at the 80,000-seat Lusail Stadium, a title decider that is filled with storylines. The 23-year-old France forward is looking to emulate Pelé by being a champion at his first two World Cups and set up the prospect of a third title, a feat only ever achieved by the Brazil great who has been hospitalized during this year's tournament because of a respiratory infection. Mbappé was 19 when he led France to its second World Cup title in becoming youngest scorer in a final since a 17-year-old Pelé did so in 1958. While Pelé ended up being a peripheral figure in Brazil's 1962 triumph he didn't play in the knockout stage because of injury — Mbappé has been France's go-to player in the team's bid to repeat. Indeed, Mbappé enters the final tied as the tournament's leading scorer with five goals. The player alongside him?

narratives around the final. There's France, the dominant national team of this generation, looking to become the first to win back-to-back World Cups since Brazil in 1962. The country that produced Michel Platini, Zinedine Zidane, Thierry Henry and now Mbappé will be playing in the final for the fourth time in the last seven World Cups, more than anyone else. France not worried about hostile atmosphere in final

DOHA, DEC 17 /--/ Holders France insist playing in front of a largely hostile crowd in Sunda final against Argentina will not have an impact as they attempt to become the first team in 60 years to retain the trophy. Argentina may have the backing of a majority of neutrals as Lionel Messi bids to win his first World Cup in probably his last ever game at the tournament at the age of 35. In addition Argentina will also have far more supporters in the crowd at the Lusail Stadium, with up to 40,000 expected in Doha for the occasion, while French fans are set to number around 6,000. "I am well aware that Argentina will have a lot of fans behind them," said coach Didier Deschamps, who is hoping to become the first coach to win back-to-back World Cups since Italy's Vittorio Pozzo in the 1930s. "I expect a festive atmosphere with the Argentine people who are passionate and will be right behind their team. "They sing a lot and are very expressive. That's good, it's a World Cup final after all, but our opponents are not in the stands." France can become the first side since Brazil in 1962 to retain the World Cup. Both teams are looking to win the trophy for the third time, with Argentina's last triumph coming in 1986. "It's the same objective for the two teams. One of the two will have a third star on their shirt after tomorrow's game," said Deschamps. Meanwhile captain Hugo Lloris insisted France are not focusing solely on Messi, with Argentina coach Lionel Scaloni having built a solid team around their superstar. "We came into this competition looking to go as far as possible. Lots of people didn't believe in us but here we are back in the final again," said goalkeeper Lloris, with France having arrived in Qatar minus a host of key players due to injury. (AFP)

France battle to stop spread of virus on eve of final against Argentina

"We are trying to take as many precautions as possible, to adapt as necessary and get on with it," the France coach said at a press conference in Doha ahead of Sunday's match. 'Obviously it would be better if this wasn't happening ut we are handling it as well as possible with our medical staff." Central defensive pair Raphael Varane and Ibrahima Konate missed training on Friday due to illness, along with winger Kingsley Coman. Midfielder Adrien Rabiot and defender Dayot Upamecano did not play in Wednesday's semi-final win over Morocco. Deschamps and his captain Hugo Lloris both insisted they could not offer any health updates on Lionel Messi

Saturday morning, with

the team set to train

again later in the day.

"I am fine. As for the players, I left quite early this morning so they were all sleeping," Deschamps, who spoke to reporters at 11:30 am local time. "We are trying to handle the situation as well as possible and remain calm and focused. "I'll get some more information later today and think about that tonight and maybe tomorrow. And of course we're looking forward to being ready for this important game." Players, staff and other sources close to the squad have spoken of a range of symptoms affecting the team in recent days, including fever, stomach pains, and headaches. Measures have been taken at the team's hotel, including isolating certain players, but Covid-19 testing is no longer imposed by world governing body FIFA. France are aiming to become the first team since Brazil

in 1962 to successfully defend the World Cup. They are facing an Argentina side determined to win the trophy in what is likely to be Lionel Messi's last-ever match at the tournament. "We are never really prepared for this type of thing but we are trying to prepare in the best way possible,' Lloris said of the illness worries. (AFP)

Griezmann, the top scorer at Euro 2016 with six goals as hosts France reached the final but lost in extra time to Portugal, is now France's midfield playmaker, a creator of goals but also a tireless worker. Karim Benzema, the Ballon d'Or winner, was ruled out after injuring himself in training before a ball was kicked in Qatar. "He is doing the job of Pogba, Kante and Karim Benzema,' former Argentina defender Pablo Zabaleta told AFP. If the 2016 team was dubbed the "Griezmann Generation", it was the emergence of Kylian Mbappe that helped France take the next step and win the World Cup in 2018. (AFP)

Argentina's World Cup 'spider' man Alvarez, the pride of his village

BUENOS AIRES, DEC 17 /--/ Julian Alvarez has been a revelation for Argentina at the World Cup but back in his tiny home village the player nicknamed "Spider" is celebrated for

his humility and hailed as a "hero" and "ambassador". Having started the Qatar tournament as a substitute, Alvarez has forced his way into the starting line-up through a series of match-winning displays that have seen him bag four goals. The 22-yearold is a near certain to start -- and perhaps star -- in Sunday's final against France. "At seven years old he was a very supportive, responsible and studious boy, given to help his companions," Patricia Magnino, one of Alvarez's teachers at the Rivera Indarte primary school in Calchin, told AFP. "Now he's a star, a great, alongside (Lionel) Messi." Another of his former teachers, Graciela De Barberis added: "He always stood out for his humility and speaking little. Dreams come true if you work for them." Calchin, which means 'salty spot' in the local vernacular, is a humble village of 3,000 people located in the northeast of the rich rural and industrial province of Cordoba. At the entrance to the village and on the school walls there are billboards praising "Julian, the pride of Calchin," alongside depictions of large spiders. Every building in the grid-like village is a single storey, with roads lined with trees such as white quebrachos, pines,

DOHA, Dec 17 /--/ FIFA expects to earn \$11 billion in the 2026 World Cup cycle with a 48-team men's tournament in North America set to deliver a big increase in revenue amid ongoing uncertainty about the exact match schedule. The four-year budget, which was presented Friday to the FIFA Council, foresees an almost 50% increase in income mainly tied to broadcasting and sponsorship deals, plus ticketing and hospitality at a tournament which will use several NFL stadiums. "We are bullish about the power of football," FIFA president Gianni Infantino said after the council meeting. (AFP)
