

8 Myanmar poachers apprehended by Police at West Bay area of Katchal Island: intensive combing operation on for remaining poachers

In a swift and effective response to credible information received from local fishermen on 27/12/ 2023, an anti-poaching team, led by Sub-Inspector Subramani, SHO PS Katchal, conducted a successful operation at the West Bay area of Katchal Island. The operation, which took place on the 28/12/2023, comprised of officers and personnel from Police Station Katchal, including HC Nitish Kumar and Buchendra Rao, PC Niraj Mondal, Sabraj Mohammed, Vinay Kumar Pandey, Sankar S. 
