All schools in A&N Islands to reopen for Classes IX to XII from August 16

Students will be permitted to attend school only with written consent of parents / guardians Schools having more than 300 students has to either run on alternate days with fifty percent students or may stagger school/class timing of each class Online / digital platform shall continue to be the only mode of teaching for Classes I to VIII Directorate of Transport arranges special bus service for N&M Andaman bound teachers

Port Blair, Aug. 11

The Secondary and Senior Secondary Schools of all management (Govt., Govt. Aided, Private Unaided and Local Body Schools) across A&N Islands will reopen with effect from 16th August, 2021 for the students of Classes IX to XII. However, online/digital platform shall continue to be the preferred mode of teaching. Students from Classes IX to XII will be permitted to attend school only with the written consent of parents / guardians.

As per an Order issued by Directorate of Education, schools having more than three hundred students in Classes IX to XII has to

either run on alternate days with fifty percent students or the school concerned may stagger the school/class timing of each class such that not more than three hundred students are present in the school at any point of time. Details of subjects to be taught through classroom transaction/ digital mode and subjects to be learnt by way of self-learning through digital mode have been given in SOPs which have already been communicated to all schools through Zonal Officers for its compliance with the COVID-19 protocols as well as to prevent the spread of COVID-19.

Online / digital platform shall

continue to be the only mode of teaching for Classes from I to VIII.

Special transport and RTPCR/ RAT test arrangements are being made for the inter-island bound teachers to enable them to reach their places of postings by 16th August, 2021 by availing special transport arrangements.

Teachers (except Primary School Teachers) bound to travel to Little Andaman and Nicobar District have been directed to undergo COVID-19 tests (RTPCR) at Multi-purpose Hall, Netaji Stadium from 9 am onwards on 12th August, 2021 positively and to avail special

shipping schedule to be made available on 13th or 14th August, 2021.

Likewise, special boats / buses are being made available for North and Middle Andaman bound teachers including Shaheed Dweep and Swaraj Dweep from 13th August, 2021. Teachers may contact Shipping and Transport Department for timely purchase of tickets.

Meanwhile, the Directorate of Transport has arranged special bus service for inter-island bound teachers. Accordingly, on Aug. 14, three buses will leave for Rangat at 12 noon, one for Diglipur on the

Distribution of foodgrains free of cost to AAY & PHH ration card holders under PMGKAY

Beneficiaries urged to collect entitlement from nearest FPS by Aug. 31

Port Blair, Aug. 11

All AAY & PHH ration card holders covered under NFSA, 2013 have been informed that the Govt. of India has extended distribution of foodgrains free of cost under Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY) @ 5 kg per person per month till November, 2021.

Accordingly, in the month of August, 2021, each AAY & PHH person residing in South Andaman District, North &

Middle Andaman District and Campbell Bay will be entitled for 5 kg foodgrains in the scale of 3.5 kg Rice and 1.5 kg wheat per person per month free of cost. Since, the tribal belt being habitual rice eaters & in the absence of Flour Mills, PHH & AAY beneficiary of Car Nicobar and Nancowry group of Islands will be entitled for 5 kg rice per person per month free of cost under Pradhan Mantri Garib Kalyan Anna Yojana

Providing insurance coverage to farmers for crop loss due to natural calamities for Kharif season 2021 through PMFBY

Isles farmers urged to take maximum benefit; cutoff date for enrolment is Aug.15

Port Blair, Aug. 11

The Pradhan Mantri Fasal Bima Yojana (PMFBY) is one of the Flagship Schemes of the Govt. of India. The scheme is being implemented in these Islands since 2016. The scheme envisages providing Insurance Coverage to the farmers for crop loss arising out of natural calamities. The PMFBY supports sustainable income in Agriculture Sector by providing financial support to the farmers who suffer crop loss due to unforeseen events. The scheme ensures flow of credit for the agriculture sector and stabilizes the income of farmers.



Pradhan Mantri Fasal Bima Yojana Crop Insurance

The PMFBY insurance has been presently notified for implementation throughout A&N Islands for Kharif Season 2021. Under the scheme, paddy crop is presently notified for

Maximum scale of finance fixed for paddy is Rs. 69506.00 per ha (for high yielding variety) and Rs.65676.00 per ha (for Traditional variety). Total sum that can be insured against

possible losses is arrived at, by multiplying the scale of finance with the area covered.

As per the guidelines of PMFBY, 2% of the sum insured is to be paid by the farmers as insurance premium for availing subsidy under the scheme. However, in case of Andaman and Nicobar, farmers need to pay only 0.5% of the sum insured while the remaining

'Swarnim Vijay Varsh Victory Flame' visits Narcondam & Barren Islands

The volcano spewed large masses of gas/lava, symbolically showering its blessings to the flame, as it sailed past the Flat Rock, an islet during low waters. 
Hut Bay, the flame will return to Port Blair for adding glory to the Independence Day parade at Netaji Stadium.

amount is additionally borne as subsidy.

PMFBY covers risks of losses arising from either of the possibilities of prevented sowing, sowing to harvesting (due to drought, dry spell, flood, inundation, pest, diseases, landslide, natural fire, lightning, storm, hailstorm, cyclone etc.), post-harvest losses up to two weeks after harvesting. It also compensates the farmers against localized calamities affecting isolated farms in notified area/single peril risk.

Less than expected average yield due to mid-season adversity viz, floods, prolonged dry spells and severe drought etc. is also compensated for under PMFBY. The enrolment under the scheme is voluntary. All farmers including tenant farmers are eligible for coverage. The cutoff date for the enrolment under the scheme for Kharif, 2021 is 15/08/2021. The farmers have to approach the SBI or Co-operative Bank of the concerned areas alongwith land records and enroll under the scheme.

After enrolment, any losses to the crop arising out of risks covered in the PMFBY need to be mandatorily reported within 24 hours to the Insurance Company (National Insurance Company) directly or through Department of Agriculture and/or Department of Revenue.

For any assistance or queries, farmers are encouraged to contact Kisan Call Centre Help Line No. 243434/18003451145 or approach the Officers/staff of Department of Agriculture in various zones. The farmers of Andaman and Nicobar Islands have been appealed to take maximum benefit of PMFBY scheme, a press release from Directorate of Agriculture said.






