3. ELIGIBILITY CONDITIONS:

- (i) The mode of application is **ONLINE** only. The printed / hard copies of the application form will not be entertained. Therefore, interested candidates shall be required to apply Online for the post whether they are registered with the Employment Exchange or otherwise.
- (ii) The Departmental Candidates must also apply online. 'No objection Certificate's issued by the Head of the Department must be produced at the time of verification of original certificates/documents.
- (iii) The CBT (Computer Based Test) Examination Centre is at Port Blair only.
- (iv) Applicant must be an Indian Citizen.
- 4. The age limits for the posts as per Recruitment Rules are as under:-
 - (i) For Males 18 to 33 years
 - (ii) For Females 18 to 35 years

Note: A Candidate for this examination must have attained the age of 18 years and must not have attained the age over and above 33/35 years in respect of male/female candidates respectively as on the closing date of receipt of online application.

b) PROCESS OF CERTIFICATION AND FORMAT OF CERTIFICATES:-

Candidates who wish to be considered against the vacancy reserved or seek age-relaxation must produce their original certificates issued by the competent authority and to submit a copy of the original certificate duly self-Attested whenever sought by the AAJVS, otherwise, their claims for ST/ OBC/ EWS/PwD/ESM status will not be entertained and their candidature/applications shall be considered under General (UR) category. Certificate for the status of Creamy Layer issued between 01/06/2020 to 31/05/2023 only will be accepted.

 \underline{NOTE} : Candidates are cautioned that they shall be permanently debarred from the examination conducted by AAJVS in case, they fraudulently claim ST/ OBC/ EWS /PwD/ESM status.

c) Visually handicapped (VH) candidates with visual disabilities of forty percent (40%) and above and candidates suffering from Cerebral Palsy can avail the assistance of a SCRIBE in CBT examination subject to such request being made in the application form beforehand. Questions Papers and Answer Sheets will not be provided in BRAILLE. No attendant will be allowed with Visually handicapped (VH)/Cerebral Palsy candidates inside the examination premises.

NOTE: Persons with Visual Disability of less than forty percent (40%) will not be considered as Visually Handicapped persons. One eyed candidates and partially blind candidates who are able to read the **normal questions set for all candidates** with or without magnifying glass and who wish to indicate the answers with the help of magnifying glass will be allowed to use the magnifying glass in the examination hall and will not be entitled to a Scribe. Such candidates will have to bring their own magnifying glass to the examination hall. Similarly, other person with less than forty percent (40%) disability will not be considered under VH/HH/OH/MI category as the case may be.

8. Date and Timing of Examination:


The CBT (Computer Based Test) examination at Port Blair centre shall be conducted in multiple shifts on the dates as indicated in the Hall Ticket

NOTE: Each candidate may be required to appear for examination as per allotment of examination centre by the AAJVS/Recruiting Agency either in Shift – I (Morning) or Shift – II (Afternoon) as indicate in their Hall Ticket/Admit Card.

NB: The Andaman Adim Janjati Vikas Samiti (AAJVS) reserves the right to restrict entry to the examination venue till 8.30~am in Shift – I the morning shift and till 1.30~pm in the afternoon Shift –II.

There shall be a single paper for the two sections of Subject Matter and General Aptitude and having "Objective Multiple- Choice- type Questions". The Authorities Shall however, have full discretion to fix the minimum qualifying marks in one and all the subjects. The question paper in all subjects at Sl No.(1) and (2) will be set in English language only.

9. VERIFICATION OF DOCUMENTS:-

All the successful candidates short listed after CBT (Computer Based Test) should get their original certificates/ Testimonials duly verified as are mandatory and submit another self attested copy of all those mandatory certificates /testimonials in person alongwith the printed copy of Online Application from the Administrative Officer, office of the Executive Secretary, AAJVS Port Blair., failing which, his/her candidature shall be struck off from the relevant panel for all purposes and no further request/correspondence shall be entertained.

10. GENERAL INSTRUCTIONS TO BE COMPLIED WITH THE CANDIDATES IN THE EXAMINATION CONDUCTED THROUGH COMPUTER BASED TEST.

- (i) Candidates must indicate the answers in their own.
- (ii) Candidates are not permitted to use calculators and other electronic gadgets except as specified in the Notice. They should not, therefore, bring the same inside the Examination Premises/Venue.
- (iii) If any candidates are found to possess mobile phones or any other means of wireless communication in the working (Switch on) or switched off mode, his/her candidature shall be cancelled forthwith.
- (iv) Other instructions will be issued along with the Admit/Hall Ticket.

11. MODE OF SELECTION:

Candidates will be short-listed on the basis of their performance and merit. The cut-offs marks shall be fixed at the sole discretion of the Andaman Adim Janjati Vikas Samti.

Provided that OBC, candidate, who are selected on their own merit without relaxed standards, will not be adjusted against the reserved share of the vacancies.

The reserved vacancies will be filled up separately from amongst the eligible OBC, are domicile of A & N Islands and who are lower in merit than the last General candidate (UR) in merit list of un-reserved category but otherwise found suitable for appointment even by relaxed standard.

Success at the examination confers no right of appointment whatsoever unless the Andaman Adim Janiati Vikas Samiti (AAJVS) is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respects of appointment to the service/post and the decision in this regard shall be final & binding.

12. **RESOLUTION OF THE TIE CASES**

13. <u>ADMISSION TO THE EXAMINATION:</u>

All candidates who apply in response to this advertisement on or before the CLOSING DATE & TIME FOR ONLINE APPLICATION will be assigned Roll numbers. The Admit Cards will be made available on the website of A & N Administration i.e. www.andaman.gov.in and https://erecruitment.andaman.gov.in around 2 weeks before the Examination (CBT). In case, a candidate does not find his/her name in the above uploaded list, candidate must immediately contact the Administrative Officer, AAJVS, Annex Building of Directorate of Tribal Welfare, Secretariat Port Blair at email esaajvs@gmail.com with proof of having submitted his/her application online. Failure to do so shall deprive him/her of any claim for consideration subsequently.

The candidates must carry at least one photo bearing identity proof such as Driving License, Aadhaar Card, Voter Card, College/University ID Card, Income Tax PAN in original and Admit Card downloaded from the website, while attending the examination, failing which, they shall not be allowed to appear for the examination.

- (i) The AAJVS has advertised recruitment to Group "B" Non-Gazetted posts of Tribal Welfare Officer Pay Level-06 (Non-Pensionable) under this Organization for which, Bachelor Degree in Anthropology/Sociology/Social Work is the minimum essential qualification.
- (ii) AAJVS will not undertake detailed scrutiny of applications for the eligibility and other aspects before the CBT examination, and thus the candidature is accepted only provisionally. The candidates are advised to go through the requirements of educational qualification, age etc. and satisfy themselves that they are eligible before applying. When scrutiny is undertaken, at any stage, if any claim made in the application is not found substantiated, the candidature shall be cancelled and the AAJVS's decision shall be final and binding.
