#### MP sanctions Rs. 60 Lakhs under MPLADS fund for construction of RCC Overhead water tank of 150000 Lts. storage capacity at Dairy Farm; Requests land from PBMC Secretary

Port Blair, Jan 16:

The Member of Parliament of Andaman and Nicobar Islands, Mr. Kuldeep Rai Sharma recently met the Secretary of PBMC and requested him to allot 200 sq mtr land (of PBMC) at Dairy Farm area of Port Blair city near the water treatment plant of APWD, for construction of an RCC Overhead water tank of 150000 Ltrs. storage capacity.

The above work, with an approximate cost of Rs. 60,00,000 (Sixty Lakhs) was earlier sanctioned by the Member of Parliament for proper water supply to the residents of Dairy Farm and its adjacent areas under MPLADS so that the acute water scarcity faced every year by residents of Dairy Farm area and adjoining area could be effectively resolved. As nonavailability of sufficient land for this project was a major hurdle the Member of Parliament met with the Secretary of PBMC recently and requested him to allot 200 sq mtr land (PBMC land) near the water treatment plant of APWD, which is at the hilltop. The Secretary of PBMC reportedly assured to do the needful in this matter at the



## Inexplicable EC relaxation on hall meetings for polls

A few clear messages and a muddled one emerged last week in the context of the upcoming elections to five states. Yogi Adityanath entered the Assembly election fray for the first time from the safest of seats in Gorakhpur, giving himself ample time to campaign extensively elsewhere in Uttar Pradesh. Though the mystery over his angling for the Ayodhya seat continues, Adityanath's X factor enthuses and worries the Big Two in the party in equal measure. If he does retain power, he would become the only UP chief minister in 35 years to get consecutive terms. And by giving close to 60% seats in UP to OBCs and Dalits, the BJP showed intent to arrest the bleeding of backward leadership in its ranks last week

As for Akhilesh, he drew the BJP defectors. But giving them tickets at the expense of party aspirants or allies is not going to be easy. He has already broken off negotiations with Dalit neta Chandra Shekhar Aazad. This will be a closely fought election with slender margins of victory in various places. Aazad's ability to transfer pockets of votes could have given the SP a significant edge. In the Congress camp, after releasing a pink manifesto, Priyanka walked her talk by giving 40% seats to women in the first list, including to the mother of the Unnao rape survivor. The Congress in Punjab went largely with state unit president Navjot Singh Sidhu's choice of candidates, giving him little opportunity to crib. Where it would leave CM Charanjit Singh Channi, the new Dalit mascot of the party, remains to be seen. Channi regretting the controversial security breach during PM Narendra Modi's Punjab visit after rubbishing it initially is set to become a major poll plank. Also, AAP chief Arvind Kejriwal did a jumla by crowd sourcing ideas for his party's chief ministerial face in Punjab.

The questionable reading of the Covid situation came from the Election Commission, which retained its ban on poll mobilisation in most forms but allowed restricted hall meetings. How would meetings within an enclosure be safer than, say, spaced-out cycle or bike rallies? Surely common sense cannot be given a pass to celebrate the festival of democracy.

# Zero tolerance towards corruption in any sector Criminal action initiated against missing fertilizers at Agriculture Sub-Depot at Ferrargunj

Case registered to unravel conspiracy & nexus between concerned officials of Department & private persons

Port Blair, Jan. 15

In line with campaign and steps taken for no-tolerance to corruption and irregular practices in the Government Departments by the A&N Administration under the guidance of the Chief Secretary, Agriculture Department has initiated action to curb such activities in the Department.

In this context, a Committee constituted under the Joint Director (Agri.) HQs detected a huge discrepancy on 12.01.2022 between the quantities of DAP(Di-ammonium Phosphate) and MOP (Muriate of Potash) fertilizers listed in the stock register and found in the physical stock at the Department's Sub-depot at Ferrargunj. The missing fertilizers details are as under:-

Apparently, the above discrepancy occurred due to pilferage and misappropriation in connivance and collusion of the concerned officials manning the Sub-Depot as no case of theft has neither been reported to the superior officers of the Department nor the Police.

Considering the seriousness of the issue of pilferage of fertilizers meant for small and marginal farmers by probable diversion and sale in the black market, a case has been lodged by the Department at P.S. Orgrabraj to unravel the conspiracy and nexus between the concerned officials of the Department and private persons involved in the said illegal act and to take action against the culprits.

Further, the Department has also initiated disciplinary proceedings against the delinquent officials. The Department has thus taken swift action to send a stern message to Govt. servants involved in such acts of misconduct and financial irregularities.

## NCPCR asks Yogi government to probe Darul Uloom Deoband portal for 'unlawful' fatwas



PTI, NEW DELHI: The National Commission for Protection of Child Rights (NCPCR) asked the Uttar Pradesh government to probe Islamic seminary Darul Uloom Deoband's website for allegedly publishing "unlawful and misleading" fatwas

The apex child rights body on Saturday also asked the state's chief secretary to block access to the website until such content is removed.

Reacting, the Students Islamic Organisation of India called it yet another attempt at targeting madrasas and their education by cherry-picking some fatwas and sensationalising them.

The NCPCR said it is acting on a complaint which alleged that the website carries a list of fatwas that are against the provisions provided under the country's law.

"Taking cognisance of the complaint u/s 13 (1) (j) of the Commissions for Protection of Child Rights Act, after pursuing the complaint and examin-

ing the website, it was observed that the explanation and answers provided in response to issues raised by the individuals do not align with the laws and acts in the country," the NCPCR stated in the letter to the state's chief secretary.

It said such statements were contrary to the rights of children and open access to the website was harmful for them.

"Therefore, it is requested that the website of this organisation may be thoroughly examined, investigated and any such content should be immediately removed," the letter stated.

"Further, access to such website may be prevented until the removal of such content for avoiding spread and recurrence of unlawful statements and consequently preventing incidents of violence, abuse, neglect, harassment, discrimination against children," the letter read.

It also asked the state

In a statement, Fawaz Shaheen, national secretary, Students Islamic Organisation of India claimed the NCPCR's letter is yet another attempt at targeting madrasas and their education by cherry-picking some fatwas and sensationalising them.

"Fatwas are nothing but personal views of religious scholars on various matters pertaining to personal and social life.

In fact, on a given issue, the scholars often have differing opinions and none of them carry any legal sanctity or institutional approval.

People are completely free to act according to their own understanding of the religion," it said.

The SIO said it is a settled position of law in India that issues of inheritance, marriage, divorce and other personal matters, including adoption, are covered by the respective customary laws of different communities and religions.

### Over 200 illegal petition writers arrested in Assam, says CM Himanta



PTI, GUWAHATI: Over 200 illegal petition writers who allegedly seek money to write petitions and add irrelevant sections of laws while drafting them were arrested from across Assam, Chief Minister Himanta Biswa Sarma said on Sunday.

Sarma, who had earlier cautioned against such illegal petition writers, said more arrests will be made soon.

"Assam Police have arrested 242 illegal petition writers since Saturday night. We can expect 20-25 more arrests shortly," the chief minister told reporters.

Such petition writers who operate outside several police stations "manipulate" petitioners by mentioning wrong sections of law in the complaints thereby making the cases "unnecessarily complicated", the chief minister said.

A police officer said that though writing a petition on behalf of another person is not illegal, it becomes so when money is charged for it and irrelevant sections are incorporated in a complaint without the petitioner being explained about it.


"These petition writers manipulate innocent people and also charge money for writing the petitions," he said.

The chief minister had in November warned of cracking the whip against illegal petition writers and asked the officer-in-charge of the police stations to act against them.

Sarma had pointed that it is the job of the sub-inspectors to draft the complaints, and people should not pay for the service.

A similar crackdown was undertaken in September last when over 500 alleged illegal land brokers were arrested from several areas of the state after the chief minister had directed the police to act tough against such middlemen.

### Now, 75 per cent jobs in Haryana with max Rs 30,000 pay mandatory for locals



PTI, CHANDIGARH: As the law in Haryana, that provides 75 per cent reservation in private sector to job seekers from the state came into effect, Deputy Chief Minister

Dushyant Chautala on Sunday said it will open new avenues of employment for thousands of youth.

The Haryana State Employment of Local Candidates

Act, 2020, applies to jobs offering a maximum gross monthly salary or wages of Rs 30,000 and it came into effect on Saturday.

It is a "historic day" for the youth of Haryana, Chautala said in Sirsa.

He said the labour department has also created a dedicated portal where companies in the state will have to reflect the number of vacancies and this will be constantly monitored by the government.

Violation of any provision under this Act will be a punishable offence, he cautioned, adding a helpline number has also be introduced.

Notably, providing 75 per

cent reservation in private sector jobs was a key poll promise of Chautala's Jannyak Janta Party (JJP).

In the 2019 Haryana Assembly polls, the BJP, which fell short of simple majority, formed the government in alliance with the JJP.

In November, Chief Minister Manohar Lal Khattar had said the Haryana State Employment of Local Candidates Act, 2020, will be made applicable with effect from January 15 this year.

Though the government had promised that the Act will apply for all jobs that offer a gross monthly salary up to Rs 50,000, it issued another notifi-

cation last year specifying that the upper cap had been reduced to Rs 30,000.

In March 2021, Haryana Governor Bandaru Dattatreya had given his assent to the Haryana State Employment of Local Candidates Bill, 2020.

The state government had last year said the said Act will be applicable to employers of private sector companies, societies, trusts, limited liability partnership firms, partnership firms and any person who employs 10 or more persons on salary, wages or other remuneration for the purpose of manufacturing, carrying on business or rendering any service in Haryana.

#### LPG distributors should provide weighing instrument to measure quantity of LPG cylinder at the time of delivery

Port Blair, Jan. 16

All LPG consumers and the authorized LPG distributors of this UT have been informed that as per the Legal Metrology (Packaged Commodities) Rules, 2011 framed under the Legal Metrology Act, 2009, it is mandatory for all the authorized LPG distributors to provide their delivery man a check weigher or nonautomatic weighing instrument to measure or weigh the quantity of the LPG cylinder at the time of delivery.

The consumers have the right to demand weighing of LPG cylinders at the time of delivery so as to ensure exact quantity being delivered to them. The weight of a domestic LPG cylinder is commercial transaction.

weight of empty cylinder +14.2 kg of LPG filled in it with a maximum permissible error of 150 gm.

Similarly, the weight of a 19 kg commercial LPG cylinder is weight of empty cylinder +19 kg of LPG filled in it with a maximum permissible error of 1% and that for a 5kg commercial LPG Cylinder is weight of empty cylinder +5 kg of LPG filled in it with a maximum permissible error of 1.5 %. The empty weight of LPG cylinder is printed on the body of the cylinder.

The distributor shall get the weighing machine duly verified and stamped from the Legal Metrology Section functioning in the Directorate of Civil Supplies & Consumers Affairs prior to using it for any

All the authorized LPG distributors have been informed to strictly comply with the rules and make necessary arrangements for weighing of LPG cylinders during delivery, failing which, strict action as per law shall be initiated against the distributor.

#### China anti-virus measures in full force after Beijing reports positive case



BEIJING: Beijing's first reported case of the omicron variant has prompted stepped-up measures in the nation's capital, just weeks before it hosts the Winter Olympic Games.

Following the positive test announced Saturday, more than 13,000 people and all places visited by the patient over the previous days have been tested, according to state media. The person's apartment complex and workplace have been sealed off.

The infected person lives and works in the city's northwestern district of Haidian and had no travel history outside of Beijing for the past two weeks, according to state media.

State media on Monday reported the capital, with its 20 million residents, was con-

sidering stronger restrictions on travel. All transit links with Tianjin have already been severed. International flights have been sharply reduced and domestic travellers have been barred if they transferred to a second location before arriving in Beijing.

No new cases were reported in Beijing on Monday, although the nearby city of Tianjin saw another 80 cases recorded over the previous 24 hours

The Olympics open on Feb. 4, just days after the start of Lunar New Year celebrations. Athletes, officials, staff and journalists are required to enter a closed-loop bubble without outside contact and undergo daily testing.

Beijing Daily reported Sunday that the capital will require travellers to take nucleic acid tests within 72 hours of entry starting Jan. 22. Some schools in Beijing have also closed early and moved classes online ahead of the winter holidays.

REVERBERATION

Officials across the country also urged residents to stay in their cities for the new year, instead of travelling back to their hometowns. Tourist sites, including sections of the Great Wall, have also closed amid China's "zero-COVID" policy that has seen millions of people placed under lockdowns.

The economic, logistical and psychological stresses resulting from that policy have become increasingly apparent, creating tension over how long the restrictions must remain in place.

Following three weeks of isolation, the ancient capital of Xi'an appeared to be turning a corner, with stay-at-home rules lifted on neighbourhoods determined to be virus-free.

Roughly 1,000 kilometres (600 miles) southwest of Beijing, the city of Xi'an, which has a population of 13 million and counts as a major tourist site for its famed Terracotta Warriors, has reported over 2,000 infections since December last year.

#### Biden, new Japanese prime minister to meet virtually Friday



WILMINGTON: President Joe Biden will meet virtually with Prime Minister Kishida Fumio of Japan on Friday, as the omicron variant of the coronavirus continues to surge around the

The White House said Sunday the meeting will take place to highlight the strength of the U.S.-Japan alliance. The two are looking to deepen ties in the face of China's growing economic and military clout in the region.

Kishida was elected in November and the two leaders will be meeting for the first time. In April, Biden met in person with then-Prime Minister Yoshihide Suga, who travelled to Washington for talks.

Kishida was chosen by the Liberal Democrats as a safe, conservative choice. They had feared heavy election losses if Suga, who was highly unpopular, had stayed in office. He resigned after only a year in office as his popularity plunged over his handling of the coronavirus pandemic and his insistence on holding the Tokyo Olympics despite concerns

of a virus surge.

White House press secretary Jen Psaki said in a statement that Biden was looking forward to "working with Prime Minister Kishida to advance our shared vision for a free and open Indo-Pacific, and to expand our close cooperation on critical issues like combatting COVID-19, addressing the climate crisis, and partnering on new and emerging technologies."

#### Satwik-Chirag pair claims maiden India Open title



PTI, NEW DELHI: Satwiksairaj Rankireddy and Chirag Shetty on Sunday became the first team from the country to win the Yonex-Sunrise India Open after toppling three-time world champions Mohammad Ahsan and Hendra Setiawan, here.

The world number 10 Indian pair, which had won its first Super 500 tournament in Thailand in 2019, upset the

top-seeded Indonesian pair 21-16 26-24 in 43 minutes to make a rampaging start to the new season.

Coming into the match with a 1-3 head-to-head record, Satwik and Chirag dished out a brave effort as they staved off a fightback to reign supreme in

From almost missing the tournament following a false COVID positive result to win-

ning the title, it turned out to be an incredible start to 2022 for the Indian pair, which accumulated valuable ranking points ahead of a busy season, which comprises some big-ticket events such as the Commonwealth Games and Asian Games.

The Indian pair started on a positive note and even though the Indonesian combination clawed back, Satwik and Chirag ensured they are two points ahead at the first interval.

The Indians tried to engage their rivals in rallies and led 18-13 but the Indonesians reduced the deficit to 16-18 before Satwik and Chirag prevailed in the opening game.

Fast-paced but short rallies were the norm in the second game as well as Ahsan and Satiawan grabbed a three-point lead at 9-6 early in the second game.

But the Indian pair again ensured they have the advantage at the break, grabbing a slender 11-10 lead.

Sawtik and Chirag maintained the intensity in the rallies after the break to lead 15-

The world number two again drew parity at 17-17 but Satwik and Chirag moved to 19-17 when Ahsan erred at net.

But Chirag went long next as it was 19-19.

Indonesian managed to move to a game point with a tap by Ahsan.

What followed next was the frequent exchange of points as both India and Indonesia earned and squandered their advantage positions in equal measure.

After a fierce battle, it was the Indian pair who showed better nerves to emerge victorious with Indonesia squandering five-game points.

Satwik and Chirag had won the Thailand Open Super 500 title in 2019, besides reaching the finals at French Open Super 750 the same year.

The duo also claimed the silver medal at the Gold Coast Commonwealth Games, besides winning the Hyderabad Open Super 100 and finishing runners-up at Syed Modi International in 2018.

Satwik and Chirag also played a crucial role in India earning the historic mixed team gold medal in the 2018 Commonwealth Games.

The Indian pair also had qualified for the Tokyo Olympics last year but couldn't cross the group stage despite winning two out of three games.

#### Australia beats England by 146 runs, completes 4-0 Ashes win



HOBART: Australia completed a dominant 4-0 Ashes series victory over England on Sunday by winning the fifth day-night test by 146 runs with two days to spare.

England set a target of 271 for victory, crashed to 124 all out in the last session on the third day at Hobart, losing 10 wickets for 56 after Zak Crawley (36) and Rory Burns (26) combined in the best opening stand of the series by putting on 68 runs.

Fast bowlers Scott Boland (3-18) and Cameron Green (3-21) made an impact in their first Ashes series by sharing six wickets on a lively greenish wicket as England crumbled against pace for the second time in the match after being dismissed for 188 in the first innings in reply to Australia's score of 303.

Australia skipper Pat Cummins also had an impact in his second spell to finish with 3-42 on an eventful day that saw 17 wickets tumble for the second successive day in the game. Cummins, who grabbed the last two wickets off three balls, led from the front in his first series as Australia captain and grabbed 21 wickets.

"It's pretty crazy, even as a professional cricketer these are the series you have in your diary a couple of years out," said Cummins. "Really feels like we are building to something big. To have someone like Cameron Green in his second year to grow as a batter and bowler as well as some of the younger players â¢; can't wait to show our wares overseas, we really judge ourselves in all conditions."

Earlier, Australia was bowled out for 155 just after the dinner break for an overall lead of 270 runs after it resumed from an overnight 37-3.

England paceman Mark Wood snared 6-37, utilizing short-ball tactics against the Australians to perfection. Alex Carey top-scored for Australia with 49 after getting two reprieves. "We've been outplayed in all areas and credit to Australia," said England captain Joe Root, who remained the tourists' lone fighter with 322 runs, behind only Travis Head (357) and Marnus Labuschagne (335) who led the home side.

"We've played good cricket in parts, just not been able to structure a whole game togetherâ¢; it's pretty obvious we need to be putting more runs on the board (and) too often we've not given our bowlers enough to work."

Australia missed an early opportunity when Burns could have been out lbw in Mitchell Starc's second over, but Cummins chose not to go for a television referral as the replays suggested the ball crashing onto the top of the stumps.

Burns and Crawley showed the first real intent from any English batsmen in the series by driving off their pads against Cummins and Starc as they scored at a healthy run-rate of more than four runs an over.

But once Green was introduced at the stroke of the tea break, the tall fast bowler had Burns deflect a short delivery onto his stump as the left-hander was unsure whether to play the ball or leave it.

Green followed up on the breakthrough with two more quick wickets at the start of the last session as Dawid Malan played onto his stumps and Crawley was brilliantly caught behind by Carey off a delivery that swung away from the righthander and took the edge.

Boland then limited the runs through his impeccable fast bowling before claiming the wicket of skipper Root for the fourth time in the series as the ball stayed below the knee roll and crashed onto the off stump.

Boland then struck in successive overs when Sam Billings, playing in his debut test, lobbed a gentle catch to mid-on and Carey played another blinder to dismiss Chris

Woakes.

Cummins finished off the game by clean bowling Wood and Ollie Robinson as Australia recorded victory in a test match in which offspinner Nathan Lyon didn't bowl a single over.

Australia won the first three test matches before England escaped with a draw at Sydney, where the last pair of batters survived the final two overs under intense pressure in a result that eventually meant the tourists avoided a 5-0 sweep.
