PORT BLAIR, JAN 23/--/ Minister, Mr. NarendraModi on Monday named 21 largest unnamed islands of Andaman & Nicobar Islands after 21 ParamVir Chakra awardees to mark 'ParakaramDiwas',

the birth anniversary of NetajiSubhas Chandra Bose. At an event held at DBRAIT here this morning, the Prime Minister through video-conferencing also unveiled the model of the National Memorial dedicated to Netaji, which will be built on NetajiSubhas Chandra Bose Dween

The proposed memorial will have a museum, a cable car ropeway, a laserand-sound show, a guided heritage trail through historical buildings and a theme-based children's amusement park, besides a restro lounge. The 21 unnamed islands located in the

Archipelago will now be known by the names of ParamVir Chakra awardees and the Netaji memorial will be a site for inspiration for the future generations," said the Prime Minister while addressing the gathering. In his speech, Mr.

Modi said Andaman & Nicobar Islands is the land where the Tricolour was hoisted for the first time by Netaji, where the government of independent India was formed for the first time. "Unfortunately, the sites of the Independence struggle, Andaman's identity, were tied to the reminders of colonisation. Even the names of our islands were imprinted with the past of colonisation," he said recalling his visit to the group of islands in 2018 when he renamed Ross Island as NetajiSubhash Chandra Bose Dweep.



Radicalisation of Muslim youth a major challenge for national security: Papers submitted at meet of DGPs

of the Muslim youth, is one of the key challenges for national security and it is important to take moderate Muslim leaders and clerics into confidence to counter organisations, according to papers submitted at a security meet attended by Prime Minister Narendra Modi.

The papers, written by some Indian Police Service (IPS) officers and submitted just-concluded conference of DGPs and IGPs. noted that the rise in religious fundamentalism in India is primarily due to high level of indoctrination, easy availability of modern means of communication, including encrypted form, cross-border terrorism and Pakistan concentratingonencouraging these radical groups. Apart from the Prime Minister, the three-day annual conference was attended by Union home minister Amit Shah, National Security Adviser (NSA) Ajit Doval and about 350 top police officers of the country. "Radicalisation, particularly of the Muslim youth, is one

for national security of our country. Several radical Muslim organisations are active in India, which indulge inorganised radicalisation of the Muslim youth. They have inherent tendency to corrupt minds of Muslim community push them on the violent path and work against composite culture," the papers noted.

In view of this, tackling radical organisations become imperative and priority in the interests of social harmony and national security. These organisations are engaged in radical interpretation of Islamic scriptures and concepts


They also create a sense of victimhood in Muslim psyche. In pursuit of puritanical Islam, their preachinggoagainstmodern values such as democracy and secularism. In India, the papers revealed, the recently banned Popular Front of India (PFI), another banned group SIMI, Wahdat-e-Islami, Islamic Youth Federation. Hizb-ut Tahreer and Al-Ummah are some Muslim organisations, which fit in this category. "Among these

Muslimorganisations, the PFI was the most potent radical organisation. It evolved as a national-level organisation since formation in 2006 by merging of three South India based outfits," the papers

Rise in religious fundamentalism is due to history and attending continuous religious programmes such as DarseQuran, Ahle-Hadith etc., high level of indoctrination, means communication viz. internet, mail in coded and encrypted form, the papers said. The cross-border terrorism and its post effects, Pakistan concentratingonencouraging these radical organisations, MuslimboysgoingtotheGulf countries and coming back with money and radical ideologies are some other reasons for the rise of radicalisation, according to the papers said. The writers that terrorist radicalisation is a dynamic whereby individual comes to accept terrorist violence as a possible, perhaps even legitimate, course of action

and each case of terrorist radicalisation results from the unique intersection of an enablingenvironmentandthe personal trajectory and psychology of a given individual. Suggesting Suggesting remedies, the papers noted that to tackle radical Organisations, multi-pronged approach is required, including monitoring of covert activities, creation of $detailed\, databases\, on\, leaders$ and other entities of interests.

'Security agencies and state police need to be sensitised about threat to nationalsecurityfromradical organisations and in order to counterradicalorganisations, it is equally important to take moderateMuslimleadersand clerics into confidence. "Emphasis should be given to identify and monitoring the hotspotsofradicalisation and prior analysis must be done about the potentiality of a radical organisation in spreading extremism and involvement of its cadres in violent action $accordingly the plan \, of action \,$ should be initiated," the

The petition was filed last year in the backdrop of Delhi chief minister Arvind Kejriwal being denied permission for his visit to Singapore for the 8th World Cities' Summit from July 31 to August 7, 2022. At the outset, Justice Prathiba M Singh asked why replies were not filed by the authorities. The counsel for the Centre and LG said as a last opportunity, some more time be given to them to file their counter affidavits. "Why are you not filing the reply. It cannot go on like this Last and final opportunity is granted to file the counter affidavits within four weeks. List on May 22,"

Delhi HC grants 'last opportunity'

The High Court had on August 29, 2022, issued notices and asked the Delhi LG and Union government through ministries of external affairs, finance and home affairs to file their counter affidavits in response to the petition. The petition said this was not the first instance of such "abuse of discretion" and mentioned that the chief minister was previously denied permission to attend the C-40 World Mayors' Summit in Copenhagen in 2019 and even Gahlot had requested for clearance to visit London on an invitation but there was no response from authorities in the Centre till the time the request became infructuous

Gahlot, who is an Aam Aadmi Party (AAP) leader, has sought issuance of guidelines to channel and guide the implementation of several office memoranda issued by the Cabinet Secretariat, empowering the Centre to grant or deny permission to state government ministers for foreign visits in their official capacity.

Gahlot, in his plea, said all these visits were on invitation and were crucial for a for exchanging ideas on improving urban governance and showcasing Delhi's own progress in urban design. The alleged draconian manner in which the central authorities have used their discretion on travel clearances is only exacerbated further by the fact that even personal visits by state government ministers must be cleared by them, he said.

The petition sought quashing of the office memoranda (OM) to the extent that they require state government ministers to seek political clearances from the respondents for personal visits abroad. The petition also sought quashing of the undated letter sent by the LG to the Delhi government on July 20, 2022, advising against the chief minister's proposed

It said according one of the OMs issued by the Cabinet Secretariat, clearances are required from the department of expenditure in the ministry of finance, the ministry of home affairs, the ministry of external affairs and the relevant central administrative ministry and once these clearances are obtained, for visits involving a chief minister, a final clearance from the PMO is required.

"The whimsical and capricious manner in which travel clearances for Indian statespersons are treated is prejudicial not just to the interests of good urban governance in this case, but also national interests in global platforms generally.

Not only has the respondent no. 1 (LG) acted beyond his jurisdiction in advising against the Singapore visit, but the actual exercise of the powers conferred by the Office Memoranda above noted has been manifestly arbitrary and reflects unchanneled and unbridled use of discretion on part of the respondents," the plea said.

It submitted that there appears to be no prima facie reason or basis for denial of clearances for this particular visit to Singapore, making the action of the authorities manifestly arbitrary and without any

evident discernible principle. "Such arbitrary and whimsical denial of travel permissions to important constitutional functionaries is a routine matter, and is often achieved either by prima facie illogical decisions or simply by delayed decision-making serving as a pocket veto," it claimed. (PTI)

JAMMU, JAN 23 /--/ Alleging that Kashmir Pandits are facing injustice at the hands of the government, Congress leader Rahul Gandhi on Monday asked Jammu and Kashmir Lieutenant Governor Manoj Sinha to apologise to the community for telling the prime minister's package

"Injustice is being meted to Kashmir Pandits by government...this morning, a delegation of KashmiriPanditsmetmeand briefed me about their issues. I was surprised to know that their delegation was told by the lieutenant governor that they should not seek alms."

gathering at the end of the day's yatra at Satwari here. Rahul said he wants to tell thelieutenantgovernorthatthey are not demanding alms but are seeking their rights. "You (LG) should seek for giveness from them (Pandits)," he said.

Earlier, social activist Amit Koul, who was part of the delegation, said they have invited Rahul to their Jagti township along the Jammu-



Srinagar National Highway and that he is likely to visit the community on his way to Kashmir. "We had a very good interaction with Gandhi and we briefed him about the issues of the community, especially the prime who were provided jobs by previous government Manmohan Singh. 

However, many of the employees fled to Jammu after one of their colleagues, Rahul Bhat, was shot dead by terrorists inside his office in Budgam district on May 12 last year in what was described as a case of targeted killing. They are on a strike demanding their relocation out of the Valley. According to Kachroo, they were initially supposed to meet him as a 13-member delegation but several more joined them and "we raised issues which the community is facing". Charging the BJP $with \, using \, the \, community \, to \,$ further its political agenda, Kachroo said: "They do not really mean to solve the problems of the Kashmiri Pandits because for them it is a political agenda to spread hate on the basis of religion.

Digvijaya questions surgical strikes, BJP accuses Cong of insulting armed forces in 'hate' for Modi

JAMMU/NEW DELHI, JAN 23 /--/ Congress leader Digvijaya Singh on Monday questioned the surgical strikes and accused the Union government of peddling lies, drawing furious reaction from the BJP which said the Opposition party was blinded by its "hate" for Prime Minister Narendra Modi and has "insulted" armed forces. Addressing a public meeting during the Bharat Jodo Yatra in Jammu and Kashmir, Singh $alleged \, that \, the \, government \, did \, not \, agree \, to \, the \, CRPF \, request$ of flying its personnel from Srinagar to Delhi and 40 soldiers sacrificed their lives in Pulwama in 2019 to a terror attack. "They talk of surgical strikes. They claim to have killed so many people but no proof is given. They are ruling by peddlinga bundle of lies," the former Madhya Pradesh chief minister, who has often courted controversy with his comments, said. The BJP launched a sharp attack on the Congress, saying that such comments show that the Rahul Gandhi-led foot march across the country is Bharat Jodo Yatra only in name while he and his party colleagues are working to "break" the country. Morbi bridge tragedy: Gujarat court issues arrest warrant against Jaysukh Patel of Oreva Group

Gujarat court has issued an arrest warrant against Jaysukh Patel of Oreva $Group\,in\,connection\,with\,the$ October 30 bridge collapse in Morbi in which 135 persons were killed.

Ajanta Manufacturing Limited (Oreva Group) was responsible for the operation and maintenance of the British-erasuspensionbridge on the Machchu river that collapsed, with a special investigation team formed by the state government citing several lapses on the part of the firm. Morbi chief judicial magistrate MJ Khan had issued an "arrest warrant" Ajanta

MORBI, JAN 23 /--/ A Manufacturing Limited's (Oreva Group) Managing Director, Jaysukh Patel, nearly a week back on getting an application for the same from police under section 70 of the Code of Criminal Procedure, said Dilip Agechaniya, the advocate representing the victims.

"As sought by the investigation officer of this chief judicial magistrate of Morbi, MJ Khan, had issued an arrest warrant against Patel under section 70 of the CrPC," said Agechaniya on Monday. The investigating officer refused to speak on the matter, while the public prosecutor and senior police officials could not be contacted. Notably, Patel, who is not named as an accused in the FIR, had moved Morbi sessions court on January 20 for anticipatory bail fearing arrest in the bridge collapse case. The hearing was adjourned till February 1 as the public prosecutor was not present.

Nine persons, including four employees of Ajanta Manufacturing (Oreva Group), have been arrested so far in the case. They includetwo managers and an equal number of ticket booking clerks of the Oreva Group that was managing the Britishera bridge. Patel's name was not included in the first information report (FIR) filed

by the police soon after the tragedy. The suspension bridge on the Machchu river was being maintained and operated by the Oreva Group as per an agreement signed with Morbi municipality. A government-appointed special investigation team (SIT) had cited several lapses on part of the Oreva Group in repairs, maintenance and

operation of the carriageway. The lapses included no restriction on the number of persons accessing the bridge and no curb on sale of tickets. which led to unrestricted movement on the bridge, as well as carrying out repairs without consulting experts.

Siddaramaiah won't contest Assembly polls from Kolar, claims Yediyurappa

BELAGAVI, JAN 23 /--/ Senior BJP leader B S Yediyurappa on Monday claimed that Congress leader Siddaramaiah was allegedly playing a drama by saying he would not contest the Assembly polls from Kolar segment as announced, and may go back to his home district of Mysuru instead.

Ending speculation, Siddaramaiah had earlier this month announced that hewould be contesting the polls from Kolar, if the party high command agrees. "Today itself I will say one thing, don'tthink I'm making a prediction, Siddaramaiah will not contest from Kolar for any reason, he is playing a $drama\, and \, is trying \, to go \, back$ to Mysuru," Yediyurappa said. Speaking to reporters

here, the former Karnataka chief minister said the Congress legislature party leader is aware that he would face a defeat and have to go home, if he contests from Kolar. "He is playing political circus and drama, according tome, he will not contest from there (Kolar) and may try to go back to Mysuru, if that happens we will do the strategy we need to," Yediyurappa added.

Asked about talks that were doing rounds that Siddaramaiah may contest from two seats, Yediyurappa, who is the member of BJP's topparliamentaryboard.said: "Idon't know about it, it is left to their party. Let him contest from two or three seats, but going home is certain."

Amid intense speculation

that he may contest from two seats like he did in 2018 Siddaramaiah, a former chief minister, had recently made



it clear that he would contest the upcoming polls from one constituency. Siddaramaiah, not wanting to contest from Badami. As the then sitting Badami. his current

contest from Kolar, if party permits. In the 2018 polls, he had contested from two seats-Chamundeshwari and chief minister, he lost the polls in Chamundeshwari (in Mysuru) to JD-S' G T Deve Gowda by 36,042 votes. He, however, won Badami, the other constituency from where he had contested and defeated B Sriramulu (BJP) by 1,696 votes.

Making his debut in the Assembly in 1983. Siddaramaiah had got Chamundeshwari on a Lok Dal Party ticket. He has won five times from this constituency and tasted defeat thrice. After neighbouring Varuna became a constituency in 2008 following delimitation, Siddaramaiah represented it till he vacated the seat for his son Dr Yatindra (MLA) in the 2018 polls and went back to

his old constituency of Chamundeshwari.

Siddaramaiah has made it clear several times that he would not contest from Chamundeshwari anymore, and if Yediyurappa's claims are to be believed, he may look for Varuna, in which case his son Yathindra would be left without a seat.

It is no secret that Siddaramaiah, who was Karnataka chief minister between 2013 and 2018, is nursing his ambition for a second term in office, if the partywinsthenextAssembly

Climate change to hit farm output

A new study conducted by agriculture economists and scientists at Punjab Agricultural University (PAU) paints a grim picture of the harmful effects of rise in minimum temperature on the yield of rice, maize, and cotton. Besides affecting farm output, it will pose a threat to food security. One of the most intriguing findings is that changes in minimum temperature have resulted in changes in mean temperature throughout all growing seasons. It means that the minimum temperature has shown a rising trend. The climate impacts on crops will vary widely in kharifandrabiseasons. Among the kharif crops, maize yield is the most responsive to temperature andrainfallthanriceand cotton. By the year 2050, maize yield would reduce by 13 per cent followed by cotton (about 11 per cent) and rice (about 1 per cent),"thereportsays. The negative impact would accumulate by 2080. The yield loss will increase from 13 to 24 per cent for maize, from 11 per cent to 24 per cent for cotton, and from 1 per cent to 2 percent for rice, respectively. The yield response of wheat and potato would be pretty much the same for the year 2050. Quite interestingly, by the year 2080, with a significant change in climate, the yield of wheat and potato will be higher by around 1 per cent each. This is because, excess minimum temperature is beneficial for potato and wheat yield. The results indicate that productivity decreases with an increase in average temperature in most of the crops. The adverse impact of climate change on agricultural production indicates a food security threat to the farming community.

The findings provide credence to the claim that the future climate scenario is not very welcoming. The results indicated that the climate-smart packages must be incorporated into the agricultural development agenda at the policy level. The study suggested focusing on linking farmers with financial institutions to boost their capacity to adapt to climate-smart technologies and practices. Climate change is predicted to reduce maize and cotton yield in Punjab by 13 per cent and 11 per cent by 2050. Punjabaccounts for around 12 per cent of the total cereals produced in the country.

The study published in the Mausamjournal of the India Meteorological Department earlier this month used rainfall and temperature data collected between 1986 and 2020 to project the impact of climate change on five major crops rice, maize, cotton, wheat, and potato -- in the agrarian state. The researchers collected climate data from five weather observatories of Punjab Agricultural University, ie Ludhiana, Patiala, Faridkot, Bathinda, and SBS Nagar. The researchers said that long-term changes in climatic variables show that the rise in temperature is driving most of the changes, rather than the change in rainfall pattern.

G20 countries have differing healthcare problems

With gross differences in the health needs of the G20 countries it is to be seen how India gets its and other developing countries' concerns addressed as priority in the G20 health agenda

The first health working group meeting under India's G-20 presidency was held at Thiruvananthapuram on 18 January 2023 to discuss about the global health concerns. The focus of discussion was bound to be around Pandemic and response to it at various levels. The discussion in the meeting as reported was on Pandemic management, emergency preparedness and vaccinations. Also under discussion were the issues of increasing antimicrobial resistance, developing blue print for vaccines, therapeutics and diagnostics. There was also discussion on harmonising a global network for countries through consensus on digital health and to mobilise funds for the same. In addition concerns were expressed over ensuring safe effective quality and affordable medicines and medical equipment.

The G20 is a heterogeneous group of countries at different level of economic development including Australia, Canada, United Kingdom, United States, France, Germany, Italy, Japan, Republic of Korea, European Union, Saudi Arabia, China, Russia, Argentina, Brazil, South Africa, Mexico, Türkiye, India and Indonesia. In the economic development, countries of the G-20 have different rankings. Whereas India and Indonesia belong to the Lower Middle income group countries, Argentina, Brazil, China, South Africa, Mexico, Russia and Turkey belong to Upper Middle income group of countries. Rest are from High income group countries. So the priorities in health agenda of each country are also different accordingly. This is reflected in prevailing gross inequity already existing in the healthcare delivery among the countries as well as for the different strata of population within the countries representing G-20. Health indicators among these countries also vary. For example in the Global Hunger

Index which is based on the criteria of inadequate food supply, Child mortality and Child undernutrition. India is at 107 out of 120 countries compared to Indonesia at 77, South Africa at 59, Mexico at 42, Argentina at 31 and Brazil at 27. Rest of the countries are among better performers with the rankings at less than 17.

Nutrition is the basic pre requisite for good health. It means to have sufficient amount of Protein, Carbohydrate and Fats as well as micronutrients like vitamins and minerals. For better health it is thus important to have sufficient food supply, sufficient remuneration, housing and good environmental conditions. It is duty of the government to ensure that all population gets its share of healthy nutrition. That 81 Crore people are being given 5 Kg of food grains free of cost which just enough for subsistence, is a matter of grave concern. How can one expect vast majority to have good health as the grains only are not sufficient to fulfil nutritional requirements for a good health and immunity from diseases?

Earlier under the National Food Security Act (NFSA) a family was entitled to get 50 Kg of grains, 25 Kg food free of cost and rest 25 Kg at Rs. 3 per Kg. This means the family was spending only Rs. Seventy five in buying this. But under the new order of the government only 25 Kg will be given free and the rest will have to be purchased at market price which is no less than Rs.20 per Kg. This will cause a burden of Rs. 500/- per month on their budget if we calculate the grain price at Rs. 20 per Kilogram. This will deprive the poor of basic food further adding to malnutrition and poor health. This is an important agenda for our country but representatives from the high income group countries in the G20 may not be able to comprehend this. Moreover to have better health indicators, it is important to have more spending on health. Out of the G 20 countries India is spending 3.1% of the GDP on health. But in terms of spending on health by the government it is just 1.28%. Rest of the spending is by patients from their pocket. As a result 60 million people are pushed to poverty. In comparison Brazil spends 9.59% of th GDP on health, Argentina 9.51%, South Africa 9.11%, Indonesia 7.58%, Mexico 5.43%, China 5.35%, Turkey 4.34%. Russian expenditure is 5.65%, UK 10.15%, Germany at 11.70% and the USA at 16.77%.

Pandemic had a negative effect on the situation of jobs and livelihood. The government hardly paid any assistance to the affected 54 crore workers and MSMEs, the nutritional health status of the low income group population was affected adversely. To add to their woes budget on Poshan Abhiyan was reduced from 3700 crore to 2700 crore rupees. These are issues of little important to several G20 countries. The disease pattern is also quite variable. For example In 2021, eight countries accounted for more than two thirds of global TB cases: India (28%), Indonesia (9.2%), China (7.4%). Number of TB cases in High income group countries is minimal in comparison. Therefore focus has to be different in different

The pandemic has seen gross inequity in global vaccine supply. The vaccine manufacturers in the high income countries were reluctant to supply the vaccines to small developing countries. They demanded guarantees from the recipient countries which included even property of the embassy buildings of those countries.

As is evident there are gross differences in the health needs of the G20 countries it is to be seen how India gets its and other developing countries' concerns addressed as priority in the G20 health agenda. (IPA)

Clinton-Lewinsky scandal turns 25 years this week

This week, the Bill Clinton-Monica Lewinsky scandal turns 25. The 24-yearold White House intern who came from an affluent family in California found out President Bill Clinton claiming he did not have sexual relations with "this lady, Monica Lewinsky" in a televised White House press conference.

Later, he said the same thing under oath and was impeached for perjury, and escaped narrowly from losing his job as the US President. Lewinsky got into an immunity agreement with the prosecutors and revealed her side of the story. She stated that there were nine sexual encounters between her and President Clinton between November 1995 and March 1997.

These encounters were fellatio and did not amount to sexual intercourse. President Clinton admitted these acts were performed "on him" and "not by him." In later interviews, Lewinsky agreed that Clinton took advantage of her but the relationship consensual

Twenty-five years later, Monica Lewinsky recalled the incident in a January 19 tweet and shared 25 pieces of wisdom after surviving this scandal that changed her life forever though, in a piece in Vanity Fair. First the tweet: "Celebrate. It's the 25th anniversary of

traumatic day of my life - when I as I had one of the world's worst friends: stung by the fbi + learned of the starr investigation that would lead to bill Clinton's impeachment. I was 24. THANK YOU to my family, friends, professionals, colleagues + people who supported me especially pre-2014."

After the much-publicized impeachment proceedings in 1998 which made Monica Lewinsky a household name in a world dominated by a blame-the-woman mindset, she took up minor media assignments and chose never to talk about the scandal prominently.

But, in 2014, she decided to take back the narrative through a Vanity Fair article titled "Shame and Survival." It was to give a purpose to her past, she told as a 40-year-old woman. Later, Vanity Fair enlisted her as a contributor to its print and web publications.

Now, Lewinsky is 49 and her bio reveals that she is an activist and writer, with a Master's degree in Psychology. She says, "Choose your SURVIVOR'S DAY—the scariest + most friends carefully. Twenty-five years ago

Linda "Judas, hold my beer" Tripp. While I have since let go of the resentment and bitterness that surrounded her and her betrayal, it's not lost on me how very fortunate I am to have been able to trust new people. My emotionally intimate relationships are with my incredible friends. These are the investments most worth nurturing."


Linda Tripp who died in April 2020 at the age of 70 from pancreatic cancer was a civil servant that Lewinsky met at the Pentagon where she was transferred after her seniors found that she was spending a lot of time with President Clinton during her White House internship. Lewinsky would tell Linda about her relationship with Clinton, who later began secretly and illegally recording the conversations. These recordings further strengthened the prosecutors' arguments in the Clinton Vs Jones case.

It was during the hearing of this case in which a state employee Paula Jones had charged Clinton with sexual

harassment when he was the Governor of Arkansas state that the name of Monica Lewinsky exploded on the scene. Tripp handed over the recordings of Lewinsky's conversations with her to the prosecutors who were pursuing a civil lawsuit against Clinton which said he had a pattern of sexual harassment

of government employees. "Grief reigns in the kingdom of loss. I refer to not only the loss of a loved one but also the loss of hope, a dream, or love itself. It seems we don't finish grieving, but merely finish for now; we process it in layers. One day (not today) I'm going to write a short story about a vending machine that serves up Just the Right Amount of Grief. You know, the perfect amount that you can handle in a moment to move along, but not so much that you'll be caught in an undertow," is another piece of wisdom from Lewinsky.

You can make the right decision and still have regret. Also, don't judge your insides by other people's outsides, she begins her random pieces of wisdom with. But what wins a place in the hearts of those who have followed her over the past 25 years is this: "One thing everyone has in common is that we have all made mistakes. It's inevitable. Get comfortable with the Art of the Mistake." (IPA)



Giving details on action taken during past one month against sellers trading in the banned 'Chinese manjha", Inspector General of Police (Headquarters) Sukhchain Singh Gill said on Monday that police teams recovered 11,364 "Chinese dor bundles (kite strings)" after registering 234 First Information Reports (FIRs) and arresting 255 people who indulged in selling this fatal kite flying string.

Notably, a few days back, a four-year-old boy received more than 100 stitches on his face after 'China dor', as it is popularly known in Punjab, got entangled around his neck and caused deep cuts near Samrala, in Ludhiana district.

It happened as the kid rolled down the window pane of the car he was travelling in and stuck his head out to see kites being flown. He had to be hospitalised Ludhiana. In Amritsar, a 28-year-old man suffered

a deep cut around his neck recently because of Chinese string and had to get 20 stitches. The kite string got entangled around his neck while he was on his way to a bank on a motorcycle. 'China dor' is made of

nylon or synthetic thread and is coated with powdered glass and metal dust to make it sharper, shopkeeper dealing in

As it is sharper and cheaper than cotton enthusiasts prefer to buy it, ignoring the risks involved. Meanwhile, the senior police officer said Punjab Police have arrested 241 drug smugglers/suppliers after registering 173 first information reports (FIRs) under the Narcotic Drugs and Psychotropic Substances (NDPS) act across the state in the last week. Inspector General of Police, Sukhchain Singh Gill told reporters here that police have recovered 5-Kg heroin, 4.90-Kg opium, 5.92 quintals of poppy husk, and 1.95 Lakh tablets, capsules, injections/ vials of pharma opioids besides recovering Rs 7.89 Lakh drug money

BHOPAL, JAN 23 /--/The centreissettounveilanew monsoon research facility at a "super site" in Madhya Pradesh to study monsoon phenomenon and make better seasonal forecasts by studying tropical clouds.

The Atmospheric Research Testbed-Central India (ART-CI) is shaping up at the 100-acre campus at Silkheda in Sehore district of Madhya Pradesh as a project of the Pune-based Indian Institute of Tropical Meteorology (IITM), after battling delays due to Covid-19 pandemic and encroachment by locals on the site. "The testbed is based at a unique location which falls under the monsoon core zone. We need to understand the monsoon process better. We need to have all the

critical location," M Ravichandran, Secretary, Ministry of Earth Sciences told PTI on the sidelines of the India International Science Festival here. At least 30 instruments numerous sensors are scheduled to be installed at the site, located away from industrial activity and the hustle and bustle of the city and in the direct path of rain-bearing weather systems such as low pressure areas and depressions emerging from the Bay of Bengal. "ART-CI is one of the super sites which will measure not only monsoon rainfall, but also give us basic parameters such as

vertical profile of relative

humidity, liquid water

content, cloud properties,

size of rain drops," a

such as C-Band Dual Polarisation Radar, Kaband Radars, Micro-Rain Radar, Met Tower, Microwave Radiometer, Ceilometer, Disdrometer, Counter, Aethalometer already been installed at the site. Army Chief visits forward posts along LAC in eastern Arunachal

Staff Gen Manoj Pande has carried out a comprehensive review of India's military preparedness along the Line of Actual Control (LAC) in Arunachal Pradesh in his first visit to the border state after last month's clash between Indian and Chinese forces in the Tawang sector. Officials said Gen Pande visited various forward posts along the defacto border with China in the Rest of Arunachal Pradesh (RALP) as well as some other strategically key posts during his visit on Sunday. They said senior commanders in Arunachal Pradesh briefed the army chief about the overall security scenario in the border areas. "Gen Manoj Pande #COAS visited units & formations along LAC in Eastern #ArunachalPradesh & was briefed on operational preparedness & security situation. #COAS complimented troops for maintaining sharp vigil & exhorted all to continue working with same zeal & devotion," the Army tweeted.

NEW DELHI, JAN 23 /--/ Chief of Army On Saturday, the Army Chief reviewed the Army's military preparedness along the LAC in Arunachal Pradesh and Sikkim during his visit to the headquarters of the eastern Army command in Kolkata

> Gen Pande's visit to the crucial command came six weeks after the clash between Indian and Chinese troops in an area along the LAC in the Tawang sector of Arunachal Pradesh. The Eastern Command takes care of the LAC in the Arunachal Pradesh and Sikkim sectors. There has been a fresh spike in tensions between India and China after troops from the two sides were engaged in the clash along the LAC at Yangtse in the Tawang sector on December 9. Defence minister Rajnath Singh said in Parliament on December 13 that the Chinese troops tried to "unilaterally" change the status quo in the Yangtse area but the Indian Army compelled them to retreat by its firm and resolute response. On January 12, Gen Pande said the situation along the frontier with China

is "stable" but "unpredictable" and Indian troops are adequately deployed to deal with any contingencies. The Army Chief also said that there was a slight increase in the number of Chinese troops in their areas across the eastern sector. "But we are keeping a close watch on the movements and activities there," he said. Besides eastern Ladakh, the Indian Army has been also focusing on enhancing infrastructure along the LAC in Arunachal Pradesh and Sikkim. Following the eastern Ladakh standoff, the Indian Army significantly shored up its operational capabilities along the LAC in the eastern theatre as well. The Army put into place an effective surveillance apparatus and there has been a substantial improvement in overall monitoring of the areas in the last two years, military officials said. From the construction of roads, bridges and ammunition depots to bolstering its surveillance apparatus, the Army is ramping up military infrastructure at

a rapid pace for quicker mobilisation of troops in the region. The Indian and Chinese troops are locked in an over 32-month standoff in several areas along the LAC in eastern Ladakh. India has been maintaining that its ties with in the border areas.

The eastern Ladakh border standoff erupted on May 5, 2020, following a violent clash in the Pangong lake area. The ties between the two countries nosedived significantly following the fierce clash in the Galwan Valley in June 2020 that marked the most serious military conflict between the two sides in decades. As a result of a series of military and diplomatic talks, the two sides completed the disengagement process on the north and south banks of the Pangong lake and in the Gogra area. In September last, the Indian and Chinese militaries carried out disengagement from the Patrolling Point 15 in the Gogra-Hotsprings area. (PTI)

The former Uttarakhand chief minister said he would like to spend the remainder of his life in reading, writing and other activities. "During the recent visit of the Hon'ble Prime Minister to Mumbai, I have conveyed to him my desire to be discharged of all political responsibilities and to spend the remainder of my life in reading, writing and other activities. "I have always received the love and affection from the Hon'ble Prime Minister and I hope to receive the same in this regard," a statement from the Raj Bhavan said. The Prime Minister Modi was in Mumbai on January 19 to inaugurate and lay the foundation stone for several infrastructure projects. "It was an absolute honour and privilege for me to serve as the Rajya Sevak or Rajyapal of a great State like Maharashtra, the land of Saints, Social reformers and valiant fighters,' Koshyari added. It was in September 2019 that Koshyari. 81, took charge as the Maharashtra Governor. When the Uddhav Thakeray-led Maha Vikas Aghadi was in power, he had several run-ins with the government on a range of issues including the appointment of 12 members to the state legislative council from the gubernatorial quota. which he never approved. The MVA had accused him of acting in a partisan manner. The latest controversy surrounding Koshyari was about his remarks on Chhatrapati Shivaji Maharaj whom he described as the "icon of olden times". The remarks triggered protests from the Opposition parties demanding that he be sacked. (PTI)

Islands renamed in Andamans just to gain popularity: Mamata

on Monday took potshots at the Centre's attempt to rechristen some islands, stating that such initiatives were made to just to "gain popularity", given that Netaji Subhas Chandra Bose had renamed Andaman and Nicobar as Shaheed and Swaraj Islands in 1943. Mamata's reaction came hours after Prime Minister Narendra Modi named 21 Islands in the archipelago after Param Vir Chakra awardees, on the occasion of Bose's 126th birth anniversary. "Today, just to gain popularity, some are claiming to have given names Shaheed and Swaraj to islands, but that is not true. Netaji, during his visit to Andaman and Nicobar Islands, had already renamed those," the chief minister said. Notably, Neil and Havelock islands in Andamans were, in 2018, renamed as Shahid' Dweep and 'Swaraj' Dweep by the Centre. Ross Island was also rechristened as Netaji Subhash Chandra Bose Dweep to honour the freedom fighter. The TMC supremo also criticised the Centre for scrapping the Planning Commission, envisaged by the legendary freedom fighter. The Prime Minister, on the occasion of Netaji's 126th birth anniversary, named 21 islands of the Union Territory after Param Vir Chakra awardees. "Today, it is a proud moment for me as I address the people of Andamans because this is the land, where Subhas Chandra Bose unfurled the national flag for the first time in 1943," he said. The freedom fighter had hoisted the Tricolour in the archipelago on December 30, 1943. The Prime Minister noted that the islands, named after famous soldiers, including Major Somnath Sharma, Lt. Colonel (then Major) Dhan Singh Thapa, Subedar Joginder Singh, Major Shaitan Singh, Company Quartermaster Havildar Abdul Hamid, 2nd Lt. Arun Khetrapal and Flying Officer Nirmaljit Singh Sekhon, will be a source of inspiration for generations to come. Continuing her attack against the Centre, Mamata said: "Netaji had constituted the Planning Commission to outline the future of the country. But today it's our ill luck that we have no planning. The Planning Commission has been scrapped. Can you tell me why? If someone has any idea, I will request him/her to explain the reason to me as Lam not that intelligent "The chief minister was addressing a programme in the city's Red Road area, where rich tributes were paid to Bose by his family members and other dignitaries. Mamata also slammed the Narendra Modi government for sending teams to Bengal over various reasons, including inspection of central scheme implementation, and claimed that no such step is taken to check the state of affairs in BJP-ruled Uttar Pradesh. The chief minister expressed shock over the Delhi High Court granting bail to expelled BJP MLA Kuldeep Singh Sengar, who was sentenced to life by a trial court for raping a minor girl in 2017 in Uttar Pradesh's Unnao. She insisted that "little courtesy" should be shown to Bengal, as it was "in this land slogans such as 'Jai Hind' and 'Vande Mataram' originated". "They have sent over 50 Central teams to West Bengal in the last three months. Central teams come to Bengal even if a cockroach bites someone. I wonder how many such teams have you sent to Uttar Pradesh," the chief minister added. At the programme, organised by the state government, Mamata also released a music album, songs of which have been penned by her. (PTI)

CEC flags threat of 'deep fake narratives'

to polls NEW DELHI, JAN 23 /--/ Chief Election Commissioner Rajiv Kumar on Monday flagged the disturbing trend of "deep fake narratives" to elections in India and abroad where "disruptive elements" attempt to alter public perception and mislead people by repetitively presenting fake as fact. Kumar said social media platforms ought to use their algorithm power and artificial intelligence to detect deep "proactively", especially in jurisdictions like India where electoral cycles are definite and announced. The CEC made these remarks at an international conference organised by the Election Commission here on the "Use of Technology and Elections Integrity". Kumar, according to an EC statement, also raised concerns over levelplaying field not being inbuilt in platforms search results to at least show officially verified versions with the same prominence as fake content. "The CEC used enforcement agencies analogy to put onus on social media platforms to detect deep proactively. "He said that it is difficult to imagine if the enforcement agencies say that they would not act unless crime is reported to them; intelligence prevention is not their responsibility,' the statement said. In his keynote address, Kumar prominent questions such as whose primary responsibility is it to identify "blatant and system detectable" fake content and prevent them from getting uploaded and circulated social media platforms. He also referred to a "trend" to discredit the electronic voting machine technology. (PTI)

Pak suffers major power outage after grid failure

breakdown on Monday due to a "frequency variation" in the national grid, leaving millions of people in large parts of the country, including capital Islamabad and financial hub Karachi, without electricity.

According to the Ministry of Energy, the system of frequency of the national grid went down at 7:34 am local time, resulting in the breakdown. "System maintenance work is progressing rapidly," it tweeted. Energy minister Khurram Dastgir said the restoration work was going on. "I can assure you that power will be fully restored across the country within the next 12 hours," he was quoted as saying by Geo News. Explaining the failure, he said the authorities shut down the power generation system at night due to lower demand in winter to save fuel costs. But when the systems were turned on in the morning, "frequency variation and voltage fluctuation were observed in the south of the country somewhere between Daduand Jamshoro" resulting in shutting down of power generating units one by one, he said. People in Pakistan's financial capital Karachi woke up on Monday with no electricity available anywhere in the metropolis.

According to details, the major power breakdown also hit other cities across Pakistan but Karachi was the worst affected. In Peshawar, a city of over 2.3 million people, some people were reportedly unable to get drinking water as the pumps were powered by electricity. It is not the first time that the country has faced such a crisis. Last year in October, Pakistan witnessed a 12-hour power outage due to technical glitches in the electricity distribution system. Pakistan is grappling with one of the country's worst economic crises in recent years amid dwindling foreign exchange reserves. The crisis forced the government earlier this month to order shopping malls and markets to close by 8:30 pm for energy conservation purposes. The sorry state of the country's power sector is emblematic of its ailing economy. The power outages occur frequently due to lack of funds to upgrade aging

Imran Khan says he will challenge Punjab caretaker CM's appointment in SC

LAHORE, JAN 23 /--/ Pakistan's ex-premier Imran Khan has said he will challenge in the Supreme Court the appointment of Mohsin Naqvi as the caretaker chief minister of Punjab, describing him an "enemy" of his party and slamming the election commission for reducing the country to a "Banana Republic".

Naqvi was sworn in as the caretaker chief minister of $Punjab \, on \, Sunday \, night, hours \, after \, the \, Election \, Commission$ of Pakistan (ECP) unanimously decided to appoint him to the post. His appointment came after the ruling party and the opposition in the province failed to reach consensus on a name for the post. Naqvi, who was one of the two candidates suggested by ex-Chief Minister Hamza Shehbaz, is the owner of a media house and said to be very close to PPP leader Asif Ali Zardari, Khan's party Pakistan Tehreek-e-Insaf (PTI) calls Naqvi "Zardari's front man in his corruption." "PML-N has history of selecting their own umpires but it's incredible how



ECP has selected a sworn enemy of PTI as caretaker CMP unjab a post meant for a non-partisan person," Khan said in a tweet. The PTI chief posted a picture of Naqvi's plea bargain to the National Accountability Bureau (NAB) requesting that he be allowed to pay Rs 3.5 million as plea bargain in the Haris Steels Mills corruption case. "Naqvi made a voluntary return deal with the anti-graft watchdog and the Supreme Court had declared in a suo motu case no. 17/2016 that a person responsible for voluntary return could not hold any public office at federal or provincial level nor in any state organisation," he said. Turkish Muslims protest Quran-burning in Sweden

ISTANBUL, JAN 23 /--/ Outrage over a Quran-burning protest in Sweden produced a second day of protests in Turkey, reflecting tensions between the two countries. Some 250 people gathered outside the Swedish Consulate in Istanbul, where a photo of Danish anti-Islam activist Rasmus Paludan was set on fire. Paludan burned Islam's holy book outside the Turkish Embassy in Stockholm on Saturday, sparking protests in Istanbul and Ankara that night. Participants in Sunday's event carried green flags featuring the Islamic proclamation of faith and banner that said "We condemn Sweden's statesupported Islamophobia." A sign on a window of the Swedish Consulate read, "We do not share that book-burning idiot's view." The protests have renewed concerns about Turkey holding up Sweden and Finland's bid to join NATO. Turkey has not yet ratified the Nordic nations' memberships in the military alliance, saying Sweden needs to address Ankara's security concerns. Turkish officials slammed Sweden for allowing the Quran-burning protest but President Recep Tayyip Erdogan did not comment on it during his weekend speeches. Swedish Prime Minister Ulf Kristersson tweeted late Saturday that freedom of expression was crucial to democracy but added that "what is legal is not necessarily appropriate." "Burning books that are holy to many is a deeply disrespectful act. I want to express my sympathy for all Muslims who are offended by what has happened in Stockholm today," Kristersson said. Mustafa Demircan, one of the people protesting in Istanbul on Sunday, said the act of burning the Quran should not be considered an act protected by the right of free expression. (AP)

UK petition demands independent probe into BBC series on Modi

LONDON. JAN 23 /--/A new online petition has demanded an independent probe into a "serious breach" by the BBC in its duties as a public broadcaster in the UK over the controversial documentary series on Prime Minister Narendra

Call for an Independent Investigation into the BBC over Modi documentary' on Change.Org, which "strongly" condemns the British Broadcasting Corporation (BBC) for failing to meet the "highest standards of editorial impartiality", has attracted over 2,500 signatures since it went online on Sunday night. The petition labels India: The Modi Question', the first part of which aired last week and the second is due to be aired on Tuesday, as a piece of "sinister propaganda journalism that deliberately misinforms its viewers". "We strongly condemn the BBC for failing to meet the highest standards of editorial impartiality in its two-part documentary India: The Modi Question'," it reads. "We call upon the BBC Board to conduct an independent investigation into this serious breach of its duties as a public service broadcaster and publish the findings in full," it

The petition also urges the UK's independent media watchdog the Office of Communications (OFCOM) to hold the BBC to account for what it calls "repeated failures to secure content standards which command the trust of licensefee paying audiences" and to discuss necessary corrections and clarifications with the broadcaster. Under the rationale for the latest move, the organisers of the petition claim the documentary is an "example of agenda driven reporting and institutional bias that now characterises this once globally respected organisation". "The timing for airing, some 21 years later, a so-called investigative report that has nothing new in it, but only shoehorns old allegations to fit the producers clearly predetermined conclusions in itself speaks volumes. Inexplicably, it comes at a time when India's Supreme Court has, after a lengthy investigation and due process, completely absolved Prime Minister Modi from the very same allegations of complicity in the 2002 riots that the BBC now seeks to rake up after more than two Many of the signatories also express similar

sentiments, calling it "complete propaganda" and condemning the BBC for carrying out a "malicious agenda". "BBC is creating a false narrative against the two-times democratically elected Prime Minister of the largest democracy in the world. Besides PM Modi was exonerated by the Supreme Court of India," writes Lord Rami Ranger, one of the British Indian signatories who has been very vocal over the issue. It comes as the Hindu Forum of Britain (HFB) wrote to Deborah Turness, CEO of BBC News, last week to complain against the broadcaster's "anti-Hindu bias". "This preposterous ill-advised production and airing of a Hindu hate piece could well be the ammunition thugs need to go out and target Hindus. Does the BBC not have any responsibility," its letter questions. It follows the Indian government's strong condemnation of the programme as a "propaganda piece" lacking objectivity. The BBC has defended the series as "rigorously researched according to the highest editorial standards".

UK PM orders ethics probe into tax scandal-hit Tory chief

British Prime Minister Rishi Sunak on Monday ordered an independent investigation into the tax affairs of scandal-hit Conservative chairman Nadhim Zahawi amid mounting pressure from the Opposition.

MELBOURNE, JAN 23 /--/A third Hindu temple has been vandalised within a fortnight in Australia's Victoria state allegedly by "Khalistani supporters" with anti-India graffiti, according to a media report Monday. management of the International Society for Krishna Consciousness (ISKCON) temple also known as the Hare Krishna Temple in Melbourne's Albert Park on Monday morning found the walls of the revered temple vandalised with graffiti

"Hindustan Murdabad". The Australia Today website reported. "We are shocked and outraged with this blatant disregard for respect for the place of worship," Bhakta Das, Director of Communication for ISKCON Temple, said. "A complaint has been filed with Victoria Police and CCTV footage is being provided to assist them in their pursuit of culprits." This is the third such incident in the country within a fortnight. On January 16, the historic Shri Shiva Vishnu Temple in Carrum Downs, Victoria, was vandalised in a similar manner.

On January 12, the Swaminarayan temple in Melbourne was defaced by 'anti-social elements' with anti-India graffiti. Acting Premier of Victoria Jacinta Allan told The Australia Today, "All Victorians deserve to practice their faith free from racism, vilification and hatred." "This behaviour is not reflective of the majority of Victorians. The diversity of Victoria is one of our strongest assets, and we condemn these attacks,"

India writes to BWF to host Sudirman Cup, Junior Worlds

India was scheduled to host the mixed team championship in 2023, but the Badminton World Federation awarded the rights to Suzhou, China, while giving the 2026 World Championships to India. Suzhou was due to host the championships in 2021 but, due to the COVID-19 situation in China, the BWF was not able to stage any tournaments in the country and the event was shifted to Vantaa in Finland. Owing to the current COVID situation in China, there is again uncertainty regarding the Sudirman Cup, scheduled to be held there from May 14 to 21. "India is keen to host Sudirman Cup this year. We have written to BWF expressing our interest. we are expecting a positive response in a fortnight," BAI general secretary Sanjay Mishra told PTI. PTI)

four-Test series against the visiting Ronaldo makes winning start to life with Al Nassr in Saudi Arabia

RIYADH, JAN 23 /--/ Cristiano Ronaldo made a winning start to life in the Saudi Pro League as he led Al Nassr to a 1-0 victory over Ettifag on Sunday in his first match since becoming the best paid footballer in history. The Portuguese superstar didn't score but there were promising signs for Al Nassr, who are eyeing domestic and continental silverware after the 37-year-old moved for deals totalling more than 400 million euros. However, Ronaldo's league debut had an anticlimactic feel in front of 22,862 fans after he scored twice in this week's lively 5-4 exhibition defeat to Lionel Messi's Paris Saint-Germain. "He's one of Martinez and Talisca — after some the best players in the history of football, so it's very important for us to do everything possible to put him in the best condition," said Al Nassr coach Rudi Garcia. "I want him to enjoy playing and tonight he was happy to play for the first time with his new team." Ronaldo, leading out Al Nassr as captain,

made a low-key start in the first half, twice losing the ball with attempted trickery as his team-mates struggled to get him on the ball. Ronaldo's early shot from the edge of the box was deflected over, and he nearly met Abdulmajeed Al Sulaiheem's cross that was headed in by Anderson Talisca for the game's only goal on 31 minutes. Shortly afterwards Ronaldo, met by shouts of "Siu!" every time he touched ball, blazed over with a free kick from an inviting position just outside the penalty area. Al Nassr's front three began to click in the second half and Ronaldo set up Pity trademark stepovers — for close chances in quick succession. A swing and a miss at a bicycle kick showed Ronaldo was warming to his task, and he then attempted a shot from a nearly impossible angle after a dribble into the box. But there was to be no goal for Ronaldo, watched by his



girlfriend Georgina Rodriguez, in a win that kept Al Nassr on top of the Saudi Pro League. Ronaldo arrived in oil-rich Saudi Arabia in early January but his debut was delayed while he served a two-match ban for knocking a mobile phone out of a fan's hand while at Manchester United. The move to Saudi is a step down for Ronaldo, an undisputable all-time great who has continually delivered on football's biggest stages and amassed an astonishing haul of team and personal honours. The five-time Ballon d'Or winner is the all-time Champions League top-scorer, collecting five titles along the way, and has won seven domestic championships with Manchester United, Real Madrid and Juventus. Ronaldo also holds the record for international goals – 118 with Portugal, with whom he won Euro 2016 — and career goals with 819. In Qatar last year, he became the first man to score at five World Cups. (AFP)

NEW DELHI, JAN 23 /--/ The BCCI is all set to get richer by up to Rs 4000 crore with some of the top business houses set to bid aggressively for the five Women's IPL (WIPL) teams that would be auctioned on Wednesday.

Team Bid:

According to market experts, the teams are expected to shell out in the "range of 500 to 600 crore INR" per team in the closed-bid auction. "WIPL has huge potential but most of the legacy teams would like to mix optimism with pragmatism," an industry insider, who has previously worked on men's IPL team bid, told PTI ahead of auction.

"Expect a few bids in the range of Rs 500 crore upwards. Rs 800 crore plus could be a bit ambitious but BCCI won't complain " he added. More than 30 odd companies have bought the bid documents worth Rs 5 lakh including all the 10 men's IPL team. Wellknown corporate houses such as Adani group, Torrent group, Haldiram's Prabhuji, Capri Global, Kotak and Aditya Birla Group have also shown interest in buying a team. Some of these companies were unsuccessful when BCCI invited bids for two new men's teams in 2021. Among the traditional IPL teams. Mumbai Indians, Rajasthan Royals, Delhi Capitals, KKR could seriously contemplate to add to the bouquet of their already existing men's teams across the globe. According to market insiders, there are two principles on which these bids are placed by the business houses. First one is "Return on Investment" (ROI), which is the core principal of any business. It is profit on what an entity spends.

The second one isn't a business principle as such but in business community they call it 'Return of Ego". This is something where some of the biggest business names are ready to shell out any amount if they have their eyes on buying a particular property. Even if it takes five to seven years for touching breakeven point. It's about wanting to purchase something at any cost An existing IPL franchise with its 'steady revenue stream" in place can afford to 'bleed" a bit more in initial years which is imperative. A former IPL franchisee official, who had once worked on bids, explained the rationale which goes into the bidding. "Let's say, a franchise makes a winning bid of Rs 500 crore for a period of five years. Now that's Rs 100 crore committed straightaway for each of next five years," the source explained.

Now what will be source of earning for the franchises? "The BCCI distributes its media broadcast revenue which is one of the major earning chunk. The second is a share from BCCI's central pool of sponsorship. The third is



a franchisee's own set of sponsorship earnings. Fourth is gate sales, money earned from tickets,' he elaborated. So what could be a franchisee's earning from WIPL's media revenue pool."The BCCI in case of Women's IPL is going to share 80 percent of media rights money with the teams (in case of men, it's 50:50) to help them develop a sustainable model. "So what will be the mathematics over here? JIO has brought media rights for five years at Rs 950 crore (approx) which is roughly Rs 190 crore per year. So 80 percent of 190 crore is 152 crore. "Let's make it a round figure of Rs 150 crore. That's what each franchise gets over a period of five years which approximately Rs 30 crore per annum," he explained. "Now BCCI will also distribute a chunk of its central pool of sponsorship (title sponsor, co sponsors, various award sponsors) also with franchise. Add to it franchisee's own revenue pool also. So it could be anything between Rs 15 to Rs 18 crore per year. Gate sales won't earn you a great deal in first year," he said. So the per year earning for a team is expected to be Rs 50 crore. Now apart from Rs 100 crore franchisee fee per year, what will be the other

"There is a salary cap of Rs 12 crore for the squad. Add another 6 to 8 crore on salary of support staff. Let's make it Rs 20 crore. Add the hotel expenses, fees paid to state associations for stadium and other operational costs. It could be anything between Rs 6 to 8 crore. First year single city would reduce expenses. "So the cumulative expenses per year could be Rs 128 to Rs 130 crore. The earnings would be around Rs 50 crore. So there is a chance during first few years, there would be a loss of Rs 50 crore or more," he explained. Herein lies the catch. "The legacy franchises (MIPL) are better placed to offset these losses as they are already making profits after 15 years of IPL. They will club their men's and women's team together and perhaps quickly make the profit zone," the official added. The five-team WIPL will be played in the month of March in Mumbai at a couple of
