Kalapahad, Kishorinagar residents demand extra bus services

MAYABUNDER, JAN 1/--/Residents of Kalapahad Kishorinagar in Diglipur have demanded operation of extra bus services from Diglipur to Mayabunder. Kalapahad is located about 30 km from Mayabunder and it takes

Mayabunder. reach According to a resident, before the outbreak of the Covid-19 pandemic, State Transport Services (STS) used to operate a bus service which started from Diglipur at 2:30 pm for Mayabunder and it returned back at 5:30 pm from Mayabunder for

about one hour for the bus to Diglipur. Presently this service has been stopped due to Covid pandemic in 2020. Non-operation of STS bus services at this time has created a lot of hardship for the office goers and residents to travel without a public transport in this route. Hundreds of office goers, private workers and

commuters avail bus services from Diglipur to Mayabunder. But with the STS halting the bus services, commuters have to undergo a lot of ordeal to reach their work place and return back to their homes after attending office.

Speaking to EOI, a local resident said that presently

one STS bus service is available from Mayabunder to Diglipur which starts at 2:30 pm, operated specially for the Schools and college students. The bus gets overcrowded and office goers hardly get a chance to get into the bus. This one alone bus gets so overcrowded with school and college students that daily commuters are left with no option but to hire private autos and jeeps to travel back to their homes by paying hefty amounts. Due to shortage of buses, the general public, especially office goers, ladies, old age people and medical patients suffer badly. The single bus meant for the school and college students remains overcrowded, which is neither convenient nor safe for the commuters. Local residents have demanded operation of extra bus services in this route in the evening hours for the convenience of the commuters. They have sought operation of STS bus from Mayabunder at about 5.30 pm so that commuters after office hours can return back to their homes at Diglipur comfortably and without

Indiscriminate felling of mangrove trees at Mayabunder

PORT BLAIR, **JAN** Indiscriminate cutting of mangrove trees in the Mangrove Interpretation Centre at Mayabunder to lay electric poles has drawn the flak of environment experts. The mangrove trees have been felled by the Department of Electricity department, Mayabunder in N&M Andaman for installing electric lines, right under the nose of the Forest department. According to a local, the Mangrove Interpretation Centre, Mayabunder Opp Helipad is a popular tourist spot with scores of tourists visiting this centre to enjoy the greenery and mangroves. But recently, in order to save a few meters of electric lines, the Electricity department laid electric poles to carry electric lines in between mangroves and jungle trees by felling mangroves. A healthy mangrove in the coastline acts as a barrier protecting the shoreline from natural calamities like tsunami & flooding. Mangroves also act as nurseries for a wide range of marine species. Governments throughout the world have been taking extra initiatives to protect mangroves. But unfortunately, for authorities in the islands. protection of mangroves comes as the last priority. Instances of destroying mangroves in the islands have been reported on many occasions in the past, but absence of strict action has encouraged people to destroy mangroves unchecked. The cutting of mangroves for laying of electric lines



is one such example, mangroves are being destroyed by encroachers as well as government departments. EOI Correspondent repeatedly tried to contact officials of Electricity and Forest departments to seek their comments. But they could not be contacted.





One killed, 17 injured in fire after blast in Nashik chemical plant; rescue operation on

person was killed and 17 others injured, four of them critically, in a massive fire triggered by a blast in a boiler of a chemical factory in Maharashtra's Nashik district on Sunday, officials

The blast in the Jindal Poly Films factory, located in Mundhegaon along the Mumbai-Agra highway in Igatpuri taluka, was so strong that it was heard in nearby villages. The fire and smoke could be seen a distance. from Maharashtra Chief Minister Eknath Shinde tweeted some labourers are still stuck in the huge fire at Jindal factory and a search and rescue operation by the Fire Brigade is on. Deputy CM Devendra Fadnavis said so far 19 persons have been rescued and 17 of them admitted to a private hospital for treatment. "Four among them are critical while another one died," he said. Coast Guard rescues 12 crew members of sinking vessel in Arabian sea off Gujarat coast

rescued 12 crew members of a sinking supply vessel in the Arabian sea off the Gujarat coast, it said on Sunday.

The operation was carried out on Saturday after a distress message was received by the Mumbai-based ICG Maritime Rescue Coordination Centre (MRCC) at around 11 am, a Defence release said. The Motorised Supply Vessel (MSV) was reported to be heavily flooded and sinking. As it eventually sank, all the 12 Indian crew were taken onboard Motor Tanker (MT) Searanger. The call was made regarding uncontrolled flooding onboard Indian MSV, 'Nigahen Karam' which was on her passage to Djibouti. After receiving the call, the MRCC alerted all the vessels operating in the vicinity of the spot and coordinated with MRSC (Maritime Rescue Sub Centre), Porbandar to divert a Motor Tanker (MT) Searanger to provide immediate assistance to the vessel, the release said. Parishad (VHP) has passed a resolution against religious radicalism, which it said was responsible for terror attacks across the world, and demanded a stringent law to illegal conversions implementation of the Uniform Civil Code (UCC), its functionary said.

This resolution was passed and demands were made during the three-day meeting of the VHP's central board of trustees and the governing council that concluded here on Sunday. "An important resolution on 'Religious Dogmatism Its Illeffects and Solution' was passed in the meeting," VHP working president advocate Alok Kumar told reporters here. "The resolution made it clear that the declarations by some traditions that 'Only my religion is right, others have to accept and if they don't, then I have the divine command to eliminate them' are unacceptable to humanity. Those who insist on such heavenly commands to destroy have actually destroyed many ancient civilisations of the world," he said. The resolution passed during the meeting said, "Unfortunately, despite the toxic experiences of many centuries, religious radicalism and dogmatism of the desert traditions remain a challenge for the whole world even today.

These radicals are also responsible for the terrorist attacks happening here and there in the world every day..." "The series of inhuman atrocities on non-Muslim women through 'Love Jihad' and also the Jihadi activism of the "Sar tan se juda gang" (beheading gang) are the ghastly faces of this religious radicalism...," a VHP statement said.

Kumar said a comprehensive policy has to be framed at the global level to deal with the toxic effects of religious dogmatism. "This narrow-mindedness and exclusivism has to be neutralised at the intellectual, social and political levels. Violence, looting, rape and murders are used as weapons by a large section of Islam in the added. "We will not allow any part of Bharat to become Dar-ul-Islam. VHP, Bajrang Dal, Durga Vahini along with revered saints and thinkers of the society have been fighting it steadfastly. We will speed up this work," he said.bA large section of Christian missionaries is engaged in the agenda of engineering social enmity, fostering terror, and converting people through the tactics of force, fraud and allurement. It was also urged in the resolution that religious radicalism would prove to be a suicidal path for the Christian and the Muslim communities instead of their development, the VHP statement said. They should replace their radical leadership by sensible and rational leadership who stand for development and harmonious co-existence, VHP's board of trustees appealed to all

sections of the society not to patronise such anti-national tendencies, not to destroy the future for the sake of immediate gains. It asked people to play their role in dispiriting religious dogmatist and separatist leadership and cheering open-minded leadership that takes the society towards harmony and development, the statement said. It also appealed to the central and the state governments to control the madrassas and missionary schools that teach exclusivism, extremism and separatism and make arrangements for development and harmony-oriented education, it said. The central government should enact stringent laws to prevent illegal conversions and religious dogmatism. Along with this, a demand was also made to pass and implement the Uniform Civil Code (UCC) in the entire country, it added. Hindu society has long been a victim of religious dogmatism of the desert traditions, but it has proved formidable to those challenges, it said, adding, "VHP will organise a mass awareness campaign in this regard to create eternal vigilance and expose the conspiracies of the dogmatic leadership.'

The favourite corners to box an argument into manufactured outrage are the supposed affronts to nationalism, majoritarian pride, and the imperfect past. The decibel levels, gravity of accusations, and the intensity of faux outrage deployed are sure desperation to suppress a far more important line of questioning.

EC plans remote voting for migrant voters

The Election Commission has developed a remote electronic voting machine (EVM) that will aid in letting domestic migrants - people who have moved to different cities within India vote during their local elections. The 2016-17 Economic Survey tracked annual interstate travel to estimate 6 crore migrant workers between 2001 and 2011. As per Census 2011, 45.36 crore or 37% of population are migrants. Many are unable to vote because they are unable to travel back to their home constituencies on the day of polling. The EC has invited political parties for a demonstration of the machine on January 16 to elicit their views on the legal, administrative and technical challenges in implementing it. But, the EC must convince political parties to support this game-changing initiative as its decision to test the possibility of remote voting for migrant workers will deepen democracy. It comes on the back of EC's acknowledgement of migration-based disenfranchisement. The commission said that it has developed a prototype for a Multi-Constituency Remote Electronic Voting Machine (RVM) that can handle multiple constituencies from a single remote polling booth. The RVMs are "stand alone, nonnetworked systems," effectively providing the voter the same experience as currently used EVMs. They will be set up in remote locations outside the state under similar conditions as current polling booths. According to EC's concept note for RVMs, "voters who are absent from their home locations on the day of polling, even if they wish to vote, are unable to travel to vote due to various reasons." This means that there is a large chunk of the population which is denied its franchise due to exigencies of work or lack of resources to travel. This goes directly against the EC's "No voter left behind" goal. The VVPAT system is expected to work along the same lines with the new technology.

The system is fraught with issues, some of which the EC has itself acknowledged. First migrants are not a uniform and defined class, with fluid identities, locations and situations. In context of the transience of migration in India, the problem for the EC is to create an inclusive definition of migrants which at the same time does not open the system up to misuse. Are all migrant voters eligible? What is the duration that a migrant has to stay outside home to qualify? The EC's statement says that resolving this issue will "require wider consultations with various legal and political stakeholders.' Second, in the context of increasing questions being asked about technology-based voting, how do RVMs enter the conversation? As various countries reject EVMs for paper-based ballots. does this move have the potential to raise further questions on the sanctity of the electoral process itself? While the EC claims that RVMs are as secure as currently used EVMs, more technological components are bound to raise further questions. Third, how does remote voting affect elections and campaigning? In a playing field which is far from level, remote voting can theoretically provide an added edge to bigger parties and richer candidates who can campaign across the constituency and beyond.

China's new Covid-19 outbreak threatens rest of world

world. Mathematical models predict one million or more deaths by early 2023, within 90 days from now. Epidemiologists estimate 60 per cent of the population of China and 10 per cent of the world are likely to be infected. This new crisis could shake the world, and India too cannot escape it, as we already experienced after Wuhan outbreak three years ago. Sudden spurt in new infections have also been noticed in Japan, South Korea, Brazil, and the US.

What India can do now is not to repeat the mistakes that the leadership did in the beginning of the outbreak and thereafter. Every entry point into India must be strictly monitored. Focusing on the new infection and related health issues and a strategy to tackle it should be promptly in place, and also a comprehensive strategy to deal with all aspect of the crisis, since what is happening now in China is most likely to disrupt the global supply chain, on which several Indian industries depend for production, which include the industries related to health but not limited to it. India must take note of the very high speed of the spread of the new variant of Omicron which has started sweeping Beijing and might soon hit the rest of China. It took only 10 days after relaxing of restrictions on December 7. It has triggered panic buying of food, preventive equipment for cold, and medicine and other health related items. No one knows what exactly is happening there since the government there has stopped reporting full daily infections data and has deactivated the COVID-19 tracking app. Even though what information is coming out from China indicates the challenges ahead for India. About 90 per cent people have already received the double doses of vaccines against the coronavirus, while about 50 per cent have received the booster third dose. Among the 60 years and elders, 69 per cent have received the booster shots. It is despite these the spread of the new infection could not be controlled. Health facilities, graveyards, and crematoriums are overwhelmed. There are also chances of emergence of new variants. India needs to be alert on the vaccination front and the deadly new Omicron variant that evades immunity. In India, Union Ministry of Health has


already issued alerts, advisories, and instructions to all States and UTs. Centre's genome sequencing notice to states and UTs has already been served. Union Health Secretary Rajesh Bhushan has said that such an exercise will enable timely detection of newer variants, if any, circulating in the country and will facilitate undertaking of requisite public health measures.

India by far, with its focus on the five-fold strategy of test-track-treat-vaccination and adherence to Covid appropriate behaviour, have been able to restrict transmission of coronavirus, which is now about 1200 cases weekly. The country has reported 129 fresh cases of infection with one death in the last 24 hours. There have been considerable relaxations in place including wearing of masks have become not mandatory. Union Health Minister Mansukh Mandaviya has even held a high level meeting today with top officials and experts to chalk out the strategy to prevent another spike in COVID-19 infection. Everybody in the meeting were seen wearing masks, though it is not mandatory as per the government's protocol. The six points have been identified which also included strategy for blocking incoming cases at the international and domestic airports and other entry points in the country; laying down guidelines for passengers travelling from abroad, and consultation with experts on new variants. The Chairman of the COVID-19 working group Dr N K Arora has said, "It is an important thing that we keep a close vigil on the Chinese situation. But I would say that there is nothing to be panicked about. There is no need for getting too much worried. They system is very vigilant we need to be very vigilant

In the meantime, Union Health Minister has written a letter to Congress leader Rahul Gandhi asking him to or he should defer further legs of the Yatra "in the interest of the nation." However, it's unfortunate, that the concern for "national interest" too slow in more important strategies for tackling the threat. For example, only a network of little over 50 laboratories across the country has been sequencing under INSACOG. The latest advisories to states and UTs for increasing sequencing have not come with the increase of laboratories. Secondly, only a select samples are being sent for sequencing. International passengers are being randomly tested and the detection of positive cases among them are about 2 per cent. Samples are gathered from designated sentinel sites, and cluster or outbreak in the community. These laboratories are also testing viral RNA in the sewage system. Obviously, we need to sharply increase the number of laboratories now.

As for the increased surveillance, there has been no change in the protocol for international arrivals as of now. India is still under the older protocol, which has done away with the need for either a negative RT-PCR or complete vaccination certificate last month. Such a slow decision cannot tackle the China like fast spread of the virus, since there is nothing in place to prevent entry of new infection in the country, despite a fortnight of nightmare in neighbouring China. Indians and India should take note of the fact that the present surge in infection is linked to Omicron sub-variant BF.7, which is a nomenclature assigned to BA.5.2.1.7, that has already been detected by INSACOG network, as people in know of the matter has reportedly said, but yet to be officially confirmed. Former AIIMS director Dr Randeep Guleria has said that nearly three years into the pandemic we are in a situation where there has been high natural infection, and the coverage of vaccines is also high. India might not see a similar situation as China, he said.

Let it be so, however, India cannot afford any laxity in preparedness, and must not put off guard against the disease. COVID appropriate behaviour must be put again in place, before we fall into the new nightmare which could prove catastrophic. (IPA)



Middle Eastern sports has arrived on the global arena

This decade and beyond could be the era of Middle Eastern sports. It may not have sunk in yet, but the Qatar World Cup was the kick-off rather than the finale. Qatar and Saudi Arabia will be this decade's focal points of Asian sports. By 2030, Egypt and Turkey could become part of the global sports-hosting mix. That doesn't mean that Arab and Berber North Africa will be sidelined. On the contrary, barely two months after emerging as a World Cup superstar, Morocco will host the FIFA Club World Cup in February.

Qatar will host the Asian Cup a bit later in 2023. Saudi Arabia is certain to host the 2027 Cup. Doha is back in the picture as home to the 2030 Asian Games; in 2034, it's Rivadh's turn. Saudi Arabia and Egypt are considered FIFA favourites for the 2030 World Cup should they decide to bid for the tournament together with Greece. A Moroccan pitch for the 2030 World Cup is also within the realm of possibilities. In between, somewhat incongruously, Saudi Arabia, better known as a desert kingdom, will host the 2029 Asian Winter Games in its futuristic yet-to-be-completed \$500 billion city of Neom on the Red Sea. Moreover, Saudi Arabia is also bidding for the rights to the 2026 AFC Women's Asian Cup. Further afar, Qatar and Saudi Arabia are separately considering bidding for the 2036 Olympics but could join forces. Egypt and Turkey are mulling their separate candidacies.

The flurry of bids and tournaments to be hosted in the Middle East and the by and large celebratory aftermath of the Qatar World Cup proves that the criticism of the Gulf state did little to make Qatar or other regional autocracies rethink the risk of exposing themselves. At the end of the day, the World Cup achieved what the Qataris wanted. That is likely food for thought for activists for whom the tournaments constitute a golden opportunity to justifiably pursue the campaign for worker and human rights in the Middle East and North Africa, provided they learn from mistakes made with Qatar. That is not to distract from the gains achieved by activists' pressure for migrant workers and the laudable effort of human rights groups and others that did not allow themselves to be sucked into culture wars. That is true. even if they failed to distance themselves for much of the past 12 years from critics who seemed more driven by prejudice and bigotry than genuine concern for the plight of the underdog.

Eager to be the regional hub for sports and everything else from business to entertainment and innovation, Saudi Arabia attempted in 2018 to create a South West Asian Football Federation. The kingdom, as well as AFC members Bahrain, Yemen, Oman, Kuwait, the United Arab Emirates, India, Bangladesh, Nepal, Bhutan, Maldives, Sri Lanka, and Pakistan, initially signed up for the federation. However, the initiative collapsed within months. Riding on the wave of the Qatar World Cup's success, a potential new move to create an Arab soccer federation would potentially see 12 Middle Eastern associations depart the 47-member AFC and leave the seven North African associations that fall under the 54-member the Confederation of African Football (CAF) little choice but to join their Arab brethren. A renewed attempt to create a South West Asian body would leave North Africans with the option to remain in CAF but potentially deprive the AFC of an additional seven associations. It didn't help that Qatar secured the rights to the 2023 Asian Cup after China had to back away from hosting the tournament because of its zero-tolerance Covid-19 policy. The Korean Football Association (KFA) responded positively to an AFC inquiry on whether it would want to replace China but suggested that Qatar made a better financial offer.

"Qatar has promised huge financial support, such as the participation of additional sponsors by its own companies in the AFC, which is currently suffering from a loss due to COVID-19, a large-scale broadcasting rights contract with its own broadcasting company, and support for operating expenses of the Asian Cup," the South Korean association said in a statement in October. The KFA said the Qatari manoeuvre was part of an "unconventional offensive and support of Middle Eastern countries trying to take the lead in Asian football.

The Koreans further asserted that the prospect of Saudi financial support for the AFC had secured the kingdom hosting the 2027 Asian Cup. Saudi Arabia is the only candidate after India, which the AFC also shortlisted, withdrew its bid. Arab influence in Asian and African soccer governance has long been undeniable. The AFC is headquartered in Egypt, traditionally one of African football's best performers at the national and club level. Potentially expanding Egypt's influence, Egyptian-born billionaire Mohamed Mansour, the British Conservative Party's incoming treasurer, last week disclosed plans to buy an English soccer club. Mansour already has a majority stake in the top-tier Danish club FC Nordsjaelland and intends to invest in the US football market.

Similarly, except for two years, Arabs have presided over the AFC for the past two decades. First, it was Qatari national Mohammed bin Hamam from 2002 until 2011 when he was ousted as part of the power struggles and corruption scandals that rocked global soccer governance. The AFC's current president, Salman Ebrahim Al-Khalifa, a member of Bahrain's ruling family, has been in office since 2013 and is set to be elected unopposed in February for a fourth term. Al-Khalifa manages the group primarily from Bahrain, even though the AFC is headquartered in Kuala Lumpur.

Finally, Qatar showcased its influence in global soccer when it's two most famous employees, Messi and Kylian Mbappé, who both play for a Qatar-owned Paris Saint Germaine, squared off in Sunday's France Argentina final of the Gulf state's World

"We have started this initiative on the first day of the year to start this year with the right initiative catering to the secluded and exploited strata of the society," said Sushil Gupta, General Secretary of Sewa Bharti Delhi Province.

He said this is the first such clinic in the area and aims to solve the health issues faced by the sex workers while maintaining their dignity and respect. G B Road, or Garstin Bastion Road, is a road running from Ajmeri Gate to Lahori Gate in Delhi. It is a red-light district which has many brothels and there are estimated to be over 1,000 sex

J&K: Mughal road likely to be closed due to heavy snowfall

Maha: Politicians, several others visit Koregaon-Bhima for annual event Chandrakant Patil gives it a miss

PUNE, JAN 1/--/Hundreds of people including political leaders visited Jaystambh military monument in Maharashtra's Pune district on Sunday to mark the 205th anniversary of the Koregaon-Bhima battle amid heavy security deployed at the venue in view of violence near it on January 1, 2018. Pune Guardian Minister ChandrakantPatil, however, did not visit the memorial to avoid any untoward incident, citing an ink attack threat to him if he went to there. Last month, ink was thrown at Patil during an event in Pimpri town of Pune district in an apparent protest against his controversial remark about Dr B R Ambedkar and social reformer Mahatma JyotibaPhule. As per the Dalit narrative, British forces that fought the Peshwas at KoregaonBhima on January 1, 1818, comprised largely of soldiers from the Dalit Mahar community, who waged a war for freedom from 'casteism' of the Peshwas. Every year on this day, a large number of people, mainly from the Dalit community, visit the Javstambh (victory pillar) which was erected by the British in memory of the soldiers who fought against the Peshwas in the battle of KoregaonBhima. Violence had broken out near KoregaonBhima village during the 200th commemoration of the historical battle on January 1, 2018 in which one person was killed and many others injured. According to police, "provocative" speeches made at the Elgar Parishad conclave held in Pune city a day before had triggered the violence. On Sunday, a large number of people gathered at the victory pillar, decorated with flowers and lights, located in Perne village on Pune-Ahmednagar Road amid heavy police security.(PTI)

Migrants unaware of rights falling prey to trafficking; coordinated effort needed for prevention, protection and prosecution: Expert

Migrants not aware of their rights have been falling prey to trafficking and exploitation. coordination among stakeholders is vital to the holistically, an expert on the subject said in light of cases suspected human trafficking recently reported from Gujarat.

It will be appropriate to separate investigation agency for with human trafficking offences, former Indian Police Service Officer P M Nair, who was the project director of a study conducted by the Tata Institute of Social Sciences (TISS) on human trafficking in vulnerable districts of India, told PTI. Initiatives like setting up anti-human trafficking clubs in colleges and at the panchayat level to prevent such offences at the grassroot level are helpful, said Nair, who is also associated with the National Resource Centre on Human Trafficking at the Rashtriya Raksha University in Gujarat's capital Gandhinagar.

TISS study, The published in 2019, explored the aspect of human trafficking in the country from the perspective of migration, how migration can lead to trafficking, or rather how trafficking of people takes place under the garb of migration, he

It also highlighted how the use of technology made trafficking "a faceless and spaceless crime" and revealed every state in the country was impacted by human trafficking. What separates migration from trafficking is the way restrictions are put on the basic rights of the trafficked person through curtailment of communication and freedom of movement, the study observed. It also noted the increasing use of social networking applications like WhatsApp, Instagram,

Telegram, Hike, JustDial, Paytm and Facebook to trap victims for sex trafficking. The Guiarat Police's

Anti-Human Trafficking Cell recently launched an investigation into the reported death of a man hailing from Gandhinagar following his unsuccessful attempt to cross the US-Mexico border wall, also referred to as the 'Trump Wall'. The state police are also probing the suspected role of a man in a case of human trafficking of a of four from family Gandhinagar district's Dingucha village who froze to death in January last year while trying to illegally cross over to the United States from Canada, Nair said while the response system against human trafficking has improved, coordination among the government departments among

governmental organisations (NGOs) working in the field remains uneven. "Unless we have all the stakeholders coming together, working together and

coordination, this issue of human trafficking cannot be addressed holistically. Prevention, protection and prosecution -- all will have to come together," said Nair, a former chair professor at TISS who also served the National Human Rights Commission (NHRC) as its nodal officer on anti-human trafficking

The TISS study showed while there is nothing wrong with migration, "there are many migrants whose rights are being exploited and they are being deprived because they don't know their rights or how to enforce them," he said. The study also revealed that every state in the country was impacted by human trafficking. "It may be a source state, transit state or a destination state. The research also shows that states cannot be classified in watertight compartments because they could be all three, and there are many such states in India," Nair said. While the Census 2011 identified 37 per cent of the population as migrants, the TISS study estimated it to be nearly 13

"An emerging form of trafficking for commercial sexual exploitation was identified as cyber-sex trafficking where cyberspace and social media are being accessed to treat female bodies as sources of voyeuristic and commercial gains," the study said. Nair said coordination government departments and among NGOs working in the field required improvement to address the issue holistically. "Some NGOs are good for rescue, some for counselling, some for rehabilitation and some for networking.

If all NGOs come and work together, the strength of each NGO can be put together for a common cause, but even that is not

paucity of vision," he said. Nair also said there was a need for a specialised investigation agency against human trafficking. "Considering

requirements specialisation, it will be (52)Mehra appropriate to have a separate probe agency for dealing with human trafficking crimes. Setting up a specialised vertical in the National Investigation Agency (NIA) or the Central Bureau of Investigation (CBI) will also fulfil the requirement," he said. The TISS study called for a comprehensive plan of action by different government ministries -home, railways, women and child development, labour and employment, etc. -- and a joint task force understand the modus operandi and routes used to traffic women migrating for work and to develop a comprehensive strategy for action." "Since trafficking is becoming a faceless and spaceless crime, the masterminds' of these networks often have no contact with lower rung agents in the network hierarchy. UP ATS arrests 1 on suspicion of radicalising youths

LUCKNOW, JAN 1 /--/ The Uttar Pradesh ATS has arrested one person suspected of radicalising youths for terror activities, it said in a statement on Saturday.

The Anti-Terror Squad (ATS) of Uttar Pradesh Police arrested Saharanpur native Azharuddin on December 30. The arrest was based on the disclosure of Lukmaan, who was nabbed earlier for allegedly having links with the al-Qaeda in Indian Subcontinent and the Jamat-ul-Mujahideen Bangladesh, it said. Azharuddin allegedly showed "jehadi videos and literature" to youths in a bid to radicalise them and was working actively to make them join with the ideology of the terror organisations. On September 26, the ATS arrested Lukmaan and slapped him with a case under the Unlawful Activities (Prevention) Act (UAPA). It had earlier arrested Md Mudassir and 10 others in the case. During the interrogation of Haridwar-native Mudassir, it emerged that Azharuddin had a suspicious background in the case and he was brought in for questioning. He was subsequently arrested on December 30, the ATS said. 'The accused Azharuddin, Bangladeshi accused persons and active criminals of AQIS (al-Qaeda in Indian Subcontinent) and JMB (Jamat-ul-Mujahideen Bangladesh), while joining hands with Mudassir, Abu Talha, Ahsan and others, used to propagate jehadi ideology...," the ATS said in the statement. Chandigarh's 'Birdman': Messiah for birds in distress

CHANDIGARH, JAN 1 /--/ Prince Mehra had just entered his forties when, during a visit to Ferozepur in 2011, he found the carcasses of two pigeons that had died of electrocution disposed

of in a roadside dustbin. "I took out both the carcasses and buried them in a nearby pit," Mortified by the incident, the Chandigarh native decided to do something for birds in distress following his return to the city. He modified his bicycle and started an ambulance service and, for the past 11 years, has been looking after injured birds -- earning the 'Birdman' sobriquet. Not only does he look after injured birds, he also disposes of the carcasses found on the roadside. 'The incident also made me wonder that if dead birds are disposed of in a reckless manner, it is not good for the environment. It can also endanger both human and animal health," Mehra told PTI. He said his bicycle bird ambulance was equipped with all necessary medical aid. "I move around the city in my bird ambulance and wherever I find an injured bird, I attend to it at the spot or bring it home. If it is seriously injured, I bring the bird to the animal husbandry hospital here where I work. "For the birds that don't survive, I bury the carcasses by digging pits on the roadside where they are found. Birds also deserve a dignified burial," he said. Libya: Mass grave with 18 bodies found in ex-IS stronghold

CAIRO, JAN 1/--/Libyan authorities on Sunday said they have found 18 bodies buried in a mass grave in a former stronghold of the Islamic State group along the conflict-stricken North African nation's coast. The Missing Persons Authority said in a statement the bodies were unearthed in the Sabaa area of Sirte, a city in central Libya. The bodies were taken to a local hospital, it added. Sirte, the birthplace of former longtime dictator Moammar Gadhafi, fell under the control of Islamic State

militants between 2015 and 2016. The militants, along with al-Qaida, gained a foothold in oil-rich Libya amid the chaos that engulfed the country after the 2011 uprising and a NATO intervention in the conflict. The militants were eventually driven out of the city in December 2016 by Libyan forces supported by the US and alied with the UN-backed government in capital Tripoli. Hundreds of alleged former Islamic State fighters remain incarcerated in Libyan prisons, many of

whom are awaiting trial. Since Ghadafi's overthrow and killing, Libya has been split between rival authorities. Sirte is now controlled by forces loyal to military leader Khalifa Hifter based in the country's east. In its statement, the Missing Persons Authority said they collected samples of the dead bones in an effort to identify the bodies. Further details on the cause of death for those found were not provided. Several mass graves

have been uncovered across Libya recently. In October,

officials said they found 42 bodies in a mass grave in a school site in Sirte. In December 2018, the bodies of more than thirty men were discovered near Sirte, believed to be the corpses of a group of Ethiopian Christians whom Islamic State fighters executed in a video the group published years earlier. In the western town of Tarhuna, hundreds of corpses have been uncovered across several graves after militia fighters loyal to Hifter retreated from the area in June

Benedict leaves German homeland with complicated legacy

Benedict XVI leaves his homeland with a complicated legacy: pride in a German pontiff but a church deeply divided over the need for reforms in the wake of a sexual abuse scandal in which his own actions of decades ago were faulted.

Benedict has long drawn mixed reviews in Germany. a country where Christians are roughly evenly split between Catholics and Protestants and where many with struggled conservative stance. The day after the then-Cardinal Joseph Ratzinger was elected as the first German pope for centuries in 2005, the bestsellingnewspaperBild'sfront page screamed "We are the Pope!" The left-leaning Tageszeitung countered with the headline "Oh, my God!" Chancellor Olaf Scholz said that "as the German' pope, Benedict XVI was a special church leader for many, not just in this country." He paid tribute to the late pontiff as "a formative figure of the Catholic Church, a combative personality and a wise theologian." "As the church in Germany, we think with gratitude of Pope Benedict XVI: He was born in our country, his homeland was here, and he helped shape church life here as a theological teacher and bishop," said the head of the GermanBishops'Conference, Limburg Bishop Georg Baetzing.

Still, a decade after his resignation, deep divisions are apparent in the German between church traditionalists in Benedict's mould and relative liberals. "The German pope filled many with pride, but above all with hope," said Irme Stetter-Karp, the head of an influential lay organisation, the Central Committee of German Catholics, or ZdK. "Forsome, this hope was richly fulfilled. For others, there remained an unfulfilled longing to find a way ... for their Christianity to succeed in the 21st century "Since 2019. Pak, India exchange list of nuclear installations, facilities

ISLAMABAD, JAN 1 /--/ Pakistan and India on Sunday exchanged a list of their nuclear installations that cannot be attacked in case of an escalation in hostilities, a Foreign Office statement said here, as part of an annual ritual that has been in practice between the two neighbours for more

The lists of nuclear installation and facilities were exchanged as per the provisions of the Article-II of the Agreement on Prohibition of Attacks against Nuclear Installations and Facilities, signed on December 31, 1988 and ratified on 27 January 1991. According to this agreement, both countries have to inform each other of the nuclear facilities. This practice of exchanging lists has continued since January 1, 1992. "Pursuant to the agreement, the list of nuclear installations and facilities in Pakistan was officially handed over to a representative of the Indian High Commission in Islamabad at the ministry of foreign Affairs on Sunday." the Foreign Office said in the statement. Simultaneously, the Indian Ministry of External Affairs also handed over their list of nuclear installations and facilities to a representative of the Pakistan High Commission in New Delhi, according to the Foreign Office. The exchange comes amid strain in ties between the two countries over the Kashmir issue as well as cross-border terrorism. These lists are exchanged under the provisions of the Agreement on Consular Access signed in May 2008

'Murder weapon' recovered in Hindu woman's killing probe in Sindh

Bheel's mutilated body was found after her son Soomar went searching for her in the mustard field. "What is agonising for us (family) is the manner in which she was killed," Soomar told PTI. "When my mother didn't return, we went out to search for her and after hours of search we found her mutilated body in the field," he added. The incident has sparked an uproar amongst the Hindu community, who staged protests in the Sanghar district demanding prompt police action. Police initially formed a joint investigation team to probe the murder. Hindus form the biggest minority community in Pakistan.

"They are now keen on isolating and stifling (North Korea), unprecedented in human history," Kim said at a recently ended ruling party

Kim accused South Korea of being "hell-bent on imprudent and dangerous arms build-up" and openly trumpeting its preparations for war with North Korea. Taliban: Kabul checkpoint bomb blast kills, wounds several

KABUL, JAN1/--/ Abomb exploded near a checkpoint at Kabul's military airport on Sunday morning killing and wounding "several" people, a Taliban official said, the first deadly blast of 2023 in Afghanistan. No one immediately claimed responsibility for the attack, but the regional affiliate of the Islamic State group known as the Islamic State in Khorasan Province has increased its attacks since the Taliban takeover in 2021. Targets have included Taliban patrols and members of Afghanistan's Shiite minority. The military airport is around 200 metres (219 yards) from the civilian airport and close to the Interior Ministry, itself the site of a suicide bombing last October that killed at least four people. Interior ministry spokesman Abdul Nafi Takor said the blast left several people dead and wounded. He gave no exact figures or further information about the bombing, saying details of an investigation will be shared later. Although Taliban security forces $prevented \, photography \, and \, filming \, directly \, at \, the \, blast$ site, the checkpoint appeared damaged but intact. It is on Airport Road, which leads to high-security neighbourhoodshousinggovernmentministries,foreign embassies and the presidential palace. A spokesman for the Kabul police chief, Khalid Zadran, was not immediately available for comment. (AP)

Canada to require Covid tests for passengers from China

OTTAWA, JAN 1 /--/ Canada plans to temporarily require people flying from China, Hong Kong and Macao to test negative for Covid-19 before leaving for Canada. The requirement will apply to all air travellers aged two and older from the three countries and will begin on Jan. 5, the federal government said in a news release Saturday. "These planned health measures will apply to air travellers, regardless of nationality and vaccination status," the release said. "They are temporary measures, in place for 30 days, that will be reassessed as more data and evidence becomes available." The United States announced on Wednesday it would require all travellers from China to show a negative Covid-19 test result before flying to the country as Beijing's rapid easing of Covid-19 restrictions leads to a surge in cases. The Canadian government said its new testing measure is "in



response to the surge of COVID-19 in the People's Republic of China and given the limited epidemiological and viral genomic sequence data available on these cases.

People will need to provide a negative COVID-19 test result to the airline, taken no more than two days before their departure, before boarding a flight to Canada. The test can be either molecular, such as a PCR test, or an antigen test from a telehealth service or an accredited laboratory or testing provider, the release said. Passengers who tested positive more than 10 days before their flight leaves, but not more than 90 days, can provide the airline with proof of their positive test instead. "Since the start, our Government has taken the necessary steps to keep Canadians safe in the face of the COVID-19 pandemic," federal health minister Jean-Yves Duclos said in a statement. "Our actions continue to be guided by prudence and we will not hesitate to adjust measures to protect the health and safety of Canadians." (AP)

Pakistan and New Zealand seek Test turnaround in 2023

Pakistan declared on 311-8 but a target of 138 in 15 overs under fading light was tough for New Zealand, who finished on 59-1. "We need to credit New Zealand with the way they played and dominated," said Azam, who finished the year as the highest scorer in Tests with 1,184 in nine matches. The National Stadium pitch helped slow bowlers as 23 of the 28 wickets in the first Test went to the spinners. (PTI)

No threat to Rohit Sharma's captaincy in **Tests and ODIs: Report**

NEW DELHI, JAN 1/--/ There is no imminent threat to Rohit Sharma's ODI and Test captaincy as the BCCI brass hasn't found anything unsatisfactory about his leadership in the traditional formats, according to a report. Skipper Rohit, along with head coach Rahul Dravid, attended the review meeting in Mumbai. The meeting was conducted by BCCI secretary Jay Shah. Along with last selection committee's chairman Chetan Sharma, NCA head VVS Laxman, president Roger Binny also attended the review meeting. Since the focus is the World Test Championships (WTC), where India have a good chance of making it to the finals, and the 2023 ODI World Cup, new T20 captain Hardik Pandya wasn't a part of the meeting. Hardik is in Mumbai for the T20 international series against Sri Lanka, which starts on Tuesday. "Rohit is leading India in Tests and ODIs and there was no such discussions about his future as leader in these two formats. Look at his captaincy record in Tests and ODIs and it is more than impressive," a BCCI source privy to the development told PTI on the condition of anonymity. It was also decided that a pool of 20 players will be rotated till the 2023 World Cup. In what could be a significant move by the board, Sharma, who attended the review meeting on Sunday, could once again retain his chairmanship of the senior national selection panel. If not chairman, he is likely to be the representative from North Zone. The name of former India pacer Venkatesh Prasad is also doing the rounds from South Zone, but his induction in the panel isn't a certainty. Sharma being included in the planning of roadmap up to the 2023 ODI World Cup in itself is a significant development. "First things first, if Chetan wouldn't have been told, he wouldn't have applied in first place. That itself is an indication. India have a World Cup to play in 10 months. Chetan and Harvinder's presence will add continuity along with three new members," the source added. It is understood that SS Das, a former opener, is a big favourite from East Zone because of his 21 Test experience unless some other compulsions lead to the BCCI choosing a lightweight candidate from east. From West, Gujarat veteran Mukund Parmar, Salil Ankola, Sameer Dighe are engaged in a three-way race. The new committee will be named in the coming week. (PTI)

BARCELONA, JAN 1/--/ Barcelona stumbled in the Spanish title race with a 1-1 draw against rivals Espanyol in a bad-tempered Catalan derby on Saturday, levelling Real Madrid at the top of La Liga. The duelling Spanish giants have 38 points each from 15 games, nine ahead of third-place Real Sociedad, who beat Osasuna 2-0 later on Saturday. Xavi's Barcelona threw away the two-point advantage they had earned before the World Cup break, with Joselu's penalty pegging Barcelona back after Marcos Alonso's opener. Both teams finished with 10 men as Jordi Alba and Vinicius Souza were sent off, with referee Mateu Lahoz allowing the game to spiral out of control at Camp Nou. "The draw is our fault, we can talk about the referee and other things but they are our mistakes,' said Xavi. "I think Mateu is a referee who controls games but today it got away from him in my opinion, he let the game get totally out of control.""(But)Idon't blame

him for anything, the fault is ours. We lowered our intensity." The teams were at loggerheads before a ball was kicked because Barcelona started Robert Lewandowski, who had been banned before a late court ruling allowed him to play. The forward, due to miss three league matches, was only allowed to feature thanks to a controversial decision announced on Friday, suspending his punishment. It greatly angered Espanyol, whose president and directors boycotted the match, while Barca coach Xavi admitted his team had prepared all week expecting to be without the division's top goalscorer. TheSpanishfootballfederation said in a statement on Saturday they could not override the court's decision. Lewandowski was not at his best but Barcelona took the lead after just seven minutes with Alonso capitalising on shoddy set-piece defending from Espanyol to head home. The former Chelsea defender,
