PORT BLAIR, DEC 12/--/ Medical staff arriving in health centres on time is crucial as every minute counts and any delay by health personnel can be risky for the patients. And in an overburdened healthcare system like ours, efficient use of time is incredibly important. When medical staff are non-punctual, it's a bad factor for the patients as they don't get timely treatment. All it takes is one staff member to come late, and then everybody else is pushed later, regardless of the ability of the health centre to cater the requirements of the patients. Patients visiting the health-sub centre at Dairy Farm have

Negligence in duty plays with lives of the sick

complained about the late arrival of the doctor and all other medical staff at this health centre. While patients visit this health centre as early as 8.30 am, the staff started arriving in the centre after 10.30 am. While the staff get around occupying their seats after 10.30 am, patients wait for several hours in advance. The health centre mentions official patients examination timing from 8.30 am to 1.00 pm. This public health centre represents the only

in these areas. Due to late arrival of medical staff at this health centre, the wait for the patients becomes longer and longer. If a patient arrives at this health-sub centre for treatment in the morning, he has no option but to wait for more than 2-3 hours to avail the treatment. Therefore, the question arises as to whether the daily working hours of the medical personnel deployed in this healthcentre start from 10.30 pm? It is often difficult to get treatment in case of sudden accidents. This is because the medical staff are not punctual and hardly care about office punctuality. For them breaking rules is the "express rule."

Agnipath scheme voluntary, those having problem don't join: Delhi HC

NEW DELHI, DEC 12 /--/ Indian Air Force. "There is a The Delhi High Court on asked who have challenged the Centre's Agnipath scheme as to which of their rights have been violated and said it was voluntary and those having any problem should not join the armed forces under it.

The High Court said the Agnipath scheme has been formed by experts in Army, Navy and Air Force and judges were not military experts. "What is wrong in the scheme? It is not compulsory. To be frank, we are not military experts. You (petitioners) and me are not experts. It has been framed after great efforts by experts in Army, Navy and particular policy that the government has framed. It is not compulsory, it is voluntary," a bench of Chief Justice Satish Chandra Sharma and Justice Subramonium Prasad said. The bench further said: "You have to show us that a right is taken away . Don't join then. There is no compulsion. If you are good you will be absolved thereafter (after 4 years). Are we the persons to decide it (service in the scheme) should be made four years or five years or seven years." The High Court was

hearing a batch of pleas challenging the Centre's Agnipath scheme. The

Agnipath scheme, unveiled on June 14, lays out rules for the recruitment of youths the armed forces. According to these rules, those between 17-and-a-half and 21 years of age are eligible to apply and they would be inducted for a four-year tenure. The scheme allows 25 per cent of them to be granted regular service subsequently. After the scheme was unveiled, protests erupted in several states against the scheme. Later, the government extended the upper age limit to 23 years for recruitment in 2022. During the hearing, advocate Kumud Lata Das,

petitioners Harsh Ajay Singh, said after being recruited under the scheme, the Agniveers will have life insurance of Rs 48 Lakh in case of contingency which is much less than the existing one.

Whatever the armed forces personnel are entitled to, these Agniveers will get them only for four years, the counsel argued. adding that if the service would have been for five years, they would have been entitled to gratuity. The counsel contended that after four years of service, only 25 per cent of the Agniveers will be considered for being retained in the force and there is no backup plan for

Senior Congress leader Shashi Tharoor on Monday called for a thorough investigation into the cyber attack on the servers of AIIMS-Delhi and urged the government to take necessary measures to ensure adequate protection of citizens' sensitive personal data and avoid such data breaches in the

Tharoor said the recent cyber attacks on the IT servers of AIIMS-Delhi had resulted in data losses which impeded its normal operations including registration, consultation booking and availability of medical records. "The origin, intent and extent of the attack remain unclear and I trust that the government recognising this as a matter of public importance will take the House into confidence about this and the measures taken to prevent a recurrence," the

Thiruvananthapuram said. The possibility of this being a hostile cross-border attack is a grave concern which calls for a thorough investigation and a tough

data protection safeguards in our country especially by government institutions. The Personal Protection Bill 2019 had created a special category of sensitive personal data including health data that required safeguards but this has unfortunately been done away with in the new draft bill released by the government," he said. "I urge the minister (of Electronics Information Technology Ashwini Vaishnaw) to take necessary measures to ensure that sensitive personal data of our citizens are adequately protected and to avoid such data breaches in the future." the Congress leader said.

--/ Three days after an RPG attack at a police station in Tarn Taran, the Punjab Police on Monday said it has detained four suspects who provided logistical support in carrying it out.

Two suspects who carried out the attack were yet to be detained, it said. rocket-propelled grenade was fired at the Sarhali police station in Tarn Taran on Friday night. the second such attack in the state in the last seven

Briefing the media here, Inspector General of Police (Headquarters) Sukhchain Singh Gill said four suspects who provided logistic support, motor cycles, etc. in the RPG attack have been detained. "Two persons who executed this act, their identification process is going on," he said. "I cannot disclose any name at this

Identification, detaining of suspects and the process of further identification were going on," the IG added.

Gill said in one or two

days, police will disclose more facts including names, who were behind it and how it was done. He said the investigation was being conducted under the supervision of additional director general of police (internal security) R N Dhoke while ADGP (counter intelligence) Amit Prasad was camping in Amritsar. Prima facie, police have got all the clues of this incident, he said, adding that the crime has been unearthed. Further investigation was underway, the senior police officer said. Some unidentified people had fired the projectile which hit the

the Amritsar-Bathinda highway on Friday night. The projectile first struck the iron grills of the gate of the police station and then hit the wall of the Saanjh Kendra, Director General of Police Gaurav Yadav, who had visited the site, had said that it was military-grade hardware which was suspected to have been smuggled from across the border.

"There is a clear indication that it is a strategy \mathbf{of} neighbouring nation to bleed India by a thousand cuts," the DGP had said. An FIR under the Unlawful Activities (Prevention) Act has been registered in connection with the incident. Earlier in May, a rocket-propelled grenade (RPG) was fired at the Punjab Police's intelligence Saanjh Kendra adjoining headquarters located in the Sarhali police station on Mohali. (PTI)

Women's Reservation Bill still alive as it has been passed by Rajya Sabha: Ramesh

Congress is committed to the Women's Reservation Bill to ensure one-third of seats in Lok Sabha and state legislative assemblies for women, party spokesperson Jairam Ramesh said on Monday. Addressing the press on the sidelines of the party's Bharat Jodo Yatra here, Ramesh said the Bill, which was passed in Rajya Sabha during the Manmohan Singh-led government around 11 years ago, was still alive as Rajya Sabha never dissolves. "The Bill is still alive as it has been passed by Raiva Sabha and once it is passed in Lok Sabha it will become an Act," he said. The Congress has repeatedly demanded that the Bill be brought in Lok Sabha and said the

party would support it, he added. "We want that women should get same reservation in Lok Sabha, Rajya Sabha and assemblies as they have got in panchayati raj and municipal institutions," he said. The Congress leader also said former Congress president Sonia Gandhi had written to the prime minister requesting him to bring the bill in Lok Sabha, but it has never been mentioned in the eight years of the Narendra Modi government. He said the Congress was the only political party in the country that has provision of reservation for women in its constitution. The party has amended its constitution to provide 20 per cent reservation to women. "It is a different point that we could not fulfil the target.(PTI)

Cong expresses strong objections to Sitharaman's

'jealous' remark NEW DELHI, DEC 12 /--/ Congress on Monday expressed "strong objections" to Union finance minister Sitharaman's comments in Parliament that some people are "jealous" of the country's economic growth, saying India is a democratic nation and every citizen has a right to question the government.

Participating in the discussion on supplementary demands for grants in the Lok Sabha, Congress member K Suresh said "nobody is jealous about India's progress". "Every single Indian has the right to question...It is called democracy. People rights are supreme...We are still living in a democracy," Suresh said. Earlier in the day, replying toaquestion, Sitharaman said it is regrettable that when Indian economy is doing well and is growing at a faster rate, somepeople are "jealous" over it. Suresh said the finance minister is stating that Indian economy is the fastest growing and if this is the case, then "we are not jealous, but we are worried".

Over 11 k faculty positions vacant in Central Varsities, IITs and IIMs: MoE

11,000 positions are vacant in central universities, IITs and IIMs across the country, according to Ministry of Education (MoE) statistics.

The data was shared by Union education minister Dharmendra Pradhan in a written reply in Lok Sabha. In 45 Central Universities, a total of 6,180 posts of Professor. Associate Professor and Assistant Professor, out of 18,956 sanctioned posts are vacant.

Institutes of Technology (IITs), a total of 4,502 posts out of 11,170 sanctioned posts are vacant. In Indian **Institutes of Management** (IIMs), 493 posts out of 1,566 faculty posts are vacant. "Occurrence of vacancies and filling thereof is a continuous process. Central Universities are autonomous bodies, established under respective Central Acts. recruitment procedure is formulated by their statutory bodies in

accordance with their acts, statues, rules and UGC regulations or guidelines," Pradhan said. The minister further said that he has directed all higher education institutions (HEIs) to fill up the vacancies in a Mission Mode. "In addition to writing to all the HEIs to fill up the vacancies in a Mission Mode, the Ministry has set up a monthly monitoring mechanism," he said. Among the vacant posts in the Central Universities and

reserved for SC category, 578 for ST category, 1,657 are OBC posts. The vacant positions reserved for EWS and PWD category are 643 and 301 respectively.

"The Central Educational Institutions (Reservation in Teachers Cadre) Act, 2019 has been notified on July 9, 2019 to ensure preparation of the rosters by considering the university as a unit. Also, according to the Act, reservation is applicable in

institutions except the institutions listed in the schedule and few other exceptions as stated in the Act. "As per this Act, reservation is provided for all posts in direct recruitment in teacher's Central cadre in Educational Institutions. After enactment of this Act, no reserved post is to be dereserved," Pradhan said. There are 23 IITs in the country while the number

President, ANVSS urges LG for speedy filling of vacant posts in Electricity dept

PeddiRaju, State President, Andaman & Nicobar Vidyut Shramik Sangh and All India Executive Committee

Akhil Member Bharatiya Vidyut Mazdoor Maha Sangh in a letter to the Lt Governor has urged for filling-up of vacant posts of direct recruitment as well as promotion quota in the Electricity department.

He mentioned that in department of Electricity, around 1450 post are lying vacant, out of the total post of 3024. Every month about 10-20

employees retire from services and the staff strength is depleting quick and fast. As a result of reduction of workforce, the department is facing hardships to undertake line maintenance and power house work.

employees. He further mentioned that one post of Superintending Engineer (HoD) is filled on Current Duty

Charges (CDC) basis and not yet filled on regular basis through UPSC. Out of seven posts of Executive Engineer, only two posts of Executive Engineer are filled on a regular basis, of which EE is under suspension and two posts are filled on Current Duty Charges (CDC) which is required to be filled-up on regular basis. Three posts of EE are lying vacant

which are also required to be filledup on a regular basis through UPSC. The divisions are functioning without EEs and additional charges to the existing EES were given.

Out of 38 postS of Assistant

on a regular basis and 14 posts are filled on Current Duty Charges (CDC). The promotion of the 31 Junior Engineers to the post of Assistant Engineers are under consideration, which will result in further shortage of strength of JEs in the site-offices.

Apart from these, about 280 posts on promotion quota are also lying vacant, which also required to be filled-up from the feeder posts. Once the promotion is given to the feeder employees, then more vacancies will be created in direct recruitment.

The President, ANVSS also brought to the notice of the Lt Governor that few employees have lost their lives in service due to electrical accidents and a few got bed ridden in such accidents. Preference needs to be given to provide jobs to any family members of the deceased on humanitarian ground for the livelihood of their family.




Kisan Mela by KVK under Jal Shakti Abhiyan

Delhi HC judgement, a historic moment for women's rights

The Delhi High Court recently upheld women's right to terminate pregnancy. It was indeed a historic moment for women's rights movement across the country. The court gave permission to a 26-year-old woman to undergo medical termination of her 33-week pregnancy. The HC observed that in cases with specific circumstances, it is the mother who has to take the ultimatedecisiontakingintoaccountwhetherthe unborn child can lead a dignified life. In the specific case in which the HC gave its order, it was found that the foetus was suffering from certain cerebral abnormalities. It goes without saying that in circumstances where the new born is suffering from any serious health complication, despite all the love and care a mother can provide, the child is considered a burden and the blame ultimately falls on the woman. Countries with quality medical facilities not just monitor the mother's health during the pregnancy but also the health of the foetus and provide informed advice in case of apprehensions. When the pregnancy does continue, no sooner the new born has been brought to life, all medical parameters are analysed and diagnosis carried out to ensure that all questions arising out of the apprehensions have been addressed. The Delhi High Court judgement will, therefore, have a far reaching impact as it sets a precedent for numerous such cases to come in the future. The right to abortion has been a debatable issue across the globe and even the first world countries have failed to recognise this right. India, however, has recognised this choice of a woman in its law. The high court judgement is not just a shot in the arm for women's rights to pregnancy but has the potential to provide the much needed force to usher in changes in the way the medical fraternity views the matter.

The Parliament of India, in order to abolish the social evil of female foeticide, enacted in 1994 the Pre-Conception and Pre-Natal Diagnostic Techniques (PCPNDT) Act--also known as the Prohibition of Sex Selection Act. However, in secrecy the act of sex selection still continues, to the extent that new born girls are abandoned by the families, mostly without the knowledge of the mothers. India, which aims to be the next world leader, ought to address the issue on war footing. Health care facilities in the country need a huge overhaul. India needs to invest heavily in the infrastructure of healthcare in the country side. We still face acute shortage of doctors and specialists and super-specialists and our district hospitals are overburdened. Thus, providing state-of-the-art healthcare to citizens across age groups and genders and to their unborn is of utmost necessity. A healthy State means a healthy economy, thus the adage 'health is wealth'.

Union Budget exercise for funding States becomes trickier

consultations of the Union Ministry of Finance for the fiscal 2023-24 on November 25 that the fiscal positions of most of the sates were in dire situation, and now, when the budget exercise has begun in right earnest, Modi government is finding the issue trickier that it has presumed.

During the pre-budget consultations the states finance ministers had demanded more funds from the Union Finance Minister Nirmala Sitharaman along with greater say in implementing centrally-sponsored schemes and an increased for royalty on minerals. Had it not been the last full budget for the Modi government before the general election 2024 in the country, it would have simply ignored the demands as it has been doing for the last four budgets during their second term since 2019. The demands are old but the political situation demands a more careful handling. It is not a secret that the Modi government has been in favour of a 'strong centre' which talks about 'one nation and one ...everything'. They have even made such policies and implemented in such manners that erodes 'federal structure' of the country. The situation had found voice in the Tamil Nadu's Minister of Finance Palanivel Thiagarajan who said during the pre-budget consultations that states cutting across party lines, that centrally sponsored schemes are constraining states' fiscal autonomy since in some schemes states end up contributing large amount which is more than the Centre's contribution.

Modi government have always tried to financially weaken the states by not providing enough funds to them and has prevented them from raising taxes through implementing GST. Several states have demanded for justice because they feel that the Modi government is not giving them their justified share in the tax revenue. All these have political implications in the pre-election year. If the states are financially crippled they cannot perform well, especially the opposition ruled states, against which Modi led BJP can successfully campaign. However, if the opposition ruling establishments are able to successfully convince the people that they have been victimised by the

Centre, the BJP will have to pay the price. Thus, there is every risk of creating a double-edged political sword that can potentially benefit and also harm the BJP, making the issue of the 'amount of funding' the states trickier. Centrally sponsored schemes have always been seen as a political tool of the Centre through which the Centre plays political right up to the Panchayat level.

It should be noted that after implementation of threetier system of governance in India - Panchayati Raj, States, and the Centre are constitutionally required not to interfere with each other's affairs. However, it has been remained in the statute book only, not on the ground. Centre devises schemes from the top and implements it up to the Panchayat level only for doing politics while ignoring the rights of the local bodies and also the states. Centre does not even give weightage to the say of the States and the Panchayats. It is in this backdrop, that the states across the party line had demanded during the pre-budget consultations that they should be given greater flexibility in implementing Centrally sponsored schemes. Bihar's Minister of Finance has even said that centrally sponsored schemes should be limited as the burden on states for such schemes are increasing, while states are fund starved.

Royalty for minerals are major source of income for the country, but states have always been demanding for more royalty since minerals are mined from their lands but they are getting pittance from that in the form of royalty. Centre and the private companies are benefitting the most, while they remain fund starved. Union Ministry of Finance is finding the demand too difficult to accept now, since mineral rich several states are opposition ruled which may become politically stronger with increased royalty.

government's strategy of keeping the states fund starved. People have started cursing Modi government more than the state governments for failure in helping them overcome the present day tribulations of price rise, inflation, joblessness, lack of social security and access to health services, medicine, diet, and even education to their children. It is therefore imperative for Modi government to keep people happy during the pre-election year as well as weakening the opposition ruling establishments in the states through restricted flow of funds from the Centre. Since the states fiscal deficits and revenue position are already in very bad shape. the flow of funds is demanding ever more careful considerations by the officials involved in budget making

Gross fiscal deficit of the states for 2021-22 was Rs 8,18,584 crore as against Rs 9,31,652 crore in the revised estimate for 2020-21. Actual gross fiscal deficit of states in 2019-20 was Rs 5,24,710 crore. As for the gross revenue deficit, it was Rs 1,21,495 crore in actual in 2019-20, which rose to Rs 3,95,149 crore in 2020-21. It was budget Rs 1,17,779 crore for 2021-22, and there are indications that it is going to rise in the revised estimate. Gross primary deficit in 2019-20 was Rs 1,73,322 crore which grew to Rs 5,38,301 crore in 2020-21. Budget estimate for primary deficit in 2021-22 was Rs 3,80,015 crore which is most likely to increase. States own tax revenue in 2019-20 was Rs 12,23,993 crore which almost remained stagnate in 2020-21 at Rs 12,41,117 crore. The budget estimate for 2021-22 was Rs 15,94,665 which is not likely to be met due to slow economic recovery. Gross non-tax revenue for states was Rs 2,60,891 crore in 2019-20 which declined to Rs 2,11,453 crore in 2020-21. Budget estimate for 2021-22 was Rs 2,86,742 which is not likely to be met on account of sluggish economic conditions

State's interest liabilities are also very high. It is growing fast from Rs 3,51,389 crore in 2019-20 to Rs 3,93,351 crore in 2020-21 and Rs 4,38,569 crore in 2021-22. Union Finance ministry has to tread very carefully in dealing with the state finances, since it has become a politically sensitive issue for the pre-general election year. (IPA)



Qatar's World Cup success punctures FIFA's political fantasy

If the Qatar World Cup proved anything, it's that sports and politics are inseparable Siamese twins joined at the hip.

Politics popped up at every twist of the World Cup's road, whether related to the right of freedom of expression of players, sports commentators and fans; antigovernment protests in Iran; anti-Israeli sentiment among Qataris and Arabs; a backlash against Western, particularly German, critics of Qatar; or ultraconservative religious rejection of soccer as

Qatari efforts to stage manage the intrusion of regional politics ranged from picking and choosing which protests fit its foreign policy agenda to seeking to ensure, where possible, that events elsewhere in the region would not overshadow or inflame passions during the World Cup. Amid escalating violence between Israelis and Palestinians, Mohammad al-Emadi, the Qatari official handling Hamas, the Islamist group that controls the Gaza Strip, travelled to the region to ensure that it and Islamic Jihad, another Gaza-based organization, would not respond with rockets to Israeli use of lethal force against Palestinian militants on the West Bank

Qatarfeared that a response to last week's killing of an Islamic Jihad commander on the West Bank and near-nightly Israeli raids could spark a renewed Israeli intervention in Gaza, already crippled by a 15-year-long Israeli-Egyptian blockade. The Qatari pressure puts in a different perspective the Gulf state's endorsement of expressions of support for the Palestinians during the World Cup in the form of pro-Palestinian flags and T-shirts and a refusal by Qatari and

Arab fans to engage with Israeli reporters covering the tournament. Despite refusing to follow in the footsteps of the United Arab Emirates, Bahrain, Morocco, and Sudan in recognizing Israel without a resolution of the Israeli-Palestinian conflict, Qatar has a long-standing working relationship with the Jewish state that serves the interests of both countries.

The Gulf state, often at Israel's request, has pumped millions of dollars into paying government salaries in Gaza, providing aid to thousands of families affected by past wars, and funding fuel for the Strip's power plant as well as infrastructure projects. Moreover, Qatar became the first Gulf state to put money into Israel when it funded in 2006 a six-million-dollar stadium in the predominantly Israeli Palestinian town of Sakhnin, an investment long before the UAE-led Arab recognition of the Jewish state 14 years later

Sakhnin and the Doha Stadium are home to Bnei Sakhnin, Israel's most successful Israeli-Palestinian club. As a result, allowing expressions of pro-Palestinian sentiment during the World Cup served multiple Qatari purposes. It gave a release valve to Qataris, a minority in their own country, who were concerned about the impact on their society of the government's live-and-let-live approach towards soccer fans with very different cultural values visiting their country during the World Cup. Preventing fans from taking pro-LGBT paraphernalia such as One Love and rainbow-coloured armbands and shirts into stadiums served a similar purpose.

It also allowed Qataris to vent their frustration at perceived double standards in European and American criticism of Qatar's rejection of LGBT rights, particularly after the German team's hands-over-mouth gesture in protest against FIFA's denial of their right to wear pro-LGBT armbands. In one instance, Qataris wore pro-Palestinian armbands of their own to a match as a protest against the donning of a pro-LGBT One Love band by German Interior Minister Nancy Faeser, who attended the game. Expressions of pro-Palestinian, anti-Israeli sentiment also suggested that Qatar's refusal to recognise Israel was more in line with Arab public opinion than efforts to project the UAE-led recognition of the Jewish state as genuinely popular and indicative of a drop in support for the Palestinian cause.

If anything, recent polls show that public support for establishing diplomatic relations with Israel had fallen across the Arab and Muslim world, including in countries that normalized their ties to the Jewish state. In Bahrain, 20 per cent of the population supports the accords, compared with 45 per cent in 2020, according to a Washington Institute for Near East Policy

poll in July. Support in Saudi Arabia fell from 41 to 19 per cent. Even in the UAE, where normalisation had the greatest impact, support dropped to 25 per cent this year from 47 per cent in 2020. For Qatari World Cup managers, Palestine was lowhanging fruit. Protest against the government in Tehran was a far trickier challenge.

A regional behemoth, Iran is a partner as well as a potential threat with which Qatar shares the world's largest offshore gas field. Maintaining relations with Iran has allowed Qatar, at times, to be a background mediator with the United States on issues like the moribund talks to revive the 2015 Iranian nuclear agreement. Qatar feared that allowing stadiums to become venues of confrontation between opponents and supporters of the Iranian government could have persuaded Iran to rank the Gulf state, alongside Saudi Arabia, Israel, and the United States, as an instigator of sustained anti-government protests in which security forces have killed hundreds. As a result, Qatar sought to prevent anti-government banners, T-shirts, and pre-revolution flags from entering stadia. The problem resolved itself when Iran was knocked out of the World Cup in the group stage. Yet, the larger issue remains. The Qatar World Cup demonstrates that FIFA's insistence that sports and politics can be separated amounts to a political fantasy.

More concerning than that, it enables FIFA and autocratic World Cup hosts like Qatar to decide what are convenient and inconvenient expressions of politics. That hardly makes for a level playing field, the starting point for any sport. (IPA)

JAMMU, DEC 12 /--/ Lieutenant Governor Manoj Sinha on Monday said no talks will be held with Pakistan unless it does not reject and openly criticise terrorism.

He said terrorism in Jammu and Kashmir is taking its last breath as its backbone has been completely broken. "Some people are often batting for talks with Pakistan. They say security and normalcy cannot return here (Jammu and Kashmir) unless there are talks with them (Pakistan). I strongly reject this notion," Sinha said. He was speaking at a function here on Monday evening. "As per the policy of the government of India, there is no question of holding talks with Pakistan unless and until it doesn't reject terrorism and criticise it openly," the Lt Governor said. They (some politicians) try to raise it by saying that that is the only right path, he added. He lashed out at those "spilling blood of innocents on this land". Quoting Abhimanyu in Mahabharata, he said, "Security forces dismantled and broken six barricades of terrorism. Now only the seventh barricade remains. I hope that this 7th barricade is broken fast." Asserting that peace and normalcy cannot be bought to Jammu and Kashmir through "bargaining", Sinha said, "GoI has a clear-cut policy that one cannot buy peace but it has to be established. We are following that." He said at Jammu and Kashmir. "That era has passed away. Now it is time to establish durable and long-lasting peace." "That time has gone when there were incidents of stone pelting (in the valley) and our neighbouring country used to issue calendars for strikes. Schools, colleges and universities used to remain shut," he said. Today, the common man is living in peace and earning his bread and butter in normalcy, the Lt Governor added. "Security forces have been able to dismantle terror financing. Now houses are also being dismantled. This process will continue till the last sign of terrorism is wiped out here.

We will be successful in ensuring peace, progress and prosperity in Jammu and Kashmir," he said. Sinha said some people used youths as cannon fodder to mislead them to engineer stone pelting and "give sacrifices", while their children were studying in peace in other parts of the country and abroad. Bogtui killings accused Lalan Sheikh found dead in CBI custody



NEW DELHI, DEC 12 /--/ In a suspected case of suicide, the prime accused in the violence in Bogtui village of West Bengal's Birbhum district was found dead in CBI custody on Monday, officials said. Lalan Sheikh, who was arrested on December 4 from a hideout along the Bengal-Jharkhand border, was "found hanging" in the agency's Rampurhat camp office in Birbhum, a source in the Central Bureau of Investigation said. "The body of the prime accused in the Bogtui violence was found hanging in the washroom of the guest house, where we have set up our temporary camp, at around 4:30 pm. We have informed the police and all necessary procedures are being followed," the CBI source told PTI.

The agency has informed the National Human Rights Commission (NHRC) and judiciary in accordance with the laid down procedure, officials here said. At least 10 people were killed in the arson and violence in Bogtui that followed the murder of local TMC leader Bhadu Sheikh on March 21. The CBI is probing the case on the orders of the Calcutta High Court. (PTI)

During her three-day visit, she will address a TMC workers' convention at the State Central Library in Shillong on Tuesday, a party leader said. "Mamata Banerjee's visit is to set the tone for the 2023 polls and she is expected to boost the morale of the party workers and prepare a strategy for the Assembly elections," the party leader said The West Bengal chief minister will also participate in pre Christmas celebrations here on December 13. In November 2021, 12 of the 17 MLAs of the Congress had joined the TMC, making it the principal opposition party in the 60member Assembly of the hill state. Of the 12 legislators Himalaya Shangpliang resigned from the assembly and also from the party last month, reducing the TMC's strength in the House to 11. Notably, the TMC has been trying to strengthen its foothold in the northeastern state along with Assam and Tripura in the region. TMC's national general secretary Abhishek Banerjee had visited Meghalaya twice this year. During his last visit, Banerjee had inaugurated a Trinamool Congress' party office in Garo Hills and also met church leaders besides addressing a public meeting in western Meghalaya. (PTI)

LS Speaker warns members against referring to anyone's caste or religion in House

NEW DELHI, DEC 12 /--/ Lok Sabha Speaker Om Birla on Monday warned members against referring to anyone's caste and religion in the House after a Congress MP alleged that Union finance minister Nirmala Sitharaman made certain remarks about his proficiency in Hindi because he belonged to a particular community. Taking serious exception to the word used by Congress member A Revanth Reddy to refer to his own social category during the Question Hour, the Speaker pointed out that people have not elected the members to Lok Sabha on the basis of their caste and religion. "Anyone here should never use such words in the House. Otherwise, I will have to take action against such a member," the Speaker warned. Birla also took serious exception to the Congress member asking the Speaker not to "interrupt"

him when he was asking a question. Birla asked the Congress leader in the House, Adhir Ranjan Chowdhury, to make his party members understand that they should never make such comments about the Speaker. "You are the Leader of the House. Make members understand that they should never comment on the Speaker in the future 'that you (Speaker) cannot interrupt'. Did you understand what I said?" Birla said. The issue appeared as Reddy began asking a question on the depreciation of the rupee against the dollar, referring to Prime Minister Narendra Modi's earlier remark when he was the chief minister of Gujarat that the rupee was in the ICU (intensive care unit). "Sir, you cannot interrupt," Reddy said as the Speaker objected to his comment and directed him to limit himself to asking the question. (PTI)

August 2017 to oust a Dhaka was trying to negotiate predominantly Muslim ethnic group from their homeland at Rakhine state. They now live in sprawling makeshift refugee camps. Bangladesh and Myanmar have held talks on repatriation of displaced Rohingya refugees back to their homeland, but they failed to resolve the issue. Pak PM condemns 'unprovoked' firing by Afghan Taliban forces in border town Chaman

Minister Shehbaz Sharif on Monday condemned the "unprovoked" firing by Afghan Taliban forces in the border area of Chaman in the restive Balochistan province that killed seven people and said that that the interim government in Kabul must ensure that such incidents were not repeated in the future.

The Pakistani Army's media wing initially said six died in Sunday's shelling, but the death toll later rose to seven. Sixteen others were wounded, the army said, blaming the casualties on the "unprovoked and indiscriminate fire" of weapons forces civilians. The firing in Chaman, the main border crossing for between the two countries, follows a series of deadly incidents and

attacks that have skyrocketed tensions between Islamabad and Afghanistan's Taliban rulers. Condemning the incident, Prime Minister Sharif tweeted that the interim government in Kabul must ensure that such incidents are not repeated in the future. A senior Pakistan government official said that "it was unprovoked and indiscriminate gunfire which continued for a while and this included artillery shelling by Afghan Border forces." The Pakistani Army's media wing described the incident as "uncalled-for aggression" and said Pakistani troops had given a "befitting" but "measured response" and avoided targeting civilians on the other side.

"Whether it is individually or collectively, the world must focus on mindful consumption rather than mindless utilisation," said Yadav. "Mission

reform has been left open-ended without a set timeline and the Security Council far from reflects true diversity, a concept note by India here said new global challenges such as terrorism, radicalism, pandemics, disruptive role of non-State actors and intensifying geopolitical competition call for a robust multilateral response and nimble platform to ensure peace.

India, the current President of the 15-nation UN Security Council, will hold signature events on reformed multilateralism and counter-terrorism that will be chaired by External Affairs Minister S Jaishankar on December 14 and 15. The first signature event will be a ministerial-level open debate of the Security Council on New orientation for reformed multilateralism' under the item Maintenance of international peace and security'. The concept note by India on the topic has been issued ahead of the meeting and India's Permanent Representative to the United Nations Ambassador Ruchira Kamboj has asked that it be circulated as a document of the Security Council "The world is not the same as it was 77 years ago. The 193 States Members of the United Nations are more than triple the 55 Member States that it had in 1945 However, the composition of the Security Council responsible for global peace and security, was last fixed in 1965 and is far from reflecting the true diversity of the wider membership of the United Nations," the concept note, seen by PTI, said.

It added that new global challenges have emerged during the past seven decades, such as terrorism, radicalism, pandemics, threats from new and emerging technologies, growing asymmetric threats, the disruptive role of non-State actors and intensifying geopolitical competition. "All of these challenges call for a robust multilateral response. The new orientation for reformed multilateralism envisages reforms in all three pillars of the current multilateral architecture peace and security, development and human rights with the United Nations at its centre," the concept note said. It points out that while there are time-bound targets for key areas, such as Sustainable Development Goals, "the reform of the United Nations itself has been

The note also voiced concern that the lack of a common negotiating text is hampering progress even as there have been several proposals from Member States and groups of States on a framework for reforms. "Similarly, the global development architecture outside the United Nations is equally distorted, and intense efforts would be required to enhance the coherence and consistency of the international monetary, financial and trading systems. Such efforts would be critical to ensuring sustainable development, including strong, sustained, balanced, inclusive and equitable economic growth for all," it said. The concept note by India states that multidimensional crises facing the world today demand a "representative multilateral architecture" that is reflective of contemporary global realities and is well equipped to meet the emerging challenges. "The rapidly shifting global security landscape, the persistence of traditional security challenges and the emergence of new and complicated challenges all demand a clear, pragmatic, nimble and effective platform for collaboration to ensure sustainable peace. The need of the hour, clearly, is to promote responsible and inclusive solutions to international peace and security," it said. It underlined that these would require early reform of the United Nations, with comprehensive reform of the Security Council at its

China to drop some travel tracking as it relaxes Covid rules

BEIJING, DEC 12 /--/ China planned to minimise numbers of cases and deaths. stop tracking some travel on Monday, potentially reducing the likelihood people will be forced into quarantine for visiting Covid-19 hot spots, as part of an uncertain exit from the strict pandemic policies that helped fuel widespread protests.

At midnight, the smart phone app that recorded a person's travel between cities and provinces will be disabled. Another app used to restrict the movement of those who test positive or enter an area with a recent outbreak remains in effect. They're

part of a package of pandemic apps, some of which have also been used by local governments to suppress protests. The move follows the government's dramatic announcement last

week that it was ending many of the strictest measures, following three years during which it enforced some of the world's tightest virus restrictions. That included near-constant testing, open-ended lockdowns and requirements that a clean bill of health be shown to access public areas. Last month in Beijing and several other cities, protests over the restrictions grew into calls for leader Xi Jinping and the Communist Party to step down a level of public dissent not seen in decades. While met with relief, the relaxation has also sparked concerns about a new wave of infections potentially overwhelming health care resources in some areas.

The easing of measures means a sharp drop in testing, but cases still appear to be rising rapidly. China reported 8,500 new infections on Monday, bringing the nation's total to 365,312 more than double the level on Oct 1. It has recorded 5,235 deaths compared to 1.1 million in the United States. China's government-supplied figures have not been independently verified and questions have been raised about whether the ruling Communist Party has sought to

Fever clinics at hospitals in Beijing received 22,000 patients on Sunday 16 times higher than previous week.

Following a rush last week to buy cold and flu medicine in many major Chinese cities, pharmacies in Hong Kong have reported a run on such medications by customers supplying relatives in mainland China, according to Lam Wai-man, chairman of the pharmacy trade association in the semi-autonomous southern Chinese city. Hong Kong has already lifted most of

restrictions. "Everyone on the mainland wants to buy some pills to have in reserve at home," Lam said. Alan COVID-19 Cheung, the owner of the Sands Medicine Shop in the Wan Chai

district, said he was receiving around 10 inquiries about flu medication from mainland residents every day. "Normally, no one would ask me about this kind of product," Cheung said. The uncertainty and apparent growing number of cases have forced the cancellation of events from foreign embassy holiday parties to next spring's Formula One Chinese Grand Prix car race in Shanghai.

Xi's government is still officially committed to stopping virus transmission, the last major country to try. But the latest moves suggest the party will tolerate more cases without quarantines or shutting down travel or businesses as it winds down its "zero COVID" strategy. Facing a surge in Covid-19 cases, China is setting up more intensive care facilities and trying to strengthen hospitals' ability to deal with severe cases. At the same time, part of the relaxation means the government will allow those with mild symptoms to recuperate at home rather than being sent to field hospitals that have become notorious for overcrowding and poor hygiene. 

Rahane, Ishant likely to lose central contracts, Surya, Shubman set for promotion

Hardik Pandya, who is being seen as future T20 captain, is likely to get a promotion to Group B from C. The meeting, which has 12 items on the agenda, will be held via video conference. A review of Indian team's performance in the T20 World Cup and Bangladesh One-Dayers is not part of the agenda but if chairperson deems necessary, non-listed items can

be considered for discussion. In a novel gesture, the Apex Council will also ratify a one-time payment for V Jaydevan, whose rain-rule formula is being used in domestic white-ball games for more than a decade now. At the international level, ICC uses Duckworth-Lewis-Stern method (DLS) while VJD is used for Mushtaq Ali T20, Vijay Hazare Trophy and erstwhile Deodhar Trophy and Challenger Trophy. One of the major items on the agenda is "Retainership Contract" of senior men $and women \, cricketers. \, It \, is \, understood \, that former$ vice-captain Rahane and speedster Ishant, who are out of India contention, will be axed from the fresh list.
