Kuldeep Rai Sharma has requested the Chief Secretary, A&N Administration to operate vehicle ferry vessel on daily basis between Yeretta Jetty and Long Island so that people willing to visit Long Islandcan easily take their four or two wheelers to Long Island and explore the Island and return in the same vehicle ferry

In a letter addressed to the Chief Secretary, the Member of Parliament mentioned that Long Island has immense potential for tourism due to its natural beauty and three famous beaches but the Island has failed to attract tourists mainly because of lack of connectivity.

## Space, not Time

The ongoing hearing before a Constitution Bench of the Supreme Court of India on the need to have a neutral mechanism for appointment of Election Commissioners raises important questions on the election body's functional independence. The Election Commission of India (ECI) has generally enjoyed a high reputation for holding free and fair polls since the dawn of the Republic, although not immune to charges of favouring the ruling party. However, given the Court's vocal concern about the ECI's independence, the relevant question now is whether the Commissioners should be appointed on the recommendation of an independent body. Article 324(2) envisages a parliamentary law for the purpose, but no law has been enacted so far. The Government is pushing back strongly against the Court's apparent inclination to devise an independent mechanism, possibly a selection committee that includes the Chief Justice of India. The perceived legislative vacuum could provide an occasion for the Court to frame a process on its own — something the Government, quite rightly, wants to avoid. There is no doubt an independent body doing the selection will enhance the ECI's independence, but the Court will have to decide if it wants to spell out its composition or leave it to Parliament.

Justice K.M. Joseph, heading the Bench, has noted that Chief Election Commissioners (CEC) in the past had fairly long tenures, unlike in recent times. However, it should be remembered that since 1993, the ECI has become a multi-member body, comprising a CEC (chairman) and two Election Commissioners (EC). The current convention is to appoint ECs, and elevate them as CEC on the basis of seniority. In effect, it is the appointment process for ECs that requires scrutiny as it is here that there is scope for personal whimsy to play a role. The CEC has a six-year tenure, but should demit office on attaining 65. The Court has questioned the practice of appointing CECs close to that age so that they have only a brief tenure. However, it may be argued that even Chief Justices have brief tenures, but that does not undermine their independence. The Government has contended that a member's whole tenure in the ECI should be considered, and not merely the duration as CEC. The real difference is security of tenure that could come from operational freedom and space. While Supreme Court judges have security of tenure they can be removed only by impeachment by Parliament — only the CEC enjoys the same status. The ECs can be removed on the CEC's recommendation. There is a good case for extending the same tenure security to the ECs too, regardless of what kind of appointment process is in place.

## Supreme Court seeks govt response on including same-sex marriage under Special Marriage Act

New Delhi, Nov. 25: The Supreme Court on Friday sought the government's response to pleas to allow solemnisation of same-sex marriage under the Special Marriage Act.

The Special Marriage Act of 1954 provides a civil form of marriage for couples who cannot marry under their personal law.

A Bench of Chief Justice of India D.Y. Chandrachud and Justice Hima Kohli agreed to hear partners Supriyo @ Supriya Chakraborty and Abhay Dang, who said the non-recognition of same sex marriage amounted to discrimination that struck at the root of dignity and selffulfillment of LGBTQ+ couples. A separate petition was also filed by Parth Phiroze Mehrotra and Uday Raj Anand.

The Bench issued separate notices to the Union of India and the Attorney General of India and listed the case for hearing after four weeks. It transferred various pending issues before various High Courts, including in Kerala and Delhi, to itself. The government too had said in the High Courts that the issue should be taken up by the apex court.

Senior advocates Mukul Rohatgi, Neeraj Kishan Kaul, Menaka Guruswamy and advocate Arundhati Katju argued that this was a sequel to the 2018 Constitution Bench judgment in the Navtej Johan case in which homosexuality was de-criminalised.

"A plethora of living issues arise out of this case... Your Lordships have also upheld privacy as a constitutional right in the Puttaswamy case," Mr. Rohatgi submitted.

The petitioners said the 1954 Act should grant same sex couple the same protection it allowed inter-caste and interfaith couples who want to marry.

Mr. Rohatgi said the petition did not touch on the personal laws but only sought to make the 1954 Act gender-neutral. "The Act only says marriage



should be between 'two persons'. It does not say it is a union of A and B," Mr. Rohatgi submitted.

Mr. Kaul said there were about 15 legislations which guaranteed the rights of wages, gratuity, adoption, surrogacy, etc, which was not available to the LGBTQ+

Ms. Guruswamy said the fundamental issue here is "how do I protect my family".

"The Act is ultra vires the Constitution to the extent it discriminates between samesex couples and opposite sex couples, denying same-sex couples both legal rights as well as the social recognition and status that flows from marriage... The Special Marriage Act of 1954 ought to apply to a marriage between any two persons, regardless of their gender sexual identity and orientation," the petition

If not, the Act, in its present form, it said, should be declared violative of the fundamental rights to a dignified life and equality as "it does not provide for solemnisation of marriage between same sex couple". The petition was also represented by advocates Shristi Borthakur and Priya

Enough has not been done by just decriminalising homosexuality, equality must extend to all spheres of life, including the home, the workplace and public places,

for LGBTQ+ citizens who form 7% to 8% of the population of the country, it

"At the heart of personal liberty lies the freedom to choose who we are, to love whom we will, and to live a life that is true to our conscience, not only without the fear of persecution but in full-hearted joy and as equal citizens of this country. Despite being free to love each other, Supriyo and Abhay still cannot have a happy marriage filled with joy and recognition," the petitionsaid.

It said marriage brought with it a host of rights, privileges and obligations bestowed and protected by the

"They can adopt children or have children by surrogacy or ART. They have automatic rights to consortium, inheritance, maintenance and tax benefits. They are beneficiaries under a host of employment statutes. The state's protection to a spouse continues even after death in the form of pension or compassionate appointments," it argued. Marriage was key to social acceptance and respect.

The Supreme Court had decriminalised homosexuality in 2018, urging the LGBTQ+ community to forgive history for their "brutal" suppression.

The Pradhan assured the gathering that all the proposals made in the meeting would be included in the action plan for the year 2023-24 as well as in the draft plan for the next three years. Expressing gratitude toward the present Government officials, he hoped that together the panchayat would be able to redress the grievances of the common villagers and long pending demands would be fulfilled. 



## Alleged fixing in football matches: CBI seeks cooperation of Indian football clubs

**New Delhi, Nov. 25:** The CBI has registered a preliminary enquiry into alleged match fixing in football matches in the country, officials said Monday.

During the enquiry which started about 15 days back, the CBI has sought and collected documents from the Delhi-based All India Football Federation on several Indian football clubs, they said.

Under the scanner, is the role of an alleged match fixer based in Singapore in rigging the results of matches, they said.

The officials refused to give any details about the suspects named in the preliminary enquiry and details of allegations as it could hamper the probe which is at a nascent stage. They said the agency has received some documents while some are still awaited.



The agency has also sought cooperation of several Indian football clubs in joining the investigation, they said.

The CBI cannot conduct searches, arrests or question through summons under the preliminary enquiry, they said citing the law.

The central probe agency depends on cooperation of stakeholders during the preliminary enquiry and registers an FIR when it has prima facie material indicating a crime, they said.

## NZ Beat India by Seven Wickets in First ODI, Take 1-0 Lead in Series


