ORDER No. 546

WHEREAS, in exercise of the powers conferred under section 10 (2) (1) of the Disaster Management Act 2005, the Union Home Secretary and Chairman, National Executive Committee (NEC) directed vide order of Ministry of Home Affairs, dated 27th December 2021 to consider implementation of the normative framework, as per the advisory of MoHFW's conveyed vide D.O. letter No. Z.28015/318/21-EMR, dated 21st December, 2021 and to take necessary measures, under the relevant provisions of the DM Act, 2005.

AND WHEREAS, in exercise of the powers conferred under section 24 (1) of the Disaster Management Act 2005, the Chairperson, Union Territory Disaster Management Executive Committee, for the Union Territory of A&N Islands has directed vide Order No.91 dt. 31st December, 2021 to ensure compliance of Containment Measures for COVID-19 as well as increased detection of the Variant of Concern (VoC), 'Omicron', in different parts of this UT as per the advisory issued by the Ministry of Health and Family Welfare (MoHFW) dated 21st December, 2021 for ensuring strict compliance prescribing a normative framework for taking evidence based containment measures at district/local level for the whole of Andaman and Nicobar Islands and which shall remain in force up to 31st January, 2022.

NOW THEREFORE, in pursuance of powers vested u/s 51(b) of the Disaster Management Act, 2005 and in order to enforce strict compliance of the National Directives on COVID-19 in North and Middle Andaman District, the following fines are hereby prescribed for the violation of the National Directives on COVID-19 Management issued by the Ministry of Home Affairs: -

1.	Non-wearing of face cover in public places, work places and in public transport	Rs.1000/-
2.	Spitting in public & work places	Rs.600/-
3.	Violation of social distancing norms by individual (s) in public places and work places.	Rs.400/-
4.	Violation of social distancing norms by shop owners in their establishments	Rs.4000/-
5.	Violation of National Directives with respect to Marriage (gathering of more than 50 persons).	Rs.20,000/-
6.	Violation of National Directives with respect to Funeral/Last rites (gathering of more than 20 persons).	Rs.5000/-
7.	Consumption of liquor in public places	Rs.10000/-
8.	Consumption of paan, gutka, tobacco etc. in public places	Rs.600/-
9.	Overcrowding in shops/establishments	Rs.5000/-
10.	Overcrowding in taxi/auto	Rs.2000/-

All Sub-Divisional Magistrates, Executive Magistrates, Revenue officials of rank Patwari and above, Panchayat Secretaries of RD department, and police personnel of rank Constable and above are hereby authorised to impose and collect fines as mentioned above.

In case of non-payment of fine, the person shall be liable for action under section 188 of the Indian Penal Code (IPC) and relevant provisions of Disaster Management Act.

All fines shall be collected through TR-5 receipts and deposited to the respective SDM offices within two days of collection, which shall in turn be remitted into the Government account under *Major Head 0070-Other Receipts*.

A daily statement of the fines imposed and collected shall be submitted to this Office for information and record.

This order shall come into immediate effect and shall remain in force till further

orders.
