Public broadcasters of India, Egypt ink MoU for sharing TV, radio programmes

NEW DELHI, JAN 25 /--/ The public broadcasters of India and Egypt on Wednesday inked a memorandum of understanding (MoU) to facilitate sharing of content, coproduction and training of officials in latest technologies. The MoU was signed by Union information and broadcasting minister Anurag Singh Thakur and Egyptian foreign minister Sameh Hassan Shoukry in the presence of Prime Minister Narendra Modi and Egyptian President Abdel Fattah El-Sisi, who will be the chief guest at the Republic Day Parade. Under the MoU, Prasar Bharati, the public broadcaster of India, and the National Media Authority (NMA) of Egypt agreed to exchange programmes for television and radio. "The MoU is a general statement of intent, the specifics on content sharing will get worked out at a later date mutually," Prasar Bharati chief executive officer Gaurav Dwivedi said when asked about programmes that India would share with Egypt as part of the pact. "The MoU is part of the efforts by Prasar Bharati to expand the reach of DD India Channel to showcase the country's progress through programmes focussed on economy technology, social development and also the rich cultural heritage," an official statement said.

It said that both the broadcasters will exchange their programmes of different genres like sports, news, culture, entertainment for telecast on their respective radio and television platforms. "The MoU which will be valid for three years will also facilitate co-productions and training of the officials of both the broadcasters in the latest technologies, the statement said. Prasar Bharati has 39 MoUs with foreign broadcasters for cooperation and collaboration in the field of broadcasting that provide for exchange of programmes in the field of culture, education, science, entertainment,

EDarrests TMC spokesperson Saket Gokhale in PMLA case

Enforcement Directorate (ED) on Wednesday arrested Trinamool Congress (TMC) spokesperson Saket Gokhale in a money laundering case linked to alleged irregularities in a crowdfunding initiative in Gujarat, official sources said. Gokhale was taken into custody under criminal sections of the Prevention of Money Laundering Act (PMLA) in Ahmedabad where he is lodged in judicial custody in a Gujarat Police case. He will be produced by the federal agency before a local Ahmedabad court seeking his remand, the sources said. The state police arrested Gokhale from Delhi in December last year in a case of alleged misuse of money he had collected through crowdfunding. The Gujarat High Court had on Monday refused regular bail to Gokhale in this case as it asked him to approach the court

a sessions court and a magistrate's court in Ahmedabad denied him bail recently following his arrest and expiry of remand. Gokhale has been in judicial custody since January 5 and lodged at a jail in Ahmedabad. He was arrested by the Ahmedabad Cyber Crime Branch from Delhi on December 30, 2022, in this case. The police FIR was registered on a complaint filed by an Ahmedabad resident online mode. According to police, the case was not just about Rs 500 as Gokhale allegedly collected over Rs 70 lakh from more than 1,700 people through 'ourdemocracy' platform and used that money for personal use. "There was no element of forgery in funds collected by Gokhale through an online platform which is used by even political parties. He is innocent and made a scapegoat. He is a fulltime activist sustaining on donations received through crowdfunding. As soon as he joined TMC, he stopped accepting funds to prove his bonafide," Gokhale's lawyer had told the court. In December, the Gujarat Police arrested him twice for allegedly spreading fake news regarding the cost incurred on Prime Minister Narendra Modi's visit to

NEW DELHI, JAN 25 /--/ Delhi chief minister Arvind Kejriwal on Wednesday alleged that several states in the country are being harassed by Centre-appointed governors and LGs, who have been doing it by obstructing the elected government's work, even as he wondered whether a "dark shadow" was being cast over democracy. "On the 74th Republic day, we need to ponder how to save democracy from these Laat Sahibs(governors/LGs)," Kejriwal said at a Republic Day function here organised by the Delhi government. The AAP supremo also referred to alleged "tussle" of the Centre with the judiciary, state governments, as well as farmers and traders, and called for an end to such fights so that India could become the "number one" country in the world. "These days, they are fighting with the



judiciary. What is the need to fight with judges? They are also fighting with the state governments, farmers and traders. If we work together and learn from each other, then nothing can stop India from becoming number one country in the world," the Delhi chief minister said. Citing his recent visit to Telangana, Kejriwal said that the government there has decided to provide free eye check up and follow up treatment to 4 crore people in the state.

"We will also do it in Delhi. There is no problem in the country whose solution has not been found in some states. The state governments need to learn from one another for finding solutions to the problems," he said. The AAP chief also urged the Centre to exempt food items from GST saying it will provide much needed relief to the people in the country. He said that 99 per cent traders in the country wanted to pay taxes, and called for the simplification of the entire GST regime. Remembering sacrifices of the freedom fighters, Kejriwal said: "State governments are being harassed these days. It was not for this that our freedom fighters made sacrifices. Is there a dark shadow looming over democracy in the country?" Governments elected by the people are supreme and no one is above them, he asserted, as he registered his objection to instances where vice chancellors appointed by the state government were allegedly rejected by governors. Highlighting the achievements of Delhi under the rule of AAP government, Kejriwal claimed that the city has left behind London, New York, Washington, Singapore in many fields including number of doctors, electric vehicles, per capita forest area, and education. 
Cong gave birth to 'illegal things and corruption' in country: Karnataka CM

BENGALURU, JAN 25 /--/ Karnataka chief minister Basavaraj Bommai on Wednesday said the Congress is the one that gave birth to "illegal things and corruption" in the country, as he hit out at the opposition party's police complaint against him and BJP leaders calling it "laughable and ignoble".

Alleging that Congress legislators were caught "red handed" in Kunigal in Tumakuru district recently distributing pressure cookers to voters and were fined by the Commercial Tax department, Bommai called it "pressure cooker party". The Congress today lodged a complaint with the police against BJP national president J P Nadda, state president Nalin Kumar Kateel, Bommai and MLA Ramesh Jarkiholi levelling allegations of offering bribes to woo voters in the ensuing Assembly polls in the

The complaint comes following an alleged announcement of Rs 6,000 per vote in the Assembly elections due in May by Gokak BJP MLA Jarkiholi. "This is an example of how low the Congress has reached. Those who made a statement will give a clarification for what they said. Congress party itself has announced that it will provide Rs 2,000 for every woman-led household, 200 units of free power, they are making announcements every day," Bommai said. Speaking to newspersons here, the chief minister said, if the same yardsticks are applied, the Congress too is guilty of alluring voters.

"Their (Congress) legislators, four to five of them, distributing cookers to voters with their photos on it have

been found with evidence in Kunigal. Commercial Tax officials have seized them and have fined four of them," he said. "With so much within they have stopped to such a low to create confusion among the people to do their politics". State Congress president D K Shivakumar, legislature party leader Siddaramaiah, who are signatories of the complaint, have requested the police to register a case and conduct an inquiry. Stating that the Congress has a guarantee that they will lose in the elections, so they are indulging in lodging complaint and other tactics, Bommai said, "police will look into it and let legal process follow, we are ready to face it." "If they give such complaints, hundred complaints can be filed against them (Congress), this is low level politics. Ultimately people will decide, it is the people's court," he said, adding that Congress is the one that gave birth to illegal things and corruption.

Further noting that Commercial Tax department officials have seized the cookers in Kunigal that were being distributed by four Congress legislators and fined them as there were no bills, the Chief Minister said, "such things have happened in other places too, we will get complete information on them and certainly get it investigated." Later speaking to reporters in Hirekerur, Bommai termed Congress' complaint based on Jarkiholi's statement as laughable and ignoble, and said, recently the Supreme Court has also said that if any individual makes a statement it cannot be attributed to his organisation or the government.

"For political reasons as they are guaranteed about their loss in the election, Congress is making false and politically motivated allegations to misguide the people. They will continue to make such attempts. People are aware of it. Everything will happen in accordance with

Pointing at cooker distribution by Congress MLAs, he called the grand old party a "pressure cooker party", and said: "they have love for pressure cooker, even if a bomb was placed inside it, they will say that there was nothing (directing to Shivakumar's statement on Mangaluru cooker blast case).

Reacting to Shivakumar calling him "Brashtacharada Pitamaha" (father of corruption), the chief minister said: "the first corruption scandal in this country was from Congress. Congress began corruption in this country and corruption is its integral part". "What should I say about Shivakumar, he is probably the cleanest person in politics," Bommai said sarcastically." THIRUVANANTHAPURAM/ NEW DELHI, JAN 25 /--/ Veteran Congress leader and former defence minister A K Antony's son, Anil, on Wednesday resigned from all his posts in the party following "intolerant calls" and "abuses" over his tweet against the controversial BBC documentary -- 'India: The Modi Question' -- on the 2002 Gujarat riots.

While announcing his resignation from the posts in KPCC Digital Media and AICC Social Media and Digital Communications Cell. Anil Antony said he has not given up the primary membership of the party as he would like to remain as a Congressmanfornow."Atthis moment, politics is not my priority. I am a computer professional who has worked in various cyber digital segments for a long time and want to continue with that. I think that will be appropriate at this point of time for the party and my interests," Anil told PTI in New Delhi. On being asked about the reasons for quitting from the various party positions. Anil said he had joined Congress in 2017 when the Gujarat elections were being held and from 2019 onwards was working for the party following a request by Shashi Tharoor and his support.But since then, there have been several incidents of planted stories and cyber bullying against him, Anil said.Back then, he had ignored it, despite knowing that it came from a certain section of the Congress, but what happened in the last 24 hours -- after his tweet -- was "shocking",theformerUnion minister's son added. "If this is the culture that has been created in the party, then I do not think I will be able to work in such environment," Anil said, and added.thatthiswasthereason why he decided to resign. Regarding his tweet, which led to "intolerant calls" to retract the same and the "wall of hate/abuses" on Facebook against him, Anil clarified that he only intended to caution people against believing what was said in thedocumentaryinthelarger interest of national security.

Congressman claimed that what he had meant was that he has a lot of political disagreements with the BJP but when it comes to the core interest of the nation, its sovereignty, "there we should not play politics as it is like playing with fire". ExpressinghisviewsonBBC, he said: "This is the same set

Kerala HC suspends conviction, sentence of former Lakshadweep MP in attempt to murder case KOCHI, JAN 25 /--/ The

Kerala High Court on Wednesday suspended the conviction of former Lakshadweep Mohammed Faizal, saying that not doing so would result in fresh elections for his vacant seat which would impose an immense financial burden on the government and the public. In the judgement which could annul the disqualification of Faizal as an MP, the High Court said the consequence of not suspending the conviction of the accused Faizal "is drastic not only for him (Faizal) but even for the nation." The High Court said while purity in politics was

decriminalisation of politics wasanessentialrequirement of every democracy, "those lofty principles cannot be the reason for denying the application of the principles of rule of law." "The societal interest in averting an expensive election that too, when the elected candidate can continue for a limited period alone if the fresh election is conducted, cannot be brushed aside by this court. The societal interest and the need to have purity in politics and elections will have to be balanced," the court said. Faizalstooddisqualifiedfrom the membership of Lok Sabha from January 11, the date of his conviction by a sessions court in Kavaratti, according to a notification issued on January 13 by the Lok Sabha Secretariat. The decision of the High Court is likely to affect the by-poll scheduled Lakshadweep Lok Sabha constituency. It said the next general polls to the Parliamentary constituencies is scheduled to be held in year 2024 and if the election for the constituency of Lakshadweep is to be held immediately on account of the conviction and consequent disqualification of Faizal, "the financial burden on the government and indirectly on the people is immense". SC refuses to entertain plea for setting up Himachal HC bench at Dharamshala

Supreme Court Wednesday refused to entertain a plea of an advocates' body seeking setting up of a circuit bench of the Himachal Pradesh High Court in Dharamshala.

A bench of Chief Justice DY Chandrachud and Justices PS Narasimha and JB Pardiwala, however, permitted the Kangra District Bar Association to take up the issue with the chief justice of the Himachal Pradesh High Court for providing videoconferencing facilities to save lawyers and litigants the hassles of travelling all the way to Shimla for attending the proceedings.

The apex court said it cannot direct the high court to set up a bench at Dharamshala. advocates' body argued against a concentration of all the circuit benches of the high court in a few areas. If travelling is an issue, then facilities may be sought, the bench said.

'The decision has been taken to set up additional courts to facilitate the convenience of litigants. Moreover, a direction for establishment of a bench for High Court cannot be entertained in an Article 32 (writ jurisdiction of the apex court) petition. Therefore, we find no merit in the petition. The petition is dismissed," the order said.

During the hearing, the CJI lauded the efforts undertaken by Himachal Pradesh HC Chief Justice S Muralidhar for establishing conferencing video facilities in every district of the state. "He (Justice Muralidhar) decentralised the system

and now there are benches in each district of the state. So, any district lawyer can appear through video conferencing in the High Court," the CJI said. (PTI)

Rising prices, food insecurity add to pangs of hunger

The latest report of the Food and Agricultural Organisation (FAO) and certain other United Nations agencies says that food insecurity rises with higher prices and worsening poverty. As a result of this, growing numbers of people in Asia lack enough to eat. Nearly a half-billion people more than eight in 10 of them in South Asia -- were undernourished in 2021 and more than 1 billion faced moderate to severe food insecurity. For the world, prevalence of food insecurity rose to more than 29 per cent in 2021 from 21 per cent in 2014. The COVID-19 pandemic was a huge setback, causing mass job losses and disruptions, and the war in Ukraine has pushed up prices for food, energy and fertiliser, putting an adequate diet out of the reach of many millions. The report is the fifth annual stocktaking on food insecurity and hunger by UN agencies including the FAO, UNICEF, World Health Organisation and World Food Programme.

Over those years, progress toward alleviating hunger and malnutrition has stalled and then backslid as growing numbers of people lost the wherewithal to get enough to eat. The prevalence of undernourishment as measured by the UN agencies was 9.1 per cent in 2021, better than the 14.3 per cent in 2000 but up slightly from 2020. Such figures show that the slowdown in the fight against hunger continues. The report also highlights the growing food insecurity faced by people who have moved to cities, where they have less easy access to affordable food. Reforming our agrifood systems to produce nutritious food and ensure equitable access to healthy diets is critical.

The FAO's Food Price Index has risen in the past several years, hitting a record in March 2022. It fell back as commodity prices declined somewhat later in the year but is still 28 per cent above the 2020 level. The Asia-Pacific region imports nearly USD 2 trillion of food a year. Rising prices for basics like rice, wheat and oil hit the poor the hardest. It's part of what the UN agencies call the "5F" crisis of not enough food, feed, fertiliser, fuel and financing. The conflict in Ukraine has dealt a heavy blow in many countries that depended on the region for wheat, edible oils and fertilisers. Nearly 2 billion people, accounting for almost 45 per cent of people living in Asia, cannot afford healthy diets, contributing to problems with anemia and obesity as well as hunger. Poverty already had risen by 2.6 per cent between 2015-2018, according to World Bank data. An increase in poverty and in undernourishment would go together as unhealthy diets and inadequate food are also compromising future health and productivity, as they cause children to suffer from stunting or wasting and make them more susceptible to illness. The report says nearly a quarter of children in the Asia-Pacific are affected by stunting, or small height for their ages.

Kerala BJP putting a premium on inefficiency

The Bharatiya Janata Party (BJP) has signalled its intent to put up a better show in Kerala the 2024 Lok Sabha elections. But the strategy it has formulated to achieve the goal is flawed in the extreme.

The main reason why the strategy would come a cropper is that the central leadership has decided to retain the present team in the State. The grim reality is that the team led by BJP state president K. Surendran is in no position to bail out the party. It has proved, time and again, incapable of measuring up to the challenges the BJP faces in a secular stated like Kerala. It was a golden opportunity for the central leadership of the party to go in for a thorough shakeup, and put in place a new team capable of putting up a better fight. But, for reasons known only to the central leaders, the party has decided to persist with the Surendran team. The strategy, amounts to putting a premium on inefficiency, favouritism and groupism which has been the party's bane in the state. Is it because the top leadership has reconciled to the reality that the BJP is unlikely to give a better account of itself in the 2024 parliamentary poll battle?

A close look at the poor performance of the Surendran team in the recent past. The Surendranteam, has the dubious distinction of putting up the worst show to-date in the electoral battles in the State. The statistics mentioned below are self-explanatory. The vote share of the BJP and its allies in the 2011 assembly polls was 6.03 per cent. It increased to 10.81 in the 2014 Lok Sabha elections. Then it registered a big rise to 14.96 per cent in the previous assembly election and then to an all-time high of 15.54 per cent in the 2019 Lok Sabha polls. However, in the local body polls held last year, the percentage dip0ped slightly to 15.02 per cent. In the 2021 assembly election, the BJP's a own vote share was 11.33 per cent. The National Democratic Alliance (NDA), led by the BJP had a provisional vote share of 12.4 per cent. A steep fall from the 15.54 per cent it registered in 2019 parliamentary poll battle. This, needless to say, was a major setback for the party, which was hoping to touch the 20 per cent vote share in 2021. The humiliation was complete with the party suffering a whopping 12 per cent erosion of votes in its stronghold

Nemom in Thiruvananthapuram district. In the 2021 assembly poll, the party lost its lone seat, Nemom in the assembly. Expectations were high in the wake of the pathetic performance in 2021, that there would be a change of guard in the State. Nothing of the sort happened. In the meantime, the BJP's relations with its only major ally, the BDJS also came under severe strain. One of the reasons for the BJP's poor show in 2021 was the resentment in the BDJS over the shabby treatment the BJP leadership meted out to it. While the party suffered vote erosion in as many as 90 constituencies, it increased the share only in Palakkad, Attingal, Chattanur and Alampuzha. Heads should have rolled. But the Surendran team survived and has now managed to get another lease

The BJP has also altered its strategy by deciding to concentrate on all the 20 Lok Sabha constituencies in the State. This is a radical departure from its past tactic of focusing on only its strongholds like Palakkad, Thrissur, Attingal, Kasaragod and Thiruvananthapuram. The change in strategy is unlikely to benefit the party. The reason is simple: Nothing has happened in the state to warrant a massive shift in favour of the BJP. The time-tested tactic of religious polarization which fetched rich rewards for the BJP in states like Uttar Pradesh, Gujarat, Madhya Pradesh and Bihar, has proved to be a counterfeit coin in Kerala's strongly secular soil.

In a development that bodes ill for the party in Kerala, the decision to retain the Surendran team for the Lok Sabha poll battle has created resentment in the state unit. The dissidents, led by former BJP state boss P K Krishna Das have not made secret of their displeasure over the central leaderships' decision to persist with the team that dismally failed in the past. Their hopes that there would be an attempt to ensure unity in the party have been dashed to the ground. Despite proddings of the central leaders, the state BJP has failed to take the rebels into confidence and work as a united team. The results of this negative tactics are there for all to see. The Krishnadas group has, reports say, moved the 'high command' in protest against the move to retain the Surendran team. Senior leaders like general secretaries MT Ramesh and AN Radhakrishnan are said to be a sullen mood. Surendran has also antagonized and marginalized the only strong woman leader and the party's firebrand, Sobha Surendran. Such is the hostility against Sobha, who is the vice-president of the BJP in Kerala, that she was not included in the core committee, the party's highest decision-making body in the state. This being the murky backdrop, the central leaders' hopes of winning at least 5 seats from the state are unlikely to be realized. It is not as if the BJP lacks good leaders. The party has in its ranks leaders who have a clean image like Kummanam Rajasekharan, a former BJP state chief, and superstar Suresh Gopi. The latter is very close to Prime Minister Narendra Modi. If the BJP seriously wants to ensure a better performance then a leader like Suresh Gopi should be made the party's state boss. True, Suresh lost the last Lok Sabha election from Thrissur. But he was able to increase the party's vote share in a big way. He is one of the few leaders whose appeal goes beyond the BJP's core Hindu constituency.

Last but not least, unless the BJP changes its strategy and reinvent itself, its prospects in Kerala in the 2024 parliamentary polls are bleak indeed. The party's determined efforts to woo the Christian voters has not produced the desired results. Even if it manages to secure a slice of the Christian vote, the party is not likely to emerge stronger in the State. For that to happen, the BJP has to build bridges of understanding with the Muslims in the State. The BJP leadership has shown no signs of intending to do anything of that sort. Demonisation of the Muslim community, which has been the party's staple food, won't do in a state like Kerala where the secular ethos which is deeply embedded in Keralites' psyche. Hate politics won't work in secular Kerala. The earlier the BJP realizes this, the better for the party. (IPA)



Law Minister fighting RSS battle against independent Judiciary

The compulsion to protect the image and personal interest of Prime Minister Narendra Modi is so domineering that his ministerial colleagues can go to the extent of retreating from their avowed ideological line and embrace their sworn enemies. The Law minister Kiren Rijiju who till a couple of days back left no occasion to decry and debase the Supreme Court, only on Sunday eulogized its illustrious status by asserting that Supreme Court was above any organisation.

Rijiju for last six months has been acting like the vanguard of Modi government and RSS to demolish and shred the prestige and image of the Supreme Court made this remark only for the simple reason that that last year it had upheld the clearance given to Modi by a special investigation team in Gujarat riot conspiracy case. Three days back the BBC released a documentary in UK which referred to Modi's role as chief minister in the Gujarat pogrom of 2002 in which around 2000 Muslims were killed by the

Just after release of the clip, Modi government denounced it, but the assertion of the former British Foreign Secretary Jack Straw in an interview with a web portal that the British government conducted an investigation of its own because many citizens of Gujarati Muslim origin were worried about their loved ones in and "were making representations" to that effect to the then Tony Blair government, put Modi literally in a vulnerable situation and had to block clips of the documentary. No doubt a big number of people were

reluctant to believe the government explanation and even shared the information contained in the documentary. This has in fact enraged Rijiju and he was forced to tweet; "Some people in India have still not moved away from the colonial influence. They consider BBC to be above India's highest court and pull down the country's prestige and image to any extent to please their ideological masters". Rijiju had to take the help of

clean chit by the apex court to get rid of

the BBC documentary allegations. Before using the statement of Justice Sodhi, the government had also mentioned the observation of the retired former Supreme Court Justice Ruma Pal. She had some reservation about the functioning of Supreme Court. Even on Sunday, the day Rijijueulogised Supreme Court, he had said "the majority of the people had 'sane views' similar to the one expressed by a retired High Court judge, who said the Supreme Court had 'hijacked' the Constitution by deciding to appoint

judges by itself". Rijiju is reluctant to accept the views of the collegium, having at least three judges, but he is too eager to use the statement of the retired judge. Through his tirade against judiciary he has succeeded in giving the impression to the "common people" of the country that he is a well versed person. Naturally one expects that he would agree to the

fact that Sodhi is one of the judges amongst thousands of retired judges. If Rijiju can accept the suggestion of a lone 'sane' then why is not willing to agree to the suggestions of other judges. Are they according to him are

The way the Modi government has been refusing to approve the names forwarded to it for being appointed as judges either at the Supreme Court or High Courts makes it clear that it intends to enter into confrontation with it just ahead of 2024 LokSabha election. Consistent harping on the issue by Rijiju underlines that they are going to make it a big issue just ahead of the election.

Last week, the Supreme Court collegium had for the second time reiterated the names of two advocates for appointment as judges of the Calcutta High Court "expeditiously", saying it was not open for the government to repeatedly send back the same proposal.

It deserves appreciation for refusing to bow down. The three-member collegium, which makes recommendations for High Court appointments, has reiterated its decision to elevate lawyers Saurabh Kirpal to the Delhi High Court, R. John Sathyan to the Madras High Court and Somasekhar Sundaresan to the Bombay High Court. Government's argument has been most ridiculous.

While it has objected to one of the candidate's sexual orientation, about another his political loyalty has been questioned. In fact the collegium has pointed out, neither the sexual orientation of Mr. Kirpal nor the airing of political views by the other advocate will impinge on their suitability or integrity. The other candidate had made some comments on Modi. The Modi government has taken it seriously and does not intend to appoint a person as judge who is opposed to him.

A question is making round the legal circle; what does the law minister's suggestion mean? Rijiju simply desires for s subservient judiciary too willing to prostrate before the office of the prime minister. But Rijiju ought to not forget that Modi government one day eventually has to bow out of office making space for the new incumbent. The new government may use the subservient judiciary against the BJP leaders who are in power now. It is not that these leaders are pure and pious. Almost all, from top to bottom, have cases against them. In case the new government decided to take revenge, then that backdrop the country will not have an independent judiciary to deliver the right and correct judgement.

Instead of curtailing the rights of the judiciary and forcing it to follow Modi government's diktat, Rijiju must adopt a democratic and pragmatic approach keeping an eye on the future. He must also keep in mind that saffronisation of the judiciary is only possible in the situation when the nation becomes a Hindu Rashtra, which does not appear to be a possibility in near future. (IPA)

The battle of Imphal deserves special mention in the army anals probably as a new epoch of world history. The north east battles are of even extremely deeper significances with regard to historical development of the country's movement of independence. The Azad

Hind Fouj (INA) joined the battle of Imphal mainly to set aflame a country wide armed revolution for the overthrow of foreign rulers. Japan and Germany had great contributions in the battle of Independence. It was in Germany (April 41 – –Feb' 43) that India $association \, gave \, Subhas \, Bose \,$ the title 'Netaji' and a resolution was also passed to make 'Jana Gana Mono' as national anthem of free India, even though on 27th October, 1926, in a large gathering, Rabindranath recited the poem 'Jana Gana Mono' in Budapest, the capital of Hungry. Before reciting , the organizers

announced that this is the national song of India. As soon as the poet started reciting the poem, all the dignitaries and attending public showed their honour by way of standing till the end of the recitation. The song was also greatly appreciated in United Nations at New York where it was first played in an orchestralarrangementlater. On 4th July, 1943 Rash Behari Bose handed over the of Azad Hind Fouj to Netaji

entire administrative set up including his own army. Netaji desired that the first blow of attack for the independence of India should be struck by Azad Hind Fouj and they should be the first to step on the liberated soil of Manipur and not the Japanese. To guard against Japanese and any kind of occupation in India, an agreement was made that after operation in Manipur only Azad Hind Fouj will go forward inside India and Japan will stop any advance of the Japanese army. destruction of major part of Japanese air force. The Japanese army was finding it difficult to stop the American Navy, moving further towards their westernpacific possession. They observed that they lost their great air superiority. And it was that stage The Azad Hind Fouj, 1st Division was called up hurriedly. This Division of INA was not supposed to take part in offensive operation in Imphal and Kohima at that time. It was only when Japanese planfailed; the INA Division was hurriedly thrown into the battle. The INA 1st Division lightly armed and were not supposed to attack British Defense position. This task was required to be entrusted to regular army which possessed heavier weapons viz, tanks and other

sophisticated equipment.

The Subhas brigade of $Azad\,Hind\,Fouj\,had\,to\,march$ over three thousand miles on foot to reach the forward base Kohima defeating British army in different places and thereby creating great surprise to British General (Azad Hind Fouj and Netaji, Shah Nawaz Khan). The 2nd Gandhi Regiment marches for over hundred miles and the 3rd Regiment, under Lt Col. Gulzara Singh marched from Yeu to Mintha covering a distance of more than 250 miles. The INA Soldiers were not having warm cloth or even required boot covering for the foot in case of large number of soldiers and others were having worn-out shoes only. There were large number of casualties through diseases and heavy air attack by British air force during their long march. There were no transports. They were full of spirit and joy and all they seemed to carry were large cotton bags filled with rice and salt containing 20 days ration, slung over their left shoulder and a fully packed haversack on their back having a total weight of more than 45 kgs. They carried their own rifles and ammunitions. They crossed several miles covered with deep forest where there were no road communication. Falling to carry more than 45 kgs of weight for long, INA had to

proved disastrous 'resulting leave there heavy machine guns and mortars behind as per direction. New India: Shedding the Vestiges of Colonial Past

n August 15, 2022, while addressing the nation from the ramparts of the Red Fort on India's 76th Independence Day, Prime Minister Narendra Modi talked about the 'PanchPraan' for the coming 25 years (AmritKaal). Elaborating on the second Praan, he said, "In no part of our existence, not even in the deepest corners of our mind or habits should there be any ounce of slavery. It should be nipped there itself. We have to liberate ourselves from the slavery mind set which is visible in innumerable things within and around us. This is our second Praan

The history of modern India is deeply entangled with two centuries of British colonialism, and decades after Independence, our nation has continued to carry its colonial baggage in various forms, some conspicuous, and some subtle. Over the past few years, the Government has slowly been steering India away from these vestiges of British rule, and a number of steps have been taken across several domains to firmly mark the identity of New India, truly freeing it from its colonial past.

• Construction of National War Memorial (NWM) and merger of flames of Amar JawanJyoti and

Constructed by the British to commemorate soldiers who lost their lives fighting for the British in World War I, the India Gate (earlier known as the All India War Memorial) is a symbol of India's colonial past. To mark India's victory over Pakistan in the 1971 War, the Amar Jawan Jyoti was subsequently added at the above location as an ad-hoc arrangement, as the country did not have another memorial for Indian soldiers killed in

wars. The National War Memorial, as a symbol of Independent India, was inaugurated and dedicated to the Nation by Prime Minister NarendraModi on February 25, 2019. It houses the names of all Indian martyrs from all the wars, including 1971 and wars before and after it. The NWM is thus a memorial for all soldiers who have either laid down their lives or will do so in the future in the service of independent India. Since its inauguration, all homage and remembrance ceremonies are being conducted only at the NWM, including those on National Days. In the presence of a National War Memorial, it was therefore considered appropriate to shift the eternal flame to this new location as it is an appropriate tribute to have the flame stand in honour of all brave hearts.

Andaman and Nicobar Islands Renamed

On December 30, 2018, marking the 75th anniversary of the hoisting of Tricolour on Indian soil by NetajiSubhas Chandra Bose, Prime Minister NarendraModi announced that Ross Island would be renamed NetajiSubhas Chandra Bose Dweep; Neil Island would be known as ShaheedDweep; and Havelock Island would be renamed as SwarajDweep. These islands had been named after the British rulers even in independent India. The Government erased these signs of slavery by giving them Indian names and Indian identity.

Railway Budget merged with annual Union Budget:

In yet another departure from British era practices, the Government merged the Rail Budget with the Union Budget from budget year 2017-18. The Railway Finances had been separated from General Finances in 1924 following the recommendations of the Acworth Committee (1920-21).

Revival of literary works banned

during British rule: During India's struggle for Independence, many revolutionary pieces of literature were banned by the British Government, as these were considered 'dangerous' to the 'security' of their rule in India. This body of literature aimed at arousing patriotic feelings in the minds of the people and invoking them to rise up to free India. As part of the AzadikaAmritMahotsav celebrations, the Government has identified poems, writings and publications that the British Raj banned and put them together as a catalogue published by the National Archives of India. These unique collections, representing the feelings, aspirations and resolves of our freedom fighters, are available in various Indian languages.

Other Initiatives taken to Remove Colonial Vestiges:

**The Government has renamed certain key roads whose original names were iconic to the British era.

*The Race Course Road in Lutyen's Delhi was renamed to LokKalyanMarg in 2016. Prime Minister's famous residential address 7, Race Course Road thus became 7, LokKalyan Marg. **In 2017, Dalhousie Road was

renamed DaraShikoh Road.

*In 2019, Finance Minister NirmalaSitharaman broke away from a long-standing colonial era practice

when she opted for the traditional Indian 'BahiKhata' rather than the briefcase while presenting the Union Budget. The time and date of the presentation of the Indian Budget, which was following the times of the British Parliament for so many decades, have also been changed.

*The youth of the country are being liberated from the compulsion of learning in foreign language through the National Education Policy, which lays stress on education in the mother tongue.

*In the last eight years, the Government has repealed more than 1,50 archaic laws, most of which were remnants of the colonial British era. "In this AzadiKaAmritKaal, new laws should be made by abolishing the laws which have been going on from the time of slavery," Prime Minister NarendraModi has highlighted.

India has entered a decisive phase and is marching ahead rapidly towards a future marked by confidence and Aatmanirbharta. Freeing the country from the shackles of its colonial past will further secure the foundation of its sovereign identity as envisioned by the Constitution, and propel the nation forward with greater vigour as it charts

abindranath Tagore was not just a poet but someone ahead of his time. At the time of independence India did not have a national anthem. The song 'BharotoBhagyoBidhata', composed in 1911 by Tagore was renamed as 'Jan Gan Man.' It was adopted by the Constituent Assembly of India as the national anthem on January 24, 1950.

Nobel laureate Rabindranath Tagore used it exactly for that reason to protest against the decision of the British Indian government to divide the then Bengal. Tagore, possibly the greatest Bengali personality in the modern era, transgressed religious and cultural divides with the help of rakhi and engineered a movement that pushed the British administration to the backfoot and left them completely dumbfounded. The British officials stated that the huge size of the region made the task of effective management very arduous, and that is why the region was neglected. So, they decided to carve up the Bengal Presidency into separate regions. The Congress, during the months before the partition was to be effected, petitioned that the division should be done based on language, but Lord Curzon, the Viceroy of

India, thought otherwise. The decision was announced on July 19, 1905, by Lord Curzon, and was implemented on October 16, 1905. A new region with the majority Muslim population was created, with the capital at Dhaka, and it created communal tension in the society. Following JallianwalaBagh massacre (13th April 1919) Rabindranath Tagore surrendered his title of Knighthood. Tagore viewed the British as a symptom of overall sickness of the social disease of the public.

Rabindranath Tagore got Knighthood from King George-V in 1915. Later in 1919, he renounced knighthood for the inhuman act of British in JallianwalaBagh. Due to same reason Gandhi returned the Kaiser-i-Hind Gold medal given to him by British government for his work during Boer war. .Many people are aware that Tagore wrote 2 national anthems. "Jana GanaMana" for India and "Amar Sonar Bangla" for Bangladesh. What many people don't know is that he also inspired the Sri Lankan national anthem "Sri Lanka Matha". Some even hold a view that Tagore composed the anthem in its entirety. Tagore had a great bond with Mahatma Gandhi. He referred to him as the "Mahatma" by 1915 and Gandhi also addressed Tagore as "Gurudev". While highly supportive of each other, they had public differences on fundamental political

and social issues. They were unsparing in debate, captured often in the pages of publications like Modern India and Harijan.Rabindranath expressed his vision of swaraj in a famous song which roughly translated goes as, "We are all kings in the kingdom of our king". If everyone was sovereign, there was no necessity for a king. Gandhi approximated to the same idea through his vision of "enlightened anarchy". We do not know when Mohandas K. Gandhi first heard Rabindranath Tagore's song "Jibanojakhonosukaayejaay" (1910). But we do know, on the testimony of his secretary and alter ego, Mahadev Desai, that it was one of Gandhi's "favourite songs". Its opening lines reproduced above, as translated by the poet, may well be the reason why it was so. Gandhi had a way of capturing songs, making them part of his mind's music repertory, so that quite a few songs have come to be known as being 'one of his favourite songs'. Tagore's "Eklachalo re" (1905) has, of course, come to be even more closely associated with Gandhi than 'Jibanojakhono". Indistinguishable from his 'lonely pilgrimage' in riot-engulfed East Bengal in 1946, "Eklachalo" has become twin to another extraordinary work of art from Bengal — Nandalal Bose's black and white linocut of the "Dandi Gandhi" (April 12, 1930).

From fledgling republic to presidency of G-20: India's long journey of 73 years

rom a fledgling republic newly independent from the yoke of a colonial rule to the presidency of the G 20 group of nations, India has travelled a long distance between 1950 and 2023. Seventy-three years down the line, India is among the fastest growing nations in the world; overcoming the setback of two years for the pandemic which many other nations have failed to do. In 2022-23, India's gross domestic product grew at seven percent, as against three percent in case of China in the same year. The world can no longer ignore the presence of India. Already the largest democracy in the world, India is now set to emerge as the most populated nation too; overtaking China in terms of population size.

From the immediate neighbourhood to the region, and now the influence of India has spread across the globe. India has always played a leading role in its immediate neighborhood in south Asia; and now more so as a member of South Asian Association of Regional Cooperation. As a member of Association of SouthEast Asian Nations, India has played an important role in the economic and social life in south-east Asia. As a responsible member of the fournation Quadrilateral Alliance, India is now taking a leading role in ensuring a free and open Indo-Pacific; the other members of the alliance being Japan, Australia and the USA. Even the growing might of India's blue water navy has been recognized by the most powerful nations in the world; as evident by the Malabar Exercises in which the U.S. and the Indian navies have been participating since 1992. Now with Japan

_ and Australia joining the annual naval exercise, the four-member alliance has emerged as a powerful grouping whose interests other countries can ignore only at their own peril. Being the champion of the non-alignment movement Independence, India has always played an important role in the other end of the global spectrum as well. International groupings like BRICS, of which the other members are Brazil, Russia, China and South Africa, and the Shanghai Cooperation Organization, which, too, have China and Russia as members, have found it prudent to have India on board. Founded in 1999, G20 has been billed as the premium forum for international economic cooperation. Its members, from the USA, the U.K. and the European Union at one end to Russia and China at the other, represent around 85 percent of the global GDP, over 75 percent of the global trade and about two-thirds of the world population. India' presidency of G20 has special significance for this premium forum as India will play an important role in finding pragmatic solutions to global problems as issues in the spirit of democracy and multilateralism,

values to which it is deeply committed. Significantly, India has assumed the presidency of G20 when the twin dangers of pandemic and climate change are threatening the very existence of mankind. Arresting climate change will be a key priority of the G20 nations during India's tenure as the president of the grouping. The focus of India's efforts in the coming months will be climate finance and technology, as well as a just transition to clean energy for the developing nations across the world.




