Parliament passes Bharatiya Nyaya Sanhita, Bharatiya Nagarik Suraksha Sanhita and Bharatiya Sakshya Bill

New Delhi, Dec. 21 Parliament has passed the Bharatiya Nyaya (Second) Sanhita, 2023, the Bharatiya Nagarik Suraksha (Second) Sanhita, 2023 and the Bharatiya Sakshya (Second) Bill, 2023, with the Rajya Sabha approving them today. Lok Sabha has already passed the Bills. The Bharatiya Nyaya (Second) Sanhita, 2023 will replace the Indian Penal Code (IPC), 1860, which is the principal law on criminal offences in the country. The new bill adds community service as a form of punishment. The Bharatiya Nagarik Suraksha (Second) Sanhita, 2023 seeks to replace the Criminal Procedure Code, 1973 (CrPC). The CrPC provides for the procedure for arrest, prosecution, and bail. The Bharatiya Sakshya (Second) Bill, 2023 replaces the Indian Evidence Act, 1872. The Act governs the admissibility of evidence in Indian Courts. It applies to all civil and criminal proceedings. The provisions have been made in these legislations to digitize the entire process from FIR to case diary, case diary to charge sheet, and charge sheet to judgment.

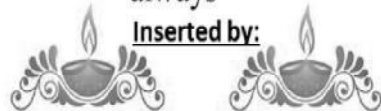

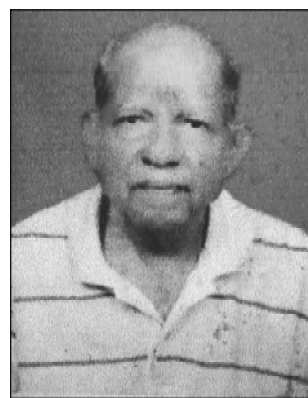
