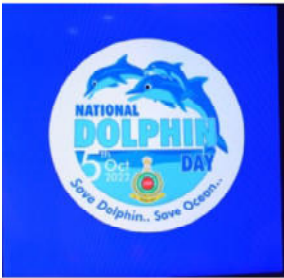

A&N Islands celebrates 1st National Dolphin Day

Chief Secretary releases Special Postal Cover on Narcondam Hornbill & Special Cancellation Stamp on Dolphin

All stakeholders should contribute towards conserving forests & natural resources including wildlife: Chief Secretary



Port Blair, Oct. 5

The first National Dolphin Day was celebrated across Andaman & Nicobar Islands today. Various awareness activities were conducted by the Department of Environment & Forests for conservation of Dolphins and other marine wildlife species on this day. The Government of India has decided to celebrate 5th October as National Dolphin Day to generate mass awareness towards this important wildlife, which is an indicator species of the health of the aquatic or marine ecosystem. To mark the occasion, a formal function was held at Secretariat today in which the Chief Secretary, A&N Islands, Shri Keshav Chandra, IAS graced the occasion as the chief guest.

During the programme, a Special Postal Cover on Narcondam Hornbill, which also carries a Special Cancellation Stamp on Dolphin was released by the Chief Secretary. Shri Anil Kumar, IPS, Post Master General (West Bengal Circle) was present as the guest of honour. Dr. R.S.C. Jayaraj, IFS, PCCF, Ms. Nandini Paliwal, IAS, Commissioner-cum-Secretary (E&F) and Shri Pankaj Kumar, IAS, Secretary (E&F) also graced the occasion.

Speaking on the occasion, the Chief Secretary remarked that all the stakeholders have their role to play in conserving the forests and natural resources, including wildlife and therefore, every citizen should come forward and contribute in safeguarding these invaluable natural resources.

Earlier, the Chief Conservator of Forests, Dr. S. Senthil Kumar, IFS briefed about 'Project Dolphin' and benefits of dolphin to society, particularly in the Andaman and Nicobar Islands. The vote of thanks was proposed by Ms. Deep Shika, IFS, DCF (Wildlife). The programme was also attended by Shri



Sanjay Waradkar, IFS, CF (Wildlife) and Shri Birendra Choudhary, IFS, DCF(WP) and other officials of A&N Forest Department and India Post.

Later in the day, Dolphin Tableau and bike/cycle rallies were organized at various places such as Diglipur, Mayabunder, Rangat, Port Blair & Nicobar. A special fishermen sensitization programme was also conducted at 10 different locations from Diglipur to Car Nicobar during which, the fishermen were sensitized about the role of Marine Dolphins in our life. India emerges as the largest producer and second-largest exporter of sugar

New Delhi, Oct. 5

India has emerged as the world's largest producer and second-largest exporter of sugar. In Sugar Season 2021-22, a record of more than five thousand Lakh metric tons of sugarcane was produced in the country. Out of this, 35 lakh metric tons of sugar was diverted to ethanol production and 359 lakh metric ton of sugar was produced by sugar mills. Consumer Affairs, Food and Public Distribution Ministry said, the season has proven to be a watershed season for Indian Sugar Sector. Records highest sugar exports of over 109 lakh metric ton has been registered. The Ministry said, supportive international prices and Central Government Policy led to this feat of the Indian Sugar Industry. These exports earned foreign currency of about 40 thousand crore rupees. It said, the success story of the sugar industry is the outcome of synchronous and collaborative efforts of Central and State Governments, farmers, and sugar mills with a supportive overall ecosystem for business in the country. EPS pensioners asked to submit 'Jeevan Pramaan Patra' digitally to get pension

Port Blair, Oct. 5

All EPS pensioners have to submit annual Jeevan Pramaan Patra for getting pension. The Life Certificate thus submitted is valid for one year and the pension shall be stopped only if it has not been submitted after one year. Hence, all pensioners have been requested to submit Jeevan Pramaan Patra digitally as soon as possible. If a person is dead, it should be intimated to the Employees Provident Fund Organization, Regional Office, Port Blair immediately alongwith Death Certificate for further necessary action, a press release from Officer-in-charge, Regional Office, EPFO said.

Port Blair, Oct. 5

Scheme of Assistance to Disabled Persons for Purchase/Fitting of Aids/Appliances (ADIP Scheme) is one of the major initiatives of the Ministry of Social Justice & Empowerment, Govt. of India to assist the needy Divyangjan in procuring durable and scientifically manufactured standard aids and appliances to promote

their physical, social and psychological rehabilitation. Assistive devices are given to PwDs with the aim to improve their independent functioning, to arrest the extent of disability and occurrence of secondary disabilities. A person with disabilities fulfilling the conditions mentioned would be eligible for assistance under ADIP Scheme viz. an Indian citizen of any age, holds a

40% Disability Certificate, his monthly income from all sources is up to Rs. 22,500/- per month, he or she shall be eligible for getting an assistance covering the full cost of the Aids and Appliances under ADIP Scheme. If the total income is between Rs. 22,501/- to Rs. 30,000/- per month, he or she shall be eligible for getting 50% subsidy of the cost of Aids/Appliances under

ADIP Scheme. Income certificate from Revenue Agencies / BPL Card / MGNREGA Card / Disability Pension Card / Certificate by MP/MLA/Councilor/ Gram Pradhan failing which Notarized Affidavit C/o Implementing Agencies may be accepted for providing aids/ appliances to PwDs. Four COVID positive cases have been detected today in A&N Islands from incoming flight passengers who arrived here yesterday. Today, 13 flights with 2083 passengers arrived, out of which, 1828 passengers were vaccinated with both doses while RT-PCR test was conducted on 197 passengers and the reports are awaited, a press release from IP&T said.

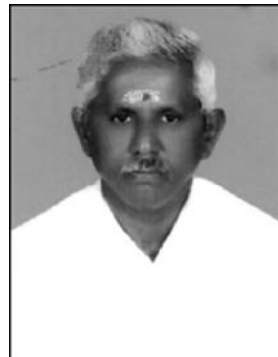
