India to deploy a platoon of women peacekeepers to UN Mission in Sudan

New Delhi, Jan. 7
India will deploy a platoon of women peacekeepers to UN Mission in Sudan. This will be India's largest single unit of women Peacekeepers in a UN Mission since it deployed the first-ever all-women contingent in Liberia in 2007, stated the Permanent Mission of India to the UN. The Indian contingent, comprising two officers and 25 Other Ranks, will form part of an Engagement platoon and specialize in community outreach, though they will be performing extensive security-related tasks as well.
The deployment in Abyei will also herald India's intent of increasing its authorized force in protecting civilians and women in humanitarian workers in Abyei. (Source: india.gov.in)

New Delhi, Jan. 7
Directorate General of Civil Aviation (DGCA) has issued an advisory to Head of Operations of all Scheduled Airlines on handling unruly passengers on board and respective responsibilities as per the regulations. In its advisory, the aviation regulator said that restraining devices should be used when all conciliatory approaches have been exhausted.
The move came following few incidents of unruly behaviour and inappropriate conduct by passengers on board aircraft during flight. DGCA further stated that non action or inappropriate action by the airlines towards such untoward behaviour has tarnished the image of air travel in different segments of society. It said that individual's responsibility for the handling of the unruly passenger has been specified under various provisions of Aircraft Rules, DGCA regulations, circulars and manuals of airlines approved or accepted by DGCA.
