Creating 'outrage' over just criticism

The government's manufacturing push, especially with the Production Linked Incentive Scheme (PLI), has not impressed all. There have been conflicting views on this issue, with many pointing out its limited benefits. One of the critics of the government's cash incentive policy to manufacturers is former RBI governor Raghuram Rajan. He has been a votary of a more service sector-led growth rather than India trying to emulate China's manufacturing model. In a recent conversation with Rahul Gandhi, he made this point again, leading to an angry retort from the finance minister.

Rajan is not the only critic of the government's manufacturing policy, especially the PLI scheme. Experts have underscored the issue of large subsidies given to manufacturers for setting up highly capital-intensive industries like semiconductors and questioned the viability since only a few manufacturers receive them. Another issue is India's attempt to be a manufacturing hub for everything instead of focusing on a few sectors, as Taiwan did with semiconductors. The focus of the PLI seems to be more on capital-intensive sectors than labour-intensive ones. Therefore, experts doubt the scheme's ability to generate the kind of manufacturing jobs the government hopes for.

A recent report by Credit Suisse also speaks of "modest" Capex growth due to PLI schemes; it sees only an 8–10% incremental Capex growth. Credit Suisse does not see many investments in non-traditional sectors like mobile manufacturing, IT hardware, batteries, etc. It also raises the concern that big global players have largely stayed away from availing benefits under the scheme. The Aatmanirbhar focus—another aspect of promoting local manufacturing—has also drawn criticism for it being unrealistically hopeful of countries willing to buy from India without gaining access to the Indian market for selling here. The government has been trying to push India's manufacturing sector through a mix of local incentives given to manufacturers here and tariff barriers created to dissuade imports. But experts see the anomaly of such a policy approach.

The government should listen to its critics—a few are left, ready to risk rubbing the government the wrong way. It should be open to constructive criticism rather than attacking every critic with all its might. Nobody questions the government's intention regarding its economic policies, but it should also take the criticism in good spirits.

COP15: India calls for new, dedicated fund for biodiversity conservation



PTI, NEW DELHI, Dec 18: There is an urgent need to create a new and dedicated fund to help developing countries successfully implement a post-2020 global framework to halt and reverse biodiversity loss, India has said at the UN biodiversity conference in Canada's Montreal.

It has also been said that the conservation of biodiversity must also be based on 'Common but Differentiated Responsibilities and Respective Capabilities' (CBDR) as climate change also impacts

As the 196 parties to the Convention on Biological Diversity (CBD) finalise negotiations for a post-2020 Global Biodiversity Framework (GBF) — a new set of goals and targets to halt and reverse biodiversity loss - there have been repeated calls for the inclusion of the CBDR principle in financerelated targets.

Addressing the stocktaking plenary at CBD COP15, Union **Environment Minister Bhupender** Yadav said the successful implementation of a post-2020 GBF will depend on the "ways and means we put in place for an equally ambitious 'Resource Mobilization Mechanism".

"There is a need to create a new and dedicated mechanism for the provision of financial resources developing-country parties. Such a fund should be operationalised at the earliest to ensure effective implementation of the post-2020 GBF by all countries," the minister said.

So far, the Global Environment Facility which caters to multiple conventions, including the UNFCCC and UN Convention to Combat Desertification remains the only source of funding for biodiversity conservation.

India said developing countries bear most of the burden of implementing the targets for the conservation of biodiversity and therefore require adequate funds and technology transfer for this purpose.

"The most important challenge is the resources needed for implementation of the GBF. Greater ambition means greater cost and the burden of this cost falls disproportionately on the countries that can least afford them," Yadav said.

The minister underlined India's stand that the goals and targets set in the GBF should not only be ambitious but also realistic and practical.

"Conservation biodiversity must also be based on Common but Differentiated Responsibilities and Respective Capabilities as climate change also has an impact on biodiversity," he said.

Established as the seventh principle of the Rio Declaration adopted at the Earth Summit in 1992, CBDR is defined as "states have common but differentiated responsibilities in view of the different contributions to global environmental degradation".

However, applying the CBDR principle to biodiversity conservation has not been straightforward as compared to climate negotiations, and there been have repeated disagreements between the global north and south on the issue.

At CBD COP15, the parties are also trying to achieve a consensus on eliminating subsidies that are harmful to the environment, such as subsidies for fossil fuel production, agriculture, forestry and fisheries, by at least USD 500 billion (one billion = 100 crore) annually and using this money for biodiversity conservation.

However, Yadav said, India does not agree on reducing the agriculture-related subsidy and redirecting the savings for biodiversity conservation, as there are many other national

For the developing nations, agriculture is a paramount economic driver for rural communities, and the critical support provided to these sectors cannot be redirected, he

The majority of the rural population in India is dependent on agriculture and allied sectors and the government provides a variety of subsidies, including seed, fertilizer, irrigation, power,

1971 India-Pakistan war: Hero of Longewala post battling health issues at AIIMS-Jodhpur



PTI, JODHPUR/NEW DELHI: Bhairon Singh Rathore (81), the veteran of the 1971 India-Pakistan war whose bravery at Rajasthan's Longewala post was portrayed by actor Suniel Shetty in Bollywood movie 'Border', is battling health issues and has been admitted to the AIIMS in Jodhpur.

Rathore's son Sawai Singh told PTI that his father was admitted to the All India Institute of Medical Sciences (AIIMS) at Jodhpur on December 14, two days before the 51st anniversary of the war, after his health deteriorated and his limbs got affected in what seemed like a paralysis. "Doctors told us that my father has possibly suffered a brain stroke. He has been in and out of ICU over the last few days," Singh told PTI.

The Singh family lives in Solankiatala village, about 120 kms from Jodhpur.

Rathore was deployed at

the Longewala post in the Thar desert, commanding a small BSF unit that was accompanied by a company of the Army's 23 Punjab regiment.

It was the bravery of these men that decimated an assaulting Pakistani brigade and tank regiment at this location on December 5, 1971.

Prime Minister Narendra Modi had called Rathore, a retired BSF lance naik, over phone a few days back and told him the nation was indebted to his contribution in the 1971 war and the nation is praying that for his revocery, according to Sawai Singh.

Bhairon Singh Rathore, posted with the 14th BSF battalion during the war, retired in 1987.

Singh said that AIIMS-Jodhpur had taken care of his father earlier too and the entire cost of the treatment is being taken care of by the government, as always.

"However, sometimes I have to get medicines from the market as they are not available at the hospital," he said.

Officers from the Border Security Force (BSF) and the General Officer Commanding (GOC) of the Army responsible for guarding the India-Pakistan front along the Thar desert area have also visited the hospital to inquire about his health and treatment, officials said.

According to BSF records about the 1971 war at Longewala post, "When one of the 23 Punjab boys was killed, Lance Naik Bhairon Singh took his light machine gun and inflicted heavy casualties on the advancing enemy. It was only their courage and determination to do or die that won the day and Lance Naik Bhairon Singh became a great inspiration to his other comrades on the post," the official records

He received the Sena Medal in 1972 for his gallant action.

Rathore has also been decorated with numerous other civilian awards and military felicitations. Union Home Minister Amit Shah met him in Jaisalmer in December last year when he visited the border town for the Raising Day celebrations of the BSF.

Bhairon Singh Rathore's role was assayed by Suniel Shetty in the 1997 Hindi movie 'Border'

While the reel Bhairon Singh (Shetty) was shown killed in action in the movie, the real BSF soldier and his legacy of guts, glory and bravery lives on.

"My father is a simple man. He recounts the story of the 1971 war when people ask him. He only gets a monthly pension of Rs 12,000 plus Rs 2,000 allowance for the bravery medal given to him. Stealth-guided missile destroyer Mormugao commissioned into Indian Navy



PTI, MUMBAI, Dec 18: The stealth-guided missile destroyer Mormugao was commissioned into the Indian Navy on Sunday.

Defence Minister Rajnath Singh, Navy chief Admiral R Hari Kumar and Goa CM Pramod Sawant were among those present at the commissioning ceremony in Mumbai.

Singh said the warship's commissioning will boost India's maritime power. He termed INS Mormugao as the most technologically advanced warship.

Indian economy is among the top five economies in the world, and according to experts, will be among the top three in 2027, Singh said.

The Navy chief said the commissioning of the warship, on the eve of the Goa Liberation Day, is indicative of the large strides taken in warship design and building capa-

bility over the last decade. INS Mormugao is the second of the four 'Visakhapatnam' class destroyers, indigenously designed by the Indian Navy's in-house organisation, Warship Design Bureau, and constructed by Mazagon Dock Shipbuilders Limited, Mumbai.

Named after the historic port city of Goa on the West coast, Mormugao coincidentally undertook her first sea sortie on December 19, 2021 when Goa celebrated 60 years of liberation from Portuguese rule.

The warship is packed with sophisticated state-of-the-art weapons and sensors such as surfaceto-surface missiles and surface-toair missiles.

It is fitted with a modern surveillance radar that provides target data to the gunnery weapon systems on board.

Applications in prescribed format including Self Contained DPR (Two sets) have been invited from Traditional/ Artisanal Fishermen/ Fisher Women and their Societies/Associations/ SHGs/ FFPOs for 'Support for Acquisition of Deep Sea Fishing (FRP/ Steel) vessels for traditional fishermen' in A&N Islands.

The Applicants who have already submitted the applications for 'Support for Acquisition of Deep Sea Fishing Vessels' may again resubmit the application in the prescribed format along with the self contained DPR (2 sets). The applicant should be a Traditional / Artisanal fishermen and their Societies/ Associations / SHGs / FPOs. Beneficiary should possess valid ownership certificate, Registration Certificate under the ReAL Craft, Fishing License and Biometric ID cards of Fishers/QR coded Aadhaar

The Governmental assistance is restricted to 1 unit per individual beneficiary; 2 units per group/society (of at least 10 members) in case of Groups of Traditional/Artisanal Fishermen i.e. Traditional/Artisanal Fishermen SHGs/Joint Liability Groups (JLGs)/ Traditional/ Artisanal Fisher Cooperatives etc. or those undertaken in a cluster/area approach. However, a cluster/area may have multiple groups/societies. As far as FFPOs/Cs are concerned, the modalities of implementation and upper ceiling on the total units eligible for support would be decided by the CAC.

The vessel should have onboard machineries/fishing equipment including refrigerated storage facilities for undertaking deep sea tuna long lining and gill netting. Appropriate communication systems, AIS/transponders and other navigational equipment for safe navigation etc., as per the relevant regulations/guidelines are mandatory onboard the vessels.

Deep sea fishing vessel should be considered as an alternative for replacement of the existing bottom trawler and the State/UT shall ensure suitable disposal of old fishing boat (against which new one is replaced).

Beneficiaries will submit Self Contained Proposal (SCP) with relevant techno-financial details of the vessel. Installation of Bio-toilet shall be mandatory within the project cost.

The selected beneficiaries should construct Deep Sea Fishing Vessel (FRP/Steel) only through the boat building yards empanelled by Department of Fisheries, A & N Administration and Ministry of Fisheries& Animal husbandry & Dairying, Department of Fisheries, Govt. of India i.e. M/s Samundra Ship Yard Pvt. Limited for FRP DSFV and Cochin Shipyard Limited (CSL) for Steel DSFV respectively.

Interested applicants may contact the Directorate of Fisheries, Port Blair, Zonal Fisheries offices, South Andaman/N&M Andaman and Nicobar or nearest Fisheries Sub Stations for detailed terms & conditions of the scheme and design, drawing FRP/ Steel Deep Sea Fishing Vessel. The completed applications in all respect should reach the nearest Fisheries Zonal Office / Sub-Stations on or before 31st December, 2022.

Expectation soaring in Argentina ahead of FIFA World Cup final



AFP, BUENOS AIRES, Dec 19: With Argentina reaching a fever pitch just hours before Lionel Messi and his teammates take on France in the World Cup final, football fans throughout the country felt a sense of destiny brewing.

From Jujuy in the north to Chubut, some 2,800 kilometres to the south, from Mendoza at the foot of the Andes mountain range in the west to Mar del Plata on the Atlantic coast, the country was preparing to rejoice at a much sought-after third-world title — 36 years after their last one.

At the Obelisk monument in central Buenos Aires where fans usually flock to celebrate the team's victories, dozens jumped up and down singing songs as passing drivers honked their car horns on Friday, with the final still 18 hours away.

"I feel very proud to be Argentine, I know Messi will bring home the cup," said Franco Llanos, 22, decked out in an Argentina shirt, blue and white joker's hat, draped in a flag and carrying a plastic replica of the World Cup trophy.

"My passion is wooo-ooo-ooo!"

Carina Disanzo, 44, who was wearing Messi's number 10 jersey in the historic Boca neighbourhood, said the team "absolutely" deserves to win.

"If what we all hope hap-

pens, it's going to be a huge party but even if it doesn't happen there's going to be a huge party because we're in the final with the best player in the world," she said.

"It's a real football country, what happens in Argentina ... on the pitch, in the stands, with the people, doesn't happen anywhere else."

Everyone for Messi

The Argentine capital was a sea of blue and white jerseys, most bearing Messi's number 10, flags, painted faces, hats and other memorabilia.

Vendors were making a packet, with Raul Machuca, 22, saying face paint and flags were selling like hotcakes at the Melu store in central Buenos Aires where he works.

With Christmas around the corner, he said it was a double boon for the shop.

In some major avenues, the city council had painted pedestrian crossings in the national team's blue and white stripes.

Foreign football fans were also getting in on the act.

English friends Josh Gwilt, 27, and Greg Layhe, 28, were travelling in Brazil but decided to switch their itinerary to Buenos Aires "on a whim."

"When are you ever going to be in South America and get to see Argentina in the final of a World Cup," said Gwilt, who was wearing the goalkeeper's jersey of Emiliano Martinez. Layhe, wearing a Messi shirt, said they had partly decided to put on their jerseys as a precaution, given the historic bad blood between England and Argentina both on and off the pitch.

Even so, he said he was firmly behind Argentina, especially Messi, who has won everything in the game except this.

"We all hope he wins the World Cup, even some French fans we've spoken to have been semi-torn because it would be an amazing end to his career. I think he's the greatest player of all time and deserves to win the World Cup," said Layhe.

Puerto Rican couple Lilly Oronoz and Antonio Secola, both 51, had also come to Argentina for the game.

"Us Latinos are very supportive," said Oronoz. "Everyone for Messi, everyone for Argentina."

"It's for the passion, we've got more passion, and the conviction that they will win," added Secola.

Uniting issue

At midnight from Saturday to Sunday, Argentina's main television channels were due to mark 12 hours to kick off with a special rendition of the national anthem recorded by the players themselves in Qatar, with goosebumps guaranteed.

Football is one of only two things in a politically polarized country with huge wealth disparities that brings all people together.

"This national team and the Falklands united us," said Edgar Esteban, a veteran of the 1982 war with Britain over the Falkland Islands in the South Atlantic and director of the Malvinas Museum in Buenos Aires.

Kangana seeks nod to shoot 'Emergency' inside Parliament premises, likely to be disallowed



PTI, NEW DELHI: Actor Kangana Ranaut has sought permission from the Lok Sabha Secretariat for shooting her upcoming film "Emergency" inside Parliament premises, sources said on Sunday.

Her letter is under consideration but she is unlikely to be granted permission, they said.

In her letter to the Lok Sabha Secretariat, Ranaut has requested that she be allowed to shoot the film based on the Emergency inside the Parliament premises, they said.

Normally, private entities are not granted permission for shooting or doing videography inside the Parliament premises. If it is being done for any official or government work, then it is a different case, sources told PTI.

Mainly state broadcaster Doordarshan and Sansad TV are allowed to shoot programmes or events inside Parliament, they said.

There is no precedent of permission being given to a private party for shooting inside Parliament for private work, they added.

Shooting for "Emergency" commenced in June this year.

The film is directed, produced and written by Ranaut. She is also playing the role of former prime minister Indira Gandhi, who imposed the Emergency in the country in 1975, in the movie.

"Emergency" is billed as the story of a watershed moment in the political history of India. "Emergency' reflects one of the most important periods in Indian political history which changed the way we view power and that's why I decided to tell this story," Ranaut had said in a statement.

She had said she was fascinated by the power dynamics that came into play at the time.

The Emergency was imposed by Gandhi from June 25, 1975 to March 21, 1977. During the 21-month period, the fundamental rights of the people were put under strict curbs.

After lifting the Emergency, Gandhi called for Lok Sabha elections, in which her Congress party was handed a crushing defeat — its first-ever since the country's independence in 1947 — by the combined opposition of the Janata Party.

The GBF targets include reducing pollution, pesticides, subsidies harmful to nature and the rate of introduction of invasive alien species among others.
