# Appalling insensitivity in dealing with flier's bad behaviour

The gross insensitivity of an Air India crew in dealing with an incident of an inebriated passenger flashing and peeing on a co-flier onboard its New York-Delhi flight a few weeks ago is appalling. It is a blot on the reputation of the Tata group that got to own the airline amid great fanfare last year. That the matter was underplayed despite the 70-yearold victim writing about her ordeal to the Tata Group chairman a day after the episode is even more worrying. There can be no place for mutual settlement in such instances. The only proper thing to do would have been to report it upon landing and make the offender, Shankar Mishra, face the full force of the law. Yet, the crew allowed him to force compensation on her despite the victim's refusal even to see him, and they let Mishra walk free upon landing in Delhi. It completely violated the standard operating protocol (SOP), drawing a sharp rebuke from the Indian aviation regulator, DGCA. For reasons only a thorough investigation can unravel, Mishra appeared more important to the crew than the victim. He was vice president of the Indian operations of a multinational firm, Wells Fargo. But the company sacked him when it could not deodorise the stench of his atrocious behaviour. Reports of similar incidents happening in the past before the airline was privatised could indicate the crew's reaction is a legacy issue. That, again, is a subject of probe.

The crew apparently showed bad judgement on how much alcohol could be served to the individual on the flight. They compounded their folly by not giving the victim proper alternative accommodation and later goading her back to her seat that reeked of urine. And the pilot refused to upgrade her from business class to first class even though it had vacant seats.

As for Mishra, he has been arrested from his hideout in Bengaluru. A Delhi court before which he was produced advised the police to go by the law and not by public pressure when they sought his police remand. Over a month after the despicable episode, national outrage forced the airline to de-roster the cabin crew and a pilot of that flight. And Tata Group's chairman admitted they fell short of addressing the situation the way they should have, adding their response should have been much swifter. Now that the airline is reviewing its SOPs, here's hoping it handles victims with compassion and empathy in future.

# Himachal Cabinet expansion: Seven ministers take oath in presence of Governor, CM



PTI, SHIMLA: After a fourweek wait, Himachal Pradesh Chief Minister Sukhvinder Singh Sukhu expanded his cabinet on Sunday with the induction of seven ministers, including Vikramaditya Singh - the son of former chief minister Virbhadra Singh and state Congress president Pratibha Singh.

The strength of the cabinet has now risen to nine.

Only Sukhu and his deputy Mukesh Agnihotri were sworn in on December 11 following Congress' win in the hill state.

Three berths are still vacant as the maximum number of ministers, including the chief minister, cannot exceed 12.

Governor Rajendra Vishwanath Arlekar administered the oath of office to the newly inducted ministers at the Raj Bhawan.

The party apparently tried to placate Sukhu's rival camp led by Pratibha Singh, who lost out in the chief ministerial race, with the induction of her son Vikramaditya Singh, two-time MLA from Shimla (Rural).

Among the new ministers, Harshwardhan Chauhan, a sixtime MLA elected from Shillai, three-time MLA elected from Kasumpti Anirudh Singh and four-time MLA Rohit Thakur from Jubbal-Kotkhai are considered close to the chief min-

The other ministers are eldest MLA Dhani Ram Shandil, a former minister elected from Solan; Chander Kumar, a former minister and six-time MLA from Jawali in Kangra district; and Jagat Singh Negi, a former deputy speaker and five-time MLA from tribal Kinnaur district.

Shimla district with seven MLAs has been given the lion's share in the cabinet with three ministers while Bilaspur, Mandi, Kullu and Lahaul and Spiti districts are unrepresented in the cabinet.

Kangra with 10 MLAs got



one berth.

Chief Minister Sukhu also appointed six Chief Parliamentary Secretaries (CPS), who enjoy the same facilities as minis-

Leader of Opposition in Himachal Pradesh Assembly Jai Ram Thakur alleged that the Congress government has failed to give adequate representation to various regions in the cabinet expansion.

The BJP leader and former chief minister also criticised the government over the appointment of six chief parliamentary secretaries, saying it would put a burden of crores of rupees on the state exchequer.

Out of the 13 appointments made by the Congress government, eight MLAs have been appointed from Shimla parliamentary constituency while the rest of the three parliamentary constituencies have not been given adequate share, Thakur said in a statement here.

The BJP had been targeting the Congress government over the delay in Cabinet expansion.

The Congress high command had on Saturday evening approved the names of ministers after Sukhu handed over the list of probables.

Out of the nine ministers, five are from Shimla Parliamentary constituency, two from Hamirpur Parliamentary constituency and one each from Kangra and Mandi parliamentary constituencies.

The ministers include five Rajputs, and one member each from Brahmin, Schedule Tribe, Scheduled Caste and OBC categories.

Later, Chief Minister Sukhu told reporters that MLAs with a clean image have been inducted into the cabinet on the basis of merit and the districts that were left out would get representation in due course.

REVERBERATION

The CPS included Sunder Singh Thakur from Kullu, Mohan Lal Brakta from Rohroo in Shimla district, Ram Kumar Chowdhary from Doon in Solan district, Ashish Butail from Palampur and Kishori Lal from Baijnath in Kangra district and Sanjay Awasthi from Arki in Solan district.

Efforts have been made to balance the claims of rival factions but caste and regional imbalances still exist, political observers said.

Meanwhile, police had a tough time controlling hundreds of enthusiastic supporters who tried to forcibly enter the already-packed Darbar hall of Raj Bhawan here during the oathtaking ceremony and even damaged two doors.

Congress workers and supporters danced to traditional music outside the Bhawan.

All roads to the governor's official residence were choked with vehicles and pedestrians.

The police struggled to control the surging crowds and many people forced their way into the main hall.

Glass panes of two doors were broken as the people tried to enter the Durbar Hall during the swearing-in ceremony.

The residents of Shimla were jubilant as three ministers are from the district.

A large number of supporters, raising slogans, followed the newly inducted ministers to the State Secretariat.

The Congress has won 40 out of 68 assembly seats including 10 seats from Kangra, seven from Shimla, four each in Una, Solan, and Hamirpur, three in Sirmaur, two each in Chamba and Kullu, and one each in Mandi, Bilaspur, Kinnaur and Lahaul and Spiti district.

# Air India peeing incident: Airline's response should have been swifter, says Tata Group Chairman

PTI, MUMBAI: Tata Group Chairman N Chandrasekaran admitted on Sunday that Air India's response to the incident of a drunk passenger allegedly urinating on a woman on one of its international flights last year should have been "much swifter".

In a statement, which came days after the aviation regulator DGCA pulled up the Tata Group-owned full-service carrier, Chandrasekaran also said that "we fell short of addressing this situation the way we should have."

In a shocking incident, an inebriated man allegedly urinated on a female copassenger, a senior citizen in her seventies, in the business class of Air India New York-New Delhi flight on November 26 last

The accused Shankar Mishra was arrested by the Delhi Police from Bengaluru on Saturday.

'The incident on Air India flight AI102 on November 26, 2022, has been a matter of personal anguish to me and my colleagues at Air India. Air India's response should have been much swifter. We fell short of addressing this situation the way it should have been," Chandrasekaran said in the statement on Sunday.

"The Tata Group and Air India stand by the safety and well-being of our passengers and crew with full conviction. We will review and repair every process to prevent or address any incidents of such unruly nature," he added in the statement.

DGCA has said Air India's conduct in handling the incident was "unprofessional". It has issued show cause notices to the airline, its director of in-flight services and the crew that operated the

The incident came to light reportedly after the woman wrote a letter Chandrasekaran recalling her harrowing experience on the flight.

Air India CEO Campbell Saturday Wilson on apologised for the incident and said four cabin crew and a pilot



have been de-rostered and the airline is reviewing its "policy on service of alcohol in flight"

Earlier, Wilson, in an internal communication, told the airline staff to report any improper behaviour on aircraft to authorities at the earliest even if the matter appears to have been settled.

Wilson wrote communication to employees after aviation safety regulator DGCA slammed the Tata Group airline, saving that its conduct was "unprofessional" and led to the "systematic failure" on the New York-Delhi flight incident, which it did nor report to the DGCA.

The Delhi Police registered an FIR against Mishra on January 4 on a complaint given by the woman to Air India. After his arrest, he was brought to Delhi.

Mishra, who was working with US multinational firm Wells Fargo in India, was sacked on Friday. He studied management at a private university in Mumbai and completed his higher studies in the United States.

According to the FIR, shortly after lunch was served and the lights were switched off onboard AI 102 on November 26, 2022, the inebriated male passenger seated in business class seat 8A walked to the elderly woman's seat, unzipped his pants and urinated on her.

According to the FIR, the accused later begged the woman not to lodge a complaint against him, saying he was a family man and did not wish his wife and child to be affected by the incident.


The airline had on Wednesday said it had imposed a 30-day flying ban on the accused passenger and set up an internal panel to probe whether there were lapses on part of the crew in addressing the situation.



PMJAY aims to provide a cashless treatment worth Rs 5 lakh per family per year against secondary and tertiary hospitalization care. Presently, 12,848 families (40,465 members) have registered under the AB-PMJAY scheme in this UT and are entitled for cashless treatment at 28,000 empanelled public and private hospitals across the country. To create awareness

among the general public and to identify the unregistered eligible AB – PMJAY beneficiaries various IEC activities are conducted in this UT.

On 4<sup>th</sup> January, 2023 an AB-PMJAY card generation drive was organized by State Health Agency (SHA), A&N Islands at Gram Panchayat Office, Mithakhari. A total of 53 people have attended the camp, out of

which, 15 new unregistered eligible beneficiaries were identified and cards were created for them. During the camp, the resource person from the State Health Agency also addressed the queries from the public pertaining to Ayushman Bharat – PMJAY scheme and also explained about the eligibility criteria to the public.

The DC (SA) informed that this concept is the second initiative in A & N Islands and the Maternity Home has been constructed through the District Health Society (SA) under National Health Mission to provide accommodation at minimal fee to the poor pregnant women of Inter Island for better health care services. It was also informed that this initiative has been inspired from Nicobari Birth Home, the idea of Maternity Home incorporates Tradi-

tional Gyan with Post Modern Technologies. He also informed that the motto of this initiative is to reduce the Maternal Mortality Rate (MMR), which could improve the health indicators of A & N Islands.

Director of Health Services appreciated the role of District Administration and the officials of the National Health Mission for such innovative idea. The Health Department could monitor the high risk poor pregnant women and refer them well in advance from Inter Islands to Port Blair to avoid any pregnancy related complications. Earlier, many poor residents

avoided coming to Port Blair for advanced treatment due to financial constraints and accommodation.

District Programme Manager, DHS (SA) informed that this Maternity Home has a capacity of 06 pregnant women with one attender each. He also informed that another 10 bedded Maternity Home was also constructed at CHC Bambooflat and both Maternity Home will be managed by the Directorate of Health Services in coordination with the District Hospital & District Administration, South Andaman to provide allotment of accommodations at affordable fee to the pregnant women.

Shri Vishal Jolly, National Executive Member BJP & Shri AjoyBairagi, State President, BJP- A & N islands have wrote a letter to Mananiya Shri Nitin Gadkari, Hon'ble Union Minister for Road Transport & Highways Government of India over the extremely pathetic condition of NH-4 in North & Middle Andaman District & an early commencement of construction of Chatham Bambooflat Bridge.

In their letter, they stated that the people residing at North & Middle Andaman are suffering enormously due to the extremely pathetic condition of the NH-4 in that region. The economic development and the transport system have collapsed due to the pitiable condition of NH-4. The construction of NH-4 was awarded to National Highways and Infrastructure Development Corporation Ltd (NHIDCL) in the year 2016 and even after elapse of almost 6 years, the work is yet to becompleted.

Further they added that, the yard stick, method and quality of work adopted by NHIDCL in South Andaman District was completely different from the works that are being done at North & Middle Andaman District. Due to non-availability of good quarry products, the previously constructed road materials were rolled over for the new construction and they say that the same was done after obtaining necessary approval.

Both the leaders further highlighted that the road construction in that regionis difficult considering the fact that around 09 months we have rainy season, yet, the truth is that the concerned contractors have miserably failed in their management and performance of work.

In respect to Chatham-Bambooflat Bridge, both the leaders wrote that the issue requires the intervention of the Hon'ble Minister for which a large number of people are awaiting. Reportedly, the DPR for this project was already completed and further course of action was required to be taken for its early implementation. This project would bring a sea change for enabling convenient vehicular traffic movement from a major part of South Andaman region to Port Blair City. This would largely reduce the travel time for the commuters from several villages of South Andaman.

Concluding their letter Both the leaders have earnestly requested take a serious note and take all needful steps to make sure that the construction work of NH 4 gets completed at the earliest by strictly maintaining the standards of National Highways and commence the project of Chatham-Bambooflat Bridge, in the interest of people of A & N Islands.

# 'Hope to breach 90m mark this year', says Neeraj Chopra



PTI, NEW DELHI, Jan 7:

His "amazing athleticism" has left even the iconic Michael Johnson in awe recently and India's Neeraj Chopra has now set himself a target in the new year: breach the 90-metre mark with his jav-

After the historic gold in Tokyo, the 24-year-old Olympic champion javelin thrower has continued to raise expectations with a silver at the World Championships, before adding another feather to his cap by winning the Diamond League Finals gold.

However, despite his superlative shows, the magical 90m mark continues to elude

"In this new year, I hope I will put an end to this question," Chopra told reporters in a video interaction from England where he's doing off-season training. He came agonisingly close with his 89. 94m throw when he finished second in the Stockholm leg of the prestigious Diamond

In hindsight, Chopra thinks he could have achieved the mark in Stockholm.

"I could have done that if I landed my foot a few centimetres ahead. Yes, it's just a matter of six centimetres but a magical mark for an athlete. Whenever you talk about a top athlete we all say like this he's done 90m. But I'm not bothered about the pressure of expectations. It will happen when it has to. It could have happened last year or the year before, but maybe God has kept a perfect time and place for that."

He's not bogged down by the pressure of expectations and said he always took them

he's "a javelin thrower with the movements of a sprinter/ jumper".

Asked about Johnson's praise, Chopra said, "I can never do a sprint. Their speed is at a different level. Maybe he liked my techniques and my exercises and my response was just in funny way. But yes, if I ever bump into him, I will sprint a bit and show him a few of my skills. As for me, I'm just focused on improving my javelin throws."

An injured Chopra could not defend his gold at the Birmingham Commonwealth Games owing to an injury but his compatriots, such as long jumper Murali Sreeshankar and steeplechaser Avinash Sable, clinched historic silver while competing among the world's top pool.

Also, triple jumpers Eldhose Paul and Abdulla Aboobacker had a top-two finish as India achieved their second-best medal haul after the 2010 Delhi CWG with one gold, four silver and three bronze.

Chopra believes Indian athletics is on the rise and hopes to see more glorious days ahead.

"In world athletics, our men's field ranking is 9, it's a good thing. I think we will do better as athletes. Whenever I talk to anyone, I feel they are all positive and clear in their mindset. The likes of Sreeshankar, Eldhose, Sable, they no longer go just to participate, they go to do their best and compete among the top. I don't think I've anything more to offer them. I have full faith in them," he signed off.
