End Kerala rhetoric, get on with jobs

That Kerala Governor Arif Mohammed Khan is angry with Chief Minister Pinarayi Vijayan, and his LDF government is an understatement. He is absolutely livid and makes it clear at every opportunity—pouring his sense of outrage into the sympathetic ears of the media almost every day. With Vijayan too deciding to reply in kind, the exchange has breached the boundaries of a civil debate.

In what could lead to a constitutional crisis, the Governor has declared he will not sign two bills recently passed by the Kerala assembly. One pertains to changes made in rules for appointing vice-chancellors in state universities, and the other is intended to alter the Lok Ayukta Act. Khan contends that the University Laws (Amendment) Bill is aimed at curbing his powers as chancellor and enabling the government to have a decisive say in the selection of VCs, thus compromising the autonomy of universities. His objection to the Lok Ayukta (Amendment) Bill is that it would enable a public servant accused of illegal actions to be "a judge in his own cause".

His outbursts indicate Khan has many bones to pick with the government and is repeatedly raking up a 2019 incident to attribute direct and indirect roles to the government and chief minister in what he considers was an attempt to intimidate him and cause physical harm. The said incident occurred during the Indian History Congress at Kannur University, where he was involved in a skirmish with historian Irfan Habib. The governor certainly has a duty to point out illegalities and lapses in the state government's actions. But, as a representative of the Centre, the governor is also expected to facilitate the smooth functioning of the democratic system, not stall it.

When a bill passed by the assembly is presented, the governor has four options—clear it immediately, temporarily withhold, reserve it for the consideration of the President or return without signing. The only option before the government if the governor does not exercise any of the options is to approach the judiciary. That is a situation both the government and governor will do well to avoid. Both must also tone down the rhetoric, which is as pointless as it is acerbic. The current standoff doesn't augur well for democracy. The governor must perform his duty and let the government carry on with its.

District Child Protecorganised an outdoor picnic for specially abled children of Divyang Home, Ferrargunj on 23rd Sept, 2022 at Colinpur.



Big question mark over Election Commission's fairness in last few years: Prashant Bhushan



PTI, NAGPUR, Sep 25:

Activist-lawyer Prashant Bhushan on Sunday said the fairness of the Election Commission of India (ECI) has come under cloud in the last few years.

He accused the ECI of keeping mum when big leaders from the ruling party violate the poll code, while acting swiftly against the opposition parties in such cases, and also claimed that the schedule of elections is made keeping in mind the convenience of the government.

Bhushan alleged that the independence of the judiciary is under threat and those speaking against the government face sedition and other serious charges, and they are not able to get bail for years.

He was speaking on the topic 'Challenges before Democracy 'during a programme organised here by 'Deshonnati', a Marathi daily.

"After T N Seshan became the chief election commissioner, for many years we could see that the Election Commission was very fair and impartial. But in the last six to seven years, a big question mark has arisen on its fairness," he said.

The Election Commission takes action if the Model code of conduct is violated by the opposition parties. But it keeps quiet when big leaders from the ruling party violate it. We have been witnessing this for a very long time, he alleged.

The election dates are prepared as per the convenience of the government, he said.

"Earlier, even the government did not know what dates will be decided by the EC for elections. But now, it is being witnessed that representatives of the ruling party even before the formal announcement tell what the polling dates are and the same dates are later announced by the EC," he said.

"The reason for the EC not being fair anymore. The problem with this has always been the selection in the poll watchdog is done by the government and there is no independent se-

dog is done by the government and there is no independent selection committee. And now, what the government is doing is that it is selecting people mostly from Gujarat and they are those who will do what the government will ask them to do. This also is an issue before democracy," he said.

Bhushan also alleged that there was a lack of independence in all regulatory institutions, and termed it as one of the biggest problems. He said the judiciary was formed to protect the fundamental rights of people and to keep the legislature and the executive within limits.

"But now we are seeing that this is not happening. Those speaking against the government are facing sedition and sometimes false cases under the Unlawful Activities (Prevention) Act. They are not able to get bail for years and this is being done blatantly. Our judiciary is not able to act against it. Hence, the independence of the judiciary is also under threat," he said.

"Media is also being controlled by the government. The police agencies are also being used for political use. The selection of some agencies like the Enforcement Directorate (ED), the National Investigation Agency (NIA) and the Income Tax department is completely in the hands of the government, which has put democracy in real danger," he alleged.

On the electronic voting machines (EVMs), he said that

although there was no significant manipulation in EVMs at present, in the coming times it cannot be ruled out.

"There is a possibility of manipulation and I feel EVMs are very dangerous. Paper ballots should return and they have returned in most of the countries," he said.

In order to tackle these challenges, a number of reforms can be brought by introducing Initiatives and Referendum law, Pre-legislative Transparency and Consultation law, he said, adding that parliamentary committees should be revived.

Since the opposition has become weak now, these reforms cannot be done by it alone and hence people need to raise their voices now. They can raise voices against unfair practices like which was done for the Lokpal Bill.

People can launch big agitations on issues like unemployment and privatisation of public sector units, which will also strengthen the opposition, he said.

Replying to a query by PTI on the sidelines of the programme about why the Supreme Court was not taking up the issue of electoral bonds on a priority basis, Bhushan said the government was not interested in the issue and probably they were stalling it.

"However, with the new Chief Justice of India at the helm, the matter will be heard," he said.

Bhushan has filed a PIL challenging laws permitting funding of political parties through the electoral bond scheme.

When asked whether the opposition parties would be able to put up a united fight against the Bharatiya Janata Party (BJP) in the next elections, he said he was not sure whether united opposition would be a good idea or not.

"But, in any case, civil society needs to play a major role to any major political change is to be brought in the country," he said.

Over 5,000 militants nabbed in Assam since 2011, only 1 convicted: Official records



PTI, GUWAHATI, Sep 25:

A total of 5,202 militants have been arrested in the last 12 years from various parts of Assam, but only one of them has been convicted so far, according to official records.

Only about half of those arrested have been charge-sheeted so far

Experts said investigators and the legal system "are at fault", resulting in an inordinate delay at multiple stages of the justice delivery system.

The Assam Police arrested 5,202 cadres of ULFA and other extremist groups, comprising people from the Bodo, Garo, Rabha, Karbi, Adivasi, and Muslim communities, from 2011 to September 4 this year, the official documents stated.

A total of 2,606 persons have been charge-sheeted in connection with the cases to date and "most of the cases are under trial and one person has been convicted", it said.

The conviction of the lone militant took place in the Lakhimpur district in 2012.

No other militant has been convicted since then.

Of the arrested people, the highest 2,392 number was from militant groups formed by Bodo people, followed by 1,468 from ULFA and 582 from Karbi groups.

Police also arrested 346 people from Adivasi groups, followed by 178 from Garo, 155 from Muslim, and 81 from Rabha communities.

Gauhati High Court Advocate Santanu Borthakur told PTI that the delay in the conviction of an accused takes place at multiple stages and it is also done "deliberately at times".

"Until we know the dates of arrest and the filing of the charge sheet, it is difficult to know where exactly the delay is taking place. At times, the investigators delay the probe purposively because many militants get political patronage and eventually become political personalities," he added.

When the charge sheet is filed after a prolonged period, witnesses cannot be found on several occasions for giving evidence in court.

Some witnesses do not appear even if they get notice after a long time, Borthakur said.

"There is a delay in our criminal justice system. ... Many a time, the witnesses turn hostile and cannot be found," he said.

Another Gauhati High Court Advocate Rakhee Sirauthia Chowdhury said that the fault lies with both the police and the legal system.

"The investigators do not probe the cases and keep it lying for years. On the other hand, a trial goes on for a long time due to various reasons," she added.

Chowdhury said that in the case of militants, the investigation often loses focus because several people start questioning the violation of human rights of the accused.

"That he or she is a criminal, killed many people, and waged war against the nation — these facts get diluted under the cover of allegations of human rights violation in police custody. And this leads to delay in investigation," she added.

Senior Advocate Angshuman Bora told PTI that in most cases involving militants, the witnesses do not come to the court to record their testimony.

"In a particular case where three or four militants are involved and only one is present and rest are absconders, then also it gets delayed," he added.

Assam Chief Minister Himanta Biswa Sarma on September 12 said that a total of 1,561 youth from Assam joined extremist organisations since the BJP-led government took charge in 2016.

During the same period, 7,935 militants have returned to the mainstream, he had said in the Assam Assembly.

All industries/units urged to obtain CTE prior to establishment of any industry & CTO after establishment of unit from ANPCC

Port Blair, Sep 25:

In compliance of Section 25 of the Water (Prevention and Control of Pollution) Act 1974, no person shall, without the previous consent of the State Board, establish or take any steps to establish any industry, operation or process, or any treatment and disposal system or an extension or addition thereto, which is likely to discharge sewage or trade effluent into a stream or well or sewer or on land. Similarly, as per the Section 21 of the Air (Prevention and Control of Pollution) Act 1981, subject to provisions of this section, no person shall, without the previous consent of the State Board, establish or operate any industrial plant in an air pollution control area.

It is the responsibility of the industrial unit to obtain Consent to Establish (CTE) from Andaman & Nicobar Pollution Control Committee (ANPCC) before establishment of the industry and also to obtain Consent to Operate (CTO) after establishment of unit. Noncompliance of this is the violation of the provisions made under the Water (Prevention and Control of Pollution) Act 1974, Air(Prevention and Control of Pollution) Act 1981 and Environment (Protection) Act 1986.

It has come to the notice of ANPCC that many of industrial units including hollow blocks manufacturing unit, have been established without obtaining CTE and also started operating without CTO under Water (Prevention and Control of Pollution) Act 1974, Air (Prevention and Control of Pollution) Act 1981, which is a violation of the aforesaid rules.

Therefore, it is informed to all the stakeholders and general public that is it statutory responsibility of all the industries or units to obtain CTE prior to establishment of any industry & CTO after establishment in Andaman & Nicobar Islands. The industrial unit/entrepreneur shall apply for CTE & CTO usthe URL: anocmms.nic.in for the fulfillment of requirement made under Water (Prevention and Control of Pollution) Act 1974, Air(Prevention and Control of Pollution) Act 1981 and Environment (Protection) Act 1986.

Any industrial unit which are operating the activity without obtaining CTE and CTO from ANPCC are liable for taking strict action against the industrial units/firms as the provisions of Environment (Protection) Act 1986.

There are a large number of eligible candidates who were waiting since a considerable time for the recruitment process to start have now unfortunately been debarred to participate in the process. They are certainly are likely to face immense hardship and would suffer irreparable loss & damages which cannot be compensated in future in any manner whatsoever. It may also be kept in mind that the every category of eligible candidates suffered equally due to the pandemic, but granting relaxation to merely one-category candidates is not reasonable in my view. Further he stressed that a yardstick cannot be set for only one category of posts as the pandemic has badly affected everyone equally. It is pertinent to mention here that the Government of Tripura, Meghalaya, Odisha & Rajasthan & several other states & UTs have extended this benefit to recruit all categories of posts.

He requested to grant two (2) years age relaxation for all Group-B non-gazetted posts for which the recruitment through direct recruitment would be held for next 1.5 years under targeted mission mode and positively consider the age relaxation for all the post of Junior Engineers under Andaman Public Works Department, the last date of submission of filled in applications for the direct recruitment of which is fixed on 30th of September, 2022.

MP met with Secretary Education on four crucial demands.

Port Blair, Sep 25: The Member of Parliament of Andaman and Nicobar Islands, Shri Kuldeep Rai Sharma on Friday met the Secretary Education and placed four crucial demands in front of her related to the welfare of Students.

The Member of Parliament demanded starting a second shift in JNRM, from the 2022-2023 session, so that the maximum number of students can get admission in degree programmes and study in their dream subjects in these Islands for their better future.

He pointed out that while many students can afford education in mainland colleges, most of the students of Andaman and Nicobar Islands, especially those who hail from remote villages of North and Middle Andaman as well as Nicobar District can't afford education in mainland colleges but they are very eager to get nigher education.

In his second demand the

Member of Parliament requested the Secretary of Education to start two new bus routes, exclusively for girl students. One from Chatham Jetty to JNRM to ANCOL and vice versa and second from Garacharma to ANCOL to JNRM and vice versa.

In his third demand the Member of Parliament requested to open more playgrounds for children and youths of Andaman and Nicobar Island under Khelo India initiative, so that children and youths can remain mentally and physically fit.

The ex President, Havelock Tourist Boat Operator Association, Shri Prashant Guchhait briefed the Chief Secretary about various water sports activities being conducted there and requested for regulation of activities at the beach. The Chief Secretary directed the officers concerned to make proper regulatory guidelines immediately.

Bhavani Devi to test skills in National Games to prepare for bigger events



PTI, NEW DELHI, Sep 25: First Indian fencer to qualify for the Olympics, Bhavani Devi is looking to test her new techniques and strategies during the National Games and use them in the big-ticket events ahead.

The 29-year-old, who won the gold medal in the Commonwealth Fencing Championship last month, will be one of the attractions at the multi-sport event in Gujarat.

"I have changed my coach, my technique, my strategies, everything is changed now. We have more important events, like the Olympic qualification in April. So I need to work on my strategies. I have to apply them to all my opponents, both beginners and experienced ones and see how it works," she said during a virtual interaction conducted by SAI.

"Sabre is a very quick sport, you can't take time in between touch, you can't think and decide what you want to do in those milliseconds. So it is still a risk to try new techniques in National Games because it is like a show, everyone going to watch. So I need to perform well but at the same time, I need to do my work (new techniques) which can help me in bigger tourna-

ments," she said.

The Chennai-born Bhavani has parted ways with Italian coach Nicola Zanotti and is currently being coached by legendary French fencer Christian Bauer. Bhavani said Indian fencers will need more international exposure to compete with the best in business.

"Right now fencing is in the developing stage, we definitely have a long way to reach a stage where we are able to give a tough fight to top fencers in the world," she said.

"We are starting more domestic competitions so players can compete with fencers who have taken part in some international competitions. So they can understand their level and players who have taken part in international competition can also understand and can improve much better. We are developing, we are progressing in a good way. We just need more time. We are getting medals in some competitions but to reach the podium in the bigger competitions we need more exposure," she added.

Bhavani said coaches also need to get more exposure to improve their technical aspects.

"Coaches also need to go for more international competitions, to understand what levels other athletes are playing, what levels we are in. What kind of technical aspects do we need to work on? We need to understand what strategies work for Indian athletes. So we have to understand that we need more competition and we need to have more international exposure," she said.

"In France, they have hundreds of Olympic and World Championship medal winners. So to reach that kind of level, we need more competition," she further added.

The 42nd-ranked Indian fencer had finished 23rd at the World Cup in Istanbul. She reached the second round in World Championships in July before retaining her title at Commonwealth Championships in August.

Bhavani said there was not much support during her junior days, so she is training more time overseas to make up for it.

"Earlier we didn't have enough support. We were not going for many competitions, maybe one or two in a year. So earlier, I lacked that experience," said Bhavani, who has been training in Europe. "For example, in my junior level, I never took part in any junior world-level competitions," she said.

"When I was in cadet like under 17, I had the chance to compete at the junior level but other than that, I never took part in any junior level competition. So that experience which I lacked sometimes affected me at the senior level too. So to bring that experience back I need to train abroad with other international players regularly so that in long term, I can improve myself," she said.
