

EDITORIAL



Emerging from China's imports grip is a long-term process The latest data released by the China customs de-

partment shows India's trade deficit with the country breaching \$100 billion for the first time in 2022. This is a blow to India's Atmanirbhar Bharat goals, especially with ongoing geopolitical tensions between the two countries. Dependence on Chinese imports continues to increase despite the government's push for manufacturing in the country. The inability to reduce China's influence often gets voiced in the call for a boycott of Chinese goods. But contrary to the narrative, rising imports may not be all that bad.

Most imports from China are intermediate goods used by Indian manufacturers. The recent surge in Chinese imports is mainly due to the Indian manufacturing sector showing signs of a pickup. A sharp rise in chemicals and engineering equipment, including electrical and non-electrical instruments, is driving a large part of the imports growth from China. They are used in the manufacturing sector here. Cheaper Chinese goods are also powering India's green transition, digital economy, and even the latest real estate and construction boom.

Any attempts to throttle the flow of these goods from China will only hurt manufacturers in India. There are risks of an increase in inflationary pressure if the government tries high tariffs as an option to reduce imports from China. Of course, it raises concerns that these imports continue to grow at a healthy pace (at 22% in 2022) even as exports to China shrink (at 38% in 2022). But there are no shortcuts to reducing dependence on them. It will require a long and sustained policy boost to empower Indian manufacturing. At the same time, the government will need to look for alternative suppliers for many important raw and intermediate goods from China.

The good thing is India is not alone in looking for alternatives. The whole world is now talking about the China Plus One strategy and looking for better alternatives to China. The Indian government is also trying hard to emerge as an alternative. However, until then, the government should adopt a pragmatic approach of using trade with China to bolster manufacturing in the country. Of course, we can only hope to reduce the Chinese influence, but any thoughts of obliterating the economic might of a country like China is, at best, a wild fantasy

Appeal against CCI order to become fait accompli due to

delayed hearing in NCLAT, Google tells SC



PTI, NEW DELHI, Jan 15:

Google has approached the Supreme Court, saying its appeal before NCLAT against CCI order, on abuse of dominant position in the Android mobile device ecosystem, would become a "fait accompli" as the appellate tribunal has refused to put a stay and listed hearing of its plea almost 10 weeks after the tech giant is required to comply with the remedial directions.

The National Company Law Appellate Tribunal (NCLAT) has "failed to appreciate the consequences of denying interim relief' as Google will have to implement changes to the status quo of 14-15 years and its entire business model by January 19, 2023.

This (the CCI order) "requires Google to modify its existing contracts, introduce new licence agreements, and alter its business model and commercial arrangements with thousands of device manufacturers and app developers," submitted Google in its petition before the apex court.

Google's petition further said, the NCLAT "erroneously rejected" its request for interim relief seeking a stay despite a "compelling prima facie case, irreversible and irreparable harm to Google" and demonstrates "non-application of mind, predisposition, and failure" to meet its obligations to preserve an existing and flourishing status quo.

"As a result, absent the Supreme Court's intervention, Google will be required to make far-reaching changes to the Android mobile platform which has been in place for the last 14-15 years, based on the Commission's deeply flawed order - this will lead to lasting and irreparable harm to Google, device manufacturers, Indian consumers, app developers,

and the wider Indian mobile economy," said Google.

Google's plea is scheduled to be heard on Monday by the Apex Court, where it has challenged refusing an interim stay by NCLAT over the order of the Competition Commission of India (CCI) imposing a Rs 1,337crore penalty on the global technology firm.

NCLAT had, on January 4, declined to stay the order passed by the CCI, after observing that the order was passed on October 20, 2022, but the appeal against it was filed on December 20, 2022.

Rejecting it, Google said: "While the remedial directions will come into effect only on January 19, 2023, Google filed an appeal a month earlier on December 20, 2022, within the statutory period of limitation," the petition said.

Google worked "tirelessly to prepare a comprehensive appeal (2,500 pages) taking into account voluminous records (16,000 pages) in response to the impugned order (~300 pages).

"Google cannot be punished for effectively exercising its right of appeal," it said.

The tech major also alleged that NCLAT acted "unlawfully" in conditioning the admission of Google's appeal upon it depositing 10 per cent of the penalty amount.

If the "Commission's order is stayed, there will be no harm caused to anyone- Google's agreements with phone manufacturers have been in place for the past 14-15 years and none of these manufacturers has complained to the Commission," it added.

The tech giant has also questioned NCLAT's directive for a pre-deposit of 10 per cent of the penalty for hearing over the interim stay and said: "Section 53B of the Competition Act does not prescribe pre-deposit of penalty as a precondition for admitting an appeal".

REVERBERATION

In October last year, CCI slapped a penalty of around Rs 2,200 crore on Google for anticompetitive practices. It had slapped a Rs 1,337.76-crore fine on Google for exploiting its dominant position with respect to Android, which powers 97 per cent of smartphones in India.

It imposed another Rs 936crore penalty on the US tech giant in a case related to its Play Store policies.

While in the first case, CCI asked Google to allow smartphone users on the Android platform to uninstall apps and let them select a search engine of their choice, the regulator had asked the company to take corrective steps on policies that forced developers to use Google Play's billing system to list their apps on its Play Store.

Currently, one cannot delete apps such as Google Maps or YouTube from their Android phones when they come pre-installed.

Google has not been able to secure relief from the appellate tribunal NCLAT, which asked the company to deposit 10 per cent of the fine within four

Google has since moved the Supreme Court in the matter of abuse of its dominant position in the Android mobile device ecosystem.

SC to hear plea on Joshimath subsidence on Jan 16



PTI, NEW DELHI, Jan 15:

The Supreme Court is scheduled to hear on Monday a plea seeking the court's intervention to declare the crisis in Uttarakhand's Joshimath as a national disaster.

According to the cause list of January 16 uploaded on the apex court website, a bench comprising Chief Justice D Y Chandrachud and Justices P S Narasimha and J B Pardiwala would hear the petition filed by Swami Avimukteshwaranand

Joshimath, the gateway to famous pilgrimage sites like Badrinath and Hemkund Sahib and international skiing destination Auli, is facing a major challenge due to land subsidence.

Joshimath is sinking gradually with huge cracks developing in houses, on roads and fields. Many houses have tilted and are sinking, locals said.

On January 10, the top court refused urgent hearing of the plea, saying there are "democratically elected institutions" to deal with the situation and all important matters should not come to it. It had listed Saraswati's plea for hearing on January 16.

"Everything important need not come to us. There are democratically elected institutions to look into it. We will list it on January 16," the CJI had said, after the counsel appearing for the petitioner had mentioned the plea and sought its urgent listing.

The petitioner has contended that the incident has occurred due to large-scale industrialisation and sought immediate financial assistance and compensation to the people of Uttarakhand.

The plea has also sought direction to the National Disaster Management Authority to actively support the residents of Joshimath in these challenging times.

"No development is needed at the cost of human life and their ecosystem and if any such thing is to happen, then it is the duty of the State and Union government to stop the same immediately at war level," the plea by the Seer

Business entities asked to refrain from selling packaged commodities beyond MRP & dual pricing

Port Blair, Jan 12:

The Department of Civil Supplies & Consumer Affairs, A & N Administration has received complaints regarding overcharging on packaged commodities and beverages being sold in food stall functioning in the inter-island vessels. Such practices are clear cut violation of Legal Metrology (Packaged Commodities) Rules, 2011 framed under the Legal Metrology Act, 2009.

The effective part of the Legal Metrology (Packaged commodities Rules, 2011 is reproduced below:-

18(2):- No retail dealer or other person including manufacturer, packer, importer and

whole-sale dealer shall make any sale of any commodity in packed from at a price exceeding the retail sale price thereof.

18(2A):- Unless otherwise specifically provided under any other law, no manufacturer or packer or importer shall declare different maximum retail prices on an identical pre-packaged commodity by adopting restrictive trade practices or unfair trade practices as defined under clause (nnn) and clause (r) of sub-section (1) of section 2 of the Consumer Protection Act, 1986 (68 of 1986).

At some places, in Airlines, Hotels and Restaurants, Cinema Halls etc, the packaged commodities (food items etc.) are

being sold at a price more than MRP, which is violation of Rules. Such practices are against the consumer interest and against the rules.

Therefore, no business entity is permitted to sale the package commodities beyond the MRP printed on the package, it is advised to adhere to the provisions of Legal Metrology (Packaged Commodities) Rules and it is advised to refrain themselves from such unfair trade practices failing which, necessary penal action shall be initiated against such offenders as per extant rules to safeguard the larger interest of the con-

68 killed as passenger plane with 72 people onboard, including five Indians, crashes in Nepal



KATHMANDU: At 68 people were confirmed dead Sunday when a plane with 72 on board crashed in Nepal, police said, in the Himalayan country's deadliest aviation disaster in three decades.

According to the Civil Aviation Authority of Nepal (CAAN), Yeti Airlines' 9N-ANC ATR-72 aircraft took off from Kathmandu's Tribhuvan International Airport at 10:33 am.

Pokhara is a major tourist destination in the Himalayan

While landing at the Pokhara airport around 11 am, the aircraft crashed on the bank of the Seti River between the old airport and the airport. There were a total of 68 passengers and four crew members. At least 32 bodies have been recovered from the wreckage site, The Himalayan Times newspaper reported.

Five Indians were among the total 10 foreign nationals onboard the plane, the Indian Embassy tweeted.

The five Indians onboard the crashed plane have been identified as Abhisekh Kushwaha, Bishal Sharma, Anil Kumar Rajbhar, Sonu Jaiswal and Sanjaya Jaiswal, a Yeti Airlines official said.

"An ATR-72 plane of Yeti Airlines crashed today near the Pokhara Airport while flying from Kathmandu. According to the info provided by Civil Aviation Authority of Nepal, 5 Indians were travelling on this flight. Rescue operations are underway," the Indian mission tweeted.

The embassy is in touch with local authorities and is monitoring the situation, it said.

There were ten foreigners on board the aircraft. Some of the passengers have been hospitalised, the airlines said.

The condition of the Indian passengers is not known yet.

According to Tek Bahadur KC, Chief District Officer of the Kaski district, the plane crashed into the Seti river gorge. Rescue operations are currently being conducted, he was quoted as saying by The Himalayan Times newspaper.

Prime Minister Pushpa Kamal Dahal 'Prachanda' held an emergency meeting of the Council of Ministers following the crash.

The emergency meeting of the Council of Ministers held on Sunday afternoon has decided to announce a public holiday on January 16 to mourn the victims of the Yeti Airlines plane crash.

He expressed sadness over the crash and directed the Home Ministry, security personnel and all the government agencies to carry out immediate rescue and relief operations.

The government announced that a five-member committee will be formed to probe the accident.

Following the Yeti Airlines aircraft crash, the Pokhara International Airport has been closed for today for all incoming and outgoing flights.

Images and videos posted on social media platforms showed plumes of smoke billowing from the crash site.

Shortly after the crash, police reached and started a rescue operation. However, the police said that it was not possible to deploy enough man-

Police said that bringing the fire under control was difficult as the fire engine could not reach the gorge where the crash took place. As a result, the fire is yet to be brought under control.

Gyan Bahadur Khadka, police spokesman, Kaski, said that there was a problem in the contd. page-6

India's Russian oil imports top 1 million barrels a day in December



PTI, NEW DELHI: India's import of crude oil from Russia increased further in December 2022, topping 1 million barrels per day for the first time ever as Moscow remained its top oil supper for the third month in a row, according to data from energy cargo tracker Vortexa.

Russia, which made up for just 0.2 per cent of all crude oil India imported in the year to March 31, 2022, supplied 1.19 million bpd in December.

This was higher than 909,403 bpd crude oil India imported from Russia in November and 935,556 bpd in October 2022

The previous record for most crude oil imports from Russia was in June 2022 when India bought 942,694 bpd, according to Vortexa.

Russia, which in October 2022 for the first time surpassed traditional sellers Iraq and Saudi Arabia to take the No.1 spot, now makes up for 25 per cent of all oil imported by India.

The imports peaked as a price cap was agreed upon by the EU on Russian seaborne oil. Russian oil is available at much lower than USD 60 per barrel cap agreed, industry sources said.

India is the world's thirdlargest oil-consuming and importing nation. It imports 85 per cent of its crude oil needs. Crude oil is converted into fuels like petrol and diesel at refineries.

According to Vortexa, an energy intelligence firm, India imported 803,228 bpd of oil from Iraq in December and 718,357 bpd from Saudi Arabia.

The United Arab Emirates overtook the US to become India's fourth largest supplier, selling 323,811 bpd oil in December 2022. The United States supplied 322,015 bpd, down from 405,525 bpd in November 2022.

India's appetite for Russian oil swelled ever since it started trading on discount as the West shunned it to punish Moscow for its invasion of Ukraine.

According to S&P Global Commodity Insights, India is aiming to pursue an oil import policy that will witness robust inflows from both the US and Russia in the foreseeable future, while stepping up efforts to diversify the crude basket even further to cushion the impact of any supply shock going ahead.

"Although the Russia-Ukraine war has given an opportunity to the country's refiners to bring in plentiful volumes of crude at discounted rates from the largest non-OPEC supplier, but that has not led to a fall in market share of the US, as India looks to bolster its energy ties with Washington," it said.

Prior to the Russia-Ukraine conflict, more than 60 per cent of the Indian crude basket was made up of Middle Eastern crudes, with the remainder made up of North American crudes at around 14 per cent, West African crudes at around 12 per cent, and Latin American crudes at around 5 per cent, with Russian grades accounting for only about 2 per cent.

Since the war began, West African crudes have become more expensive for Indian refiners because they are mostly Brent-linked and are being pulled in by European refineries that are running low on Russian crudes.

According to S&P Global data, the share of US crude in the Indian crude basket increased from 5-6 per cent in April to around 10 per cent in November last year.

In the last quarter of 2022, the US displaced Kuwait to become the fifth-largest oil supplier to India.

As per Vortexa, India imported just 36,255 barrels per day of crude oil from Russia in December 2021, compared to 1.05 million bpd from Iraq and 9,52,625 bpd from Saudi Arabia.

There were no imports from Russia in the following two months, but they resumed in March 2022, soon after the Ukraine war broke out in late February.

India imported 68,600 bpd of Russian oil in March 2022, which increased to 266,617 bpd in the following month and reached the previous peak of 942,694 bpd in June 2022.

But in June 2022, Iraq was India's top supplier with 1.04 million bpd of oil. Russia, in that month, became India's second-biggest supplier. Imports dipped marginally in the following two months.

They stood at 876,396 bpd in September 2022 before rising to 935,556 bpd in October, according to Vortexa.

The Indian government has been vehemently defending its trade with Russia, saying it has to source oil from where it is the cheapest.

The government has previously indicated that oil companies will continue to buy oil from Russia outside the price cap.

External Affairs Minister S Jaishankar on December 7 told the Rajya Sabha that Indian refiners will continue to look for the best deals in the interest of the country.

"We do not ask our companies to buy Russian oil. We ask our companies to buy oil (based on) what is the best option that they can get. Now, it depends on what the market throws up," he had said while replying to clarifications sought by MPs on his suo moto statement on foreign policy.

The companies will go after sources that are more competitive, Jaishankar had added.

"Please do understand it's not just we buy oil from one country. We buy oil from multiple sources, but it is a sensible policy to go where we get the best deal in the interests of the Indian people, and that is exactly what we are trying to do," he had said.

The executive body of the European Union has asked its 27 member countries to cap the price of Russian oil at USD 60 a barrel as part of the West's attempt to squeeze Moscow's oil revenues and limit its ability to wage war in Ukraine while keeping global prices and supplies steady.

From December 5, 2022, western shipping and insurance companies are prohibited from handling Russian oil sold above the price cap.

However, ships loaded with Russian oil before December 5 and unloaded at their destination before January 19, will not be subject to the price cap.

A top government official said India can continue to buy Russian oil if it can send ships, cover insurance and devise a mode of payment.

Manu Bhaker tops India's national shooting trials in 25m pistol



ANI, NEW DELHI: Manu Bhaker topped the women's 25m pistol event in India's national shooting trials held at Karni Singh Shooting Range in Delhi's Tughlakabad this week. The trials were held from January 8 and concluded on January 14.

The seven-day trials were split into two groups (Groups A and B). Indian shooters at the top of their game were in Group A, while shooters who qualified for open selection trials were in Group B.

The national squad will only be chosen from Group A shooters for the international and continental competitions given Olympic quotas in 2023.

Manu Bhaker, who was as-

signed to Group A, won the first trial qualifying with a total score of 581 points and a final score of 27. Chinki Yadav of Madhya Pradesh finished second with a final score of 21, while Esha Singh of Telangana took third place.

Bhaker, who won a gold medal at the 2018 Youth Olympic Games in Buenos Aires, was equally consistent in the second trial and topped qualification with 590 points followed by a final score of 27. Abhidnya Ashok Patil came a close second with 26 points this time while Niveditha Nair finished

World champion Rudrankksh Patil, who secured a Paris 2024 Olympic quota for

India in November, won the second Group A trial in the 10m air rifle, defeating Chain Singh 17-13 in the gold medal round. Patil had finished fourth in the qualification round while Chain was sixth. Rudrankksh Patil also made it to the final of the first trial but was stunned by Lagad Saurav Gorakh in the final by a 17-9 scoreline.

Sift Kaur Samra bagged a double in the women's 50m rifle 3 positions (3P), winning both finals in the trials against the country's top shooter in the category, Anjum Moudgil.

Mehuli Ghosh of West Bengal (women's 10m air rifle) won trial one and Ramita won the second trial in the same category.

London 2012 silver medallist Vijay Kumar, who is on a comeback trail, was pipped by Vijayveer Sindhu in the first men's 25m rapid-fire pistol trial. He did not make it to the top eight in the second trial which was won by Ankur Goel.

Olympian Aishwary Pratap Singh Tomar won the first men's 50m rifle 3 positions (3P) trial while the second was won by Akhil Sheoran.
