## No wriggle room for Govt after fresh SC reiterations

One interesting fallout from the Centre's intransigence on the issue of judges appointing judges was the Supreme Court collegium issuing detailed explanations on fresh reiterations of five candidates for the judgeship in high courts. Its total demolition of the government's reservations that cited inputs from intelligence agencies about them was unprecedented. This was also the first time the collegium was coaxed into putting its reasoning in the public domain in over three years. The rare gust of transparency contrasted against the SC collegium's otherwise opaque recommendations, as the court generally puts up bland lists of the chosen ones for promotion, transfer, or both on its website. The other aspect that stood out was its emphasis on competence, merit and integrity while refusing to read meaning into the sharp social media posts they might have made against the government of the day. That the candidates had no overt affiliation with any political party or any other biases were factors. But as it pointed out, all citizens have the right to free speech and ex-

On a different note, the parents of three of the five candidates are retired judges—Saurabh Kirpal's dad is former Chief Justice of India B N Kirpal; Amitesh Banerjee is the son of former SC judge U C Banerjee; and Sakya Sen's dad is Shyamal Sen, retired Allahabad High Court Chief Justice. A lazy inference would be of nepotism, but the collegium was impressed by their core competencies in the Bar and inferred they would enrich the bench. The BJP's antipathy for Justice Banerjee is known, as a probe commission headed by him ruled out any conspiracy angle in the Sabarmati Express blaze that killed 58 kar sevaks in Godhra in 2002. Lalu Yadav appointed the panel during his tenure as railways minister in UPA-I. As for Sakya Sen, this was his third reiteration, drawing an angry comment from the collegium that it was not open to the law department to send back a reiterated file for fresh consideration repeatedly.

Saurabh Kirpal's reiteration made the biggest headlines because if appointed, he would be India's first openly gay judge of a high court. The collegium gave him credit for being open about his sexual orientation and dismissed objections about his partner being a Swiss national. After these reiterations, the government has no room to stall. It must quickly announce the appointments and uphold the majesty of the judiciary.

#### 'Is India breaking? Rahul creating hatred, tarnishing India's image': Rajnath Singh



PTI, BHOPAL: Defence Minister Rajnath Singh on Sunday accused Congress leader Rahul Singh of creating hatred among people in order to regain power, and alleged that he was tarnishing India's image on international platforms.

Addressing a programme organised by the Madhya Pradesh government to provide land rights of residential plots to the poor in the Singrauli district of the state located around 650 km from here, Singh asked Gandhi not to play with India's "prestige and pride".

The minister also said that in the recent clash with the Chinese troops, Indian soldiers did a "charismatic job" and displayed bravery, and slammed the Congress for questioning the valour of the country's jawans.

"Is India breaking? The country already got divided in 1947. Pakistan was created, though the leaders at that time were not in favour. These days, Rahul Gandhi is going around saying in his Bharat Jodo Yatra that there is hatred everywhere in India," he said.

"Rahulji, what has happened to you? You want to regain power by creating hatred. Power cannot be achieved by creating hatred, it can be achieved only by earning the public's trust and love. I want to ask him who is creating hatred in India? Is Modiji creating hatred in the whole country? Is (MP Chief Minister) Shivraj Singh (Chouhan) doing the work of creating hatred in Madhya Pradesh? Are these leaders creating hatred among people? Where did he see it," he asked the gathering.

The minister also accused the Congress of trying to defame India and tarnish its image by saying that only hatred prevails in India, although the country has earned great respect in the world now. India is the only country that considers all the people of the world as its family. India is being maligned that there is only hatred in India, he alleged.

India has never discriminated on the basis of caste, creed or religion as those born on Indian soil are brothers as all have sacrificed their lives for the country's independence, he added.

"I humbly want to say to Rahulji, don't spoil the image of India in the world by talking about hatred. You are creating hate by talking about it. You create hatred towards Modi and BJP by going to the people. The whole world is getting the image that there is only hatred in India," he said.

Referring to Rahul Gandhi's remark that he is out to sell love in the market of hatred, Singh asked the gathering, "Have you also got some love from him? Now, what does he know about love?" He said that Rahul Gandhi and Congress members should keep in mind that politics should not be done just to form the government and it should be done for society and the country.

"Rahulji, don't play with India's prestige and pride. India is moving forward, if you can cooperate then do it, if you can't, then sit silently, don't try to defame India in the international arena," he said.

Singh also said that Congress leaders can defame the Bharatiya Janata Party (BJP), but they dared to question the bravery and valour of the country's army and soldiers who risked their lives to protect the country.

"Being the country's defence minister, I don't want to speak openly. But I wanted to make it clear that whatever war has happened this time, be it between India-China, the bravery that our army soldiers have exhibited, if I discuss it in front of anyone, then everyone will boast, they have done a charismatic job," Singh said.

Last month, Rahul Gandhi alleged that China was preparing for war and the Indian government was sleeping over it and trying to ignore the threat.

He had also alleged that China had taken away 2,000 square kilometres of Indian territory, killed 20 Indian soldiers and was "thrashing our jawans in Arunachal Pradesh".

Singh said that India's economy has made a place among the top five economies in the country during the past eight years. Earlier, Rajnath Singh and MP CM Chouhan distributed free plots under CM Land Rights Scheme to over 25,000 beneficiaries besides disbursing the benefits of Rs 135 crore to 6. 78 lakh farmers under the CM Kisan Kalyan Yojana.

#### India will become model of global science, technology, innovation in **2047: CSIR DG**



PTI, BHOPAL: India will become the model of global science, technology and innovation in 2047 and will be among the top three countries in the field in 2030, Council of Scientific and Industrial Research (CSIR) Director General Dr Nallathamby Kalaiselvi has said.

Talking to PTI, she also denied that young scientist awards have been discontinued and said people will see definitely see multi-dimensional growth in the science sector in the coming days.

Kalaiselvi, the first woman director general of CSIR, established by the government in 1942, was in Bhopal to participate in the 8th India International Science Festival (IISF)-2022 which began on Saturday.

The theme of the four-day event is 'Marching towards Amrit Kaal with Science Technology and Innovation'.

"In 2030, India will be one among the top three nations, in 2047, the country will become the model of global STI (science, technology and innovation). In 2070, the entire globe will accept that India is a ruling power (in science). Because this will become a reality in 2070, this is my strongest belief as a scientific researcher," Kalaiselvi said.

Asked about media reports claiming that CSIR has stopped giving young scientists awards and prizes, Kalaiselvi said, "Nothing has been stopped, scientist-related programmes are happening everywhere, at every level, even the students are called young scientist students, so everywhere science, researches and researchers are getting celebrated."

"If you feel that something looks like getting stopped, I think you will definitely see multi-dimensional growth in the coming days," she added.

On women's role in science,

Kalaiselvi noted this is a critically, historically and scientifically important era wherein Minister Prime Narendra Modi has also said that in the 'Amrit Kaal' "we have escalated ourselves in science, technology and innovation."

The government of India has already identified that women

in science can really do wonders and women have also started reaching various heights, Kalaiselvi said, adding that is why she got identified as a woman scientist.

"Therefore, I am not here as Kalaiselvi, but as the recognition given to women in science," she said.

Kalaiselvi, who is also secretary of the Department of Scientific and Industrial Research, said when the country starts celebrating not only science and research but also women in science when it is trying to give women additional support through a number of projects, "I think days are not far when India should be among the top three nations (in the field of science)."

She said the CSIR was coming up with dedicated programmes for women.

On women's participation in the IISF, Kalaiselvi said the participation of women is very unique everywhere and here as well.

The CSIR DG said she is thrilled to see the next generation, both males and females, coming forward in the field of science and it is no wonder that males are taking up the job far-

"But nowadays, girls are also coming forward and they have started sharing the responsibility not only in terms of the family but also in science and technology, in the nation's development, in maintaining and making sustainable growth, and development of India's tradition and culture through science technology," she said.

Asked about the new innovations being showcased at the IISF, she said the participants are exhibiting what they have done and they have been told to make the CSIR community understand the critical

## France want to be partner in building national base for defence industries in India: French envoy Lenain



PTI, PANAJI: French Ambassador Emmanuel Lenain has said his country wants to be a partner in the process of building a national industrial base for defence industries in India.

Talking to reporters on Saturday on board French aircraft carrier Charles De Gaulle which took part in the Indo-French naval exercise 'Varuna' off the Goa coast, Lenain said the two countries can coproduce lot of equipment for the defence and space sectors.

France is committed to making available the best technologies to Indian forces without restrictions, he said. Lenain said France has

really understood the vision of 'Aatmanirbhar Bharat' (self-reliant India).

"We understand that also because we are a highly independent country and we have been through that process also. We want to be a partner in the process to build a national industrial base for defence industries in India," he said.

When India is looking to diversify its suppliers, France is a great option, the envoy said. Lenain said his country is committed to making available the best technologies to Indian forces without restrictions.

"France will not only support for make in India, but also come forward to co-develop and co-produce equipment," he said

Asked about relations between the two countries, Lenain said "The bilateral ties between India and France are exceptionally good and trustworthy".

"We are of the same values. The best way to assert our strategic autonomy is by cooperating together. The two countries can co-produce lot of equipment for the defence and space sectors," Lenain said.

The Indo-French naval exercise that began here on January 16 culminated on Friday.

A French Navy official earlier said this joint preparation for air-sea warfare exemplifies the outstanding Indo-French naval cooperation in the Indo-Pacific, with ships, frigates and helicopters as well as a French command and replenishment ship carrying out numerous training sessions of increasing intensity, the official informed.

The aim of the joint exercise was to prepare the crews of the two countries to face a variety of challenges together, mobilising their anti-surface, anti-submarine and anti-aircraft assets, as well as shared control of the air-sea environment and ship control, the official said.

### Uphaar cinema fire tragedy: 26 years on, victims' families still knocking in vain on doors of justice



IANS, NEW DELHI: The legal route taken by Neelam and Shekhar Krishnamoorthy and the families of the other Uphaar cinema fire tragedy victims is full of twists and turns. It has been 26 years and the search for justice still continues.

The Krishnamoorthys' home is quiet with the photo frames of their two children, who perished in the fire, hanging on the wall. Unnati and Ujjwal seem to be looking for justice. It is their parents' hard work and courage that has kept them going to seek what they want from India's judicial system. They are determined to fight on until their last breath.

Neither they nor their kids knew that a movie on a Friday evening will turn Neelam and Shekhar's lives upside down. In a span of a few hours, a family of a cheerful four was reduced to two members. Twenty six years ago a fire broke out in Green Park's Uphaar ninema at New Delhi while the film "Border" was being screened.

In June 1983, the Deputy Commissioner of Police, Licensing, had suspended the cinema's license for four days due to structural and fire safety deviations.

The Green Park Theatre & Associated (P) Ltd. (which ran Uphaar cinema), obtained a stay order from the Delhi High Court.

On account of the stay order, only temporary permits were issued to the cinema and the theatre owners — Sushil and Gopal Ansal — kept on obtaining temporary permits from the Licensing Authority for periods of two months each, for 14 years till June 13, 1997, the day the fire broke in Uphaar.

At 4.55 p.m., a swirling mass of thick smoke engulfed the bal-

cony section of the hall. In the absence of fire exits and ushers to help the patrons, the people seated on the balcony found themselves trapped. By 7 p.m., 59 people from 28 families had died. This included Unnati (17) and Ujjwal (13).

For the victims' families, who were devastated at losing their loved ones, the Krishnamoorthys formed AVUT (Association of the Victims of Uphaar Tragedy) on June 30, 1997, barely 17 days after the tragedy struck. Starting off as a nine-family association, it is a 28-family powerful registered society now.

The investigation into the fire incident which began with the Delhi Police's crime branch conducting the probe, on July 24, 1997, was transferred to the Central Bureau of Investigation (CBI).

On November 15, the CBI filed a chargesheet against 16 accused persons including appellants Sushil Ansal, Gopal Ansal and HS Panwar.

In an order dated July 31, 2000, that is three years later, the Delhi High Court directed the trial court to frame charges by October 16, in the petition filed by AVUT for the main case.

#### Australian Open: Sania Mirza suffers defeat in second round of women's doubles



ANI, MELBOURNE: India tennis ace Sania Mirza's women's doubles career at the Grand Slam came to a disappointing end after she suffered a Round 2 defeat in the ongoing Australian Open 2023 on Sunday.

Sania and her women's doubles partner Anna Danilina lost to the unseeded duo of Anhelina Kalinina and Alison Van Uytvanck. Playing at Court 7, Mirza and Danilina lost by a margin of 4-6, 6-4, 2-6 at Melbourne Park.

Given that Mirza, a six-time Major champion, will retire after the Dubai Open next month, this was her final appearance in a women's doubles Grand Slam match.

Earlier in the day, the all-French duo of Jeremy Chardy and Fabrice Martin defeated the event's alternates, N Sriram and Balaji Jeevan Nedunchezhiyan in a straight set 6-4, 6-4.

In the opening set of the match, Mirza-Danilina nearly had an ideal start as they contested the Van Uytvanck serve. Five break points were available during the 11-minute match, but none were converted since the Belgian was able to hold serve.

Earlier, Sania Mirza and Anna Danilina overpowered the Hungarian-American team of Dalma Galfi and Bernarda Pera to advance to the second round of women's doubles.

REVERBERATION

On the other hand, the Indian ace mixed doubles pair of Sania Mirza and Rohan Bopanna breezed into the second round at the Australian Open 2023 at Melbourne Park on Saturday. The semi-finalists from Rio 2016 Saina Mirza and Rohan Bopanna defeated Australian wild card entry Jaimee Fourlis and Luke Saville 7-5, 6-3 in an hour and 14 minutes.

The Indian pair suffered an early setback in the match, having been broken in the fourth game. After a prompt retort, Mirza and Bopanna took six of the next eight games to capture the opening set. As they gained momentum, Mirza and Bopanna maintained their hold on the second set and defeated Jaimee Fourlis and Luke Saville in the seventh and ninth games to win the set and the match.

Sania Mirza and Mahesh Bhupathi won the Australian Open mixed doubles championship in 2009.

The court framed charges against all the 16 accused under various Sections of the Indian Penal Code (IPC), including 304 (culpable homicide), 304 A (causing death by negligent act) and 337 (hurt), on February 27, 2001.

Later in April, Sushil Ansal filed a revision petition against the order framing charges. On April, 4, 2002, the HC asked the trial court to wrap up the case by 15 December.

"The trial court shall also take expeditious steps to complete the trial as far as practicable by 15th of December 2002," the court said, adding that the "trial court shall hold trial of sessions case for 10 days in a month from May except June 2002".

On 27 January, 2003, the Ansals' plea seeking re-possession of the theatre was rejected on the ground that the place of incident is to be preserved to appreciate evidence.

From September 4, 2004 to August 20, 2007, the court recorded the statements of the accused, recorded testimonies of defence witnesses, the Additional Sessions Judge (ASJ) Mamta Sehgal inspected the theatre, the accused started advancing final arguments and senior advocate Harish Salve appeared for the CBI to advance final arguments.

The AVUT on May 18, 2007, approached the High Court seeking conclusion of the trial within a time frame. On October 22, 2007, the court fixed November 20 as the date of verdict. On the date of verdict, the court convicted all the 12 accused, including Sushil and Gopal Ansal, in the main case and sentenced them to two years imprisonment. By that time, four accused had died.

One and a half months later, the High Court granted bail to the Ansal brothers and two other accused.

However, in the same year on September 11, the Ansals were sent to Tihar Jail after the Supreme Court (SC) cancelled their bail.

On December 19, 2008, the High Court upheld the trial court's order convicting the Ansal brothers but reduced their sentence from two years to one year.

In 2009, the SC issued notice on a petition filed by AVUT for enhancement of the sentence and alteration of charges. The CBI too filed an appeal seeking enhancement.

Later in April, 2013, the SC reserved its order on the appeals of the Ansals, the CBI and AVUT.

In a twist, on March 5, 2014, the judges differed on the sentence. One judge awarded one year, another sentenced the Ansals to the term already undergone. The matter was referred to a threejudge bench.

A year and four months later, in August 2015, the SC allowed the Ansals to walk free after paying a fine of Rs 30 crore each (Rs 60 crore in to-

The amount by way of a demand draft was to be paid to the Chief Secretary of the Delhi Government for setting up a new trauma centre, which is now called AIIMS Jai Prakash Narayan Apex Trauma Centre.

Moreover, HS Panwar was awarded a two year sentence subject to the condition that if he pays Rs 10 lakh for the Trauma Centre, then the sentence will stand reduced to the period already undergone.

In 2017, in the review petition filed by AVUT and the CBI, the SC asked Gopal to undergo the remaining one-year jail term while his elder brother Sushil was given relief from incarceration, in view of age-related complications keeping in mind the prison term already served by him. However, the fine of Rs 30 crore each for the Trauma Centre was maintained as directed by the SC in its judgement dated August 19, 2015.

On February 20, 2020, the SC dismissed a curative petition filed by AVUT. On November 8, 2021, a Delhi court awarded seven-year jail terms to the Ansals in the tampering with evidence case and imposed a fine of Rs two crore twenty five lakhs on each. The rest were fined Rs 3 lakh each.

Last year on 18 July, Principal District and Sessions Judge, Patiala House courts, upheld the order of conviction under Sections 409, 201 and 120B of the IPC passed by the trial court against the Ansals, Dinesh Chandra Sharma (Ahlmad, who was charged with tampering of a document) and P. P. Batra except Anoop Singh as he was acquitted of all charges.
