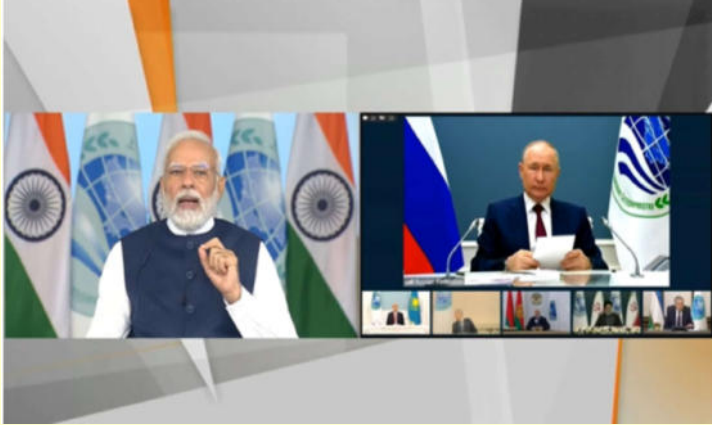

PM chairs 23rd SCO Summit Calls for decisive action against terrorism as it remains a major threat to regional, global peace

New Delhi, July 4

Prime Minister, Shri Narendra Modi has described terrorism a threat to regional and global peace and called upon Shanghai Cooperation Organisation (SCO) countries to fight this menace together. Addressing the SCO virtual summit today, Shri Modi said, some countries are using cross-border terrorism as an instrument of their policies and SCO countries should not hesitate to criticize such nations. Shri Modi underlined that there should be no double standards on terrorism. He also said India's concerns and expectations



regarding Afghanistan are similar to those of most SCO countries. Shri Modi added that it is necessary that the land of Afghanistan is not used to spread instability in neighboring countries or encourage extremist ideologies. The Prime Minister

said the food, fuel and fertiliser crisis are a big challenge for all countries in the world surrounded by controversies, tensions and epidemics. He added that over the past two decades, the SCO has emerged as an important platform for peace, prosperity and

development in the entire Eurasia region. He said, India has made sustained efforts to take SCO's multifaceted cooperation to new heights as the chair of SCO. He said, India has made five new pillars for cooperation in the SCO and they are Startups and

Innovation, Traditional Medicine, Youth Empowerment, Digital Inclusion and Shared Buddhist Heritage.

The Prime Minister said, several new platforms including Young Scientist Conclave, Authors Conclave, Startup Forum, and Youth Council have been organized to harness the talent of the youth from SCO countries. These platforms aim to channel the potential of SCO's youth and provide them with meaningful opportunities. Shri Modi added that India supports proposals for reform and modernisation of

victims under one roof.

According to the Ministry, the support will be available at childcare institutions up to the age of 18 and extended support till the age of 23 in aftercare facilities. The Ministry has leveraged the administrative structure of Mission Vatsalya in

Safeguarding interest of consumers under Legal Metrology Act Weighing machines made mandatory during LPG Cylinder distribution

Port Blair, July 4

All LPG consumers and the authorized LPG distributors of this UT have been informed that as per the Legal Metrology (Packaged Commodities) Rules, 2011 framed under the Legal Metrology Act, 2009, it is mandatory for all authorized LPG distributors to provide to their delivery man a check weigher or non-automatic weighing instrument to measure or weigh the quantity of the LPG cylinder at the time of delivery. The consumers have the right to demand

weighing of LPG cylinders at the time of delivery, so as to ensure exact quantity being delivered to them. The weight of a domestic LPG cylinder is weight of empty cylinder + 14.2 kg of LPG filled in it with a maximum permissible error of 150 gm. Similarly, the weight of a 19 kg commercial LPG cylinder is weight of empty cylinder + 19 kg of LPG filled in it with a maximum permissible error of 1% and that for a 5 kg commercial LPG cylinder is weight of

Bengaluru, July 4 India and Mumbai City FC winger Lallianzuala Chhangte and forward Manisha Kalyan were on Tuesday named the AIFF Men's and Women's Footballer of the Year for 2022-23 season for their impressive performances throughout the season.

The 26-year-old Chhangte becomes only the second player from Mizoram, following Jeje Lalpekhlua in 2016, to be bestowed with the men's Player of the Year award.

The winger played 12 times during the international season for India, scoring two goals and providing one assist in the 2022-23 season. He beat the national team-mates Nandhakumar Sekar and Naorem Mahesh Singh to the coveted award.

Chhangte also emerged as one of Mumbai City FC's most influential figures in their League Winners' Shield run, appearing in all 22 of the club's Indian Super League (ISL) matches last season and scoring 10 goals while providing six assists.

On the other hand, the 21-year-old forward Manisha won the AIFF Women's Footballer of the Year award for the 2022-23 season, surpassing Dalima Chhibber and Ngangbam Sweetie Devi.

The Punjab-born footballer continues to shine brightly in her career, securing this prestigious award for the second consecutive time.

'Niramaya' scheme aims to provide affordable Health Insurance to persons with Autism, Cerebral Palsy, Mental Retardation (ID) & Multiple Disabilities. The scheme is being run by the National Trust, Ministry of Social Justice & Empowerment, New Delhi.

The Niramaya Health Insurance Scheme has a single premium across age band and insurance cover up to Rs.1.0 lakh (per year) on reimbursement basis only. The services covered under the insurance scheme ranges from Medical Check up to Hospitalization, Therapy to Corrective Surgeries, Transportation as per the benefit chart issued by the National Trust which may be revised from time to time. This scheme demands no pre-insurance medical tests and treatment can be taken from any hospital.

If the person with disabilities (only Autism, Cerebral Palsy, Mental Retardation (ID) and Multiple Disabilities) comes under BPL category the Enrolment fee is Rs.250 (one time per year), for APL category it is Rs.500 (one time per year). The required documents to enrol under Niramaya Health Insurance Scheme are Disability Certificate, Photo, Income Certificate (if APL / BPL card).

empty cylinder + 5 kg of LPG filled in it with a maximum permissible error of 1.5%. The empty weight of LPG cylinder is printed on the body of the cylinder.

The distributor shall get the weighing machine duly verified and stamped from the Legal Metrology Section functioning in the Directorate of Civil Supplies & Consumer Affairs prior to using it for any commercial transaction.

The Department of CS&CA has time and again advised all the authorized LPG distributors to provide weighing instrument at the time of delivery of LPG cylinders to facilitate the consumers. Now therefore, all the authorized LPG distributors have been once again advised to strictly comply with the Rules and make necessary arrangements for weighing of LPG cylinders during delivery at the earliest, failing which, strict action as per law shall be initiated against the distributor.

The Department of Civil Supplies and Consumer Affairs has been relentlessly working towards safeguarding the interest of the consumers. All the consumers have been advised that any malpractice by any person/shop/establishment may be brought to the notice of the Department over Toll Free No. 1800-345-3197 or telephone no. 03192-230337, a press release from Department of CS&CA said.




