empty cylinder + 5 kg of LPG filled in it with a maximum permissible error of 1.5%. The empty weight of LPG cylinder is printed on the body of the cylinder.

The distributor shall get the weighing machine duly verified and stamped from the Legal Metrology Section functioning in the Directorate of Civil Supplies & Consumer Affairs prior to using it for any commercial transaction.

The Department of CS&CA has time and again advised all the authorized LPG distributors to provide weighing instrument at the time of delivery of LPG cylinders to facilitate the consumers. Now therefore, all the beneficiaries of this card holders have been not able to lift ration in authorized LPG distributors have been once again advised to strictly comply with the Rules and make necessary arrangements for weighing of LPG cylinders during delivery at the earliest, failing which, strict action as per law shall be initiated against the distributor.

The Department of Civil Supplies and Consumer Affairs has been relentlessly working towards safeguarding the interest of the consumers. 
