The President of India, Smt Droupadi Murmu took a historic sortie in a Sukhoi 30 MKI fighter aircraft at the Tezpur Air Force Station in Assam today. The President, who is the Supreme Commander of the Indian Armed Forces, flew for approximately 30 minutes covering Brahmaputra and Tezpur valley with a view of Himalayas before returning to the Air Force Station.

India registers over 6000 new cases of COVID-19 in last 24 hours

New Delhi, April 8

The country has registered six thousand one hundred and 55 new cases of COVID-19 in the last 24 hours. The Union Health Ministry said, a total of two thousand two hundred people have recovered from COVID during the



same period. The Ministry said, there are over 31 thousand active COVID cases in the country and the recovery rate currently stands at

98.74 per cent.

The Ministry said, over one thousand nine hundred vaccine doses of COVID were administered during the last 24 hours. Over 220 crore 66 lakh vaccine doses were administered across the country so far. (Source:india.gov.in)

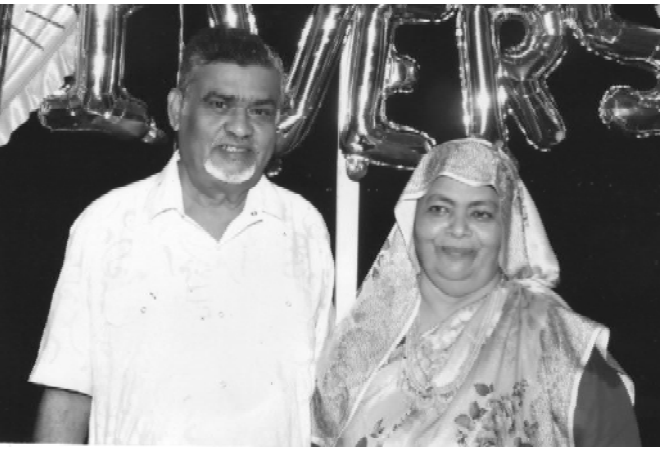

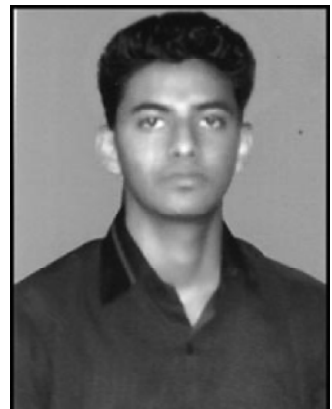
